(57) **CLAIM**

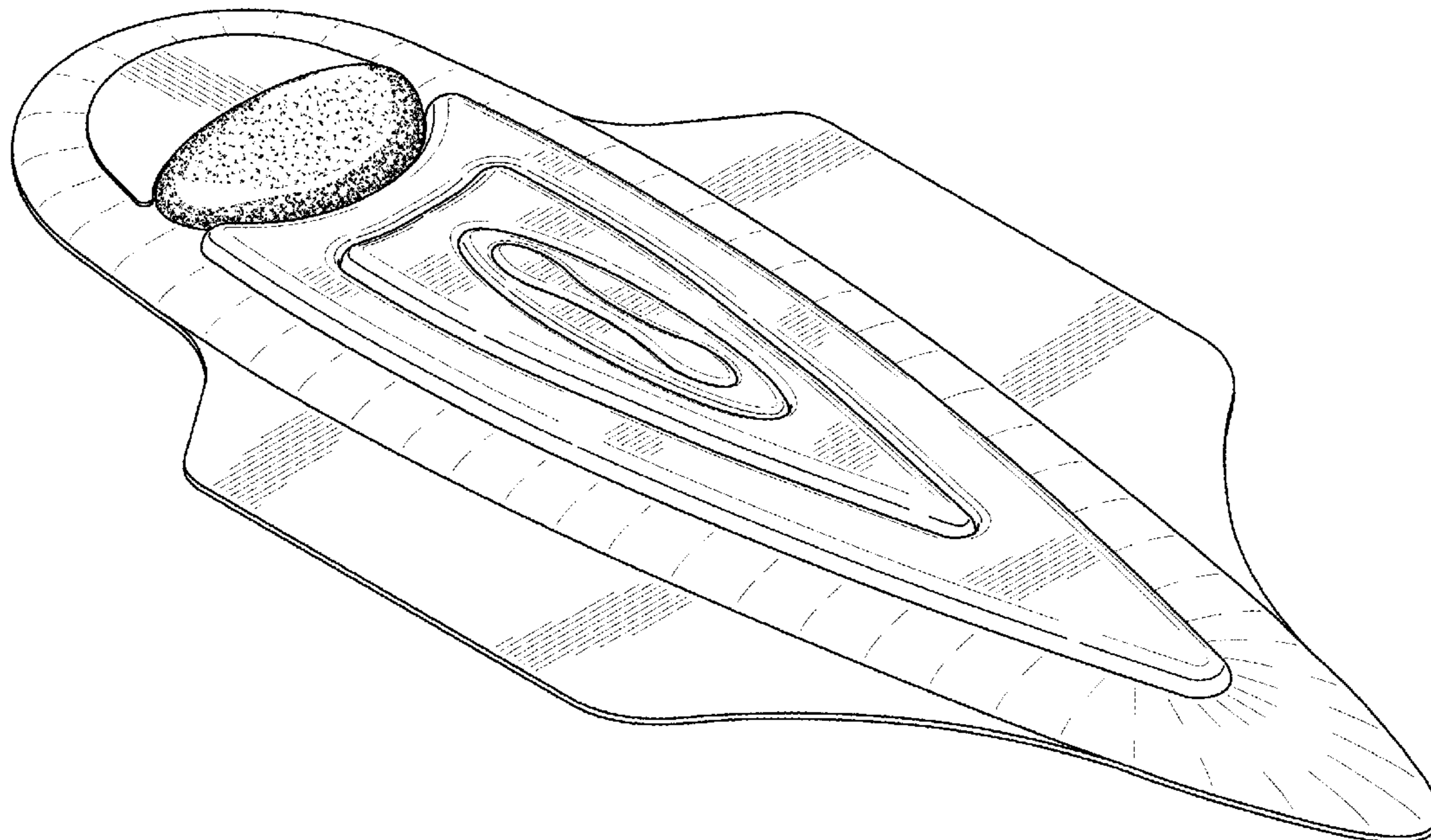
The ornamental design for a sanitary pad, as shown.

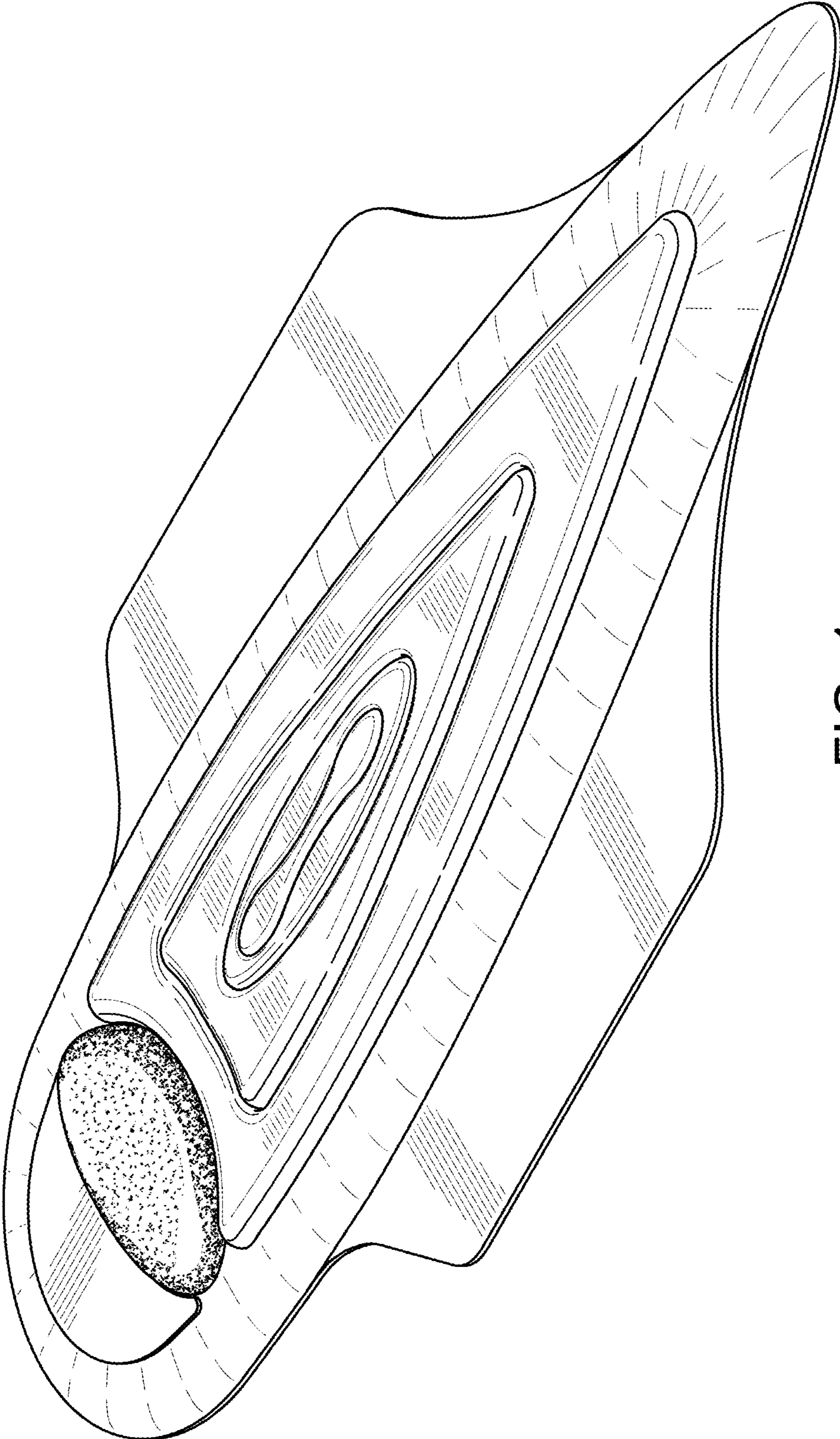

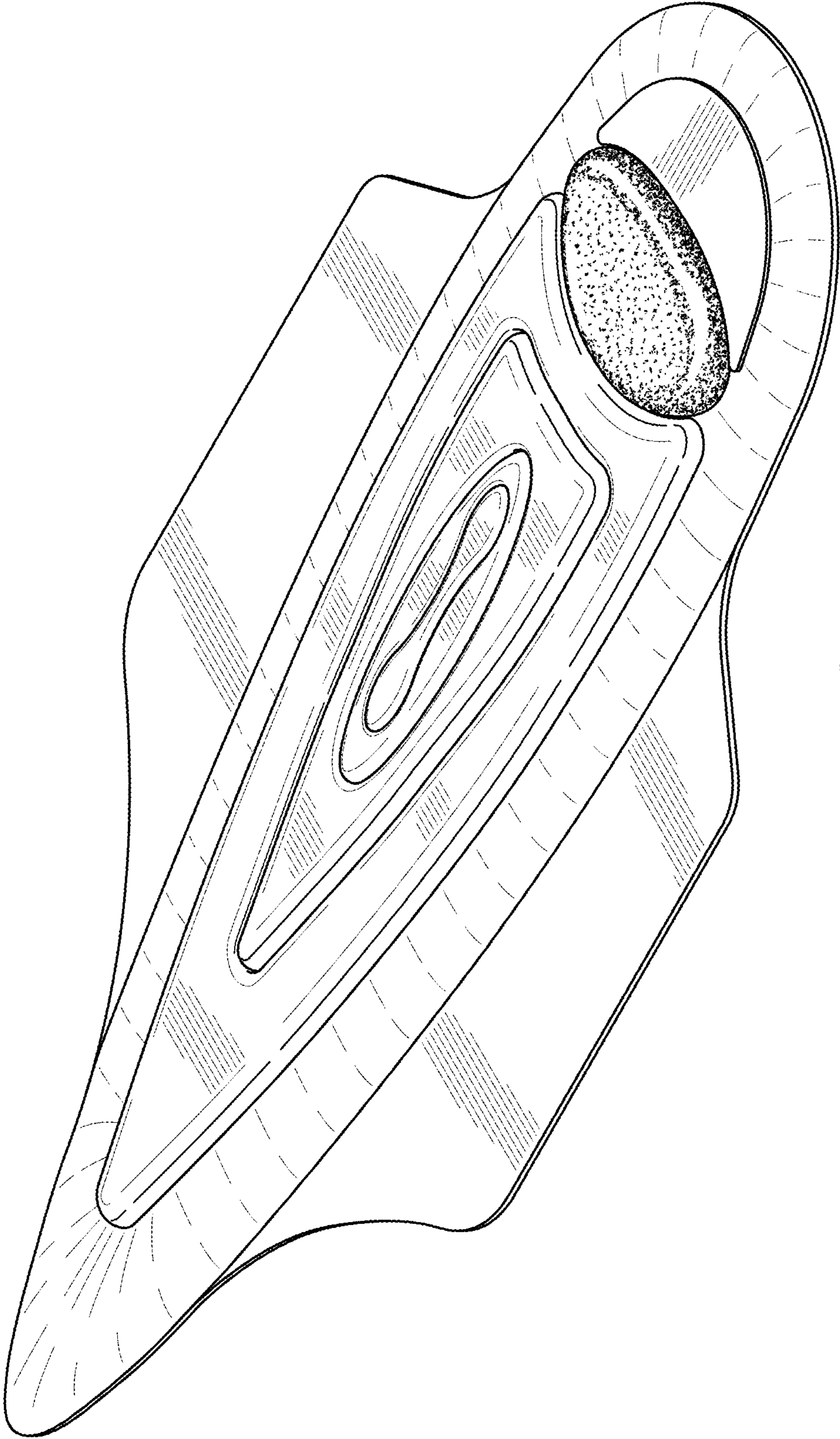

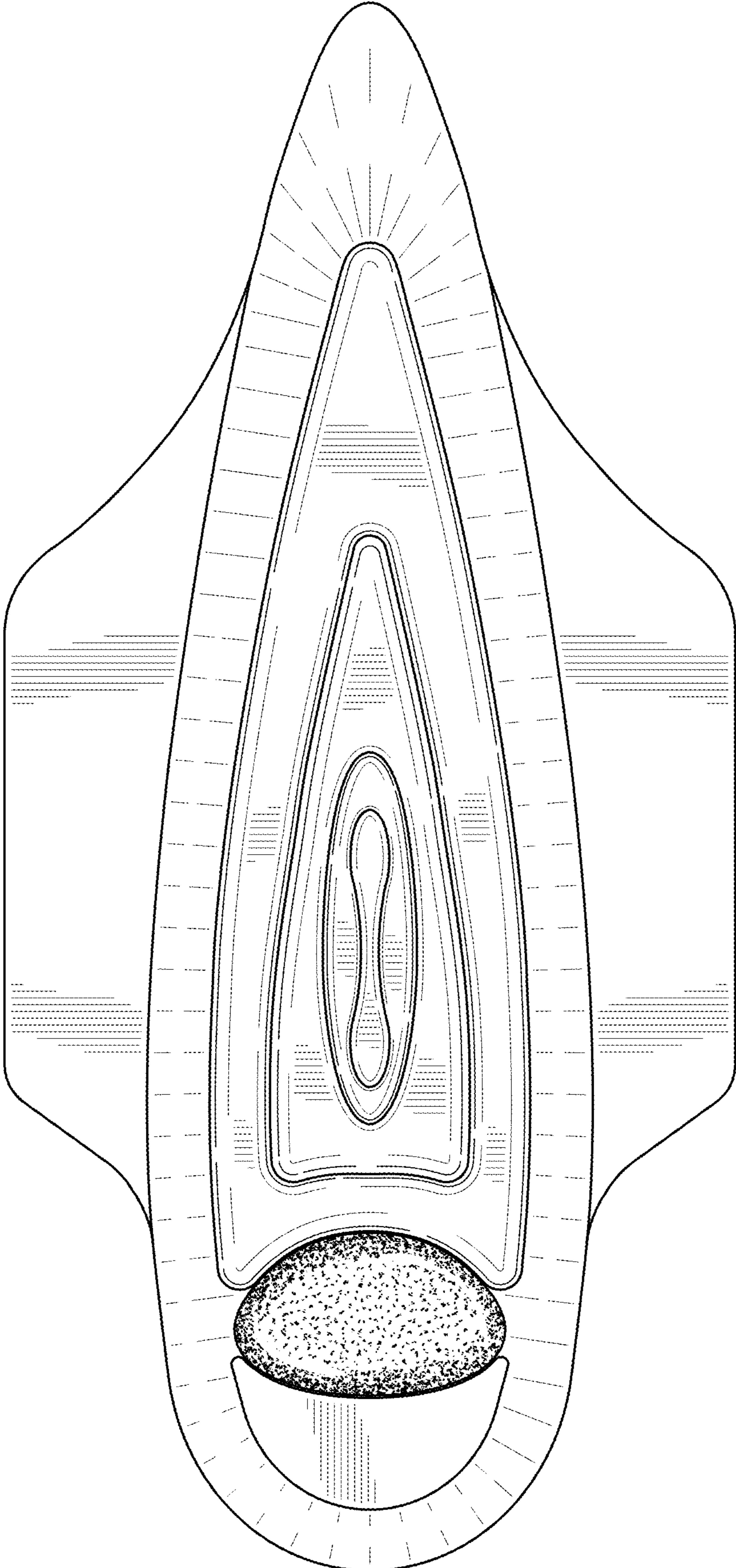

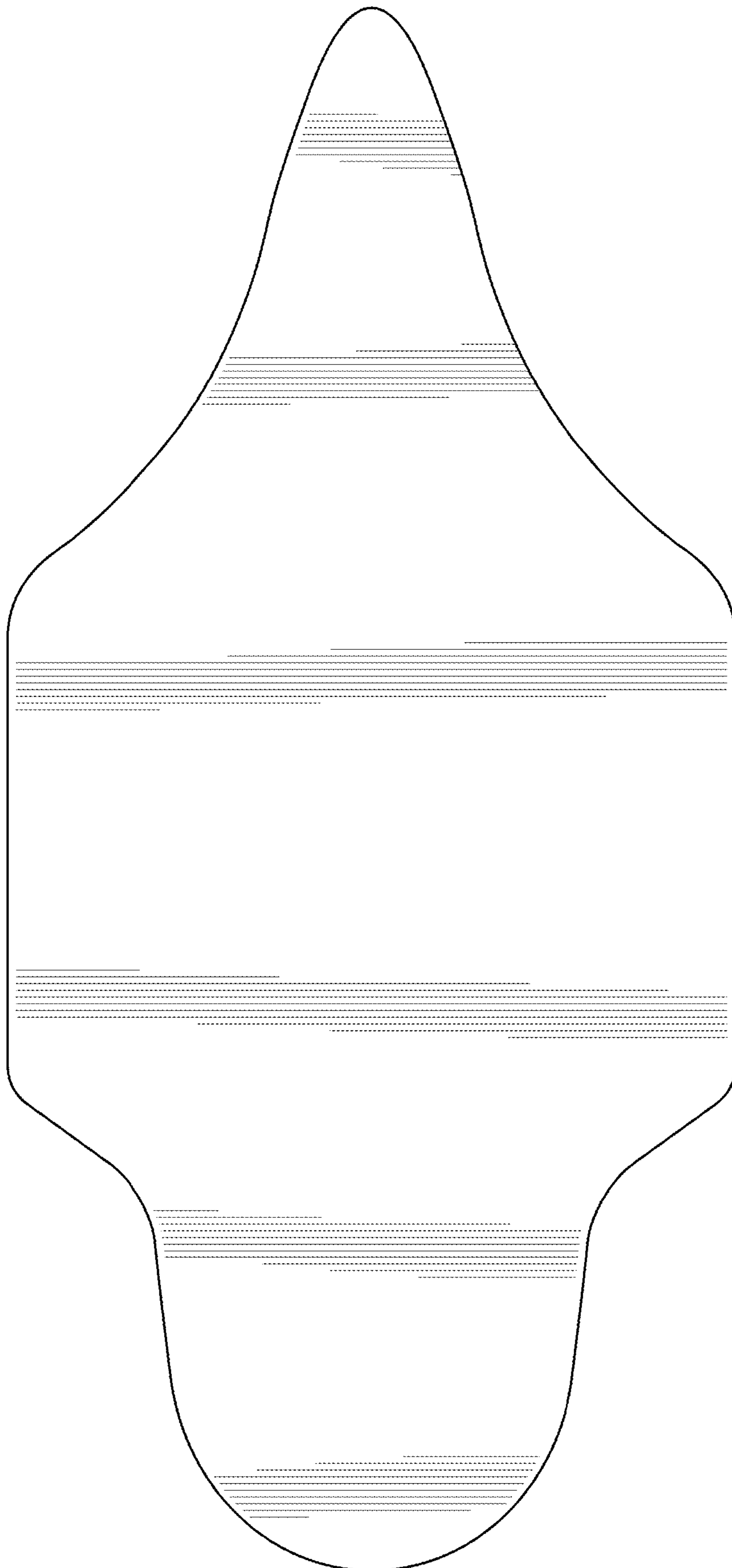

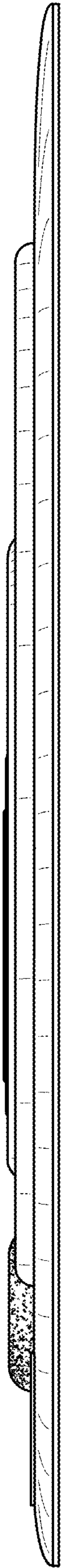

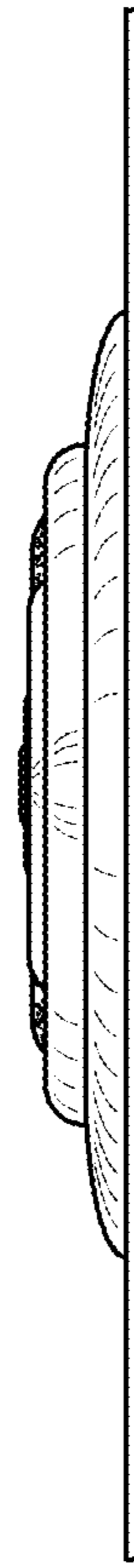
