**DESCRIPTION**

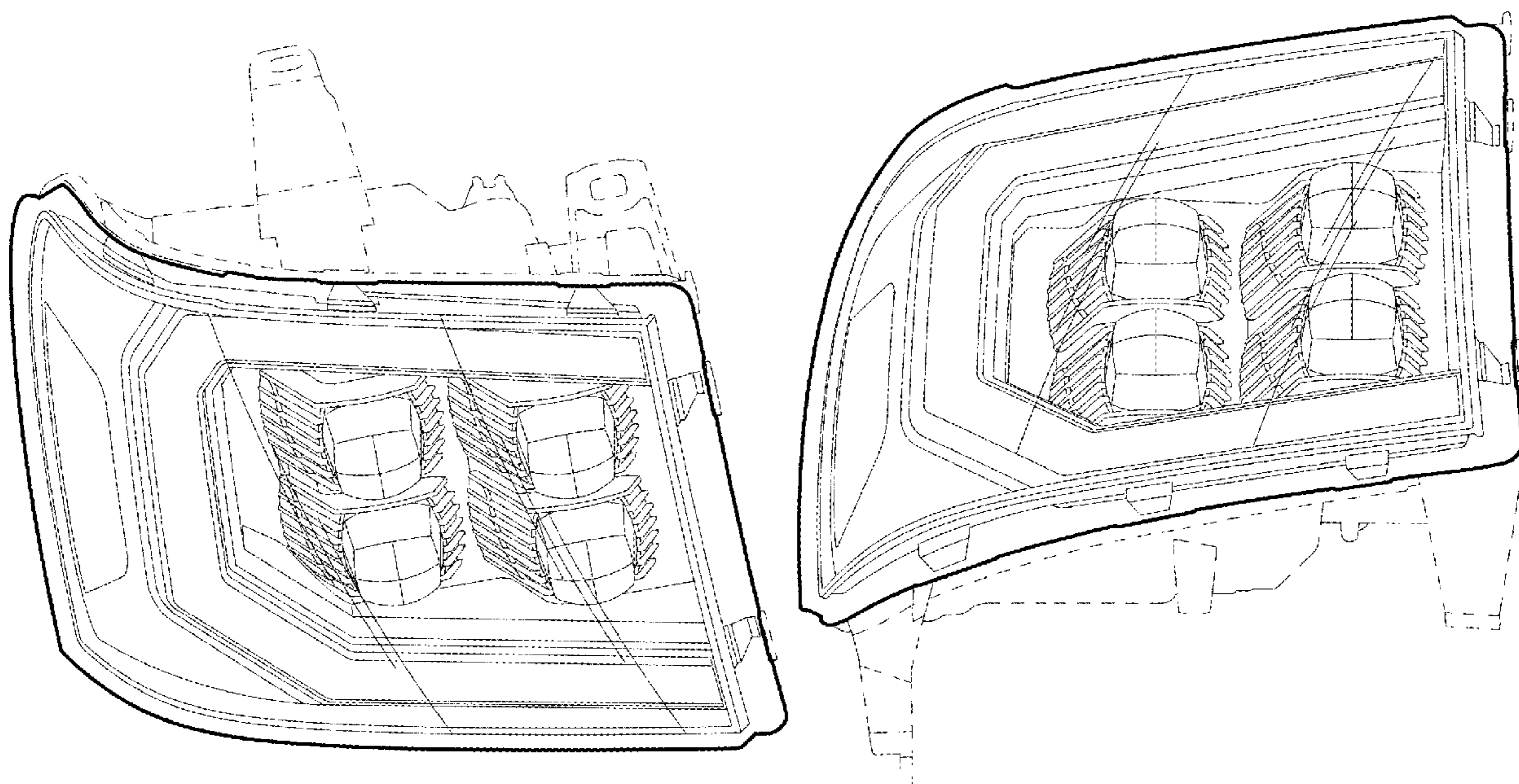
FIG. 1 is a perspective view of an exterior surface configuration of a headlight for a vehicle according to the novel design;

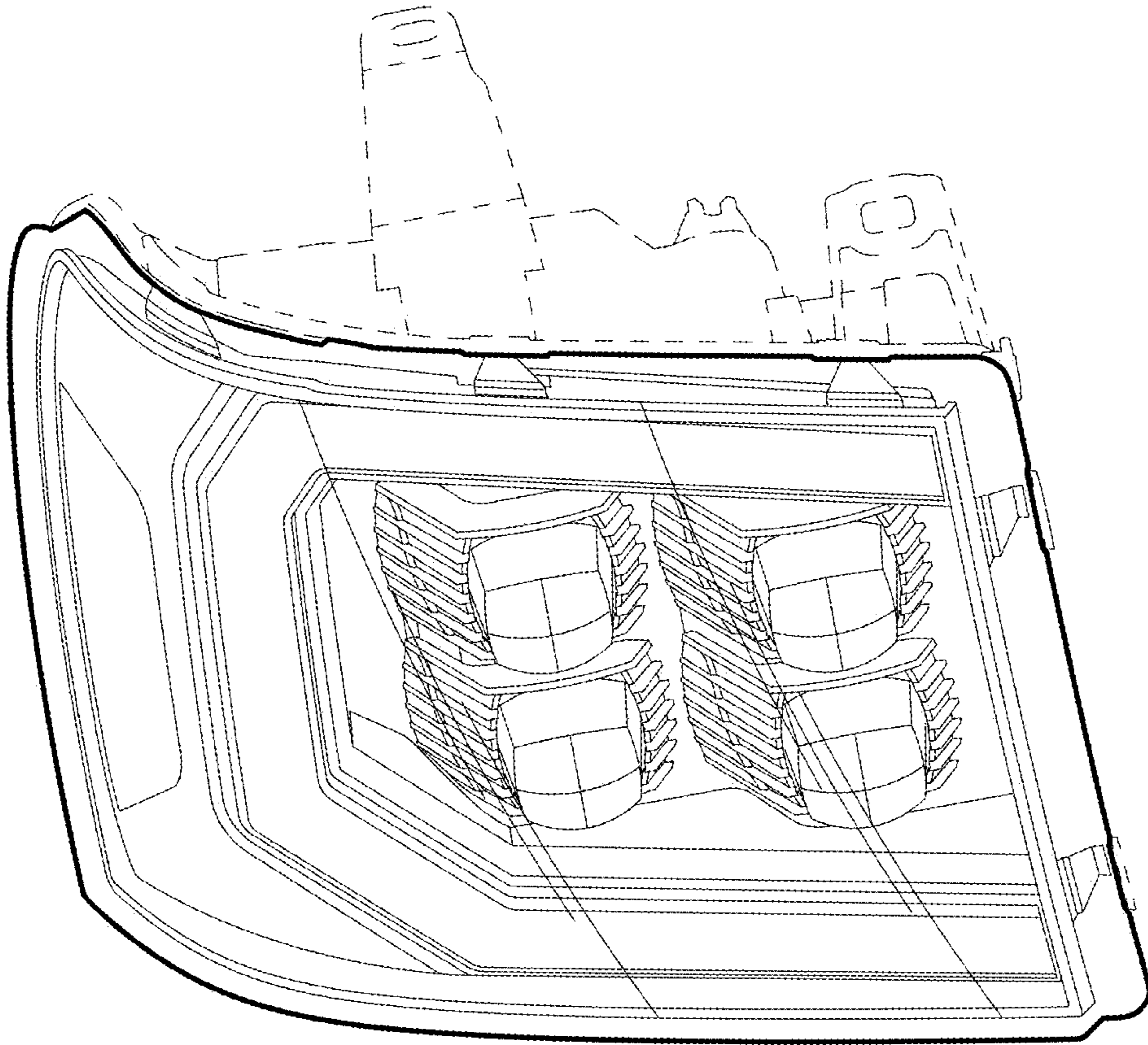

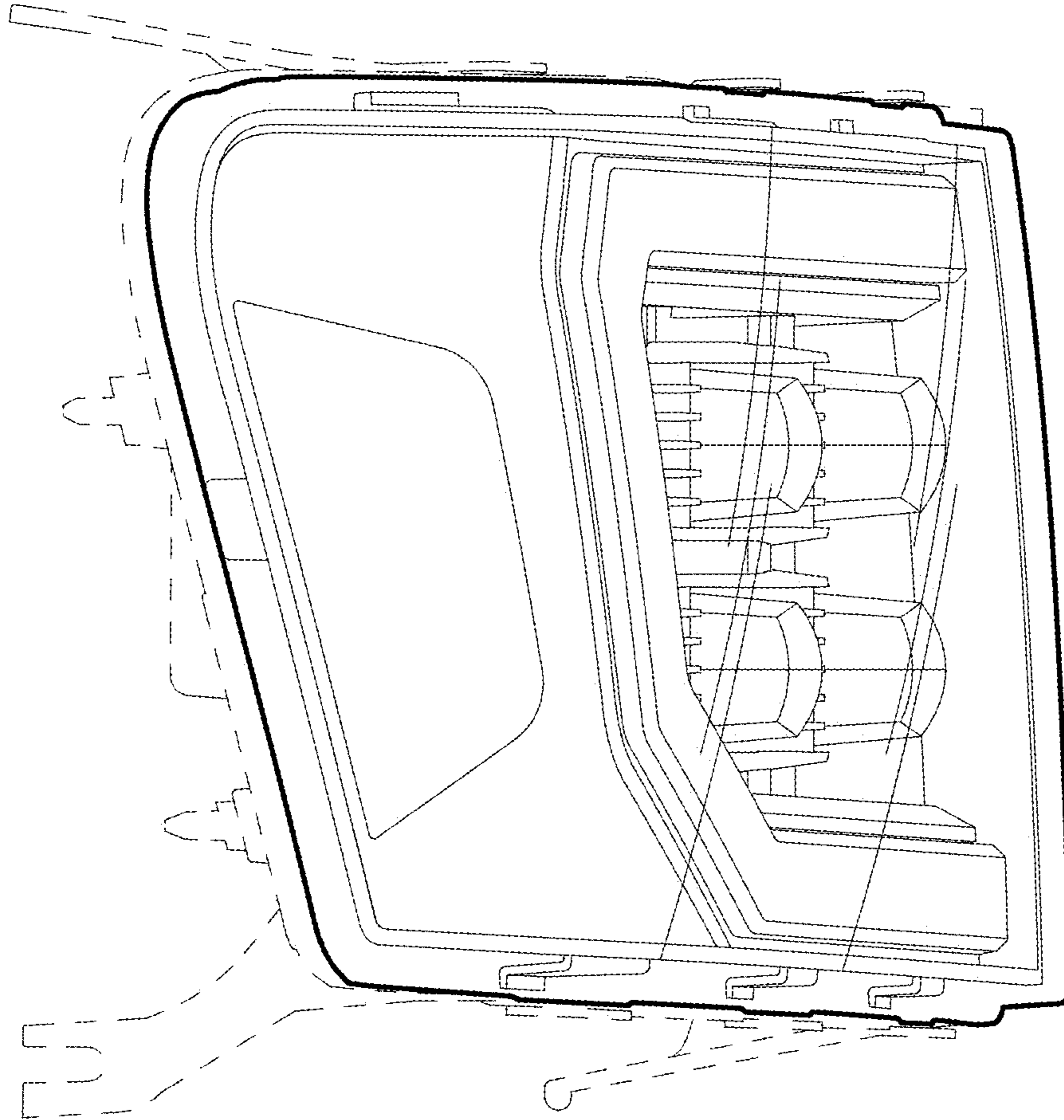
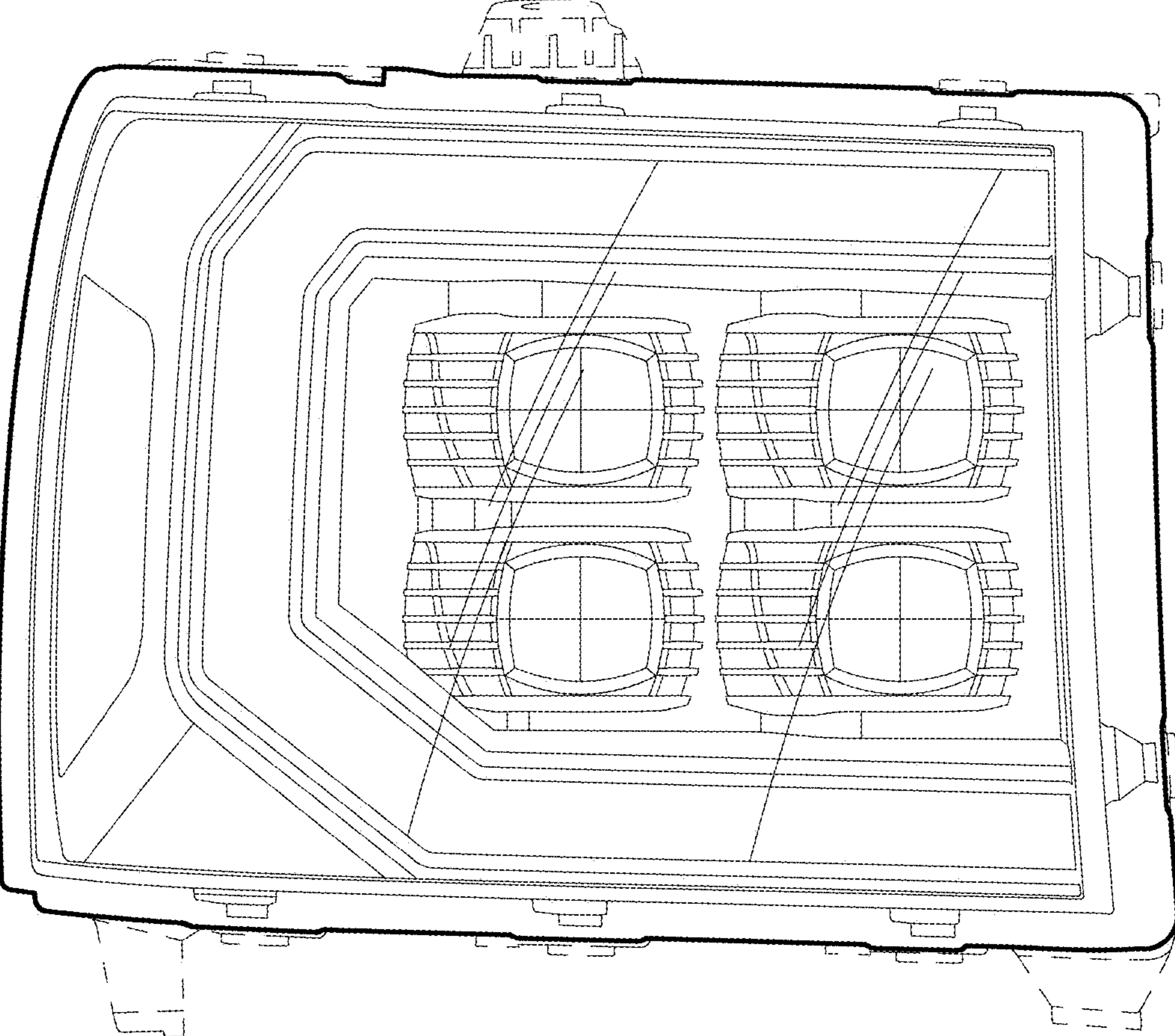

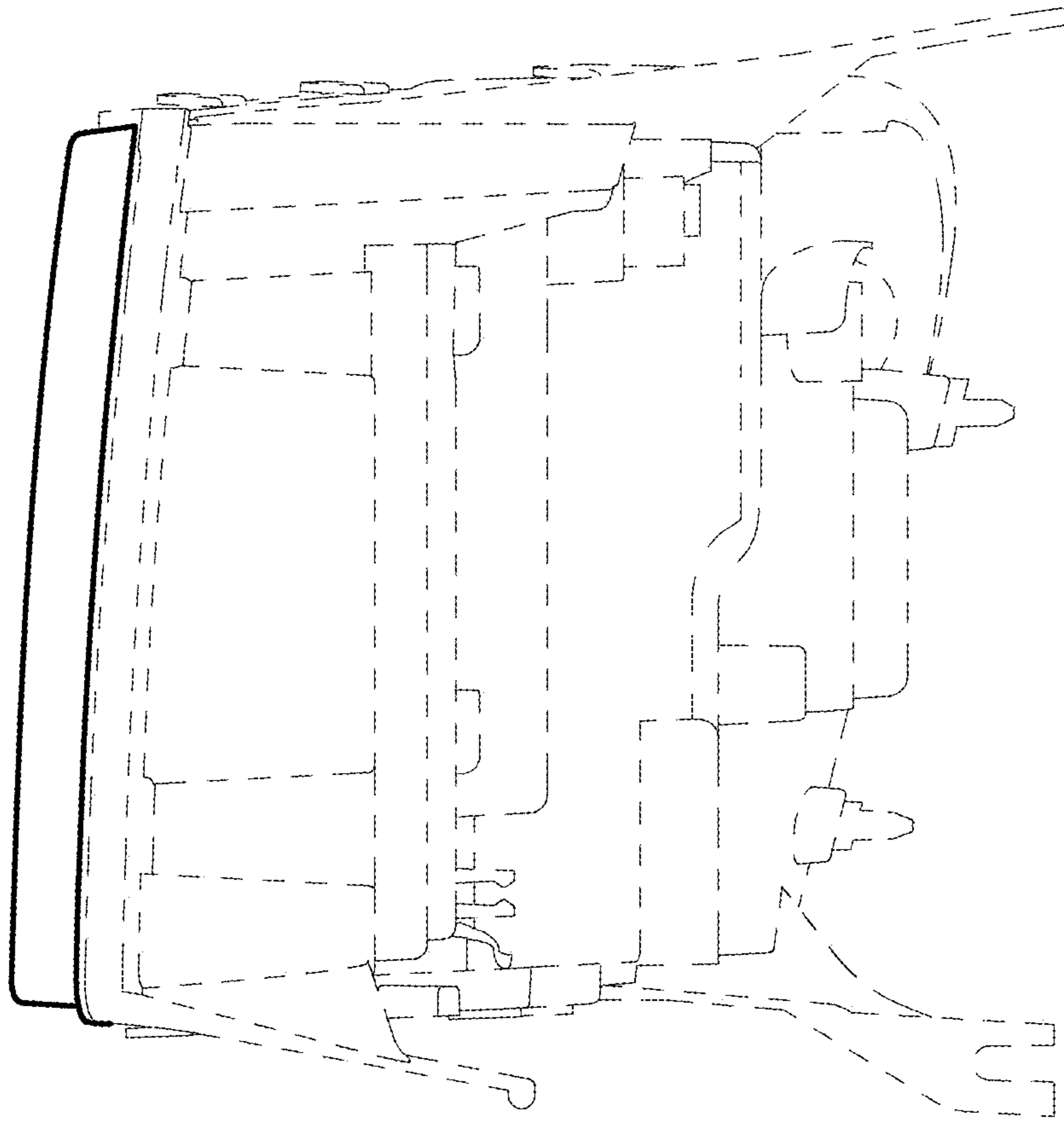

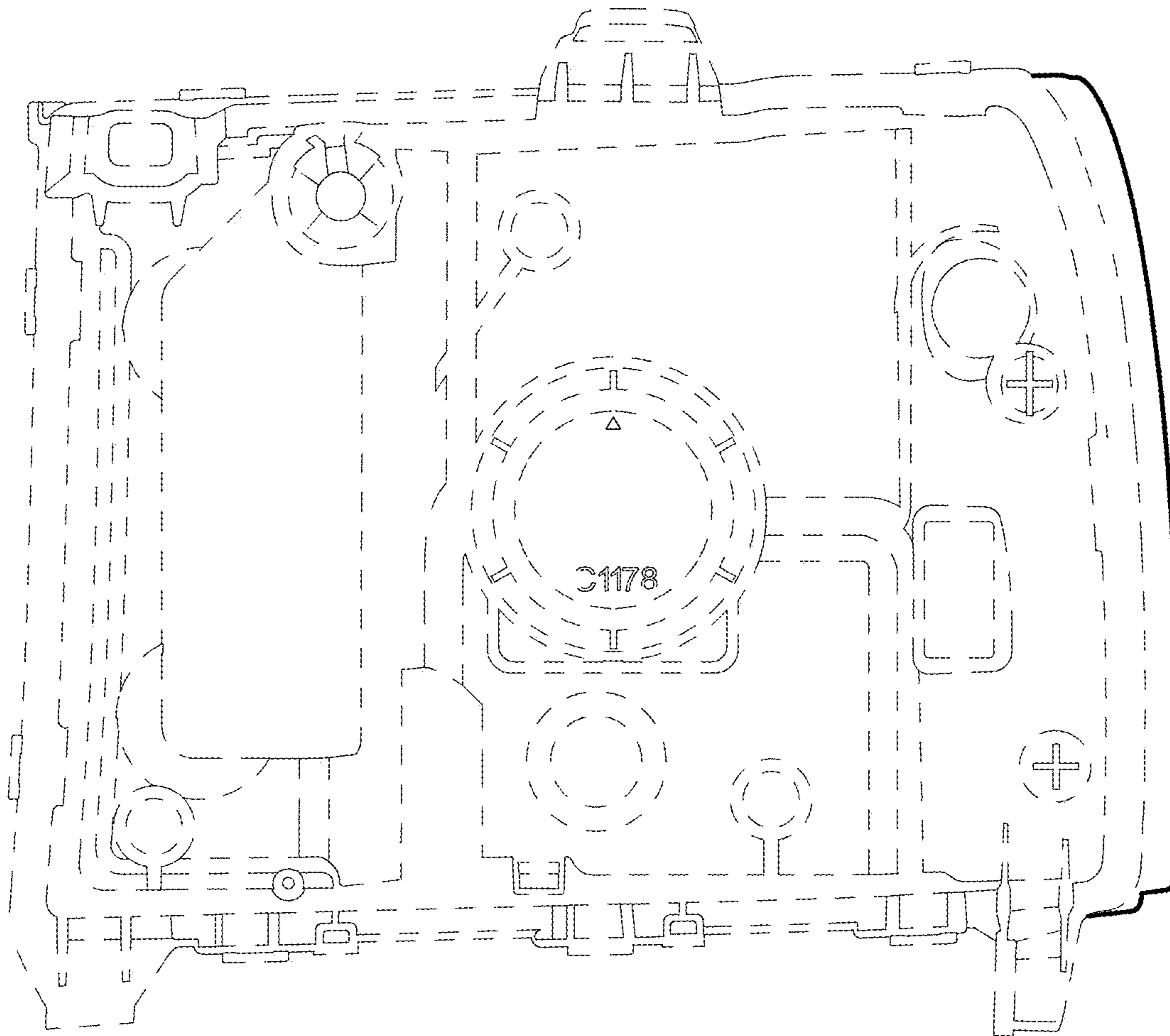
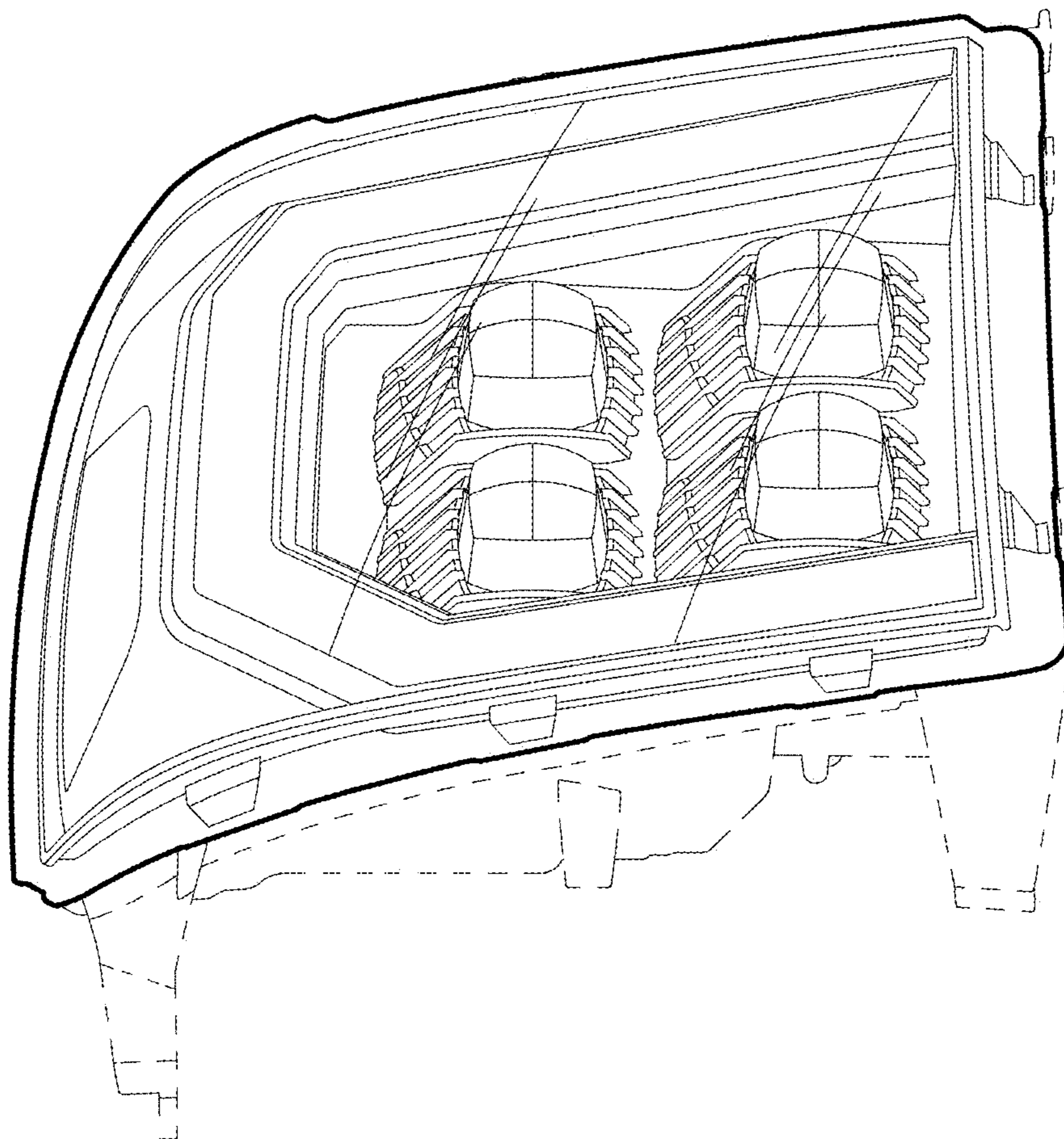
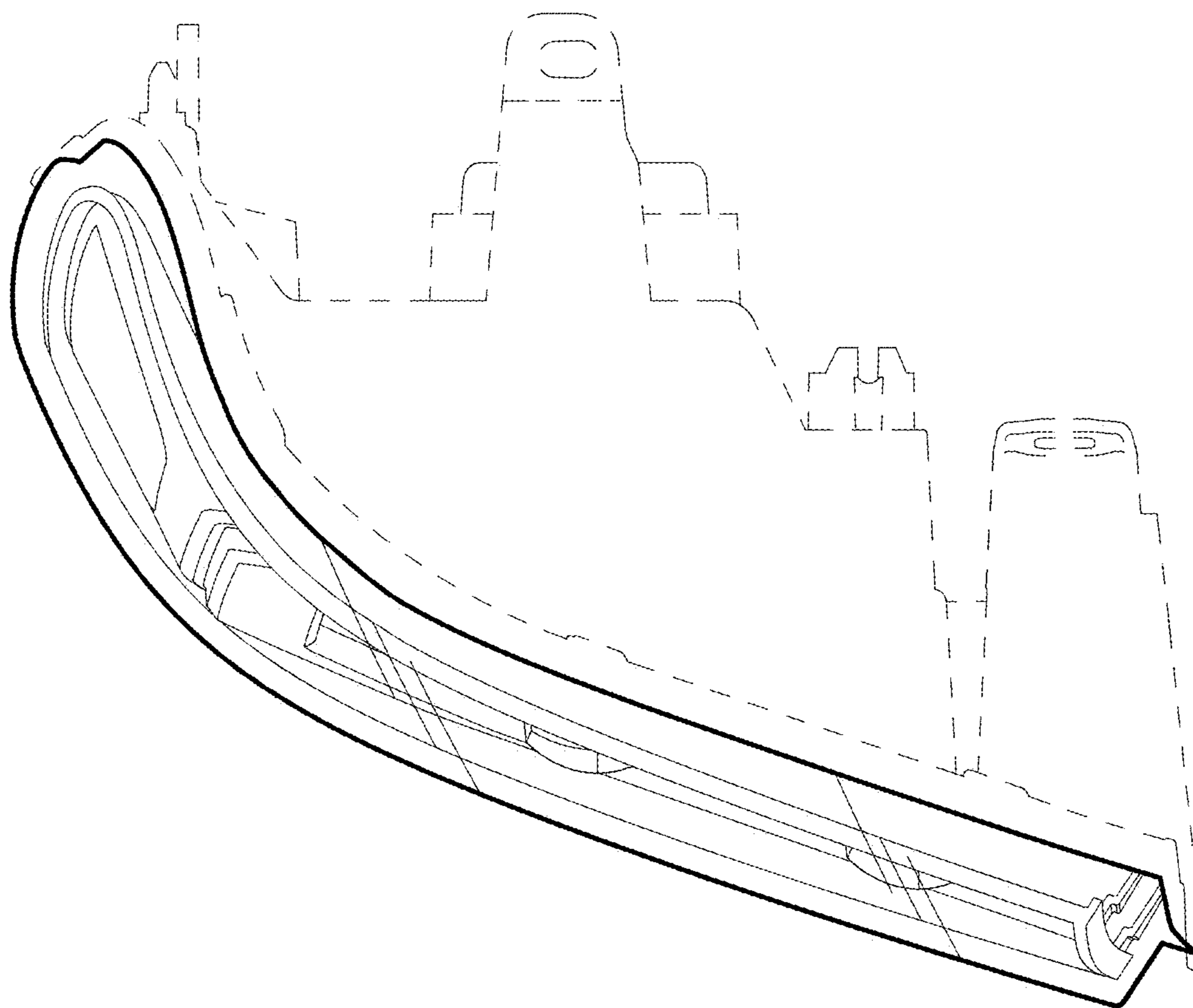
