DESCRIPTION

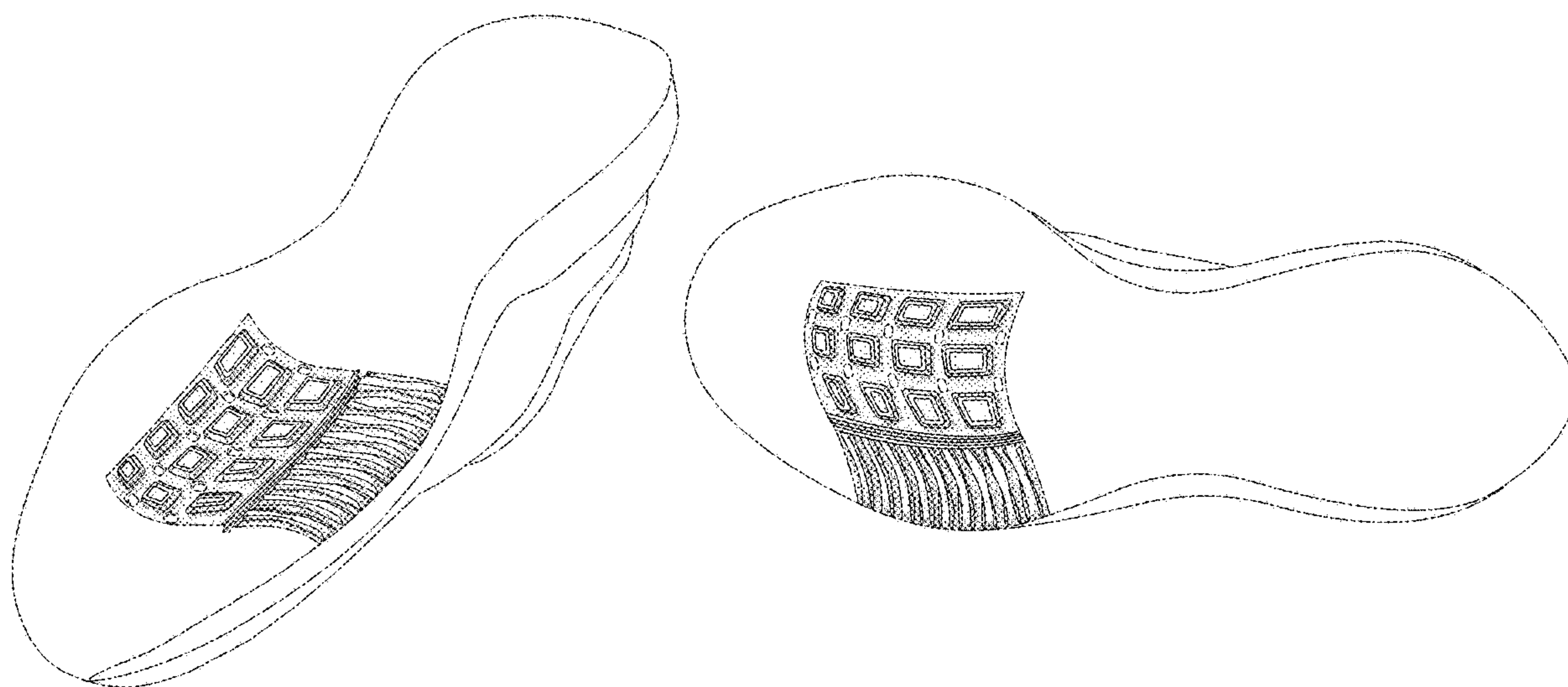
FIG. 1 is a front perspective view of a shoe showing my new design;

The broken lines showing of the eight race-track shaped elements form no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.

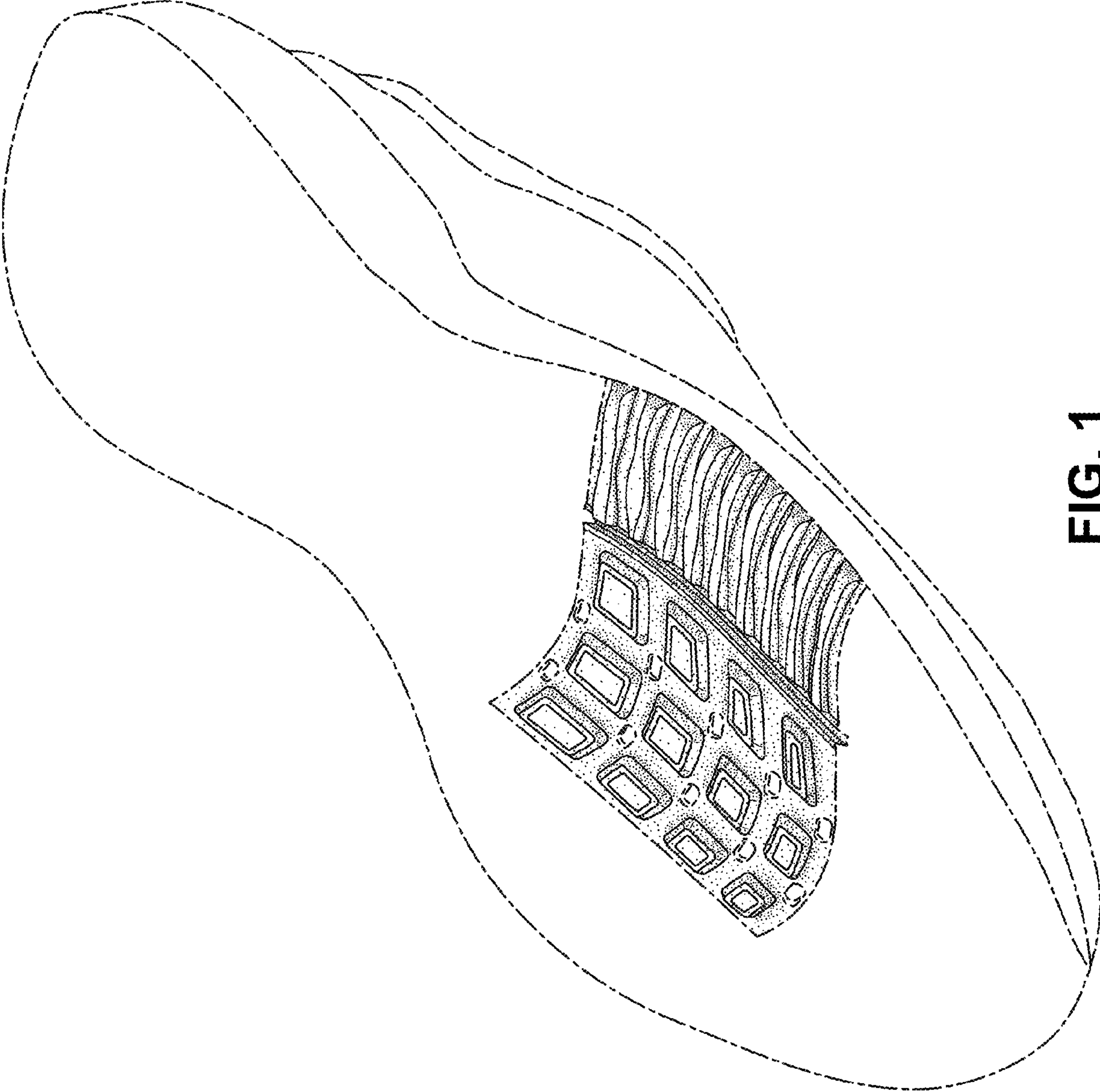

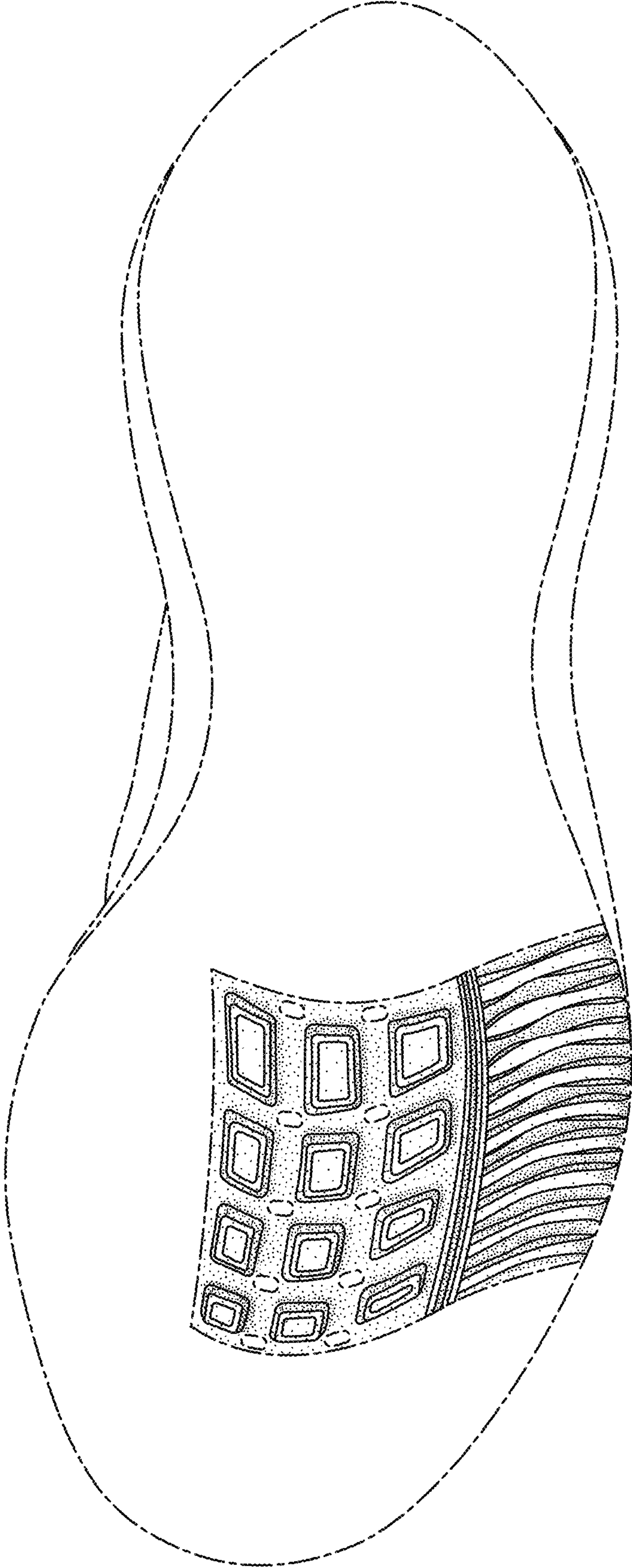

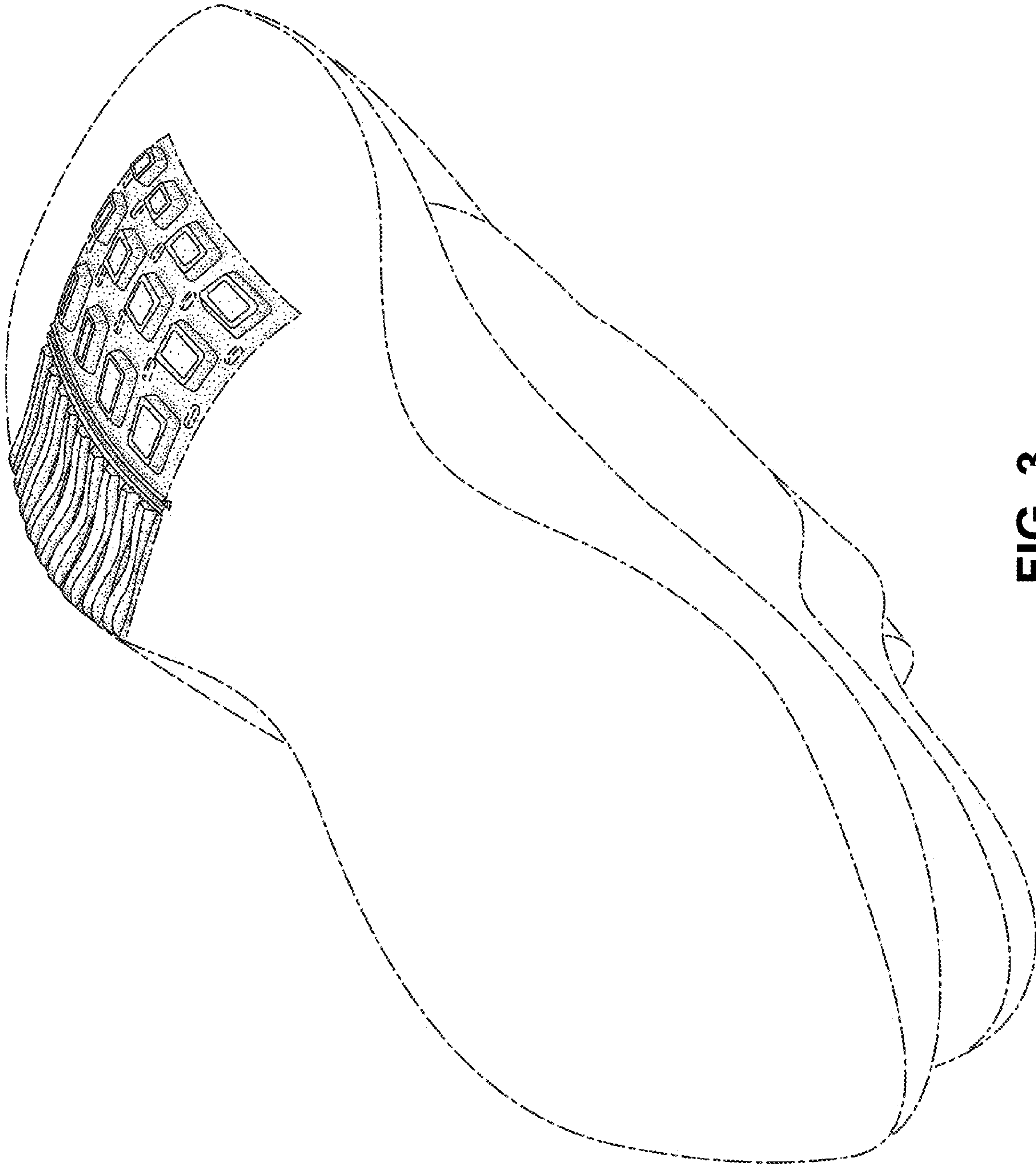
