(57) **CLAIM**

I claim the ornamental design for a backpack, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of a backpack showing my new design;

FIG. 2 is Front-side view of the backpack as shown in FIG. 1;

FIG. 3 is a Back-side view of the backpack as shown in FIG. 1;

FIG. 4 is a Left-side view of the backpack as shown in FIG. 1;

FIG. 5 is a Right-side view of the backpack as shown in FIG. 1;

FIG. 6 is a Top-side view of the backpack as shown in FIG. 1;

FIG. 7 is a Bottom-side view of the backpack as shown in FIG. 1; and,

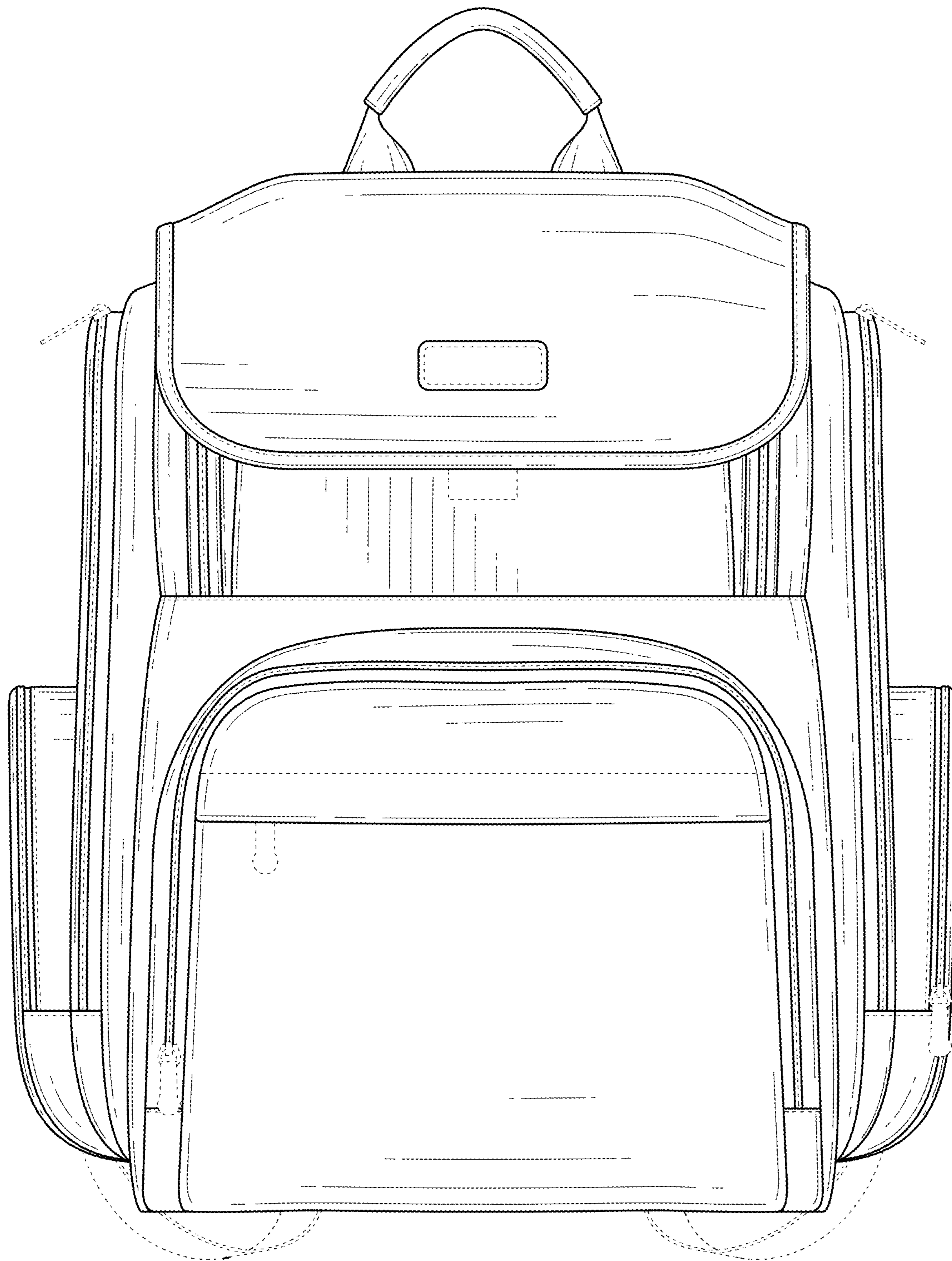

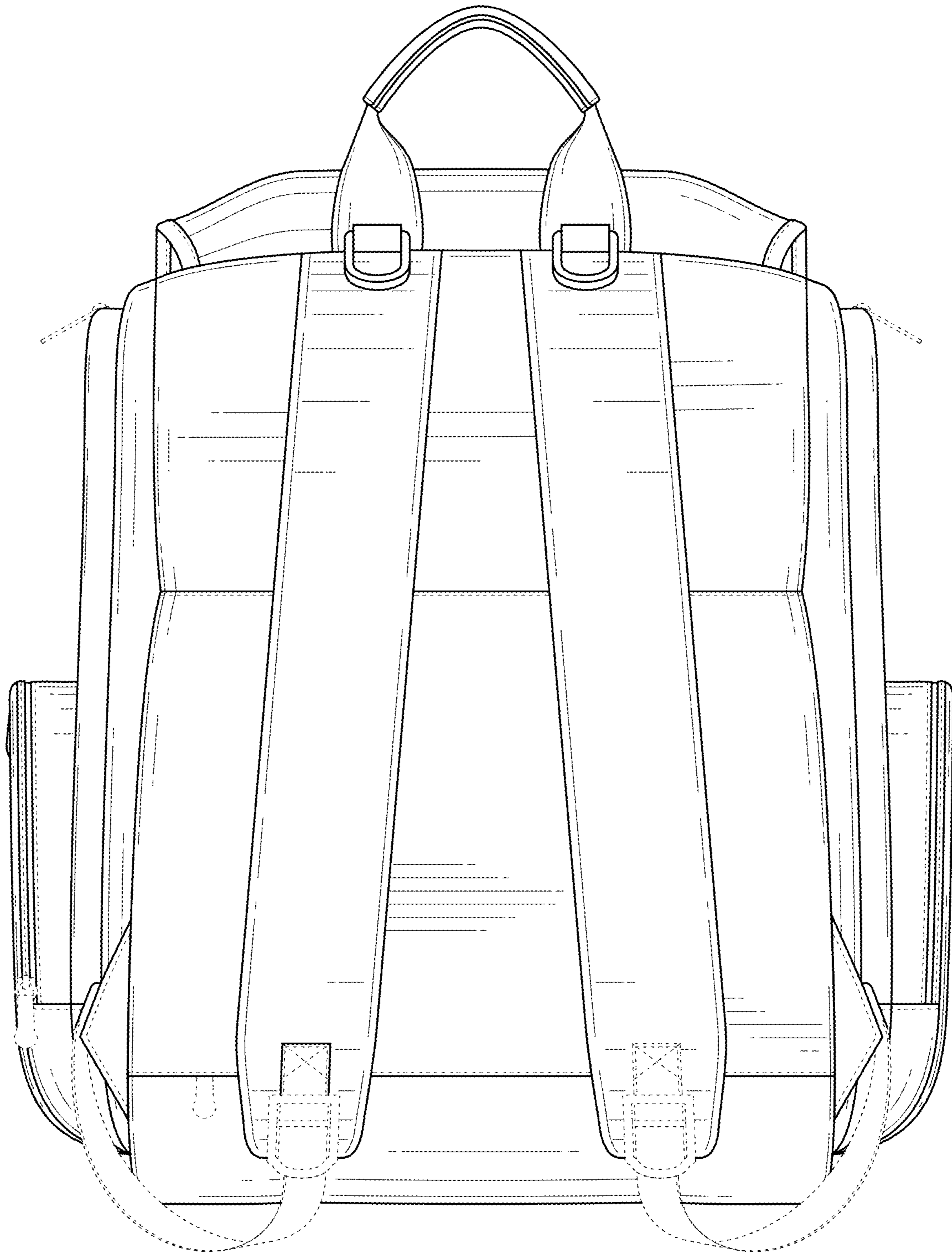

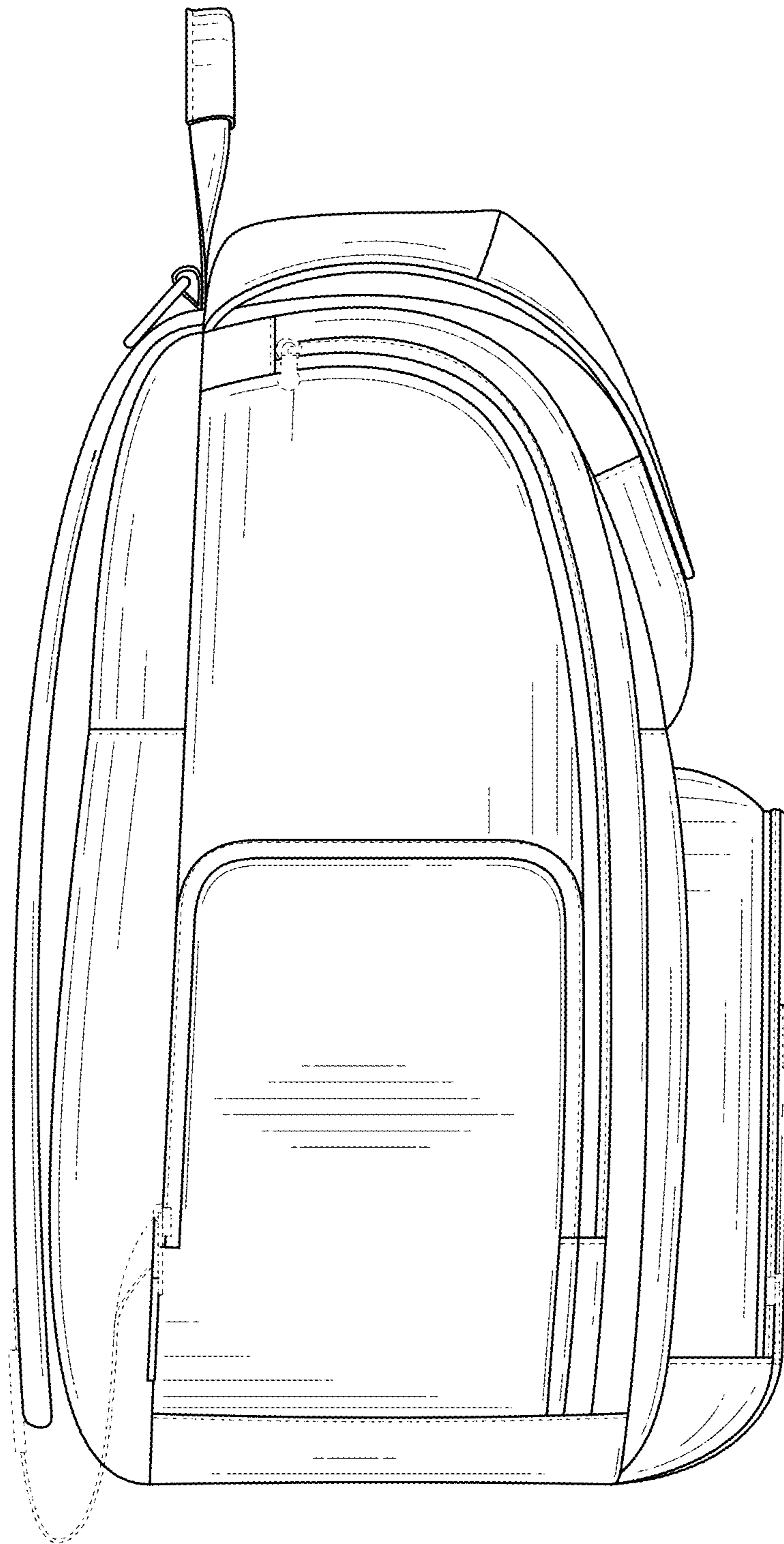

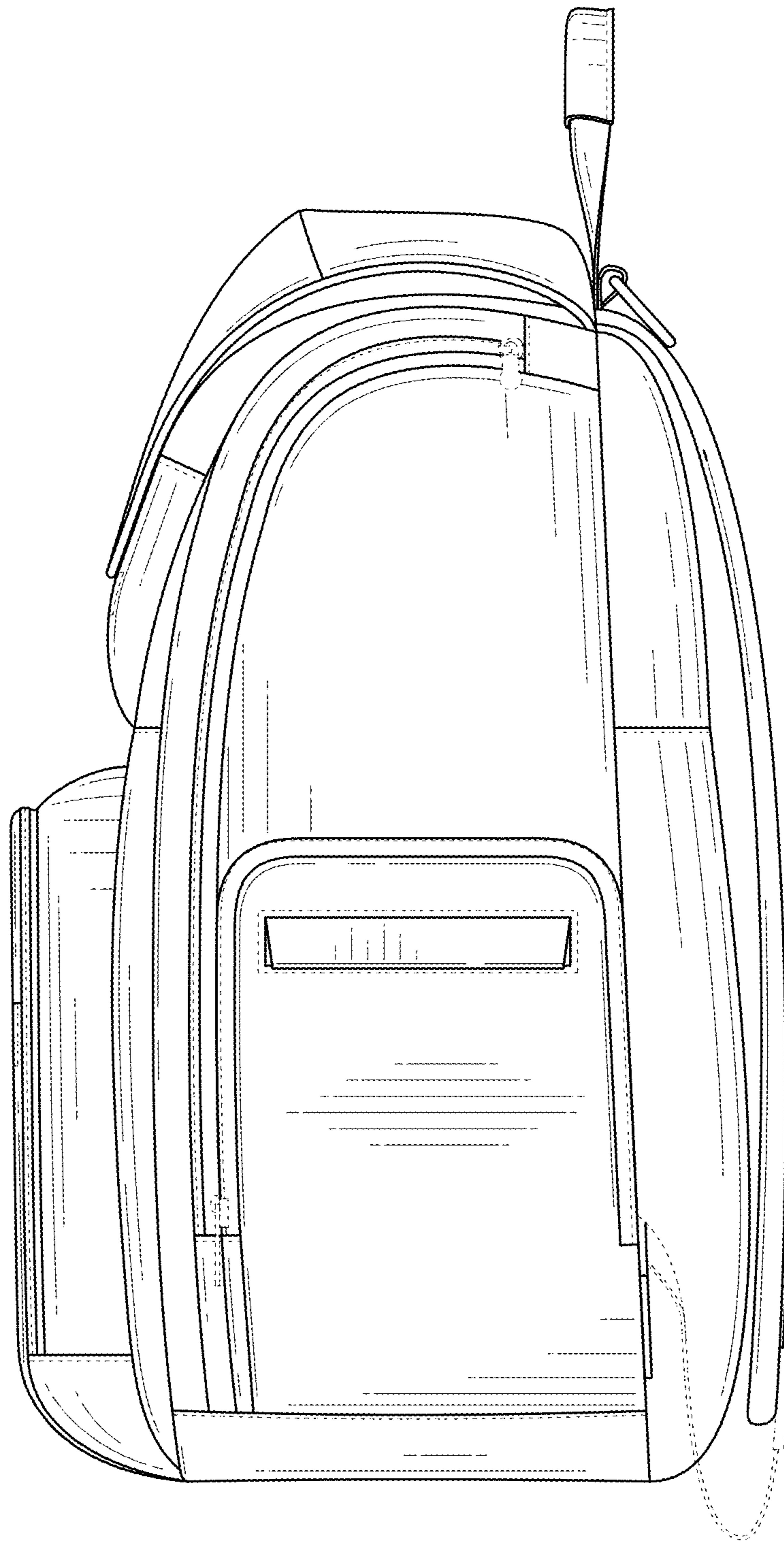

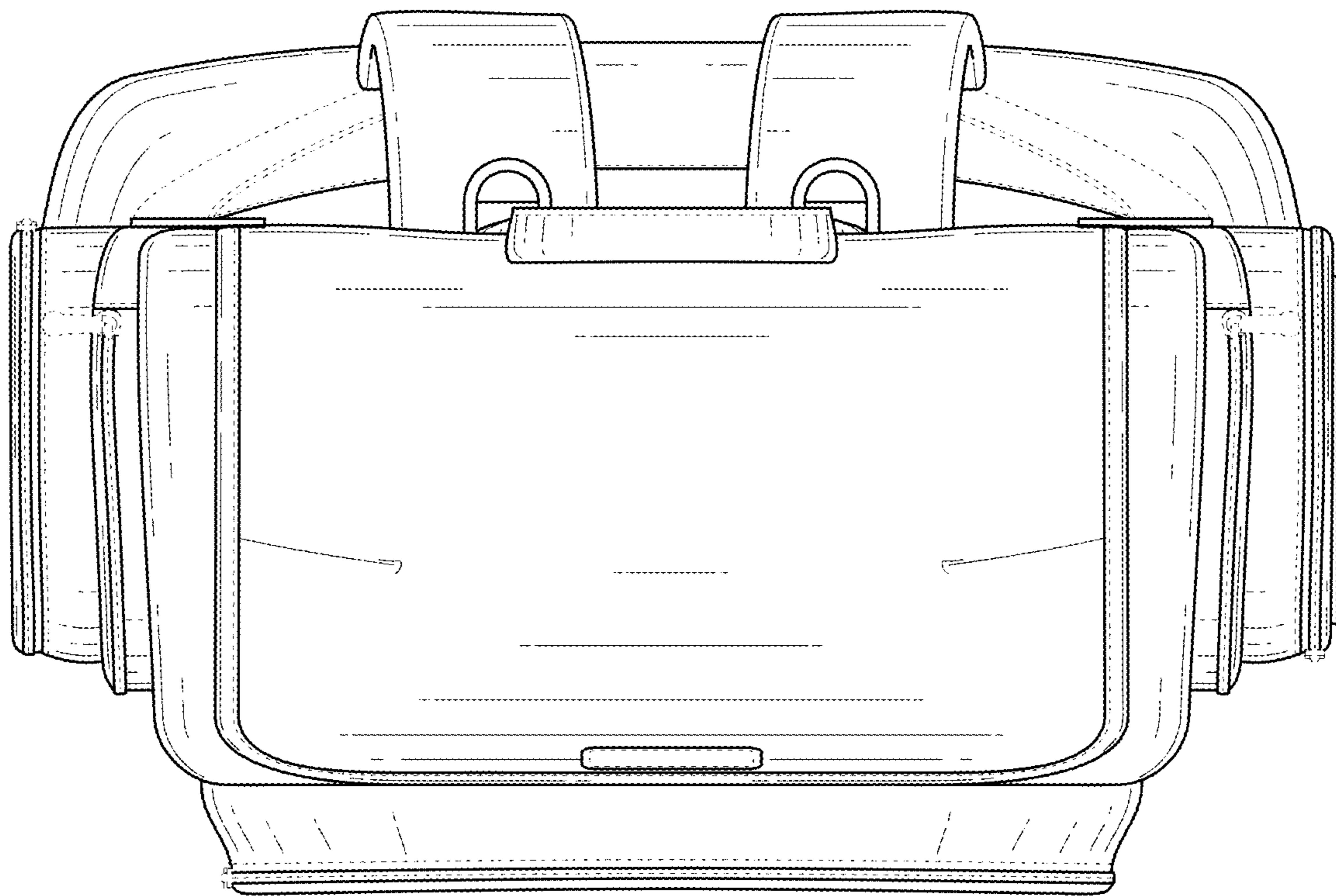

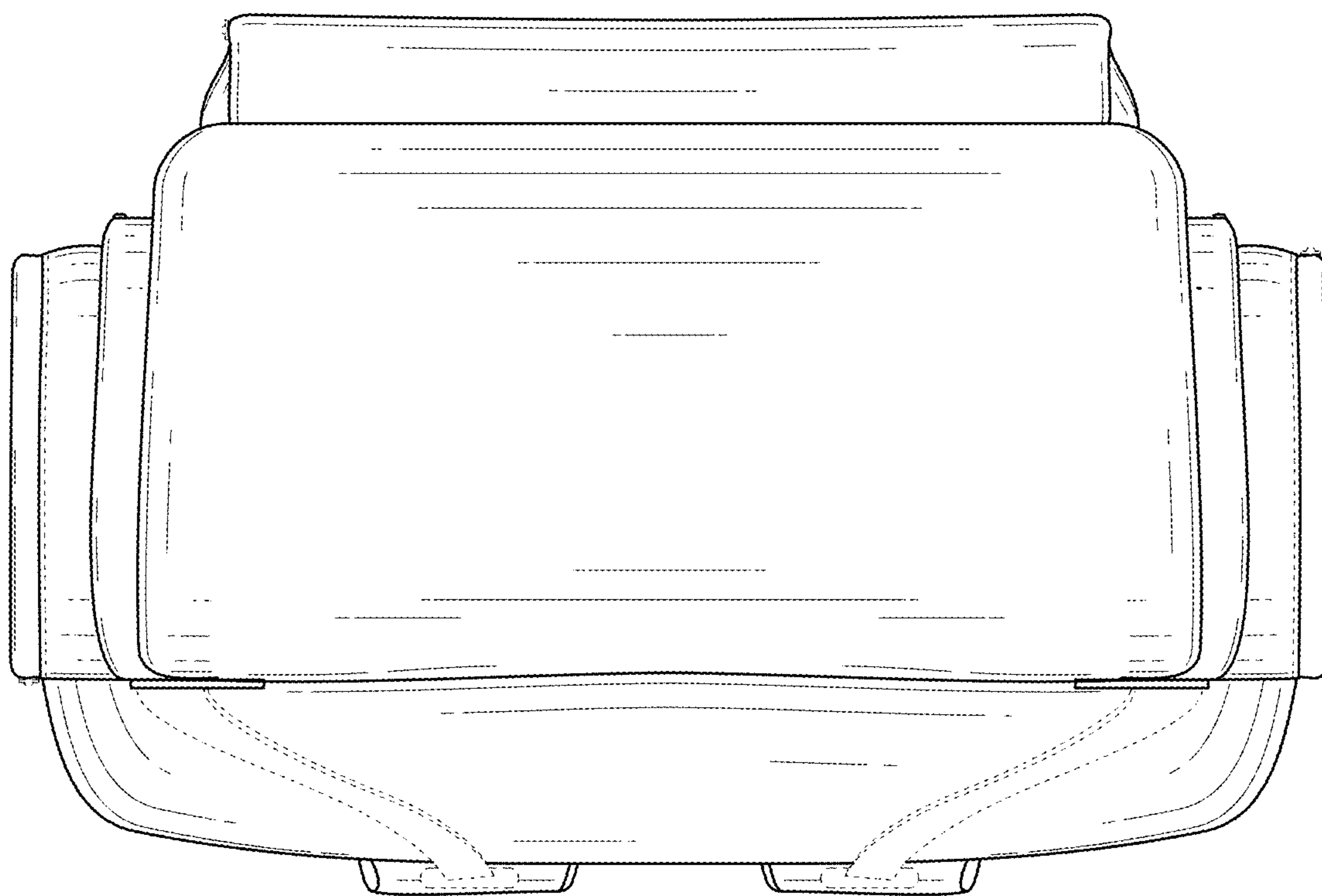
