(57) **CLAIM**

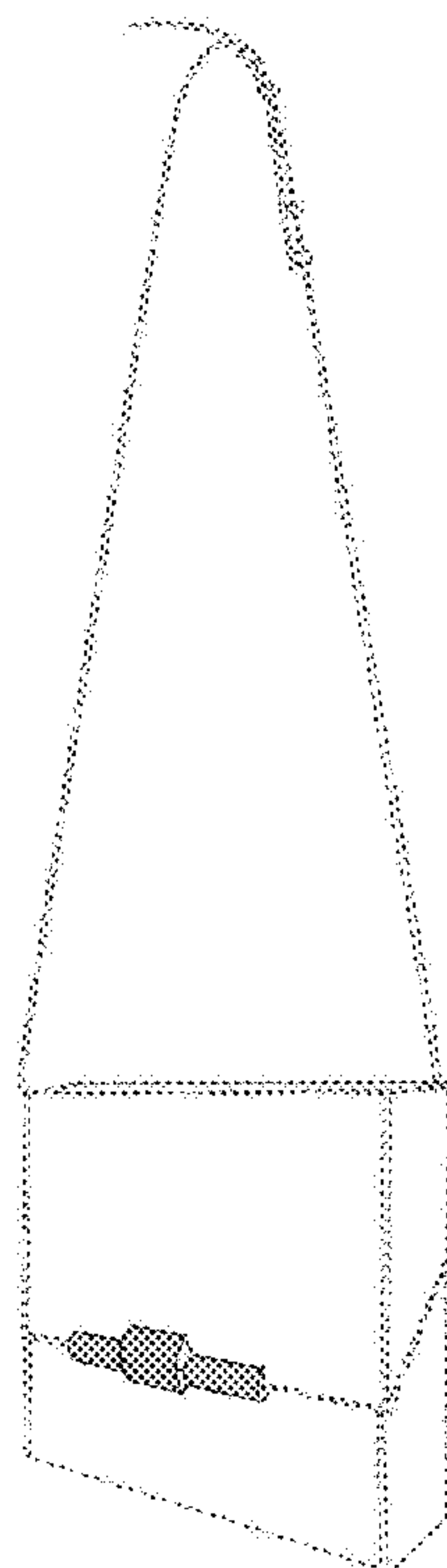
The ornamental design for clasp for handbag, as shown and described.

DESCRIPTION

FIG. 1. is a front perspective view of a clasp for handbag showing my new design;
FIG. 2 is a front view thereof;

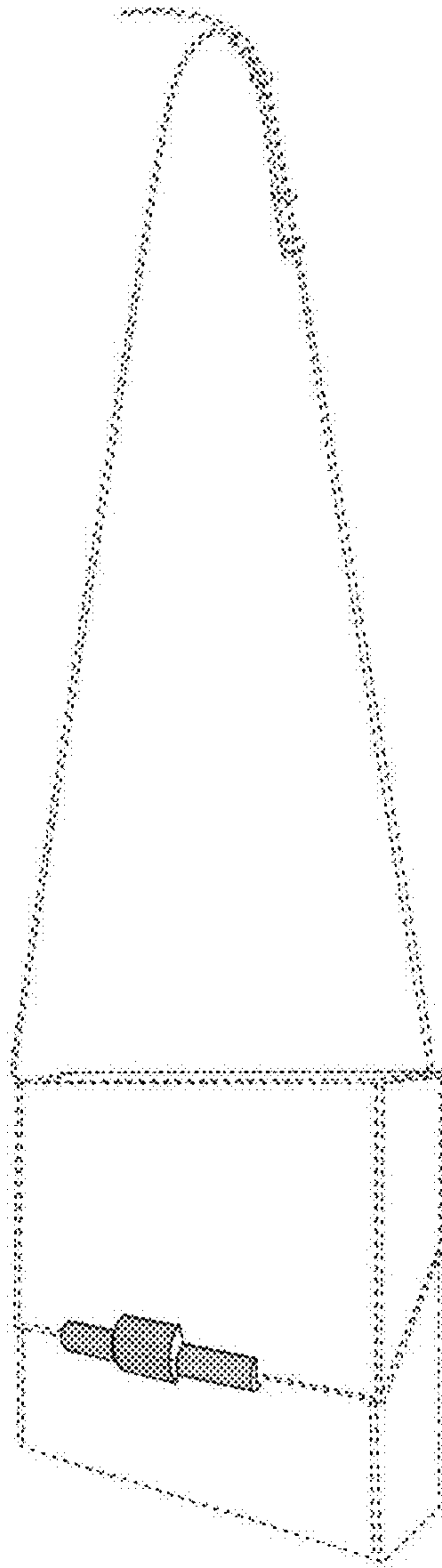

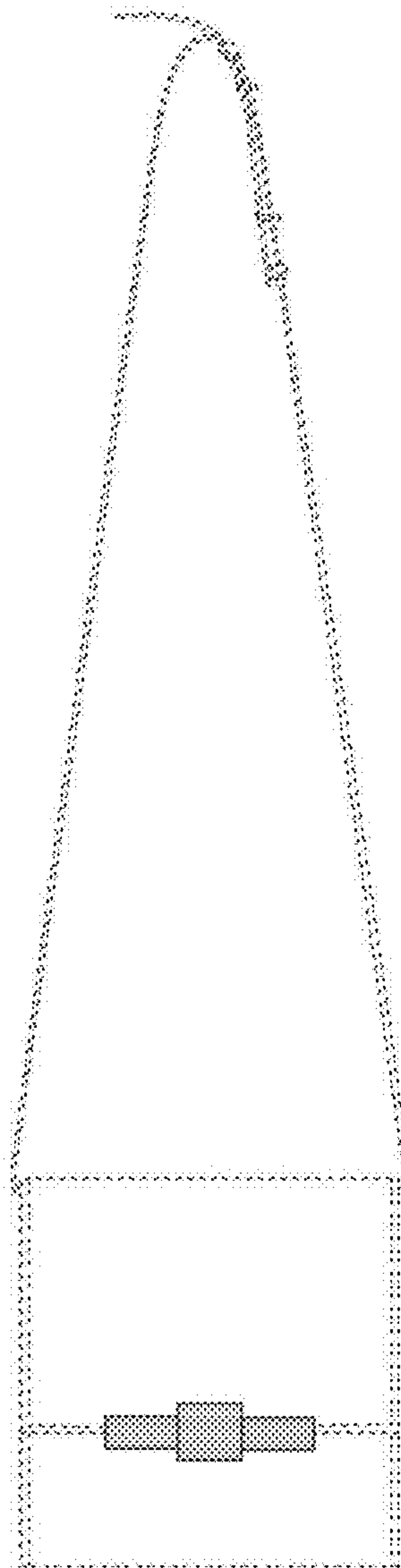

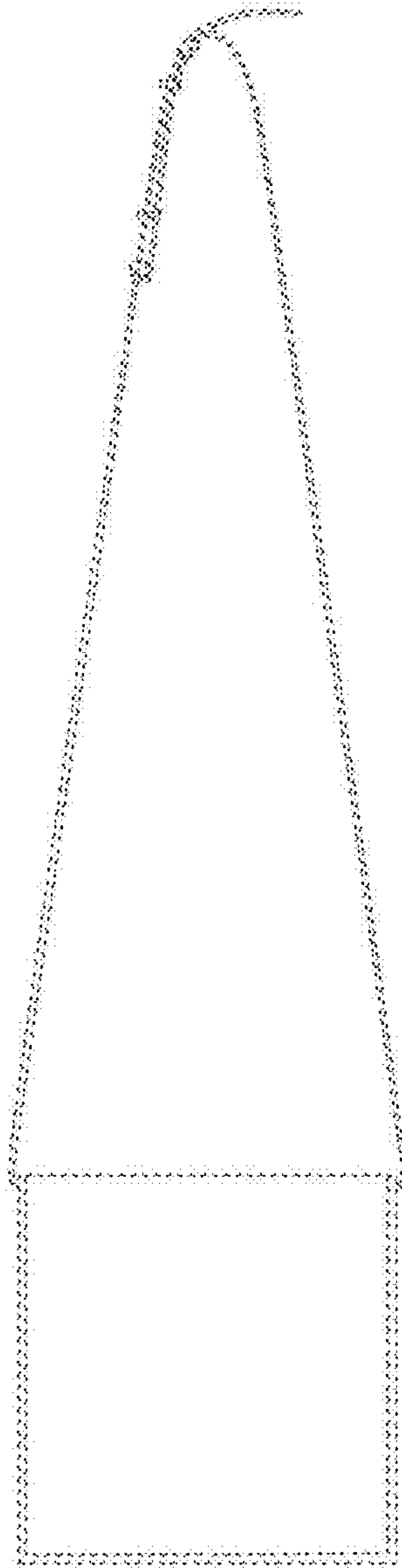

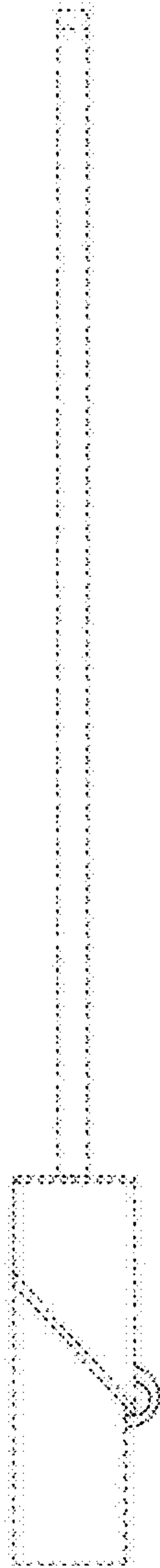

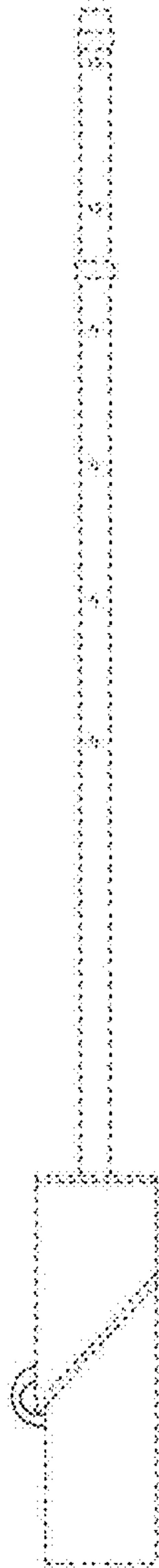

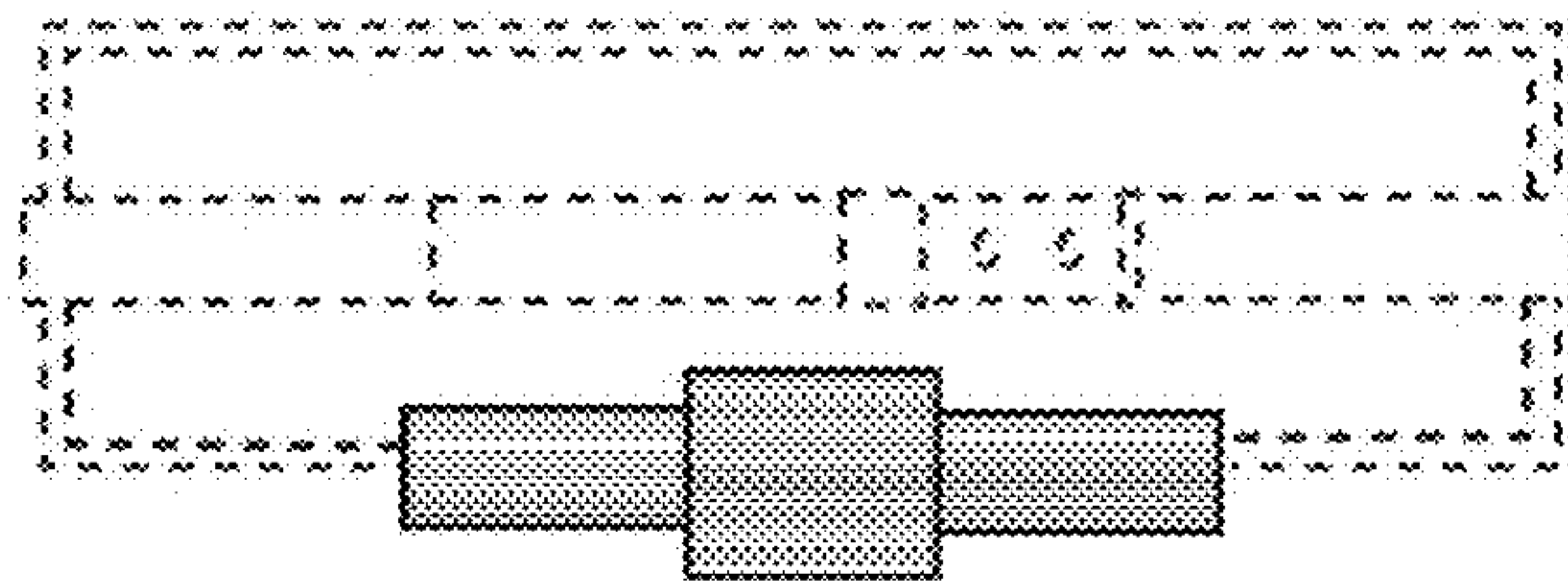

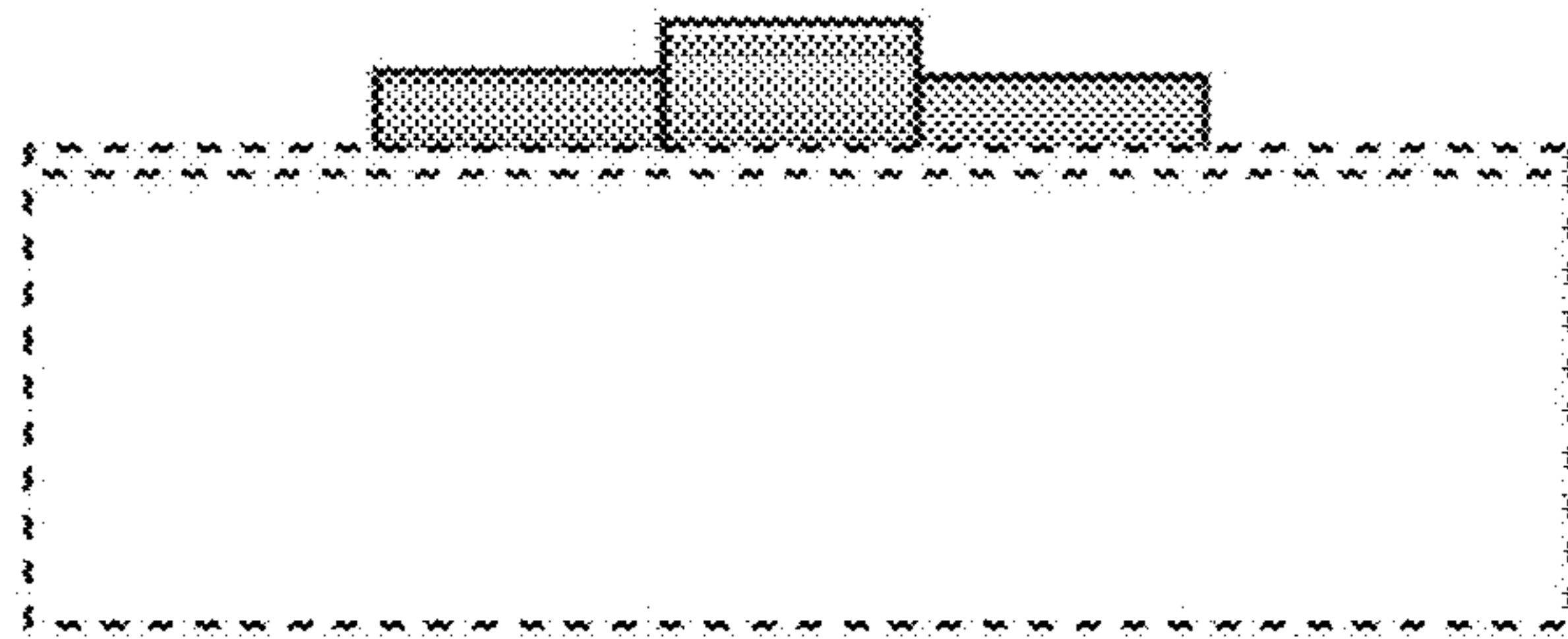
