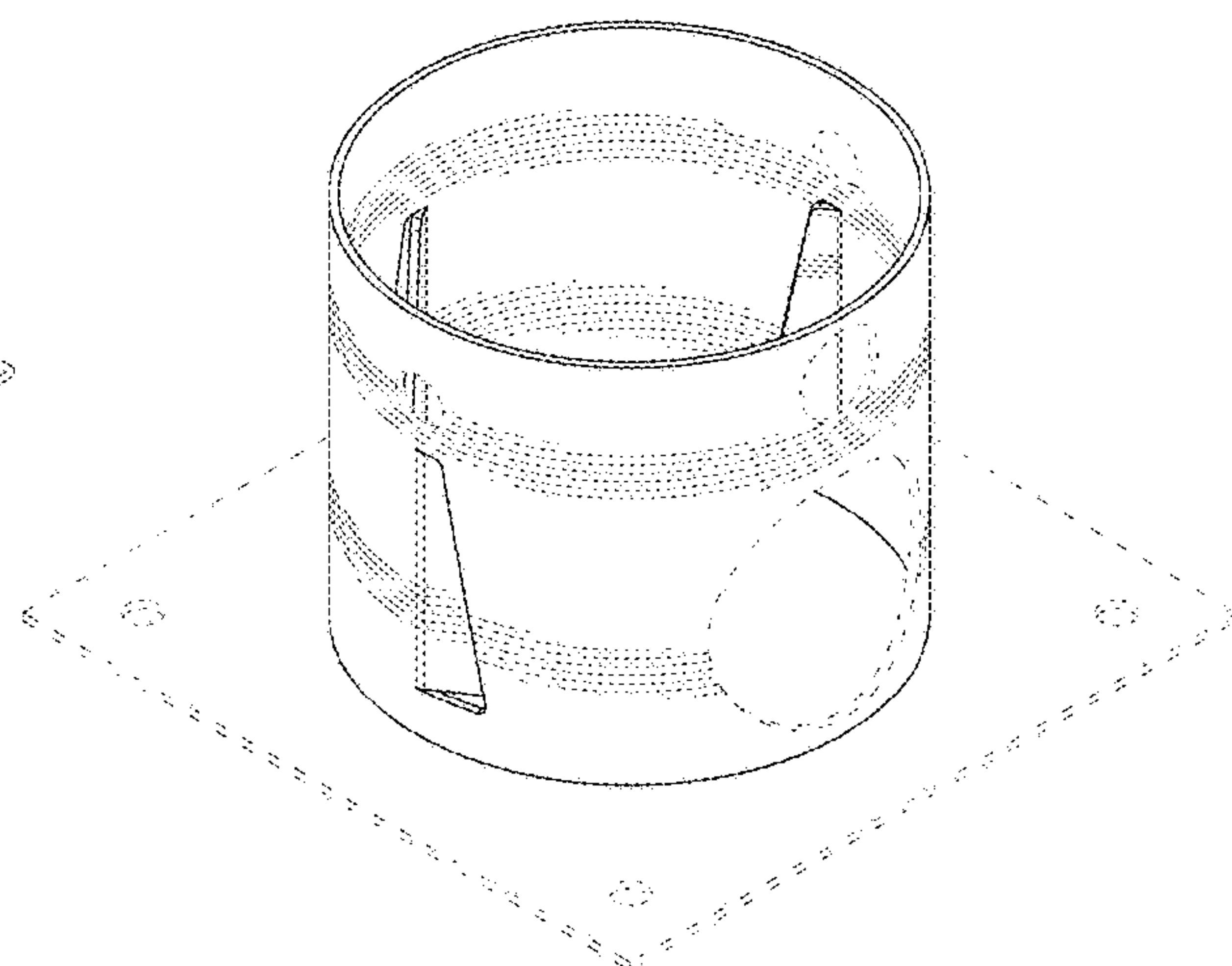
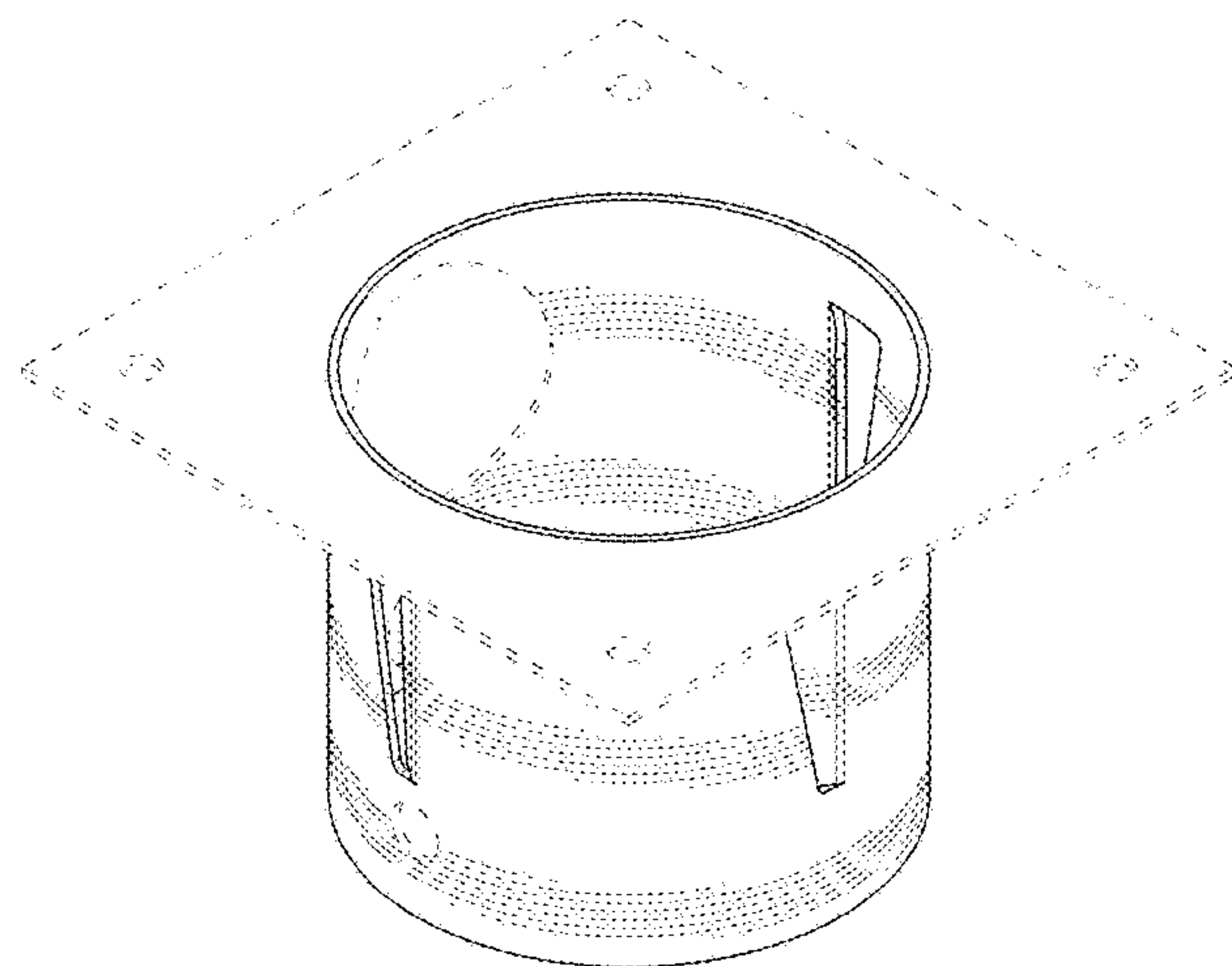
The ornamental design for a burner housing, as shown and described.

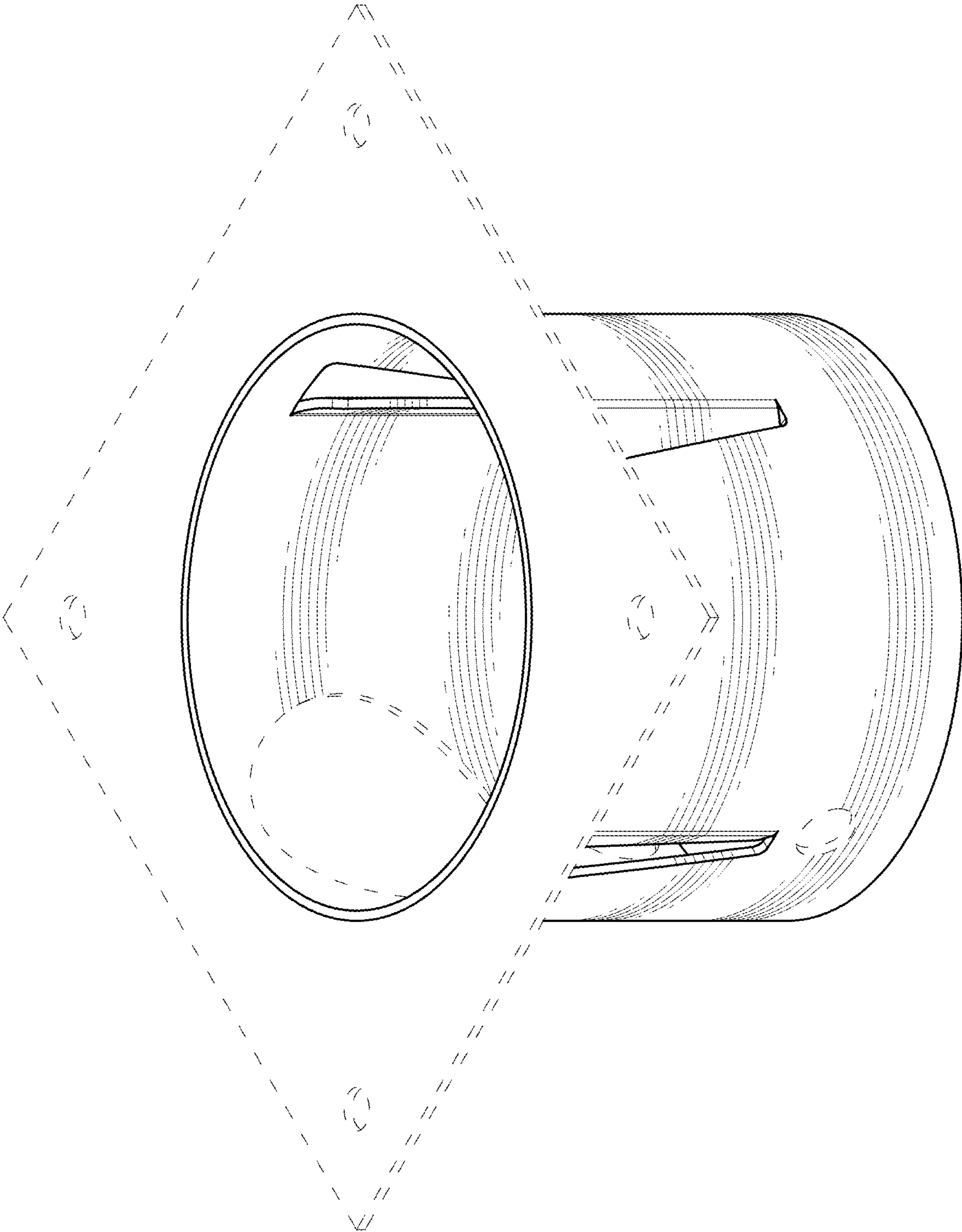
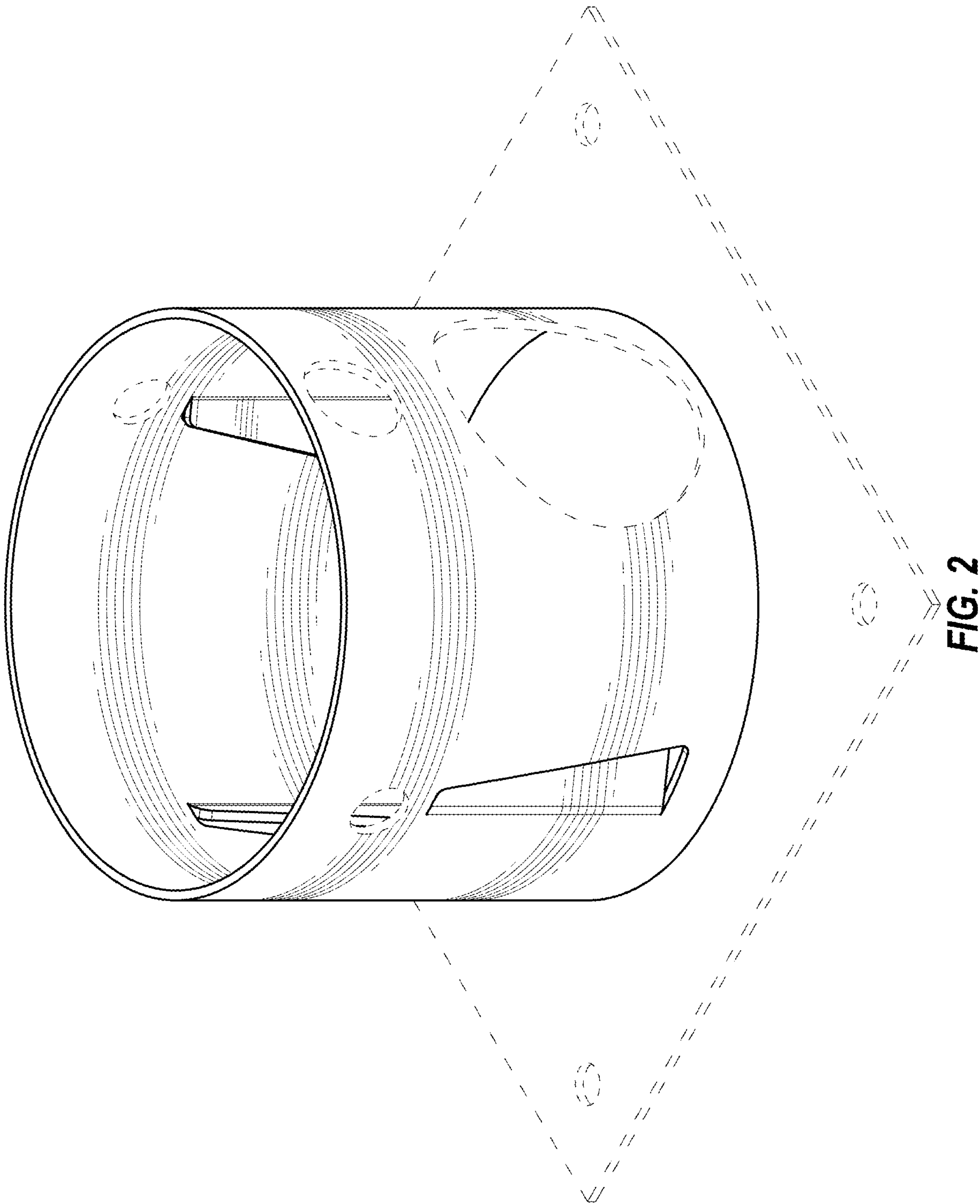

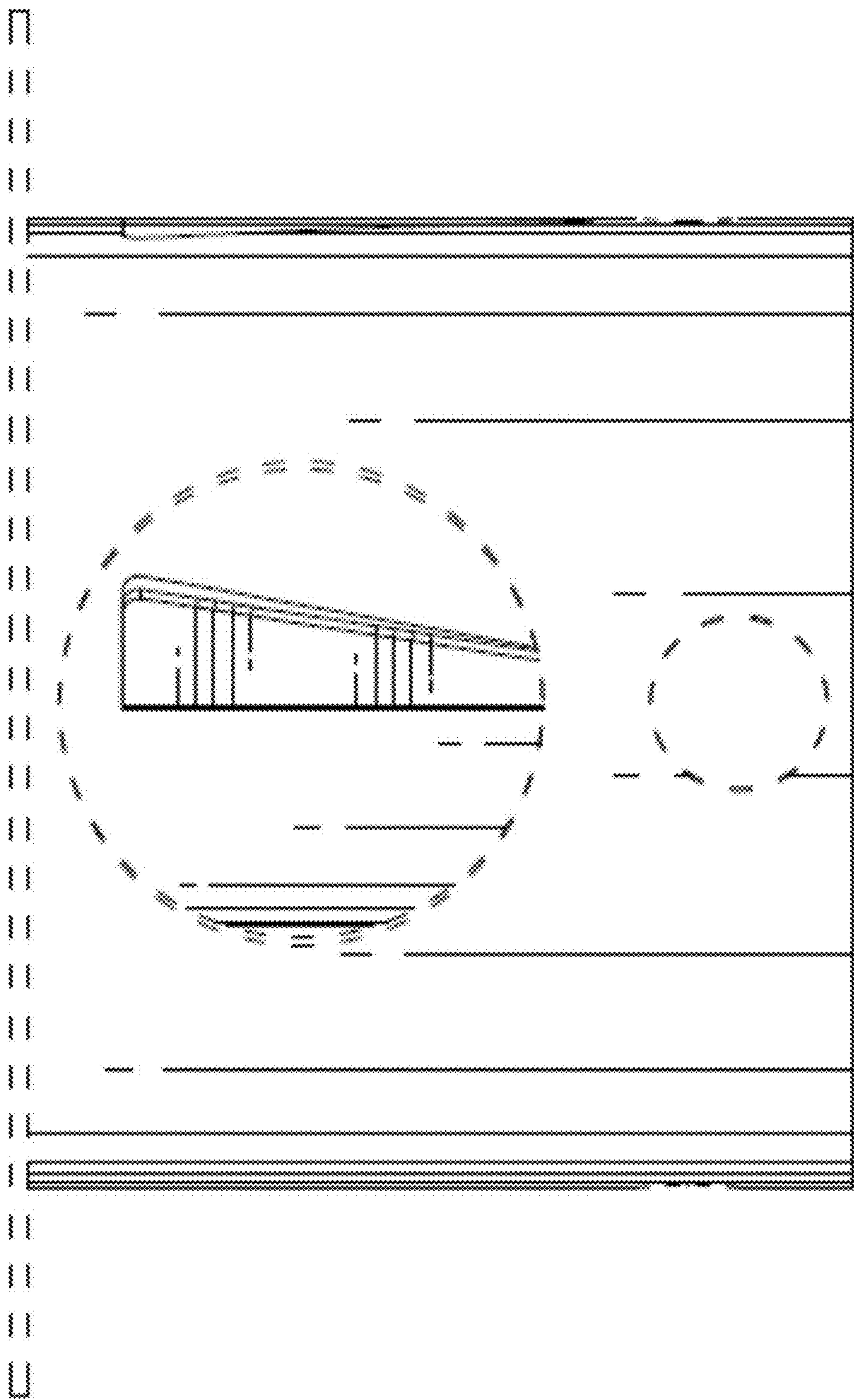

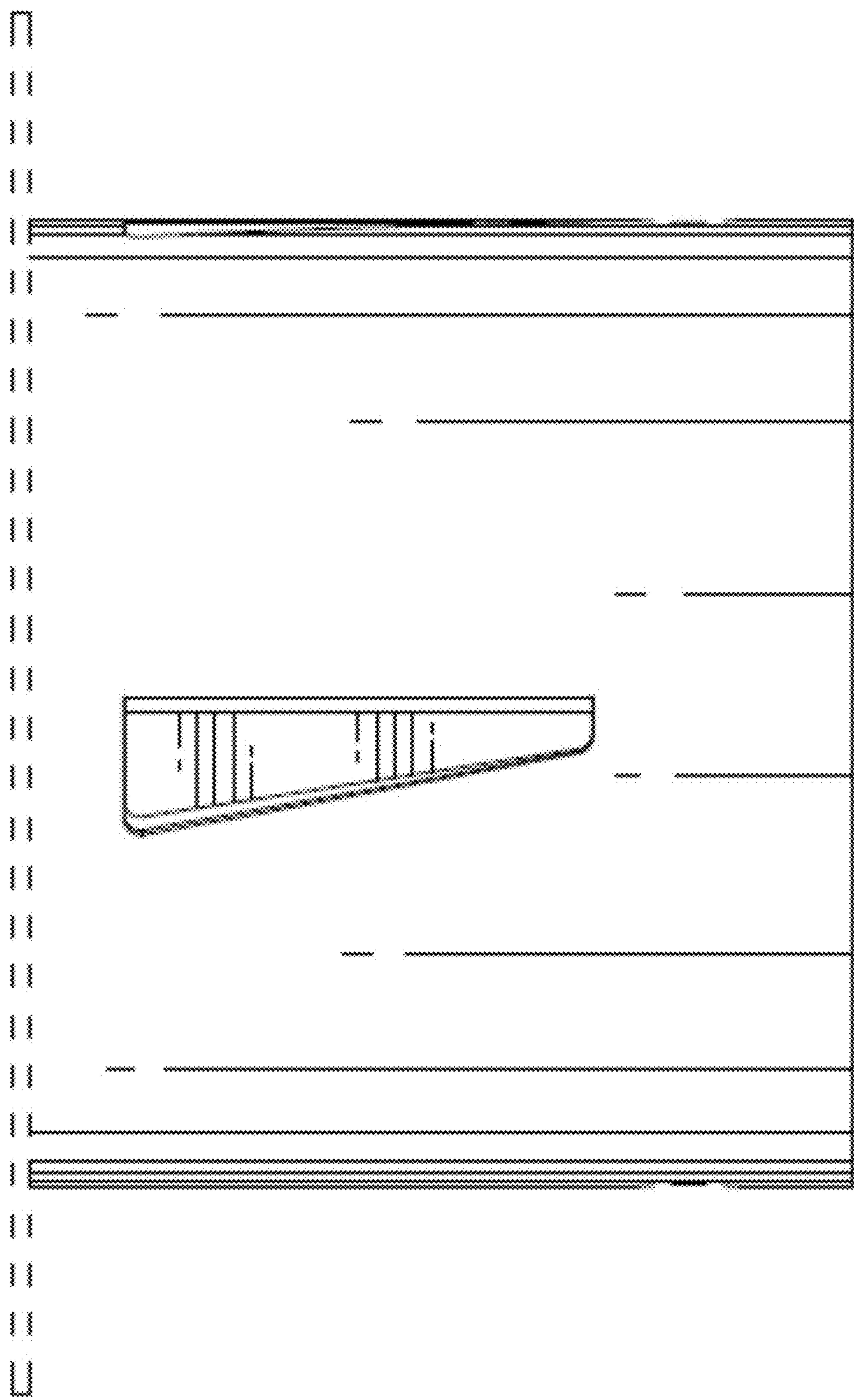

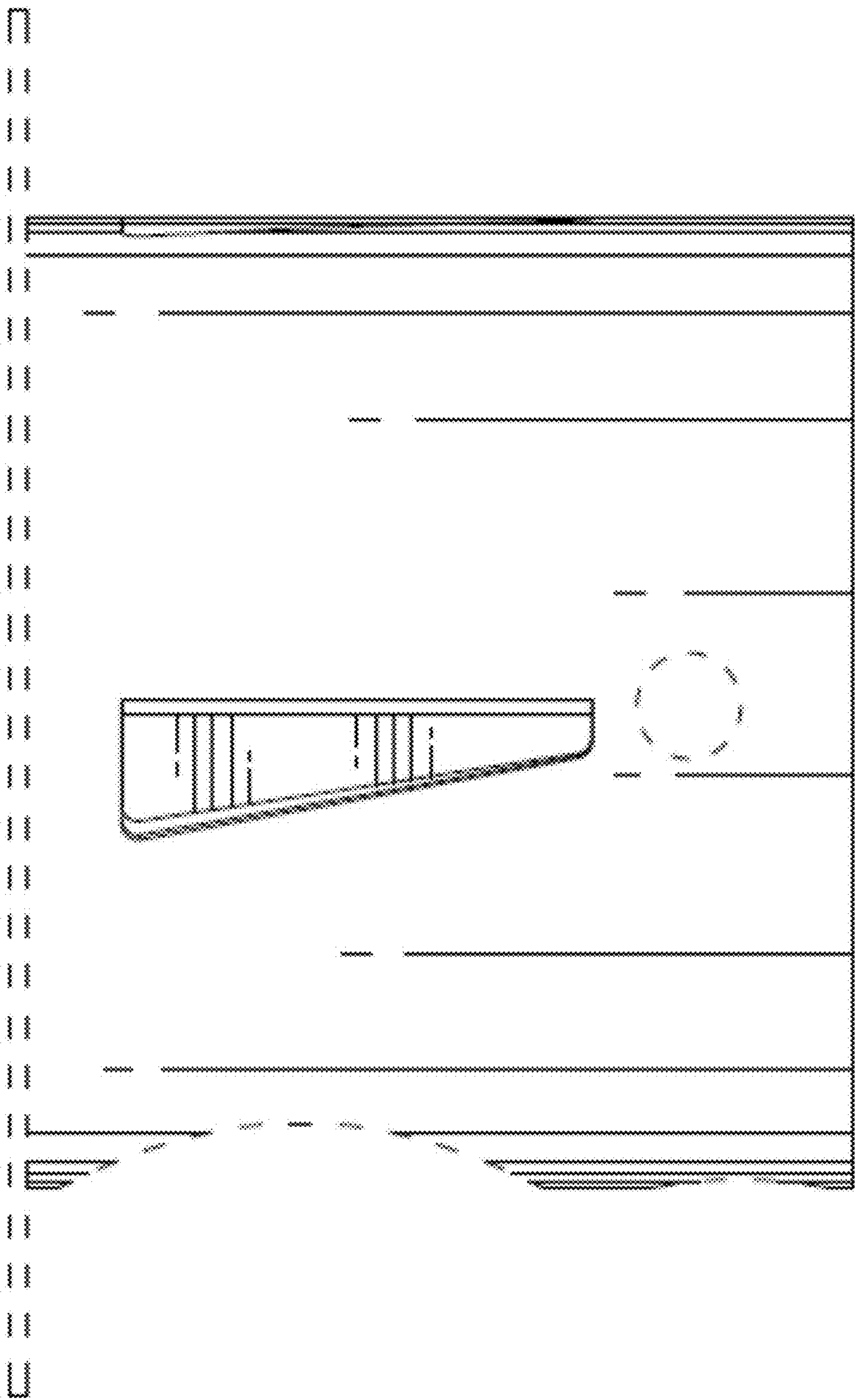

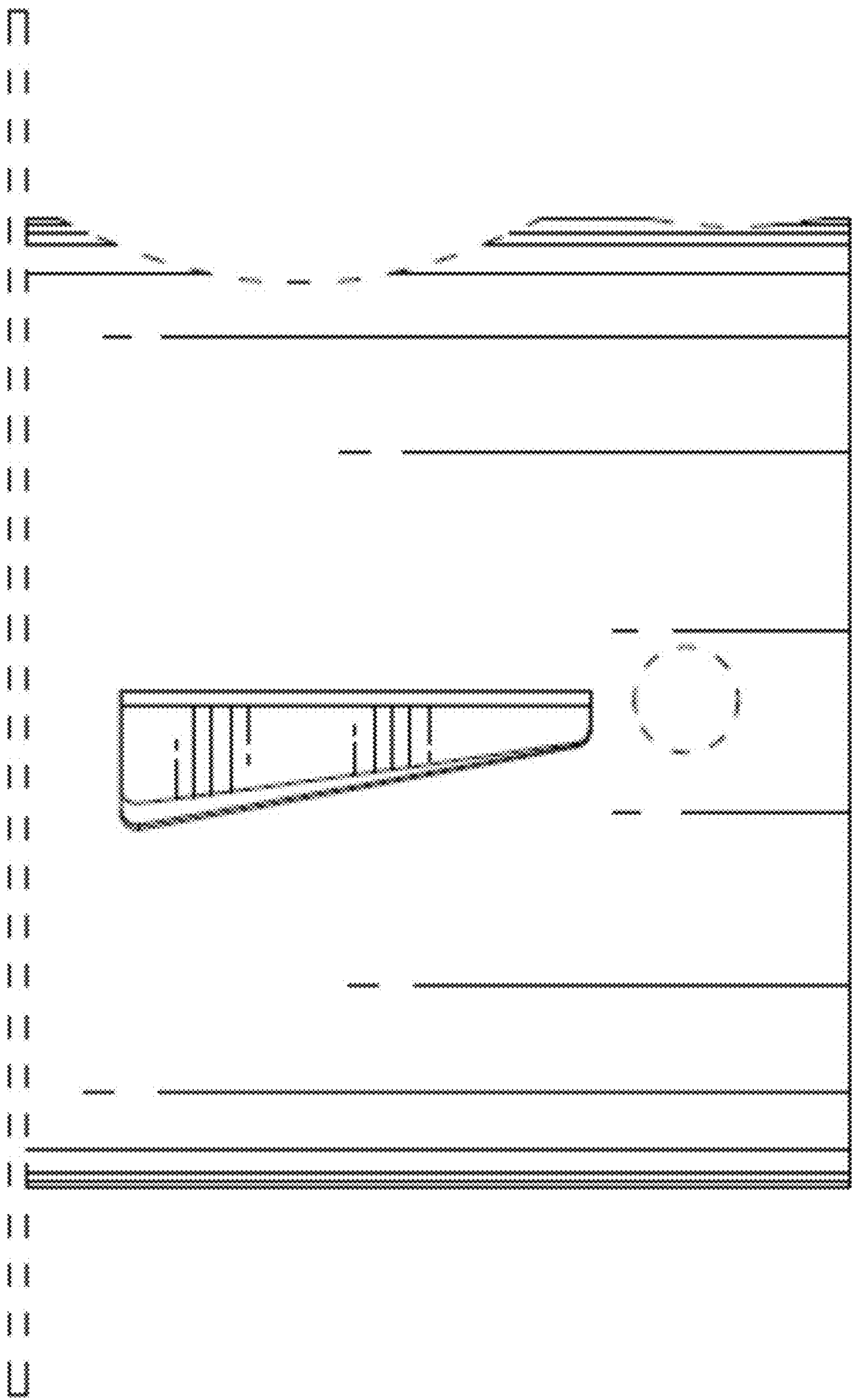

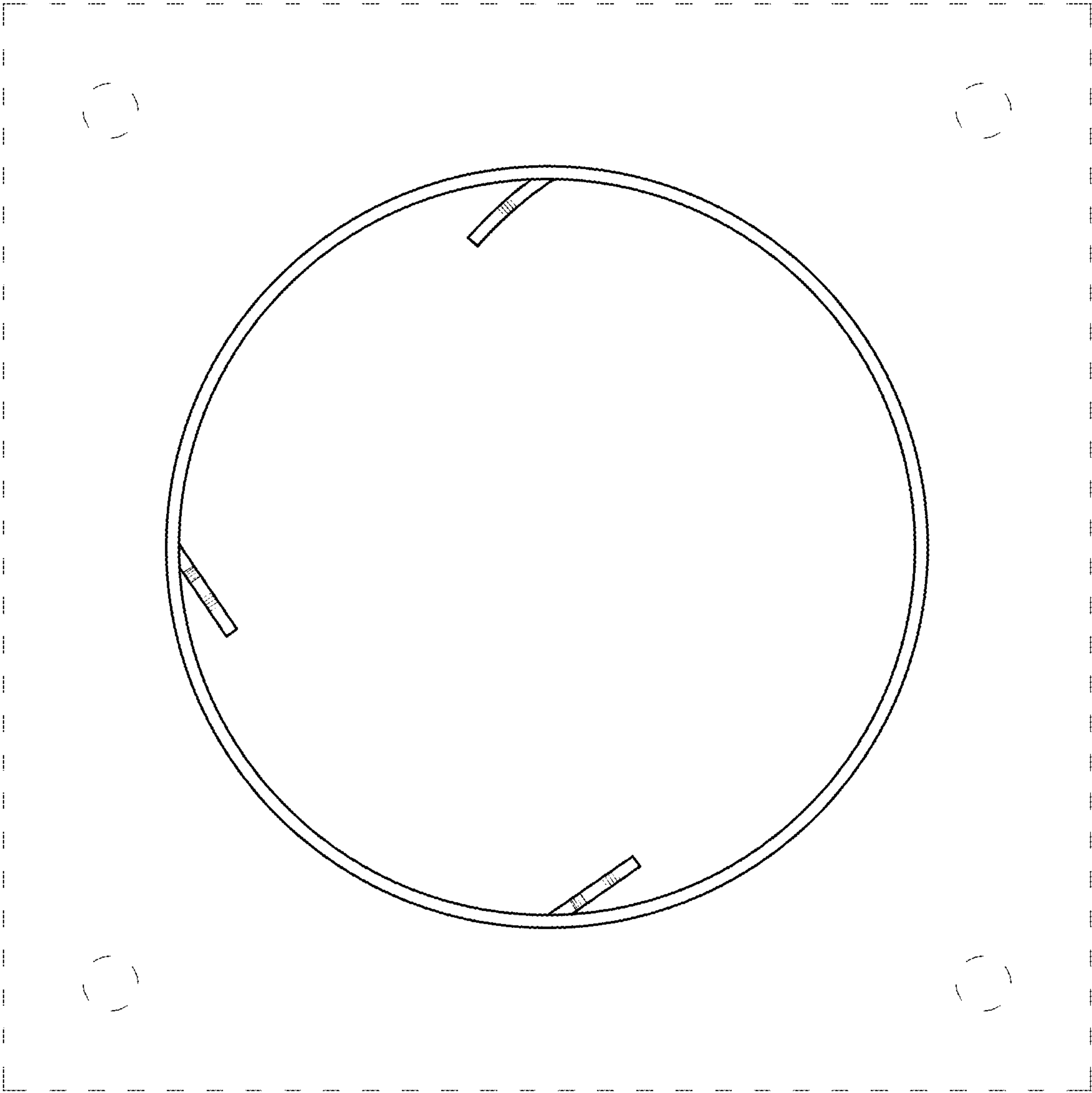

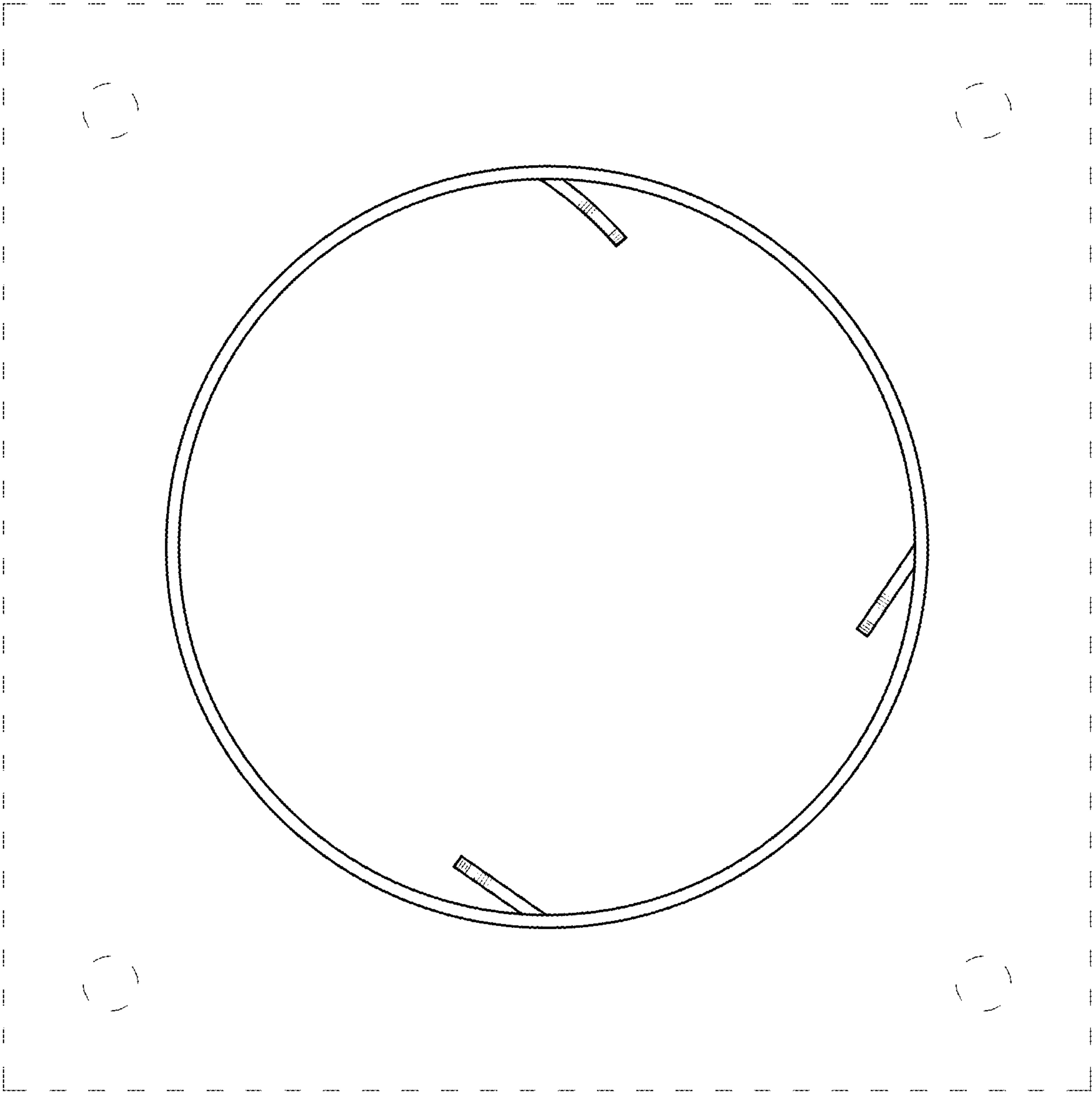
