(57) **CLAIM**

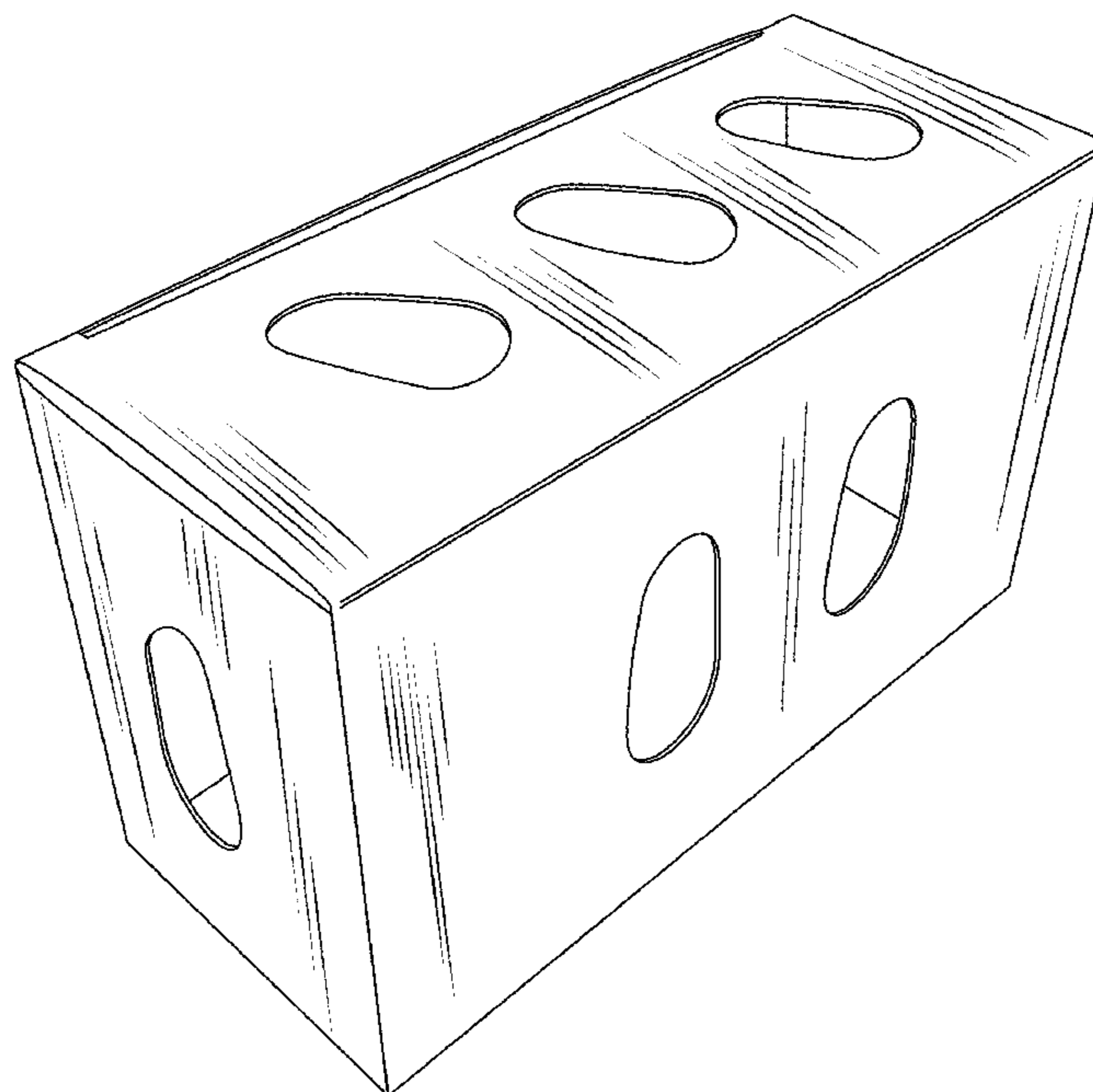
The ornamental design for an avocado container, as shown.

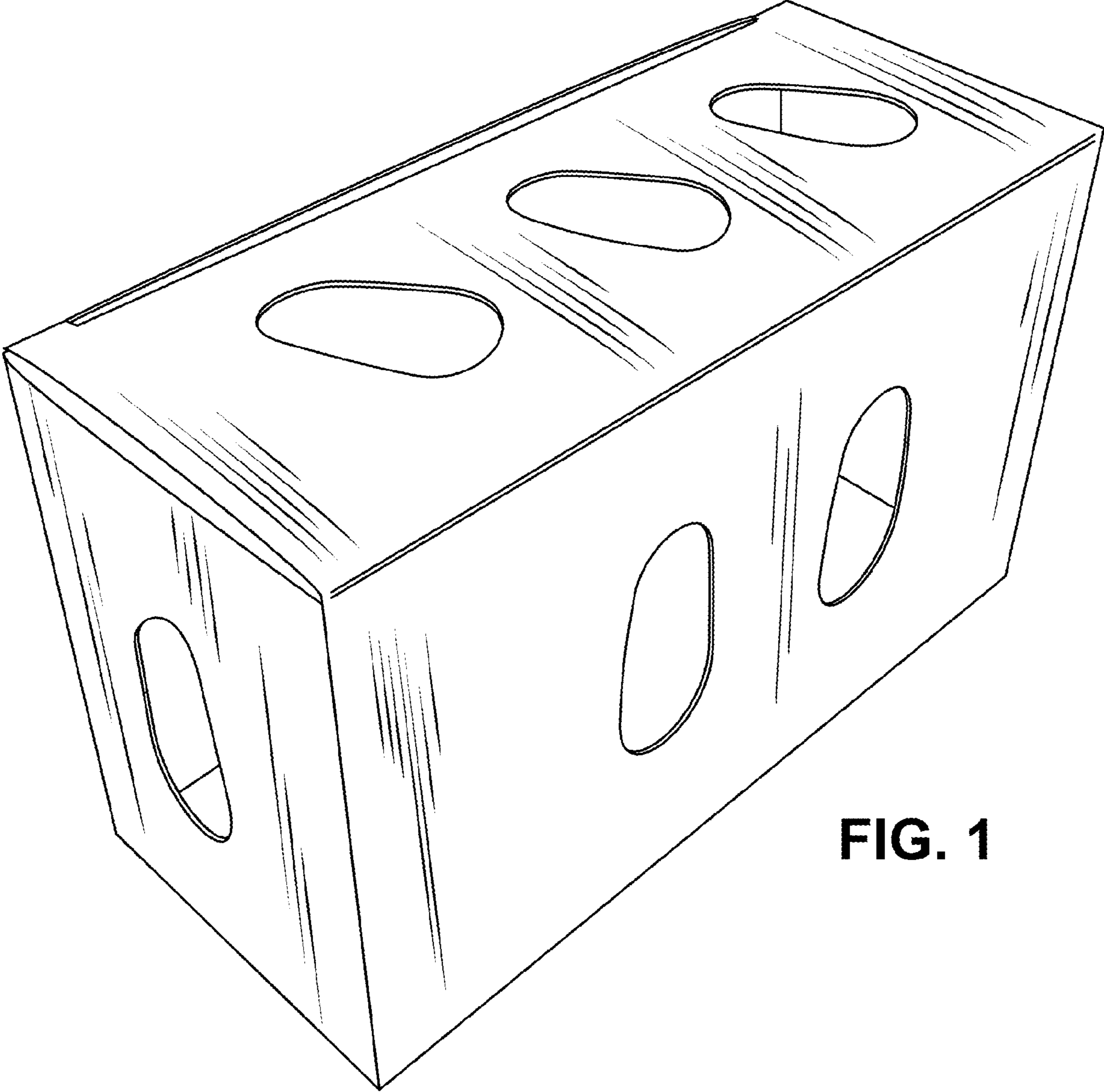

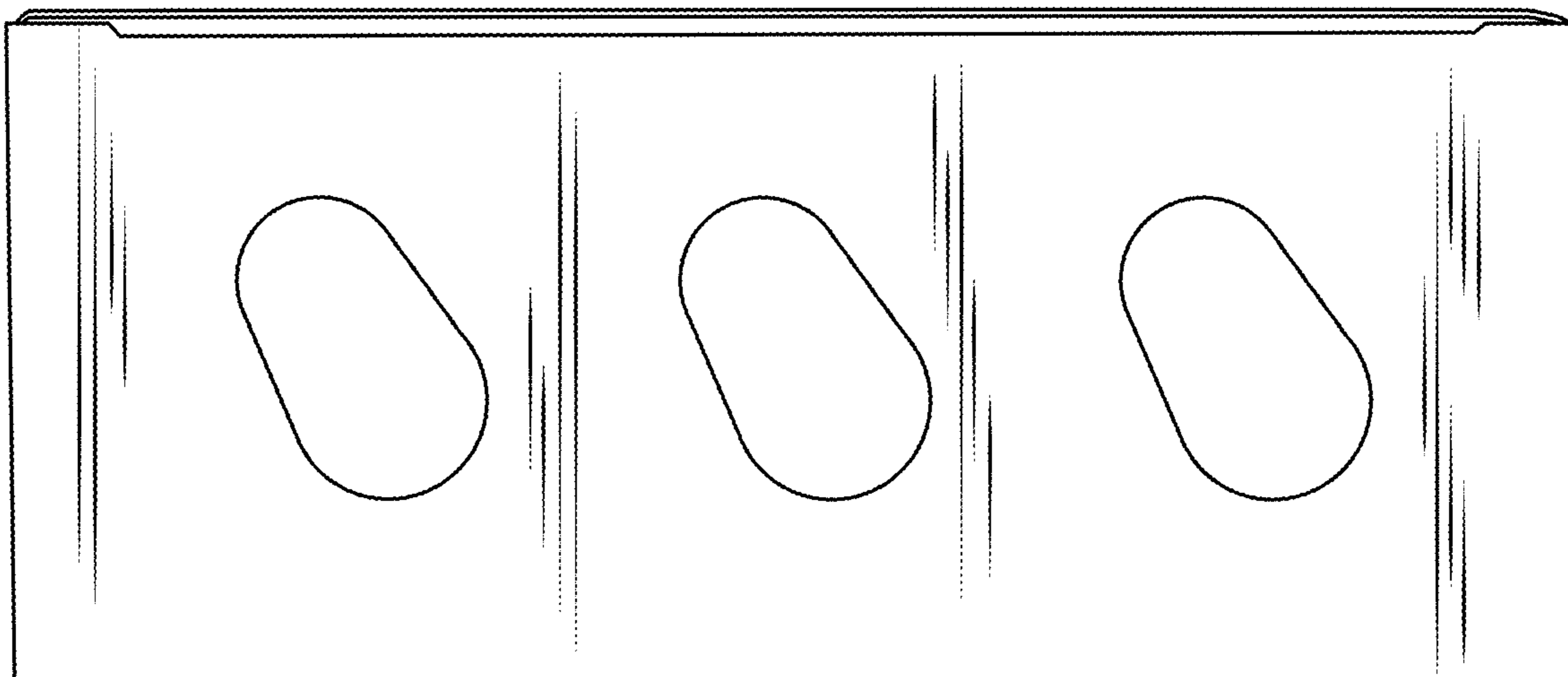

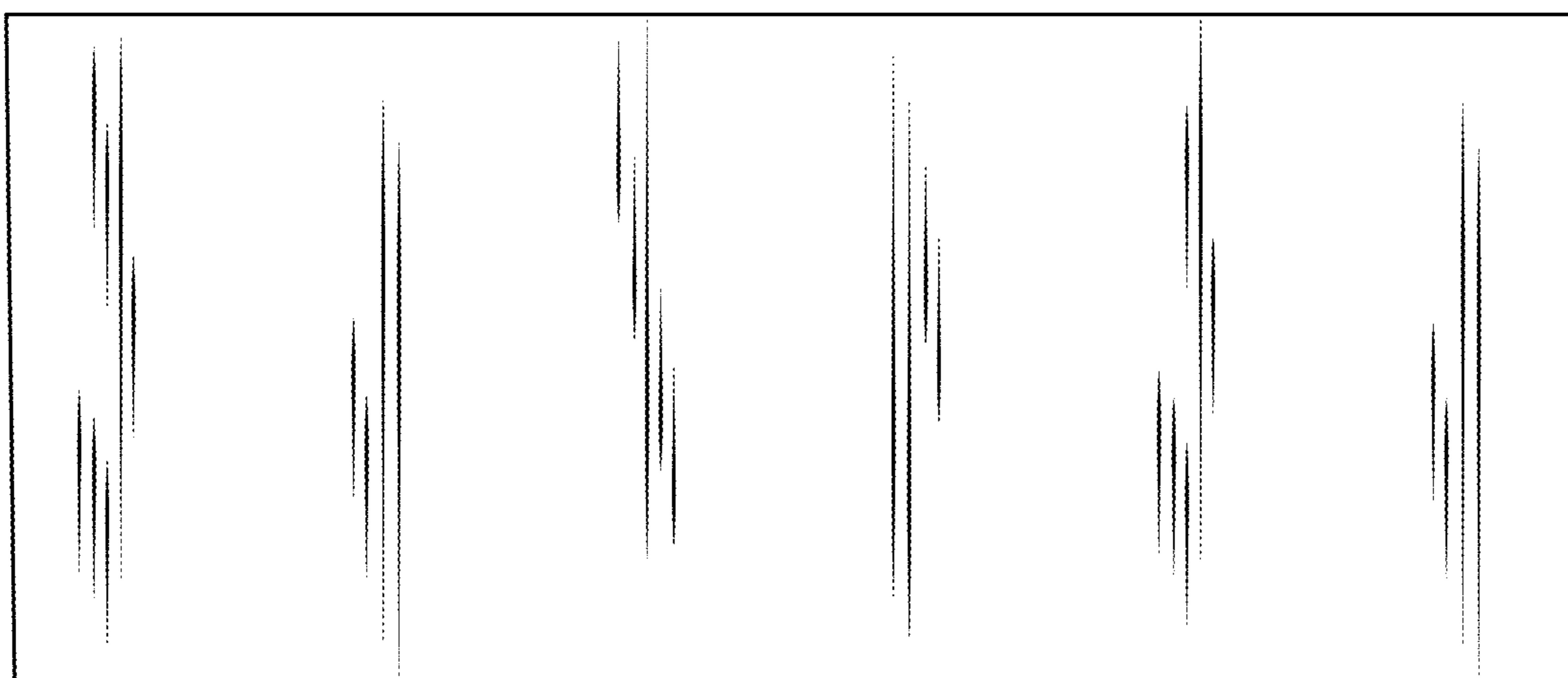

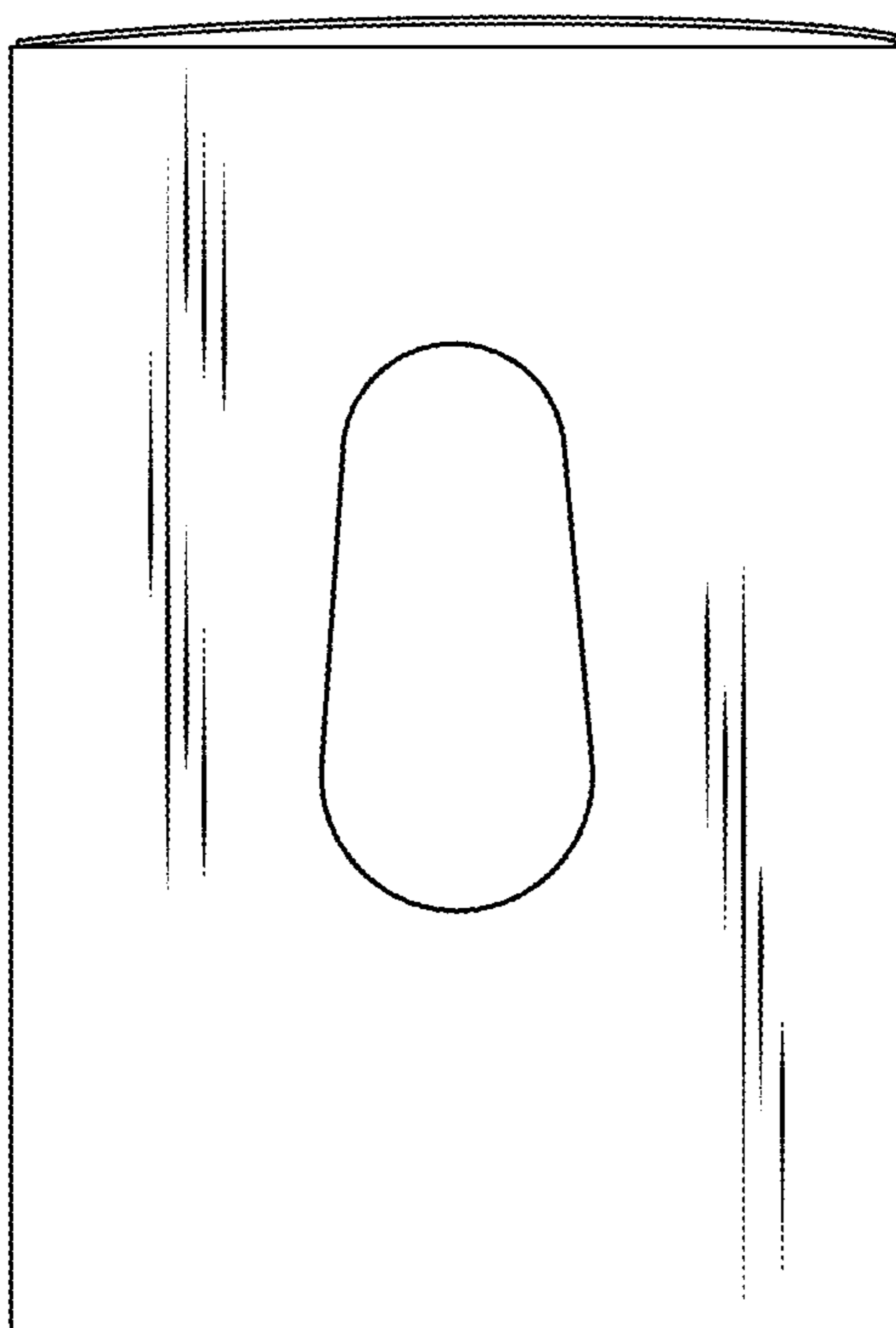

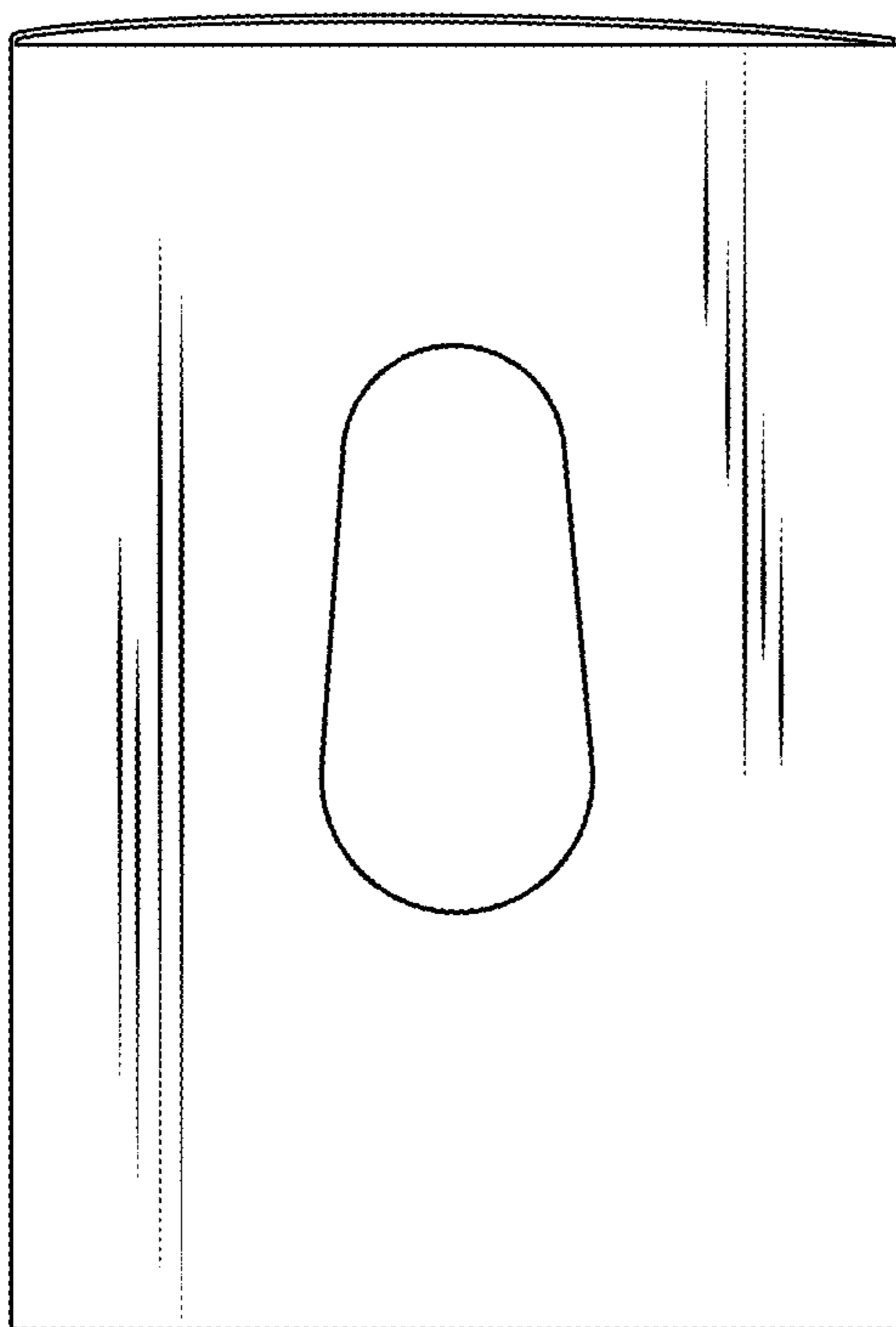
