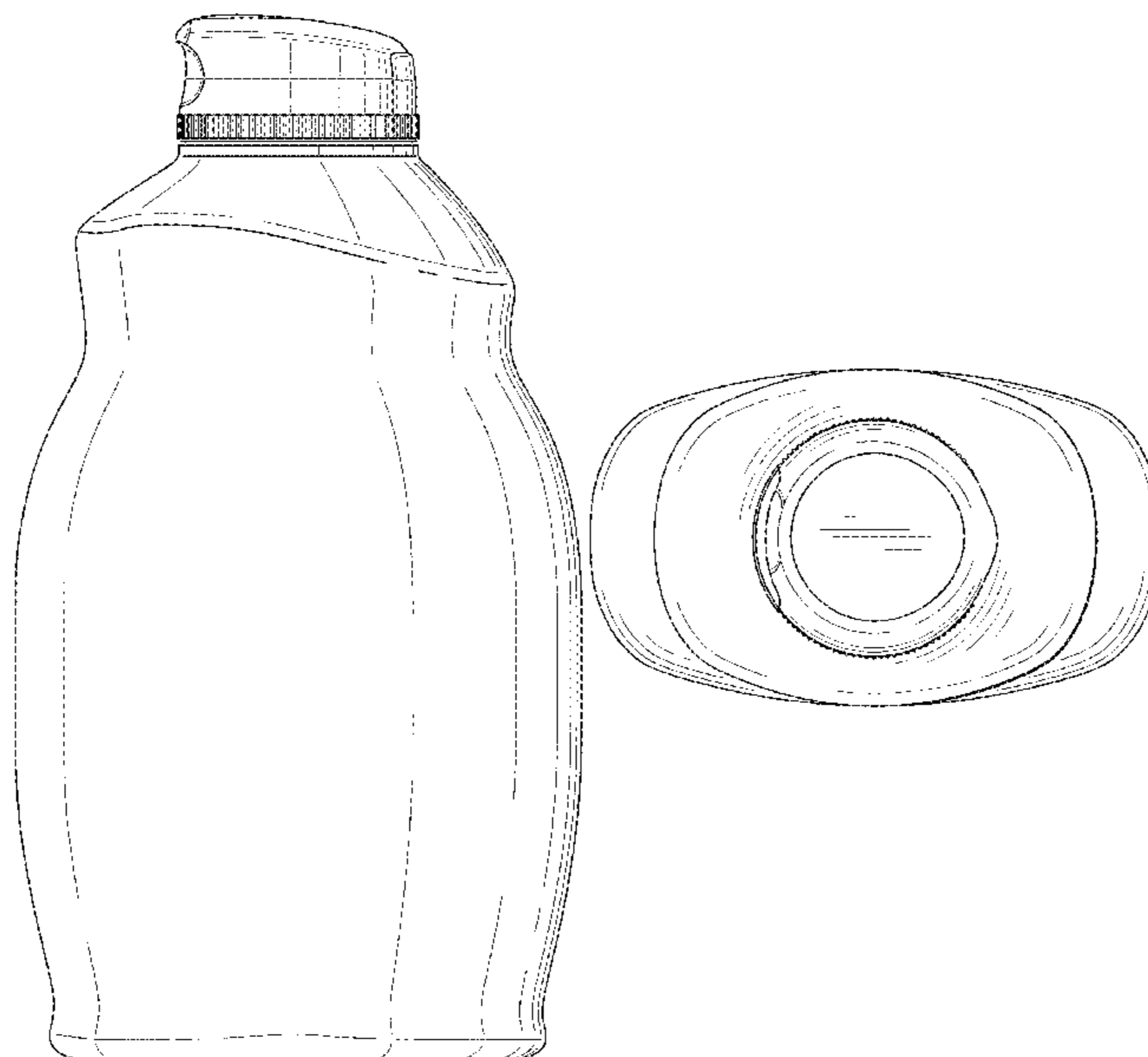
(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container showing our new design;  
FIG. 2 is a front elevation view of the container of FIG. 1;  
FIG. 3 is a rear elevation view of the container of FIG. 1;  
FIG. 4 is a left side elevation view of the container of FIG. 1, the right side elevation view being the mirror image thereof;  
FIG. 5 is a top plan view of the container of FIG. 1; and,  
FIG. 6 is a bottom plan view of the container of FIG. 1.  
The broken lines in the drawings showing the container illustrate the portions of the container that form no part of the claimed design.

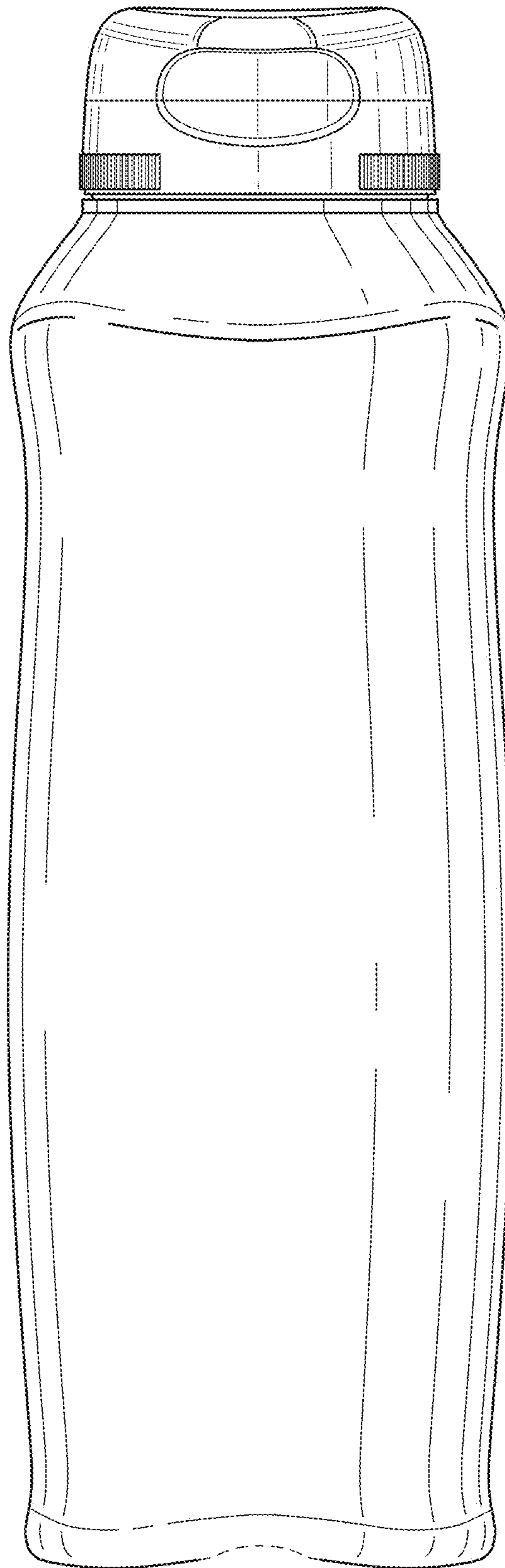

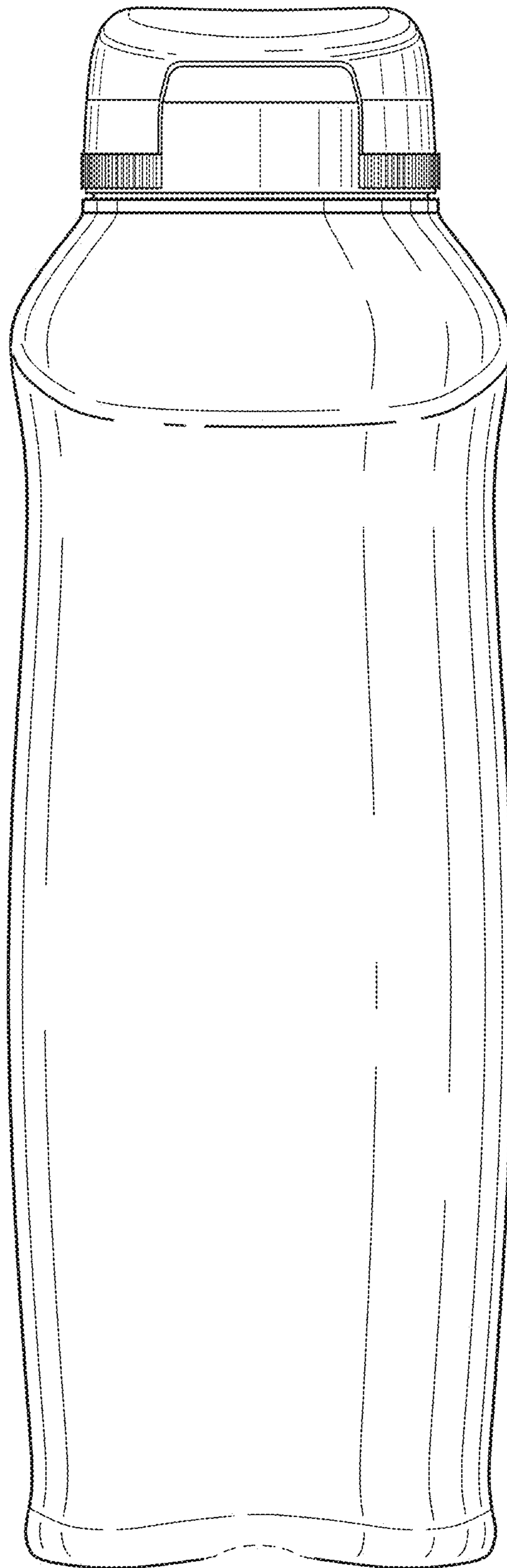

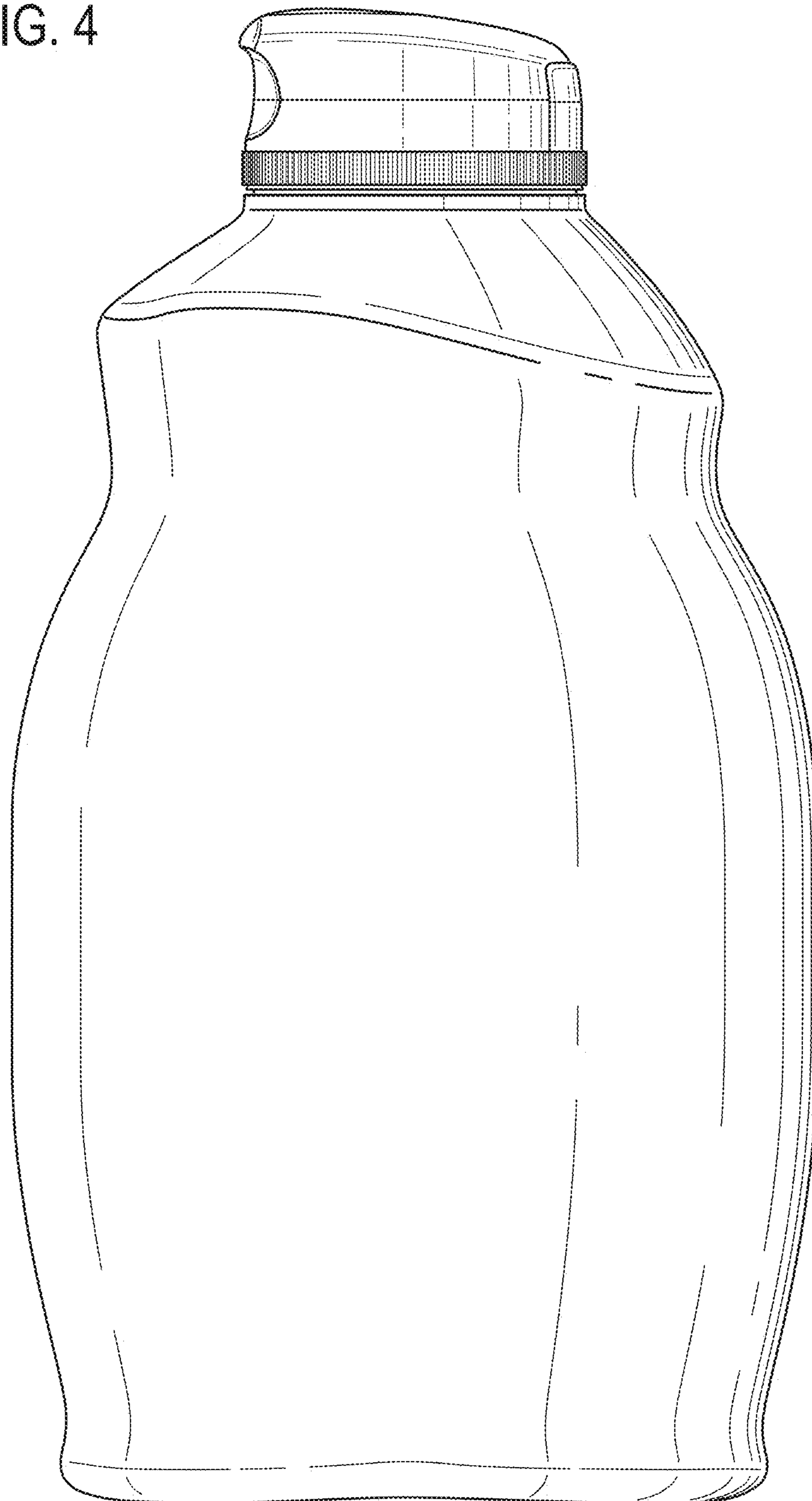

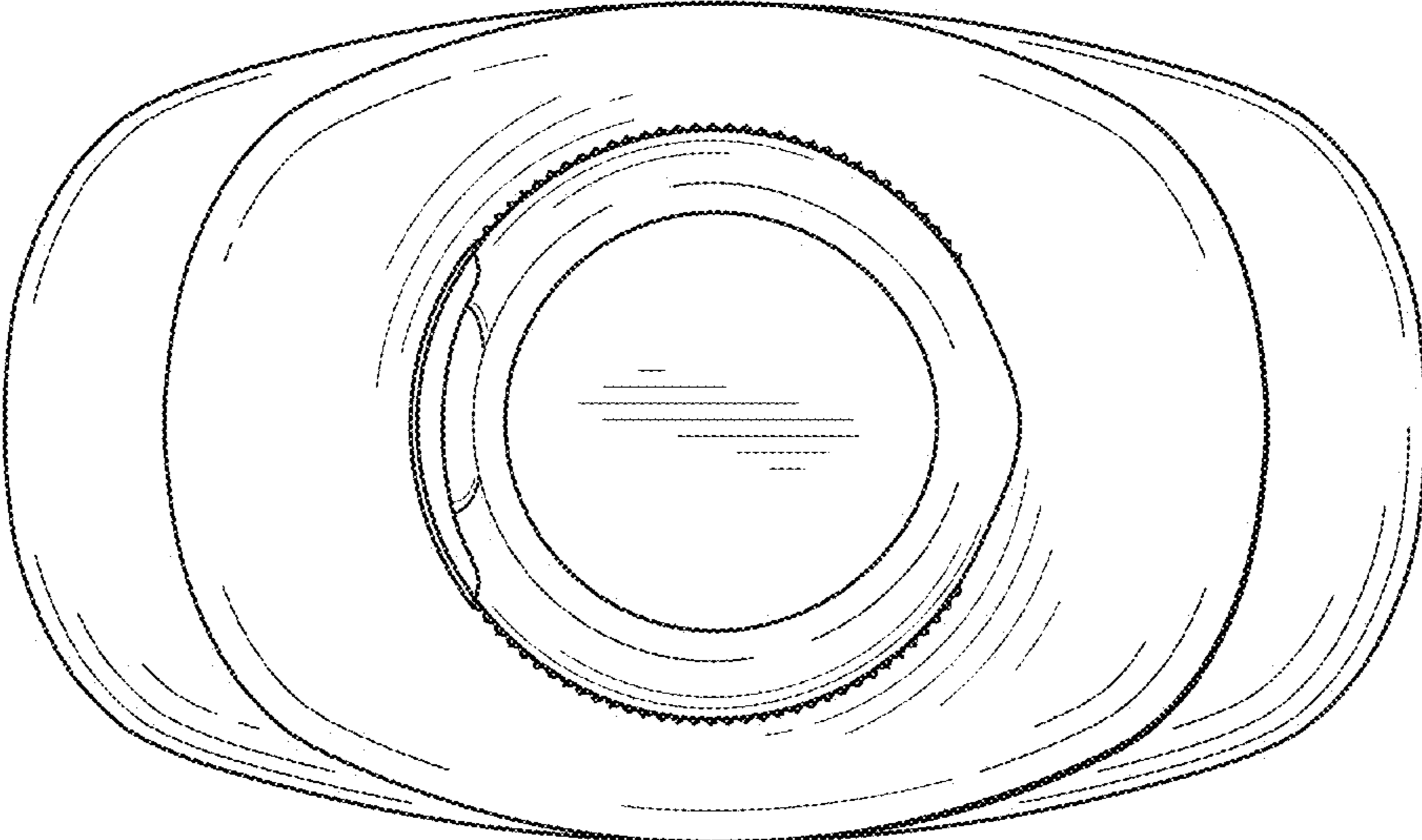
