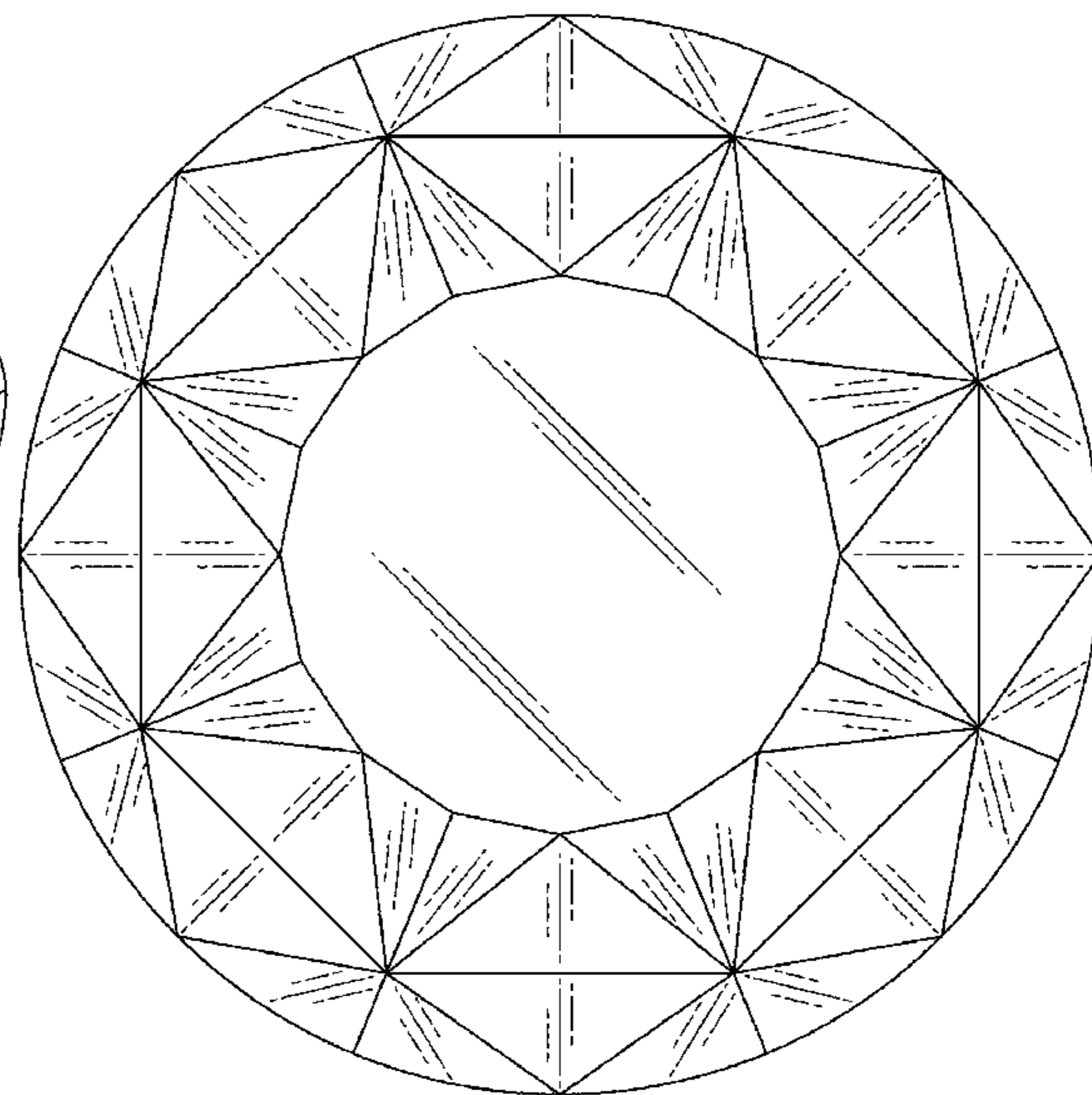
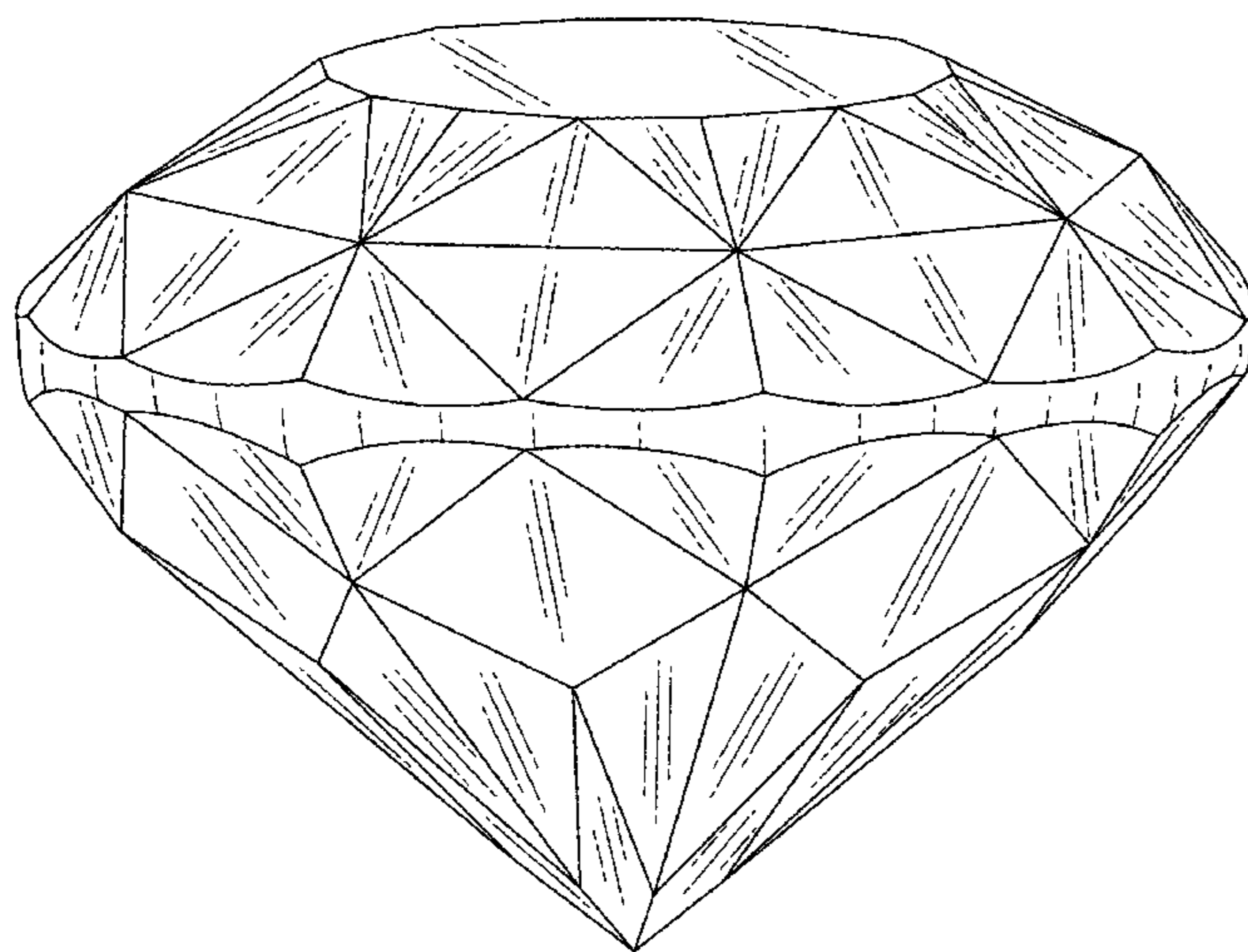
(57) **CLAIM**

The ornamental design for a gemstone, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a gemstone;
FIG. 2 is an elevation view of the gemstone of FIG. 1, which is identical for the front, rear, left side, and right side of the gemstone;
FIG. 3 is a bottom plan view of the gemstone of FIG. 1; and,
FIG. 4 is a top plan view of the gemstone of FIG. 1.

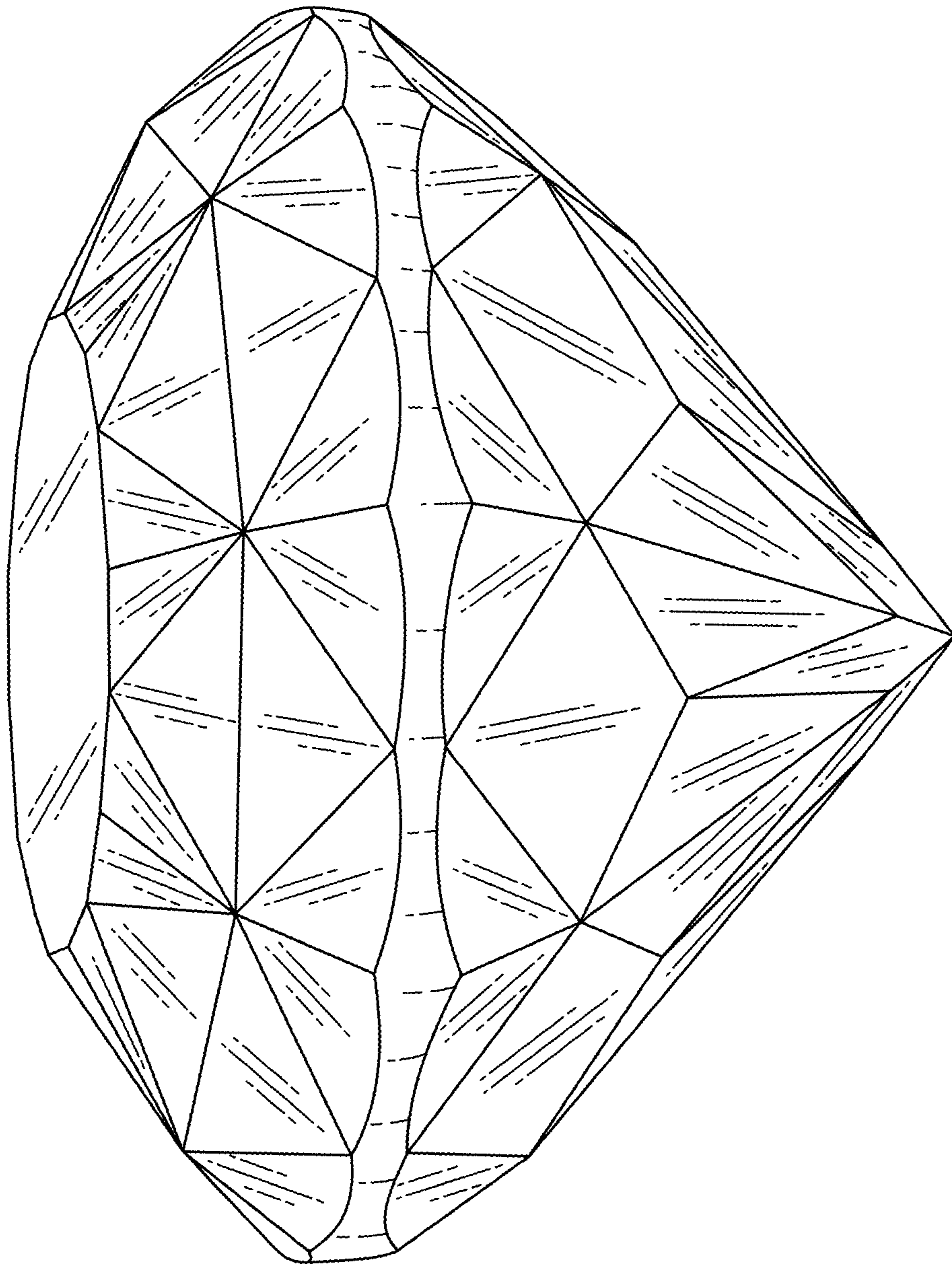

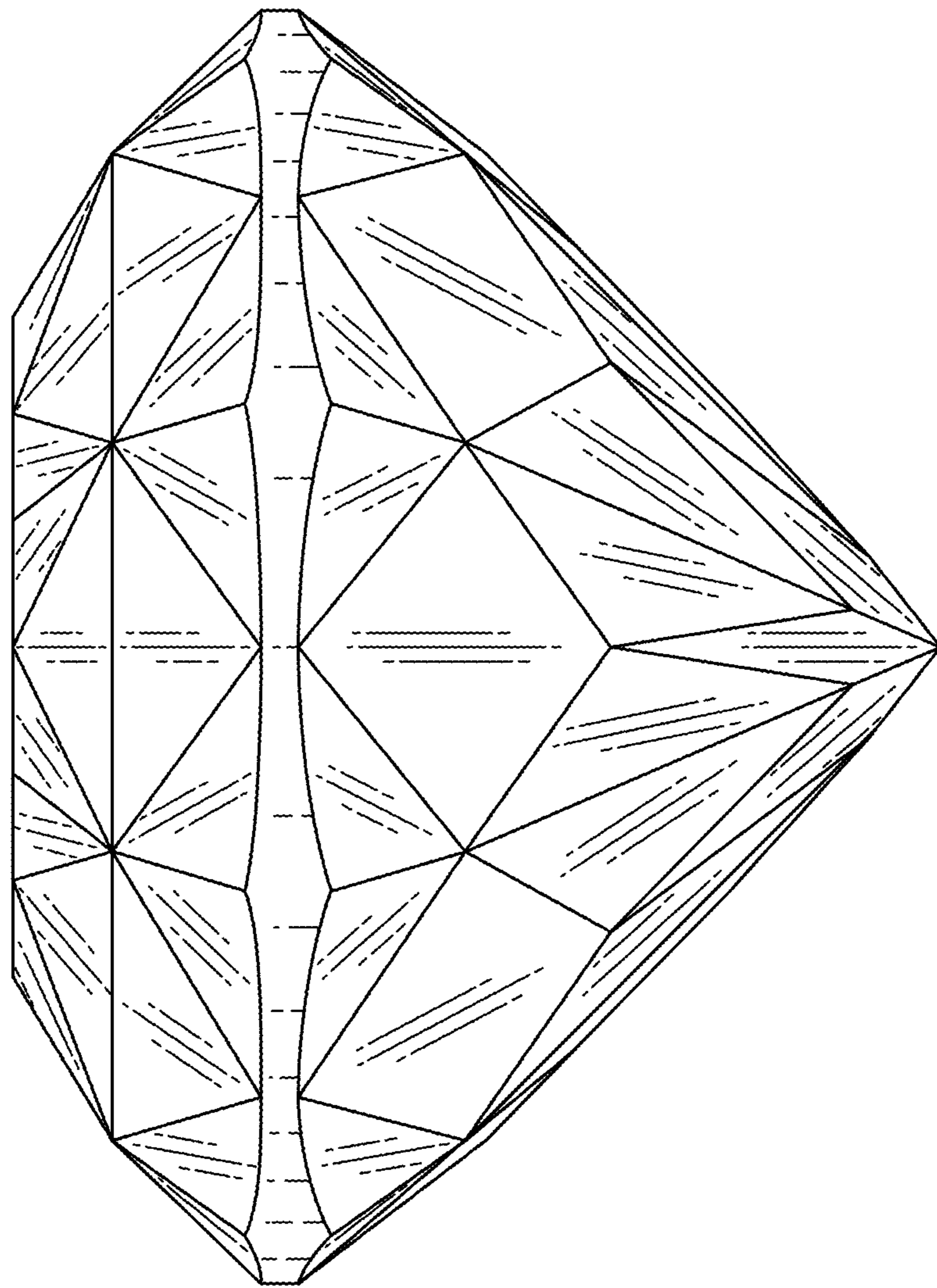

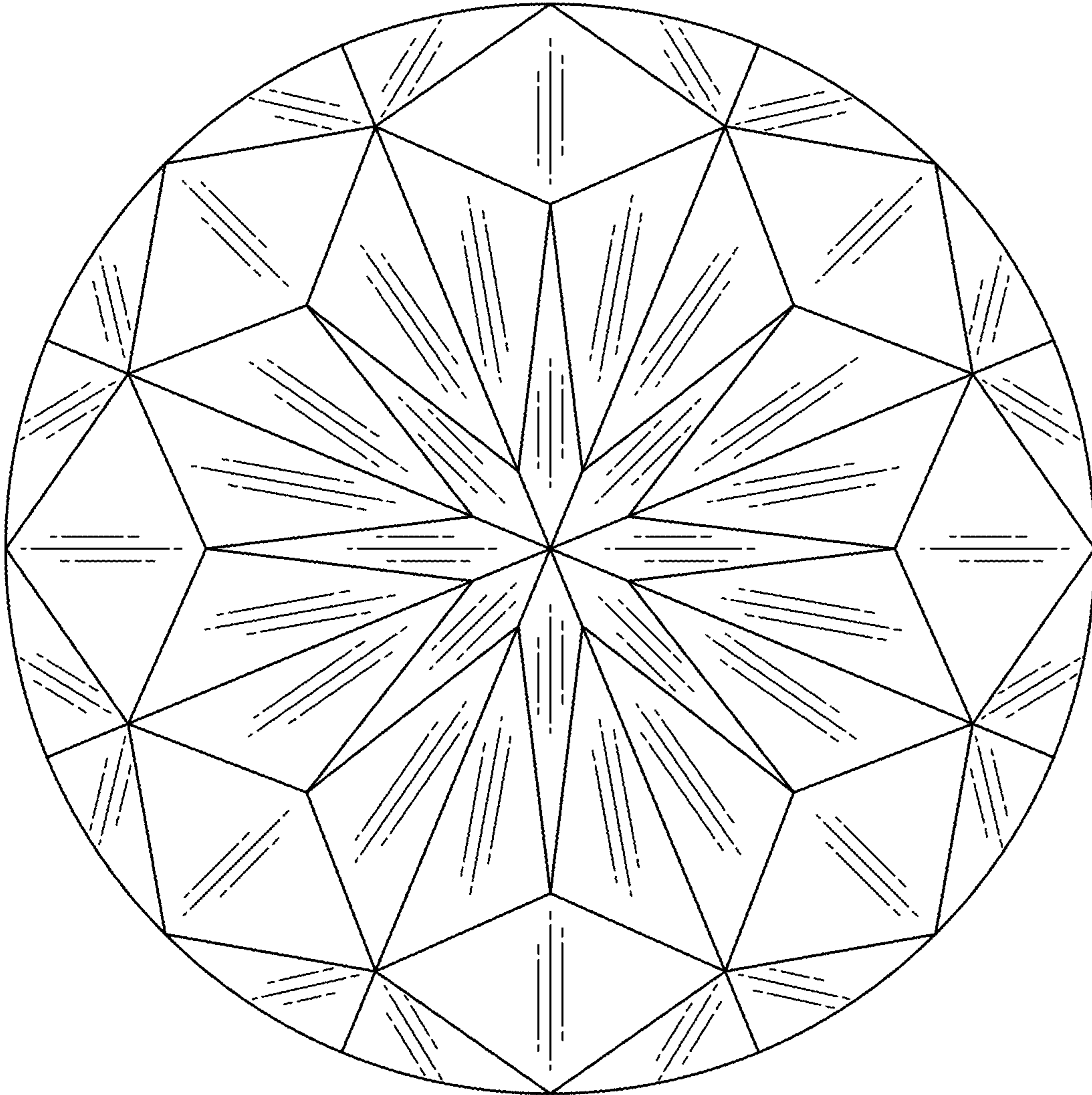

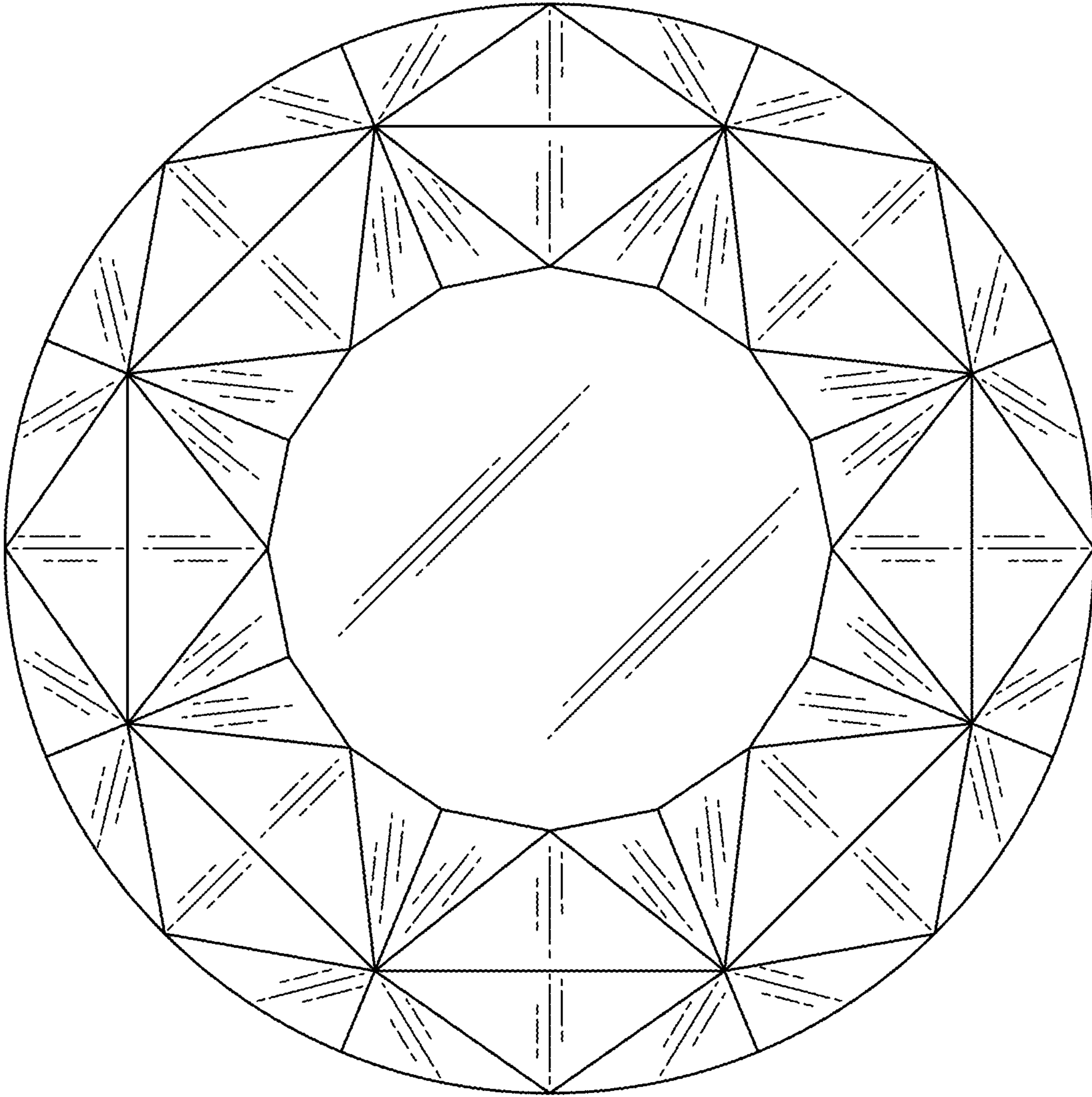
