FIG. 5 shows a fifth image thereof;

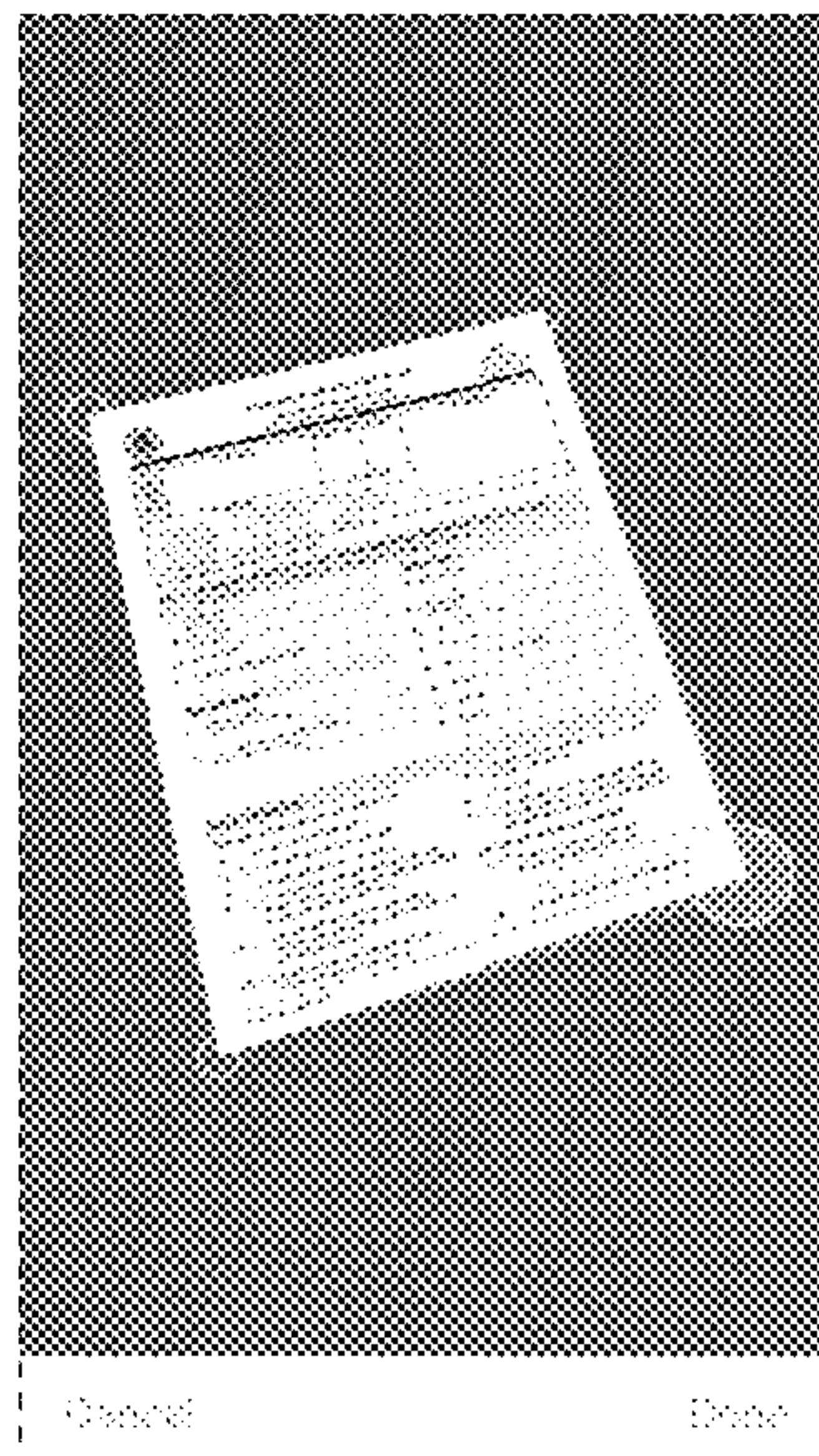
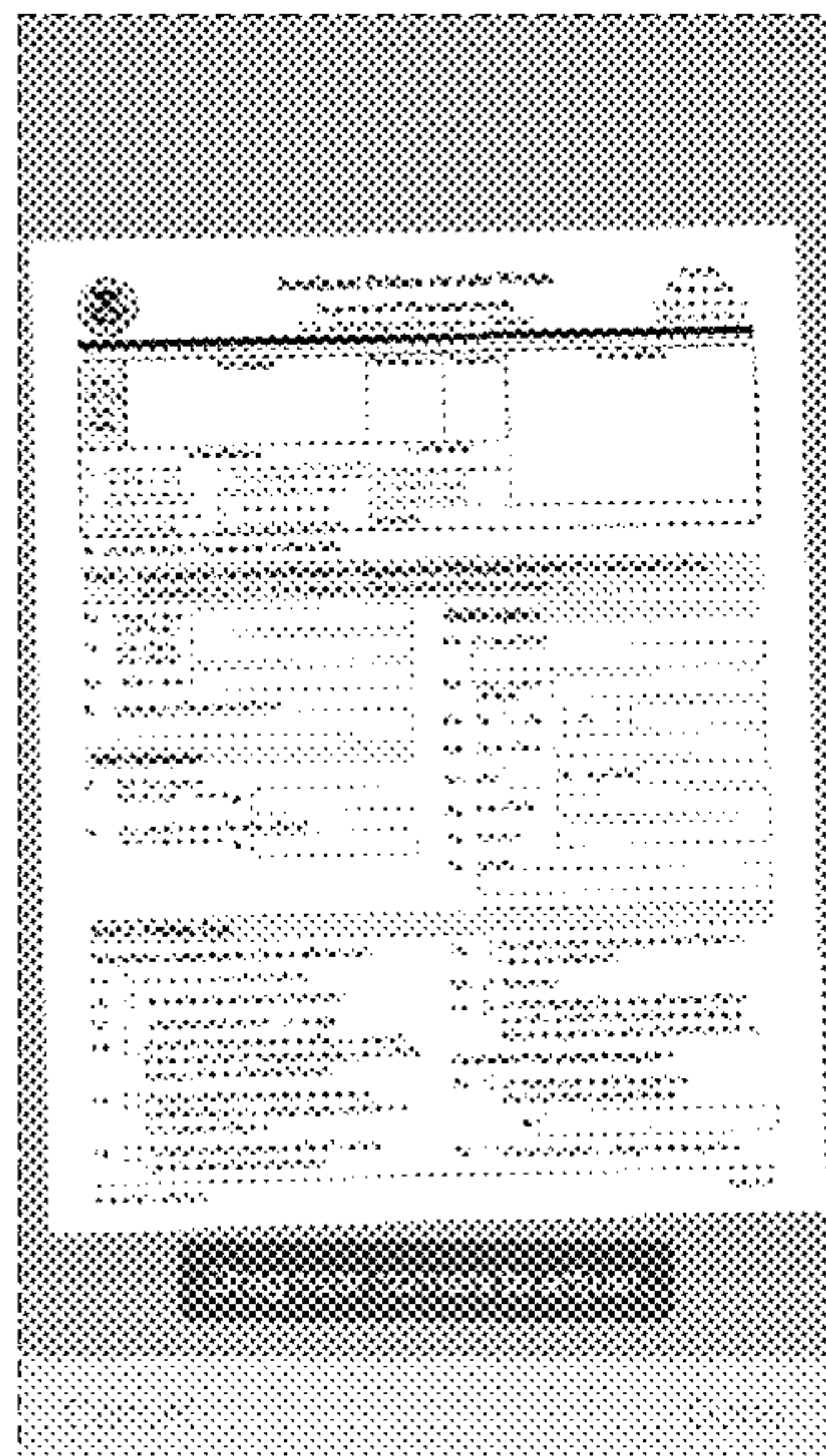
FIG. 6 shows a sixth image thereof; and,

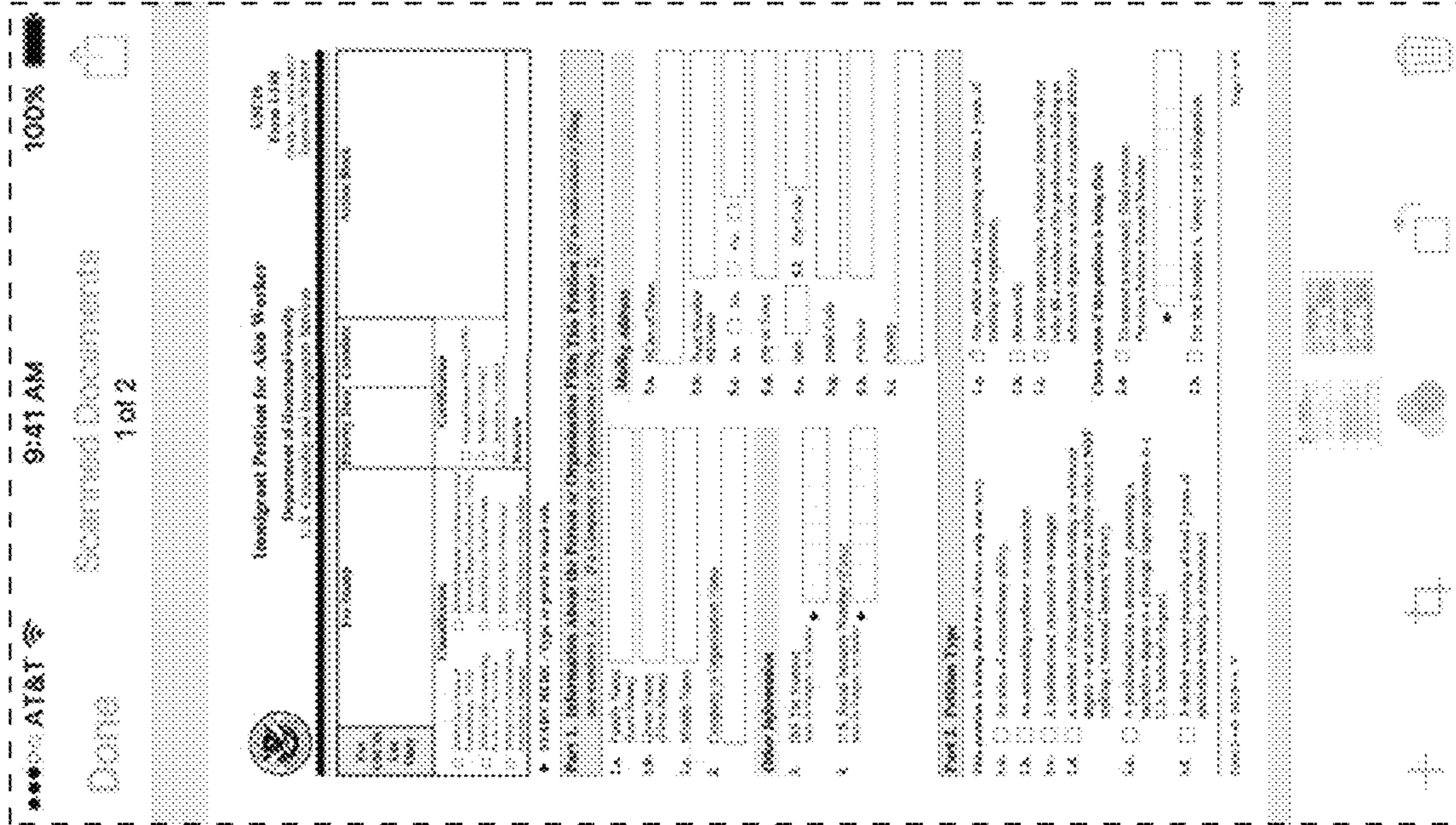

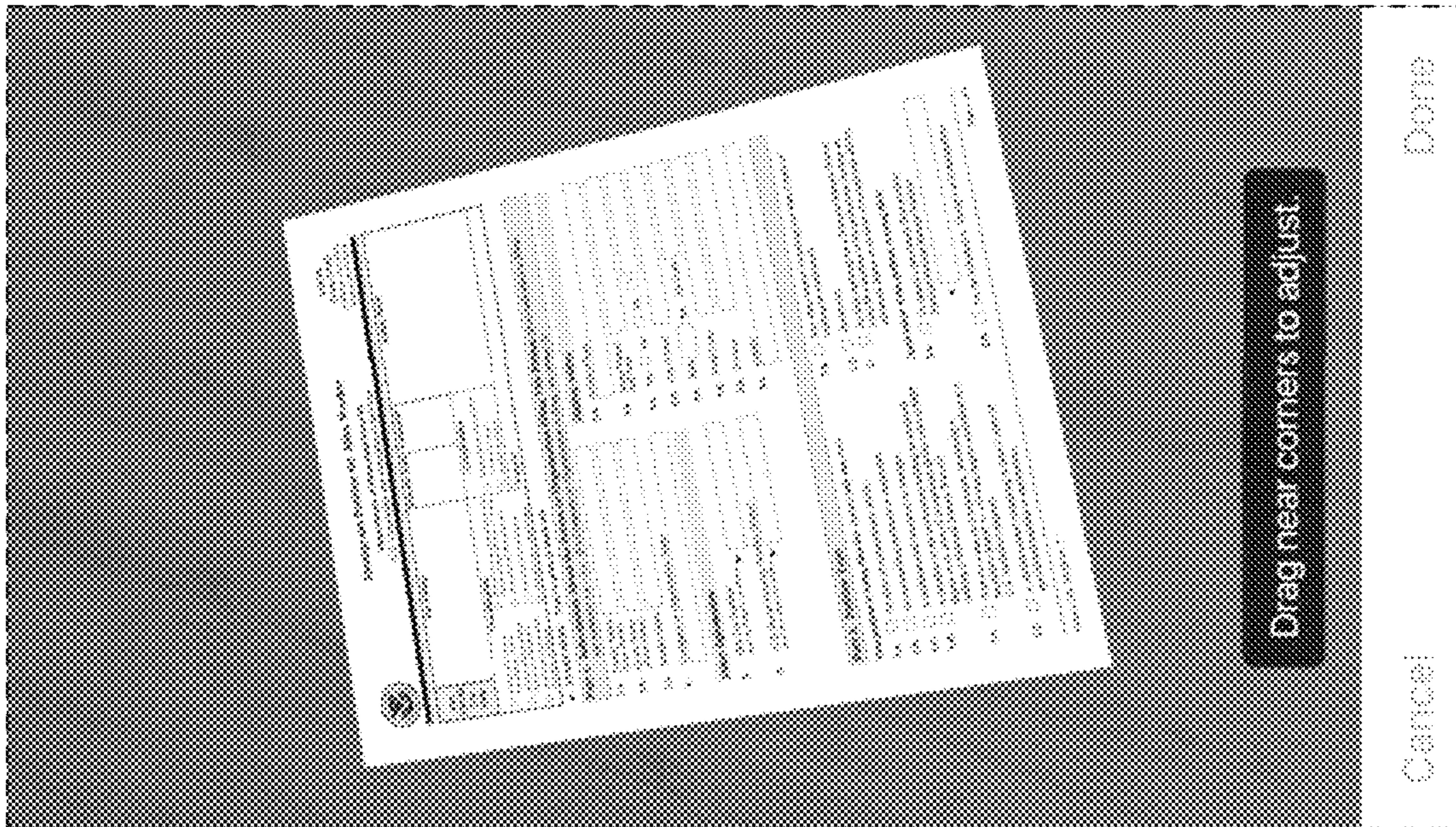

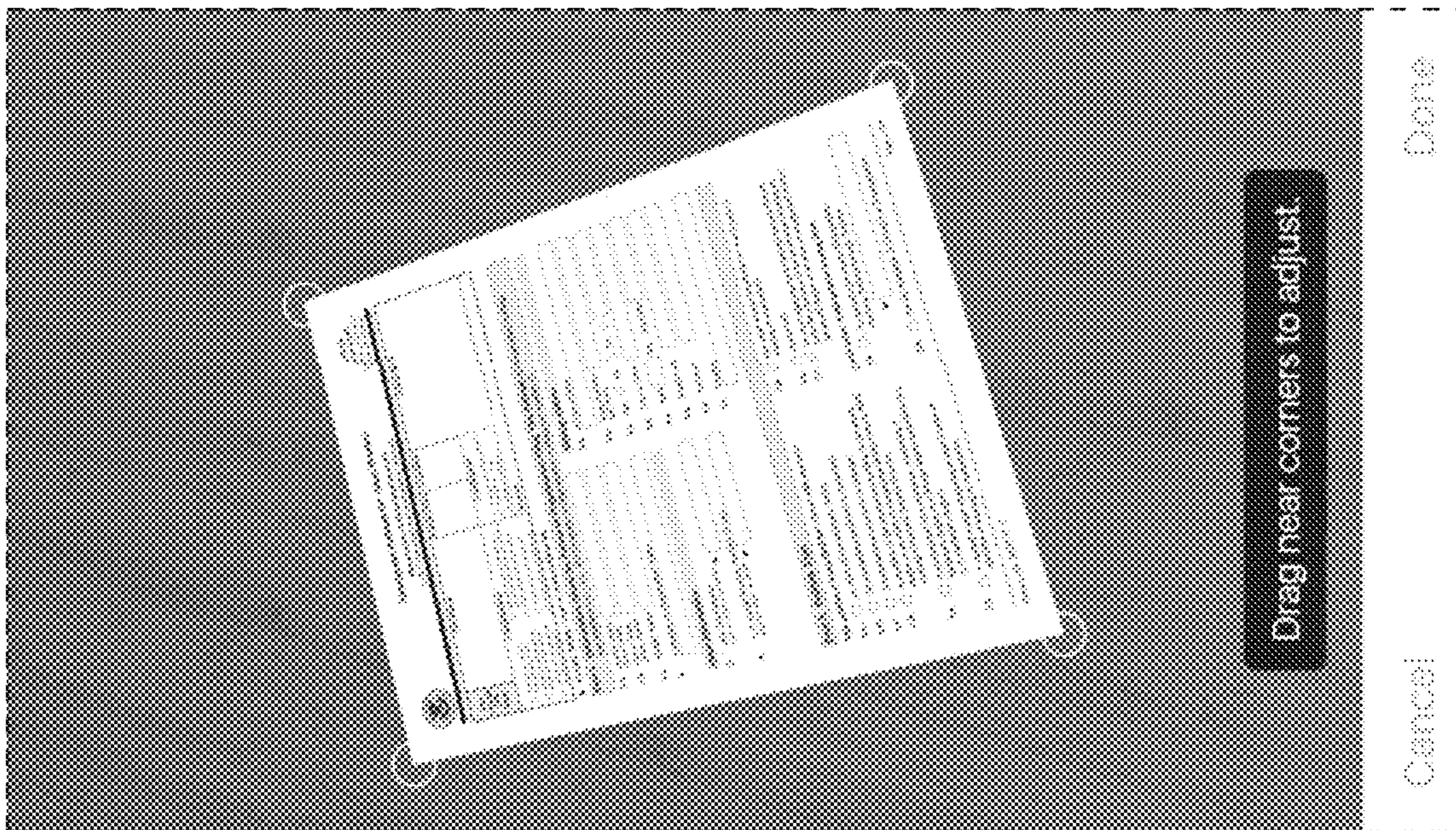

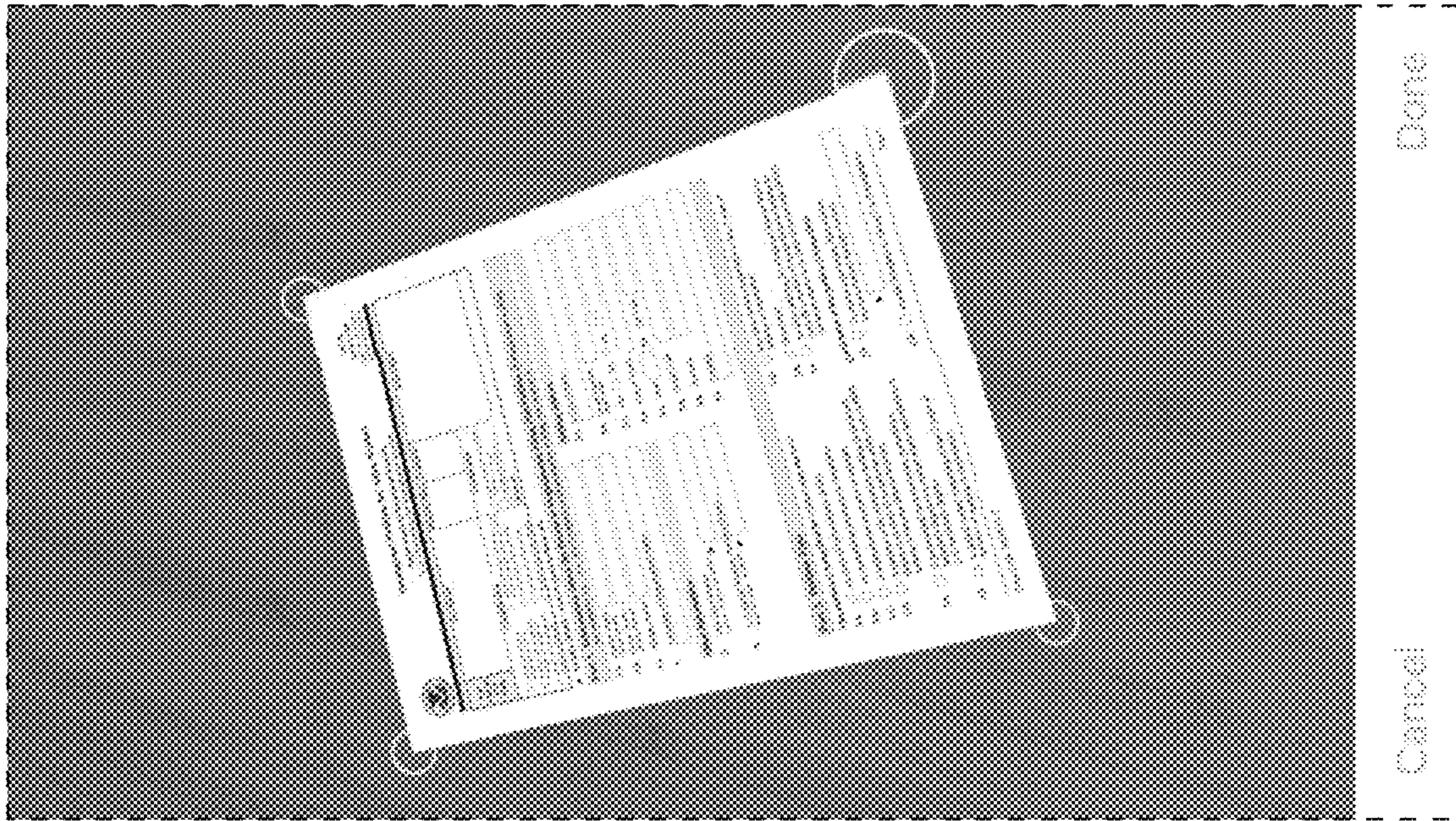

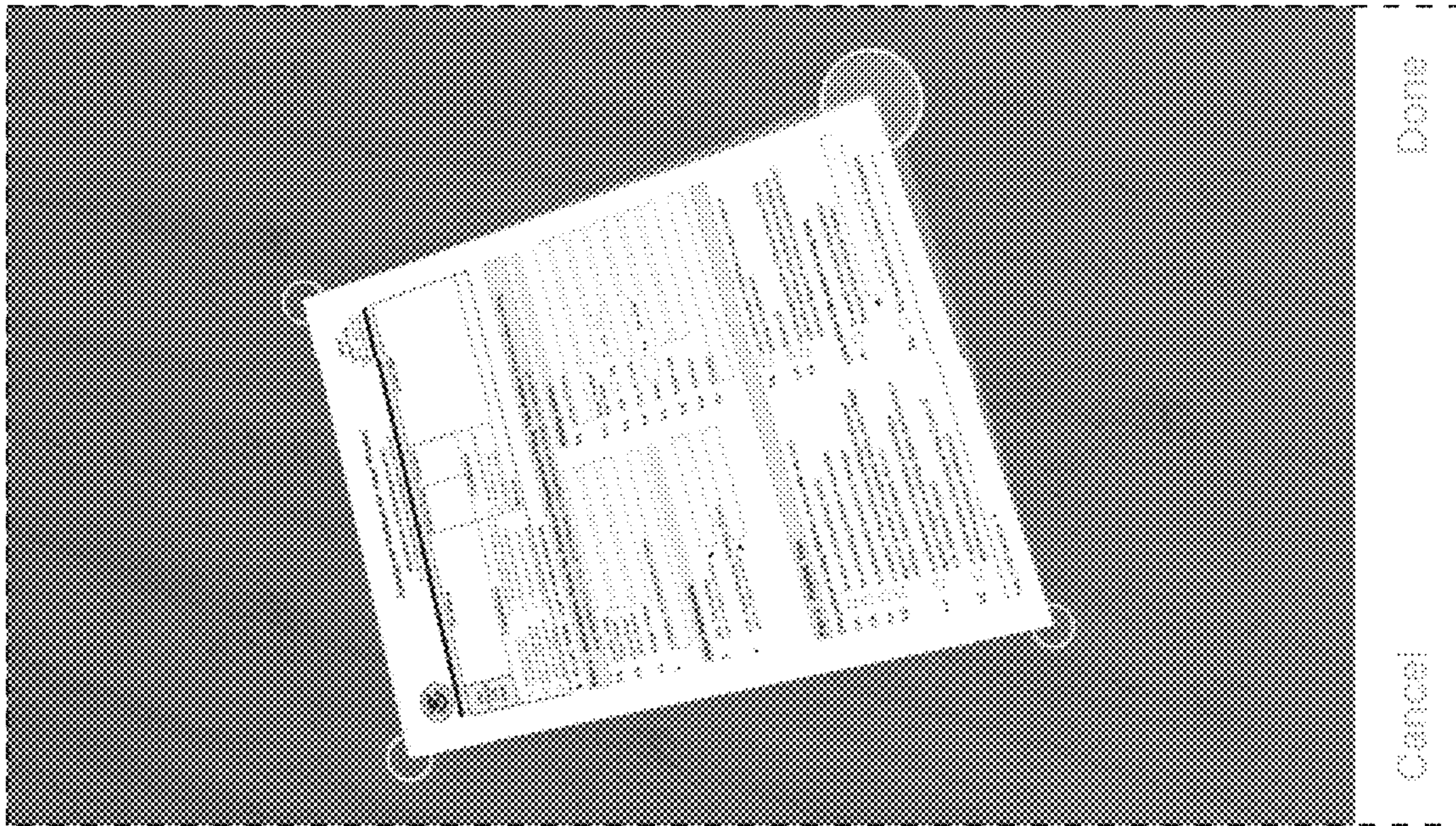
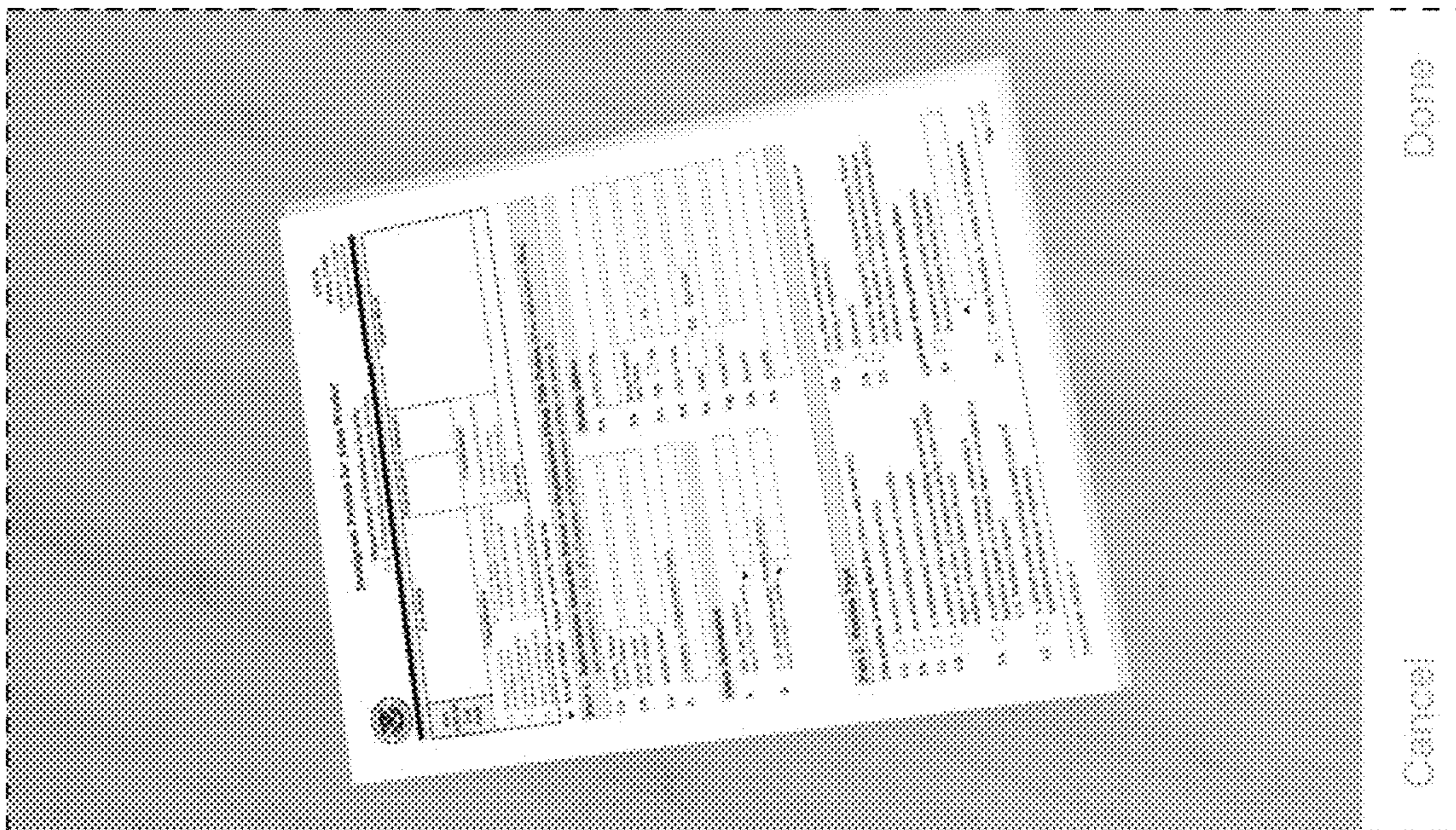
