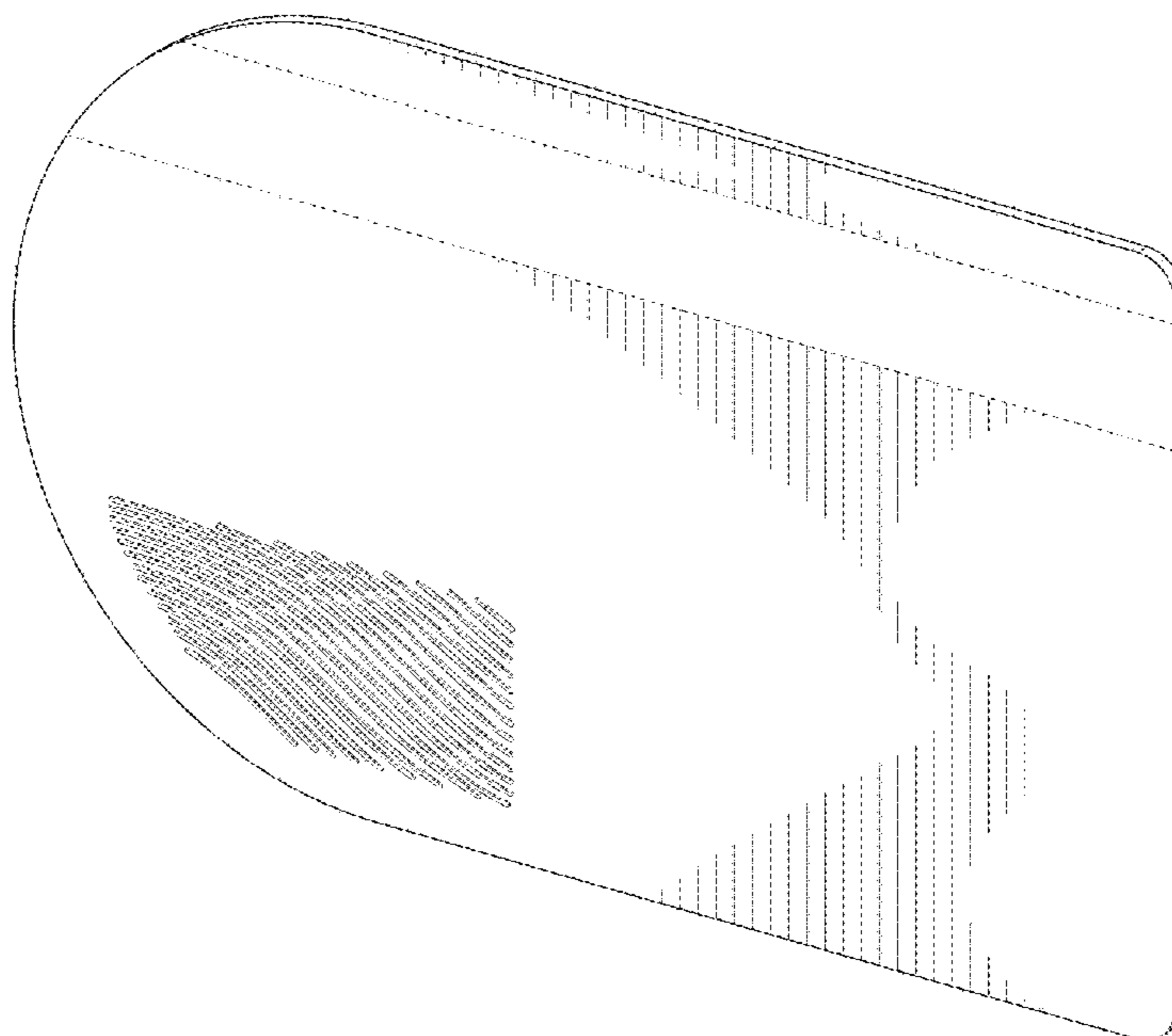
(57) **CLAIM**

The ornamental design for a card with ergonomic texture grip, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of the card with ergonomic textured grip showing our new design; FIG. 2 is a bottom view thereof; FIG. 3 is a top view thereof; FIG. 4 is a first end view thereof; FIG. 5 is a second end view thereof; FIG. 6 is a first side view thereof; and, FIG. 7 is a second side view thereof. The broken lines showing portions of the card with ergonomic textured grip are included for the purpose of illustrating environmental structure and form no part of the claimed design.

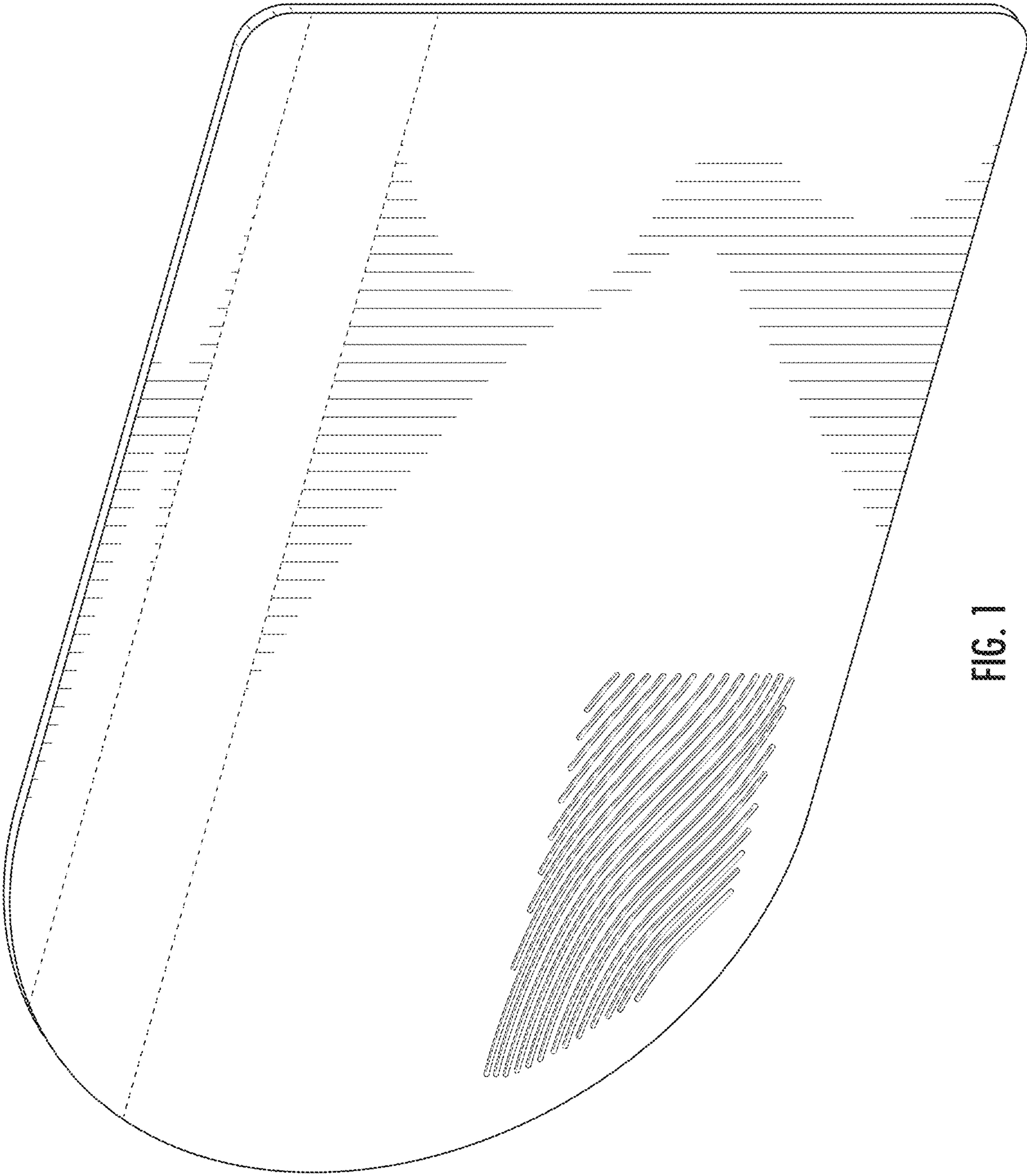

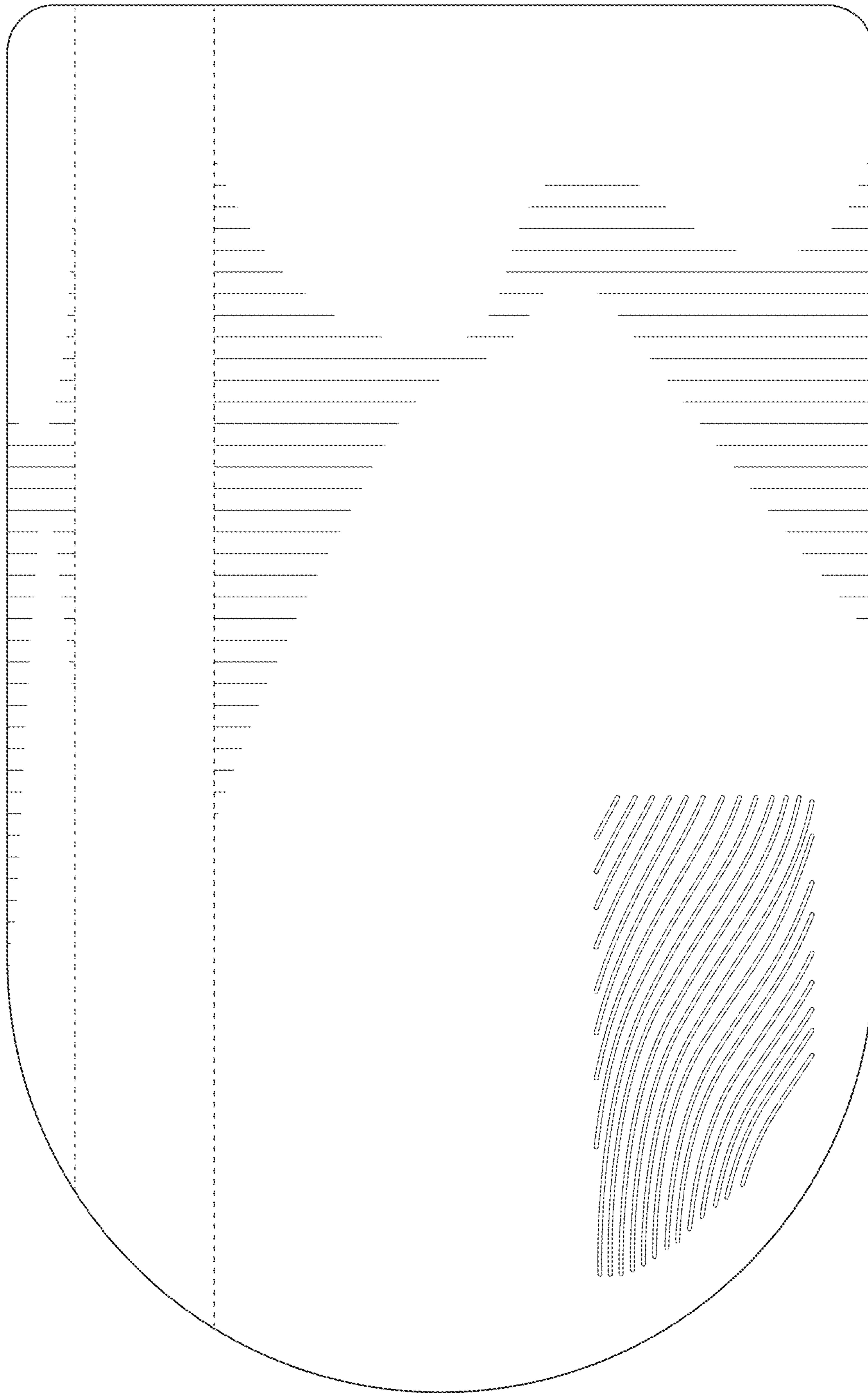

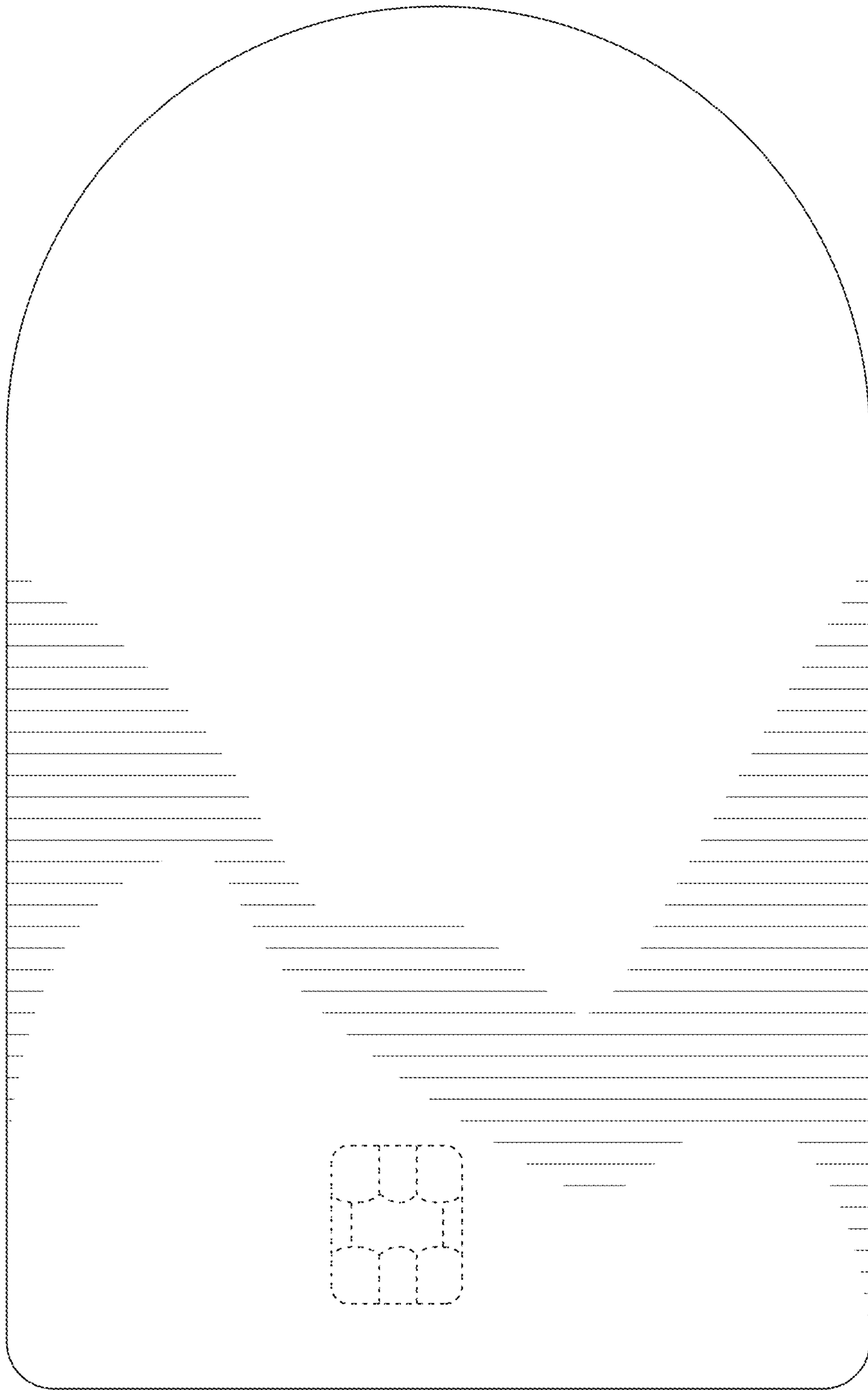

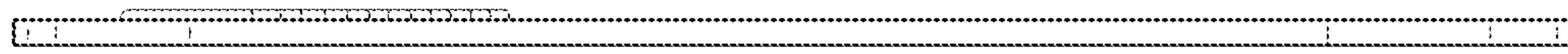

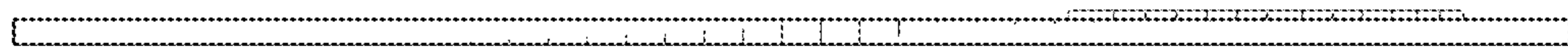

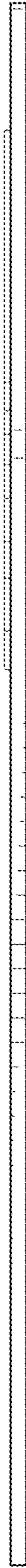
