(57) **CLAIM**

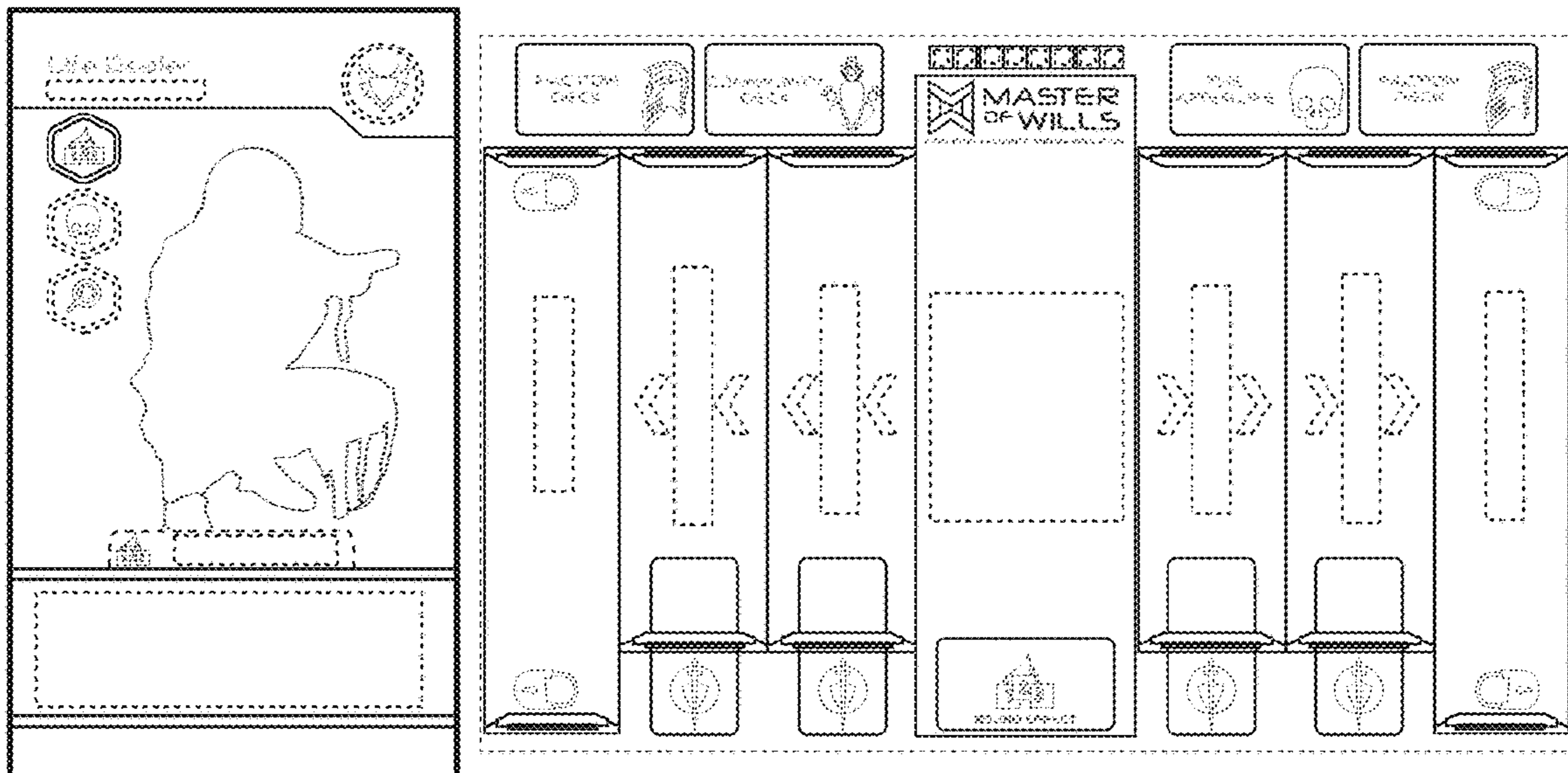
I claim the ornamental design for a game equipment including a card and a playing board, as shown.

**DESCRIPTION**

FIG. 1 is a plan view of the front the card;  
 FIG. 2 is a plan view of the back of the card;  
 FIG. 3 is a left side view of the card;  
 FIG. 4 is a right side view of the card;  
 FIG. 5 is a top view of the card;  
 FIG. 6 is a bottom view of the card;  
 FIG. 7 is a plan view of the top of the playing board;  
 FIG. 8 is a plan view of the bottom of the playing board;  
 FIG. 9 is a left side view of the playing board;  
 FIG. 10 is a right side view of the playing board;  
 FIG. 11 is a front view of the playing board;  
 FIG. 12 is a rear view of the playing board; and,  
 FIG. 13 is a rear view of the game board.

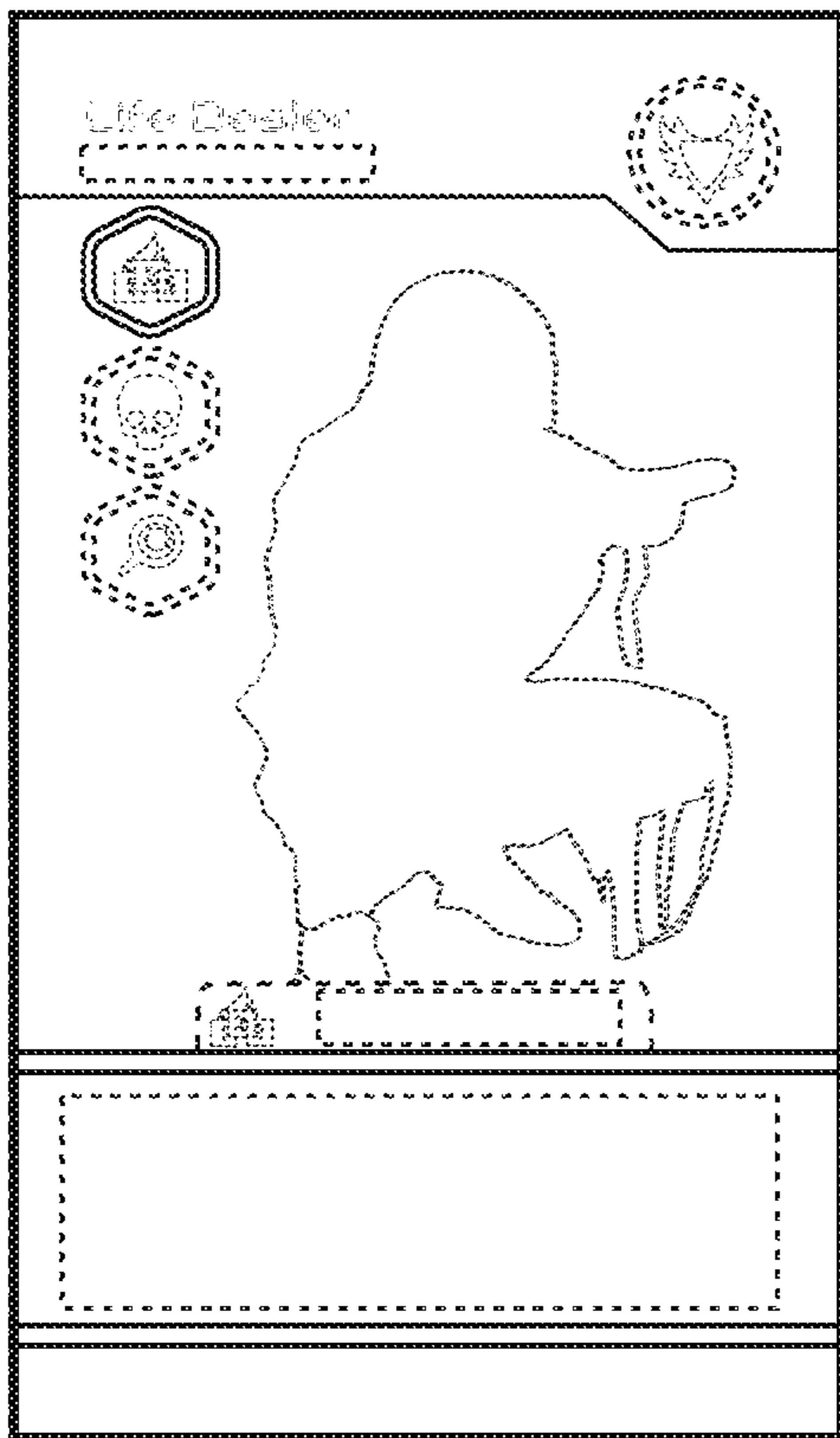

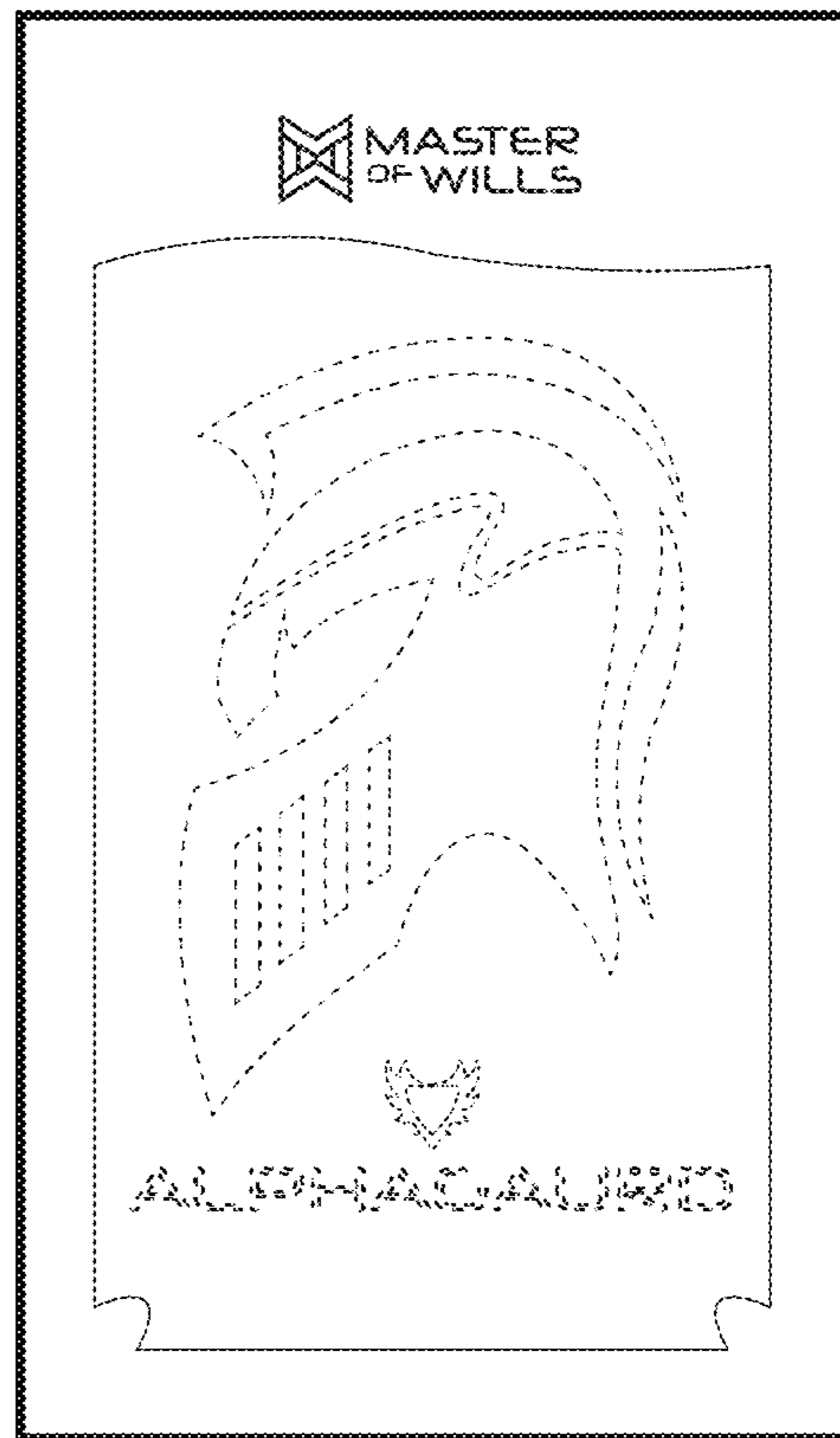

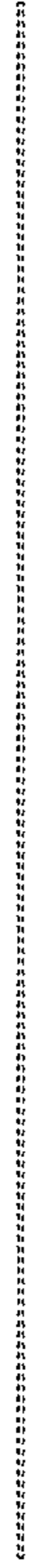

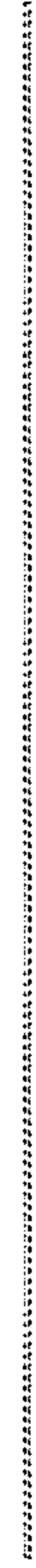

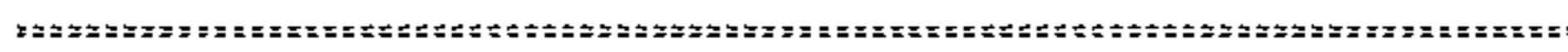

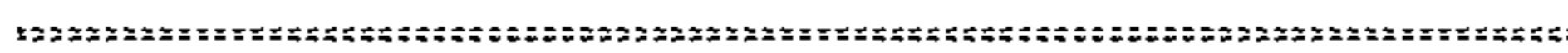

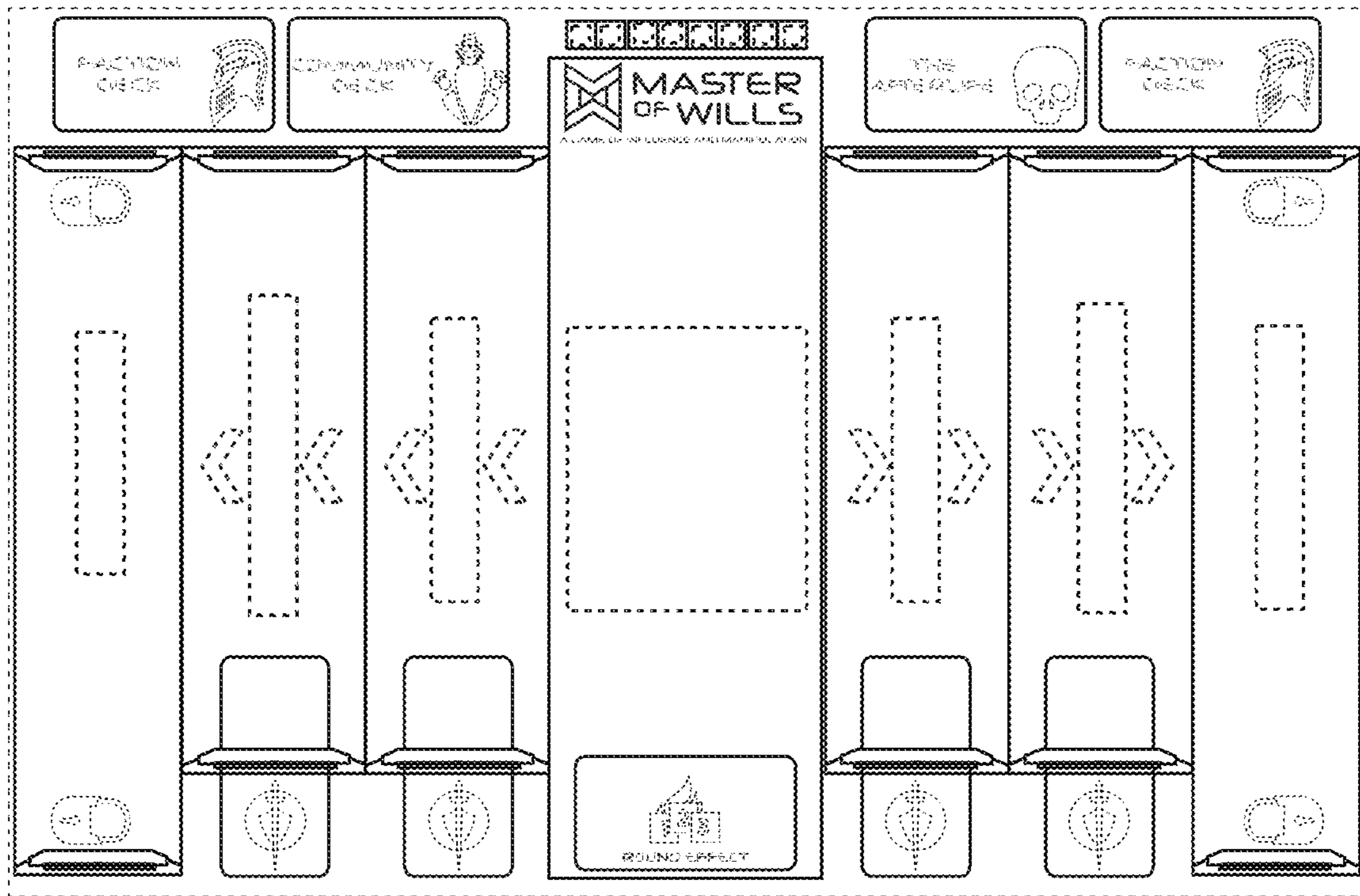

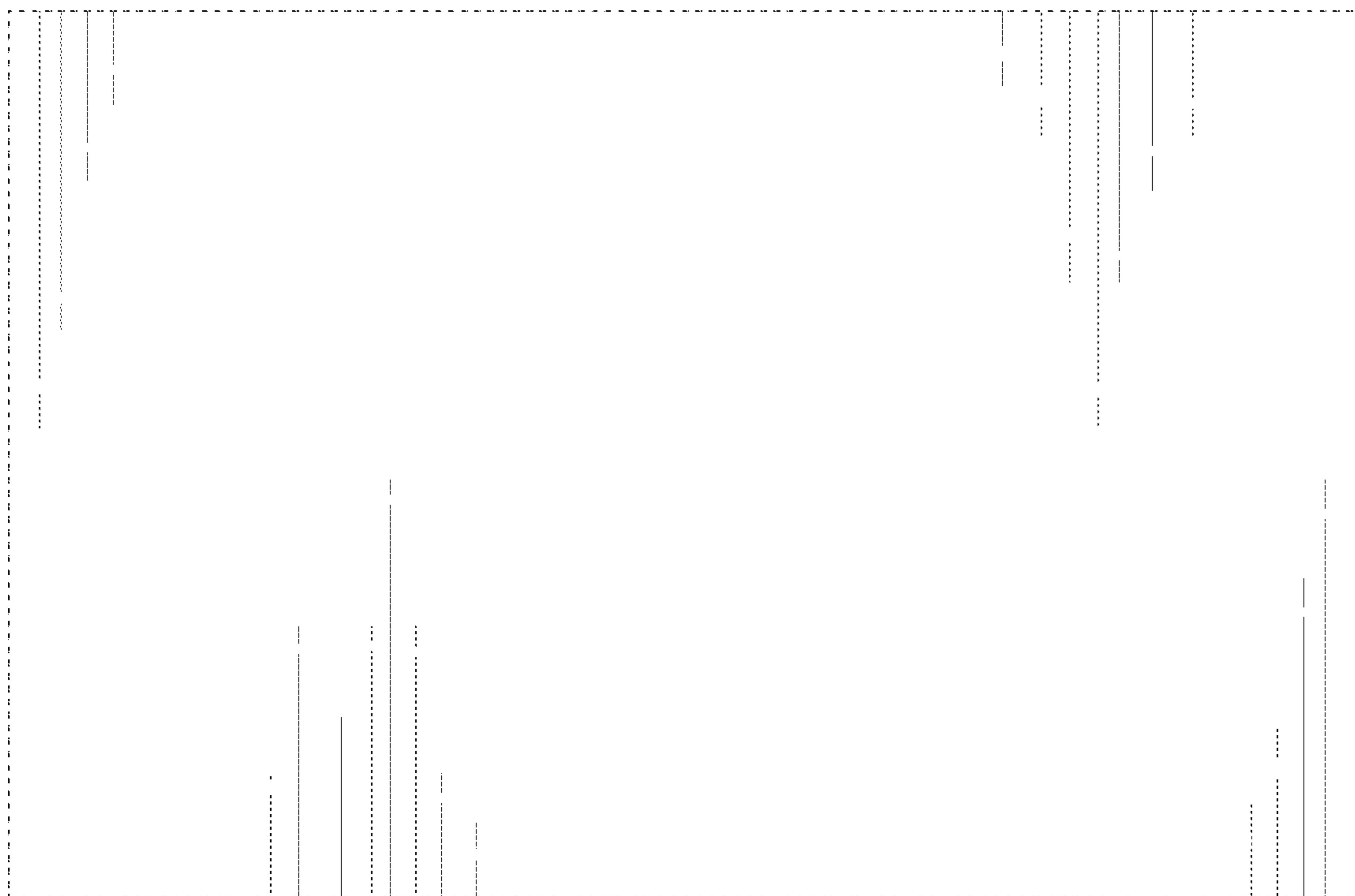

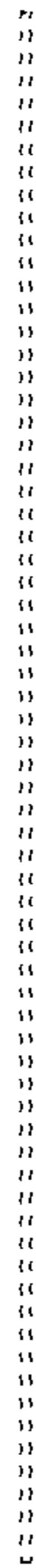

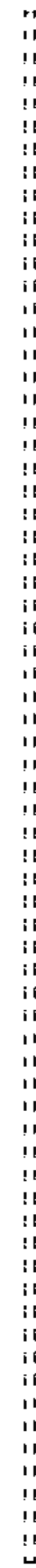

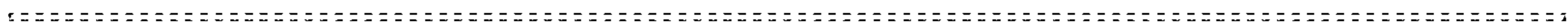

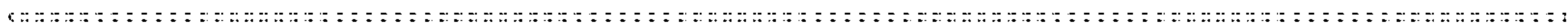
