FIG. 2 is a front plan view of the massage device of FIG. 1.

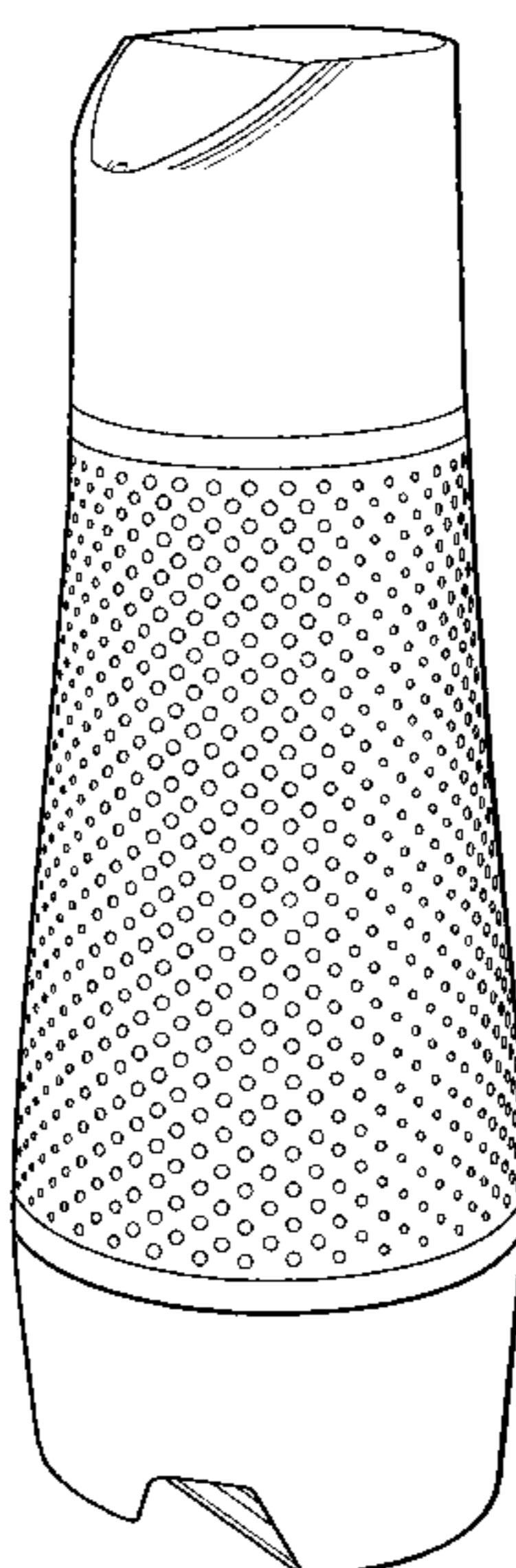
FIG. 3 is a back of the massage device of FIG. 1.

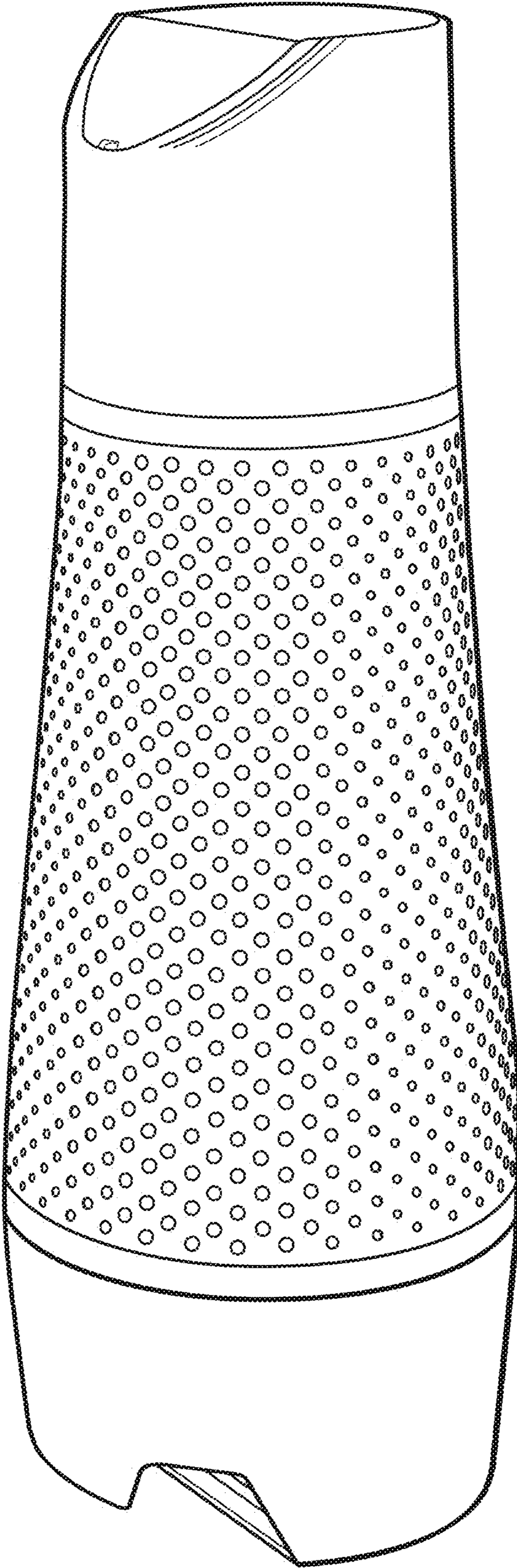

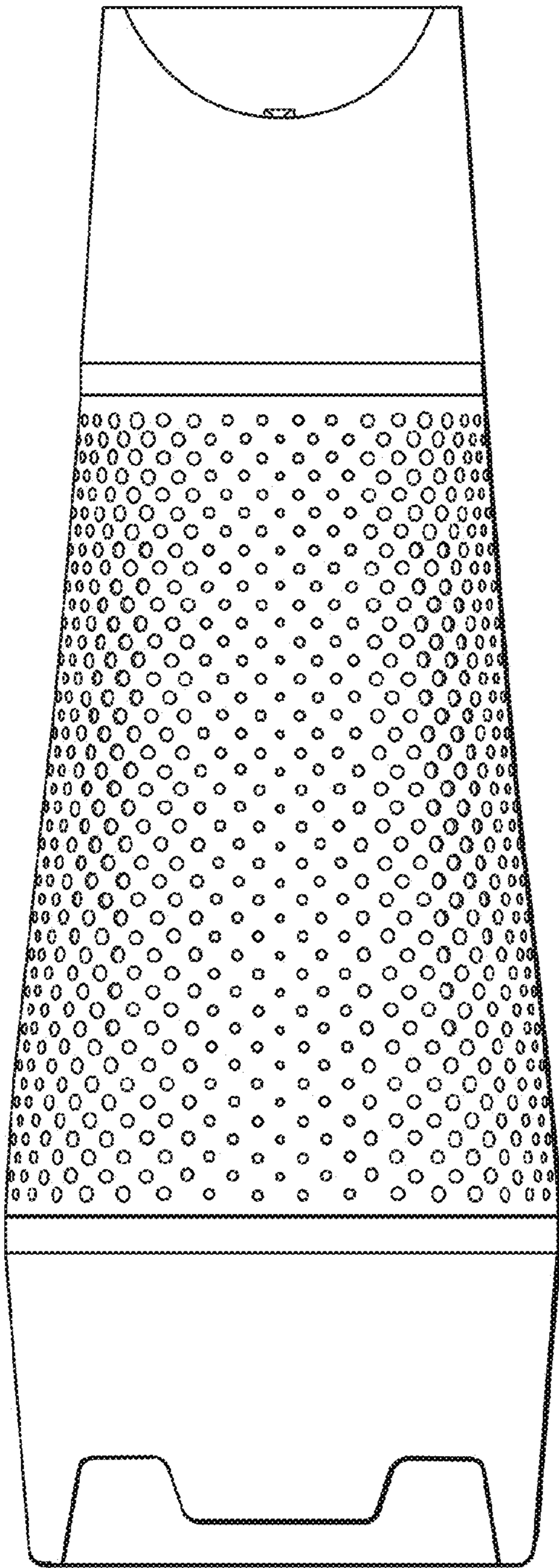

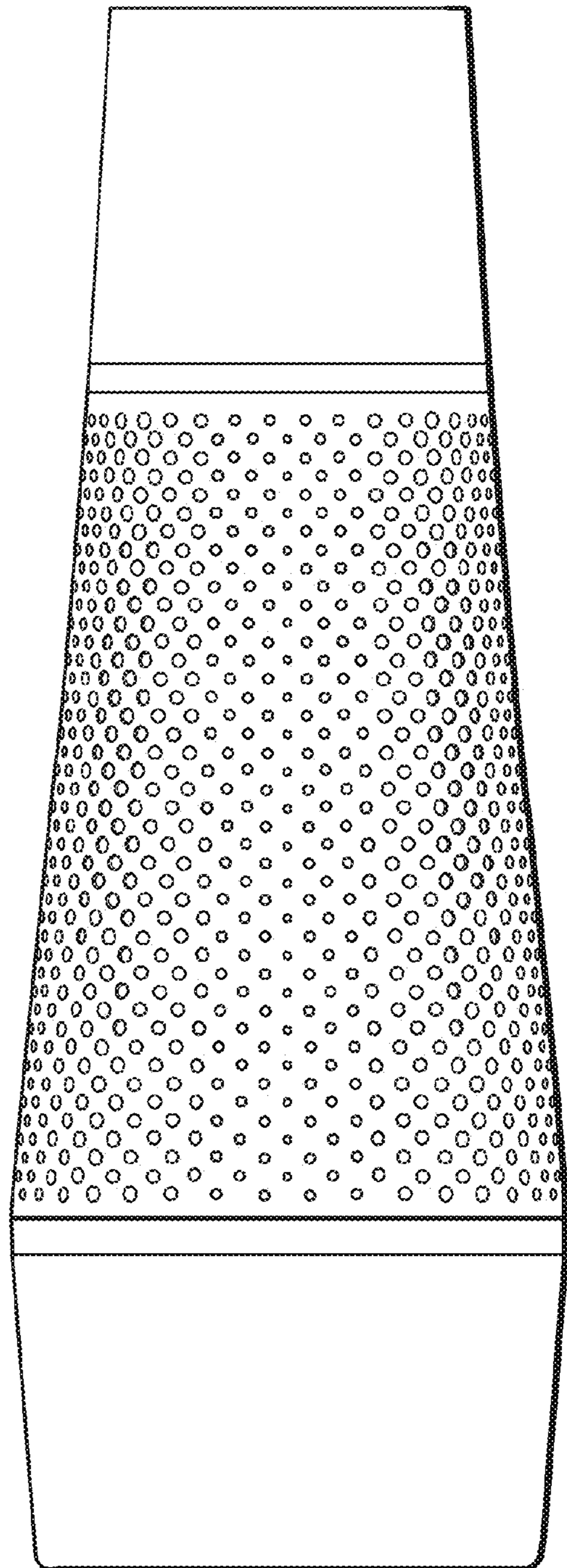

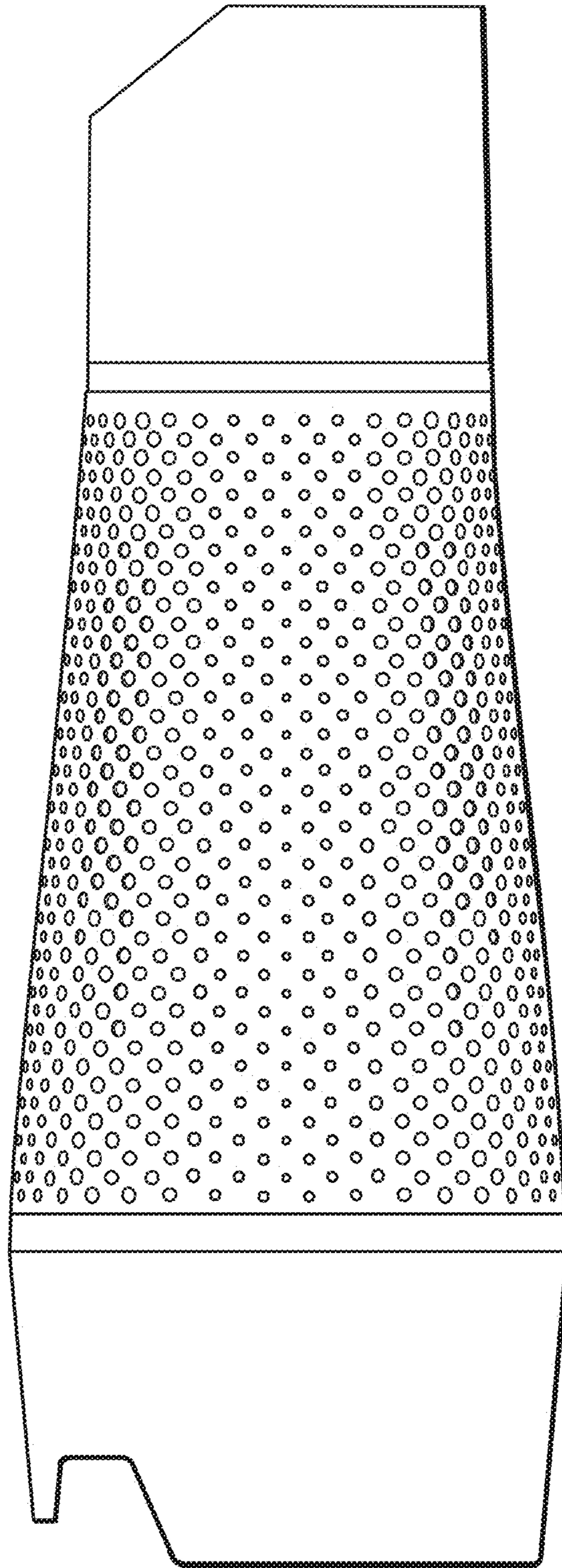

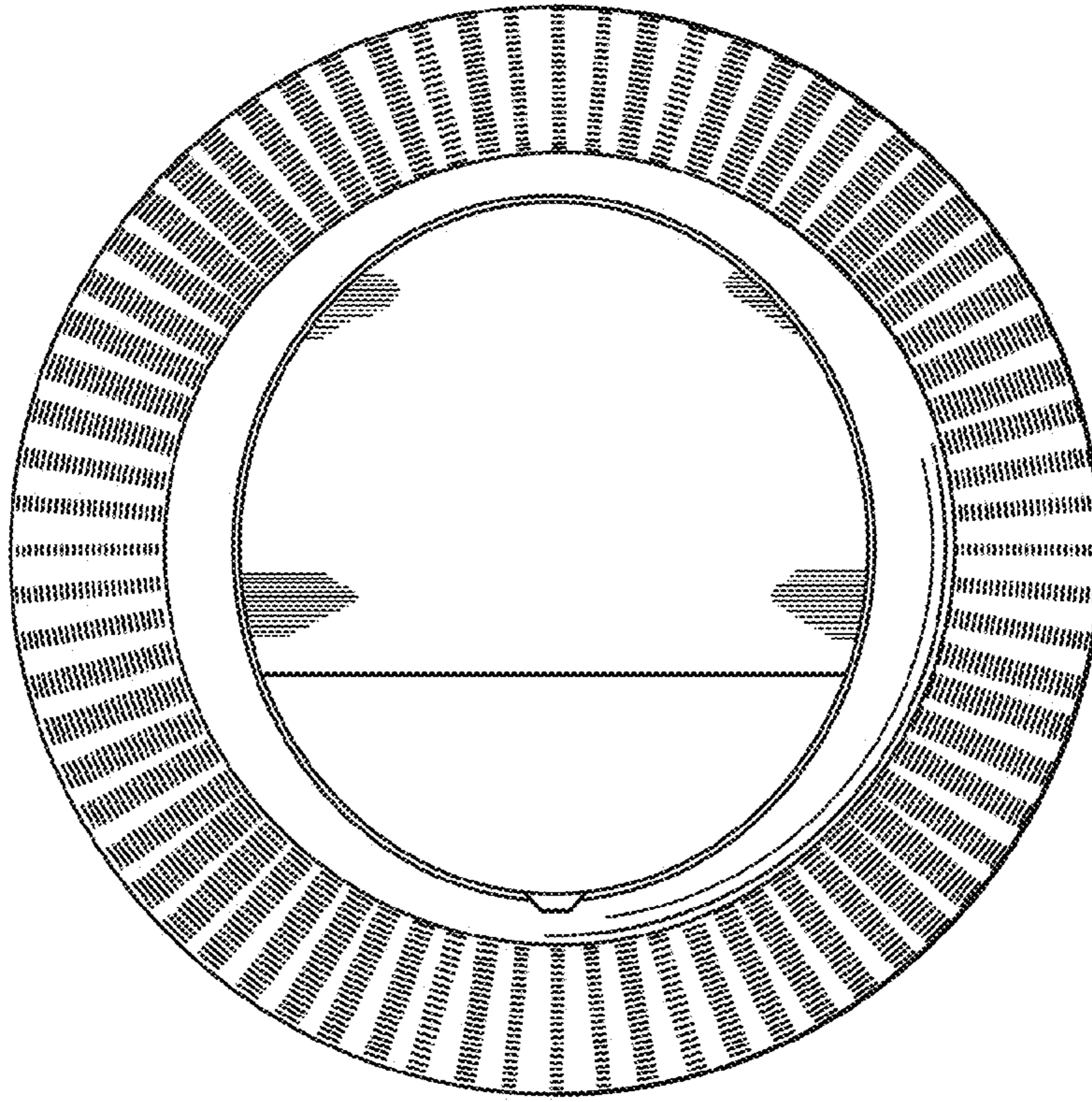

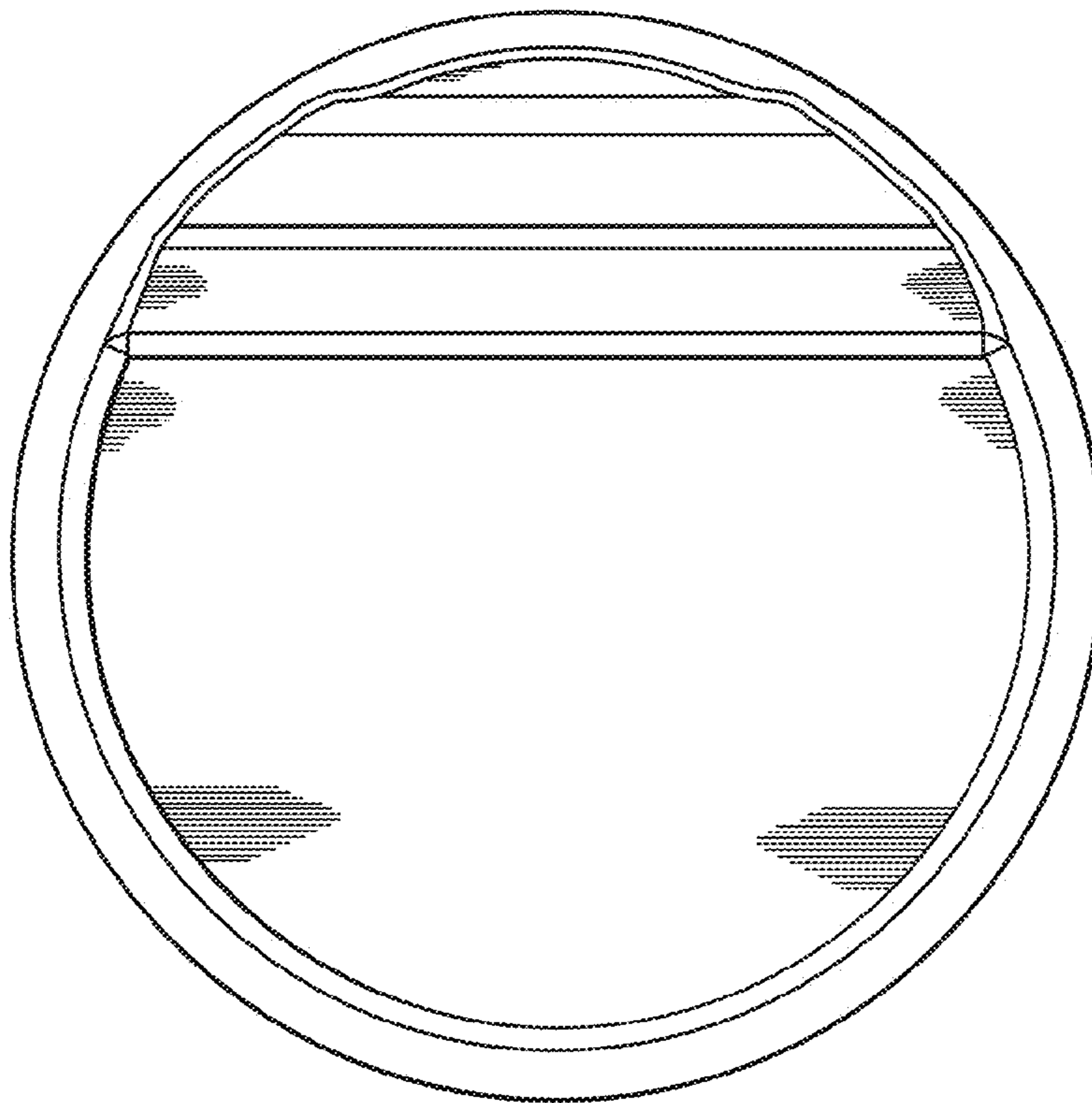
