(57) **CLAIM**

The ornamental design for a horticulture grow light, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a horticulture grow light, as viewed from above, showing my new design;

FIG. 2 is a perspective view of the horticulture grow light shown in FIG. 1, as viewed from below;

FIG. 3 is a left side elevation view of the horticulture grow light shown in FIG. 1;

FIG. 4 is a right side elevation view of the horticulture grow light shown in FIG. 1;

FIG. 5 is a front elevation view of the horticulture grow light shown in FIG. 1;

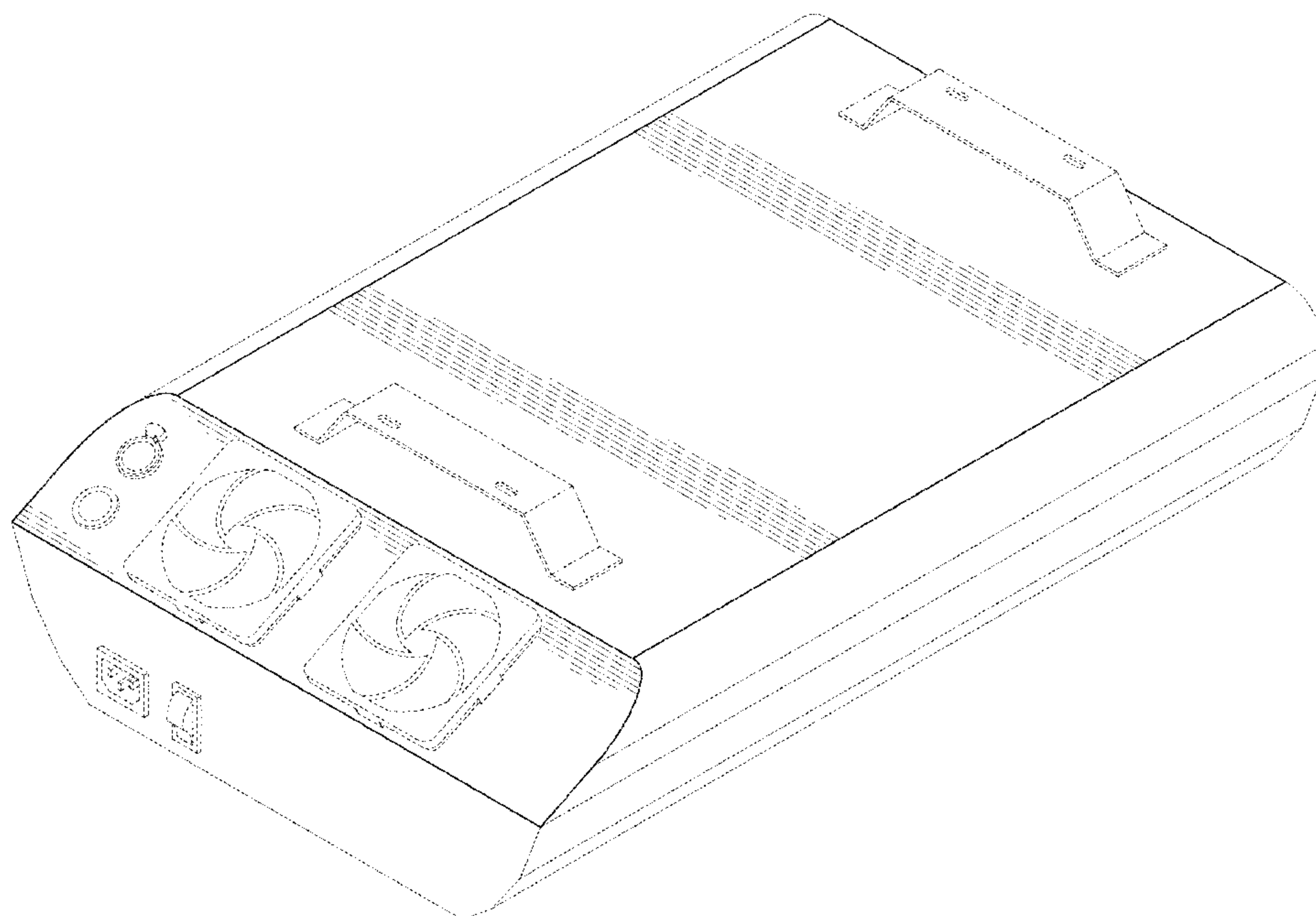
FIG. 6 is a rear elevation view of the horticulture grow light shown in FIG. 1;

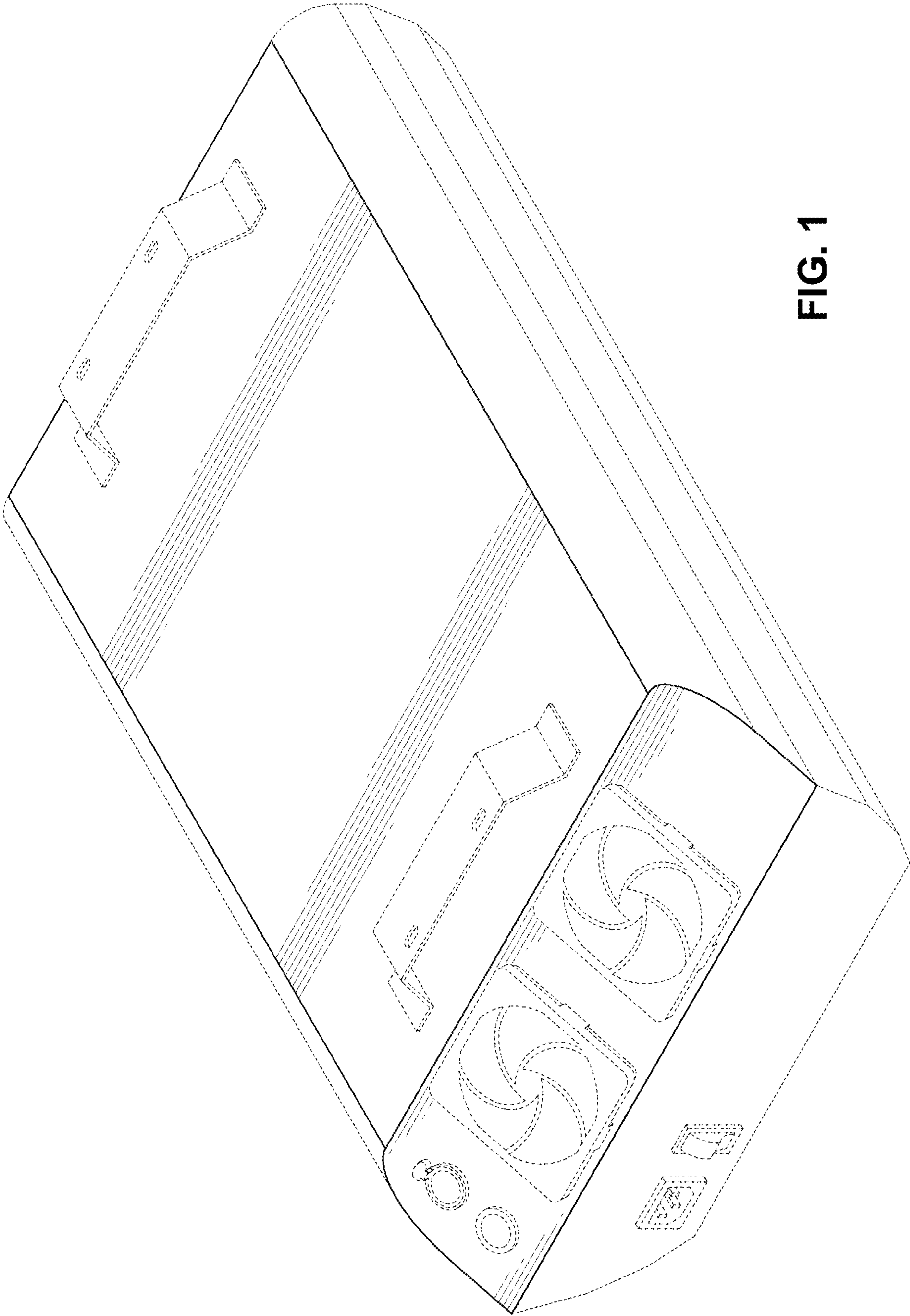

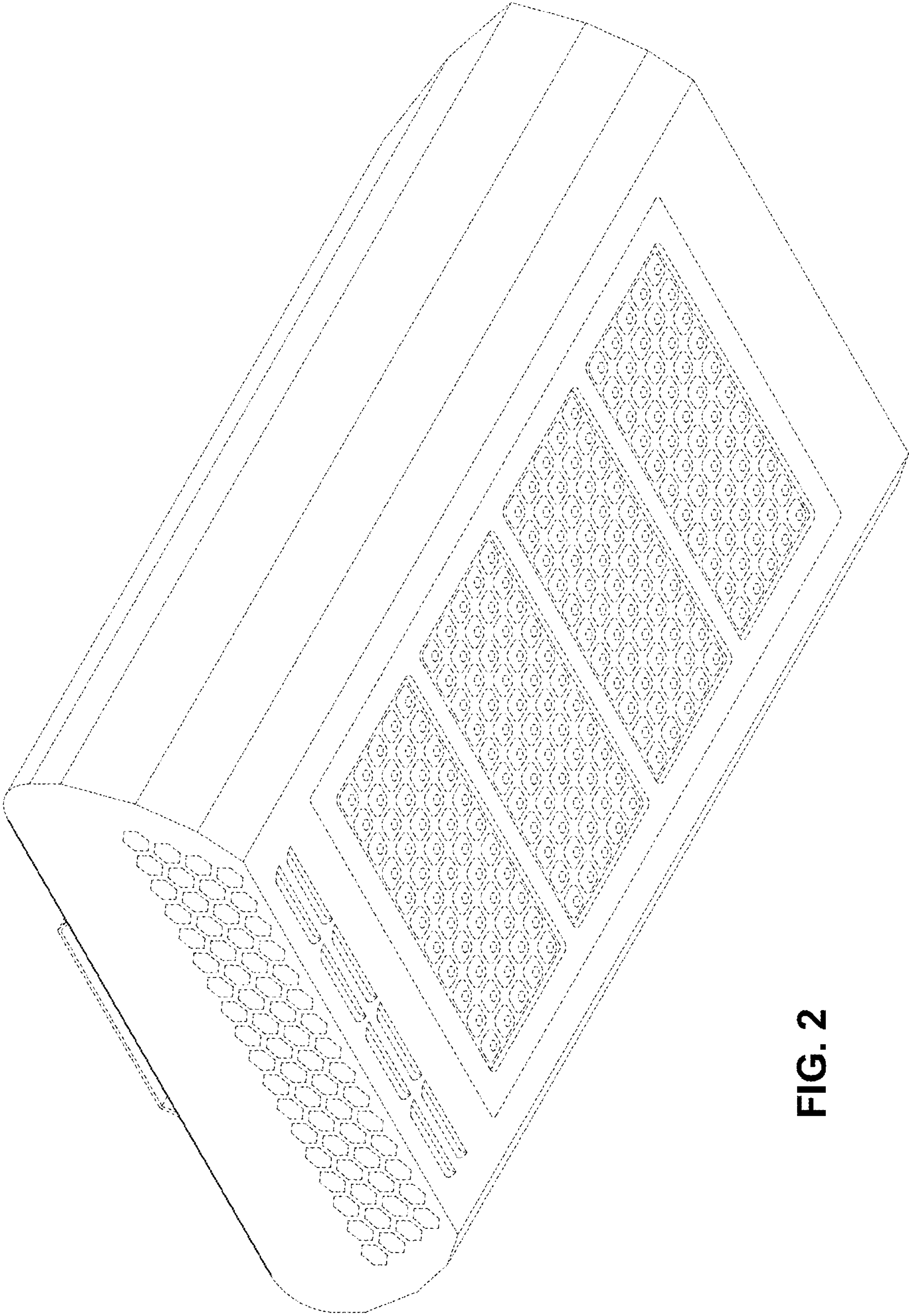

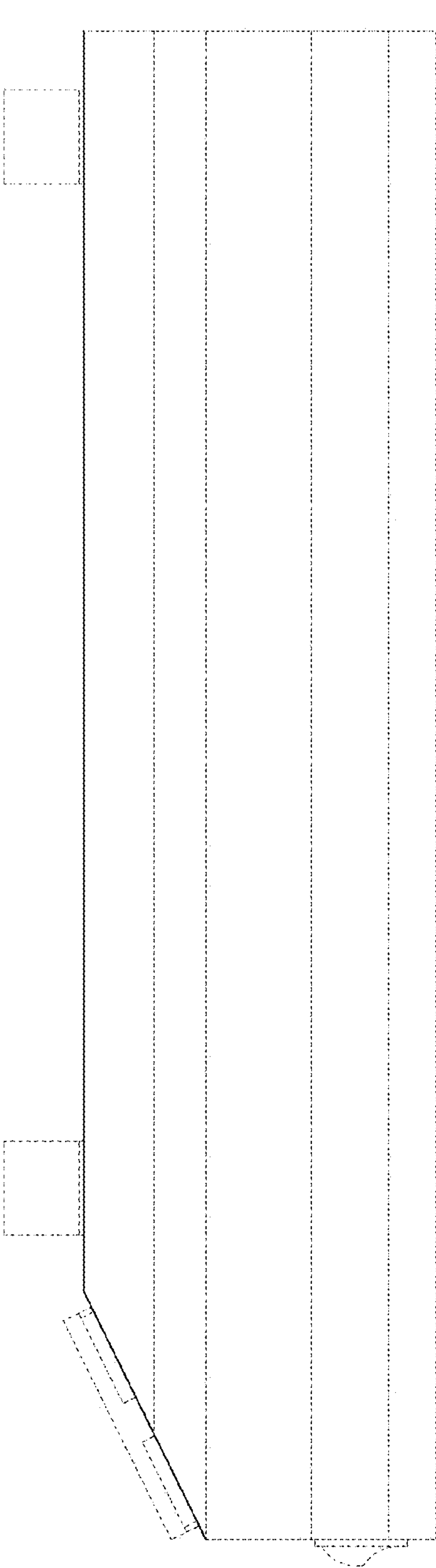

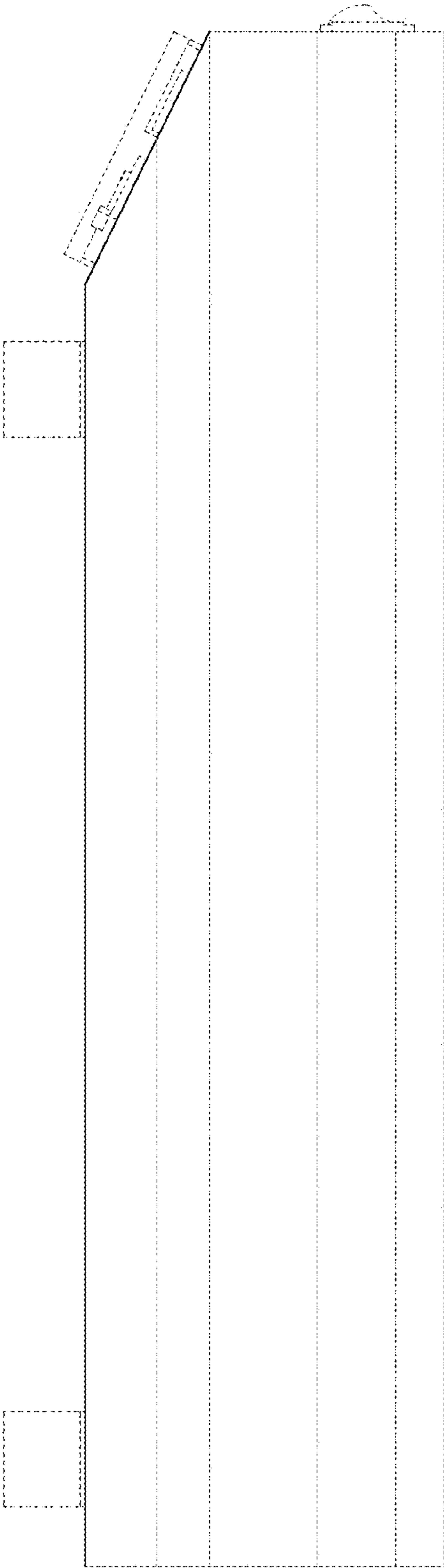

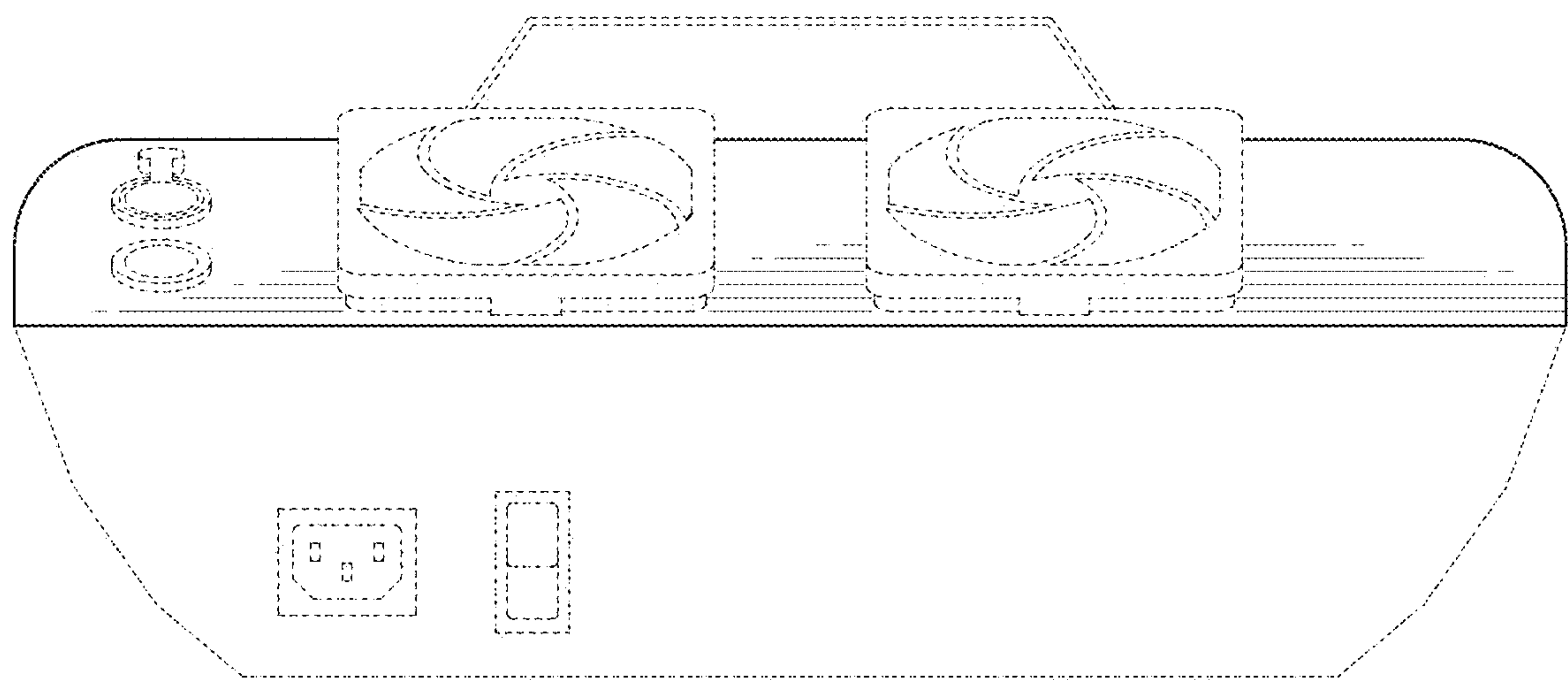

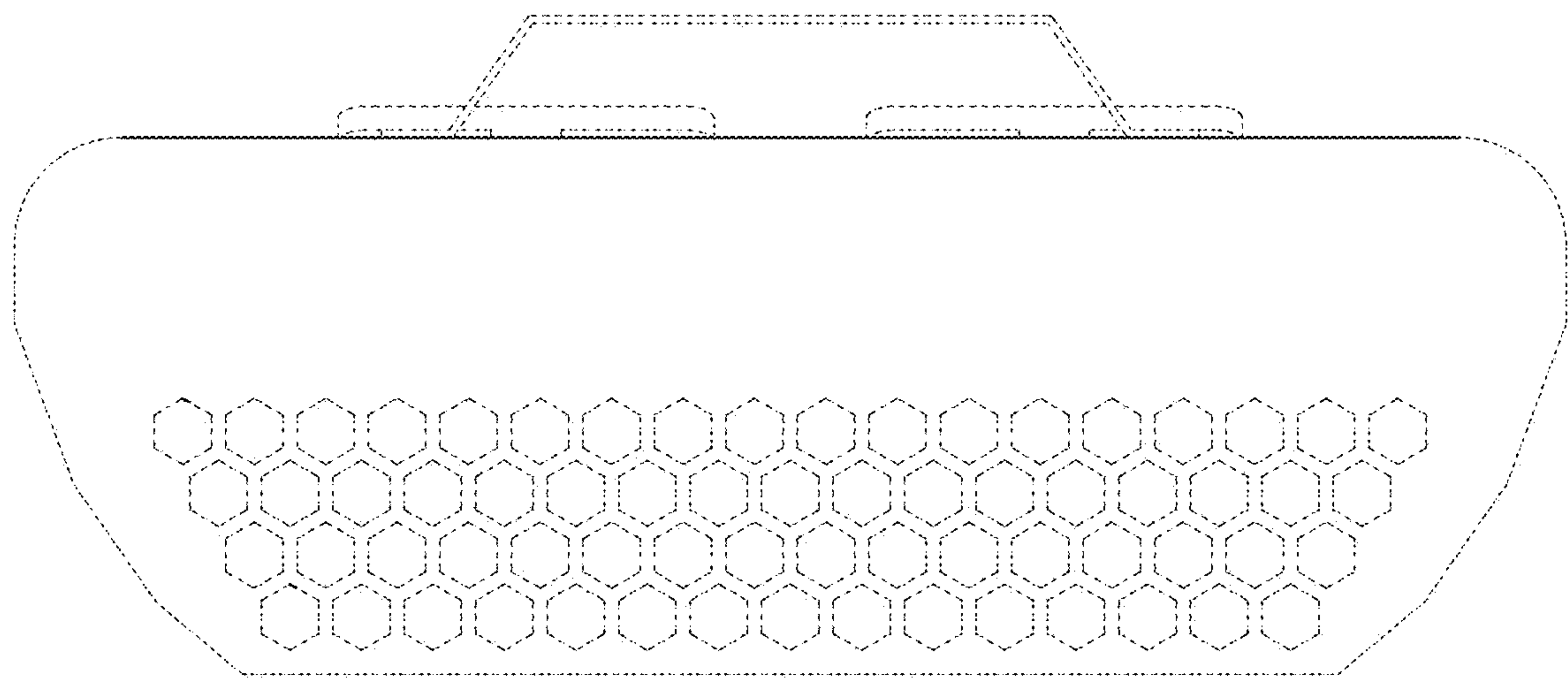

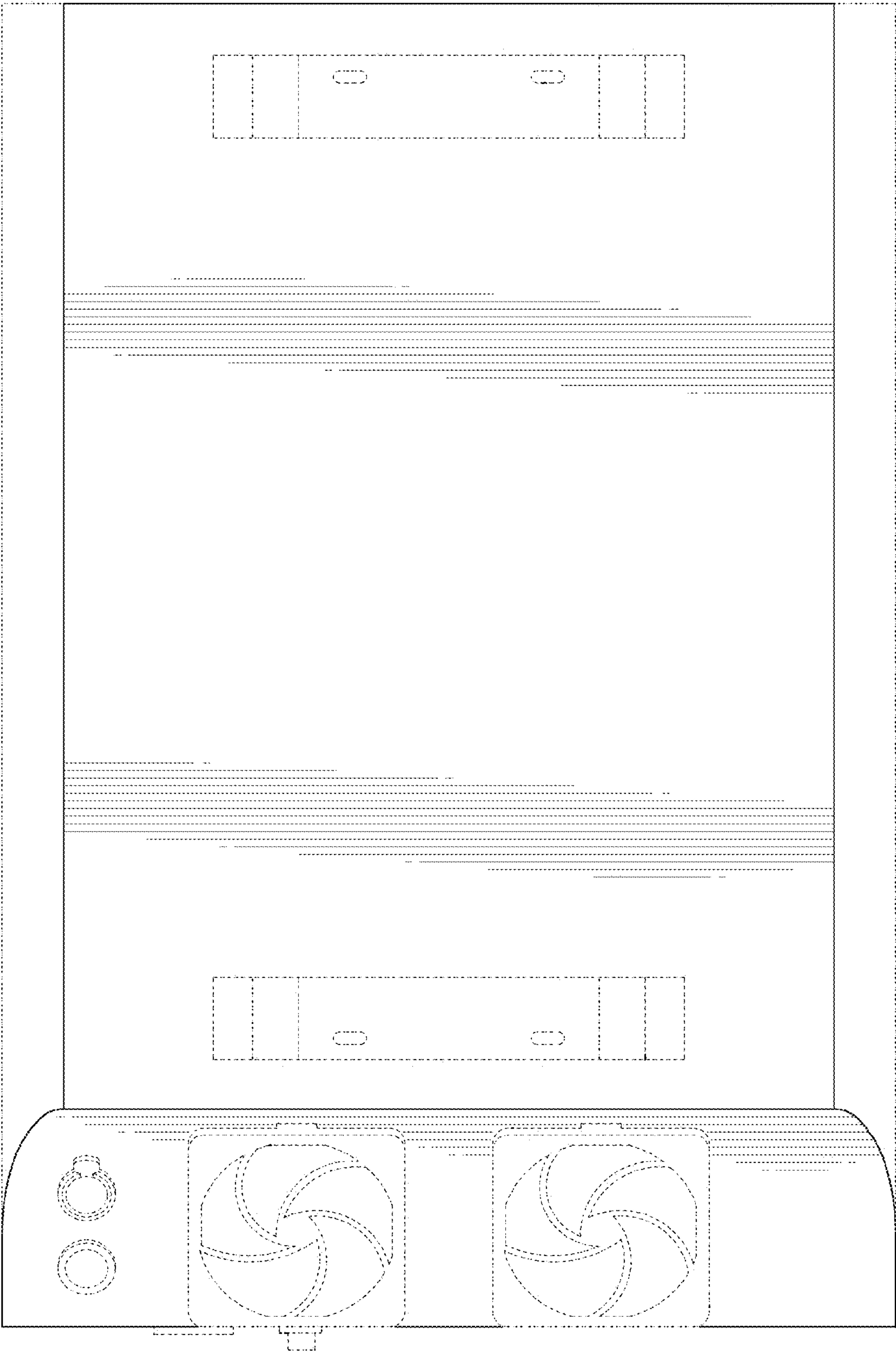

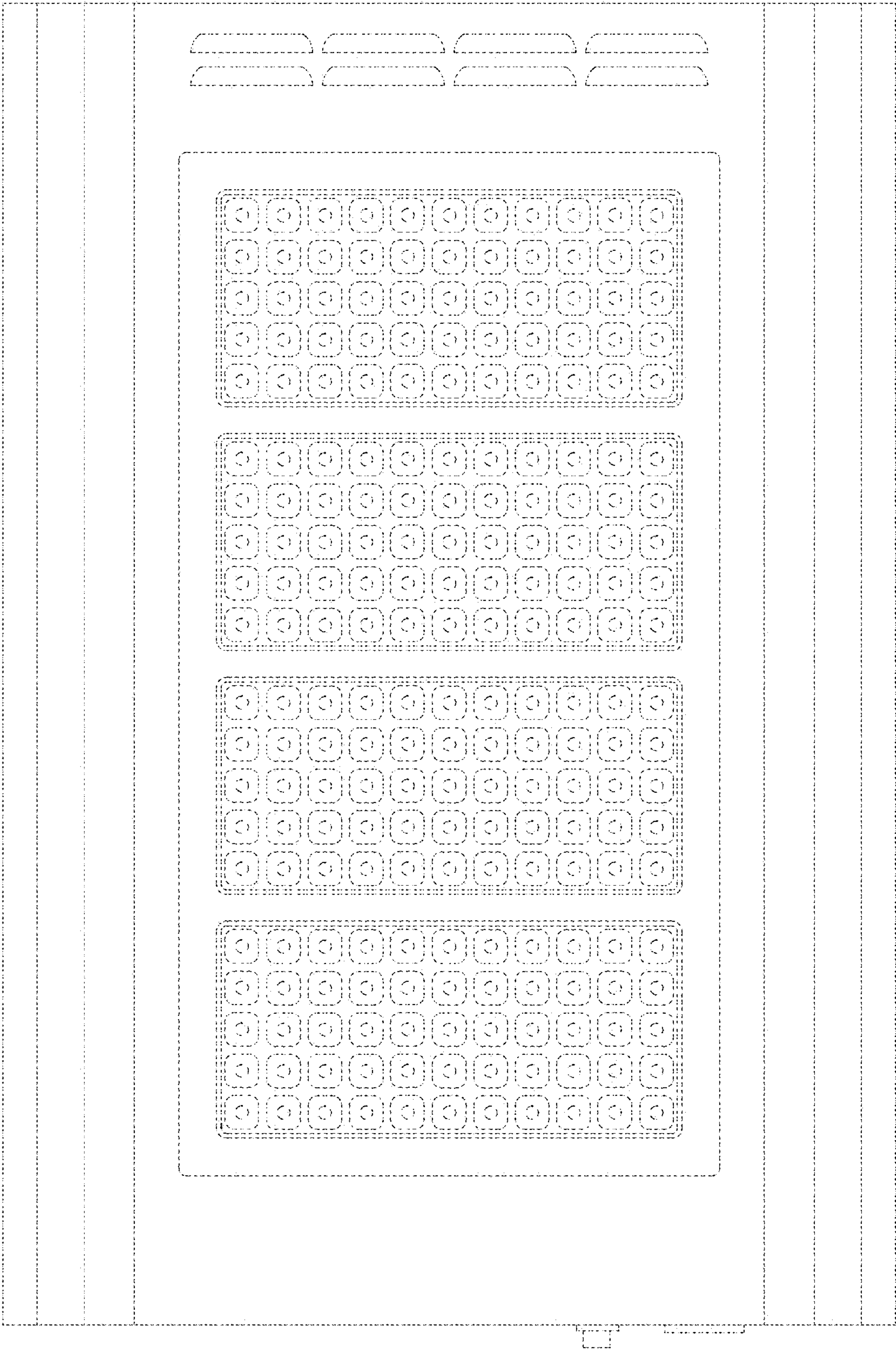
