(57) **CLAIM**

The ornamental design for a microfiber hair curling glove, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a microfiber hair curling glove showing our new design in a state of use;
FIG. 2 is a front view of a microfiber hair curling glove showing our new design when not in use;
FIG. 3 is a back view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The broken lines illustrate portions of the microfiber hair curling glove that do not form a part of the claimed design.

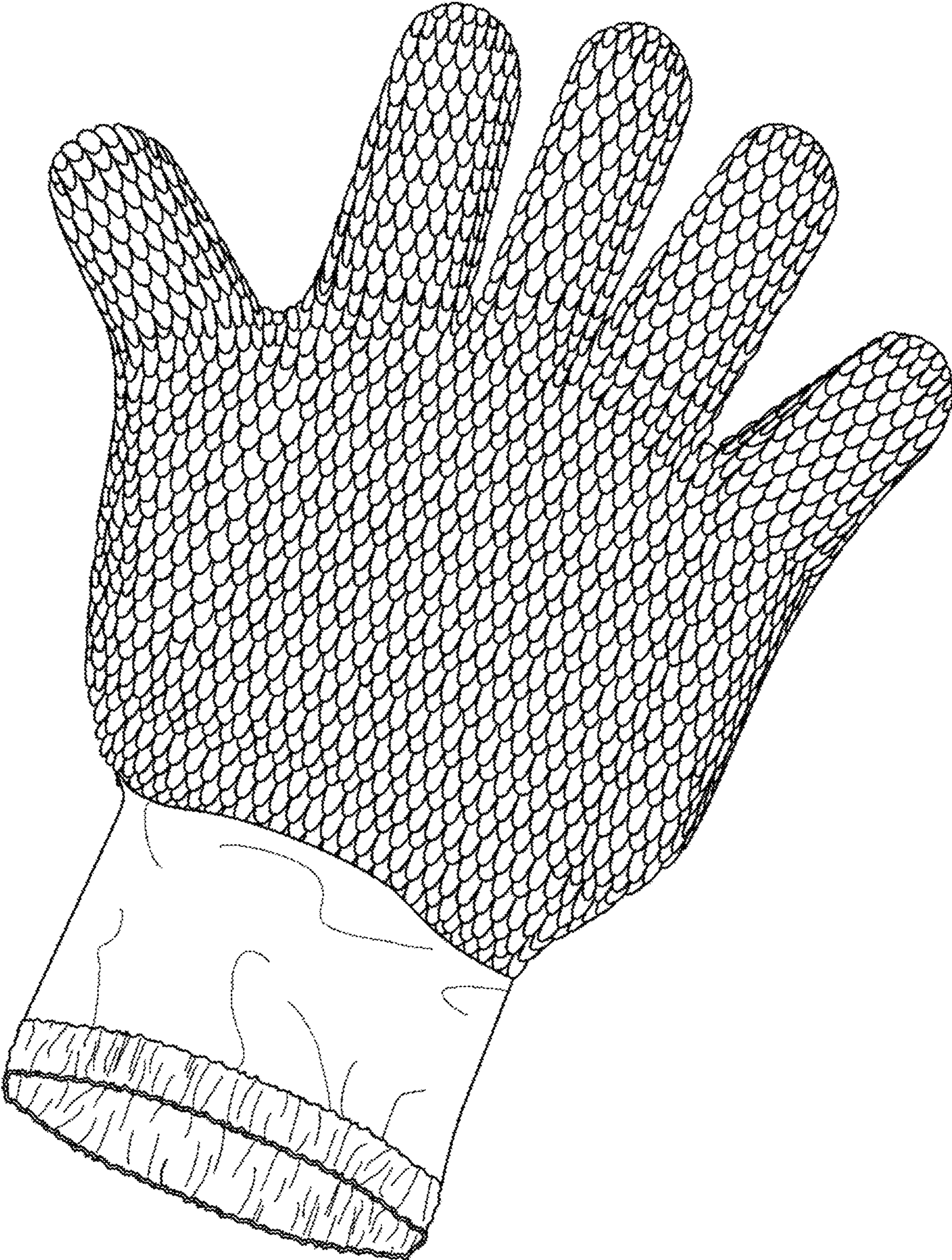

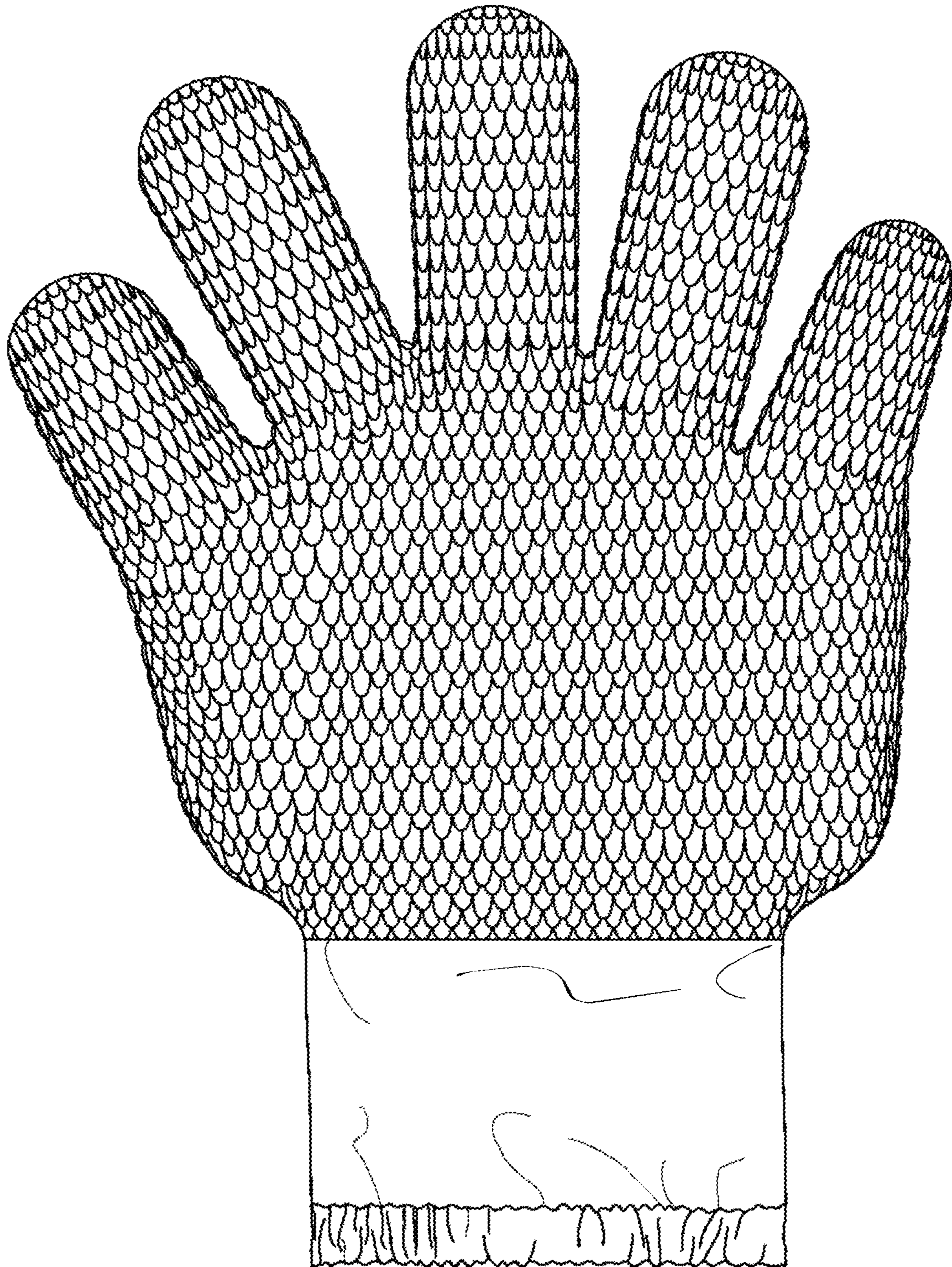

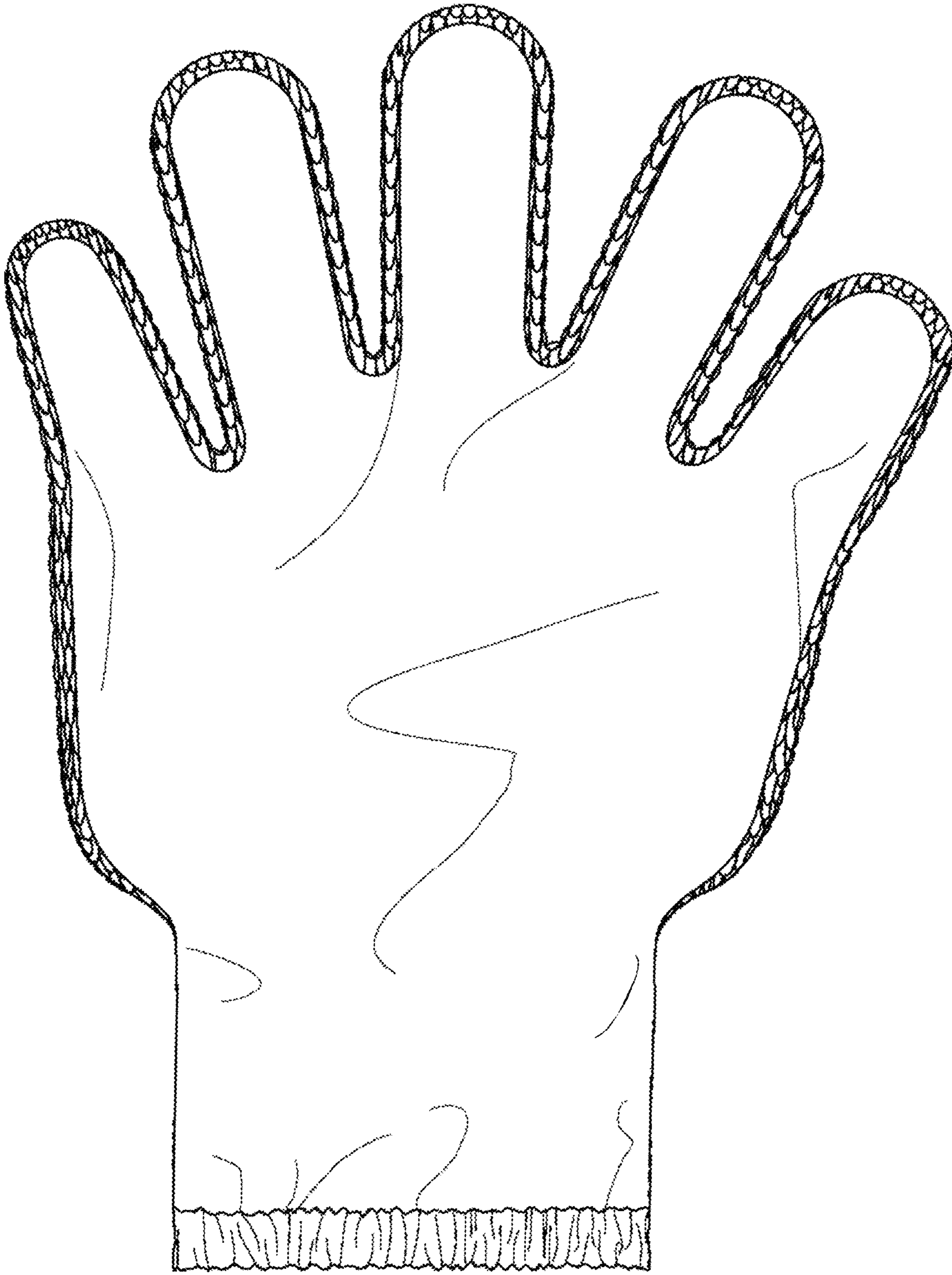

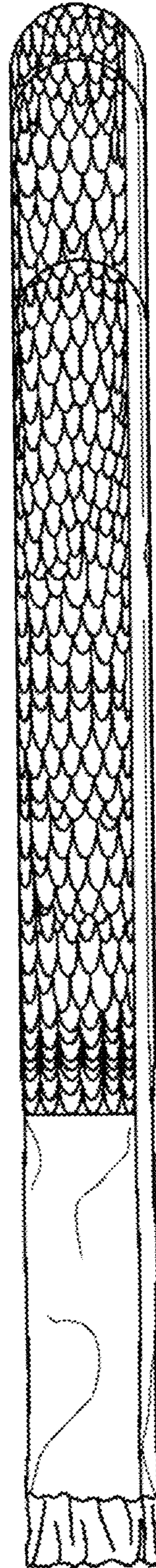

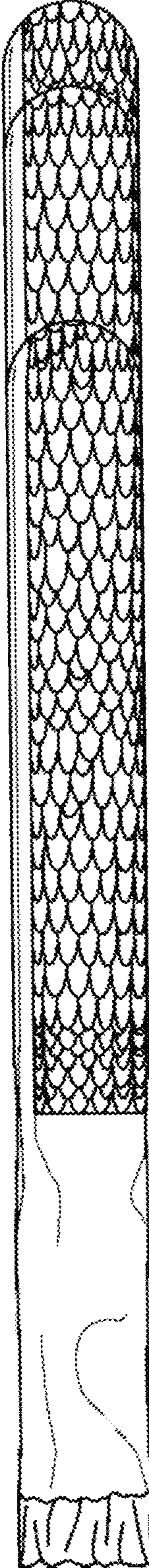

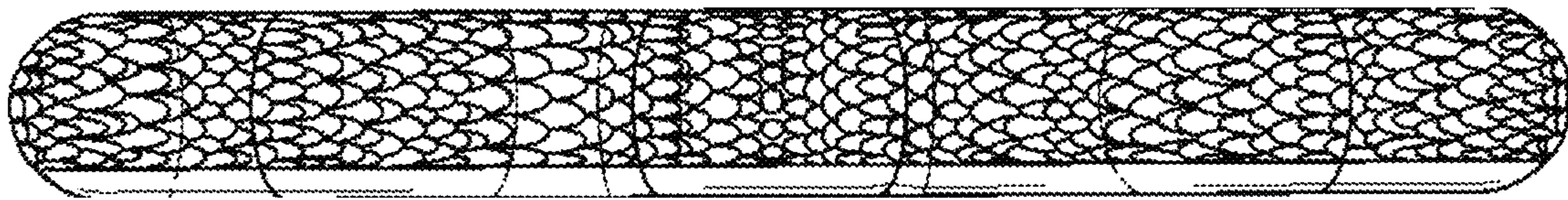
