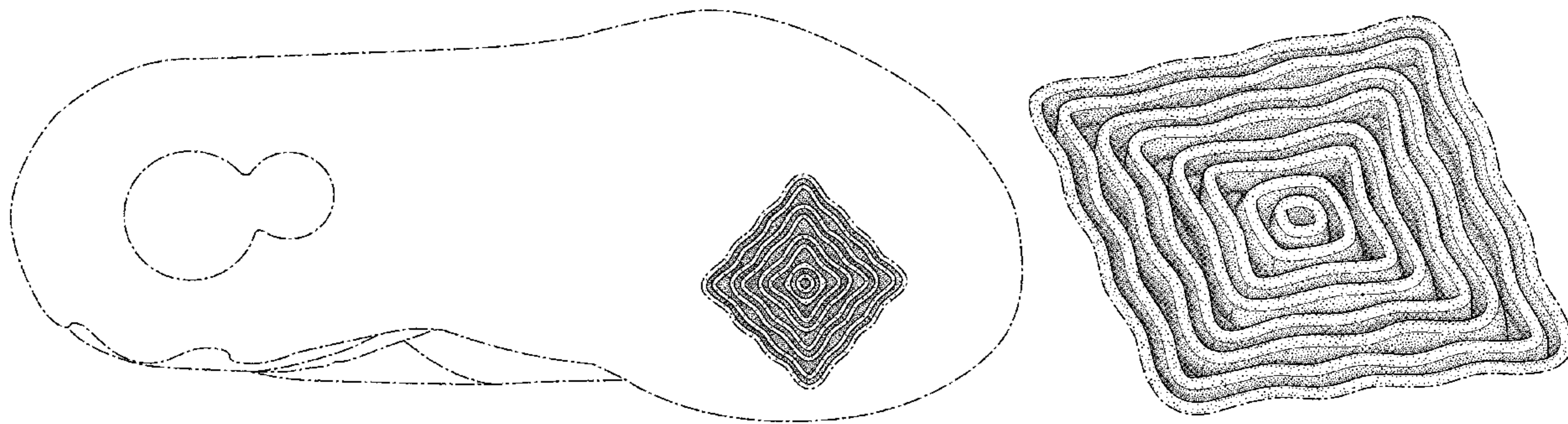
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is an enlarged view of the claimed design shown in FIG. 1 with environment removed for clarity purposes.
The broken line immediately adjacent to and surrounding the shaded area defines the peripheral bounds of the claimed design and forms no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

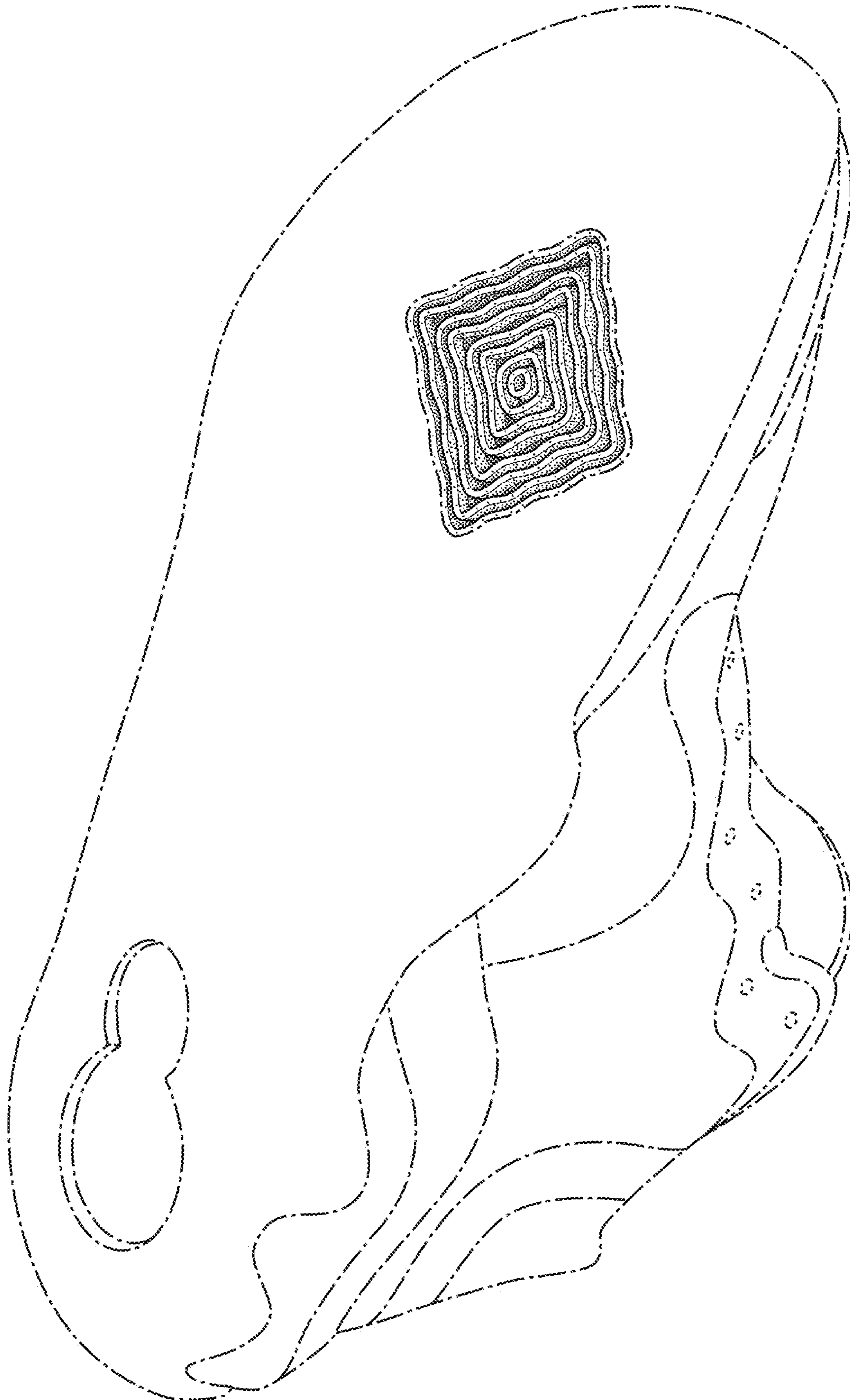

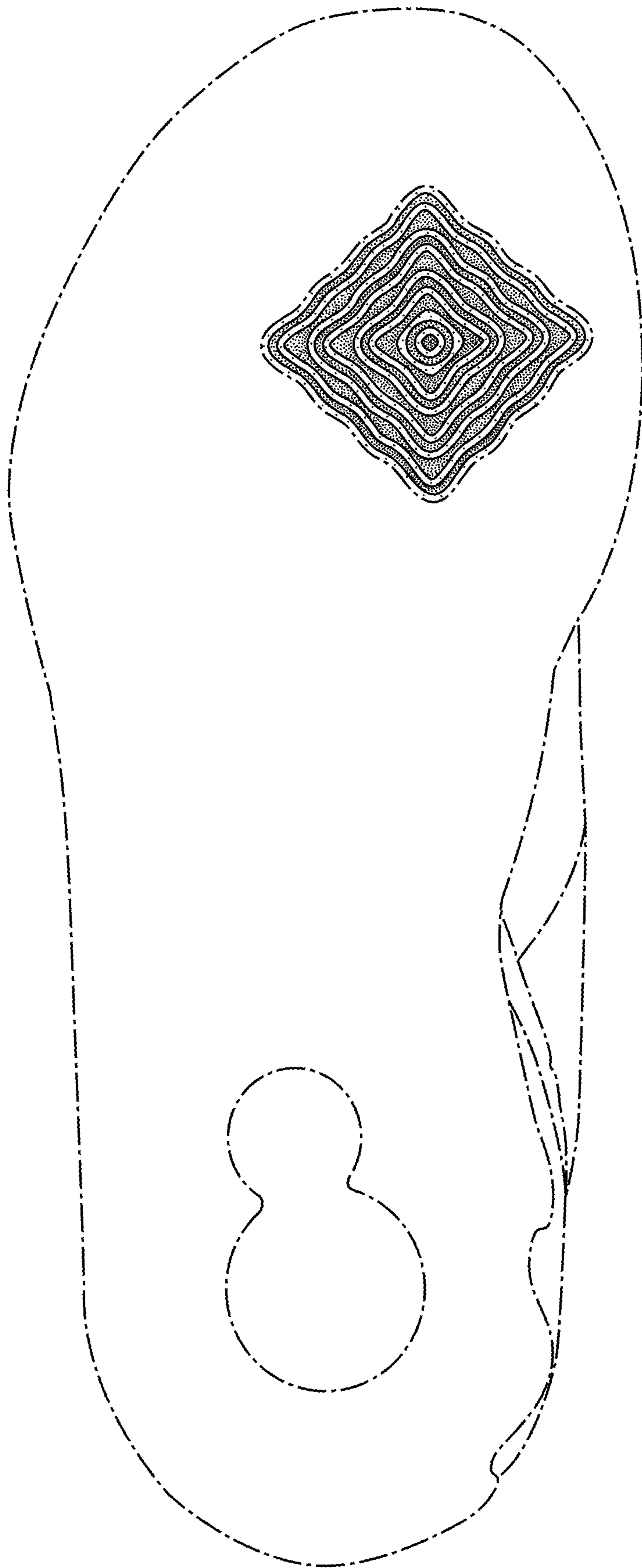

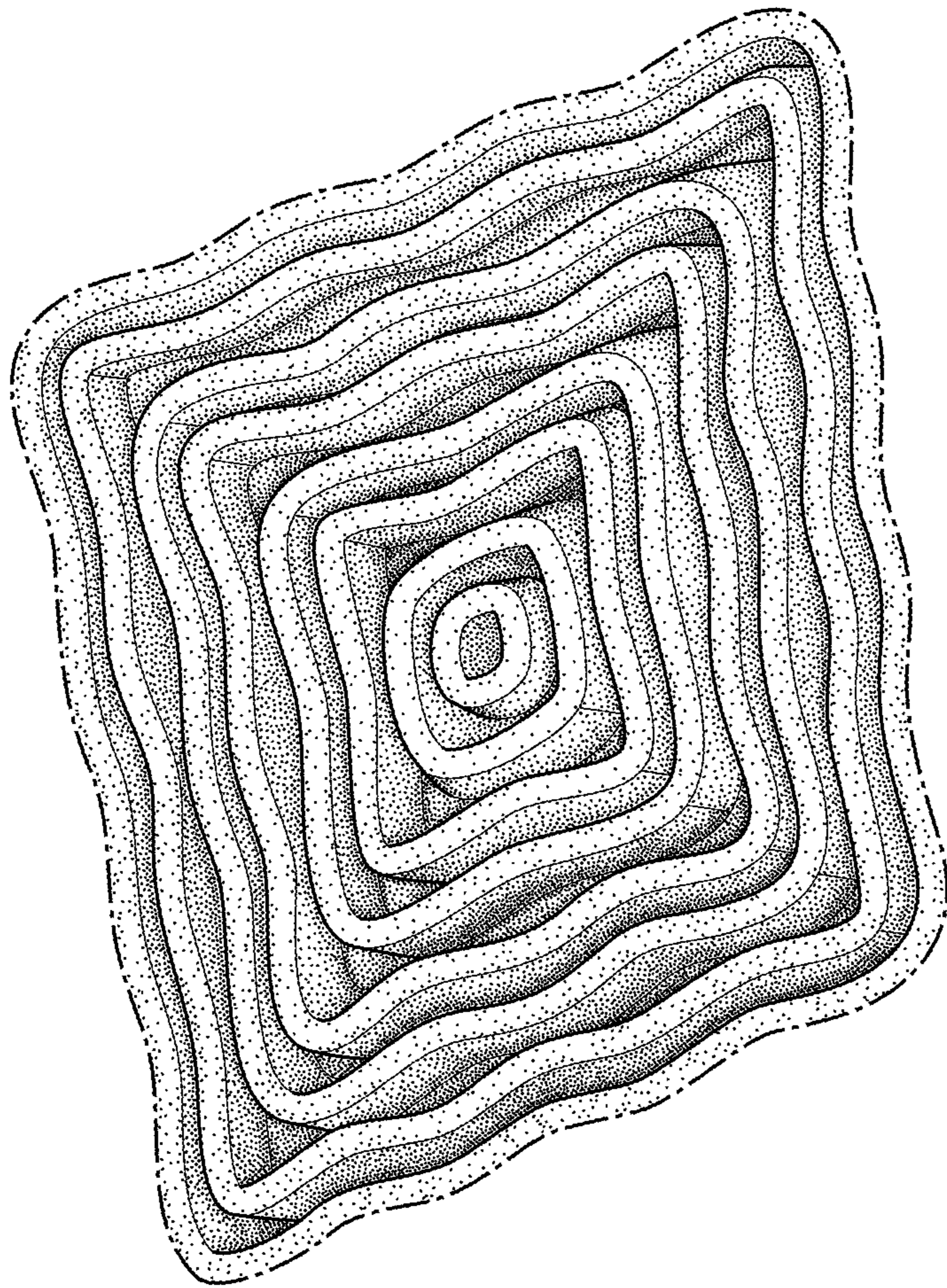
