The ornamental design for a shoe insert, as shown and described.

DESCRIPTION

FIG. 1 is a bottom, side perspective view of a shoe insert showing my new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is the opposite side elevation view thereof;
FIG. 6 is a front elevation view thereof; and,
FIG. 7 is a rear elevation view thereof.

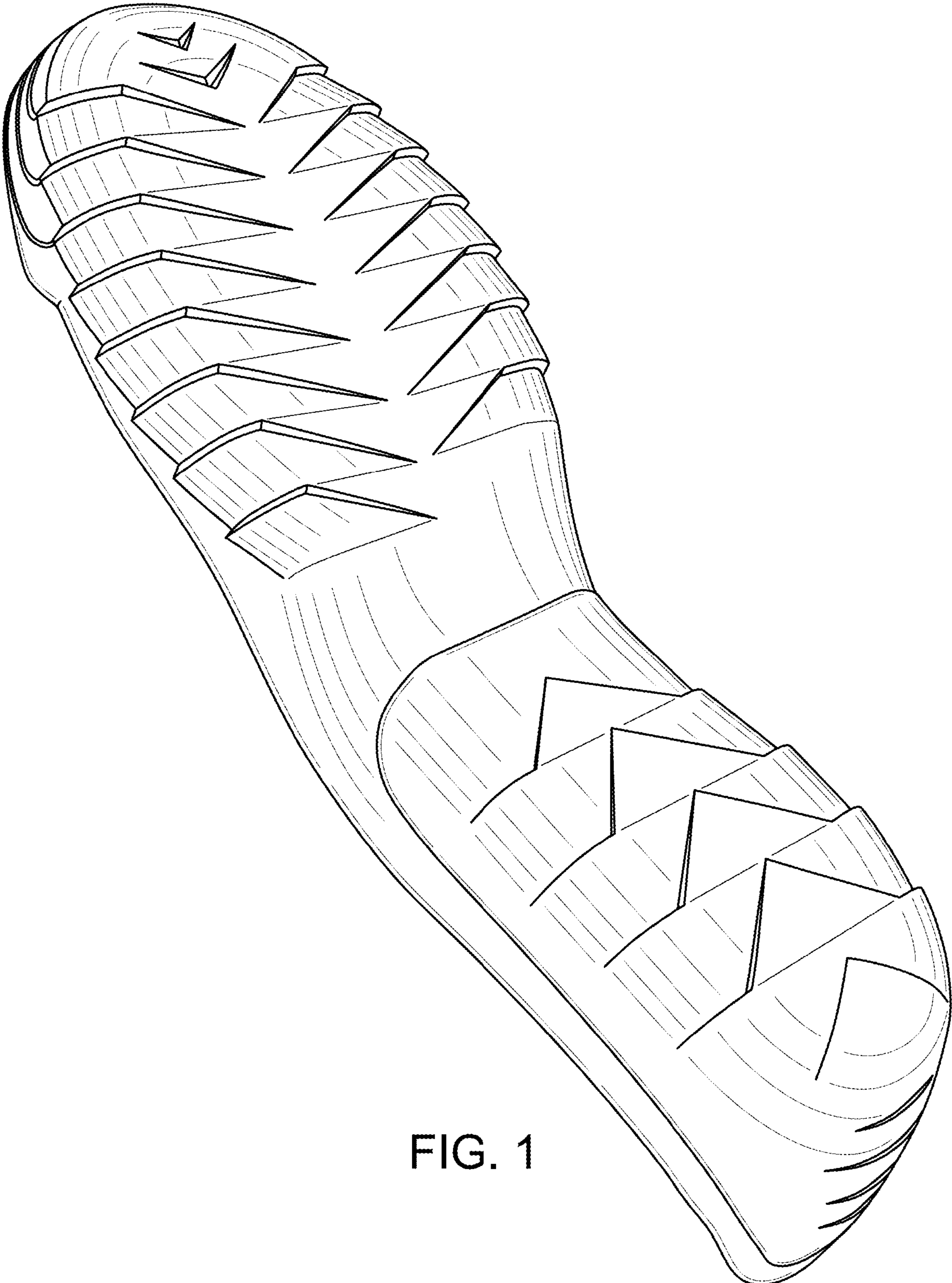

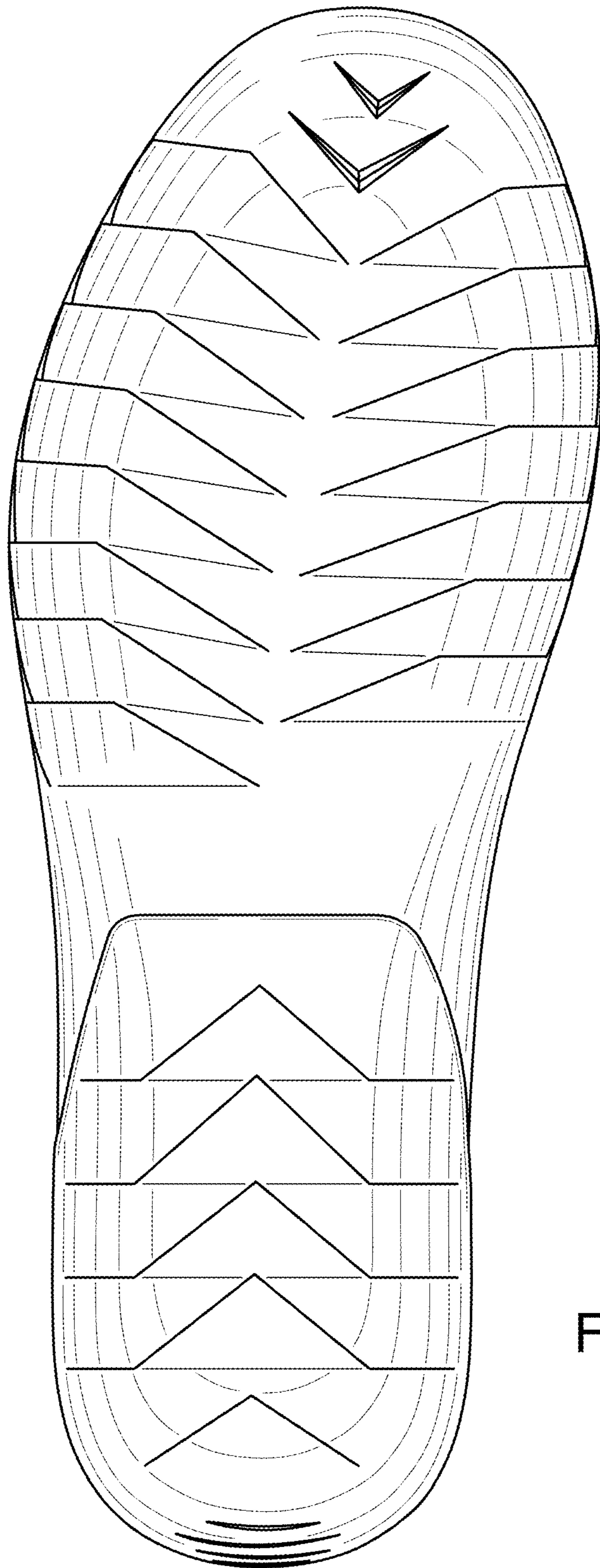

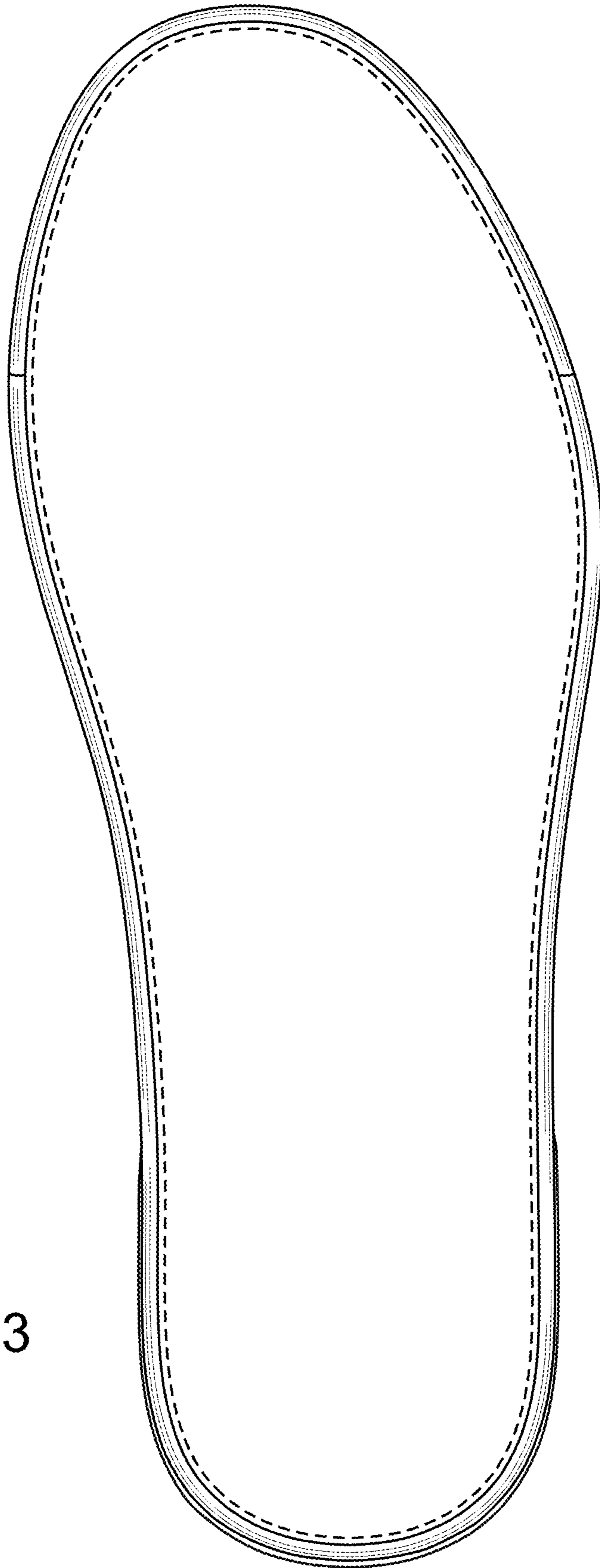

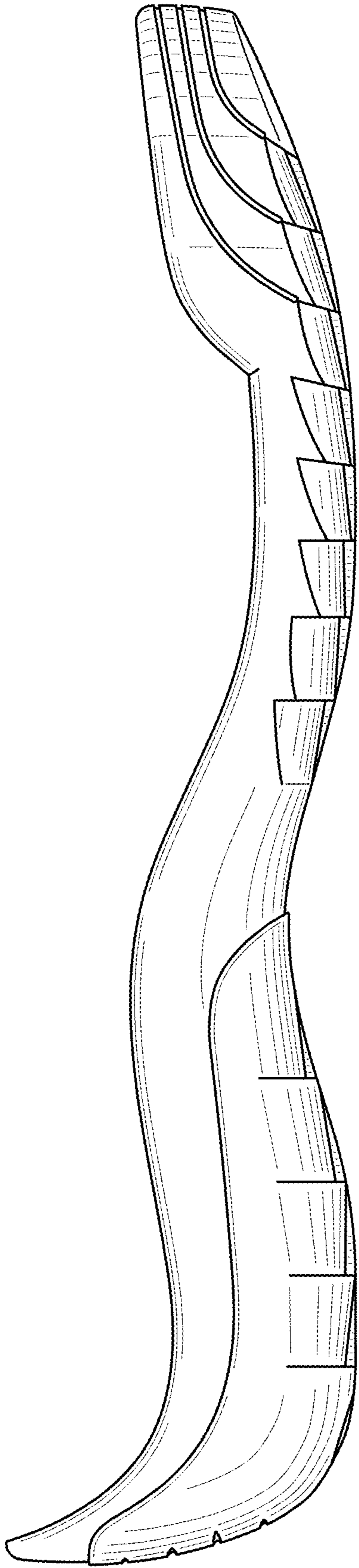

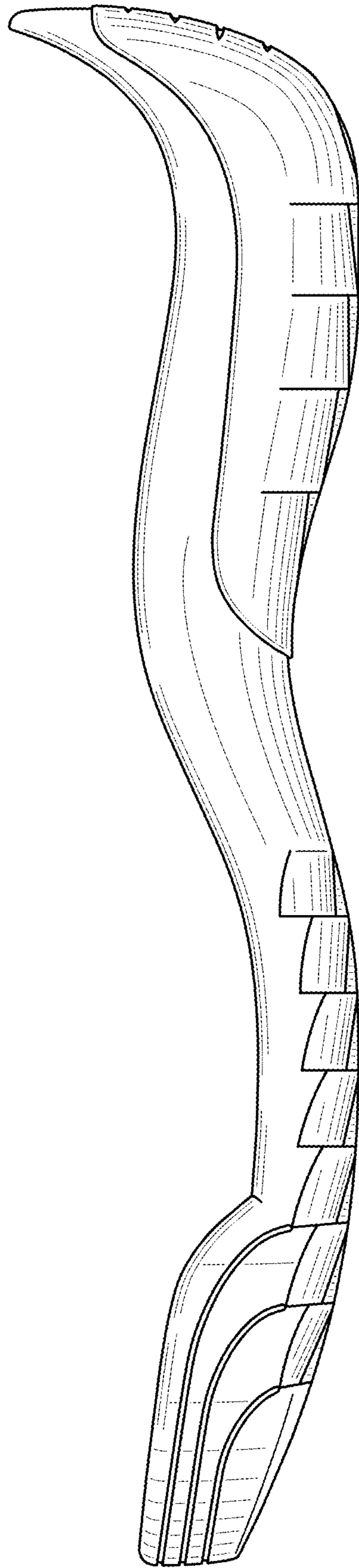

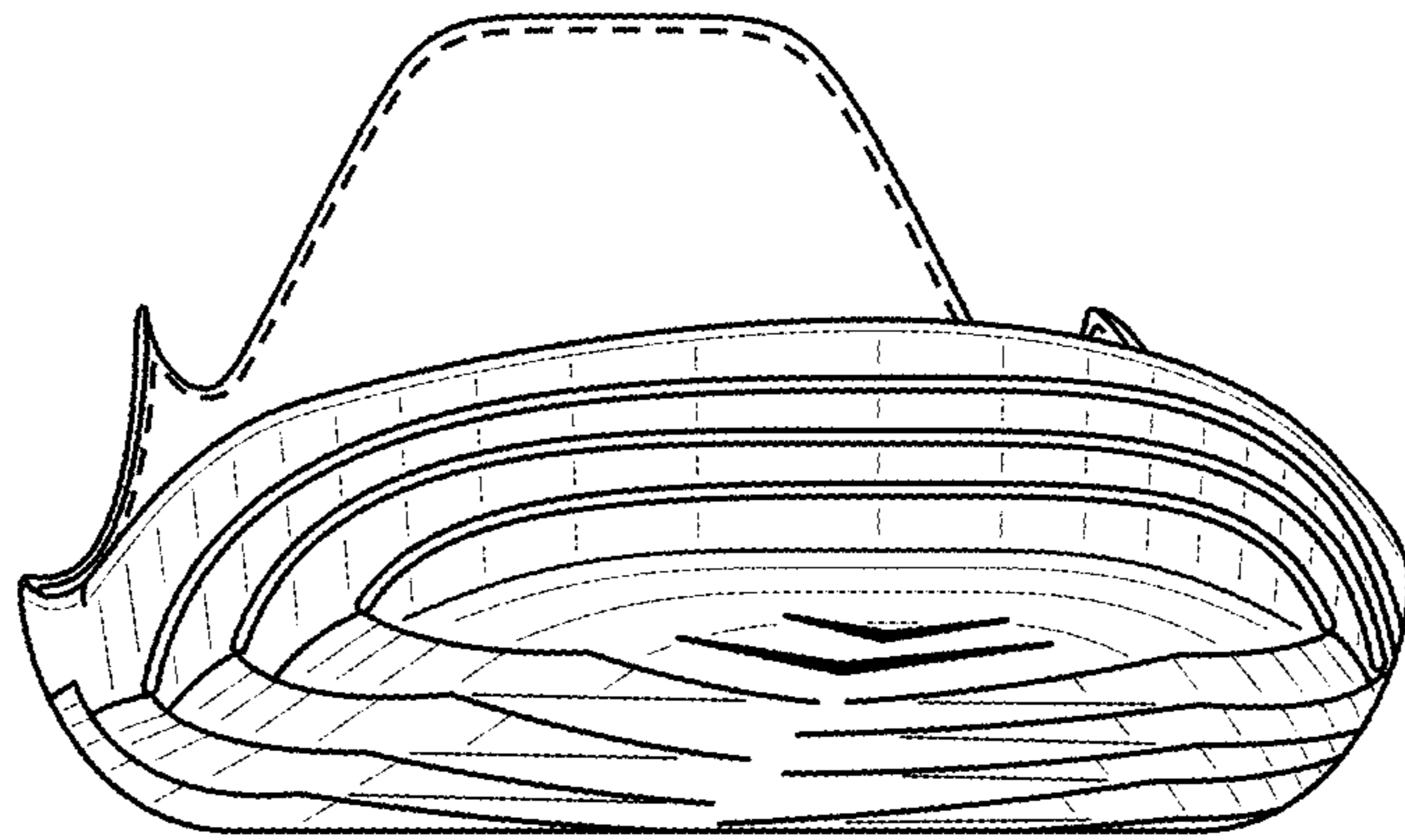

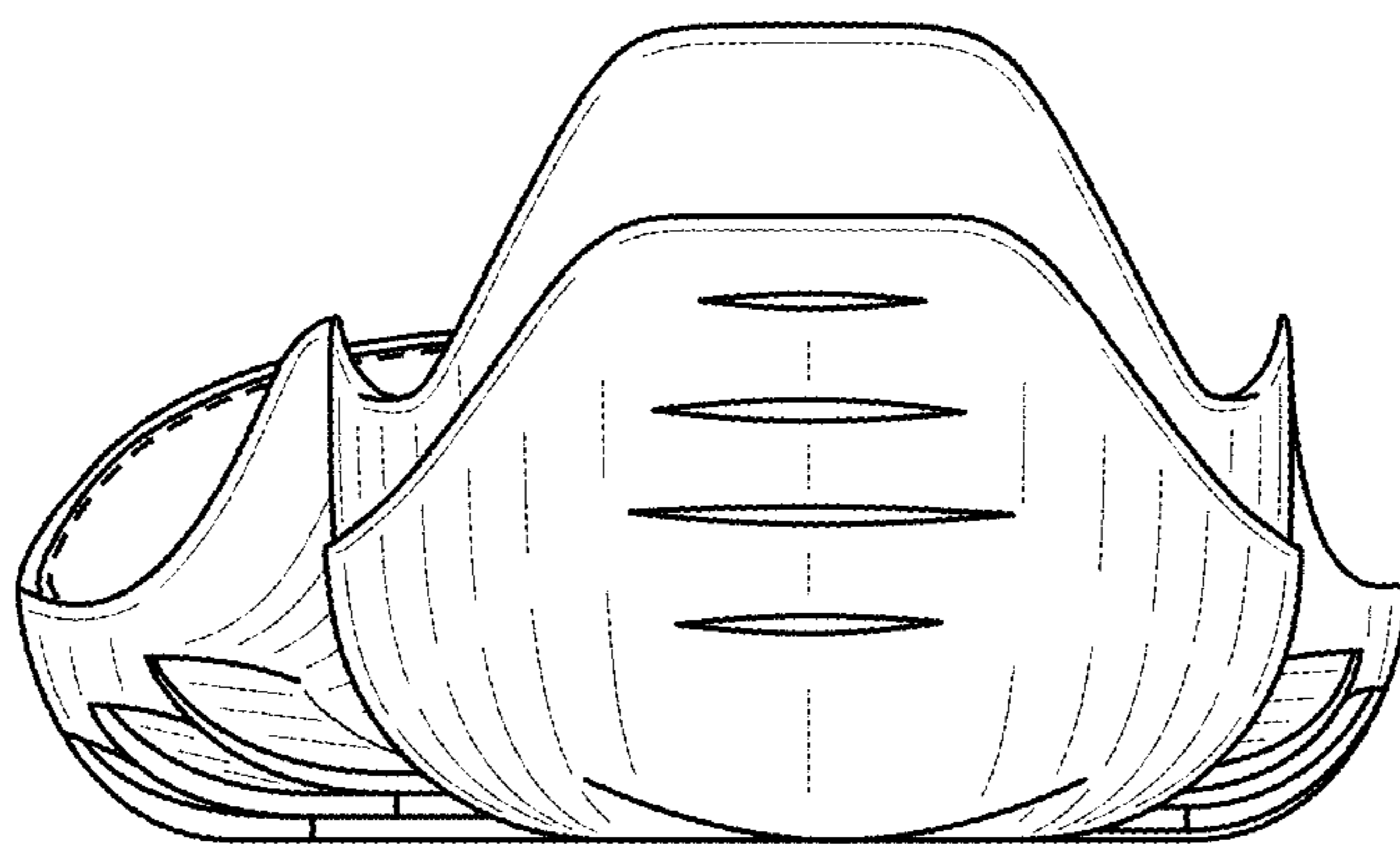
