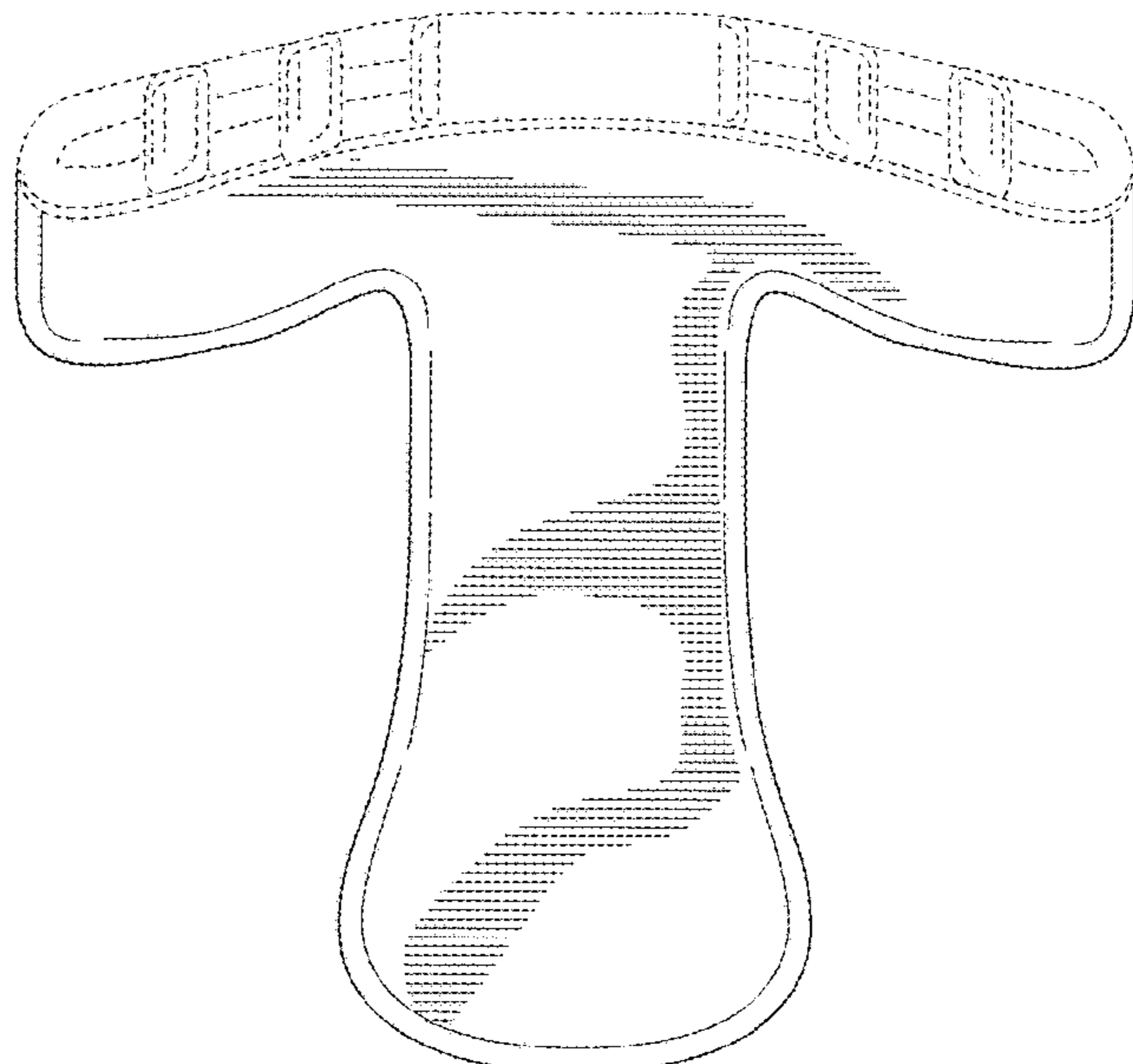
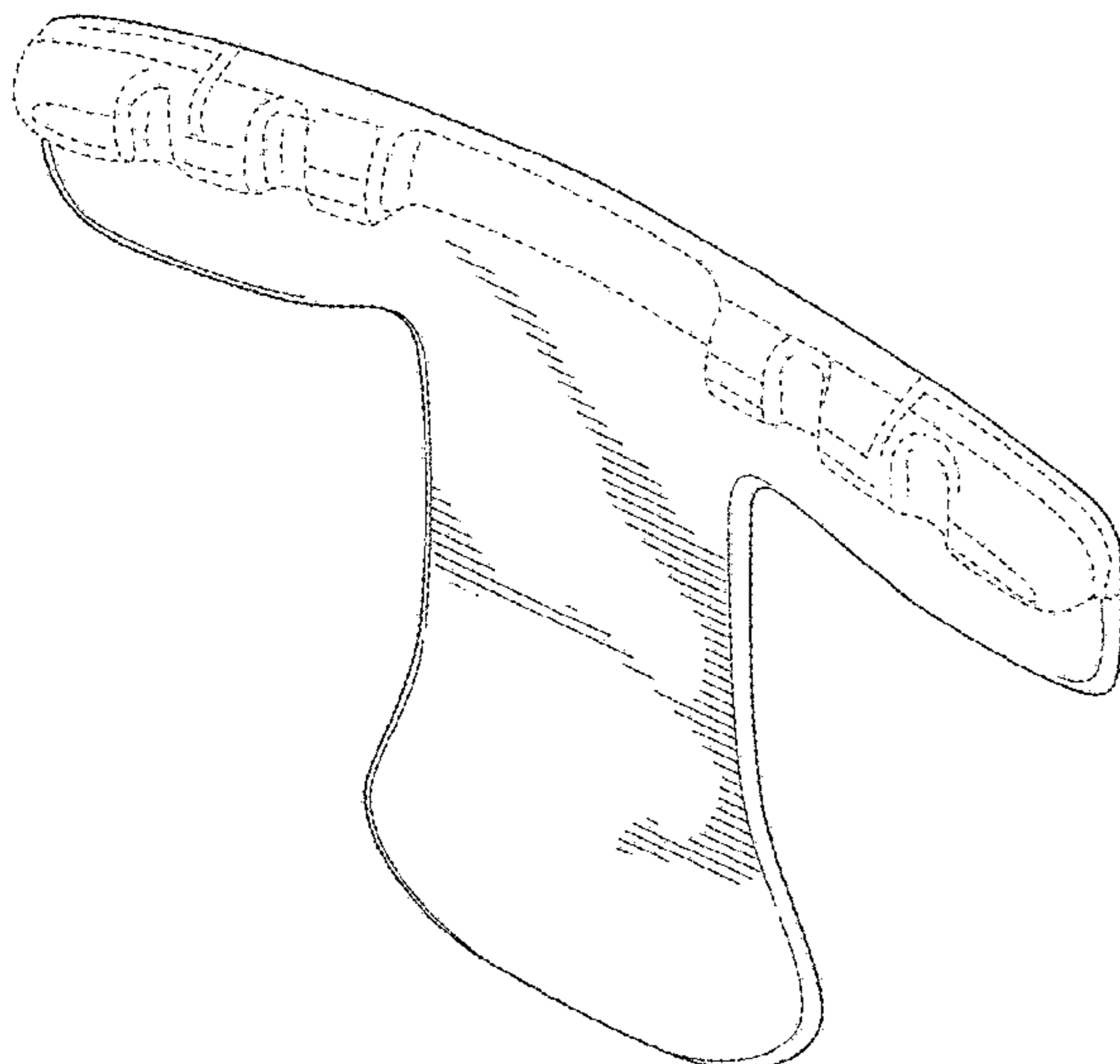
(57) **CLAIM**

The ornamental design for a shoe bumper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, perspective view of a shoe bumper showing my new design.

FIG. 4 is a left side elevation view of FIG. 1.

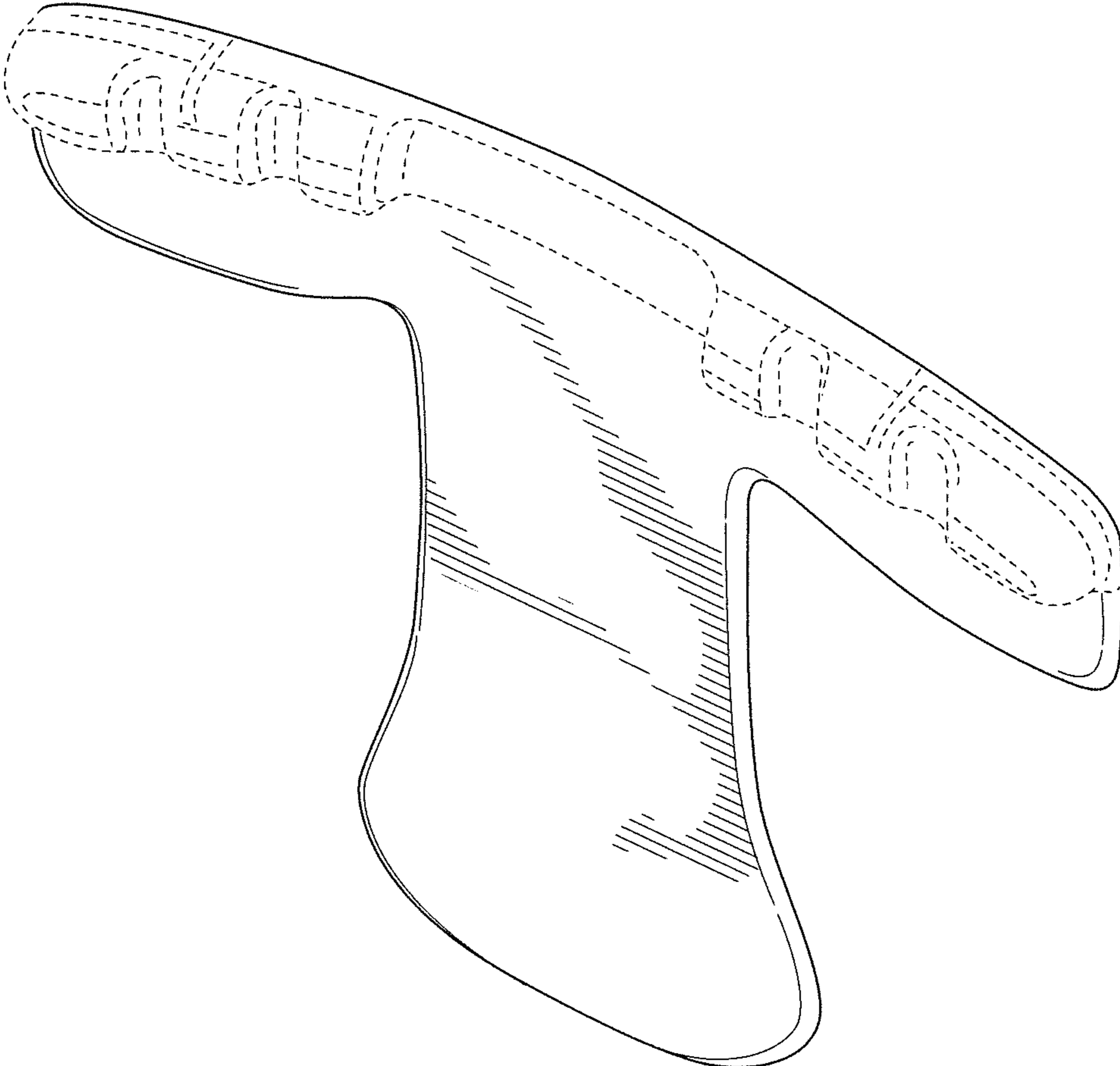

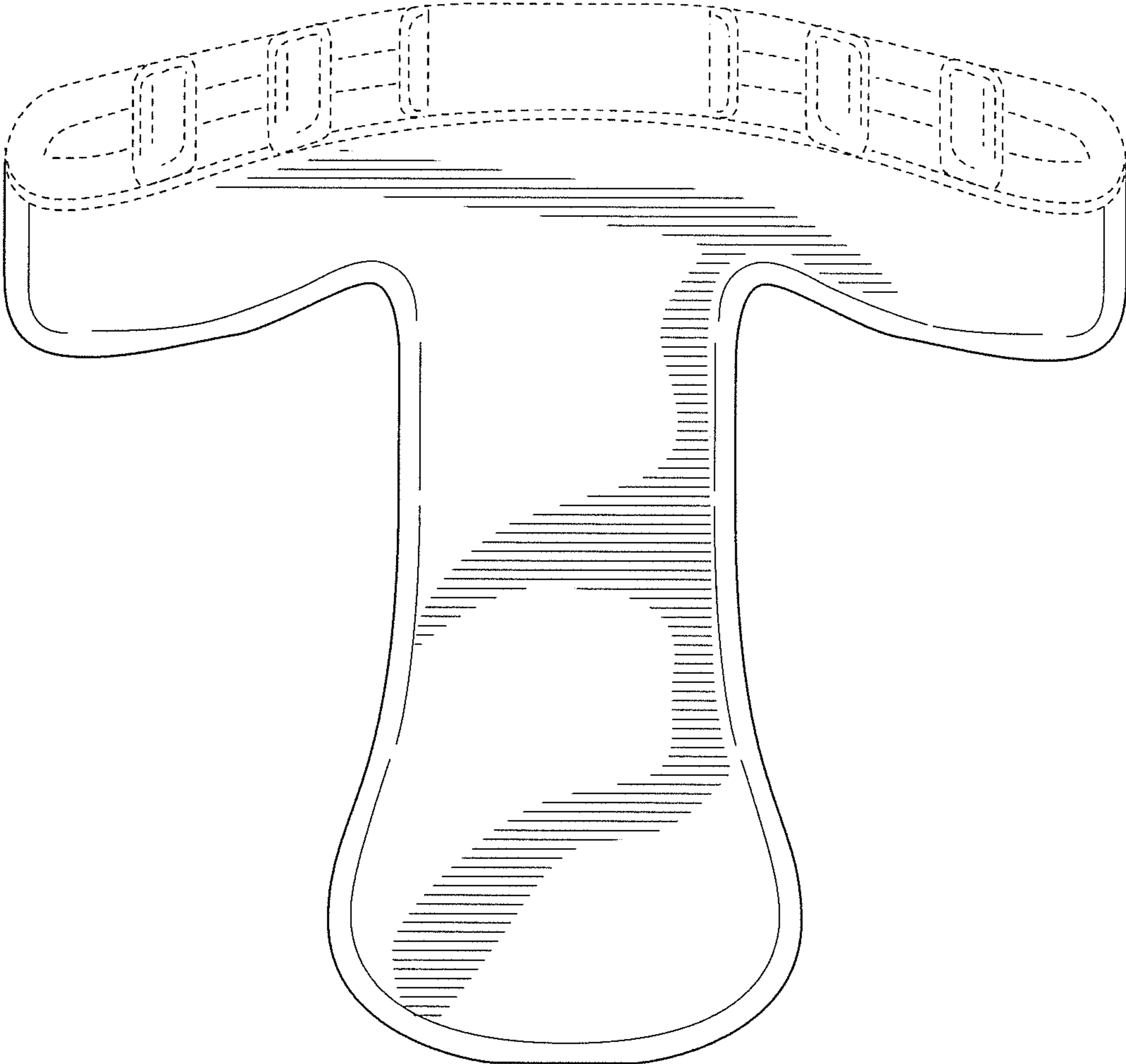

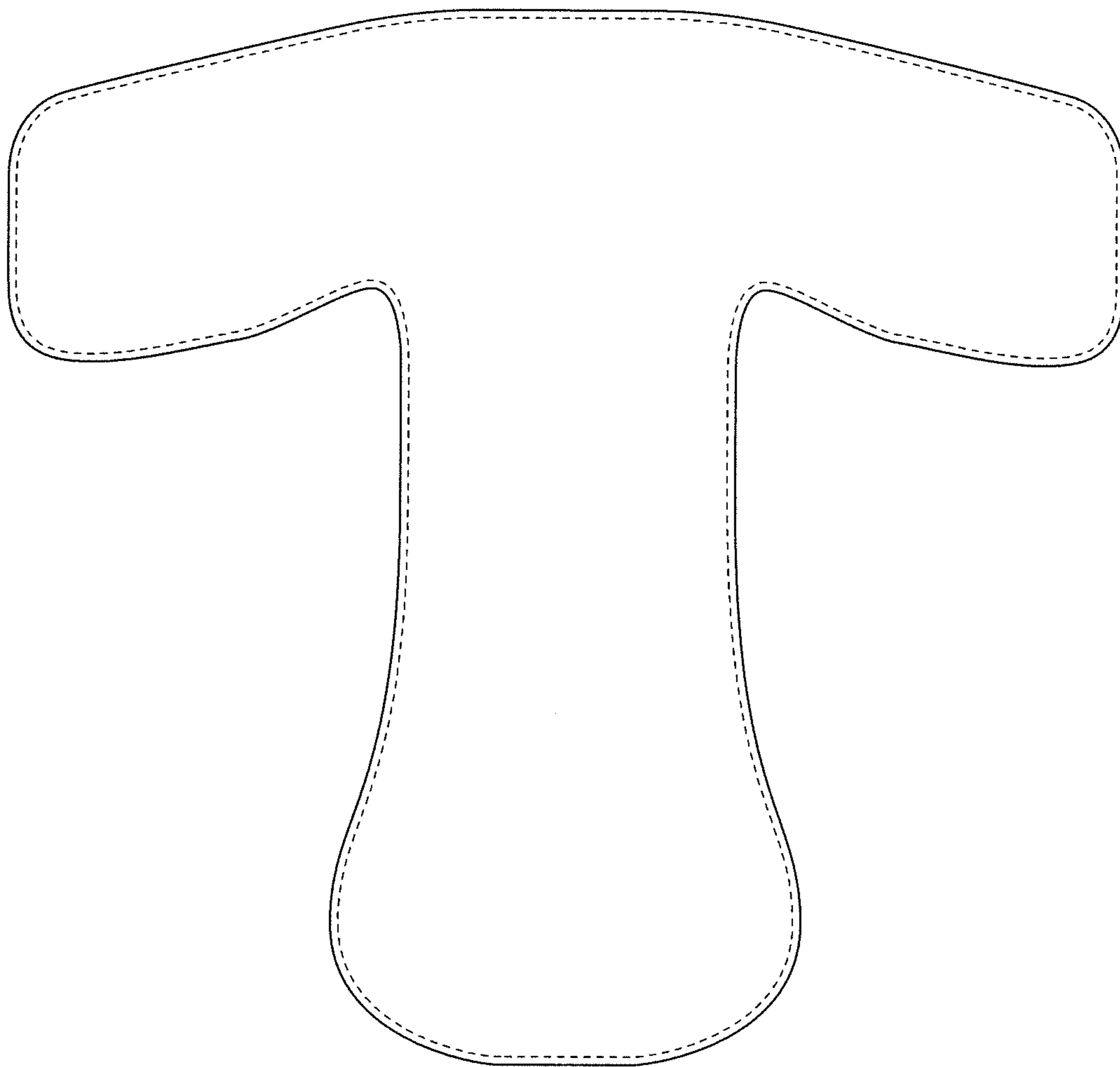

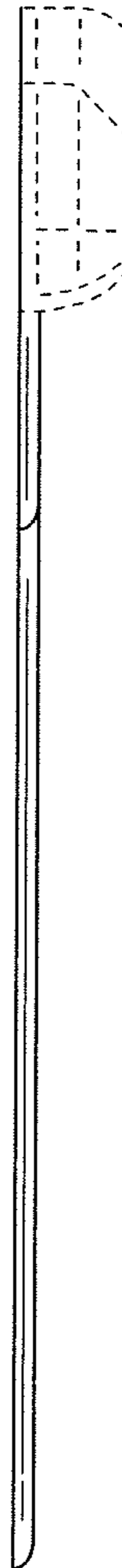

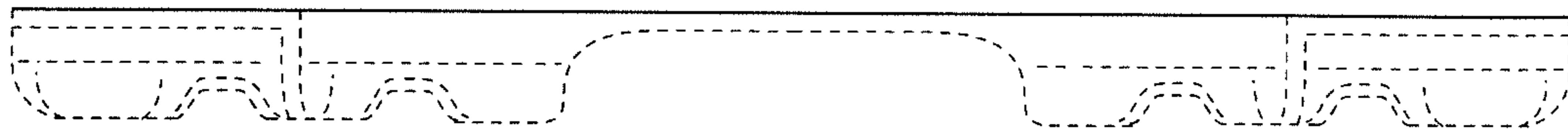

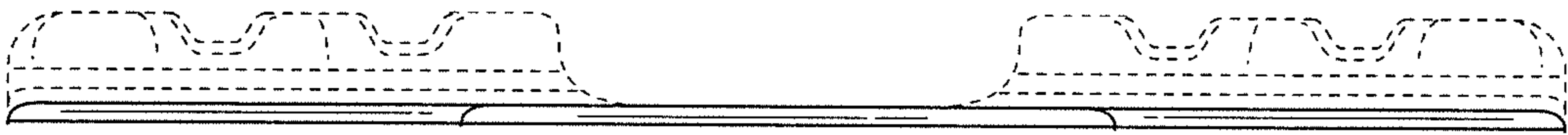
