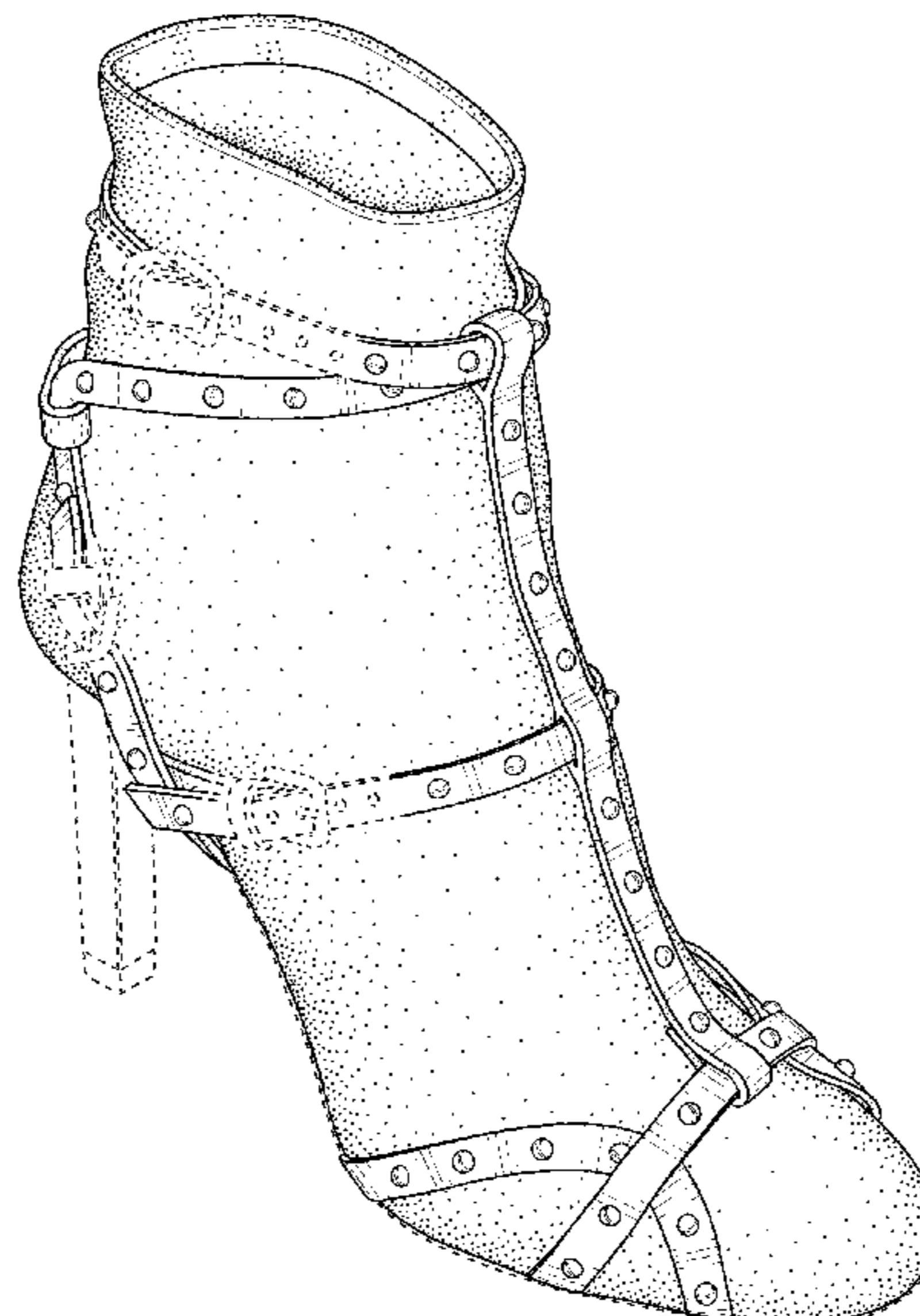
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of footwear showing my new design;  
FIG. 2 is a right side view thereof;

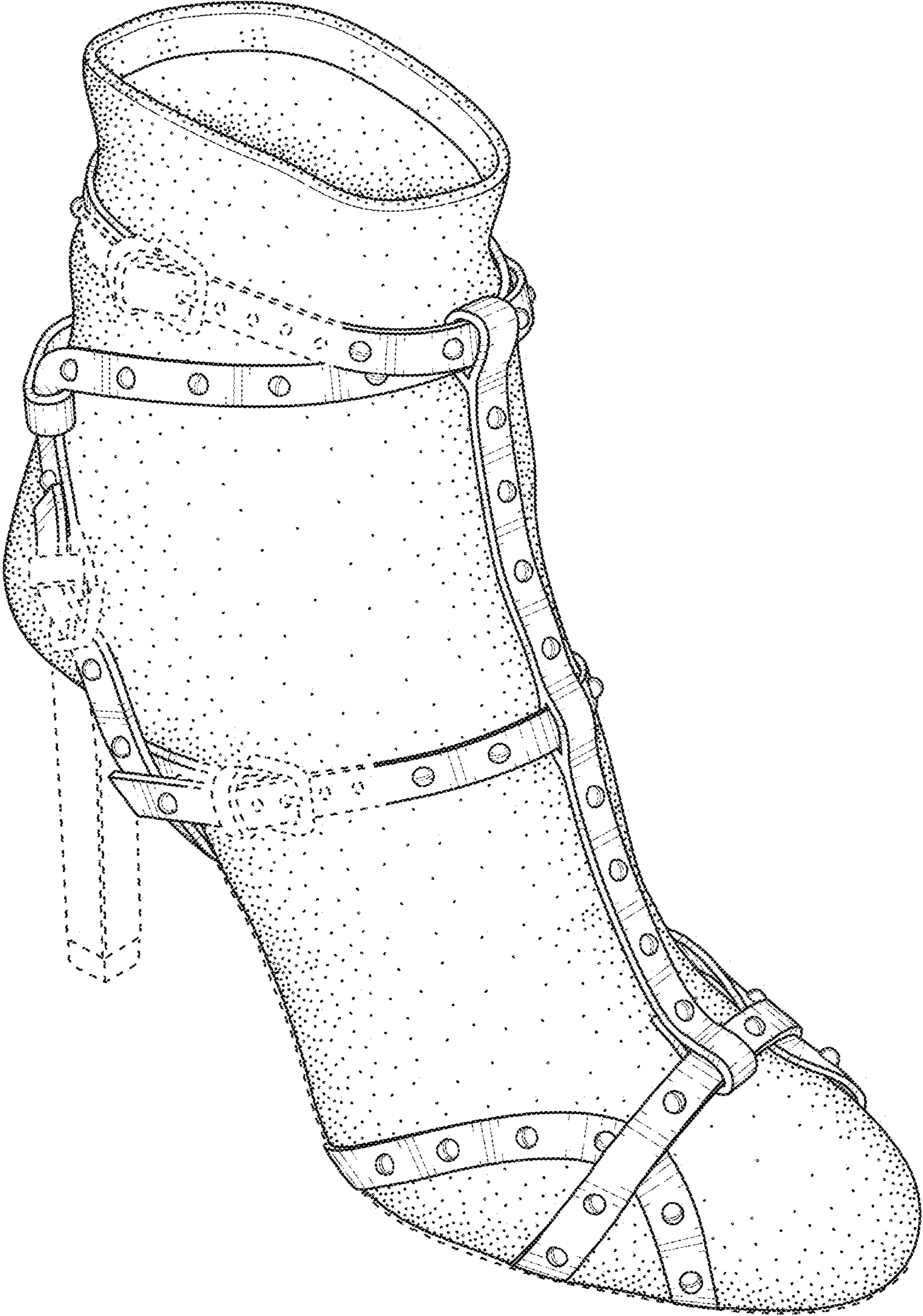

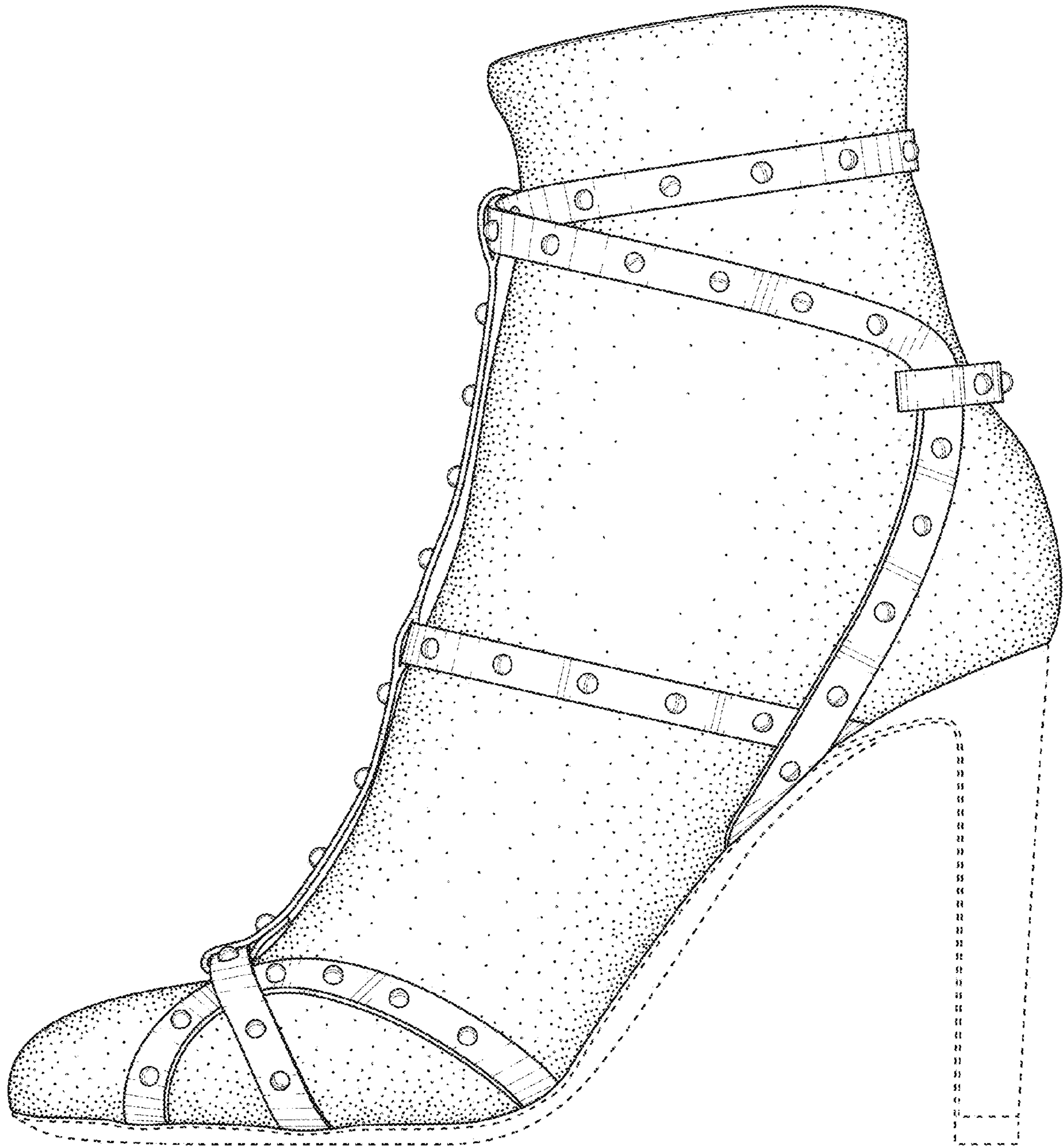

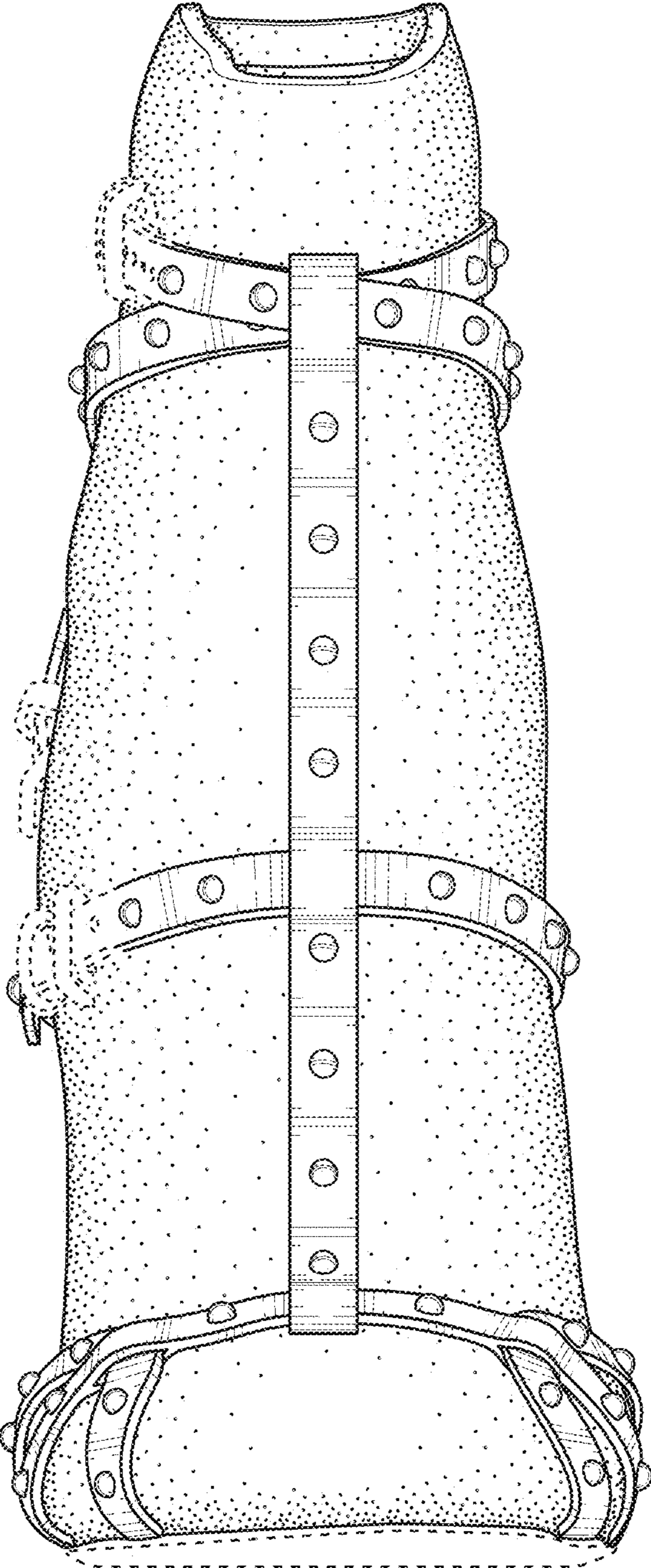

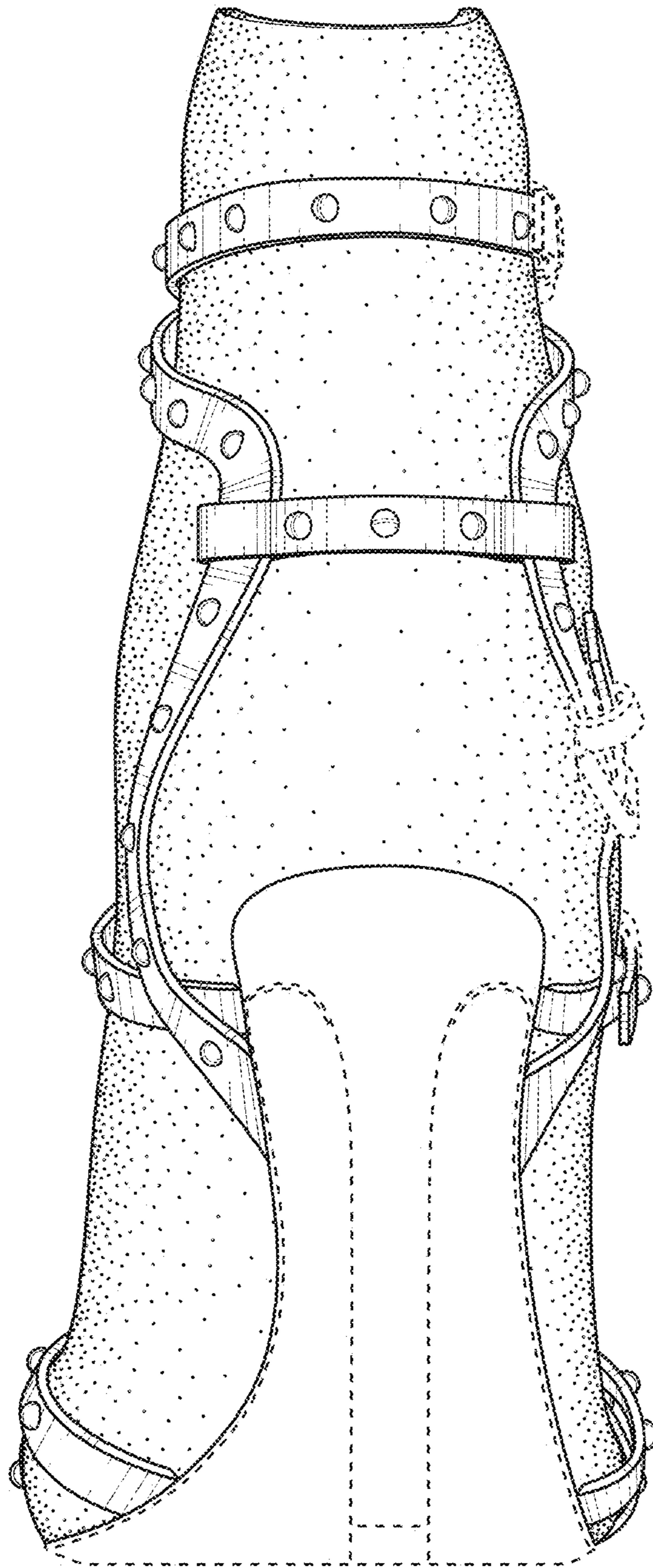

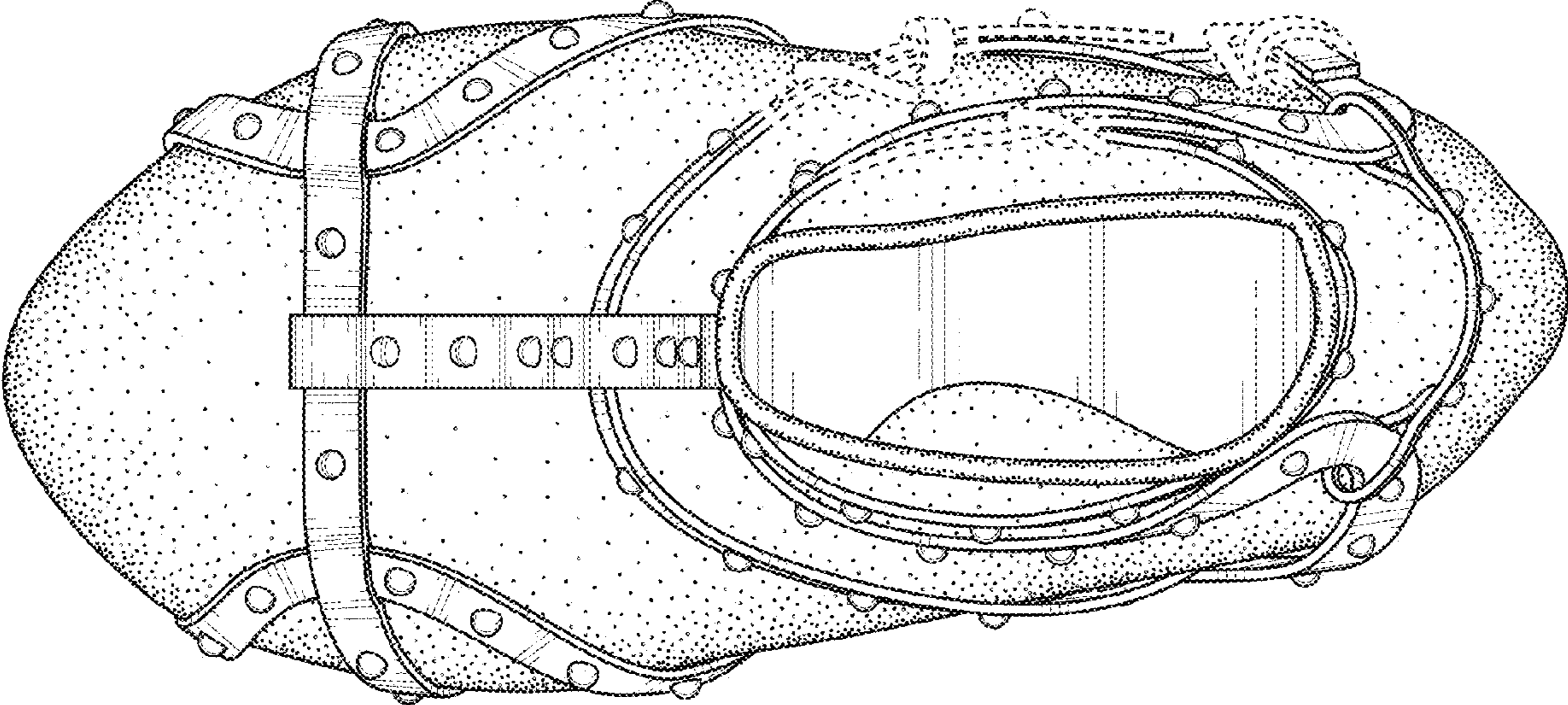
