The ornamental design for a pendant, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pendant, showing the new design in a closed position;

FIG. 4 is a left-side elevational view thereof,

FIG. 5 is a right-side elevational view thereof;

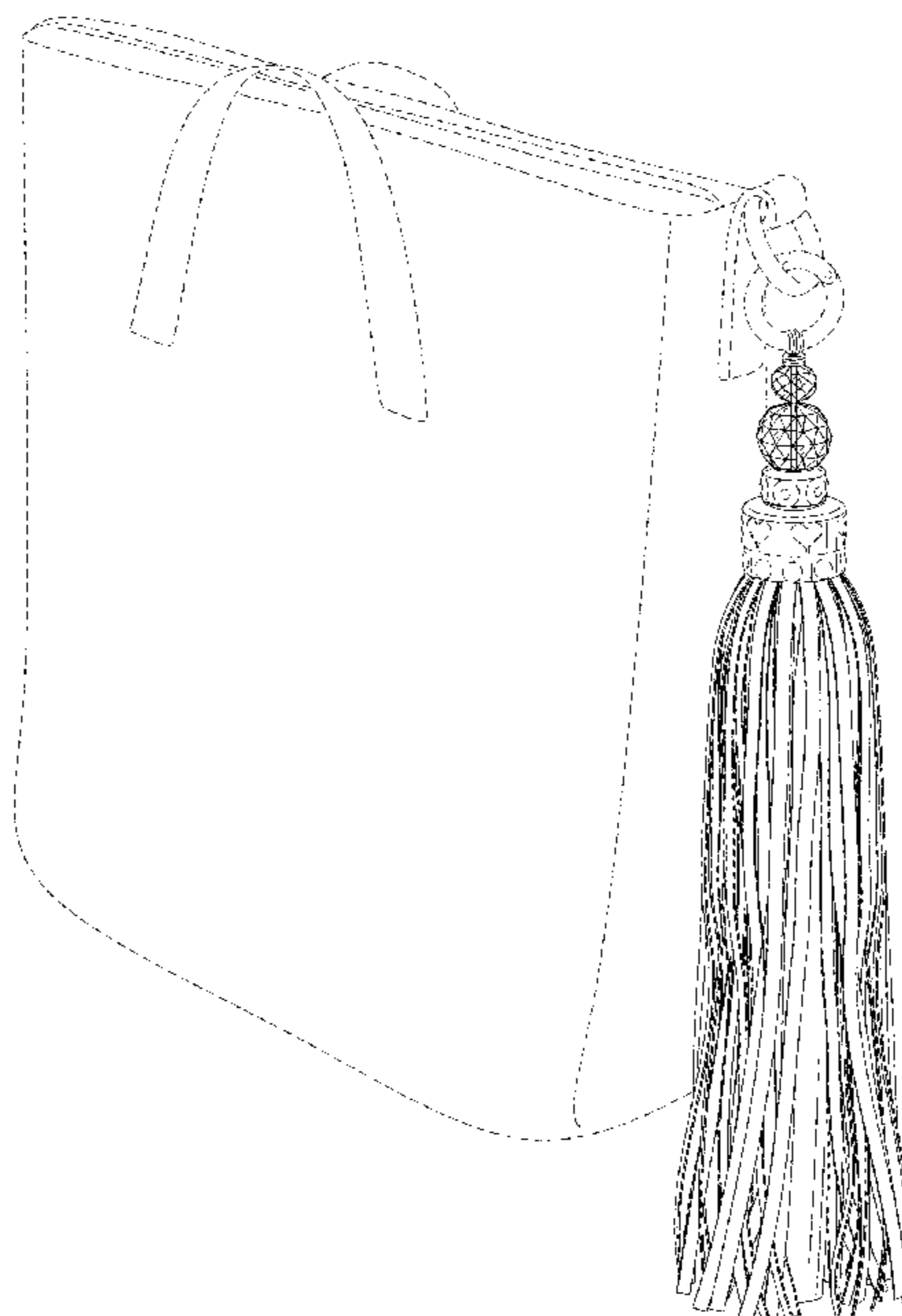
FIG. 6 is a top plan view thereof;

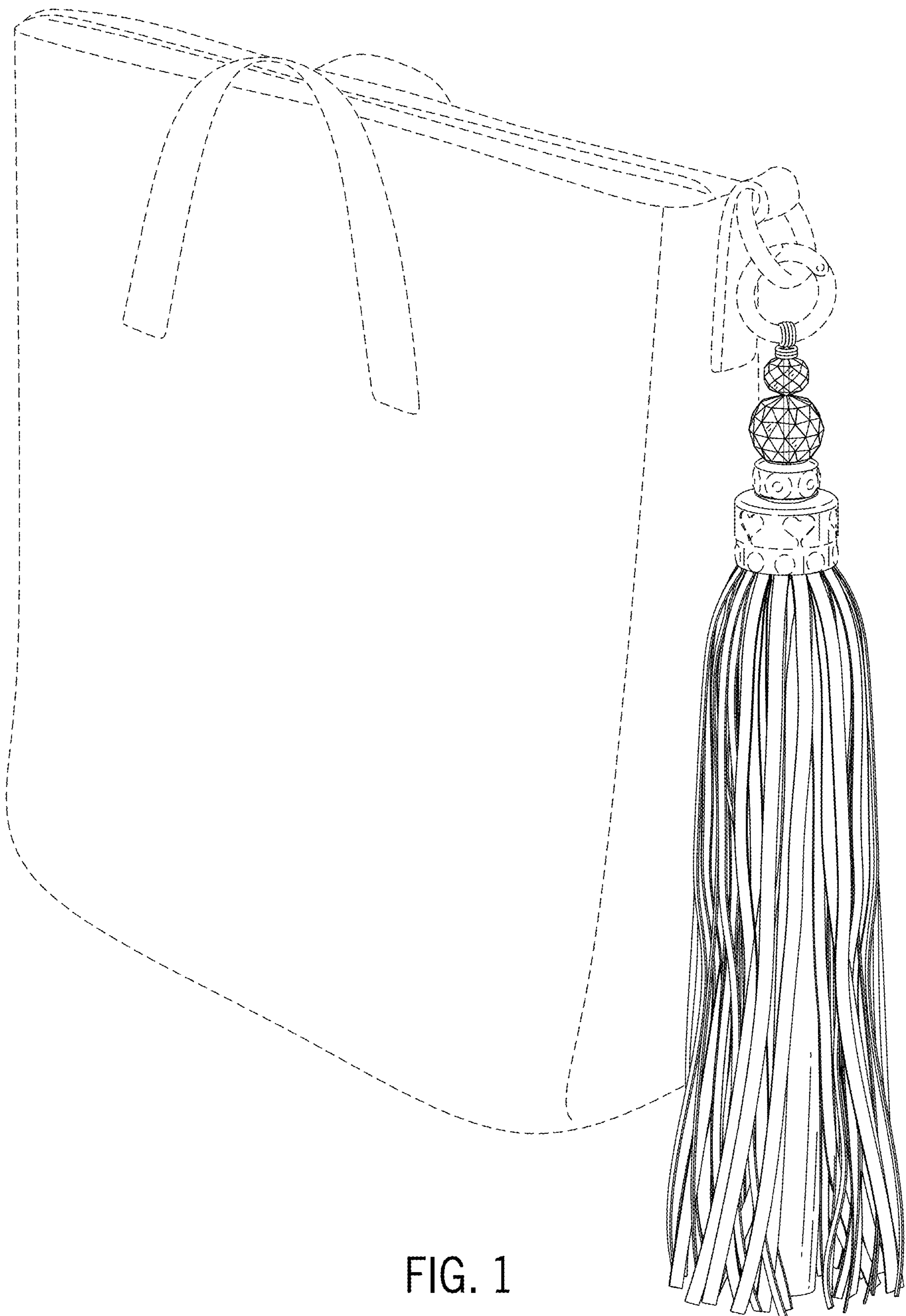

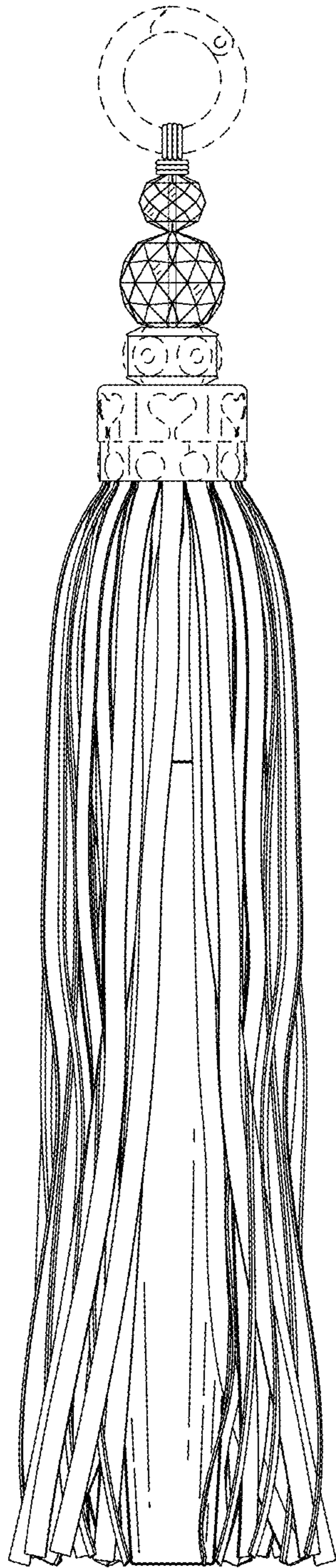

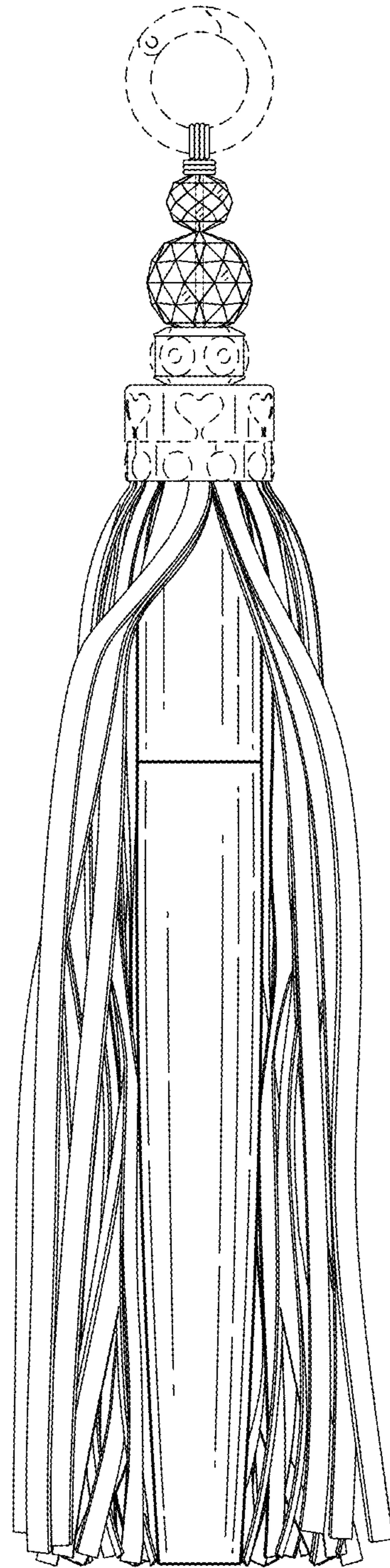

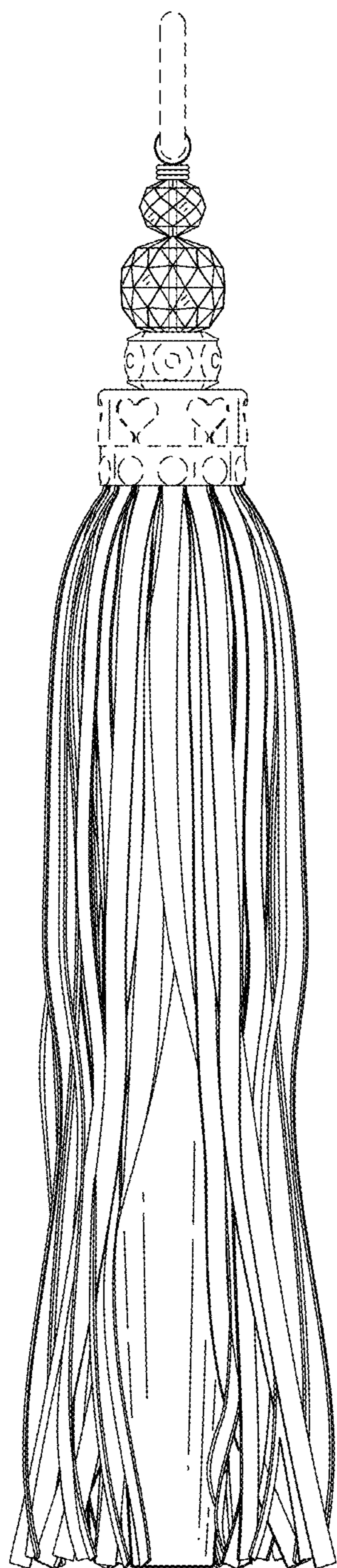

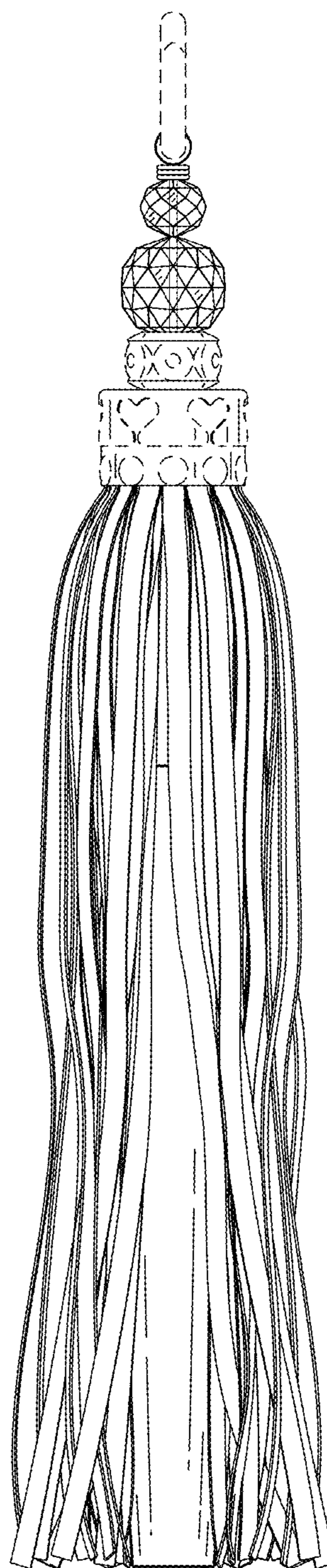

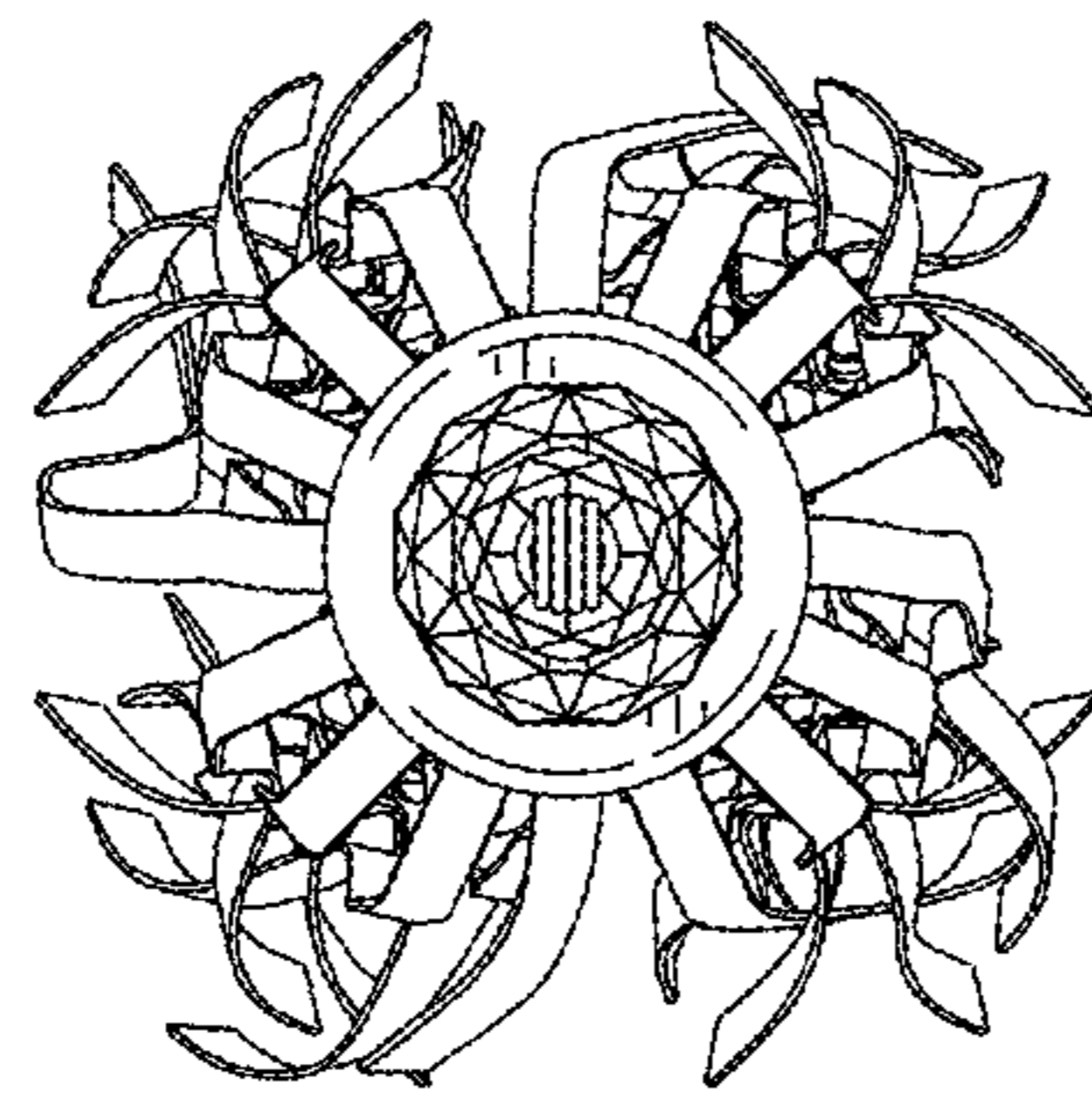

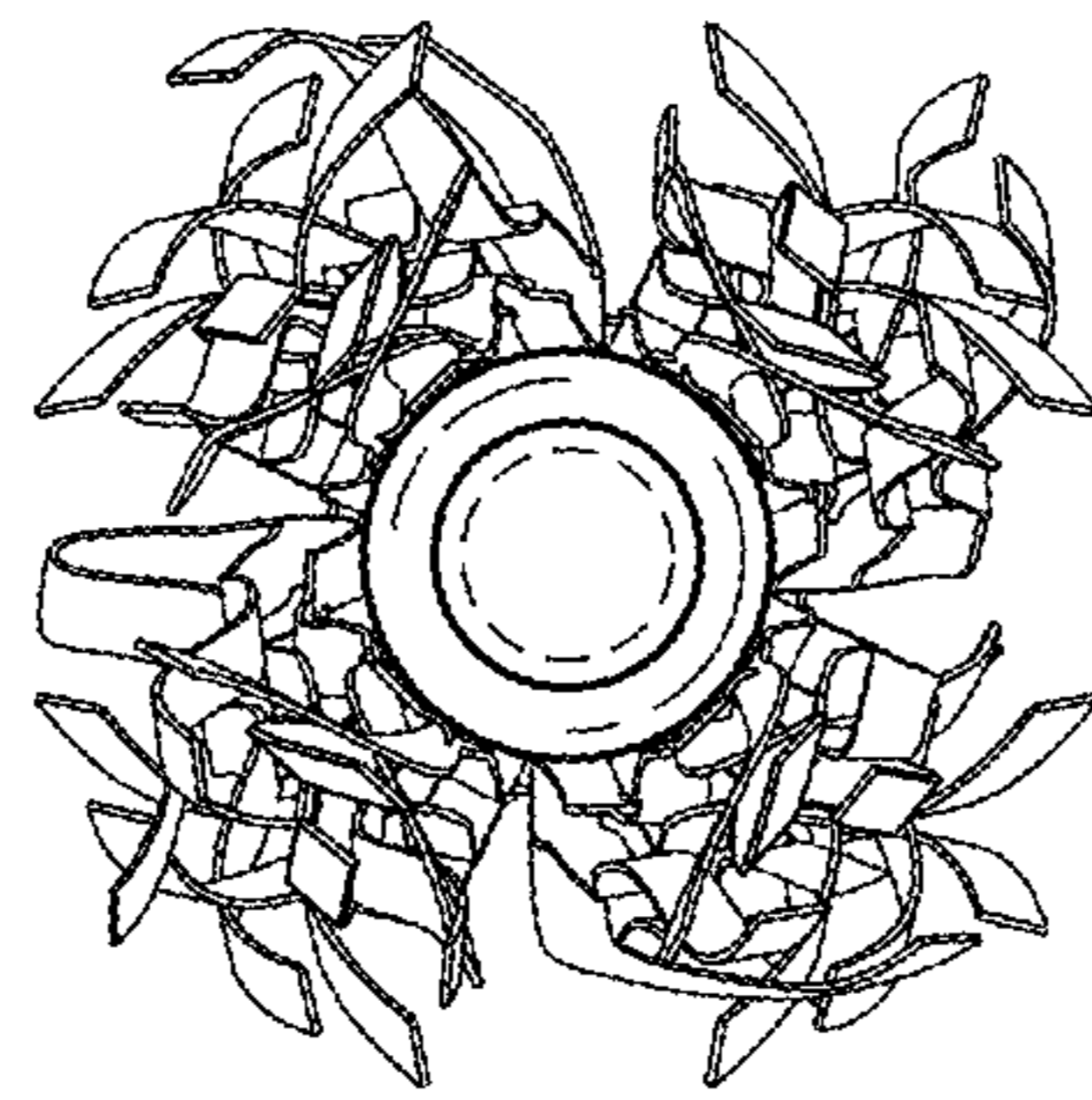

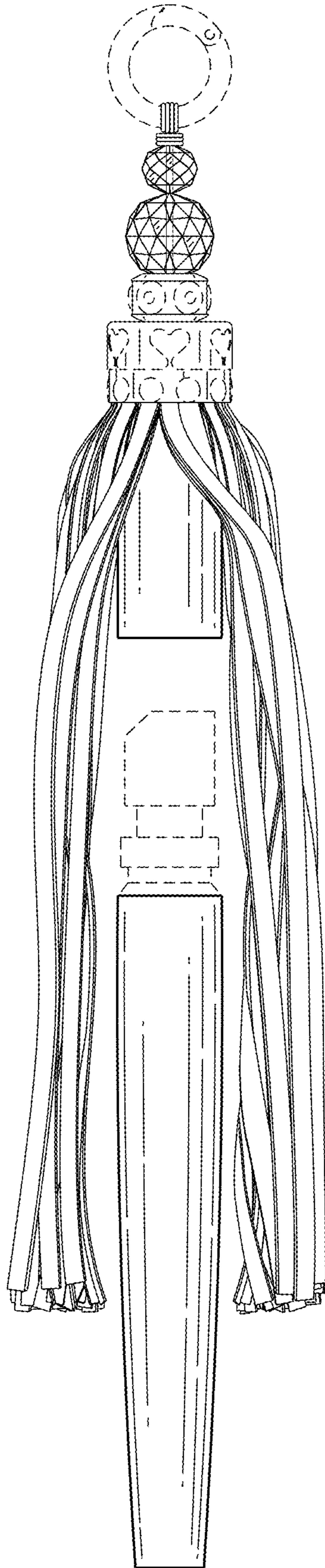
