The ornamental design for a display stand, as shown and described.

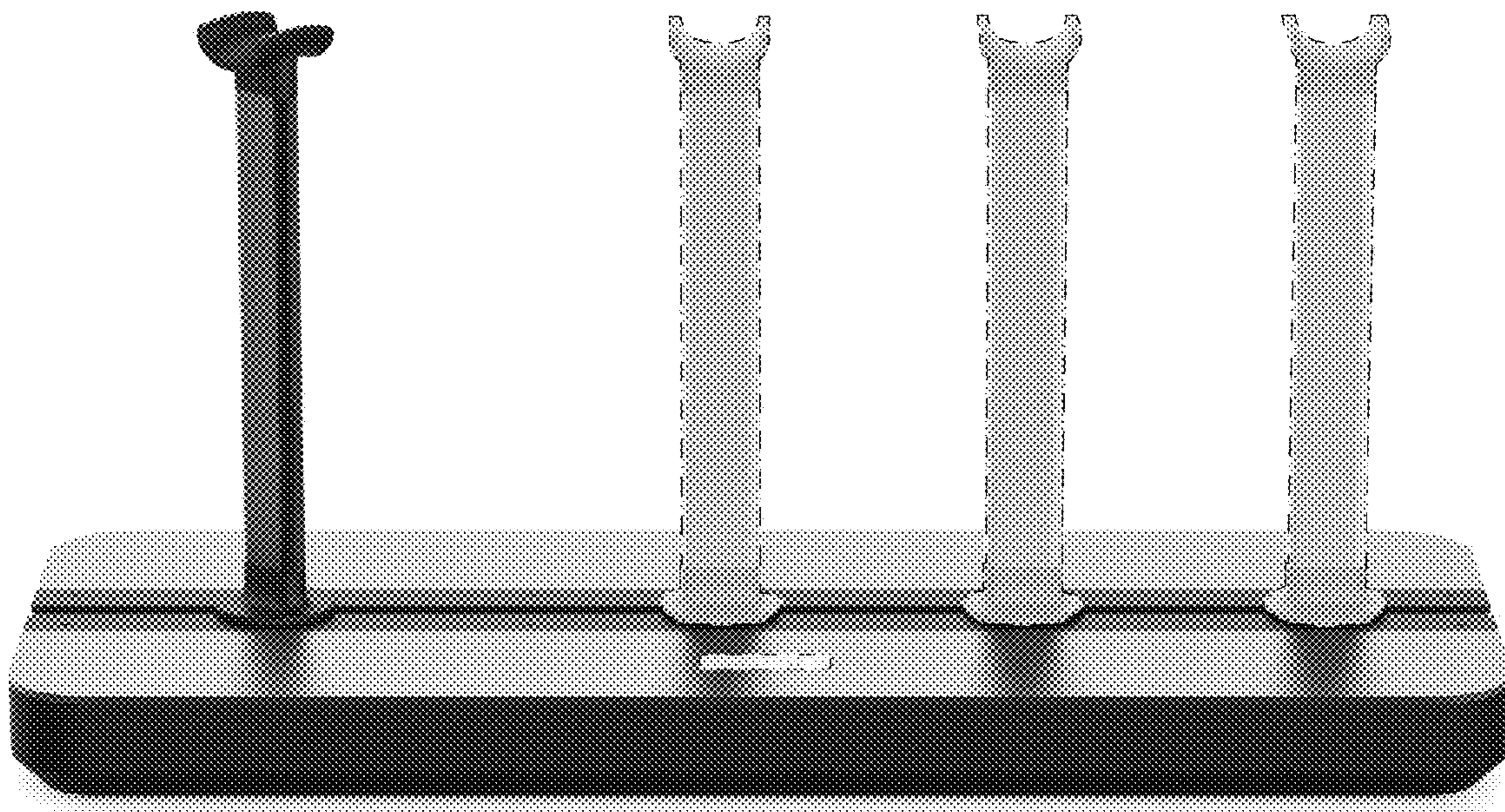
DESCRIPTION
