The ornamental design for a cooking utensil with surface pattern, as shown and described.

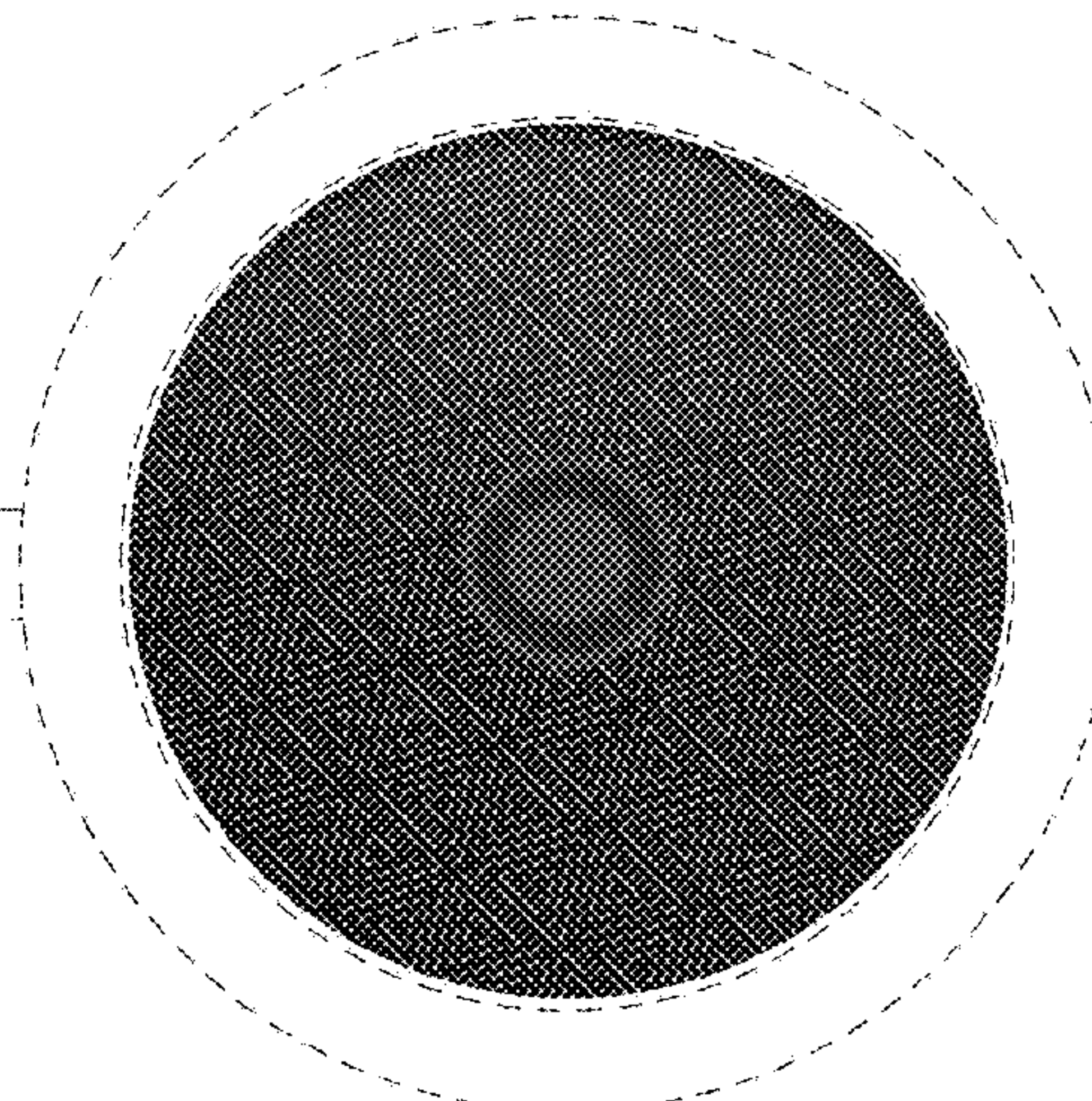
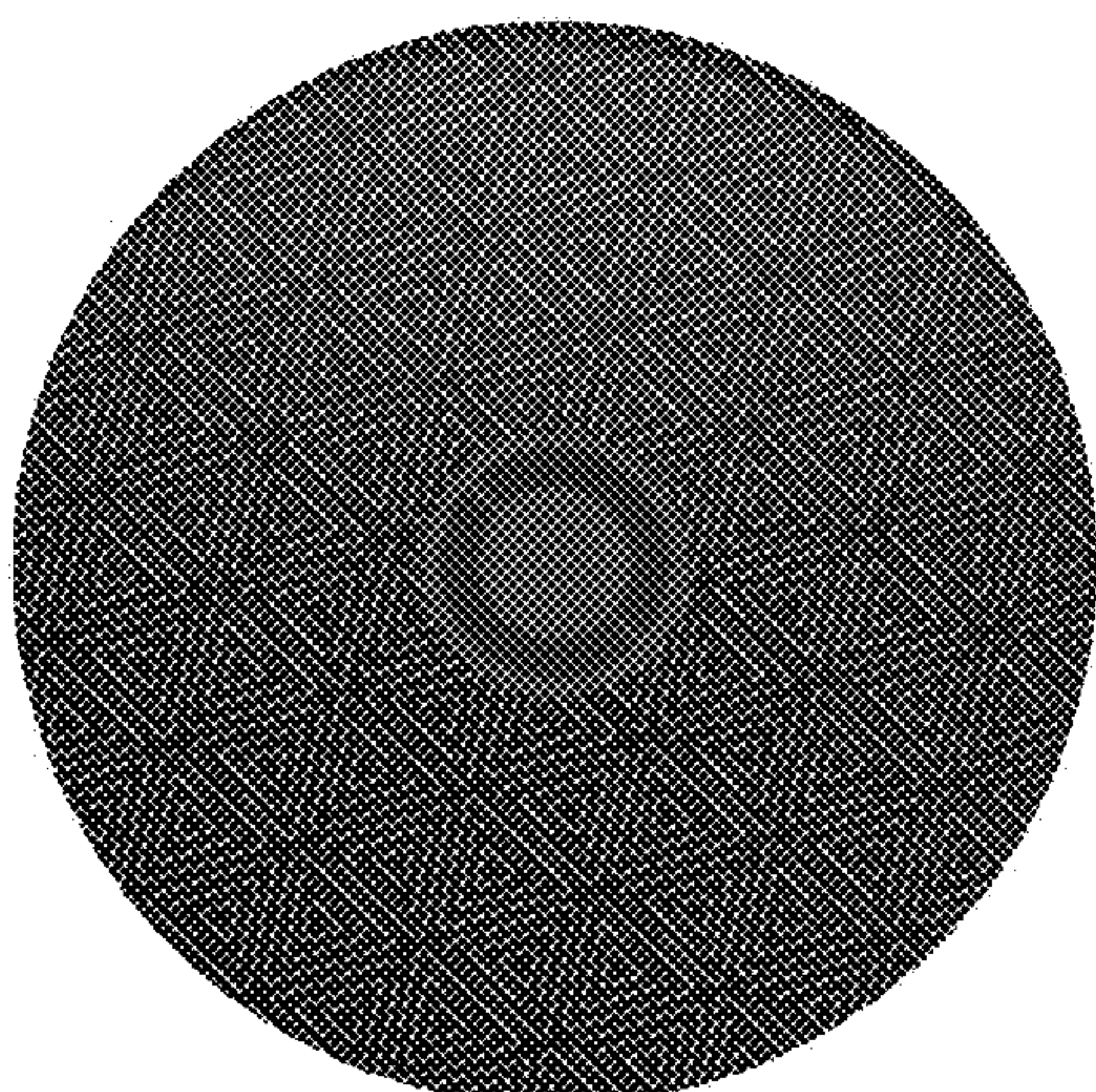
DESCRIPTION

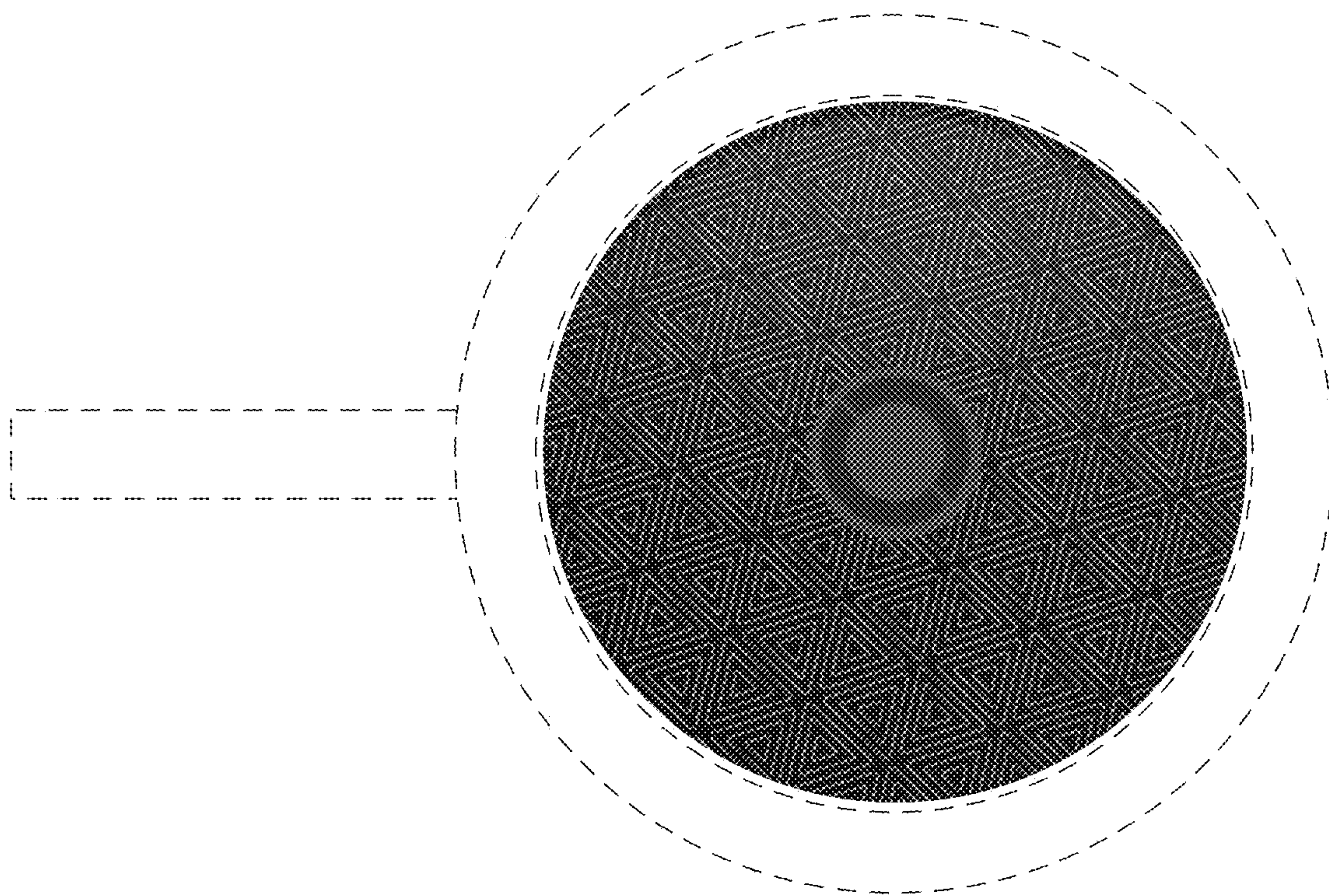
