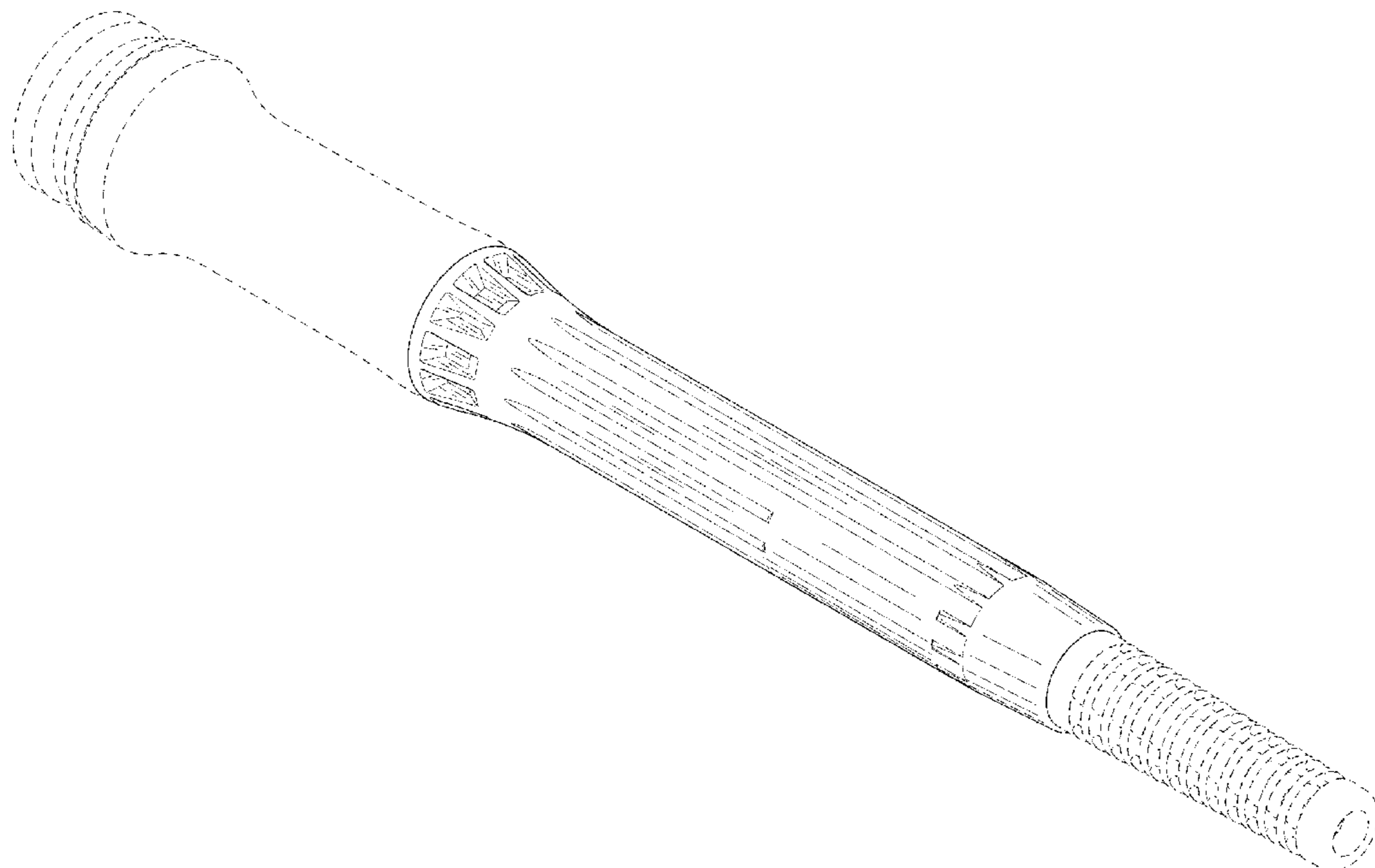

(57) **CLAIM**  
The ornamental design for a grip for soldering iron, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a grip for soldering iron;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a top view thereof, the opposite side being a mirror image of the side shown herein; and,  
FIG. 6 is an enlarged right side view thereof.  
The broken lines depict portions of the grip for soldering iron in which the design is embodied that are not considered part of the claimed design.

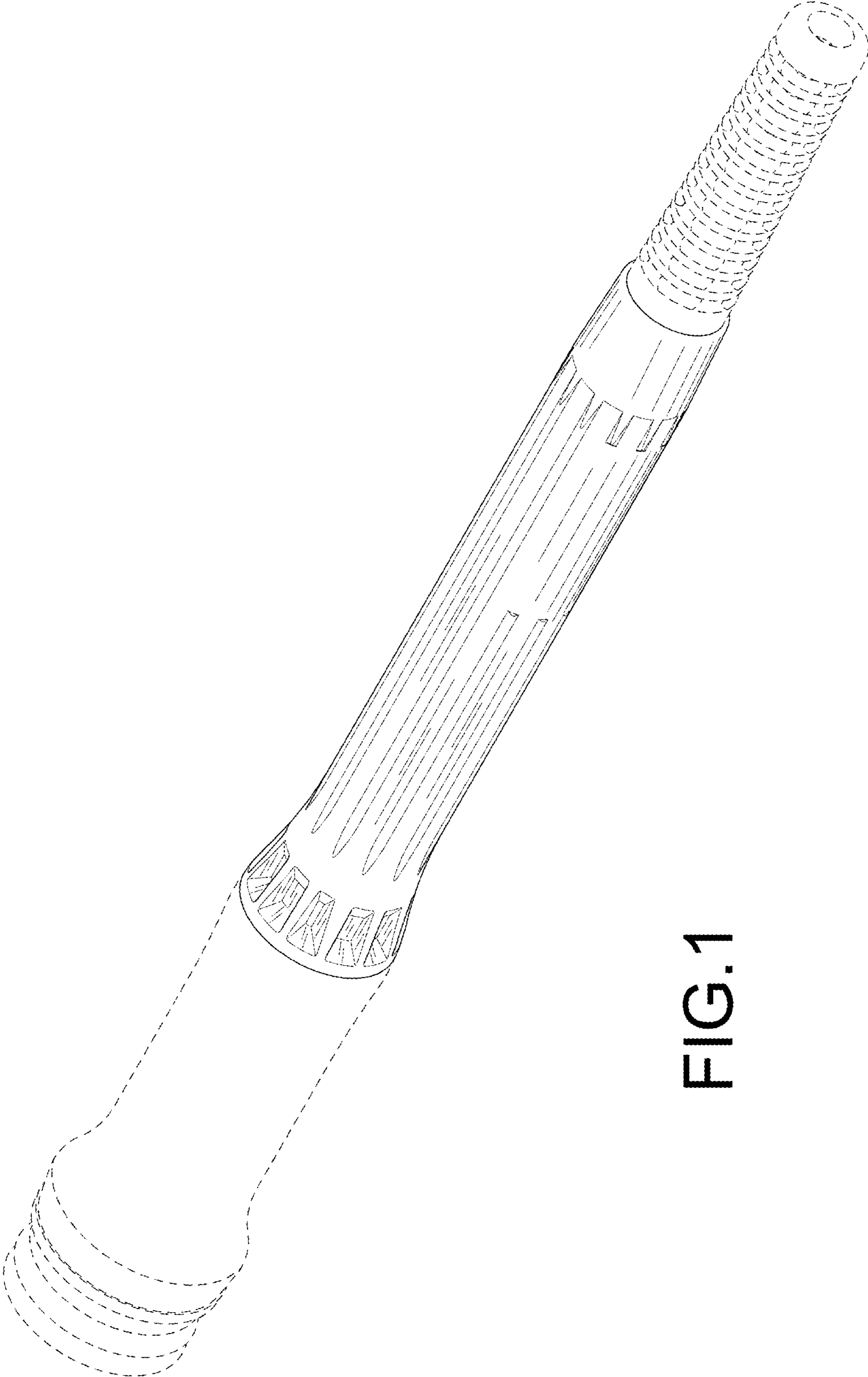

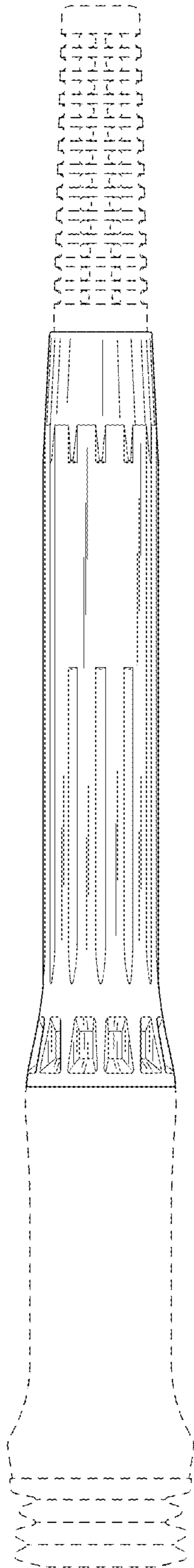

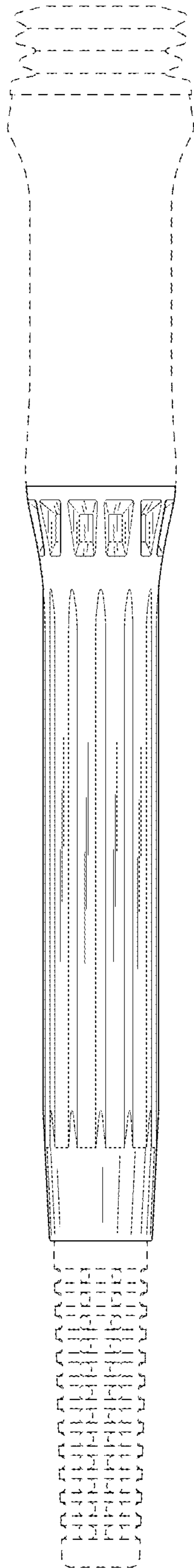

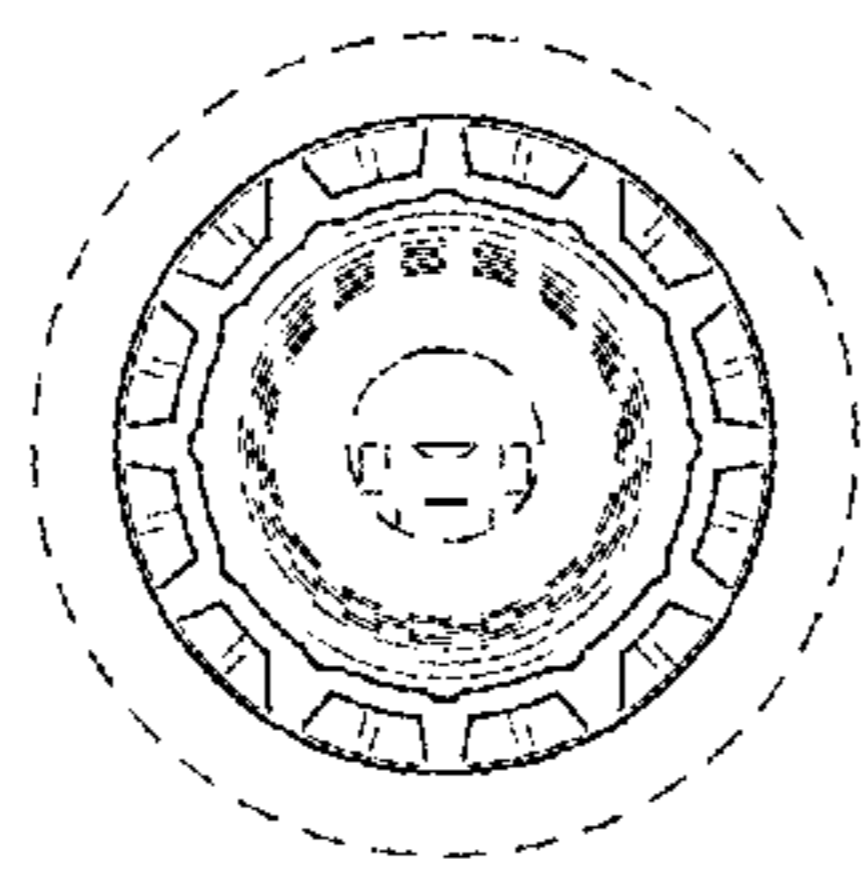

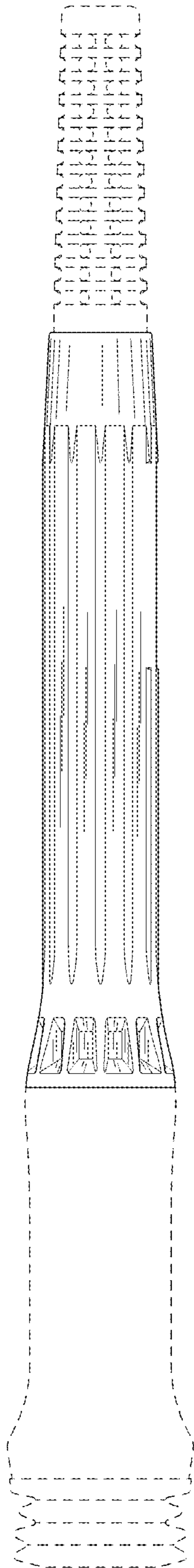

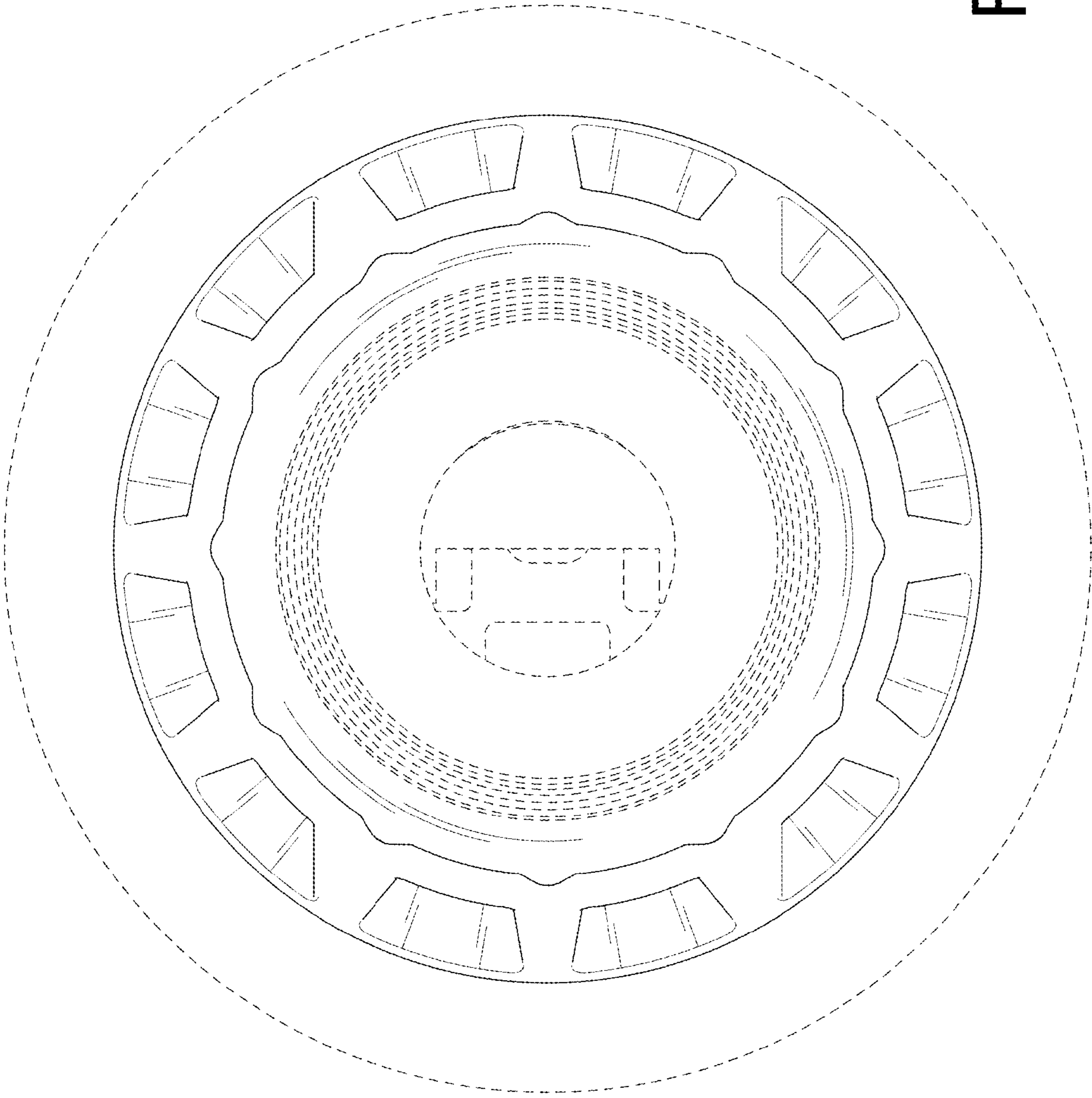
