FIG. 13 is a left side view of the mobile phone of FIG. 1 in the closed state;

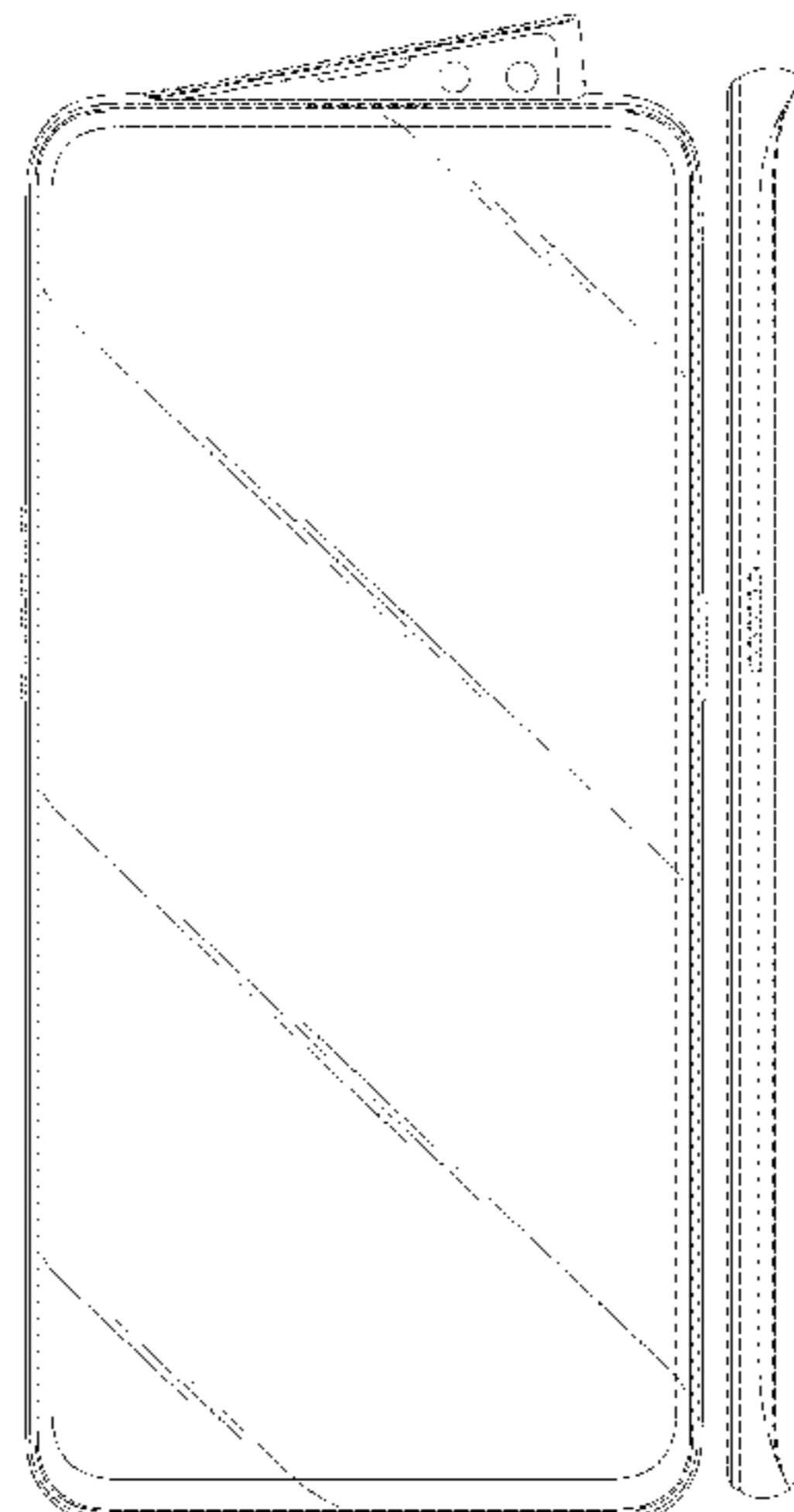
FIG. 14 is a right side view of the mobile phone of FIG. 1 in the closed state;

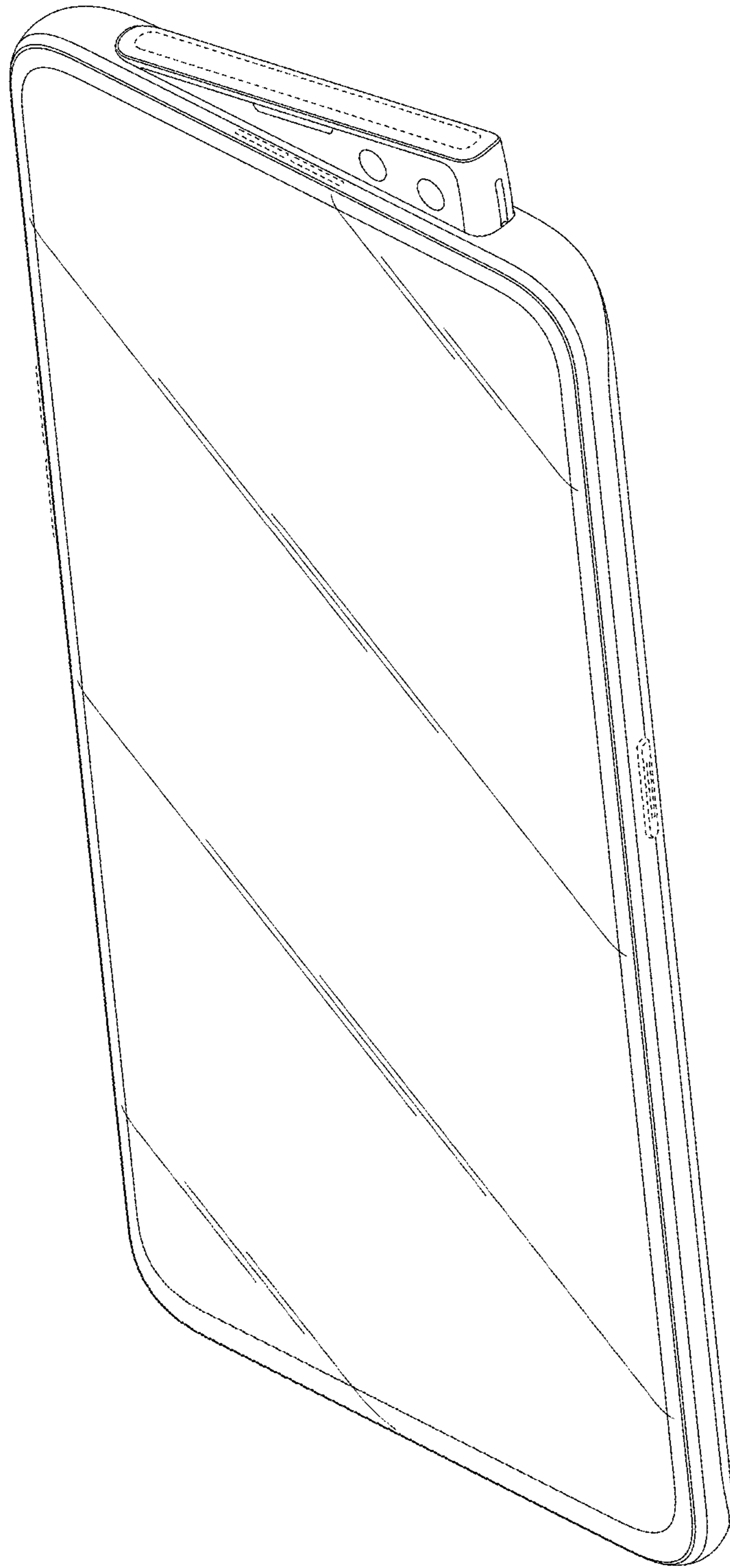

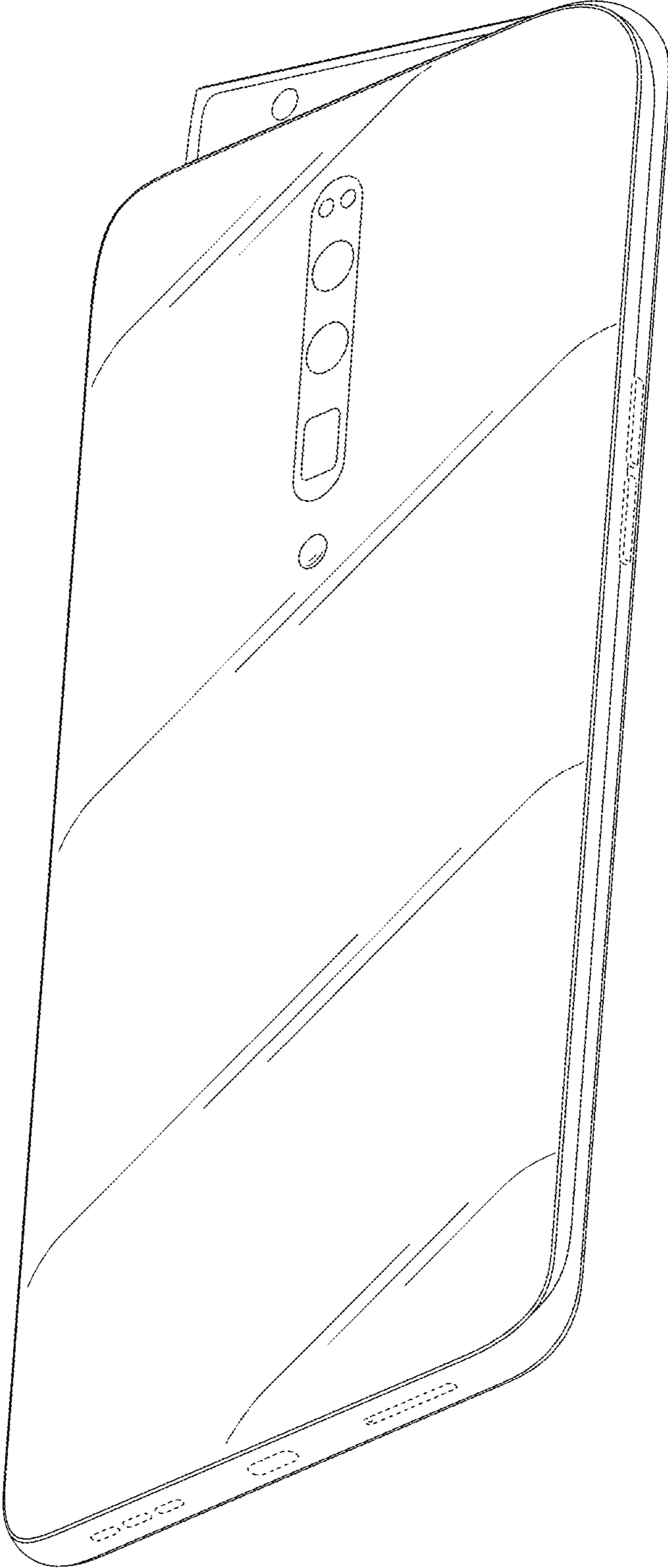

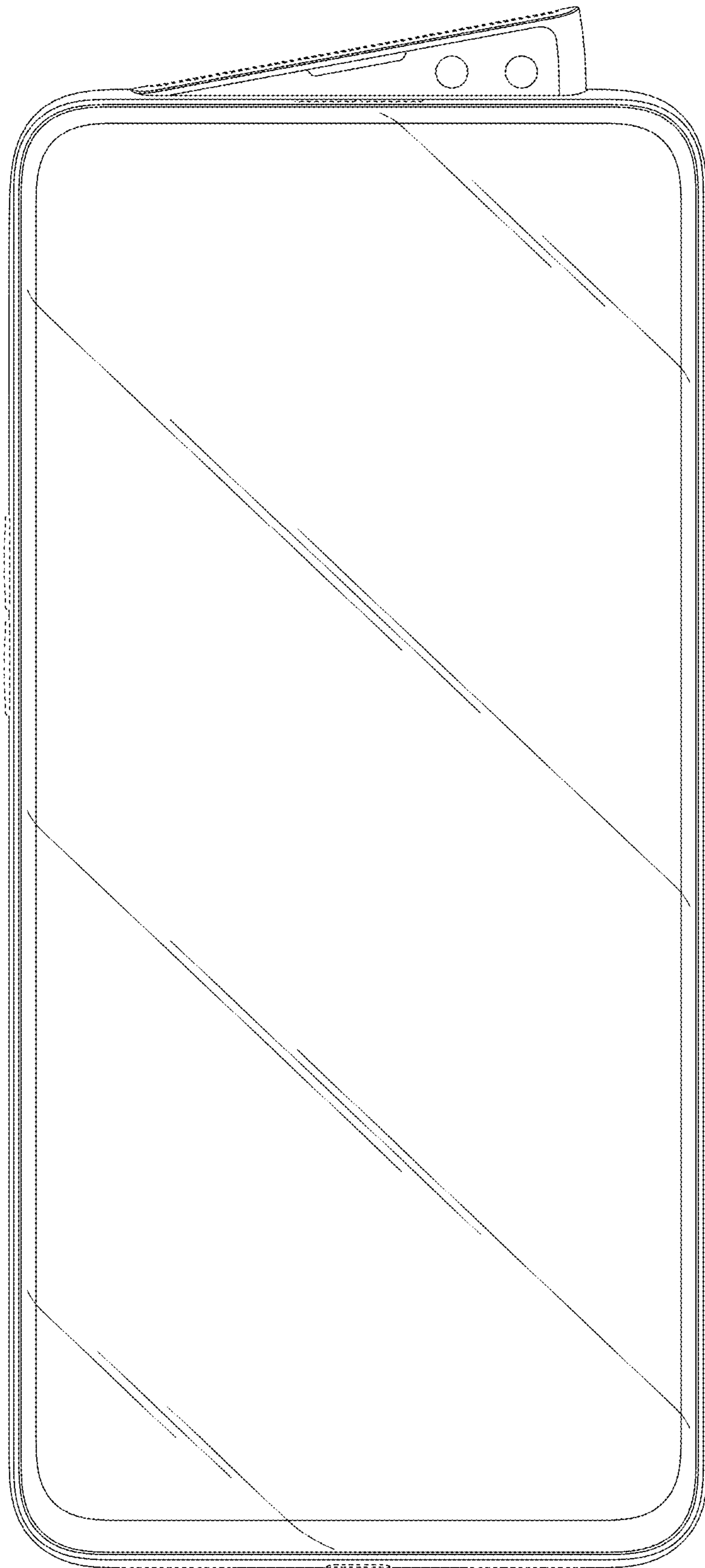

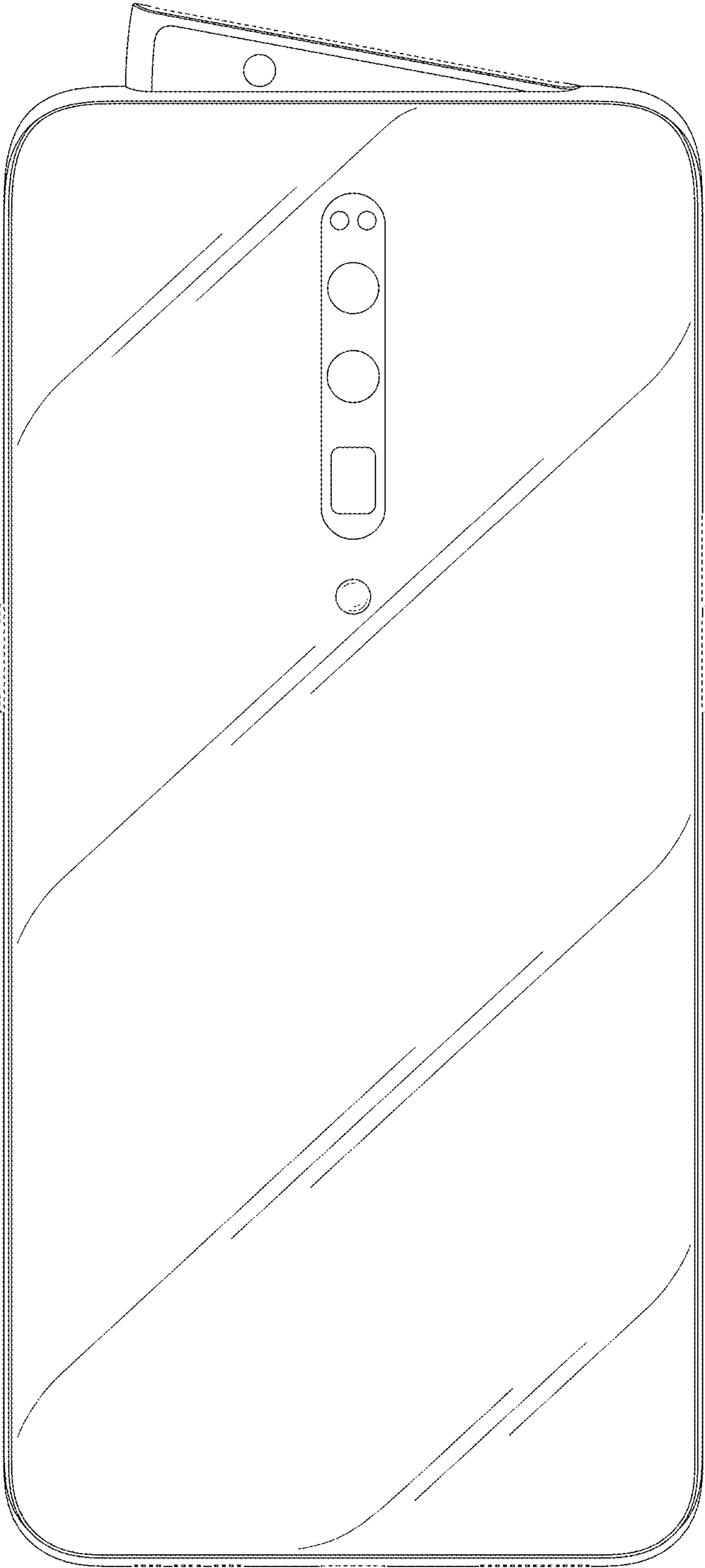

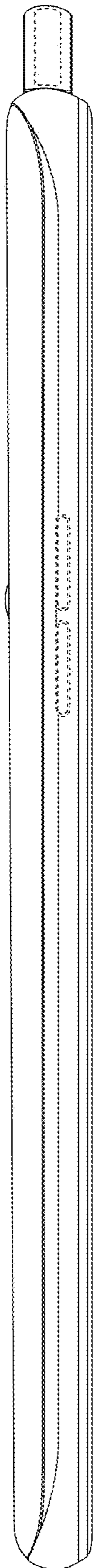

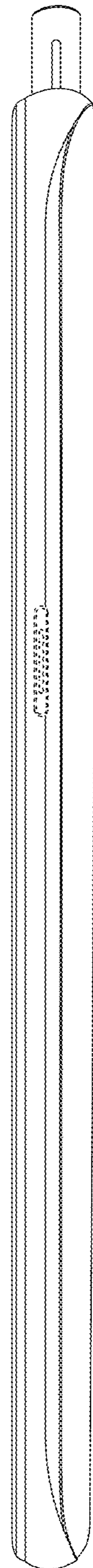

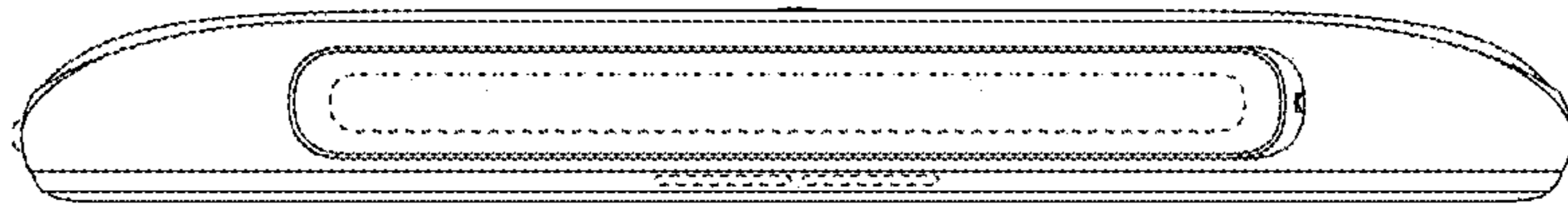

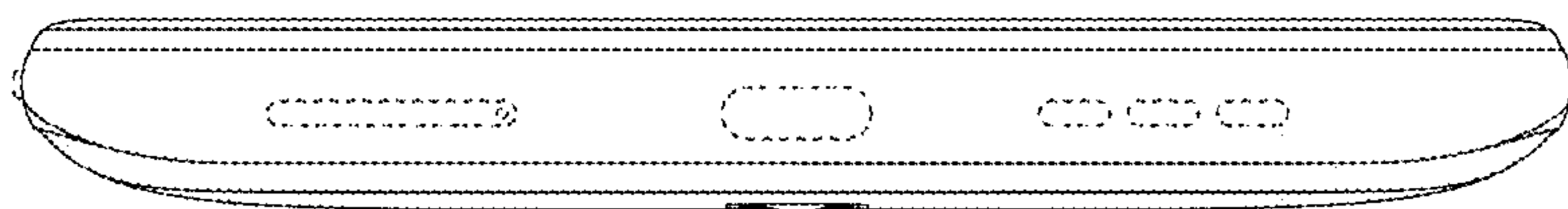

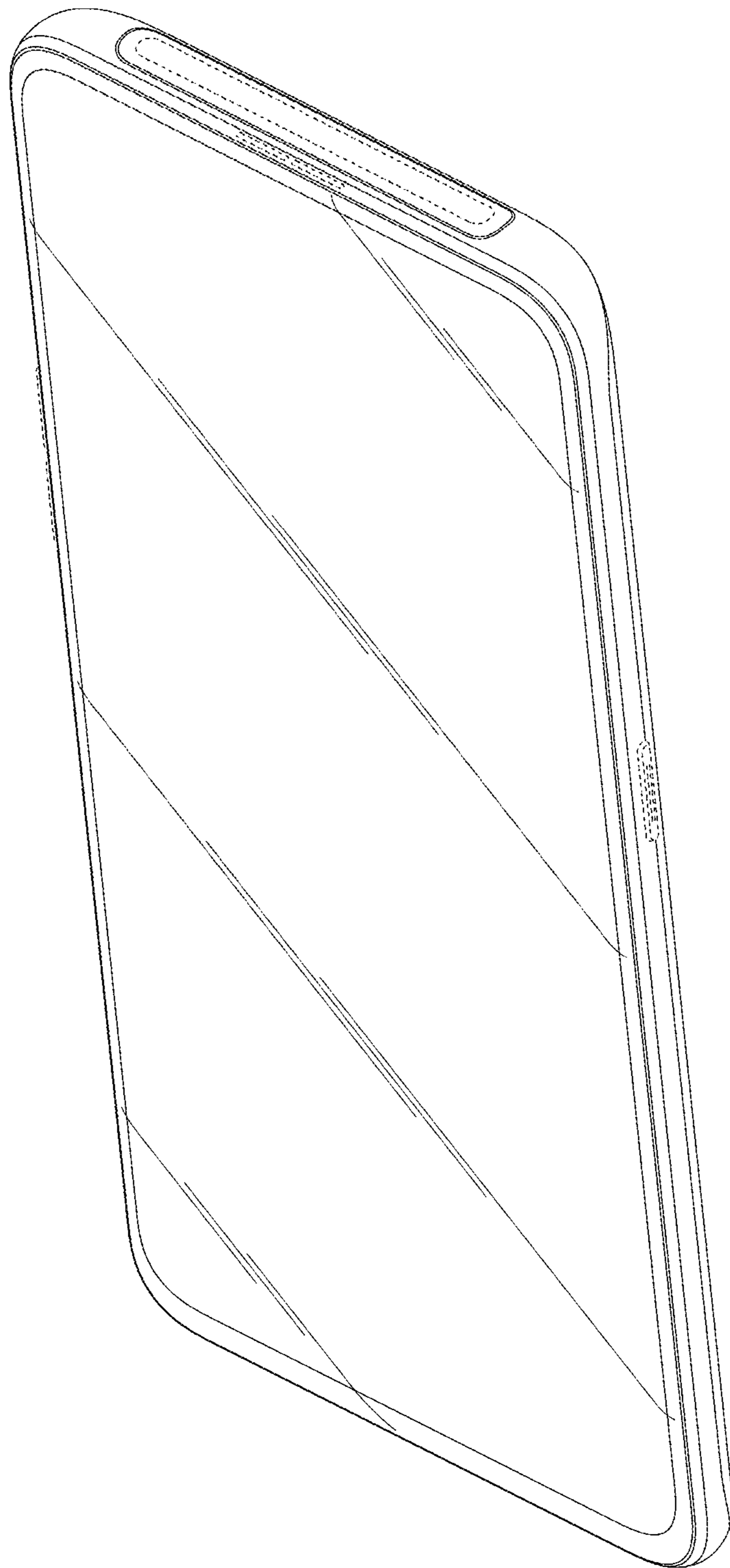

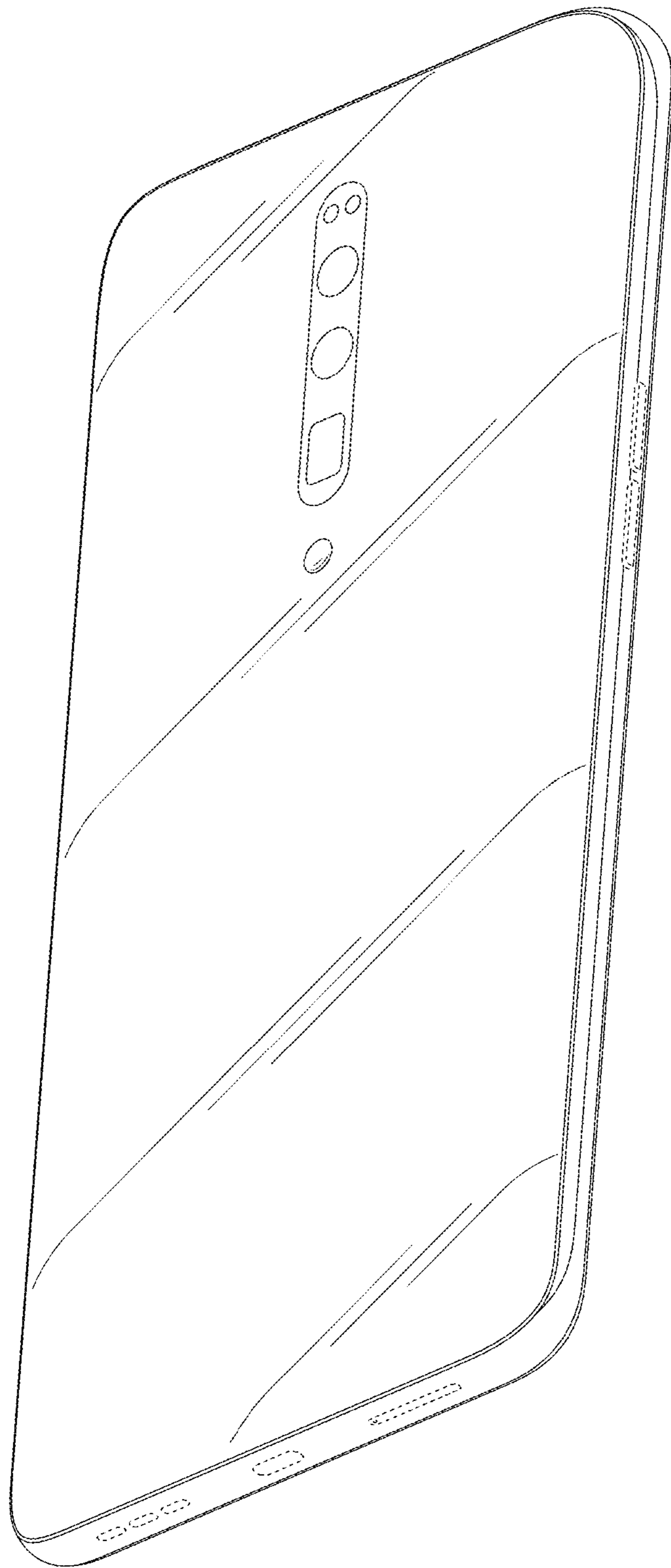

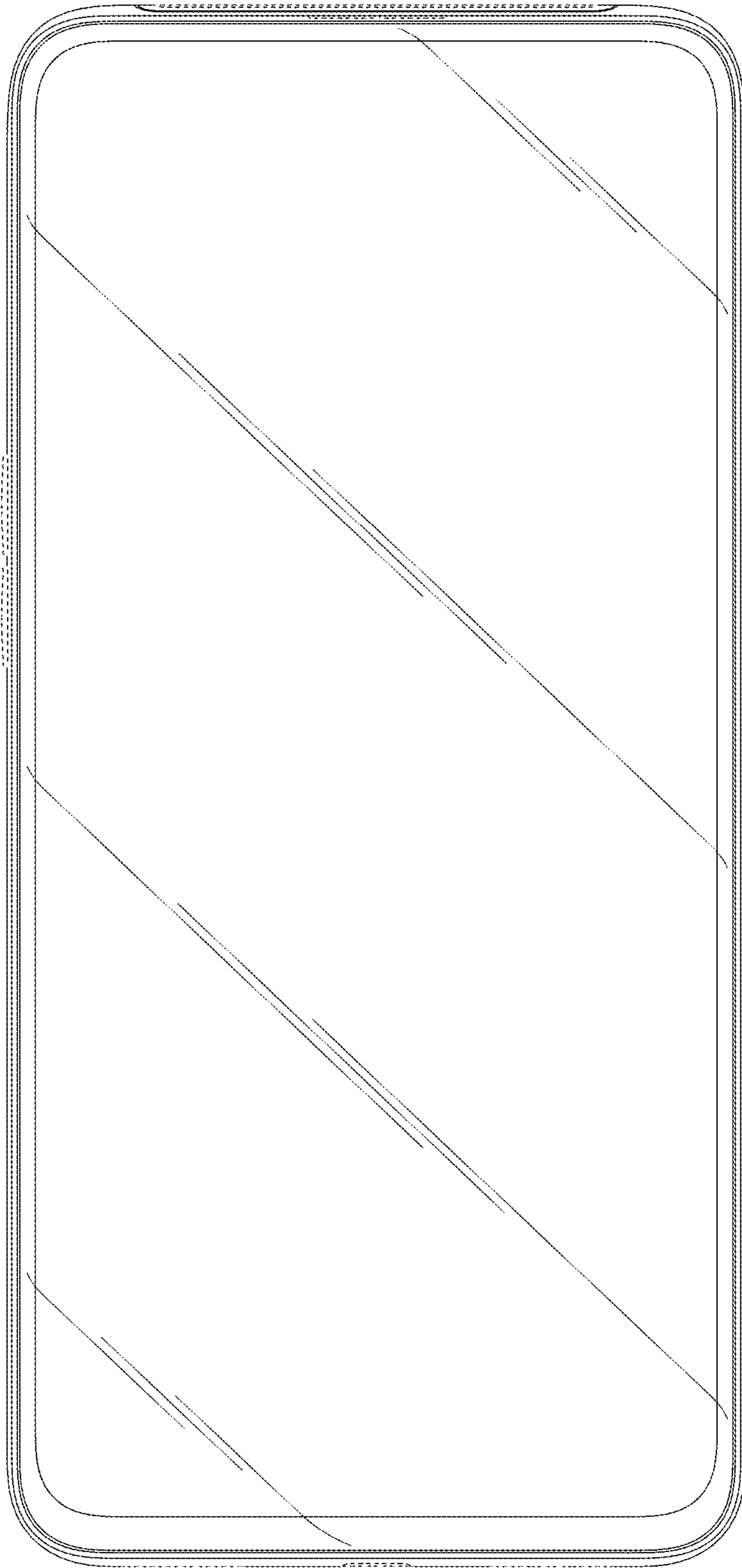

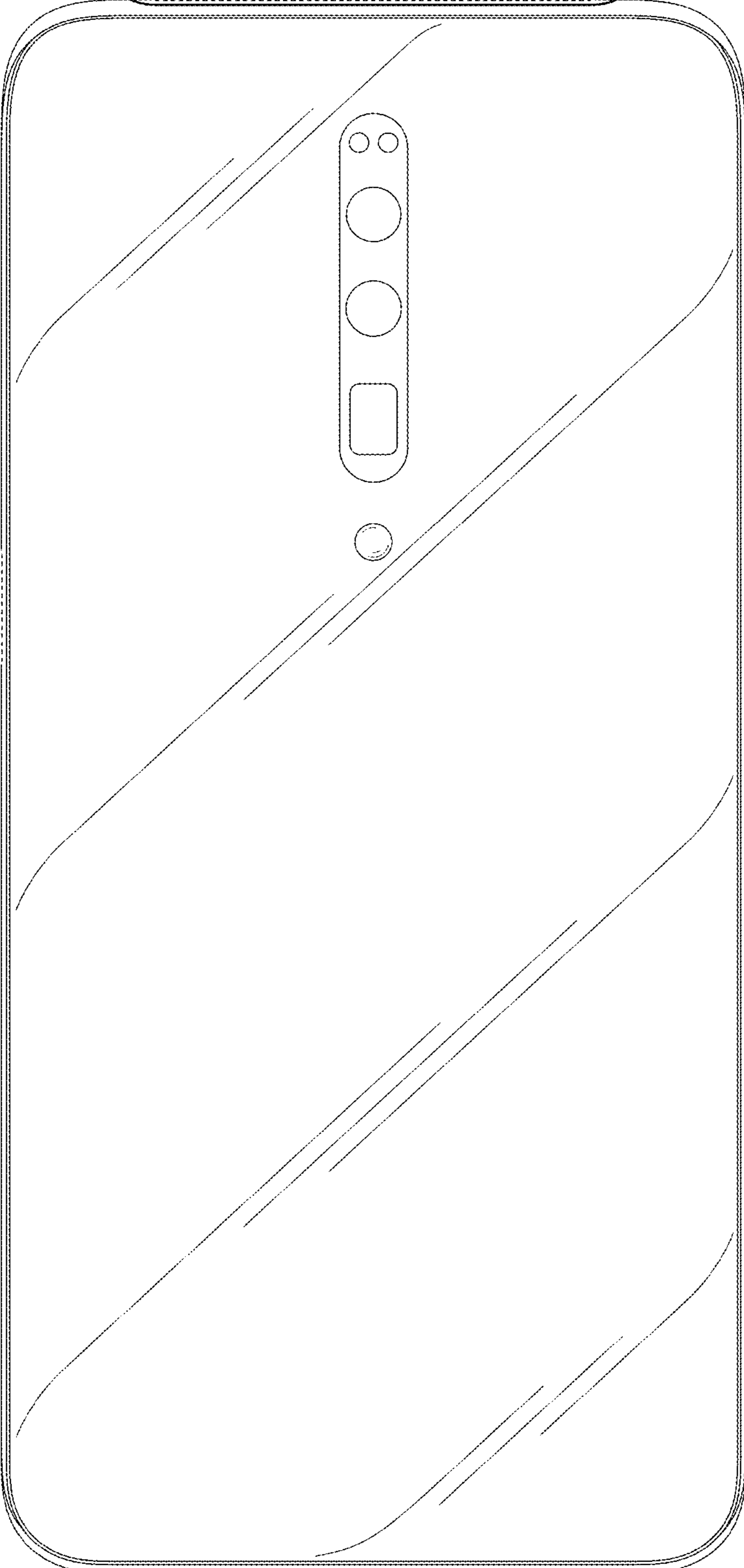

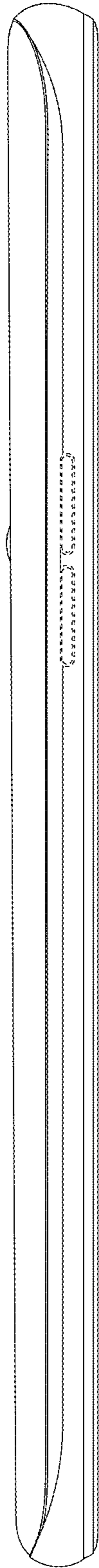

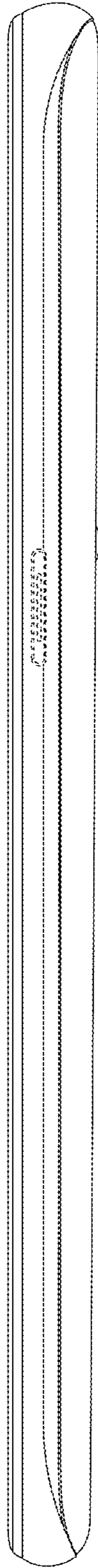

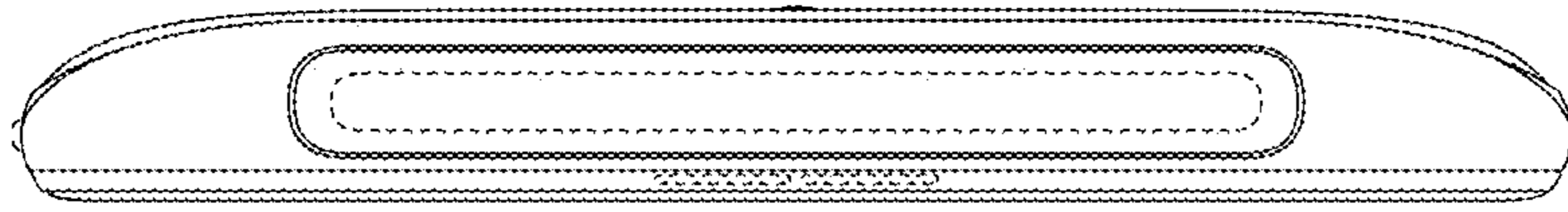
