(57) **CLAIM**

I claim the ornamental design for a display screen with graphical user interface for a prompt animation, as shown and described.

**DESCRIPTION**

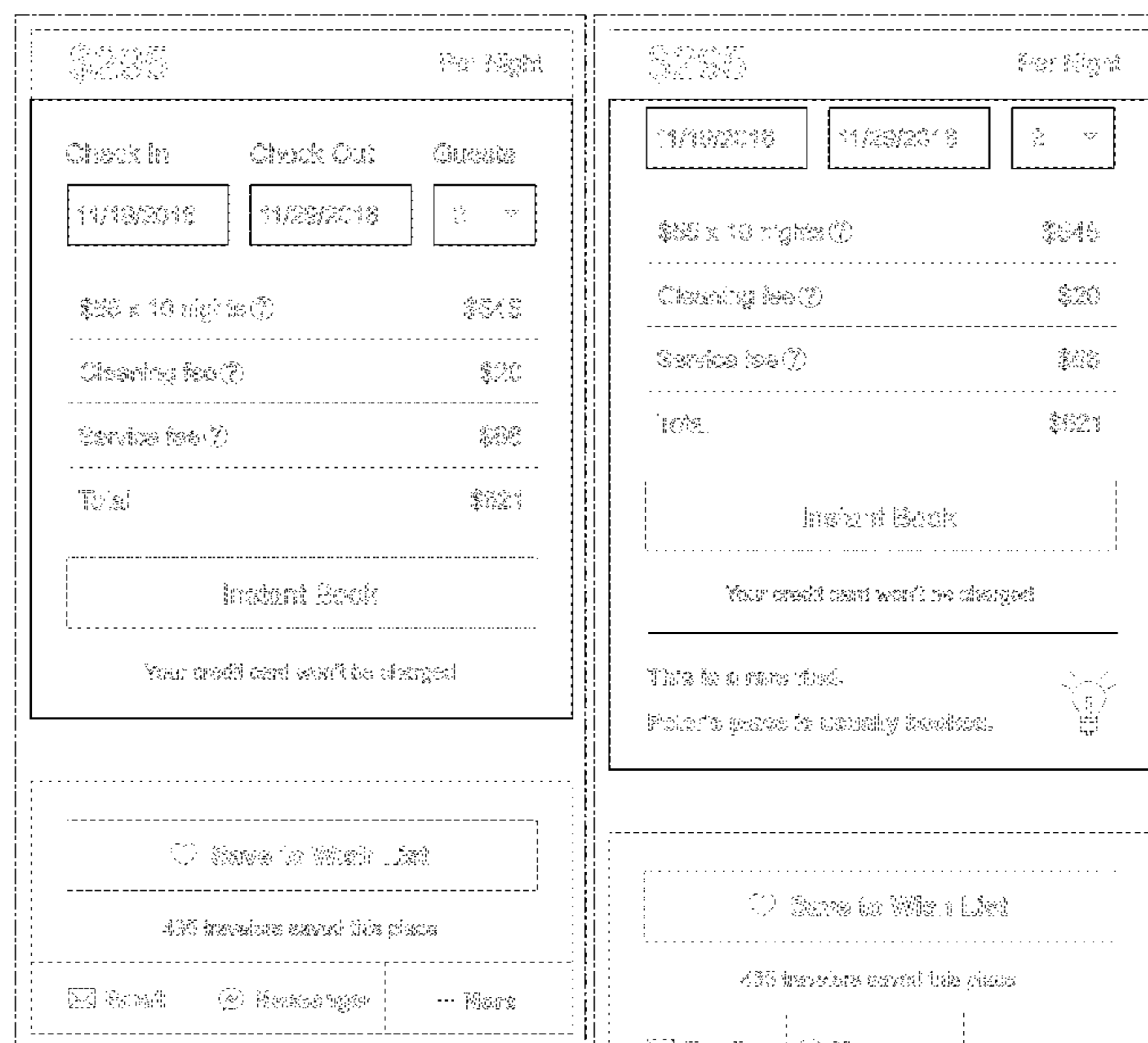
FIG. 1 is a view of the entire display screen on which the prompt animation shown in FIGS. 2-5 is displayed. The outer rectangle shown in FIG. 1 represents the perimeter of the graphical user interface.

FIG. 1 is a first view of a first image of a display screen with graphical user interface for a prompt animation; FIG. 2 is a second view of the first image thereof; FIG. 3 is a view of a second image thereof; FIG. 4 is a view of a third image thereof; and, FIG. 5 is a view of a fourth image thereof.

The broken lines (including the dash-dash broken lines and the dash-dot broken lines) shown in the figures illustrate portions of the graphical user interface that form no part of the claimed design.

The subject matter in this patent includes a process or period in which an image changes into another image. This process or period forms no part of the claimed design.

The outer edge of the portion of the display screen is understood to be congruent with the outer edge of the graphical user interface.

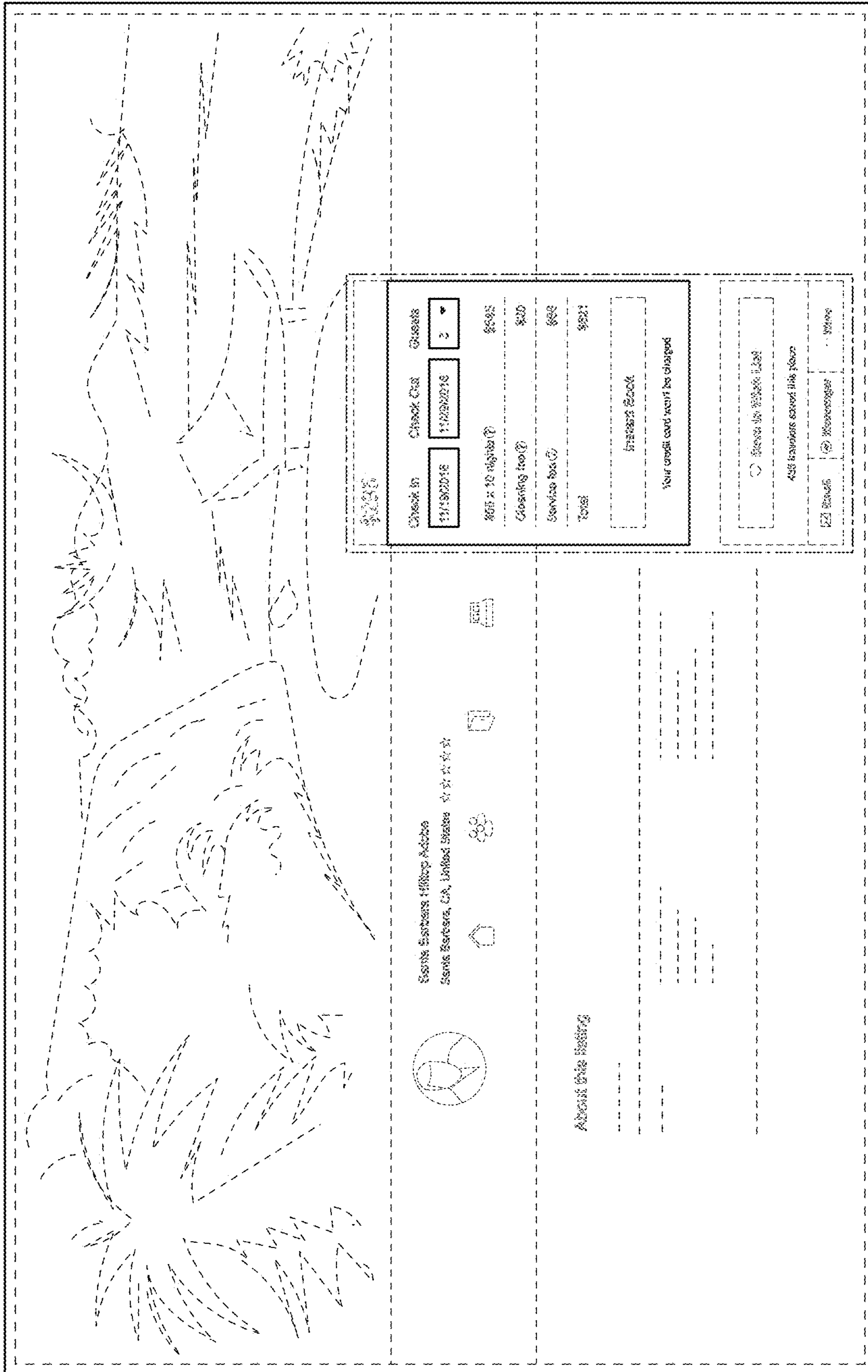
