(57) **CLAIM**

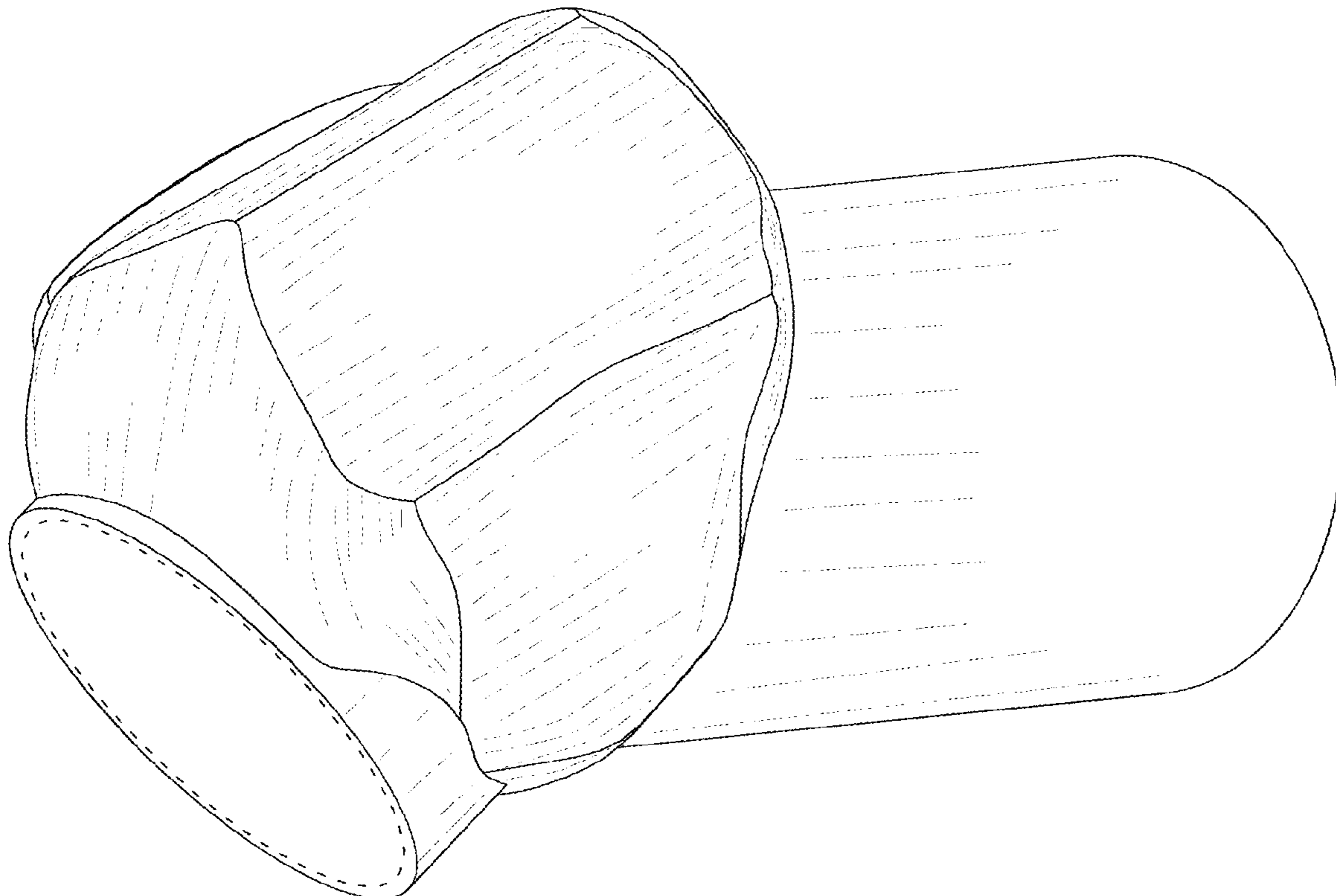
The ornamental design for a surgical binocular loupes casing, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a surgical binocular loupes casing showing my new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a front elevated view thereof; FIG. 4 is a rear elevated view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right elevated view thereof; and, FIG. 8 is a left elevated view thereof.

The broken lines showing of orifices in FIGS. 1-4, and FIG. 6 are included for showing portions of the surgical binocular loupes casing that form no part of the claimed design.

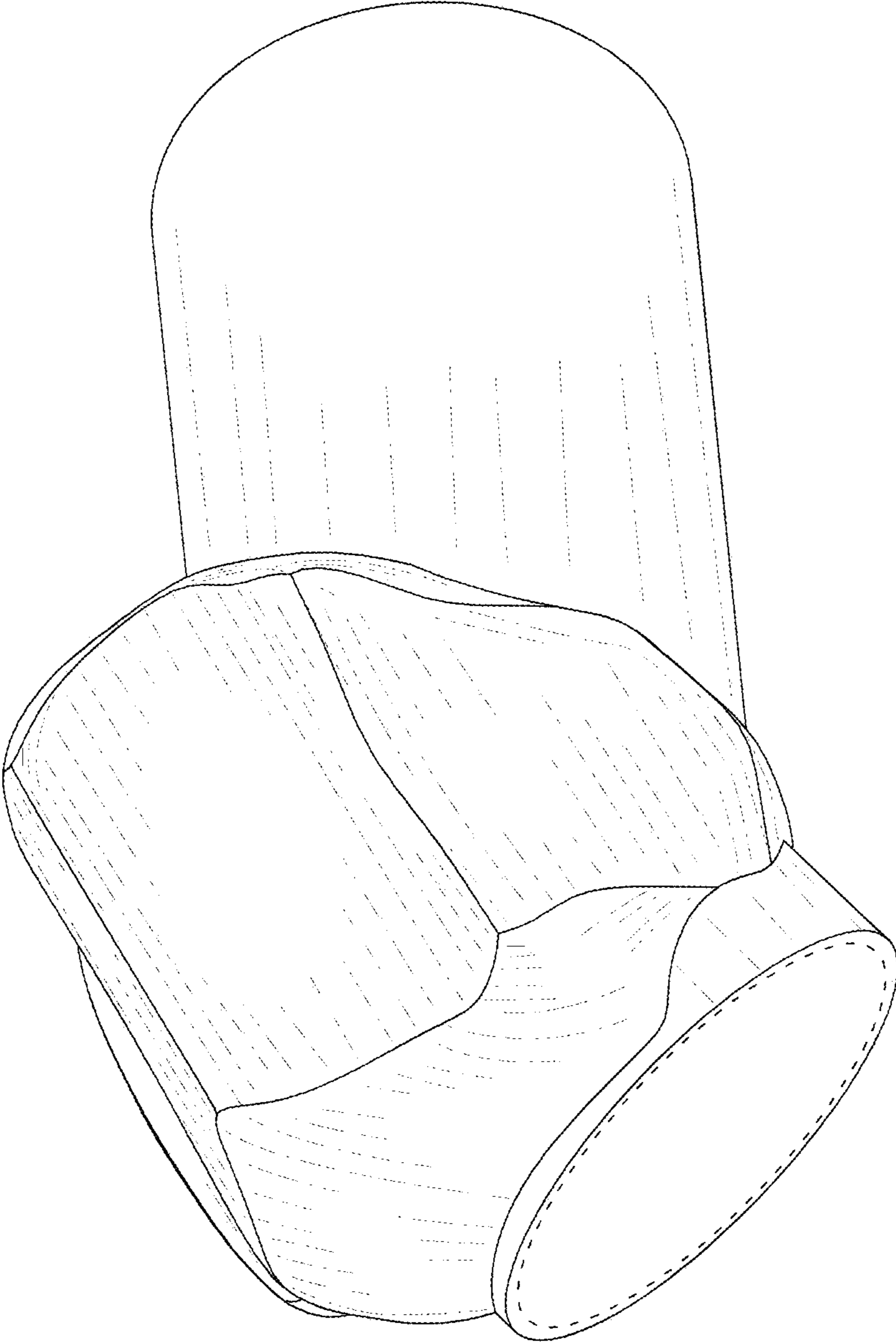

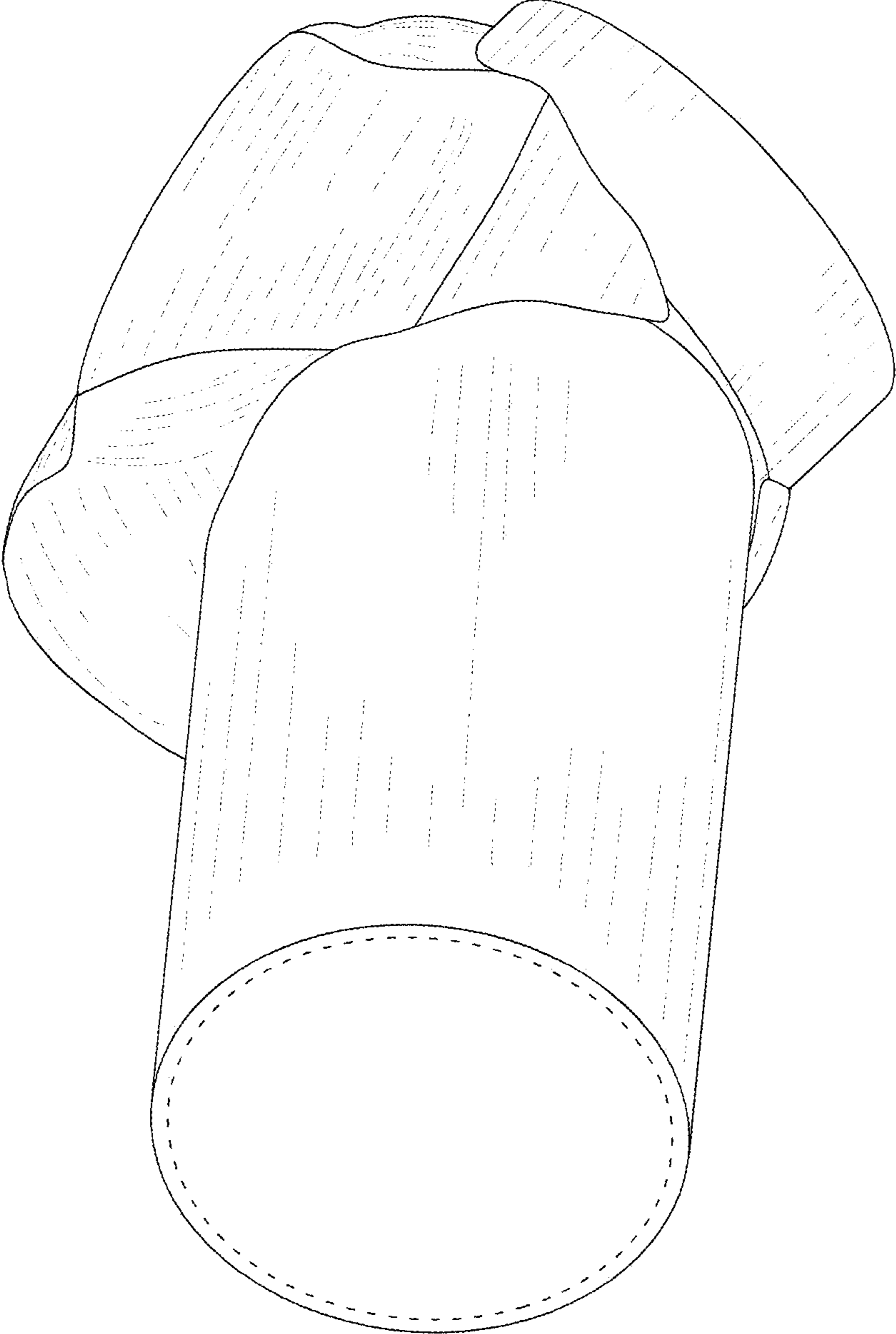

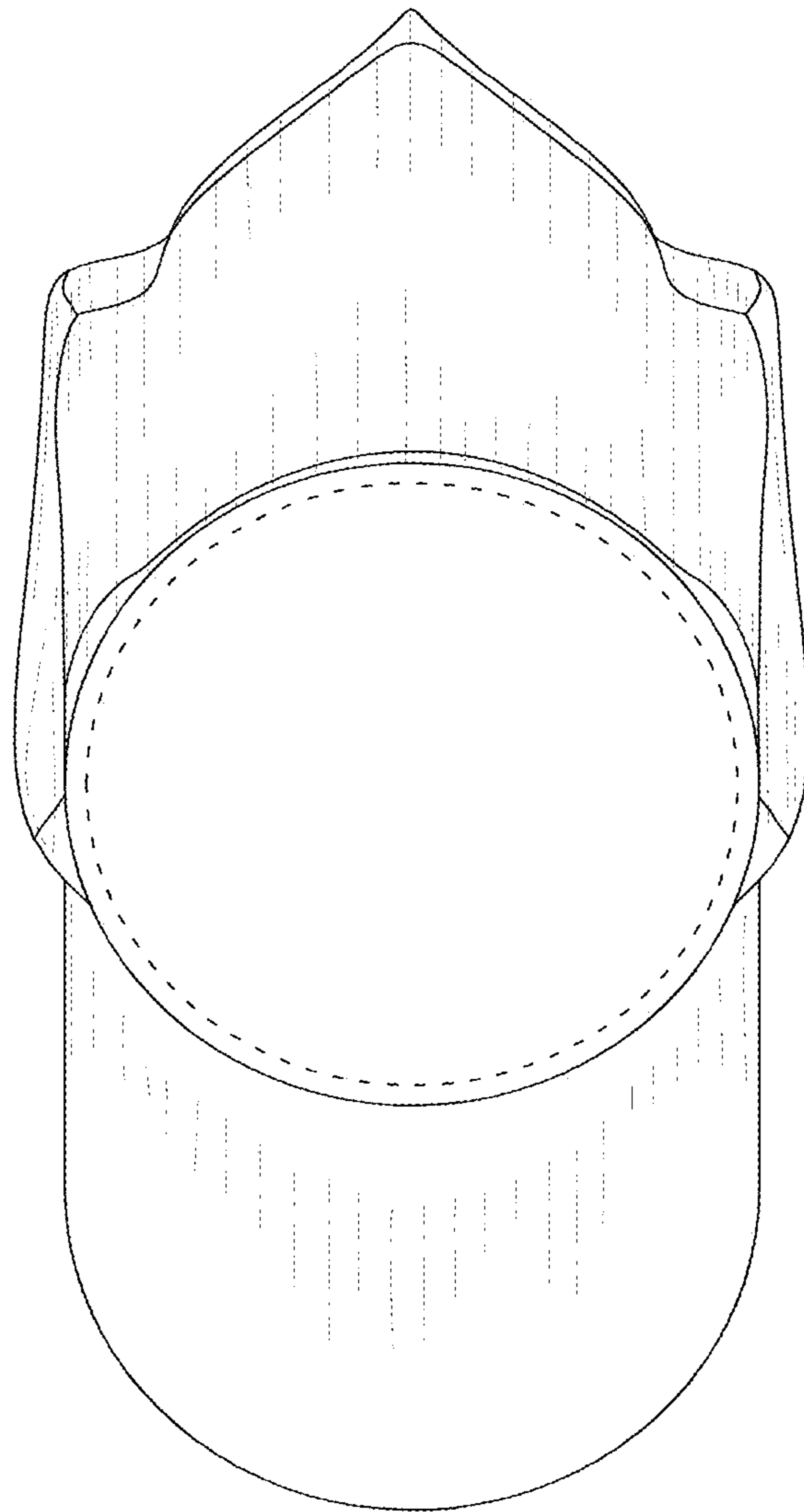

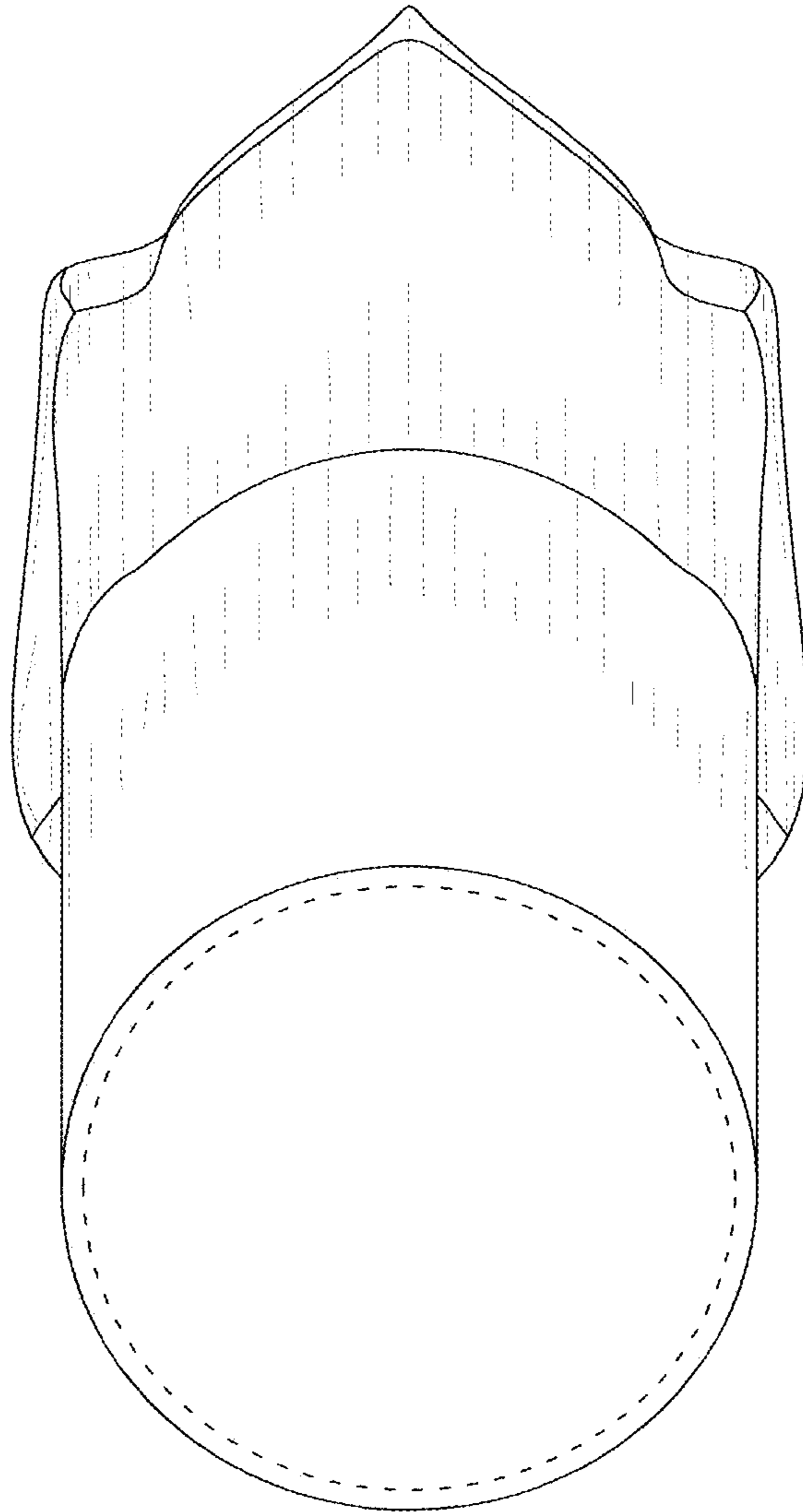

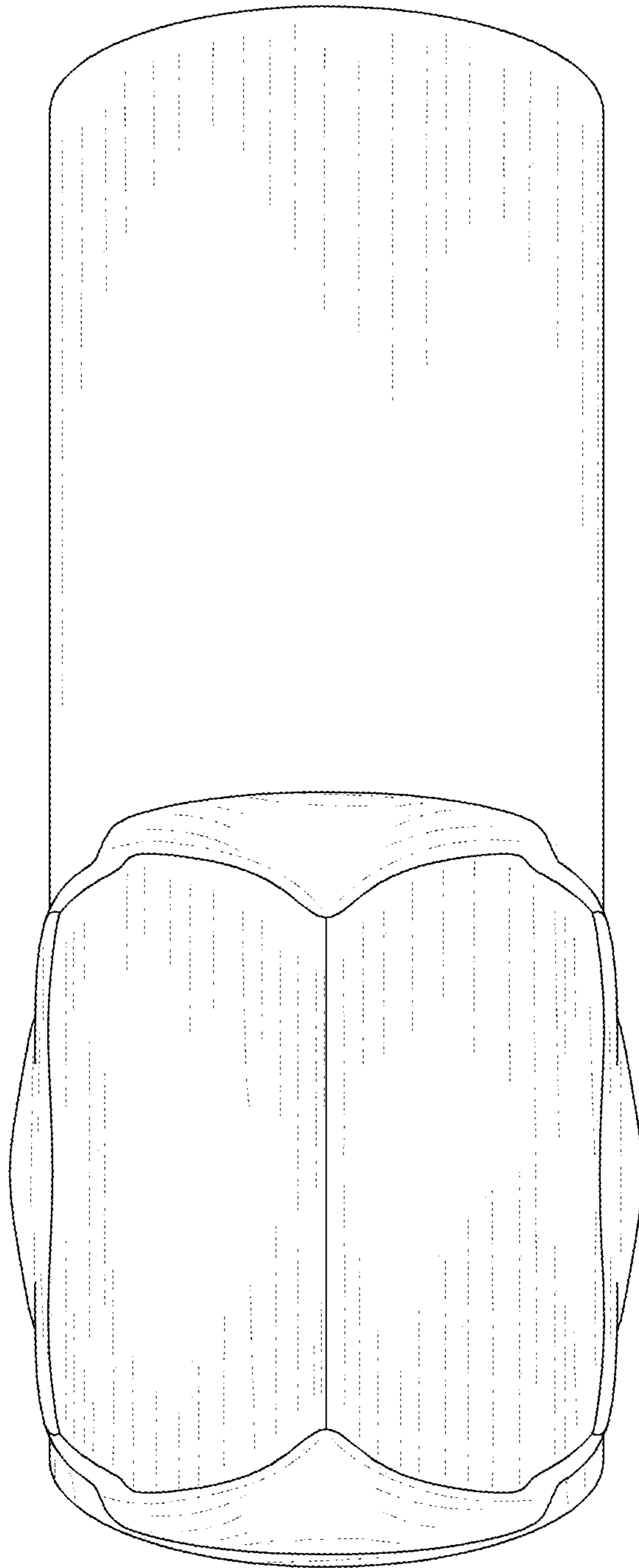

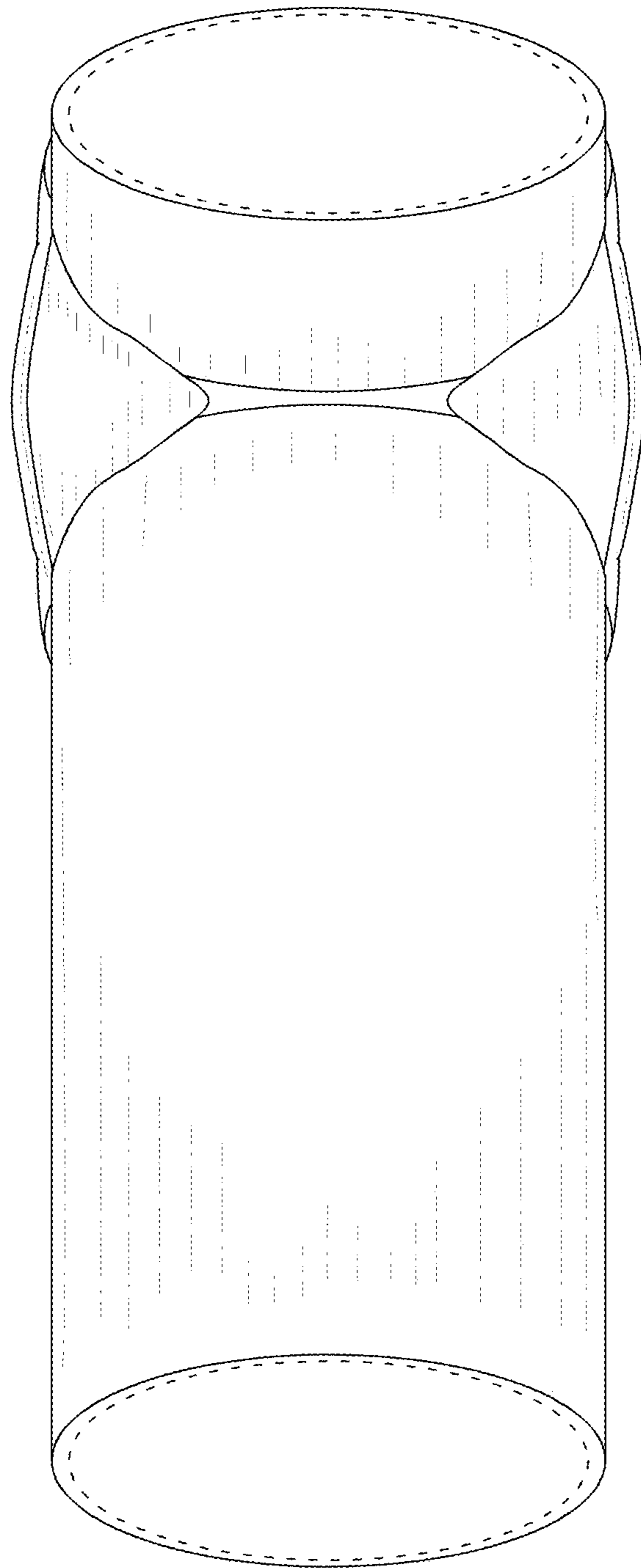

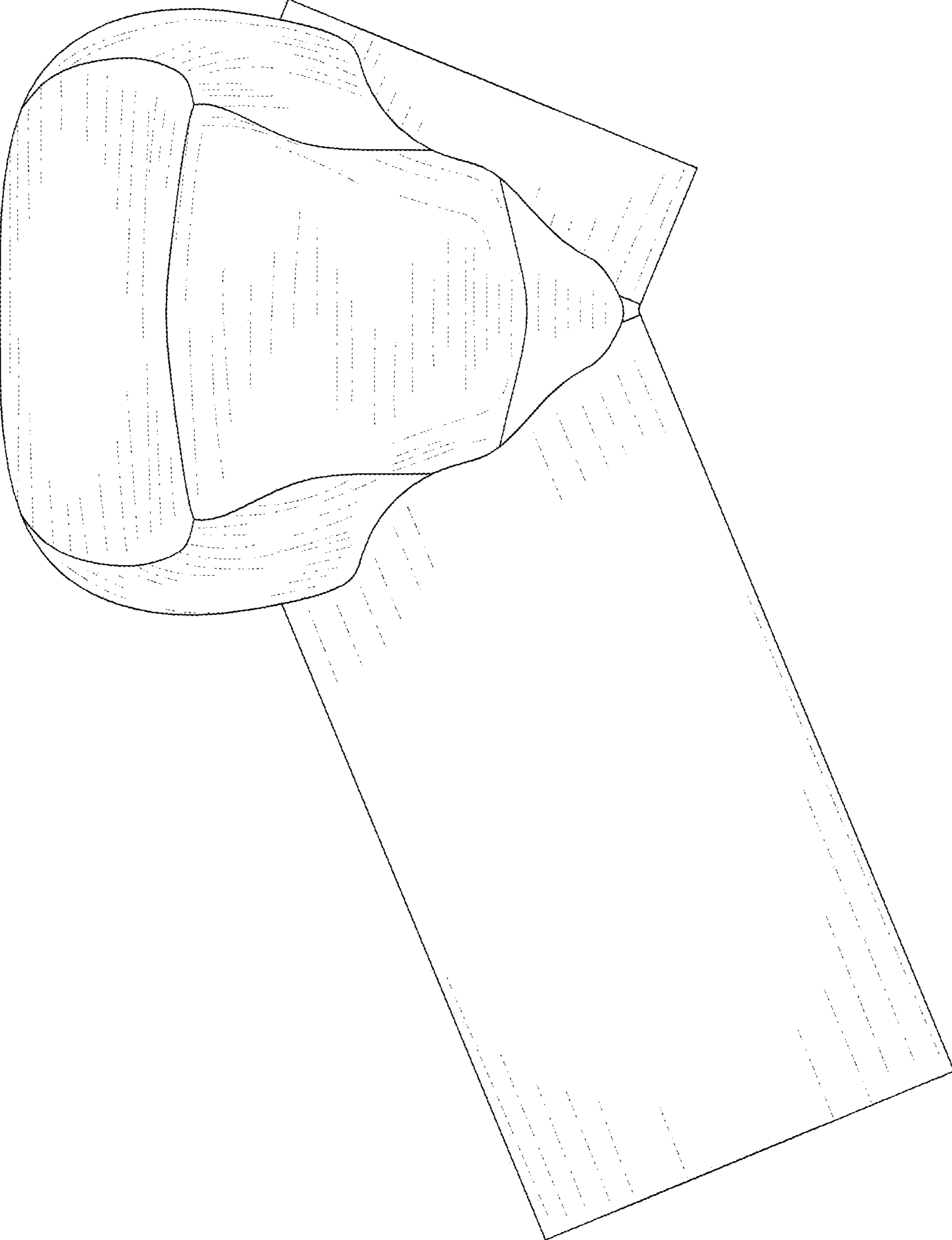

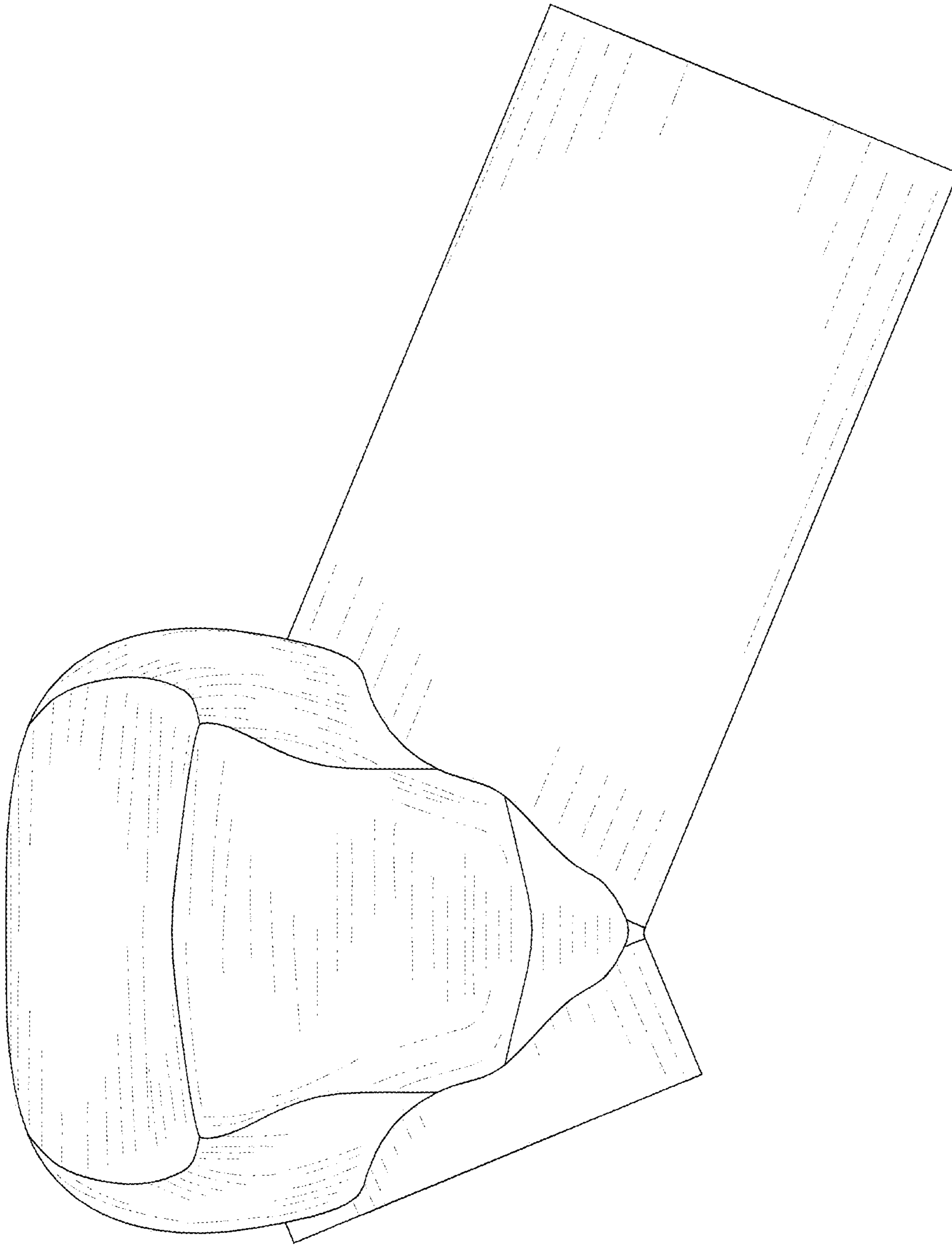
