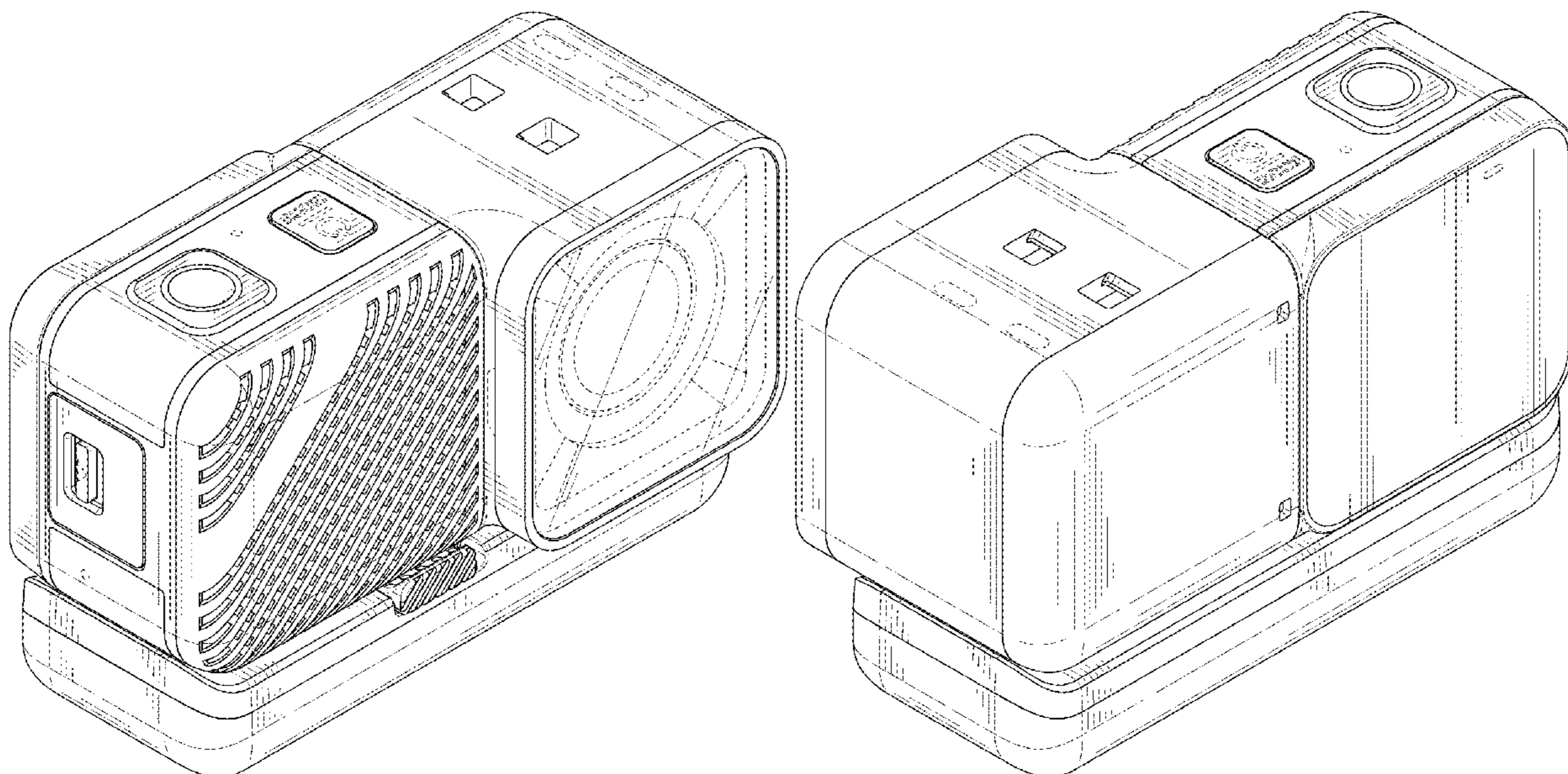
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front and left side perspective view of a camera showing our new design;

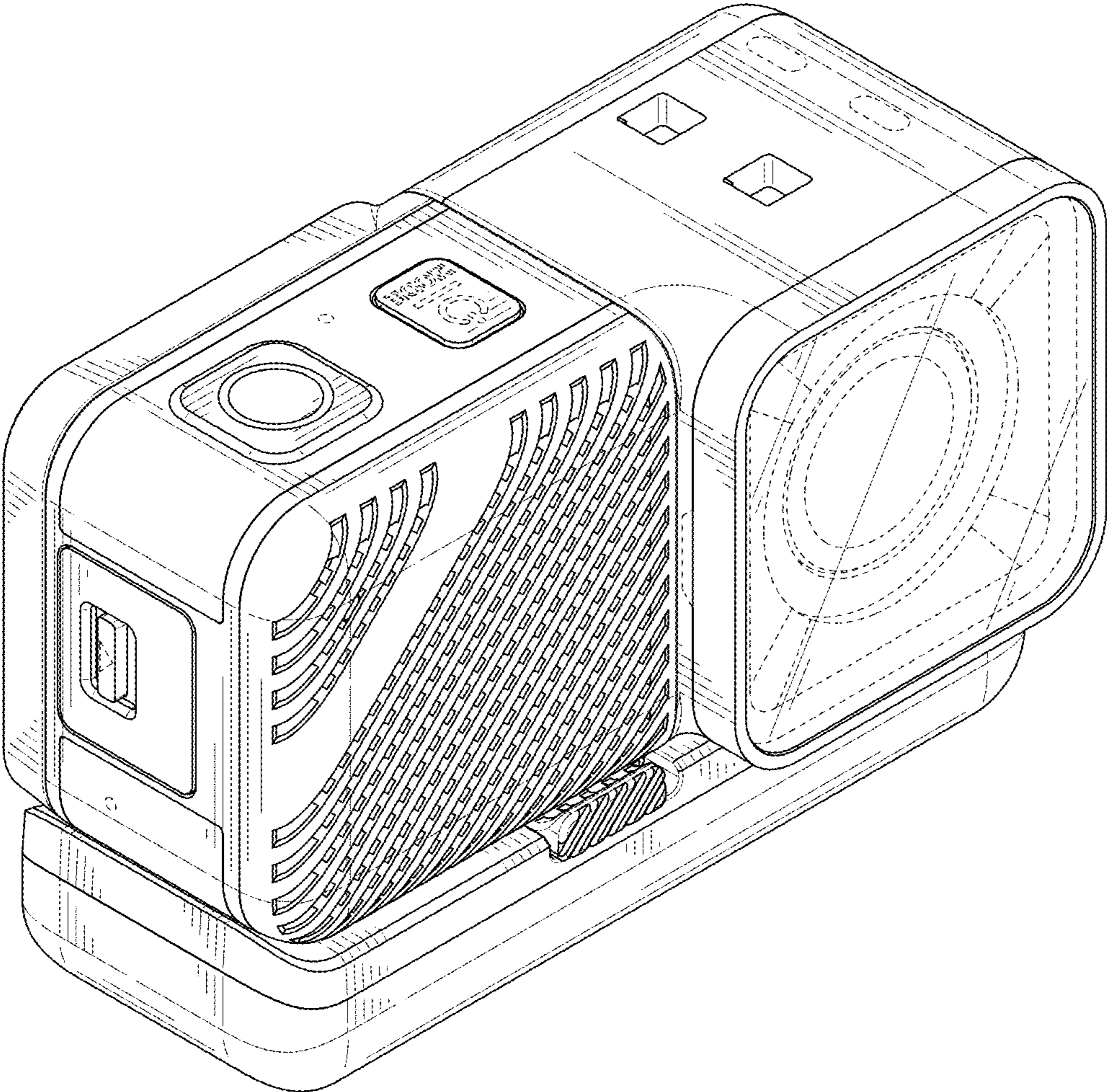

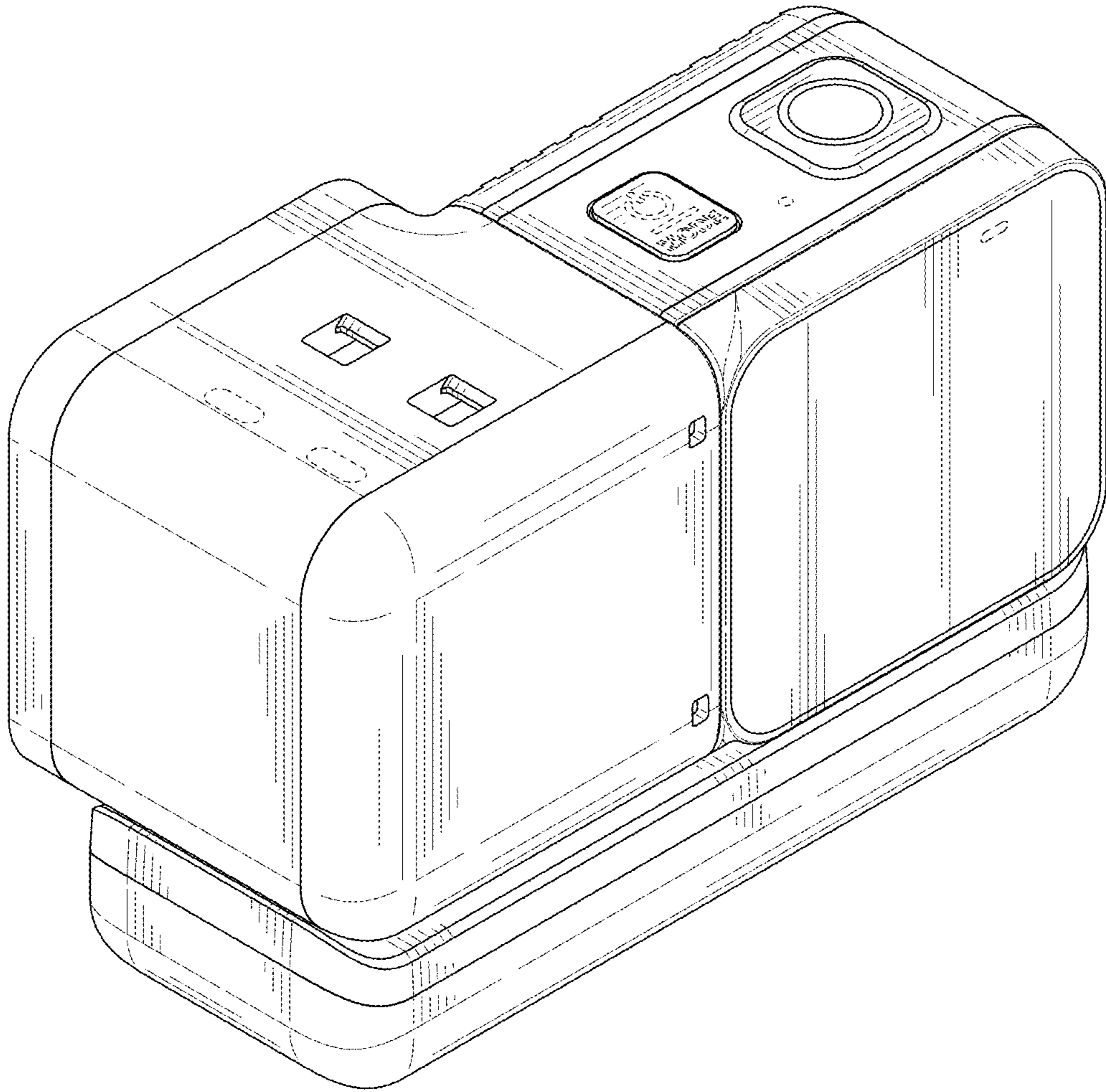

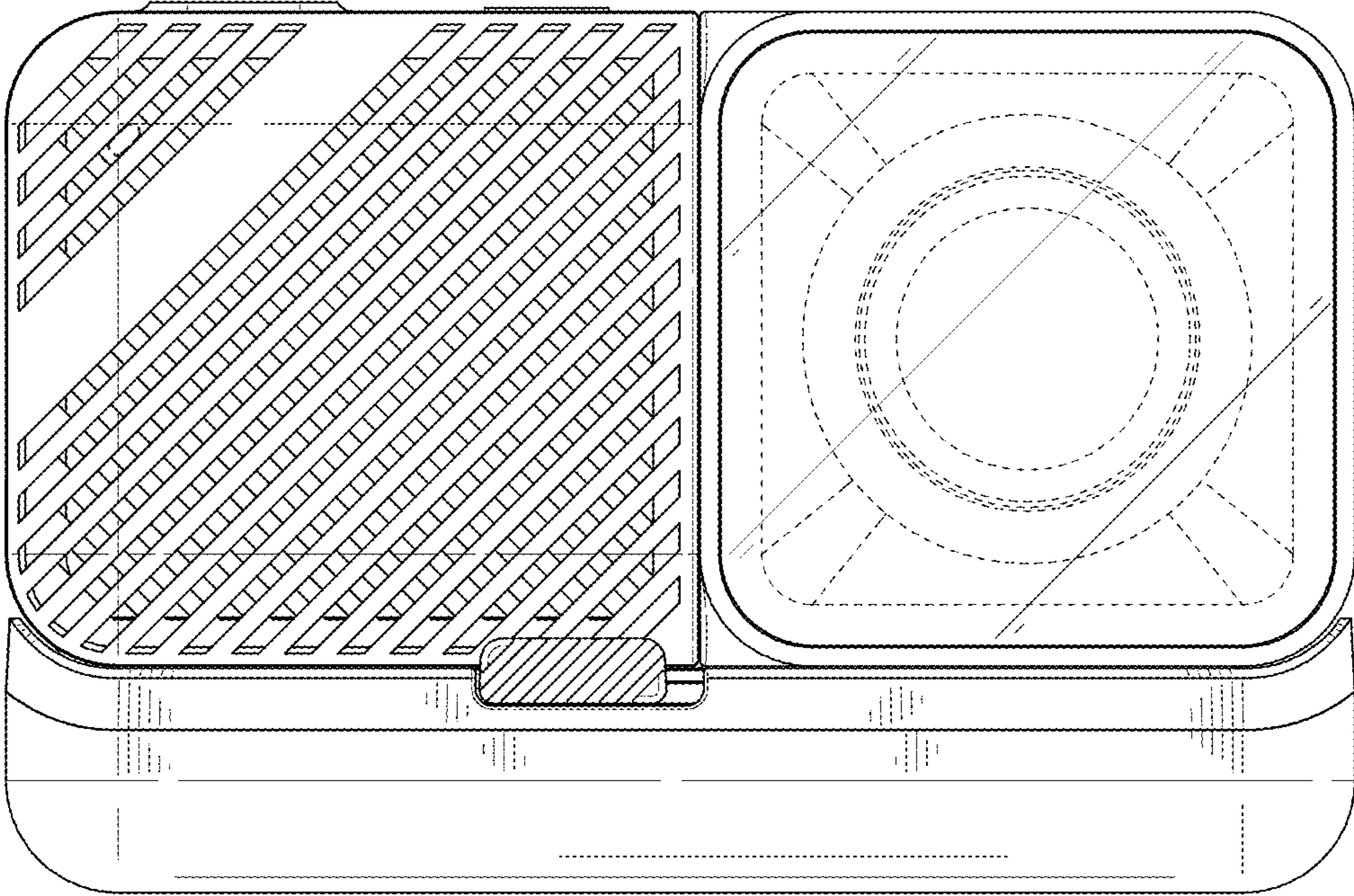

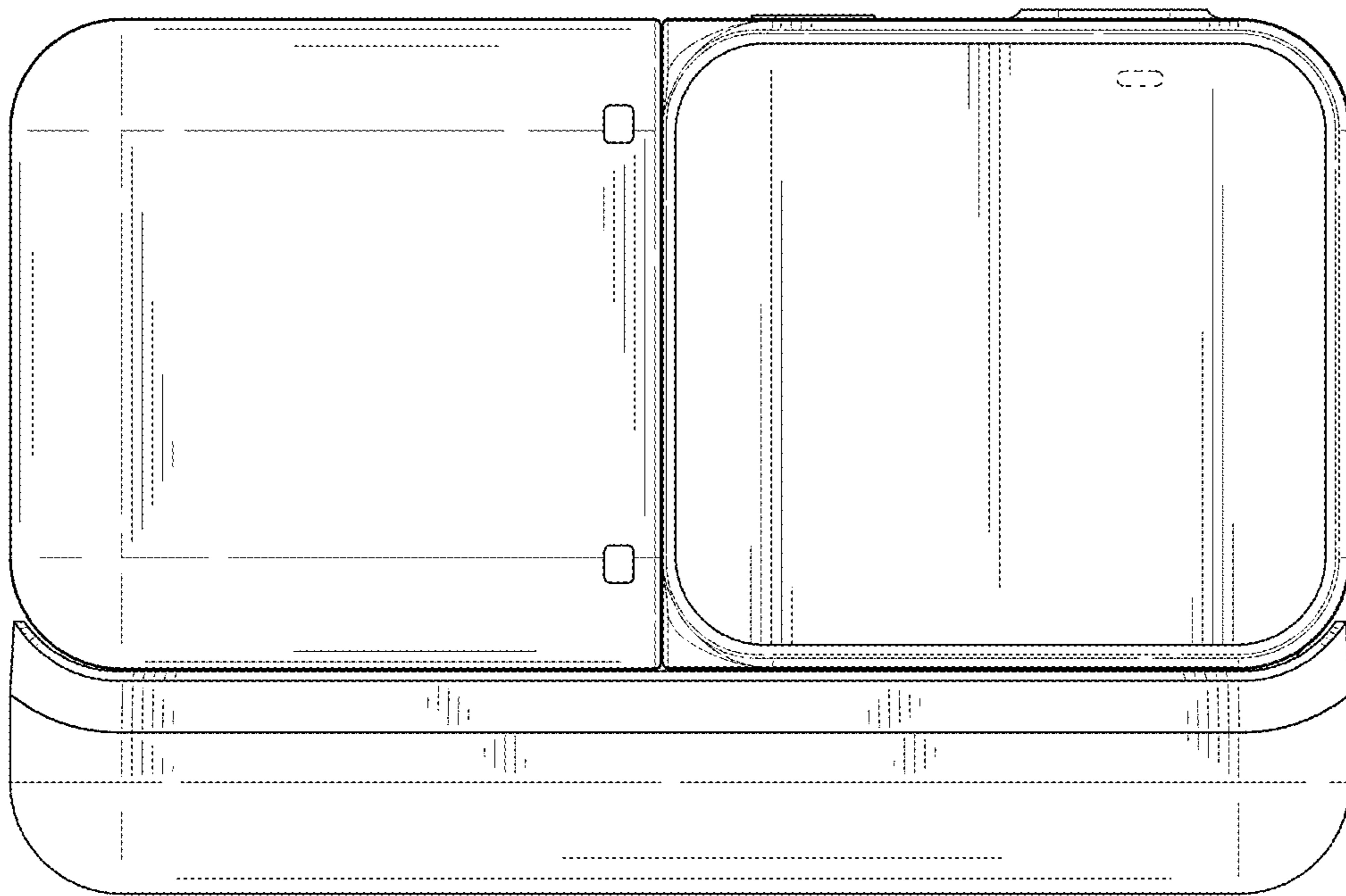

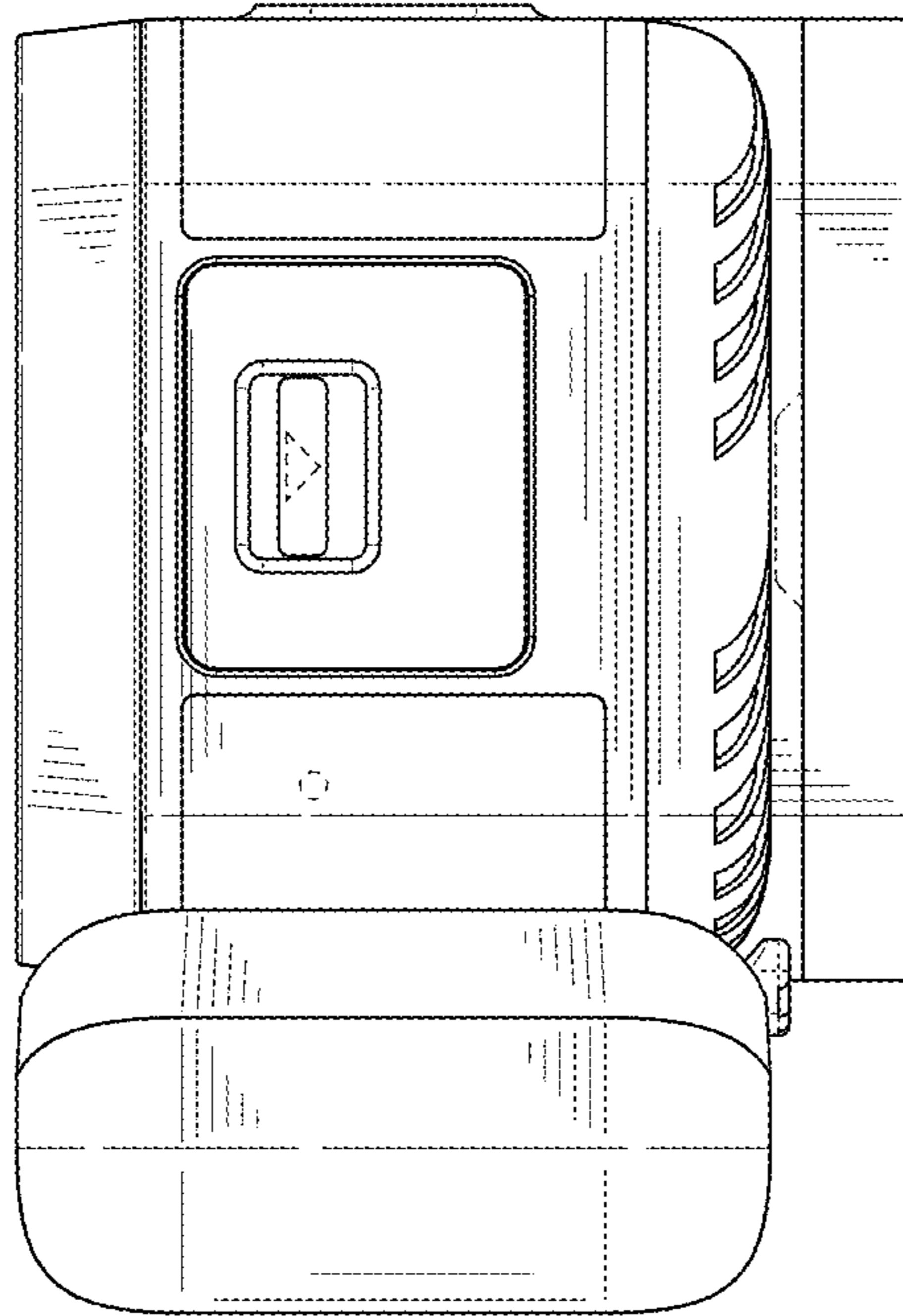

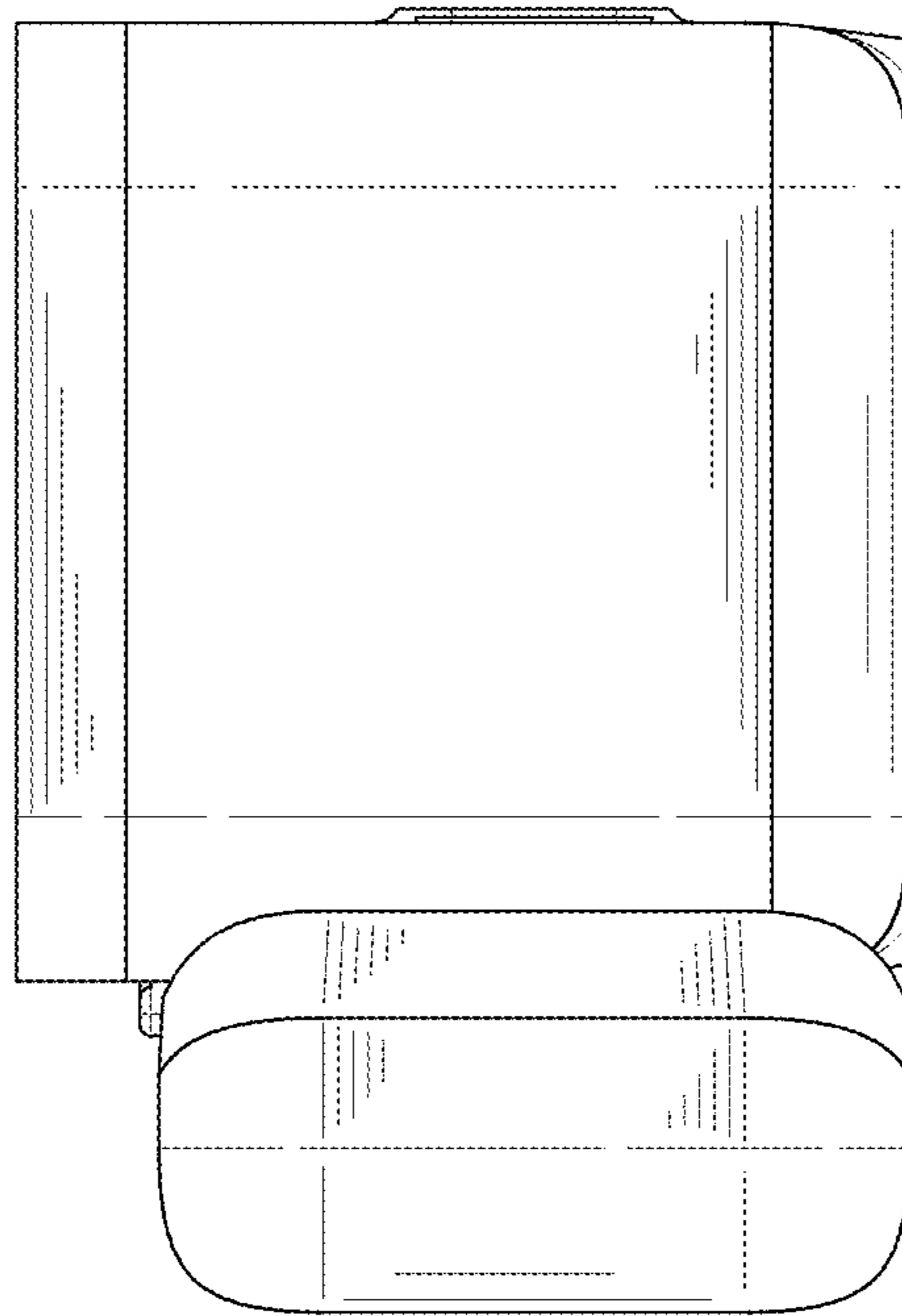

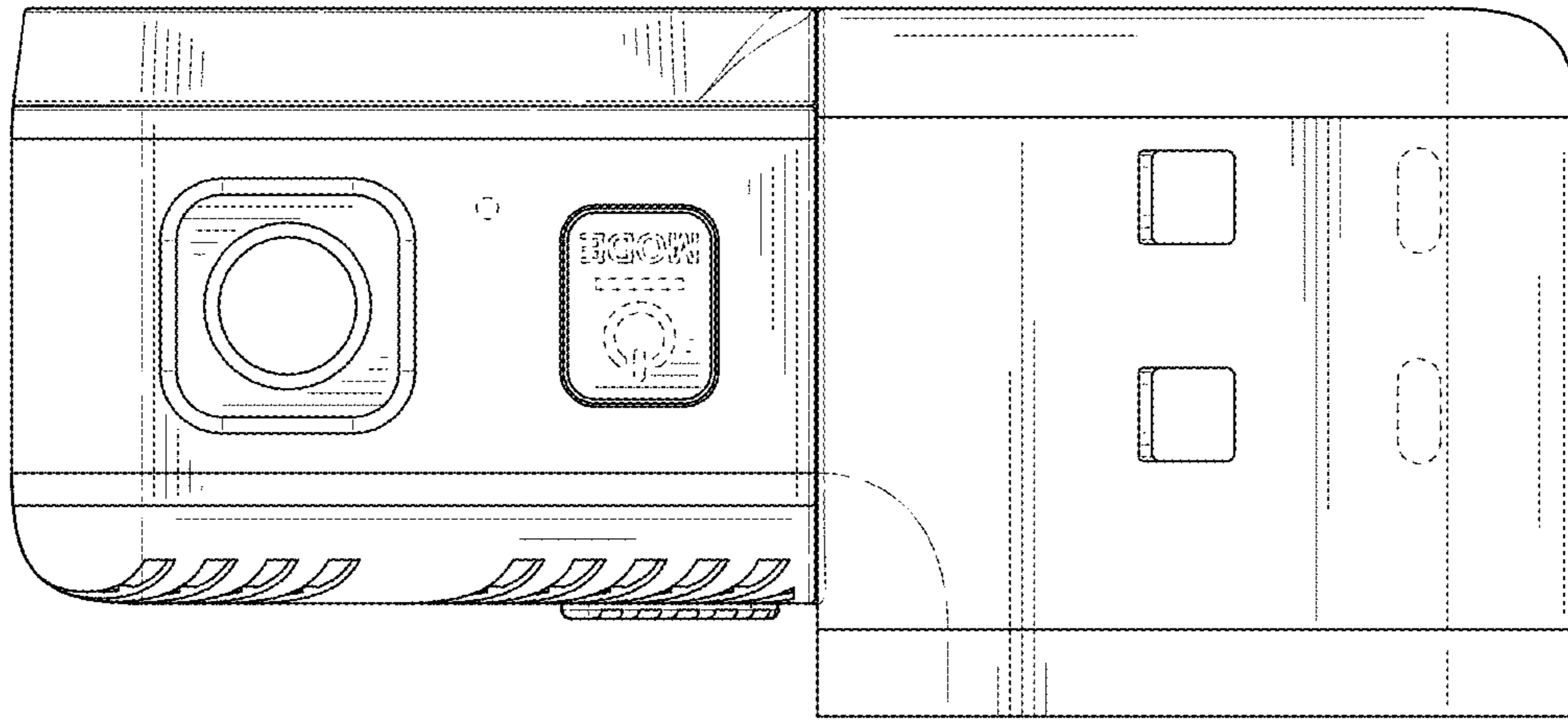

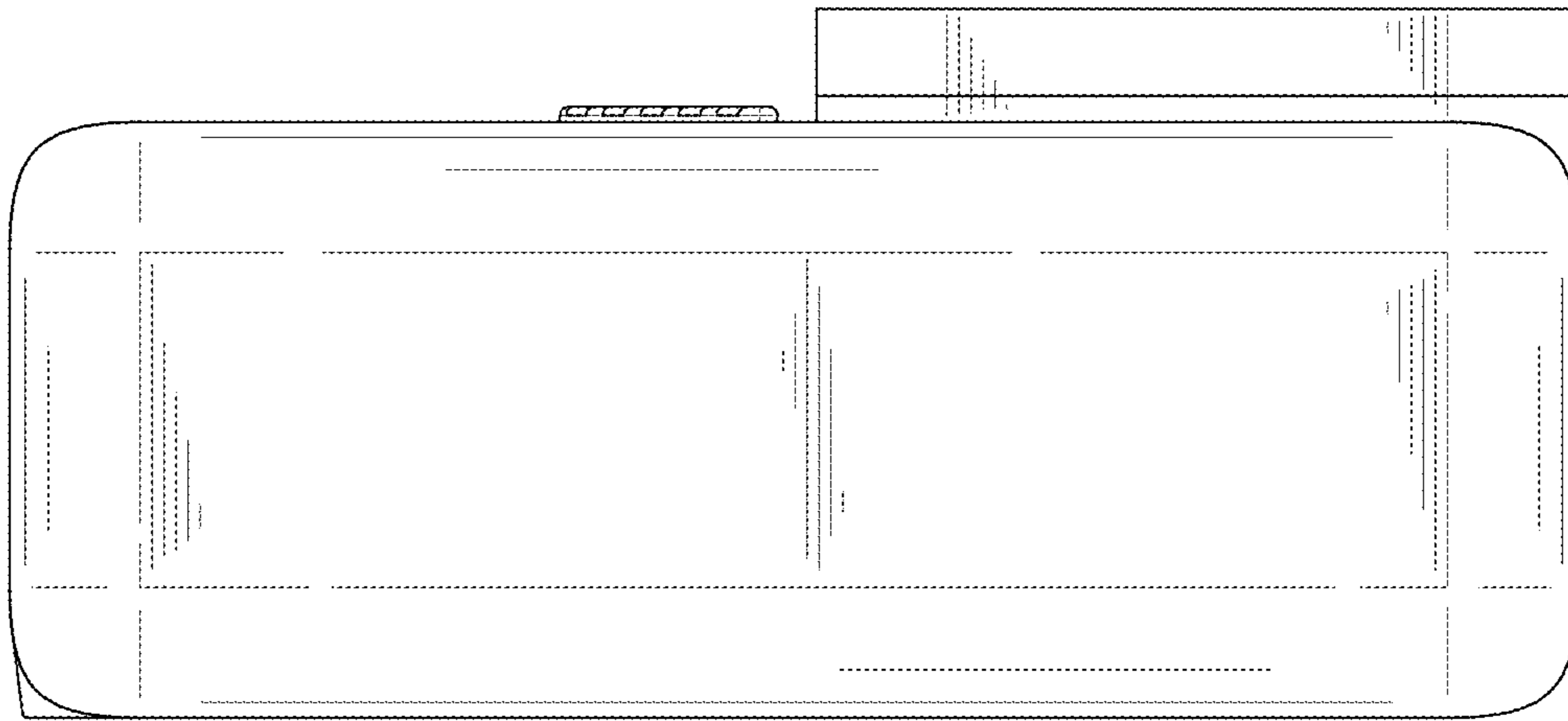
