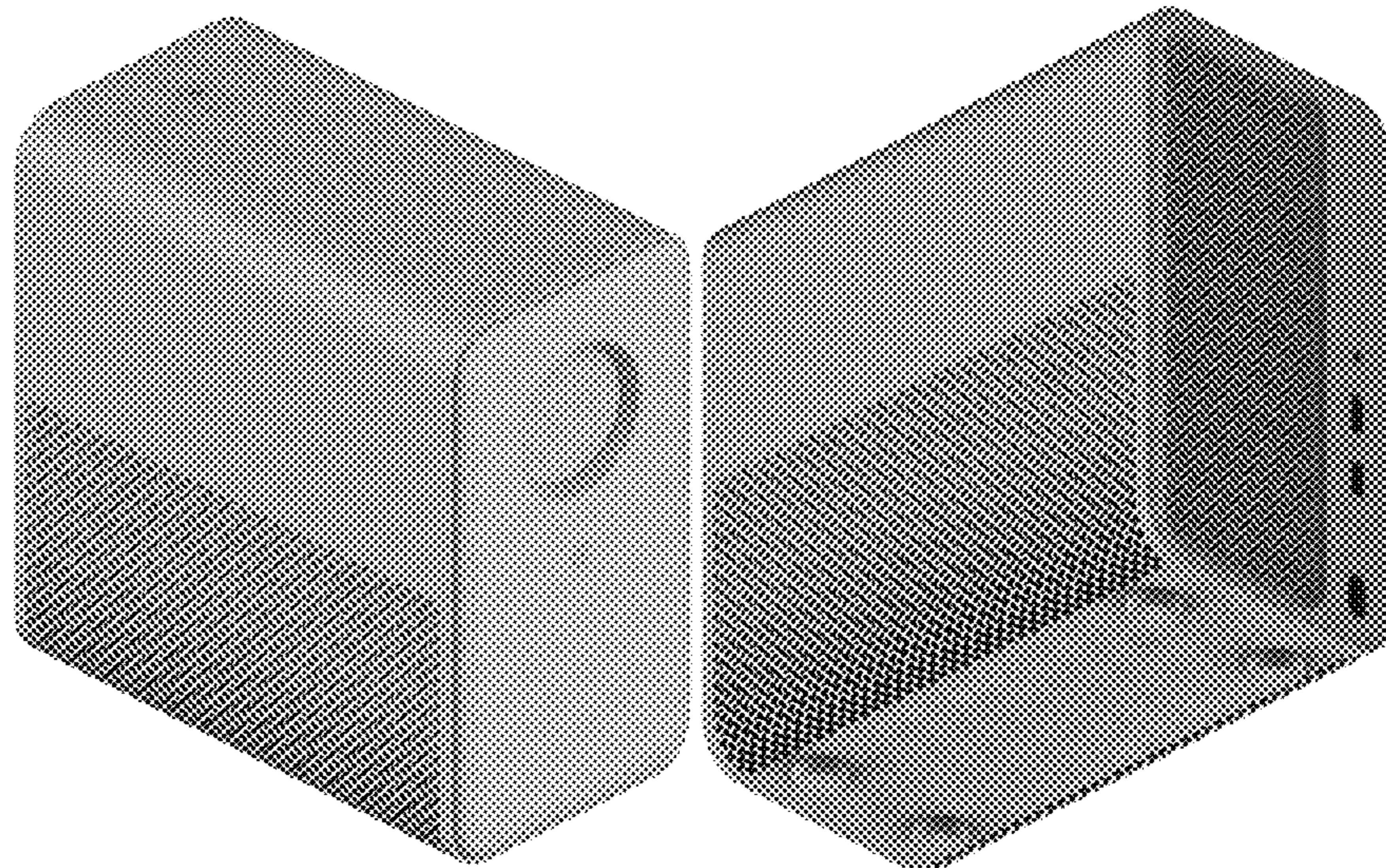
(57) **CLAIM**

**DESCRIPTION**

1. Projector

FIG. 1.7 is another perspective view thereof.

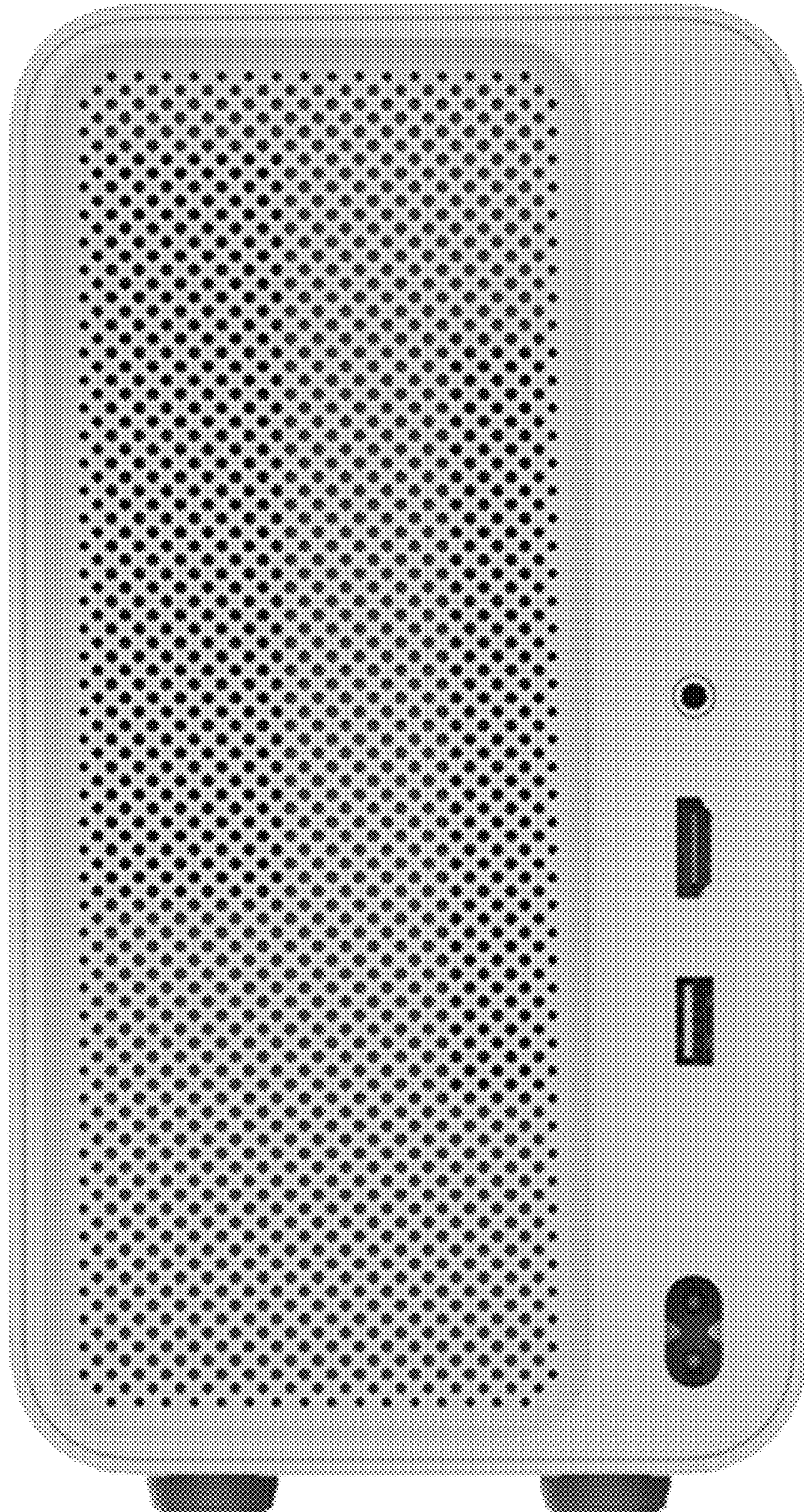

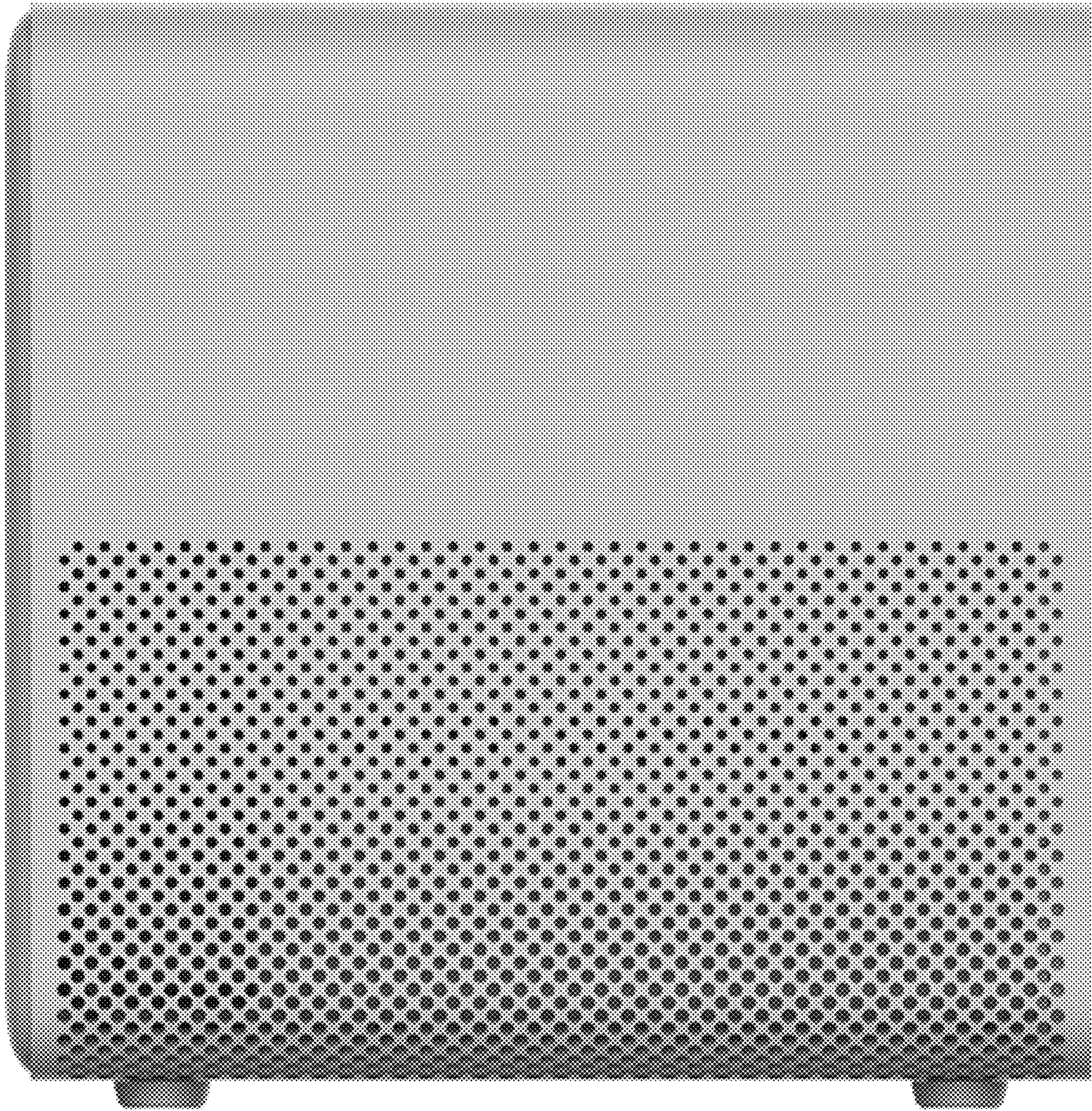

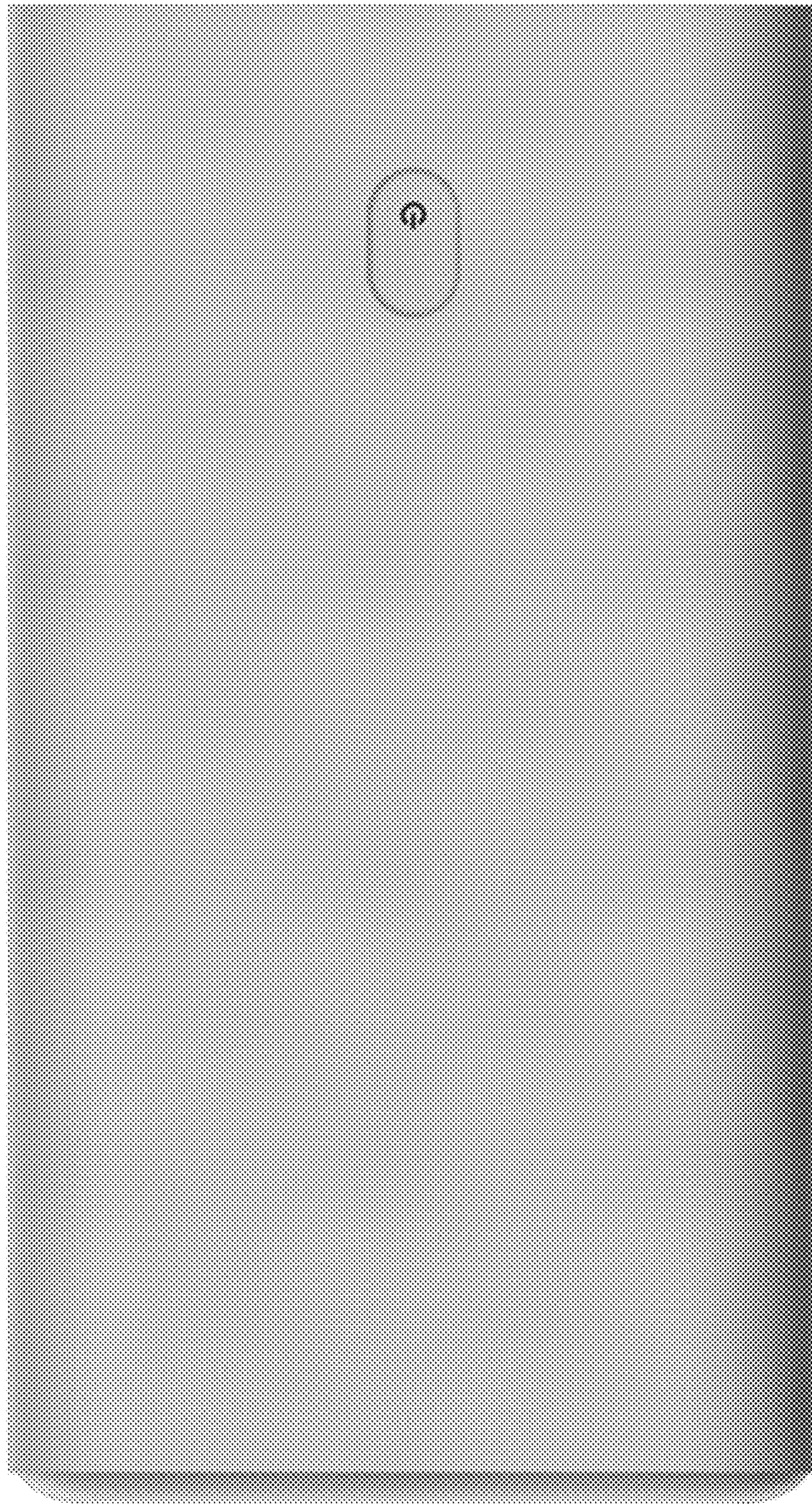

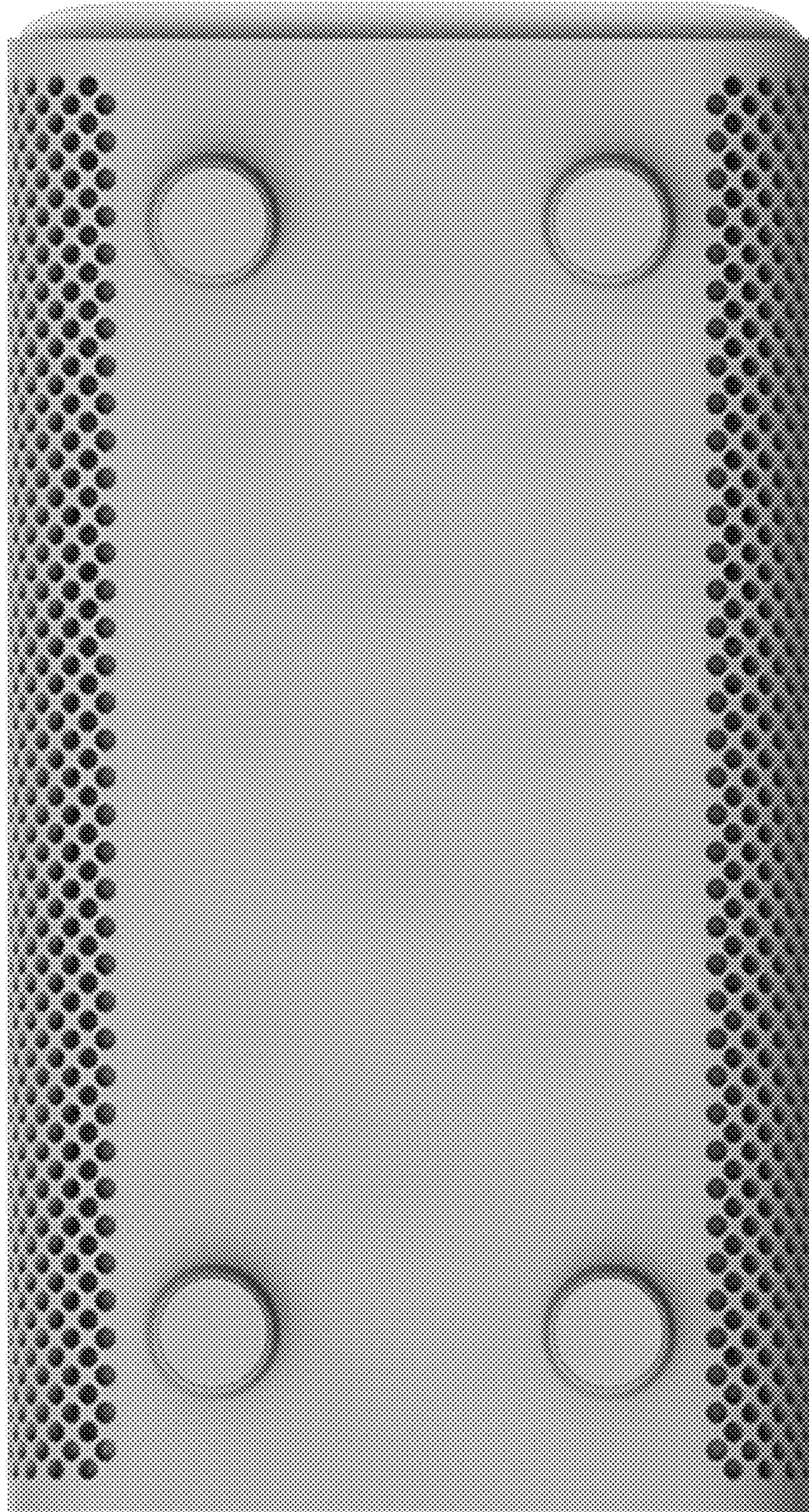
