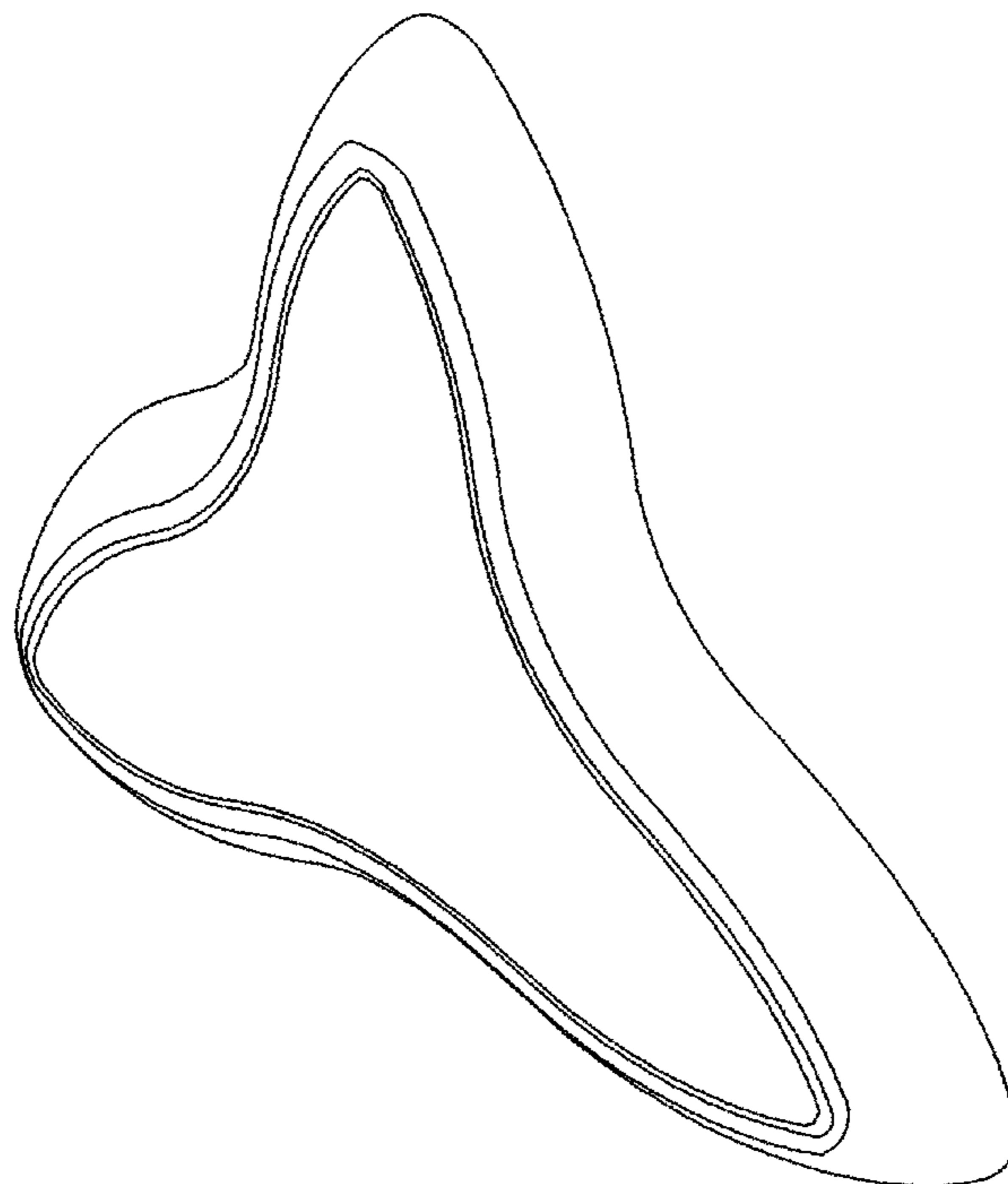
The ornamental design for a medical patch, as shown and described.

DESCRIPTION

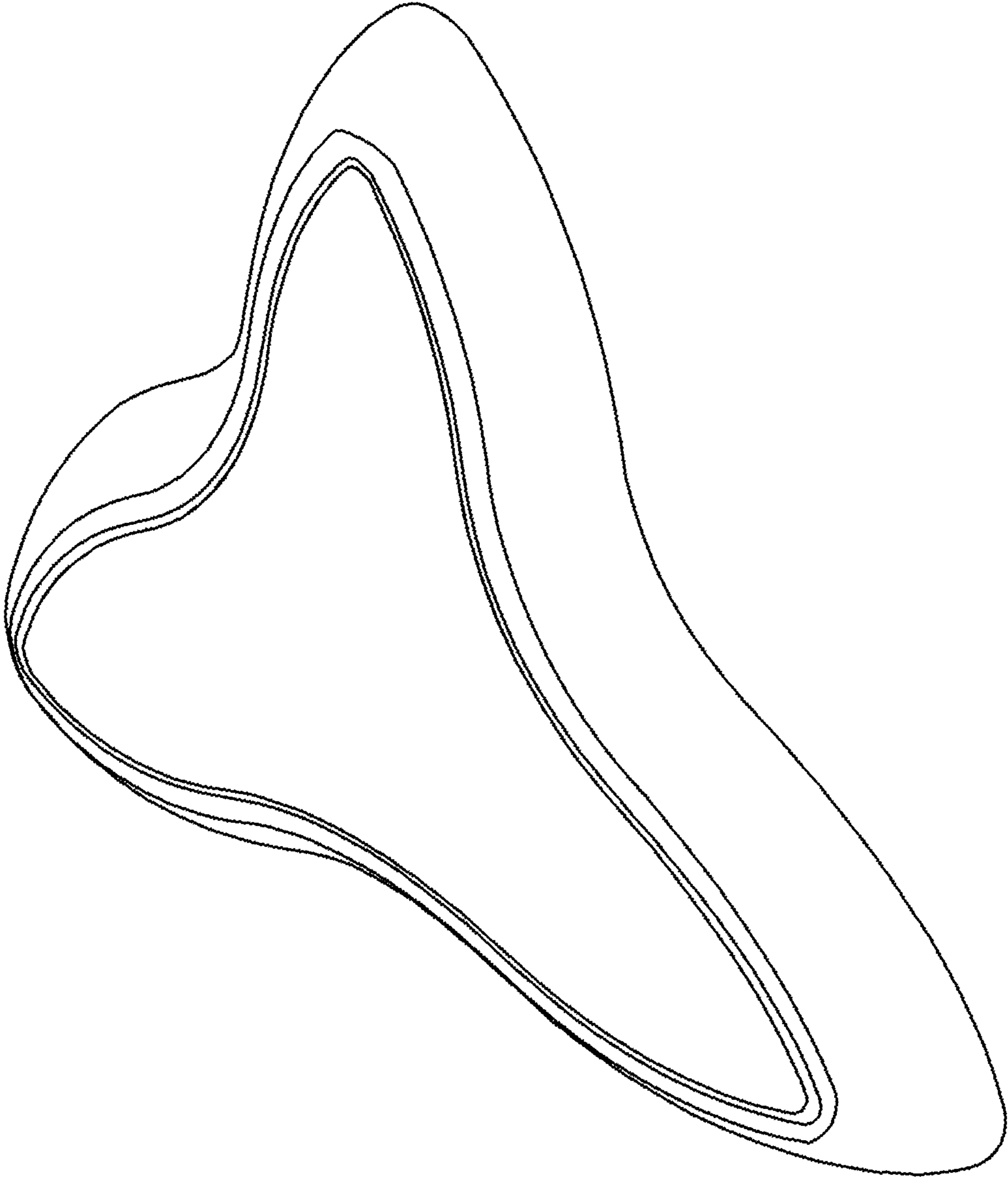
1. Medical patch

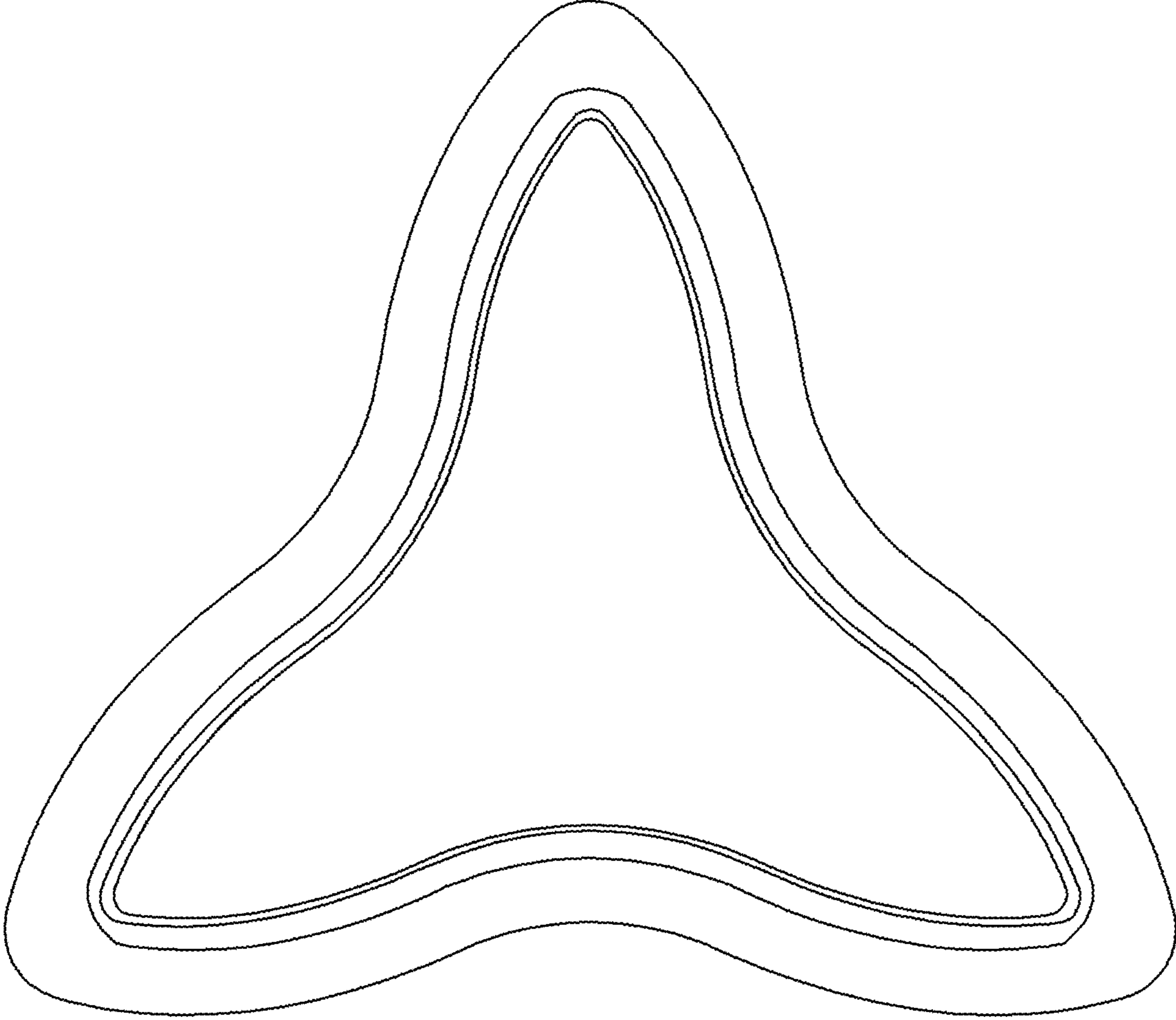

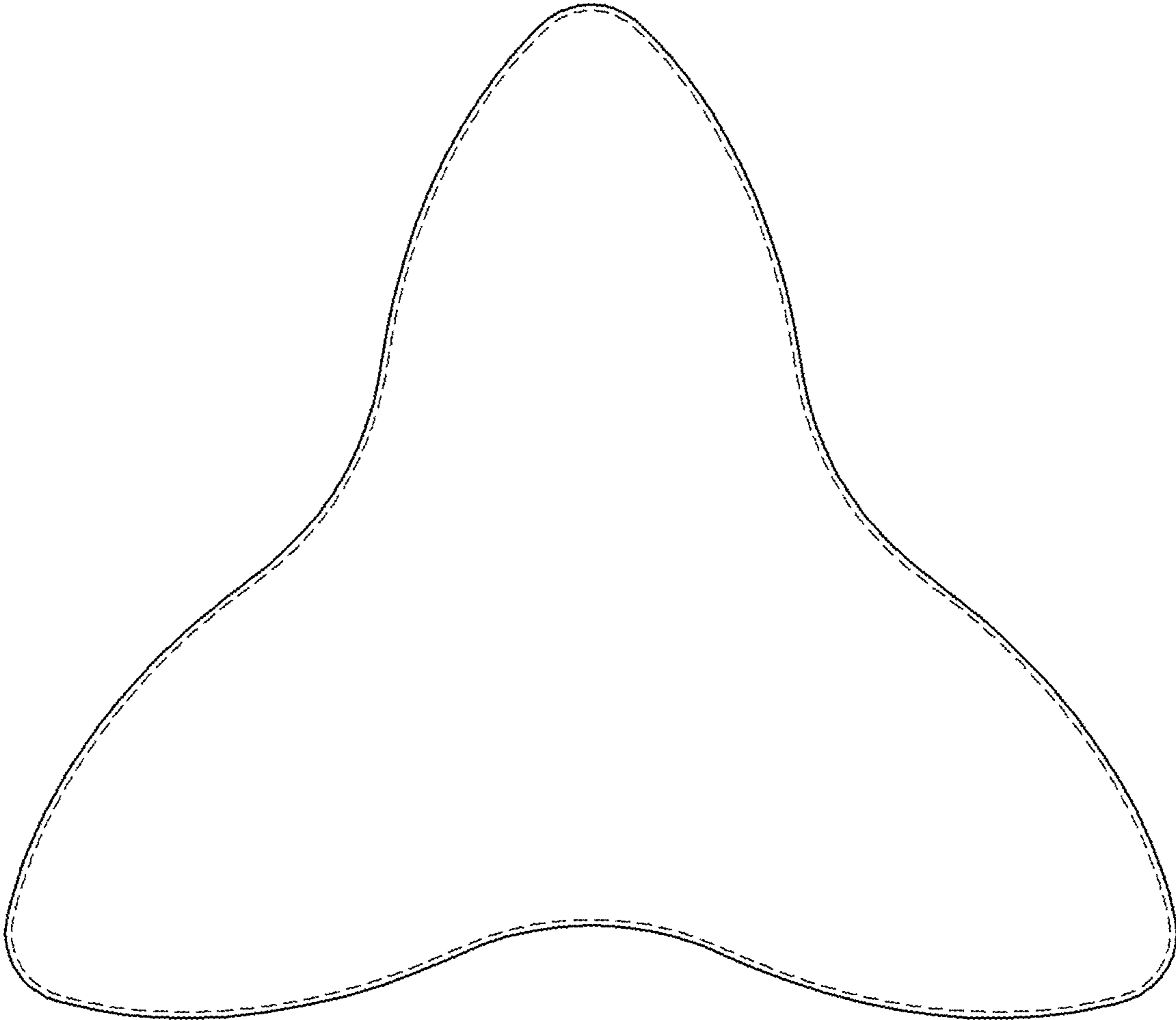

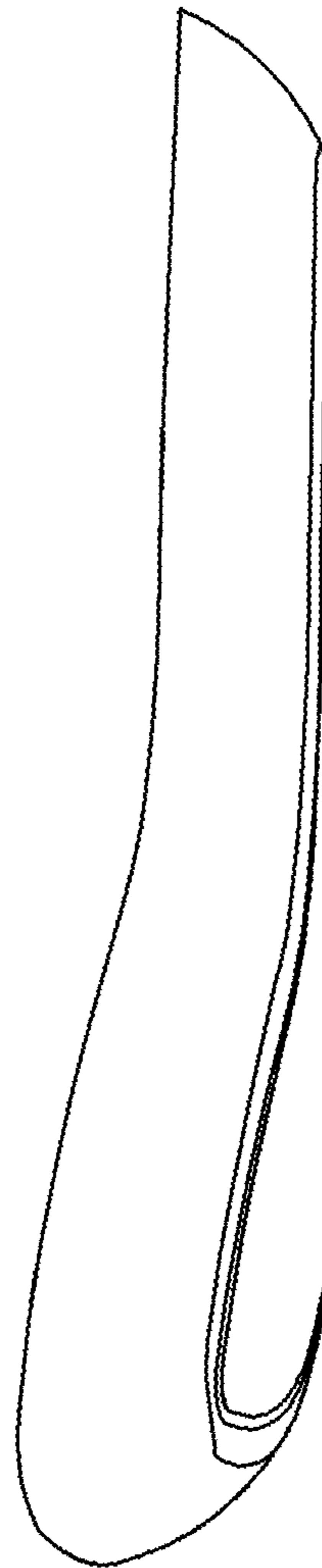

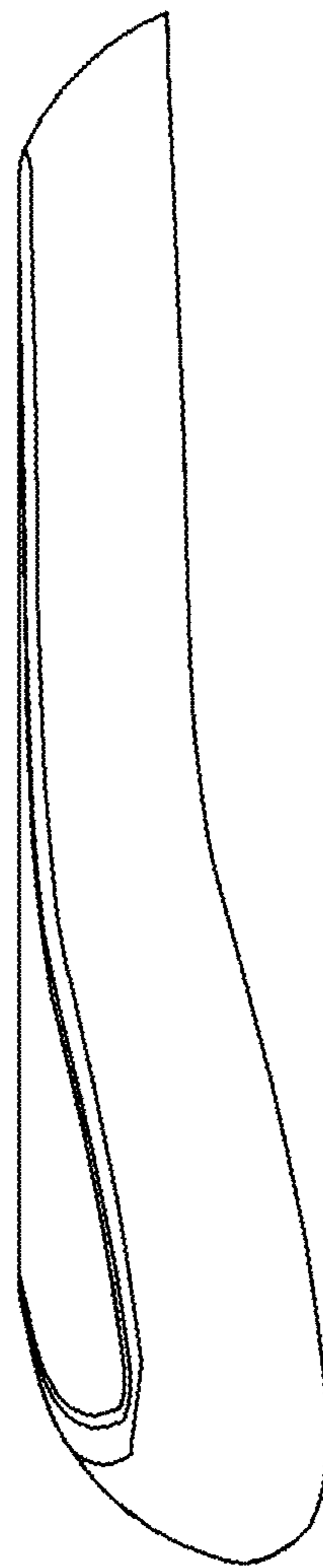
