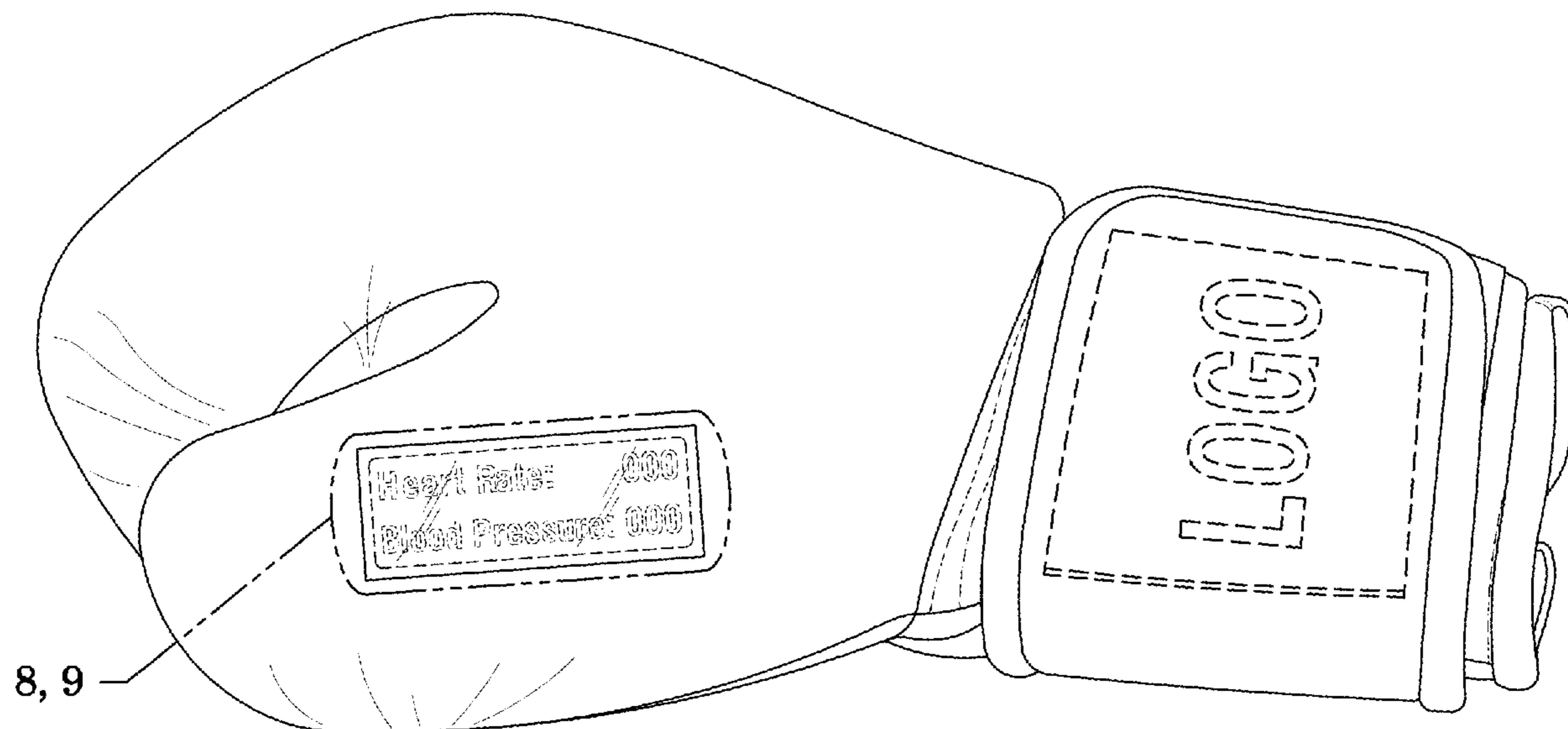
(57) **CLAIM**

The ornamental design for a boxing glove, as shown and described.

DESCRIPTION

FIG. 1 is a right side perspective view of the boxing glove. FIG. 2 is a top view of the boxing glove. FIG. 3 is a bottom view of the boxing glove. FIG. 4 is a right side view of the boxing glove. FIG. 5 is a left side view of the boxing glove. FIG. 6 is a front view of the boxing glove. FIG. 7 is a back view of the boxing glove. FIG. 8 is an enlarged view of the digital display on the boxing glove as shown in FIG. 1, in the first state of use; and, FIG. 9 is an enlarged view of the digital display on the boxing glove as shown in FIG. 1, in a second state of use. The dash-dash broken lines depict portions of the boxing glove and form no part of the claimed design.

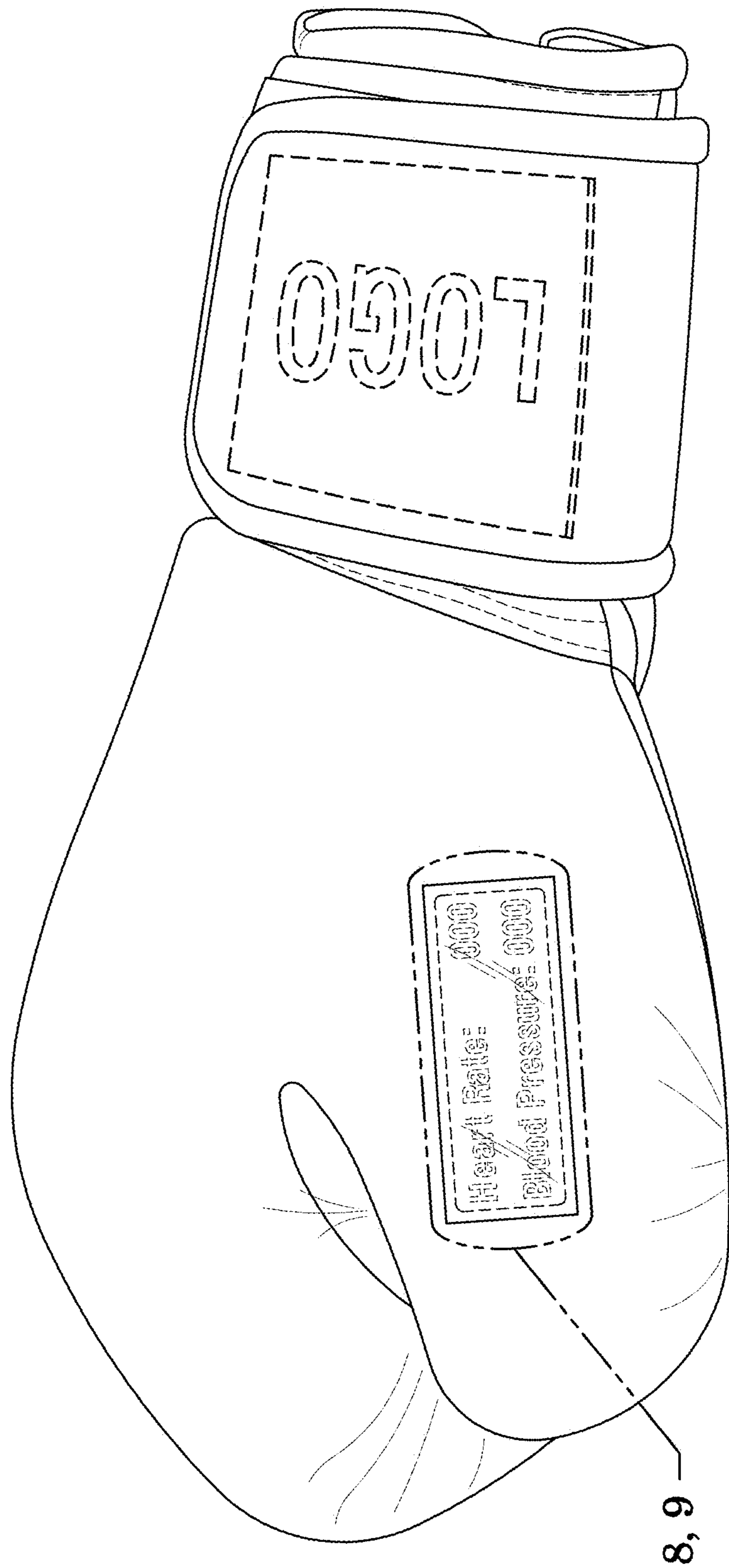

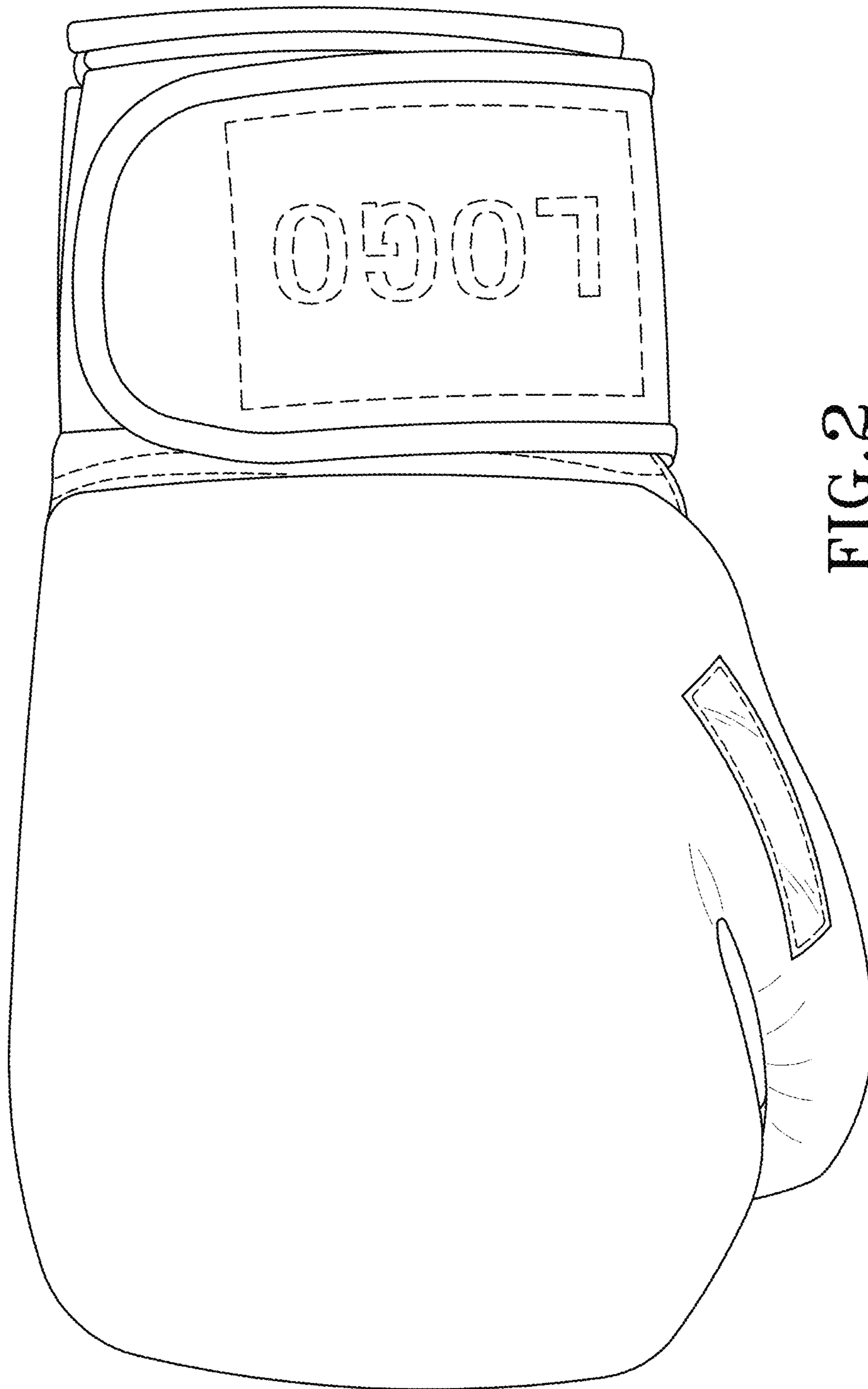

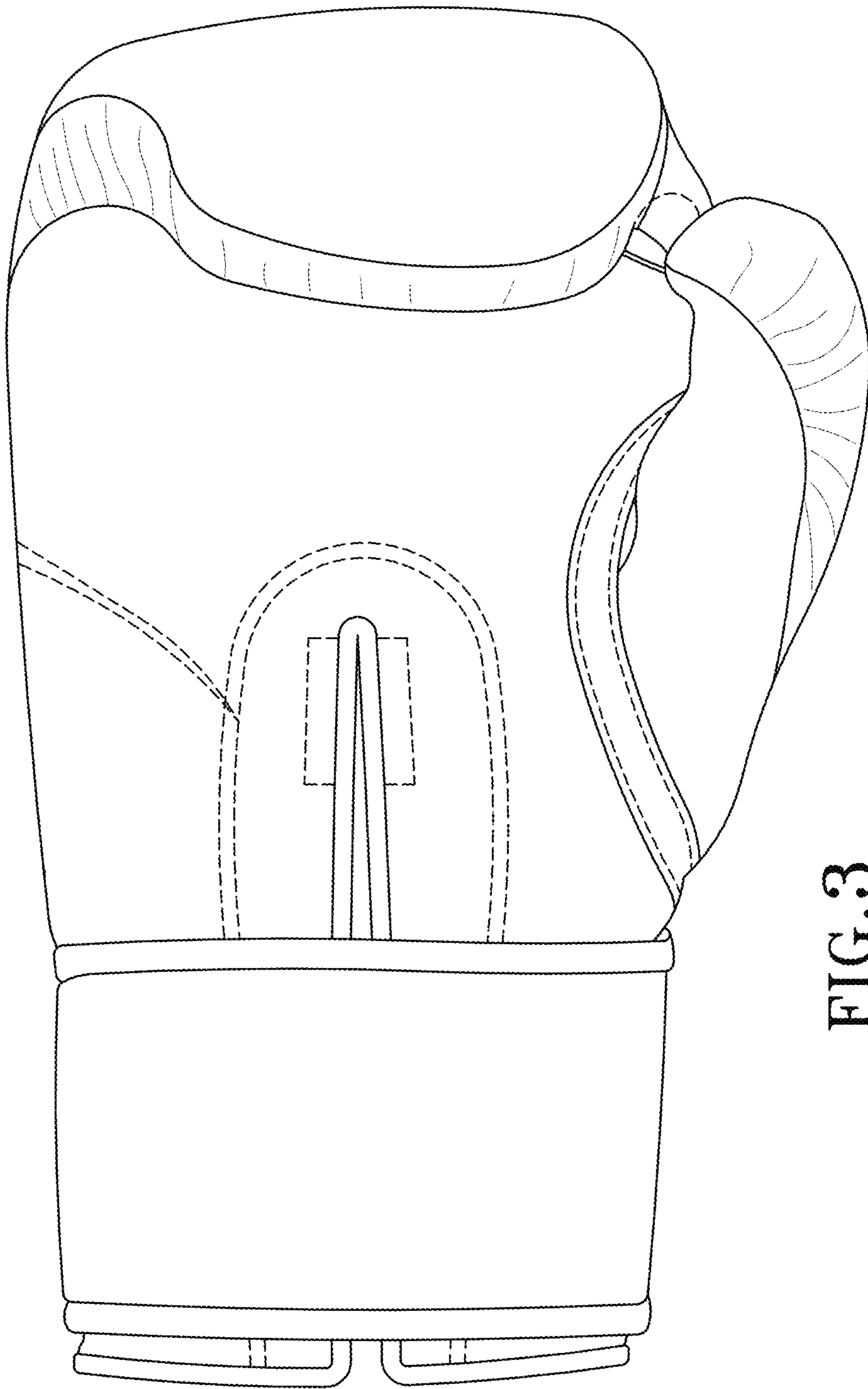

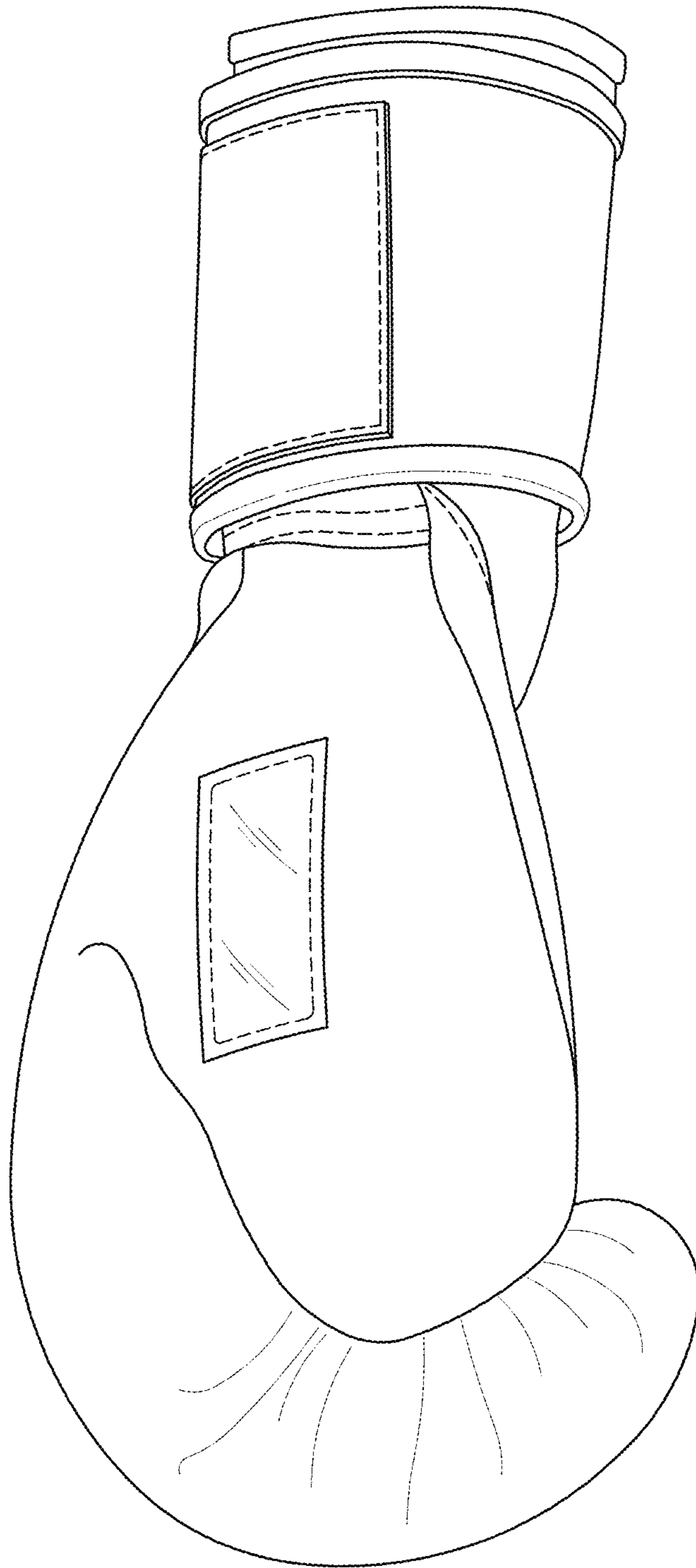

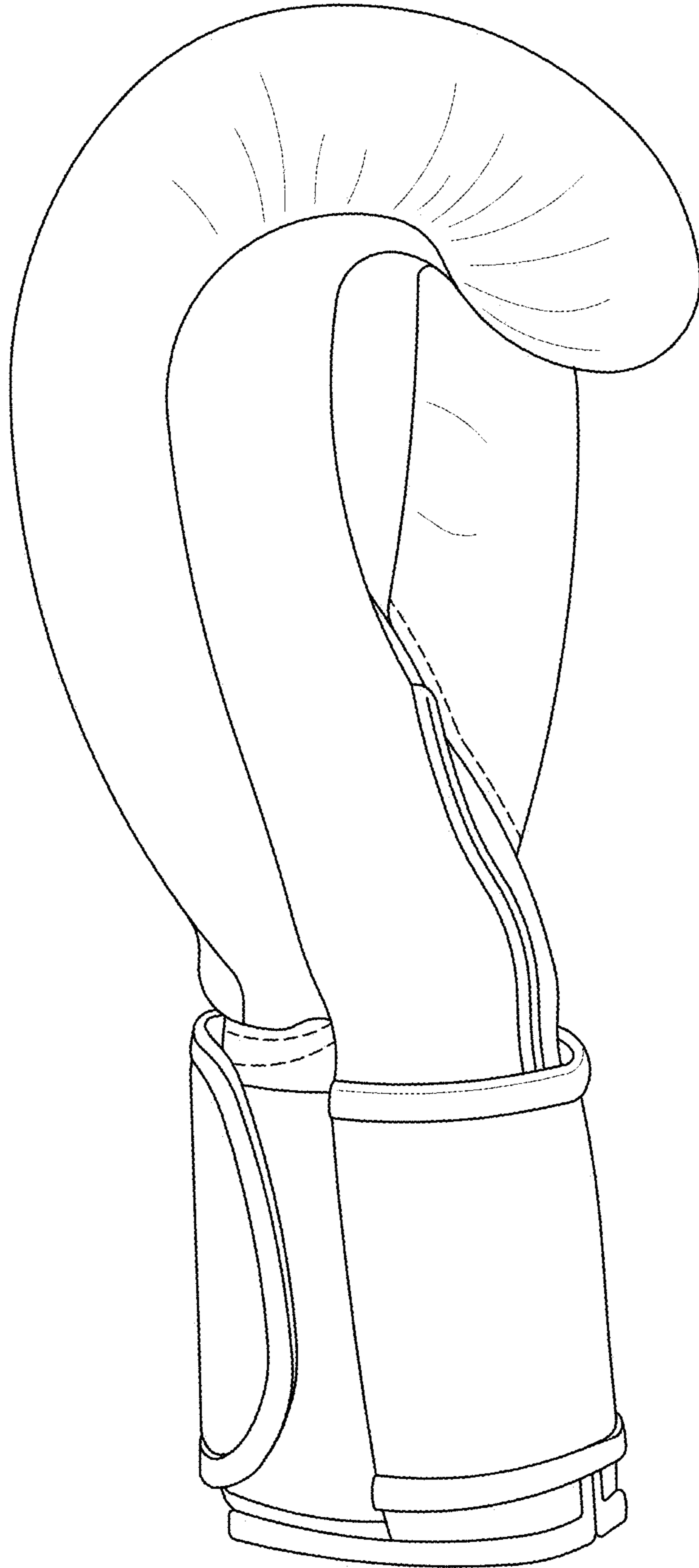

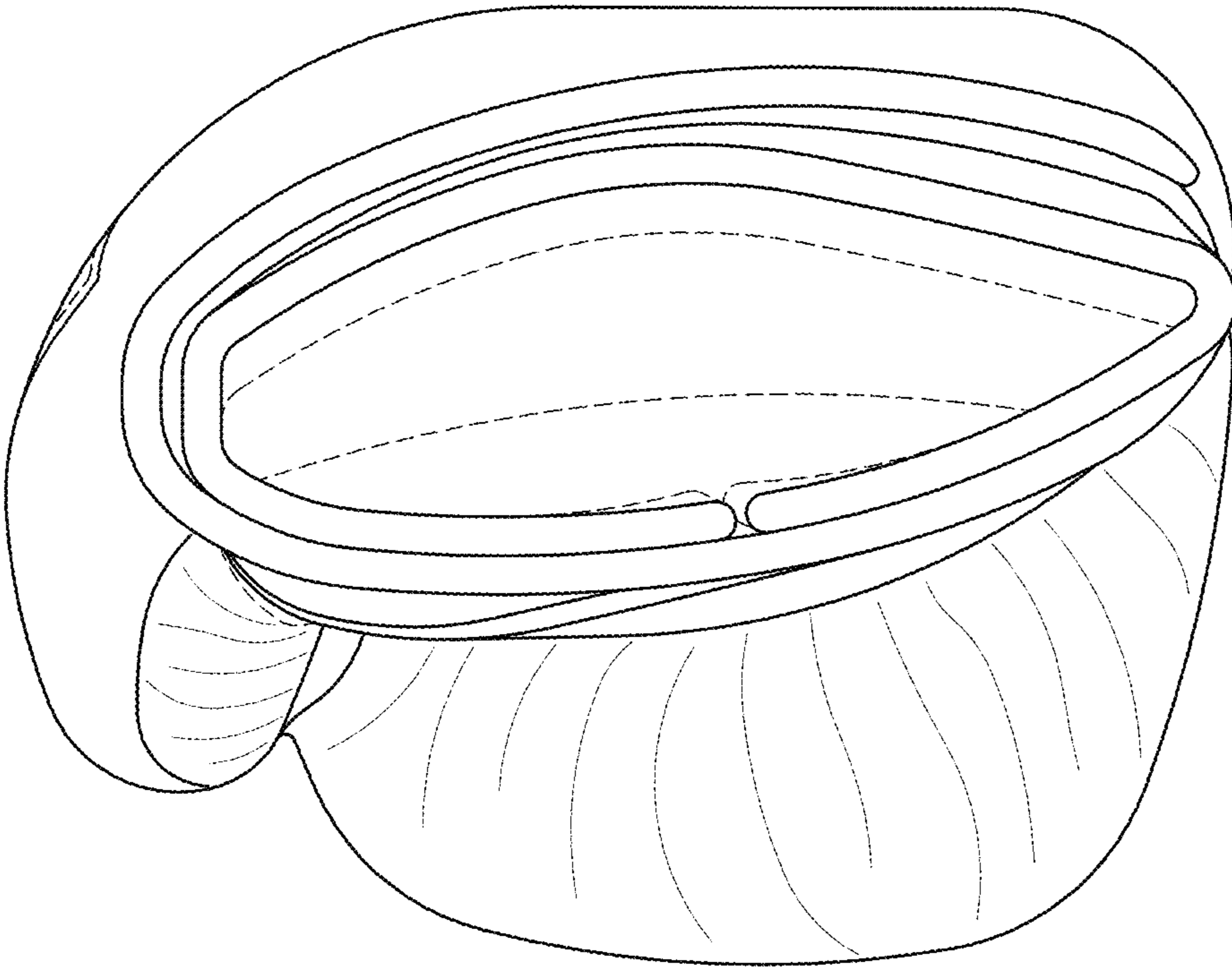

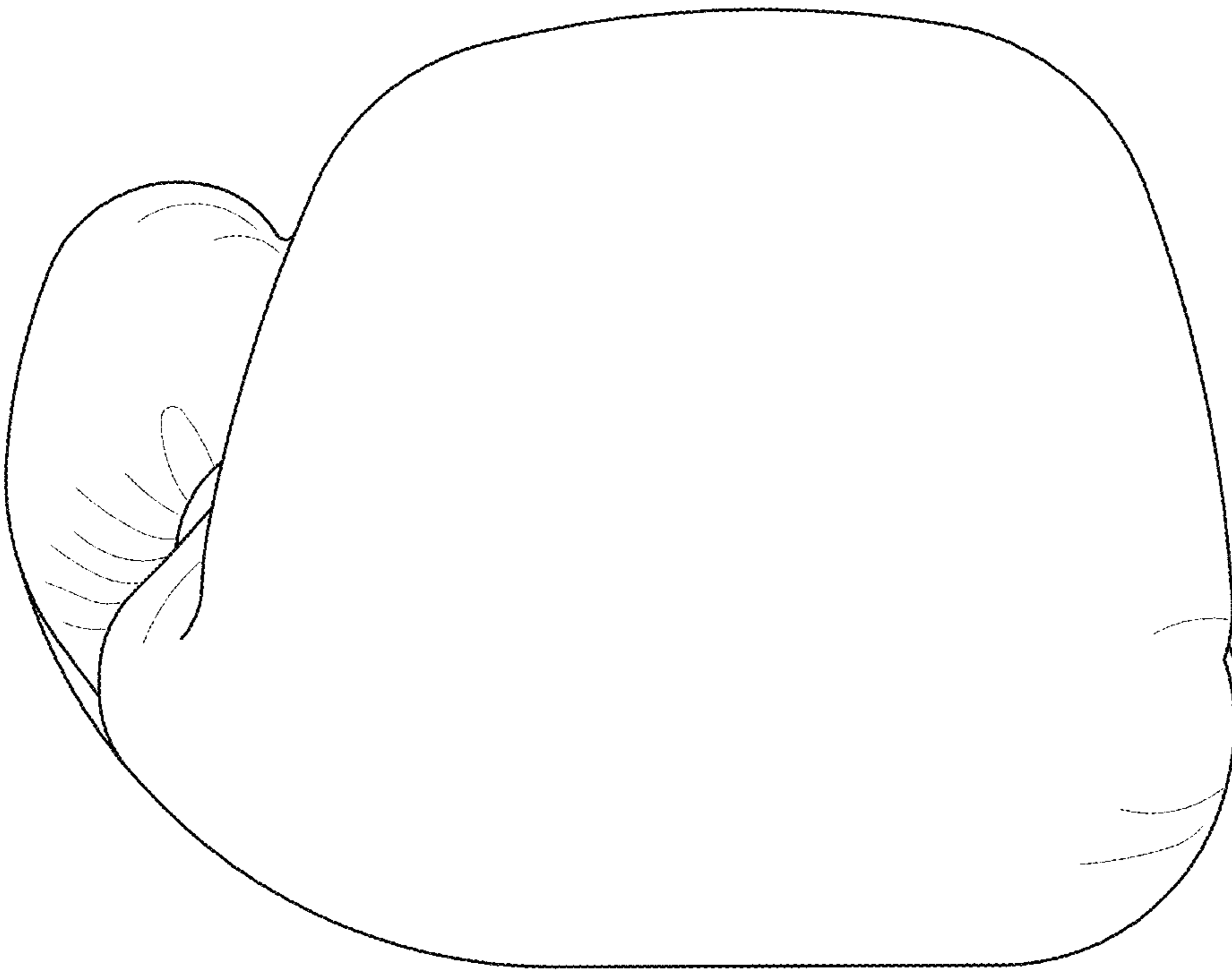

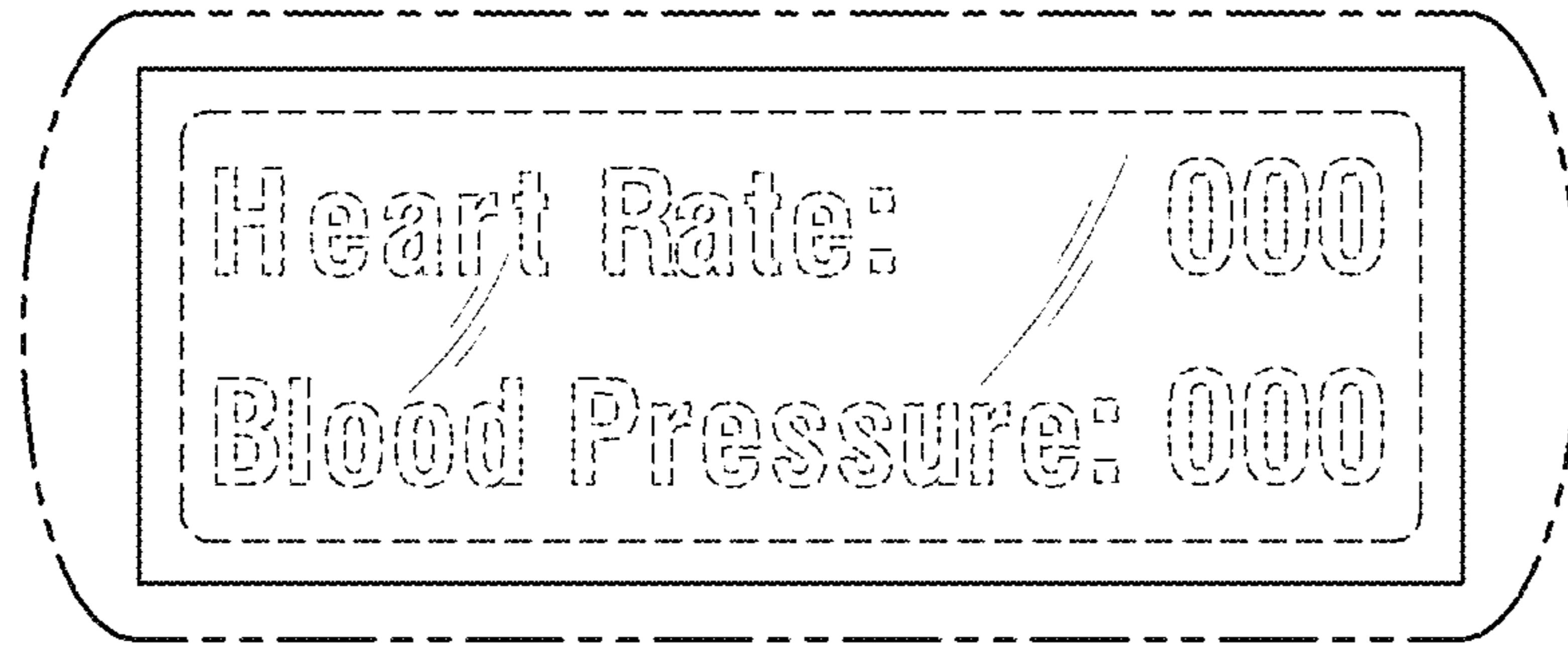

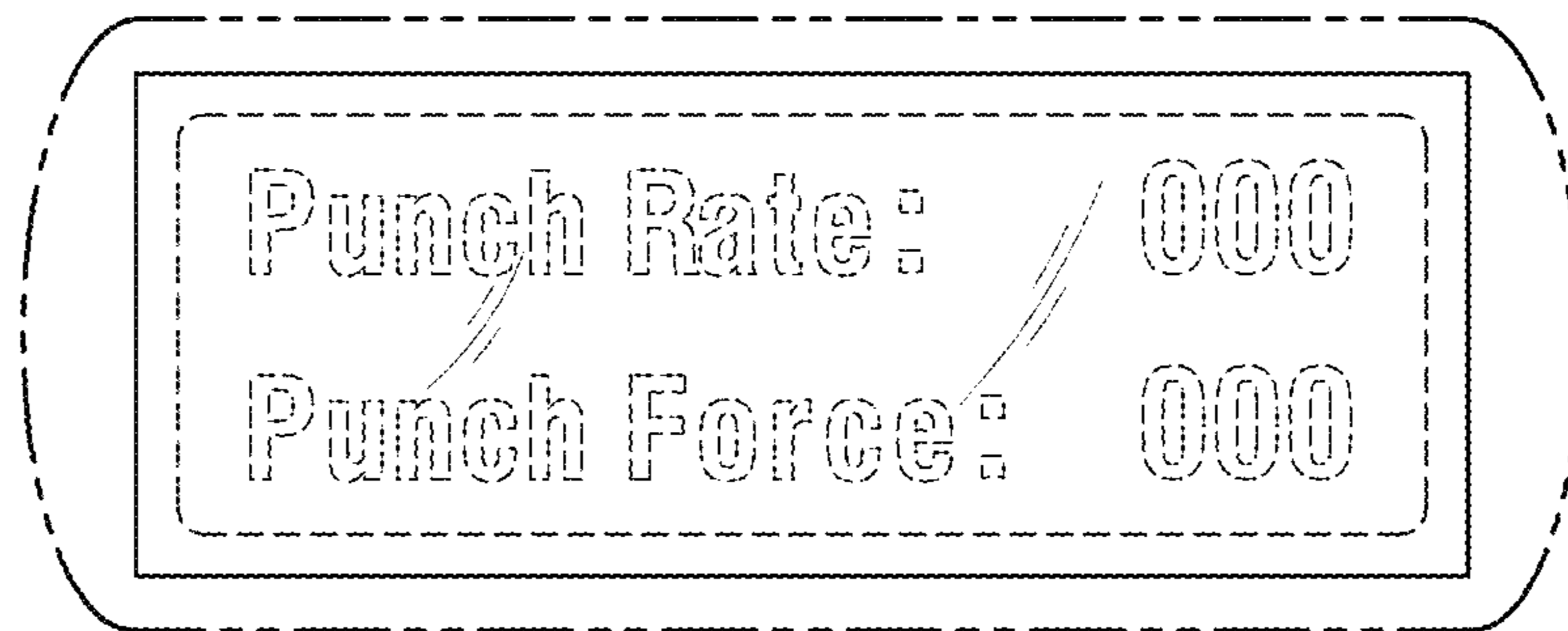
