FIG. 9 is a perspective view of the shape fitting bra of FIG. 3.

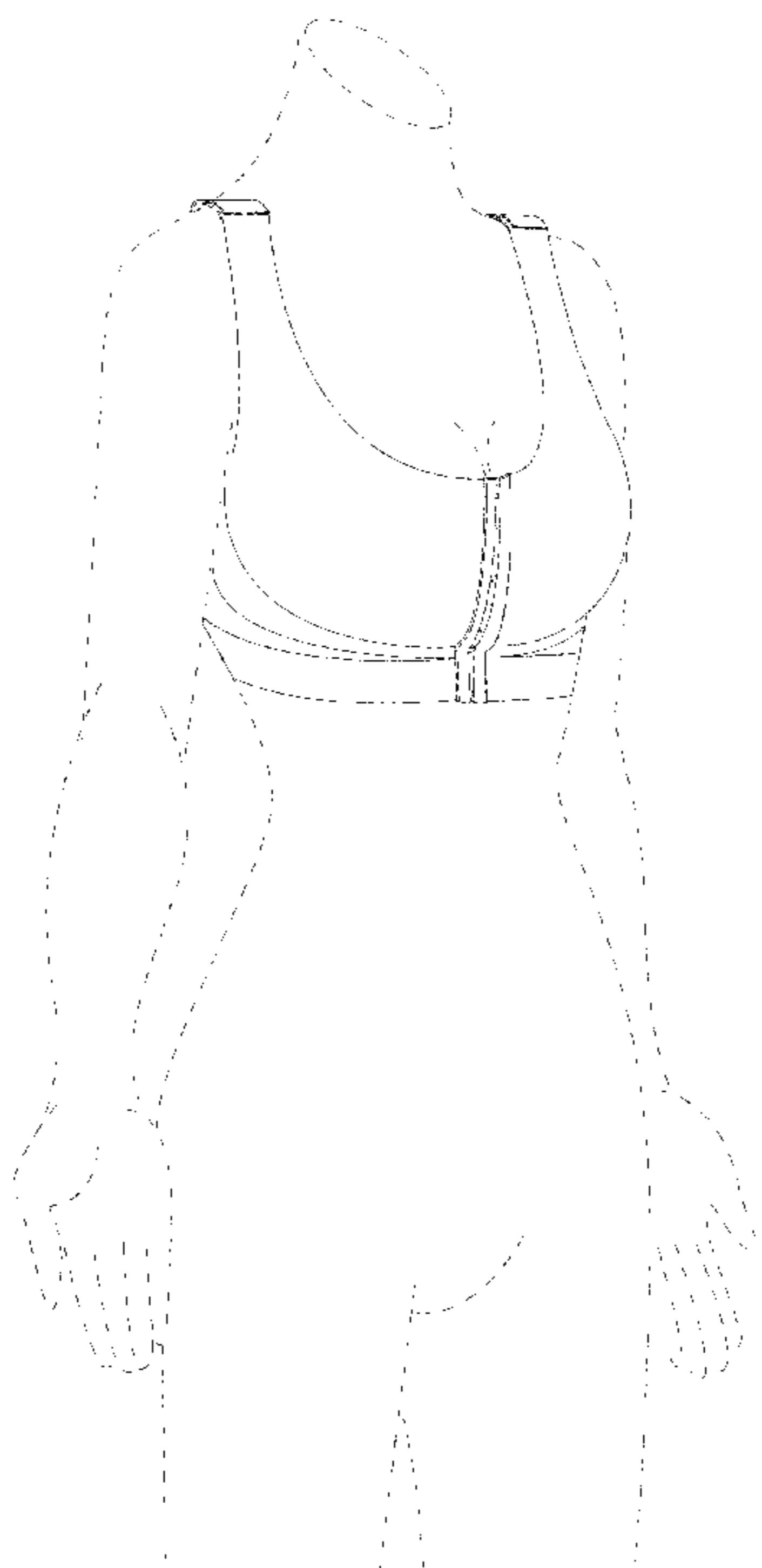
The clasps shown with broken lines in FIGS. 1-3, 6-7, and 9 on the front of the bra form no part of the claimed design.

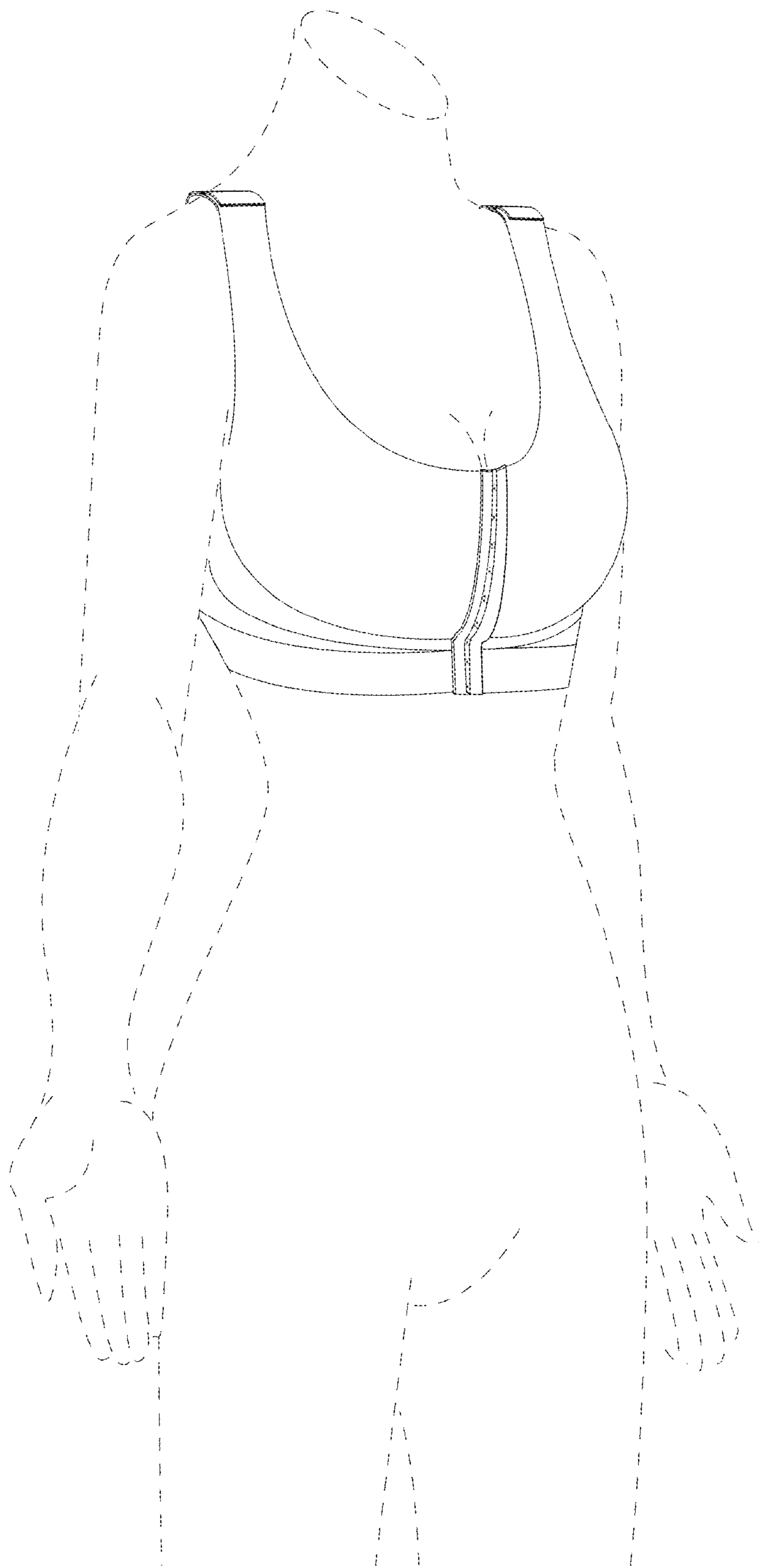

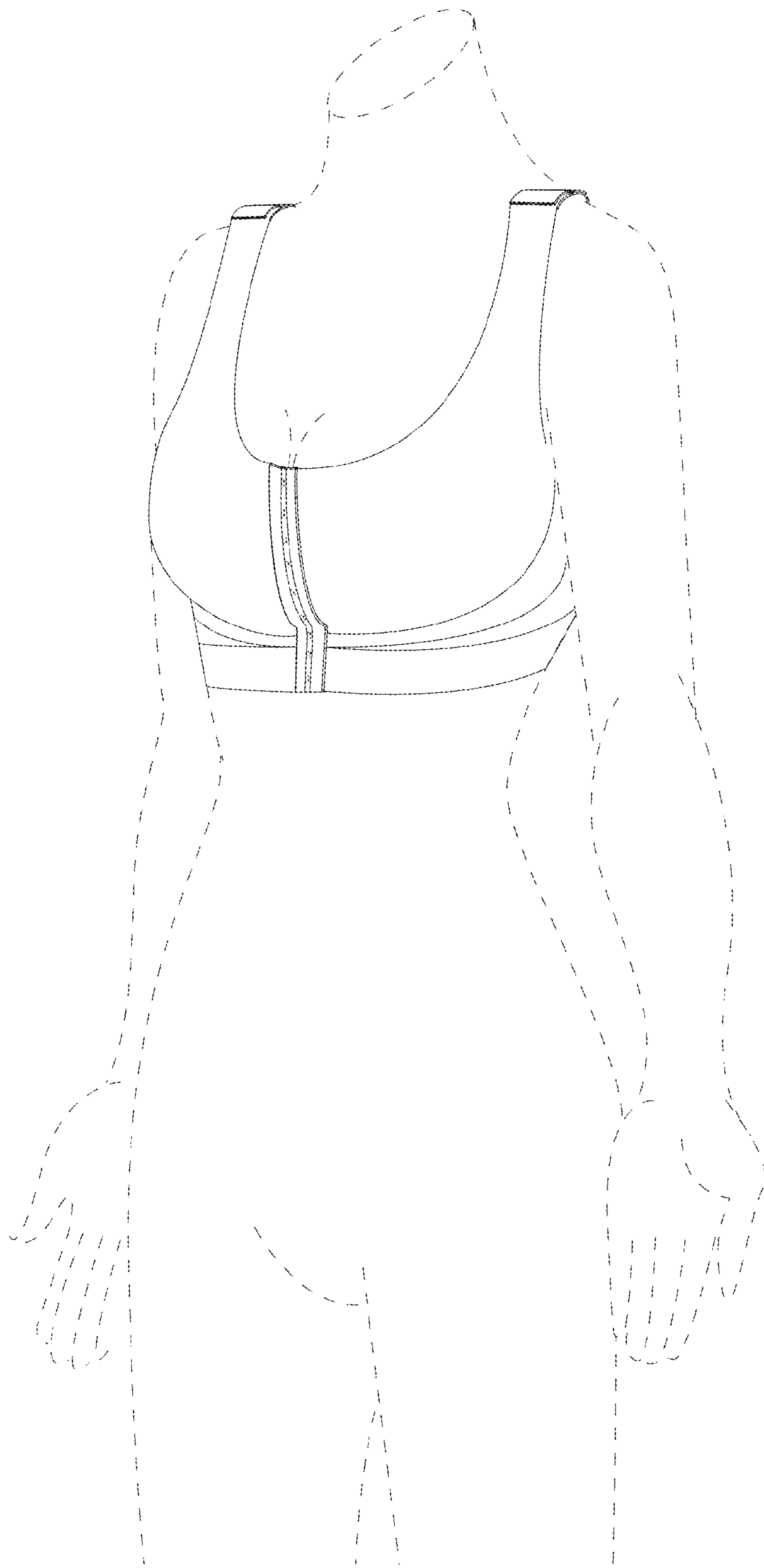

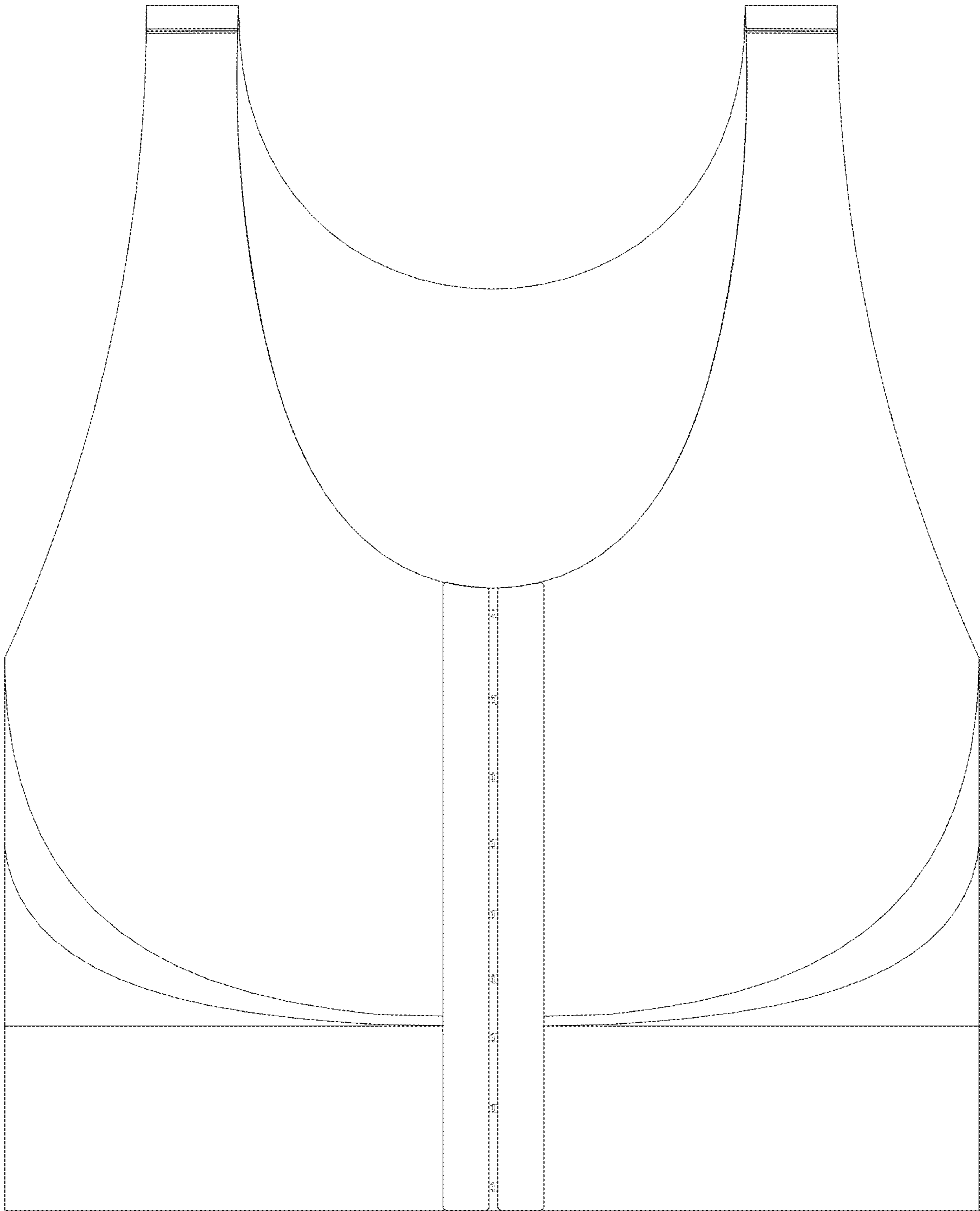

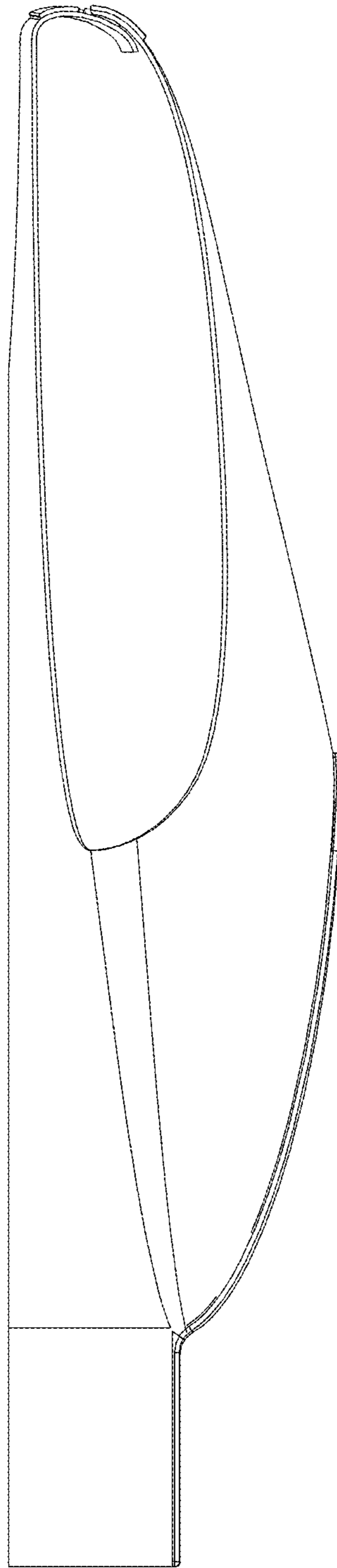

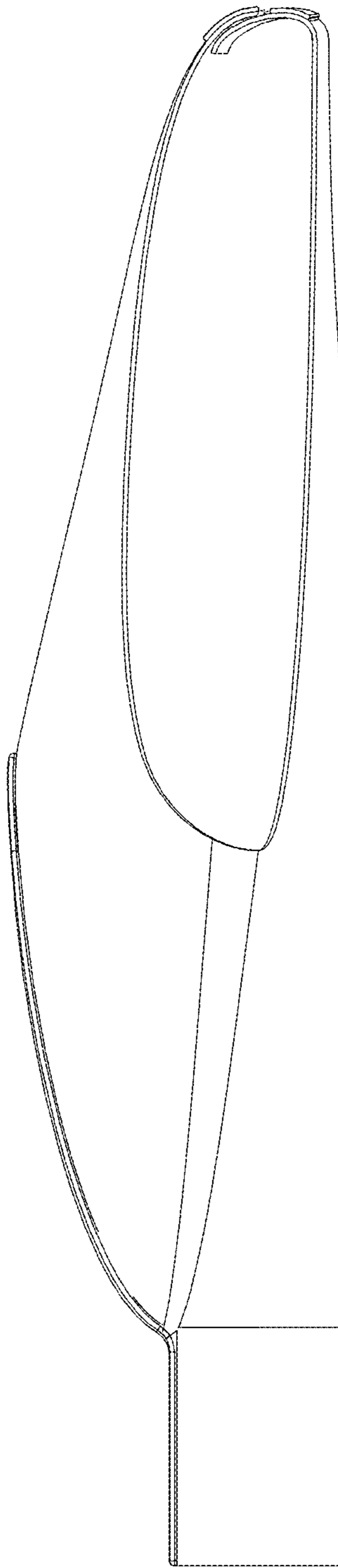

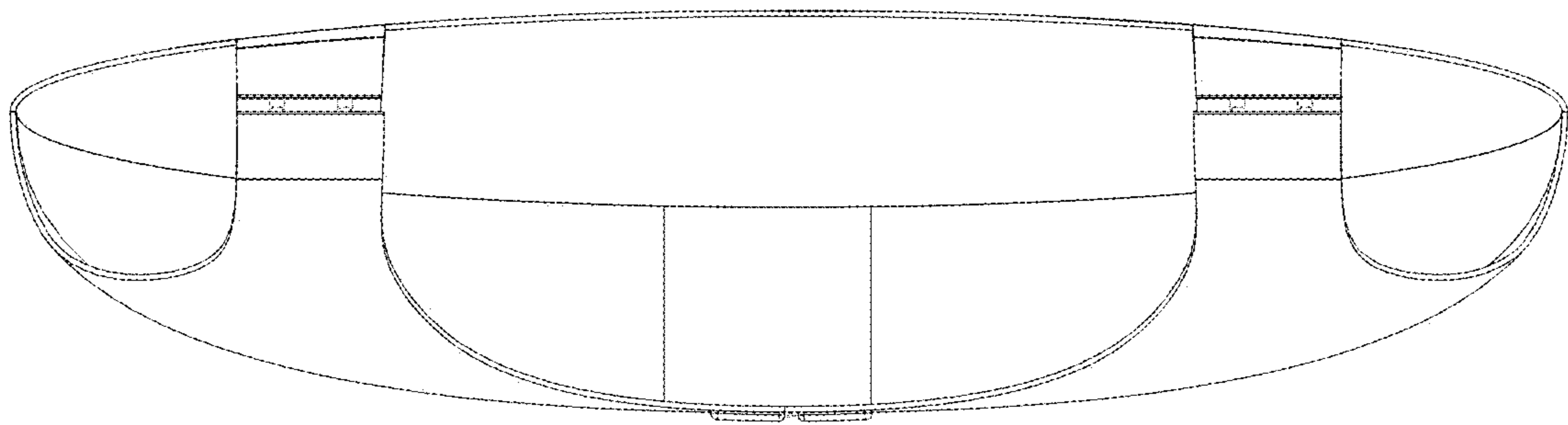

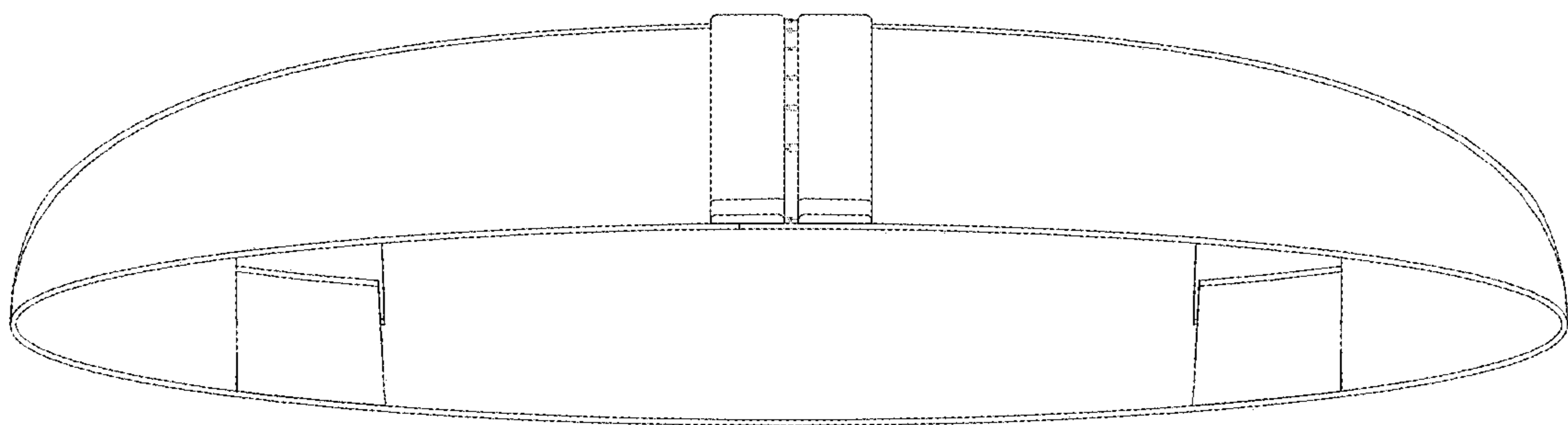

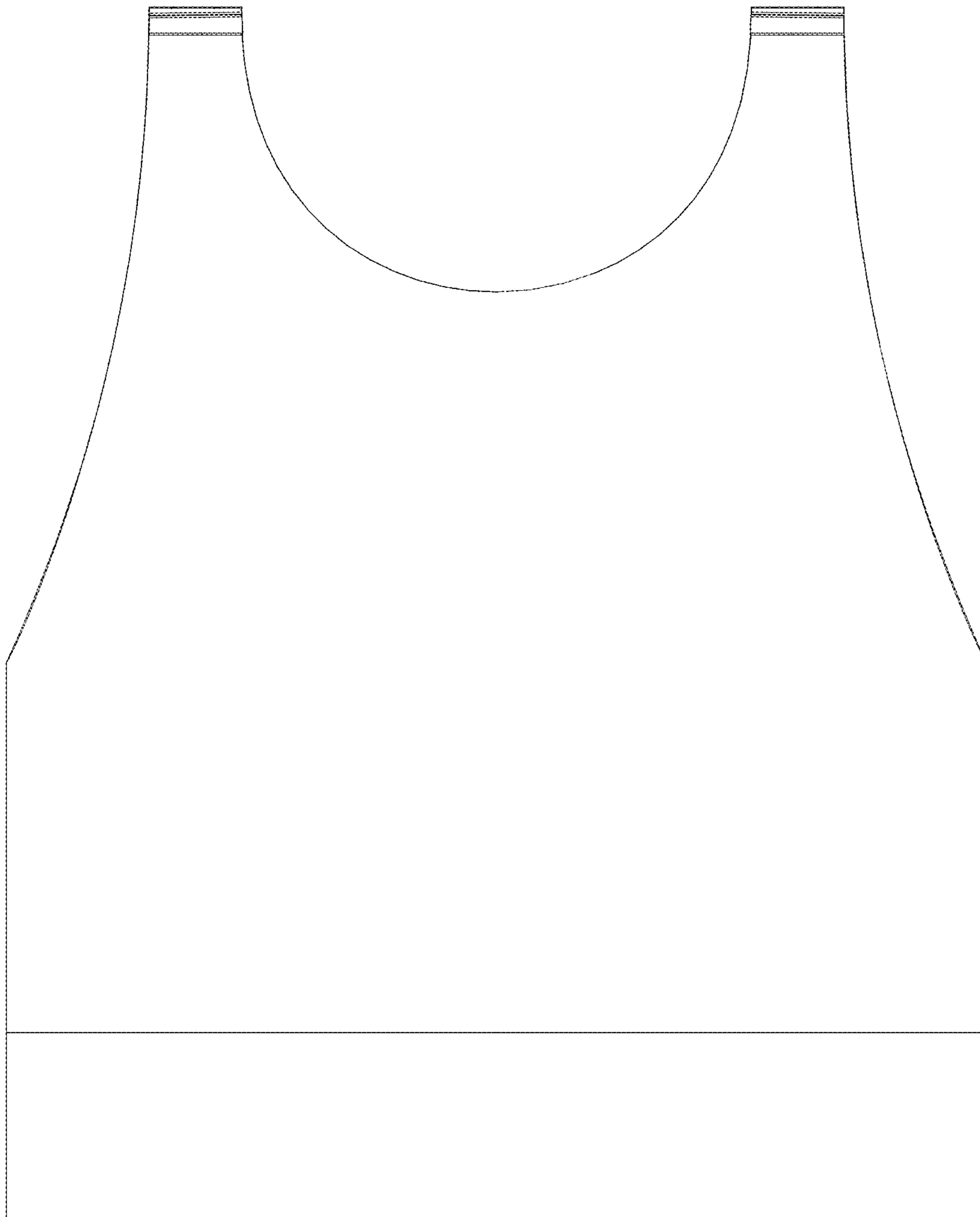

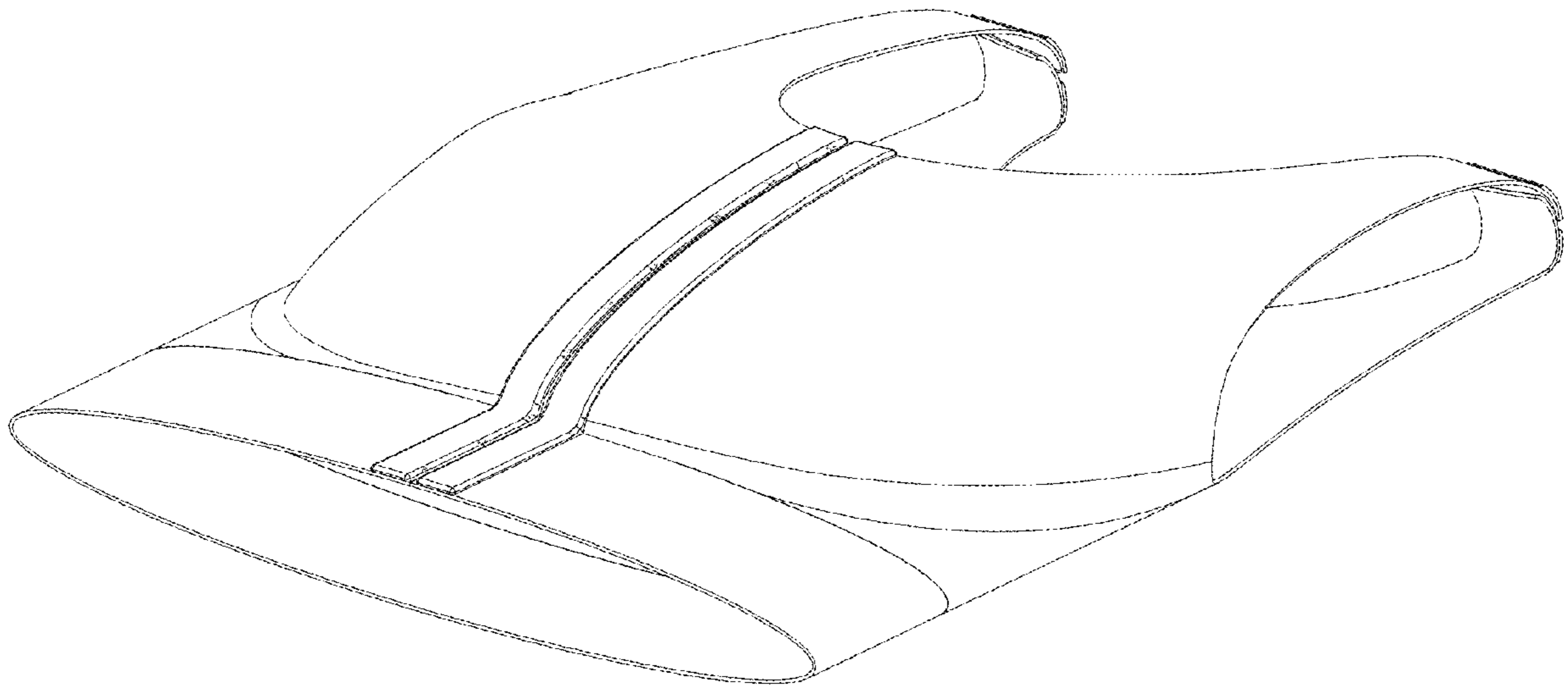
