The ornamental design for a wearable baby blanket, as shown and described.

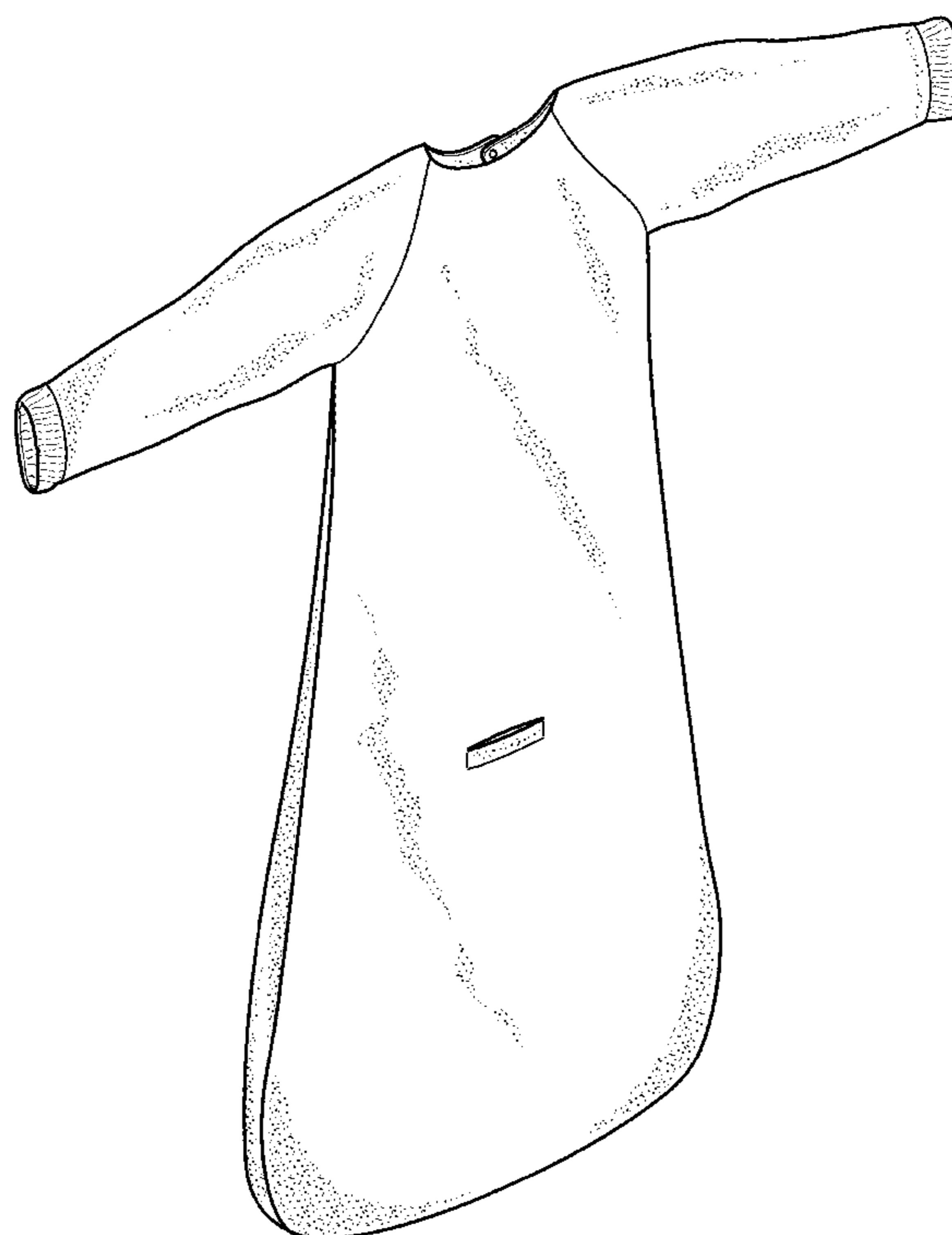
DESCRIPTION

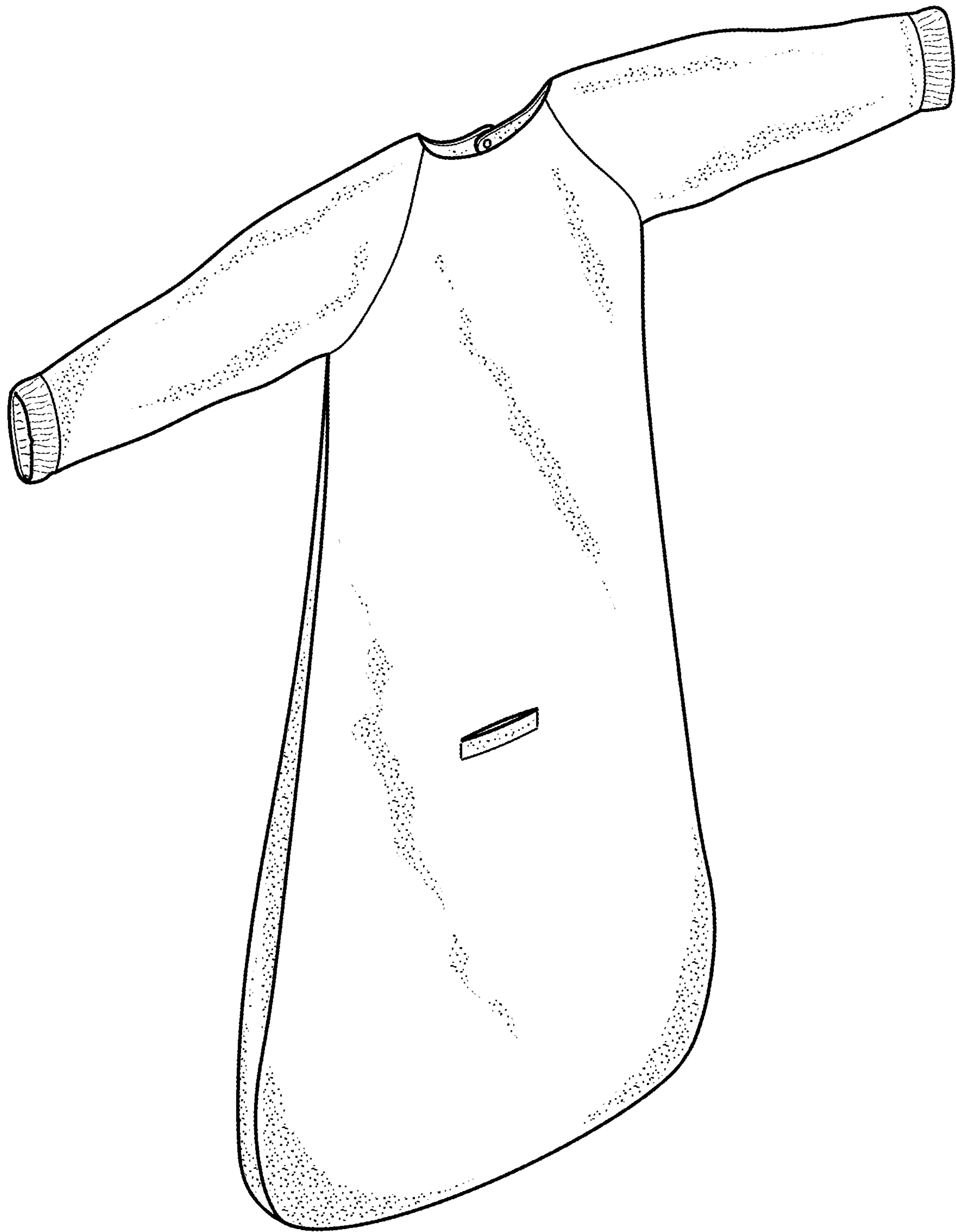

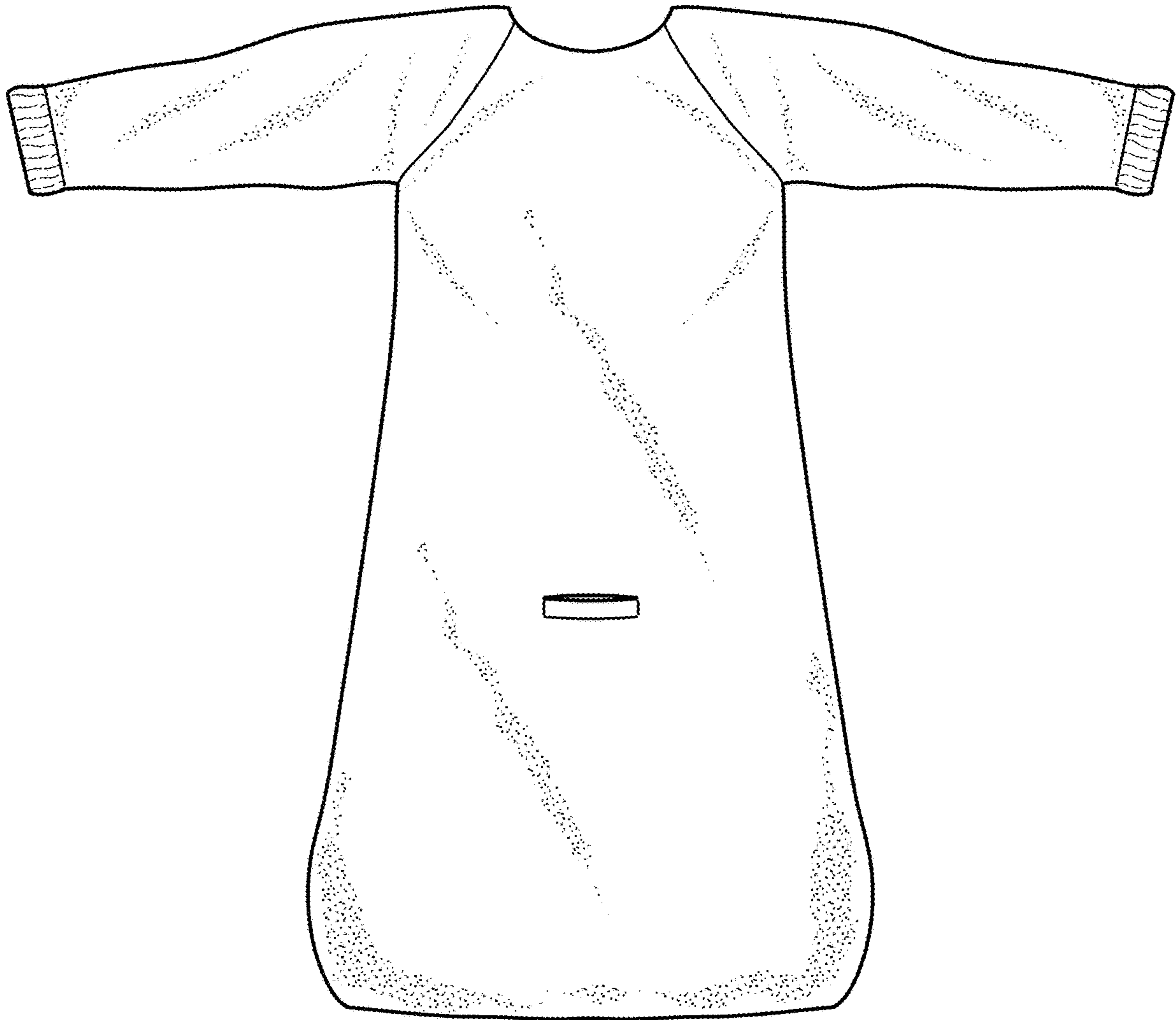

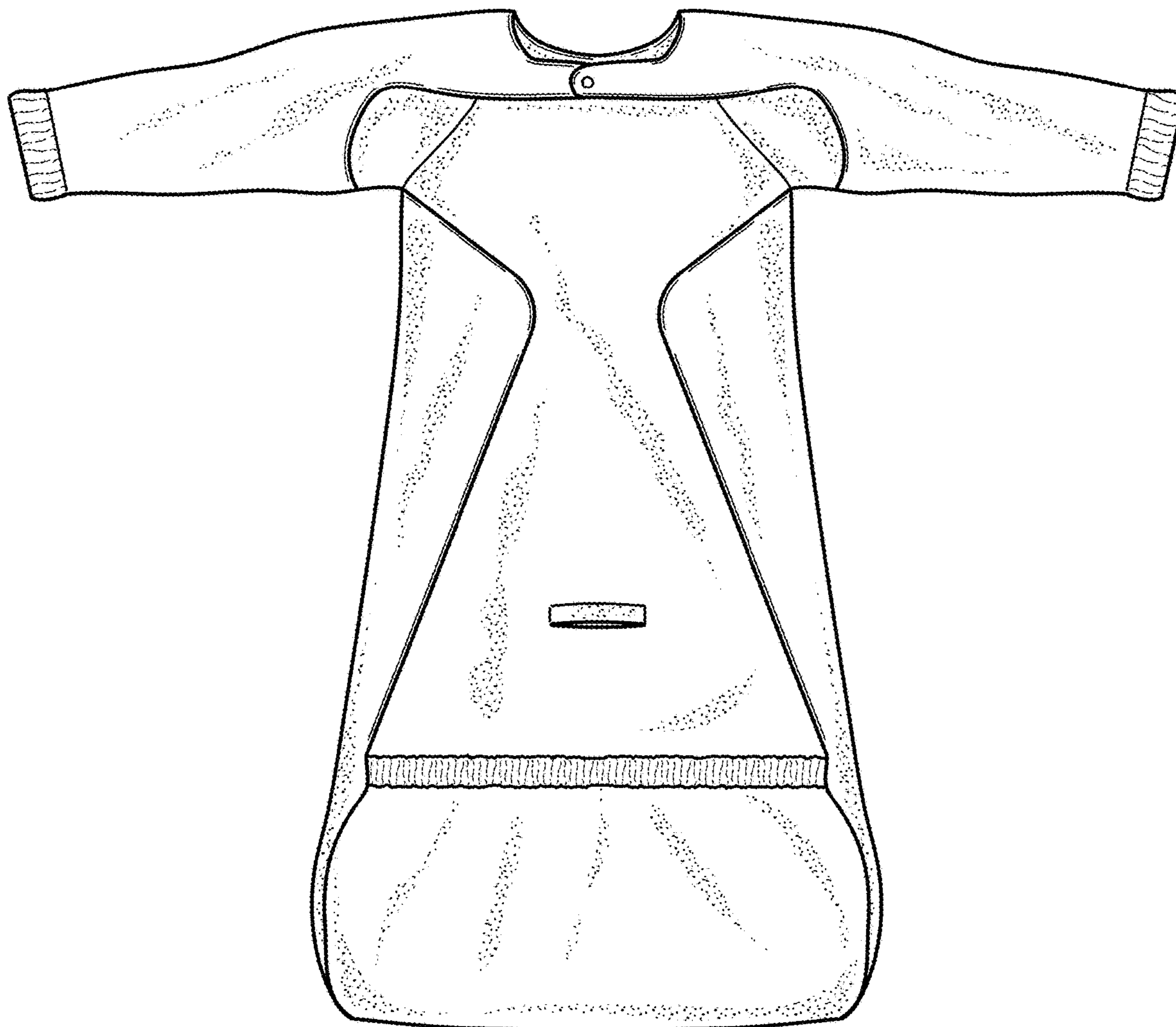

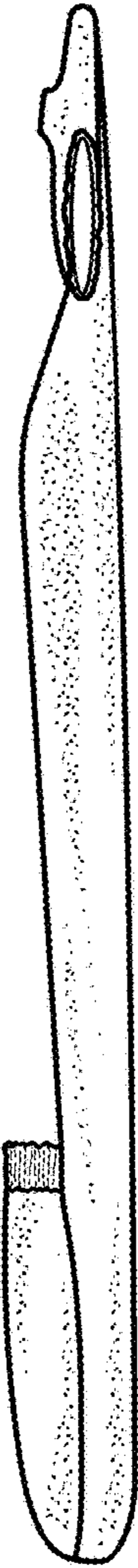

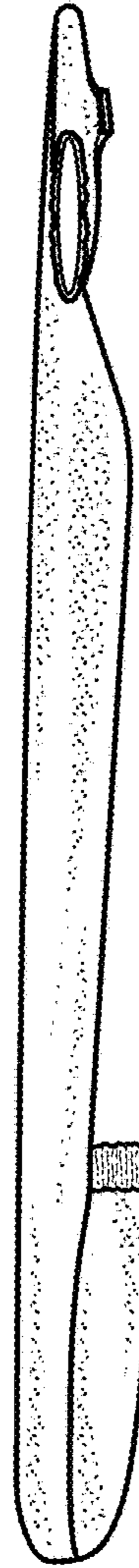

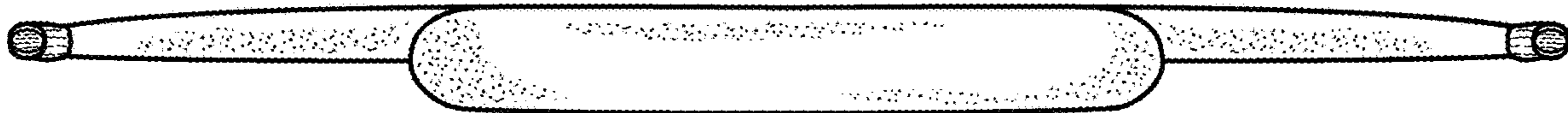
