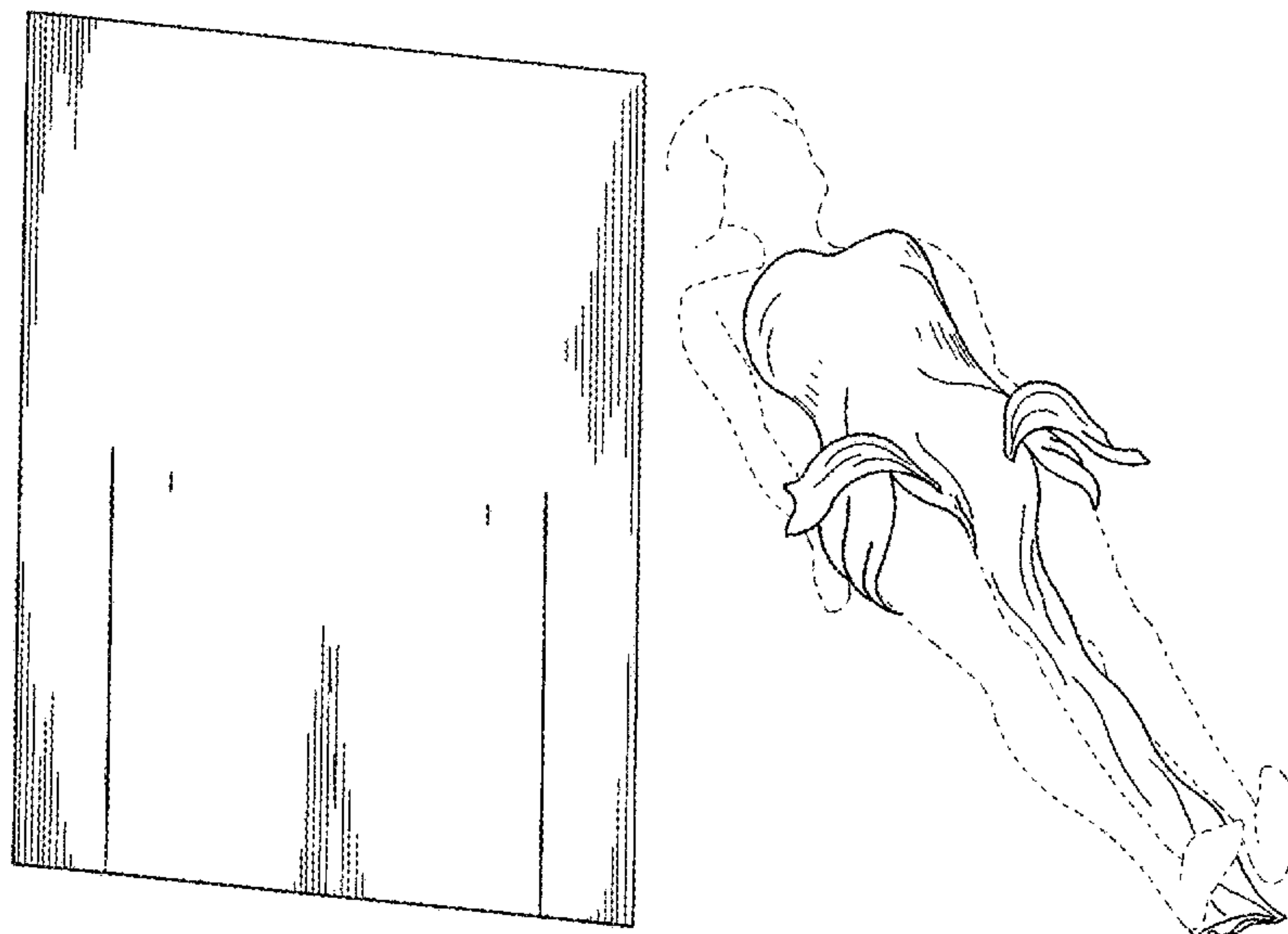
(57) **CLAIM**

The ornamental design for a massage privacy sheet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a massage privacy sheet in accordance with the present invention;  
FIG. 2 is a front elevation view of FIG. 1;  
FIG. 3 is a top plan view of FIG. 1;  
FIG. 4 is a bottom plan view of FIG. 1;  
FIG. 5 is a right side elevation view of FIG. 1, the left side elevation view being a mirror image thereof;  
FIG. 6 is a front perspective view of another embodiment of a massage privacy sheet in accordance with the present invention;  
FIG. 7 is a front elevation view of FIG. 6;  
FIG. 8 is a top plan view of FIG. 6;  
FIG. 9 is a bottom plan view of FIG. 6;  
FIG. 10 is a right side elevation view of FIG. 6, the left side elevation view being a mirror image thereof;  
FIG. 11 is a perspective view of the claimed design of FIG. 1 as positioned on a human body;  
FIG. 12 is a perspective view of the claimed design of FIG. 1 as assembled on a human body;  
FIG. 13 is a perspective view of the claimed design of FIG. 1 as assembled on a human body; and,  
FIG. 14 is a perspective view of the claimed design of FIG. 1 as assembled on a human body.  
The human body shown in broken lines in FIGS. 11-14 are to show environment and form no part of the claimed design.

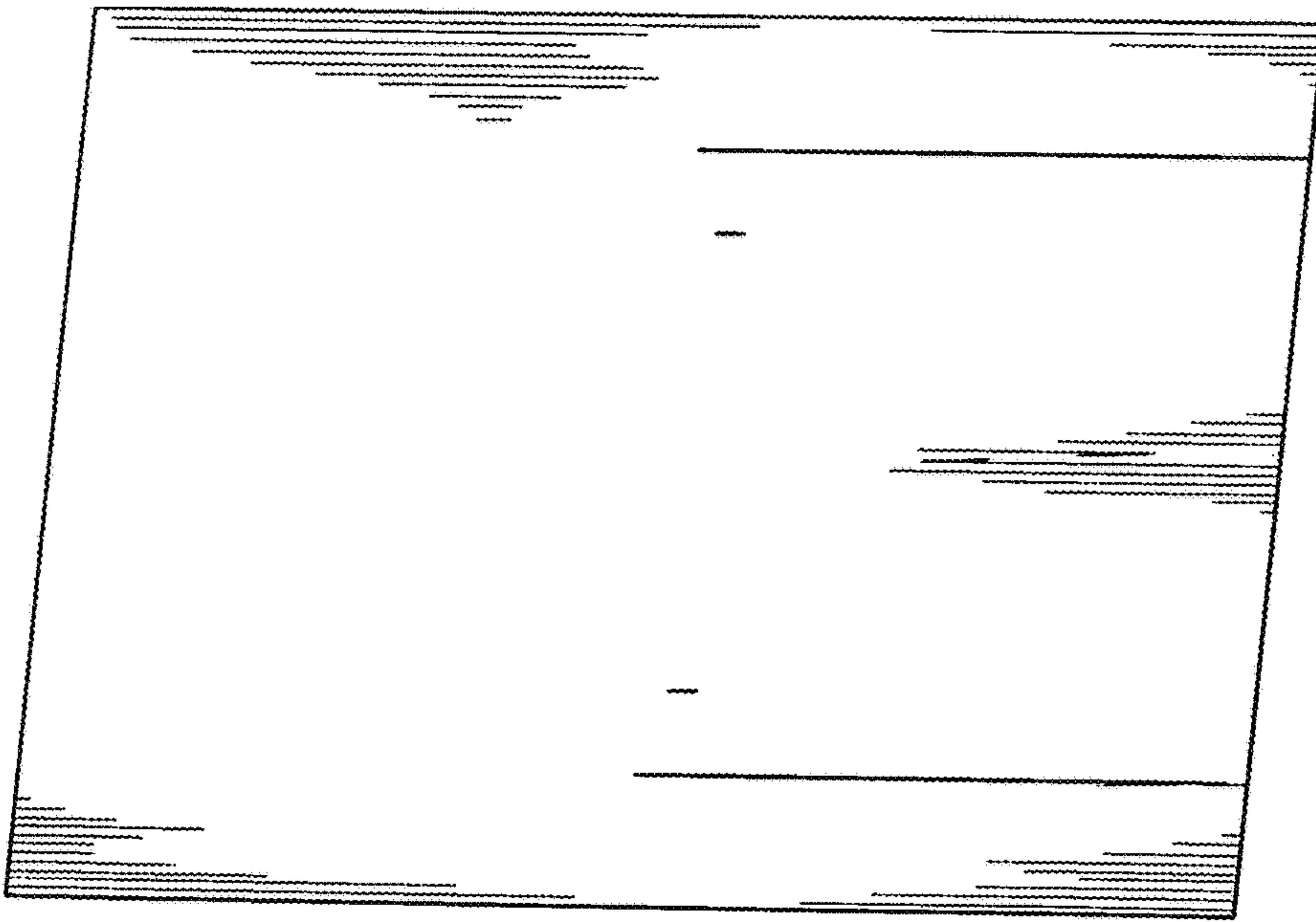

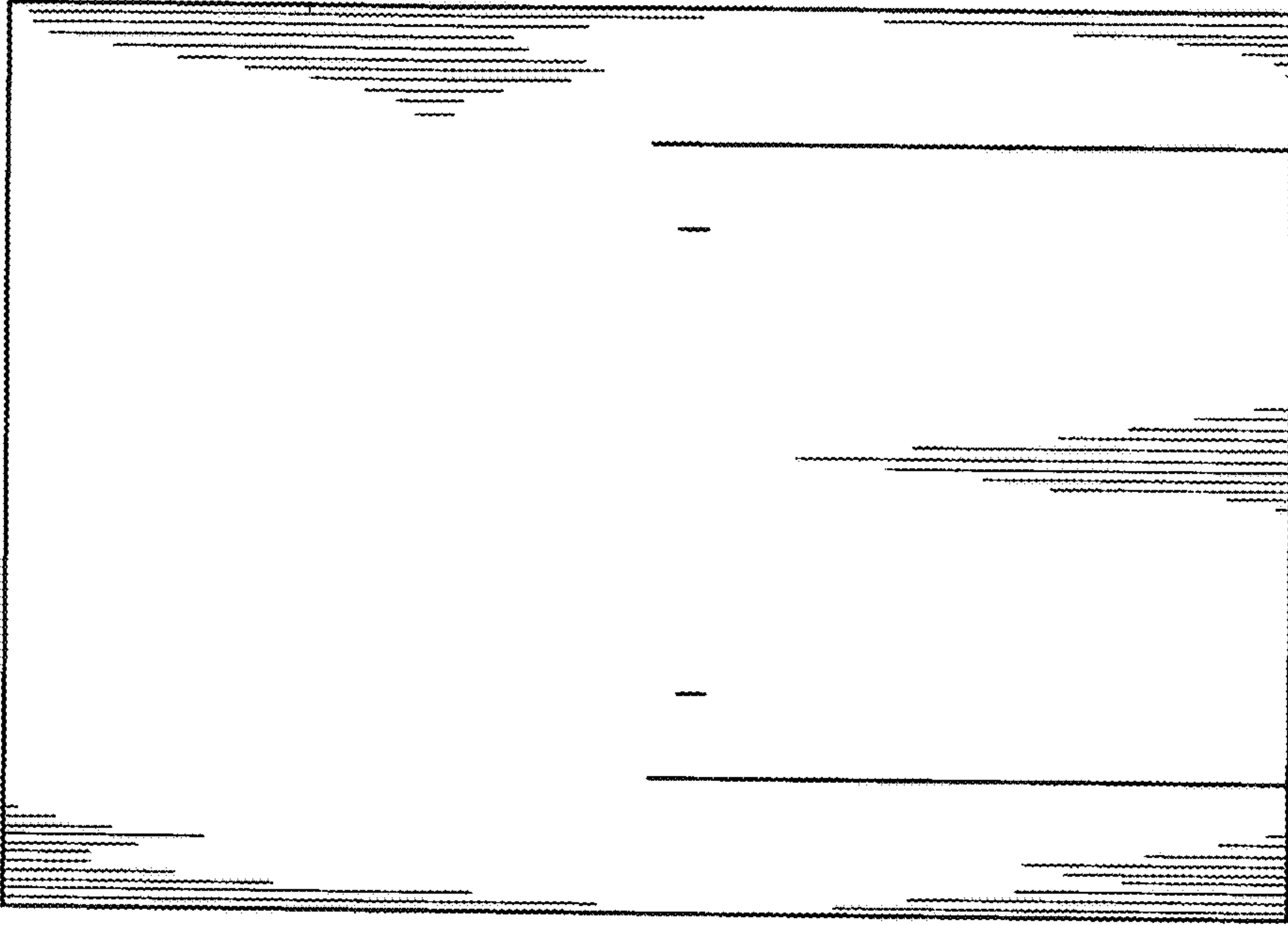

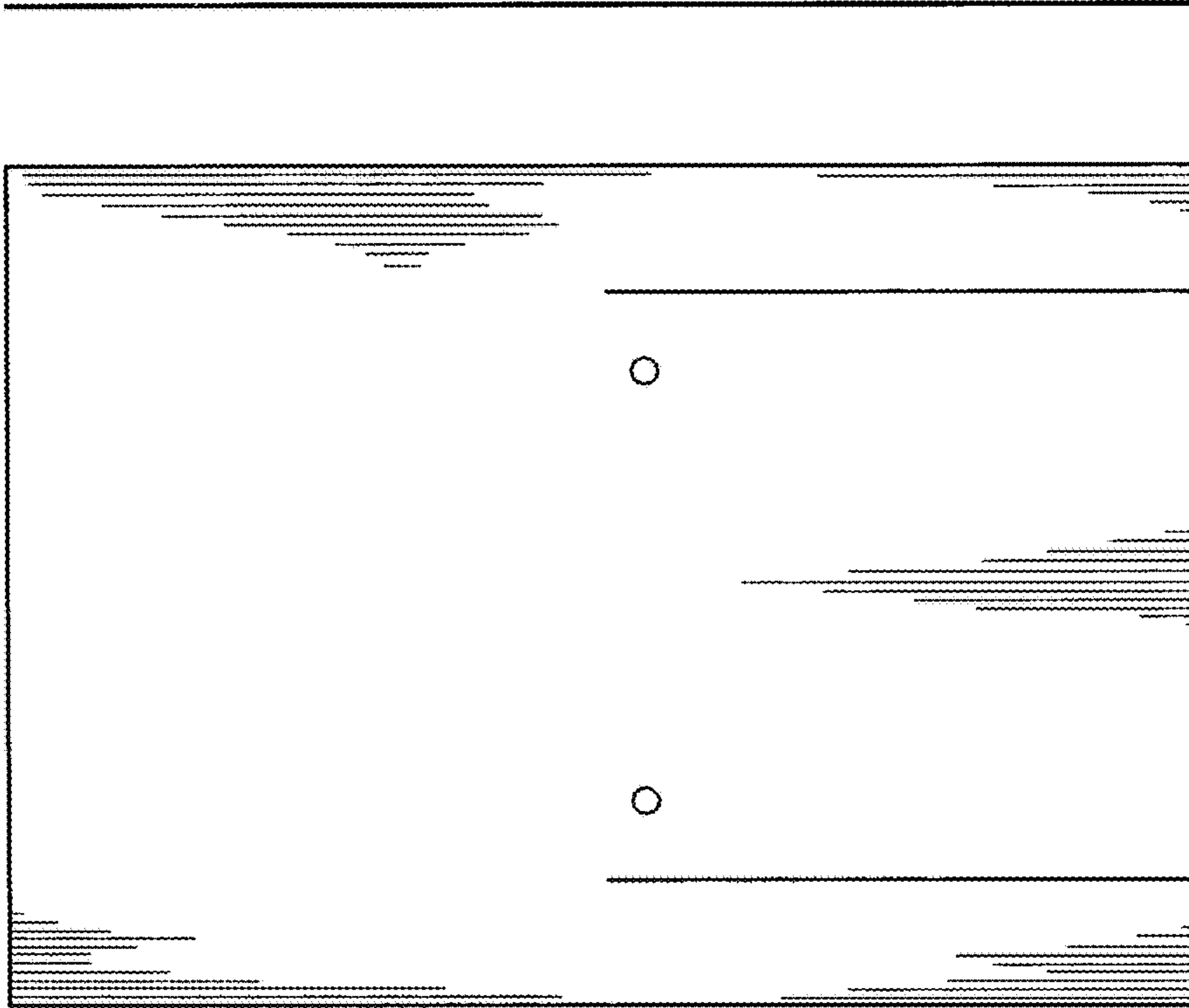

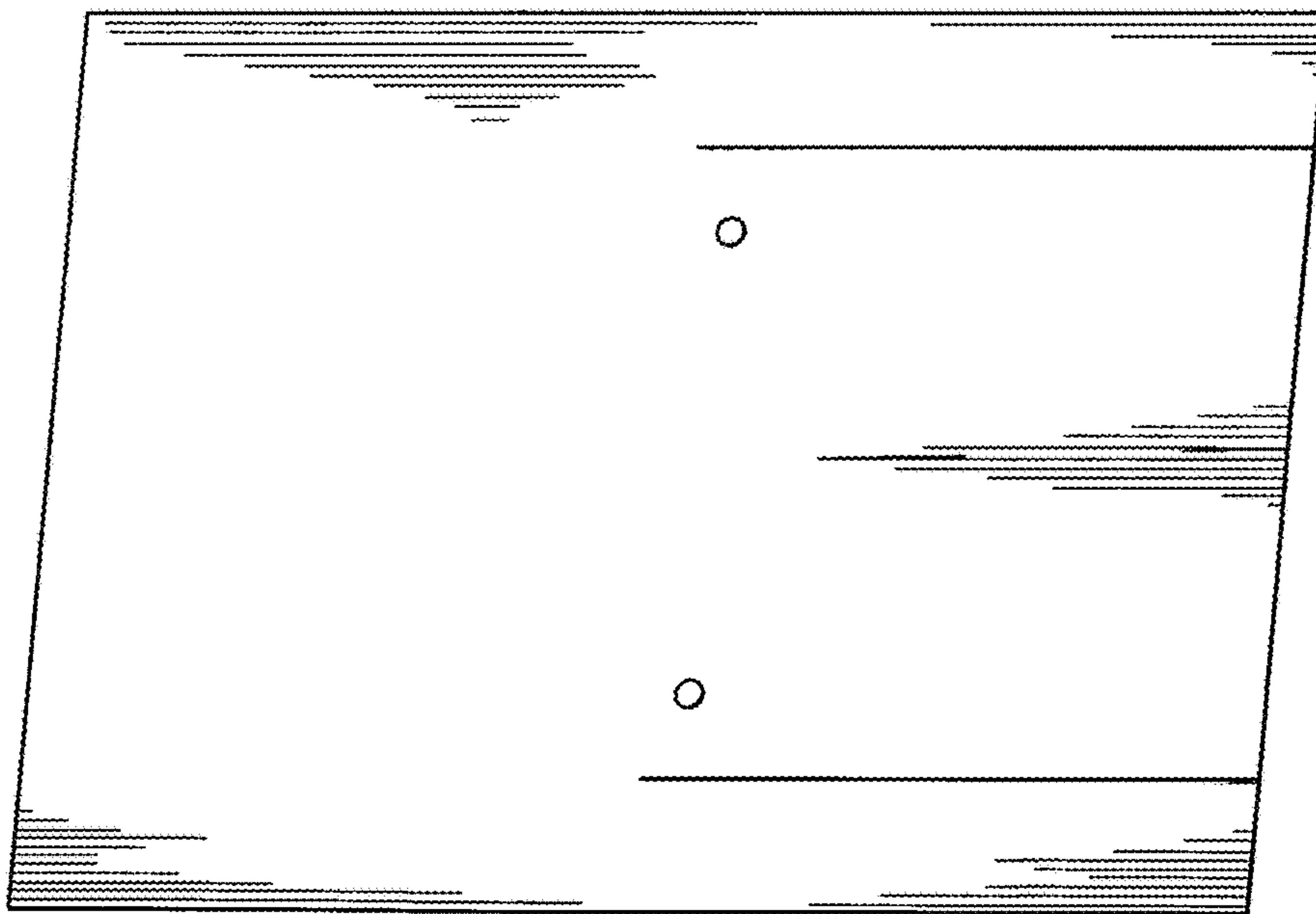
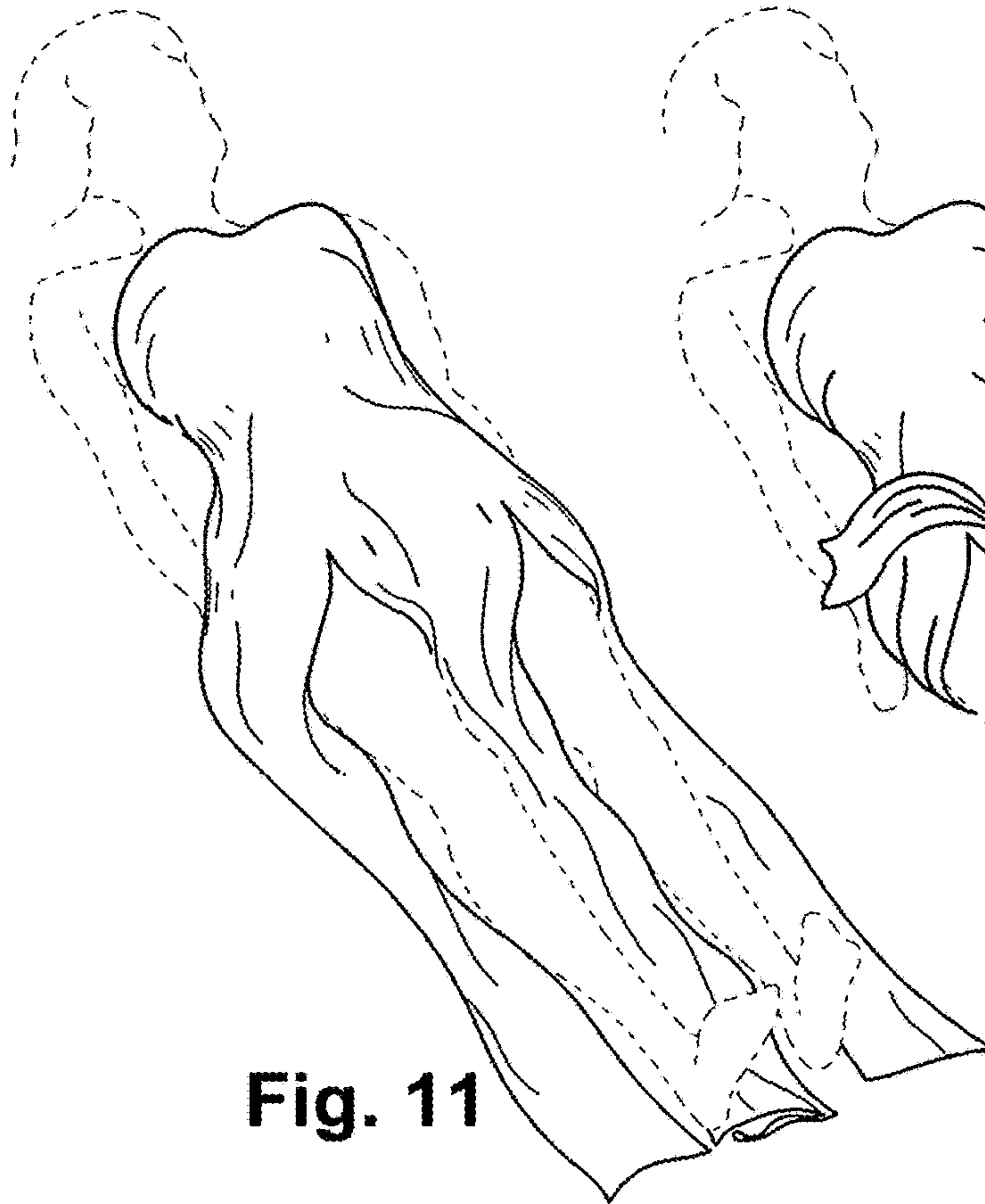
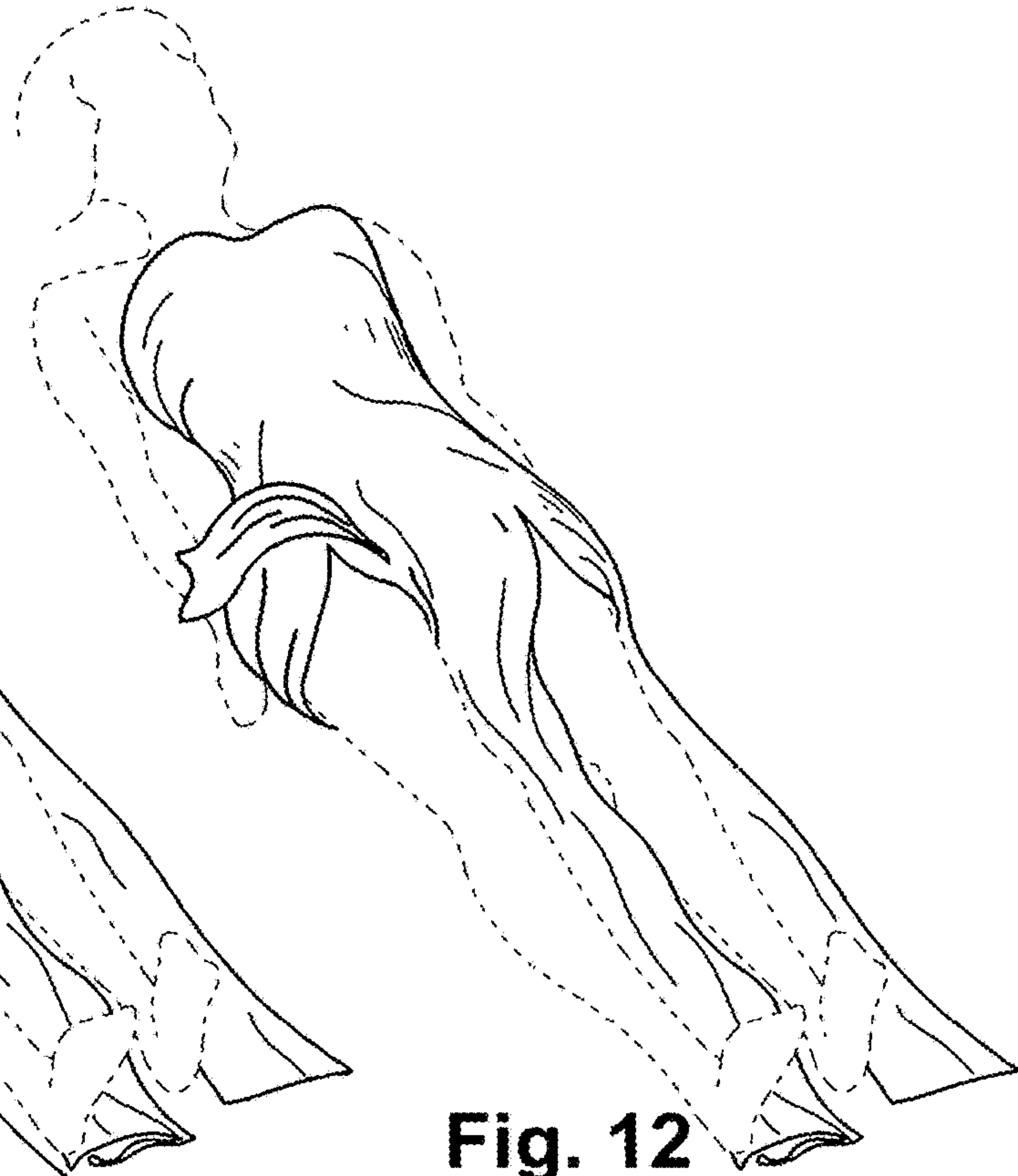

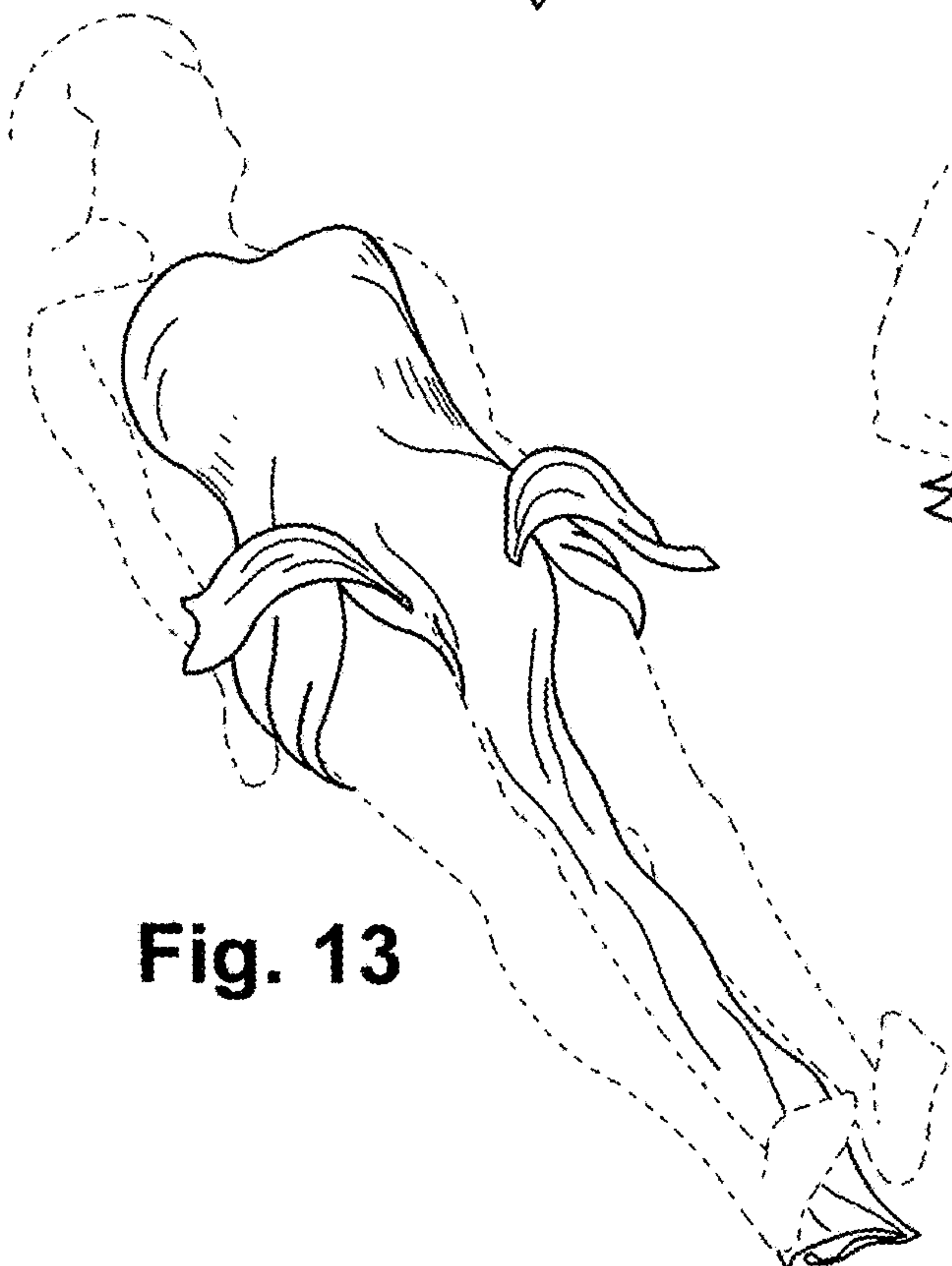




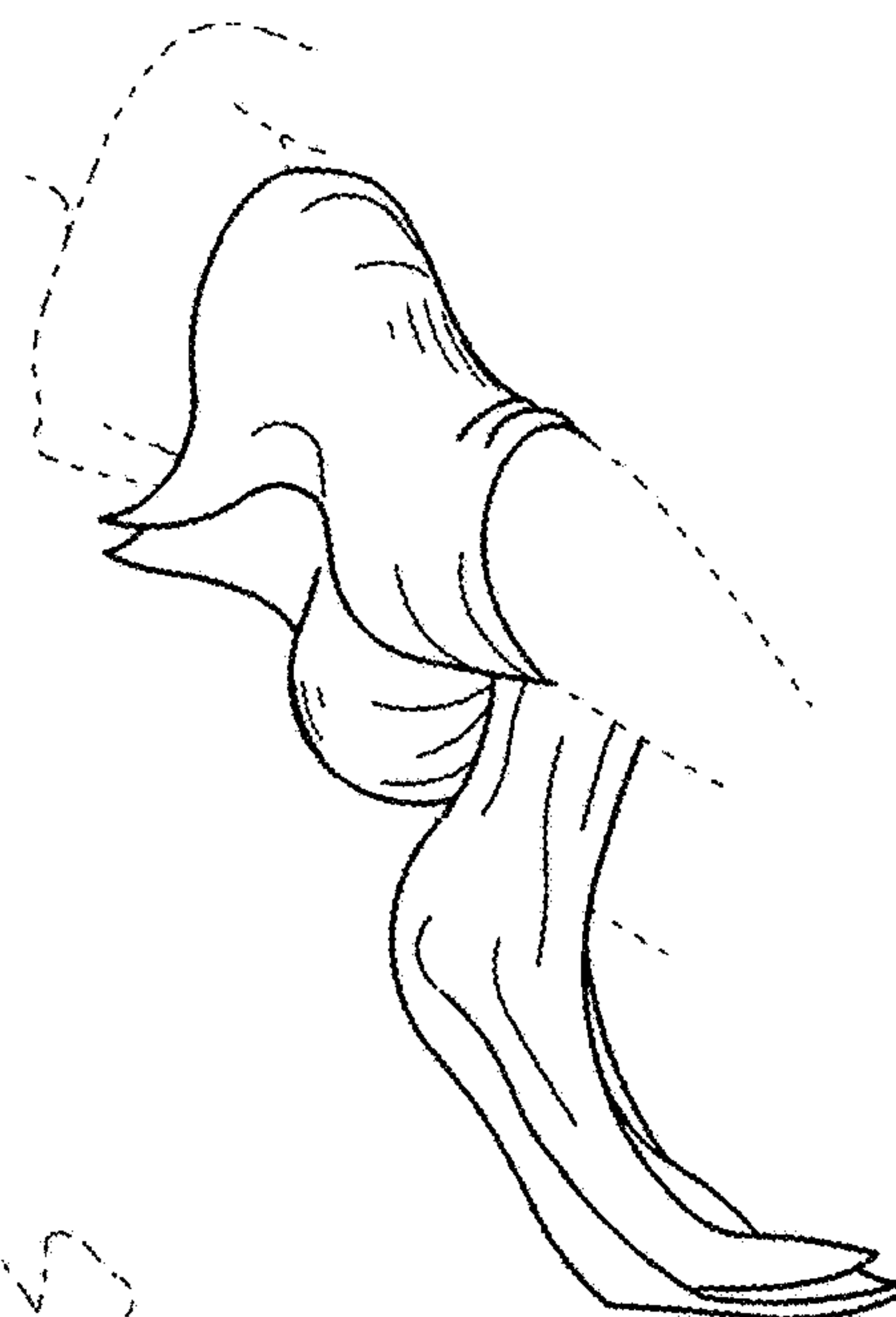
