(57) **CLAIM**

The ornamental design for a garment with side opening, as shown and described.

DESCRIPTION

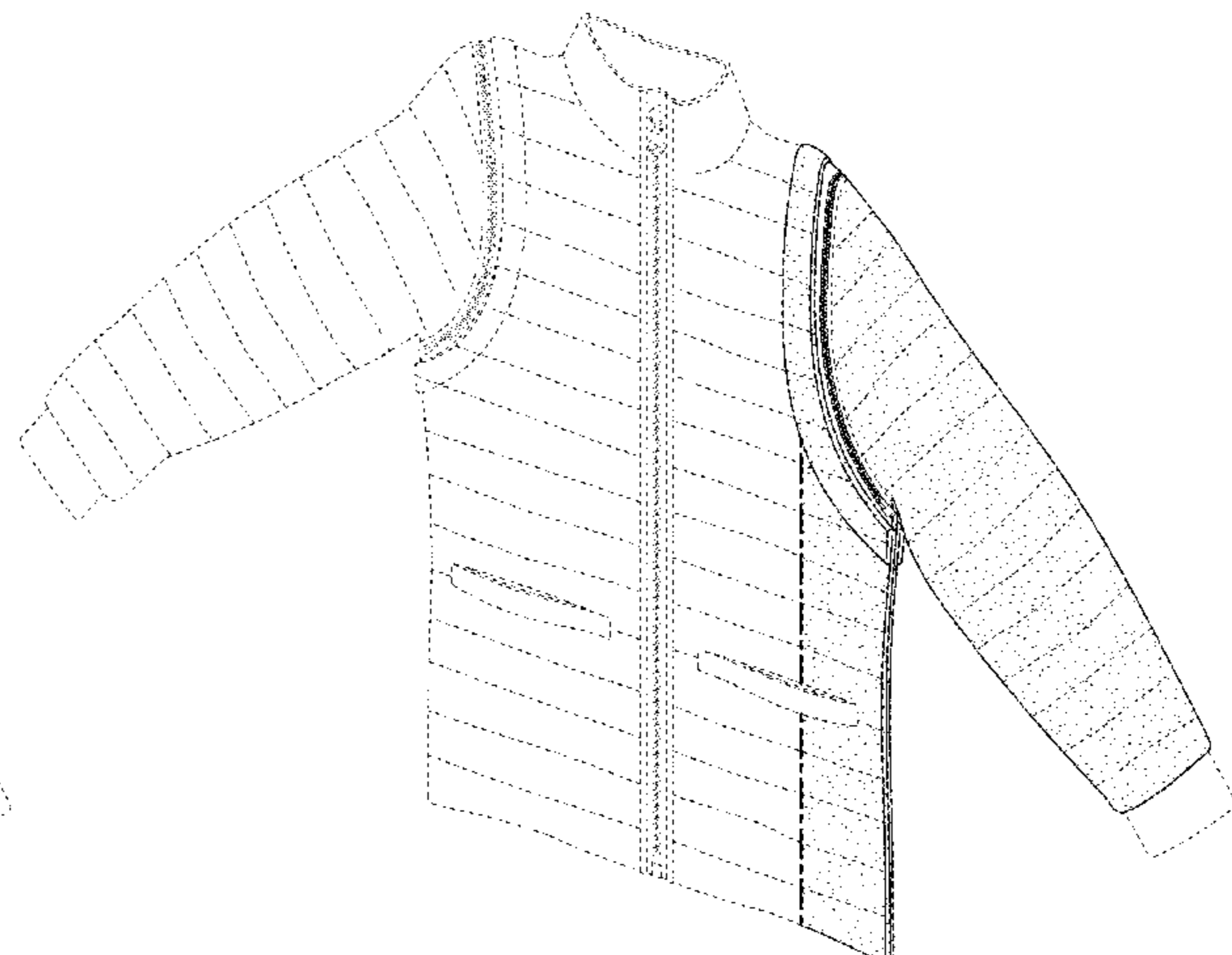
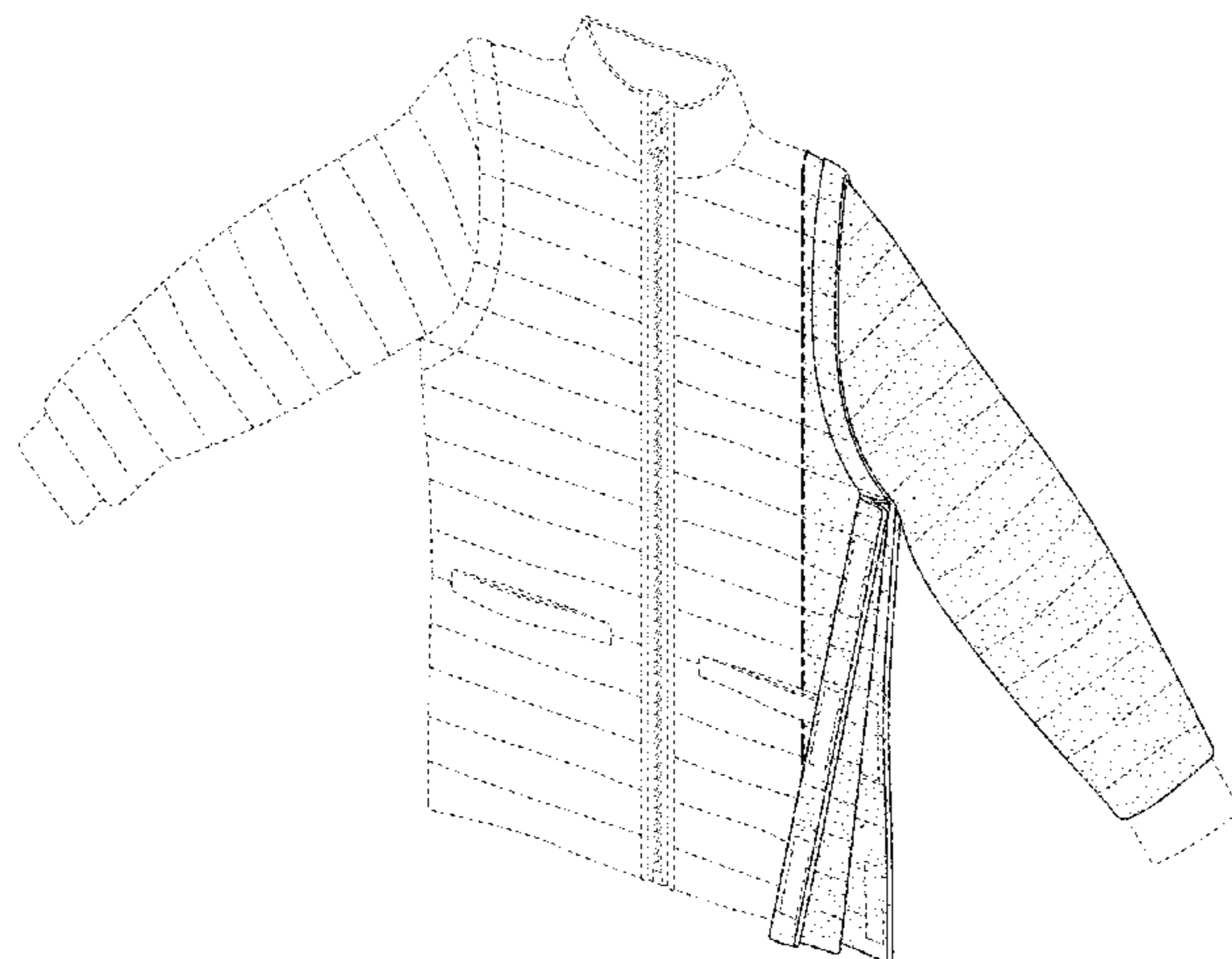


FIG. 20 is a right side view thereof;

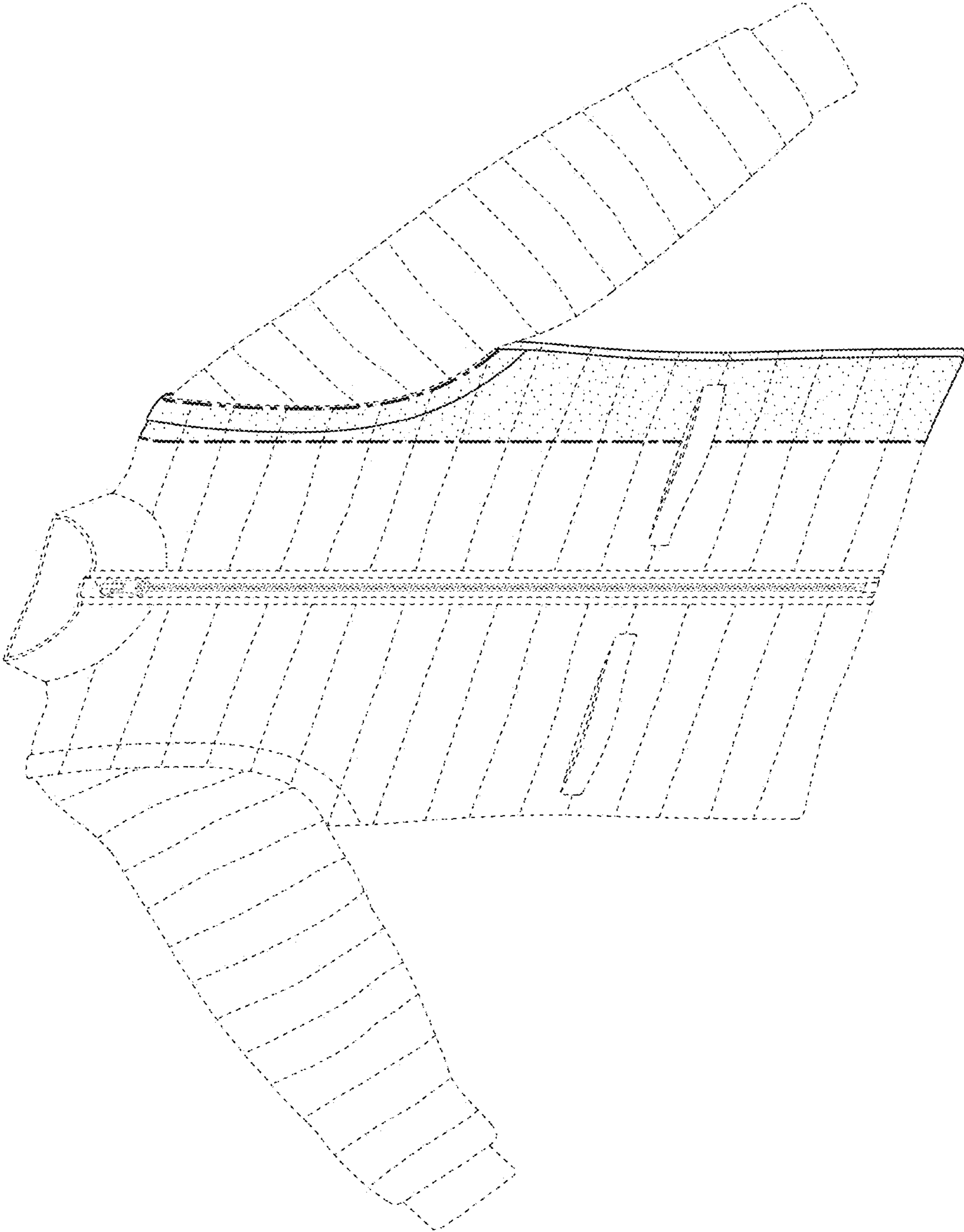

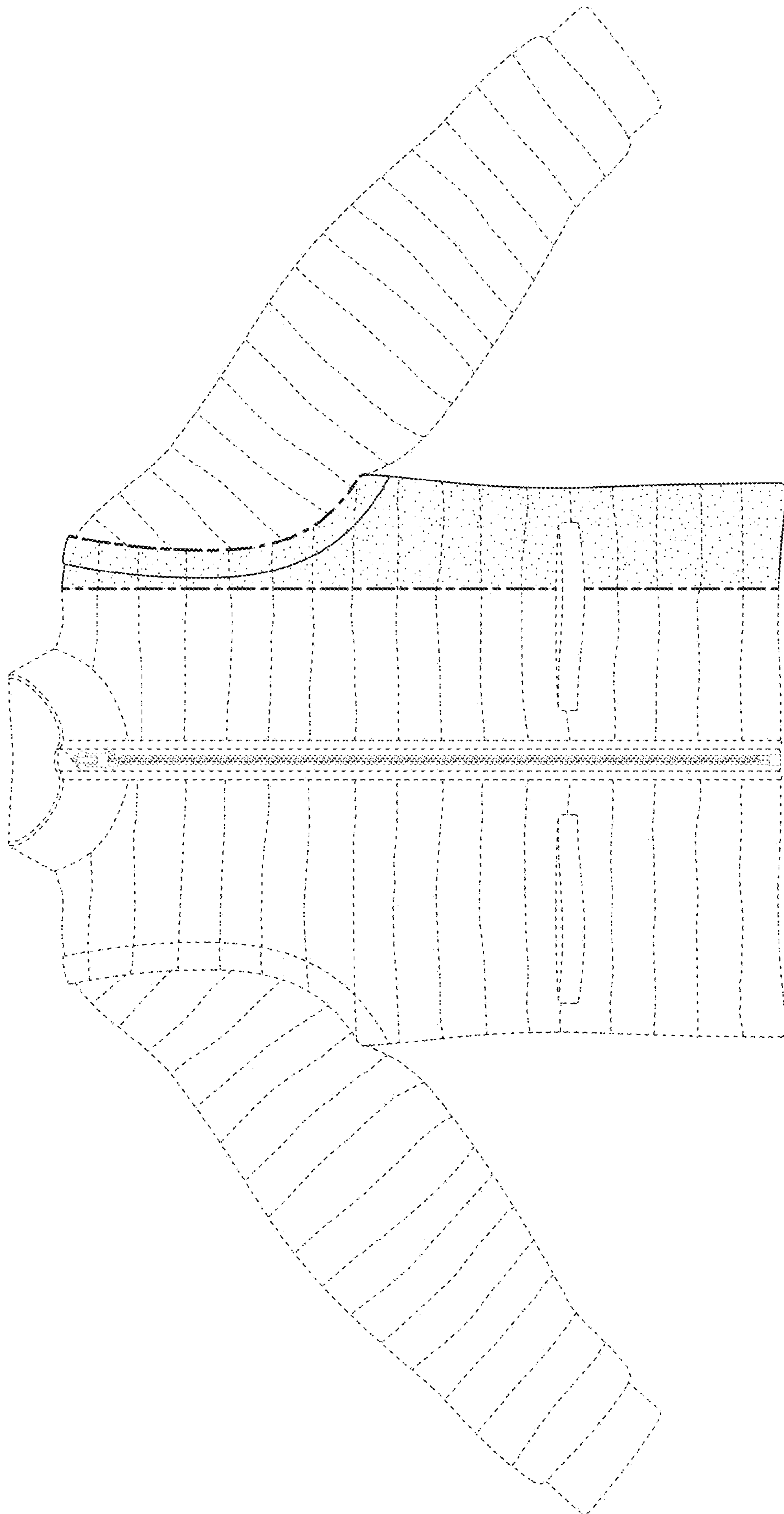

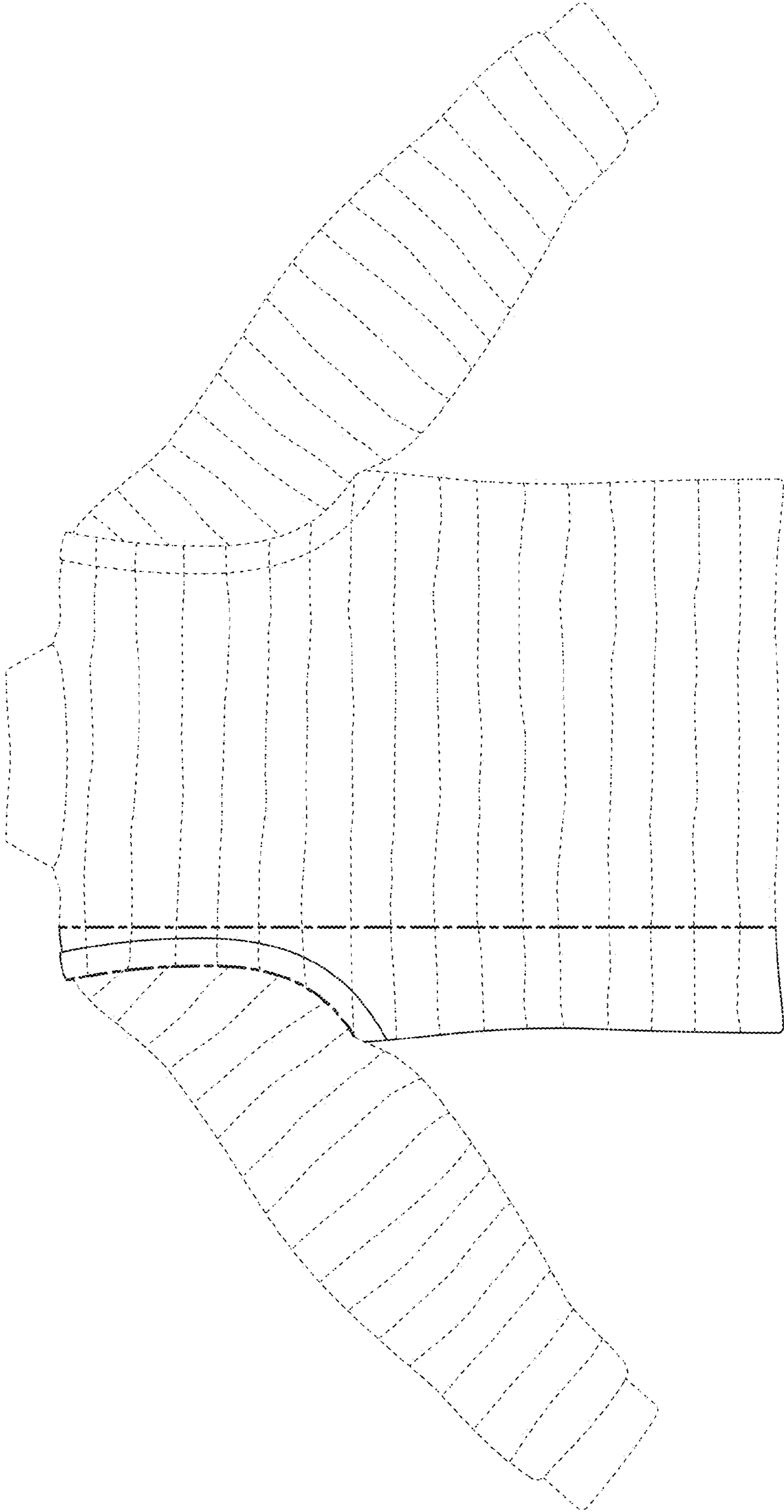

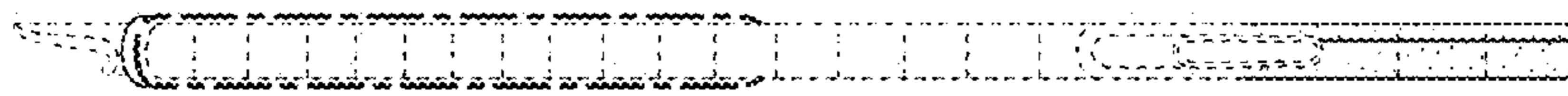

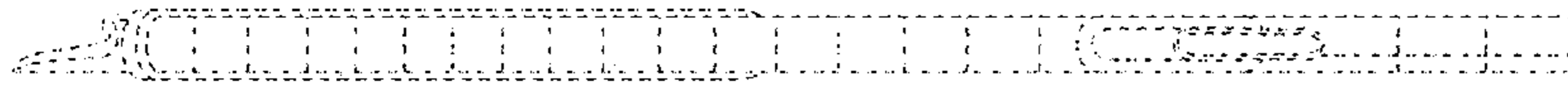

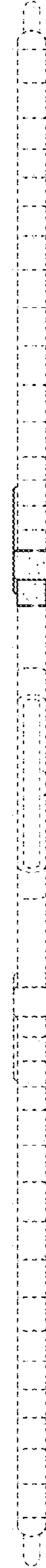

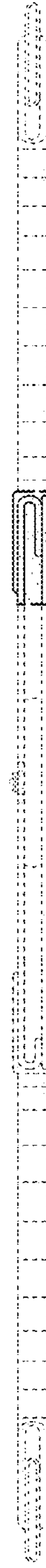

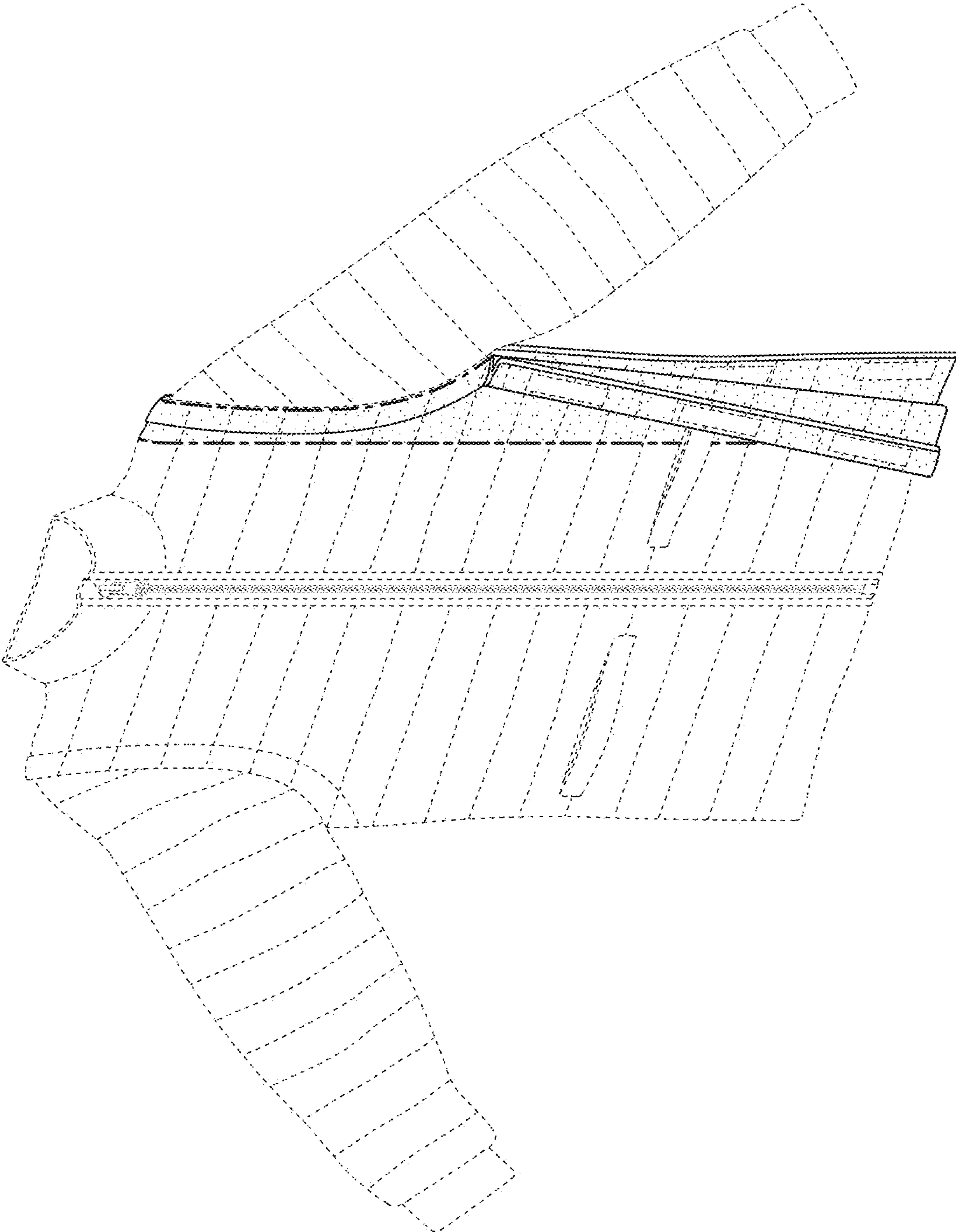

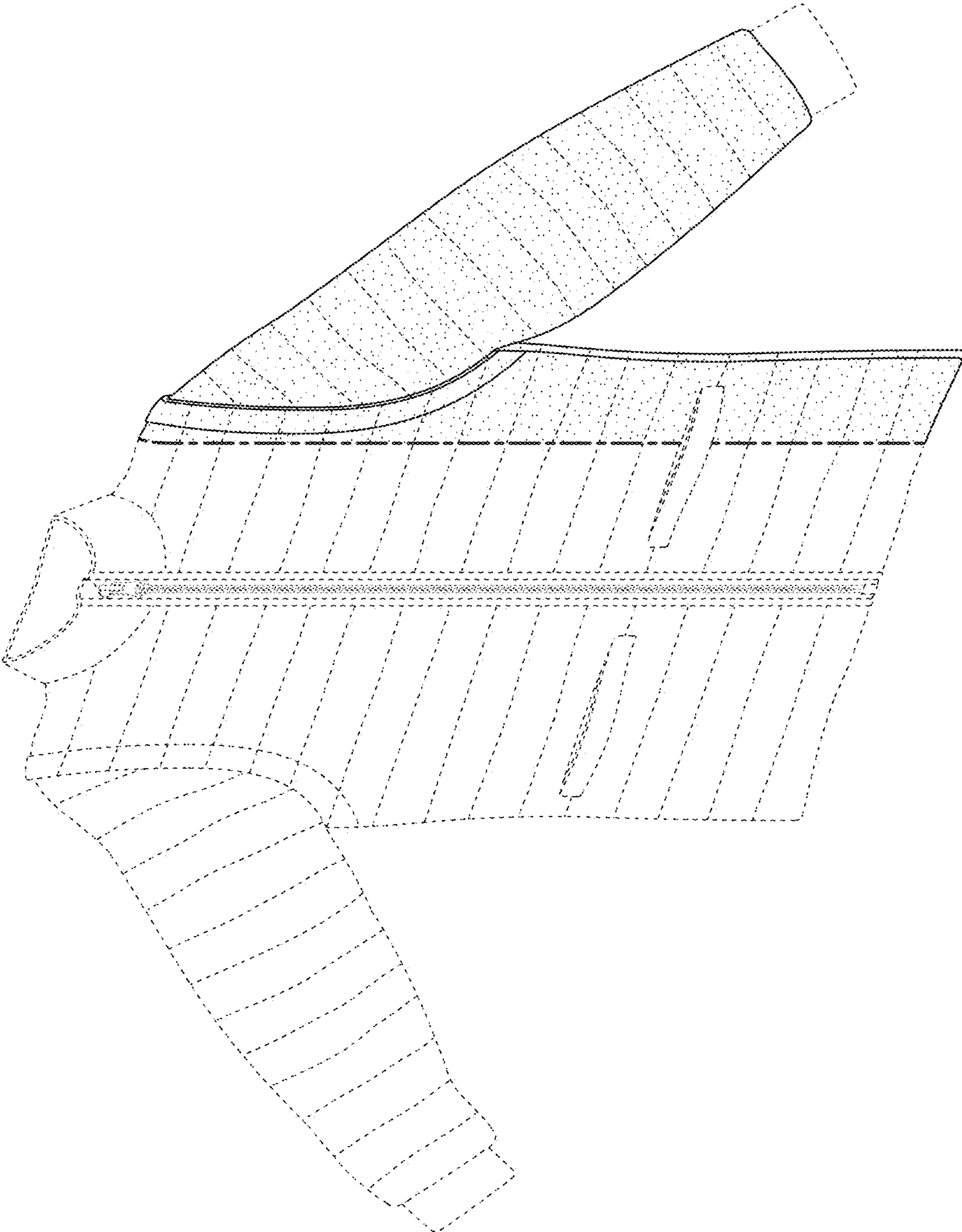

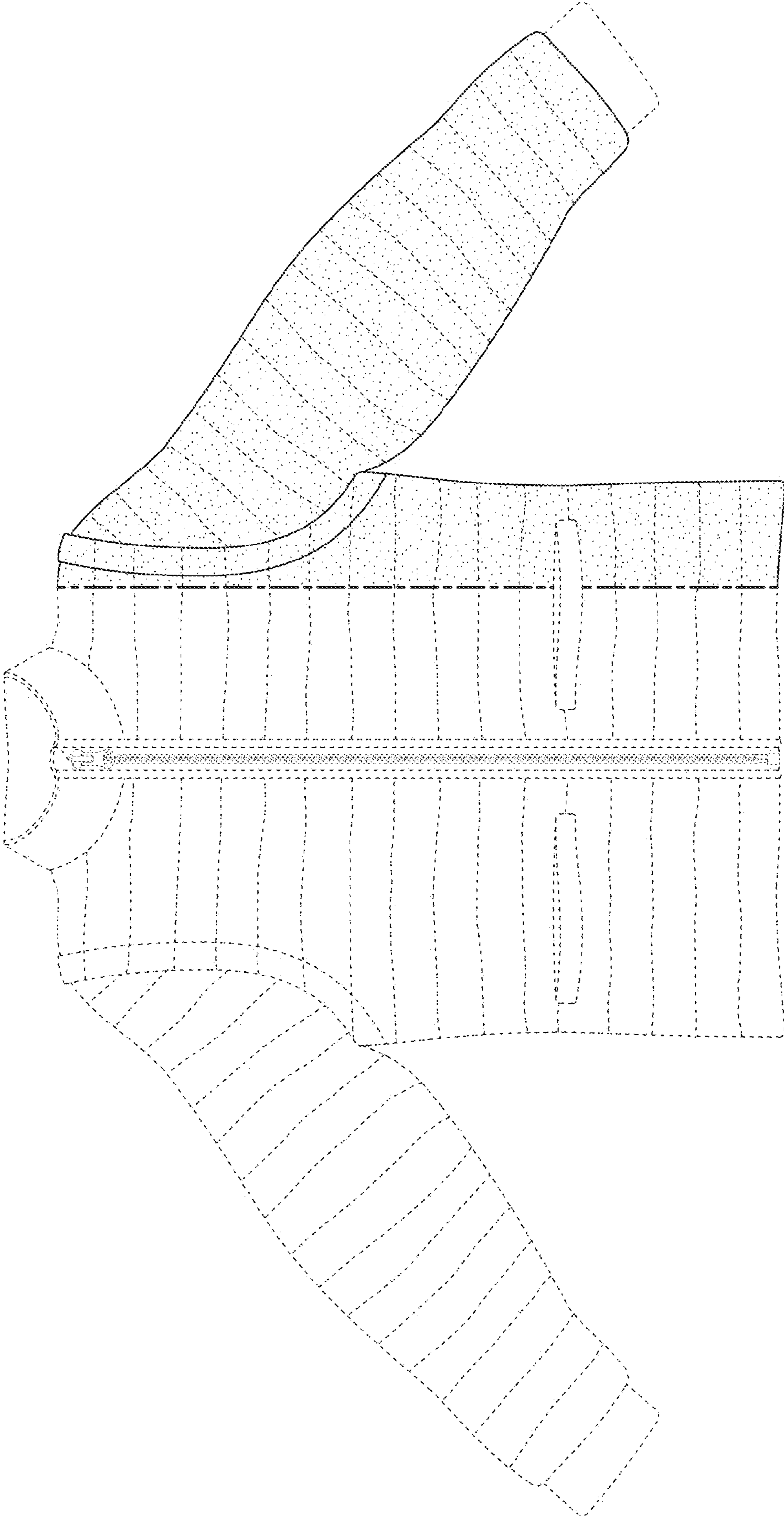

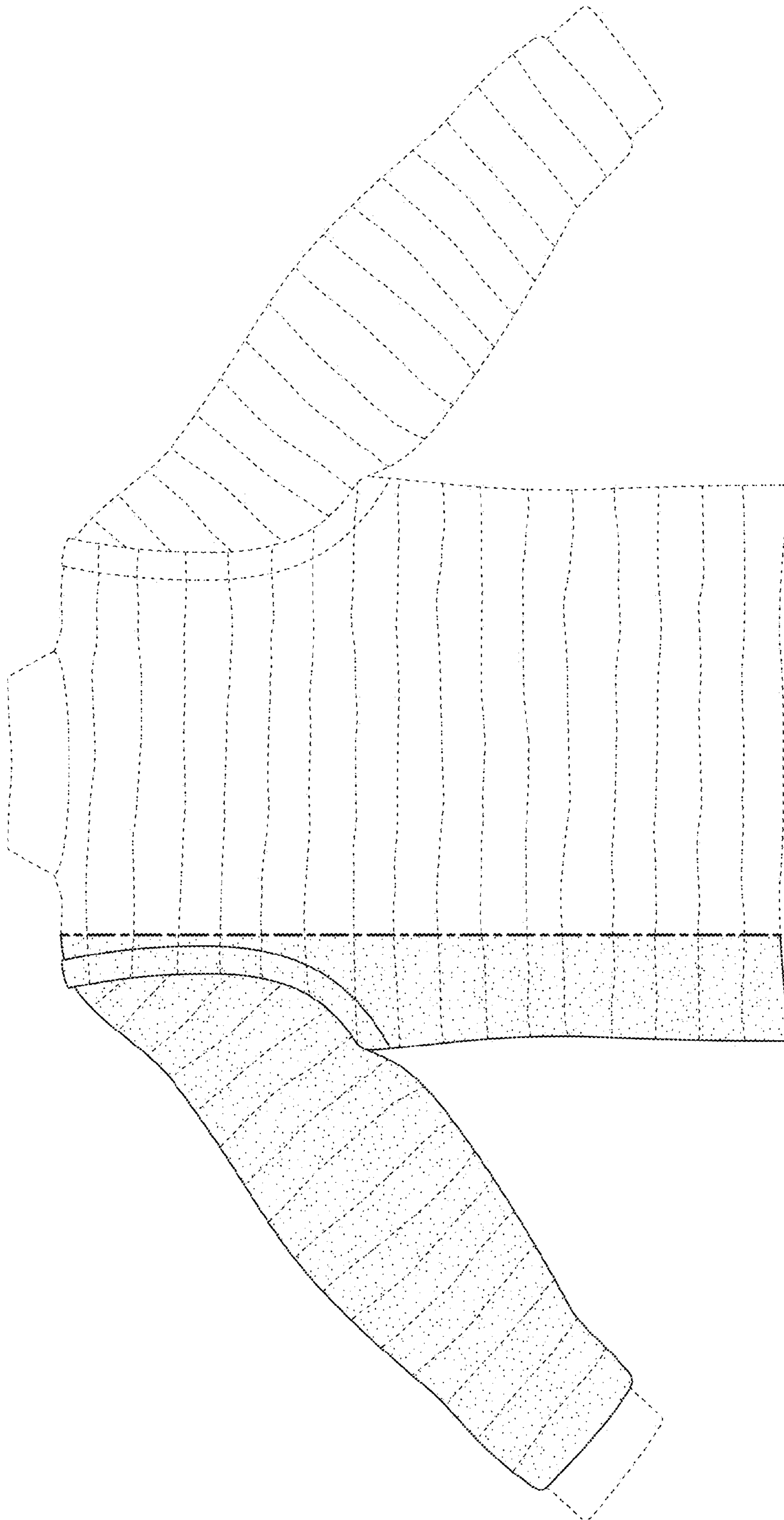

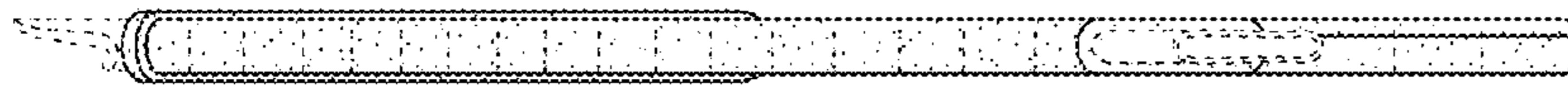

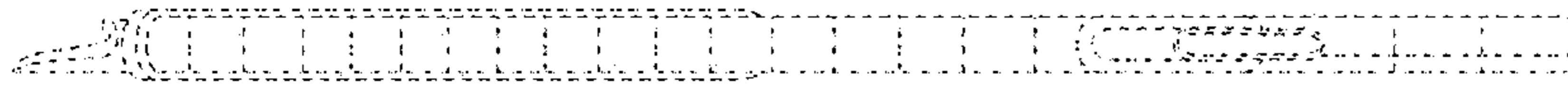

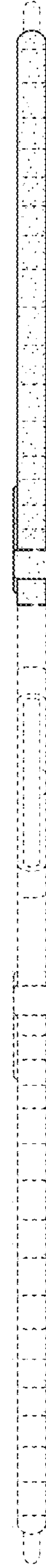

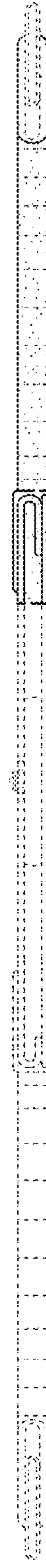

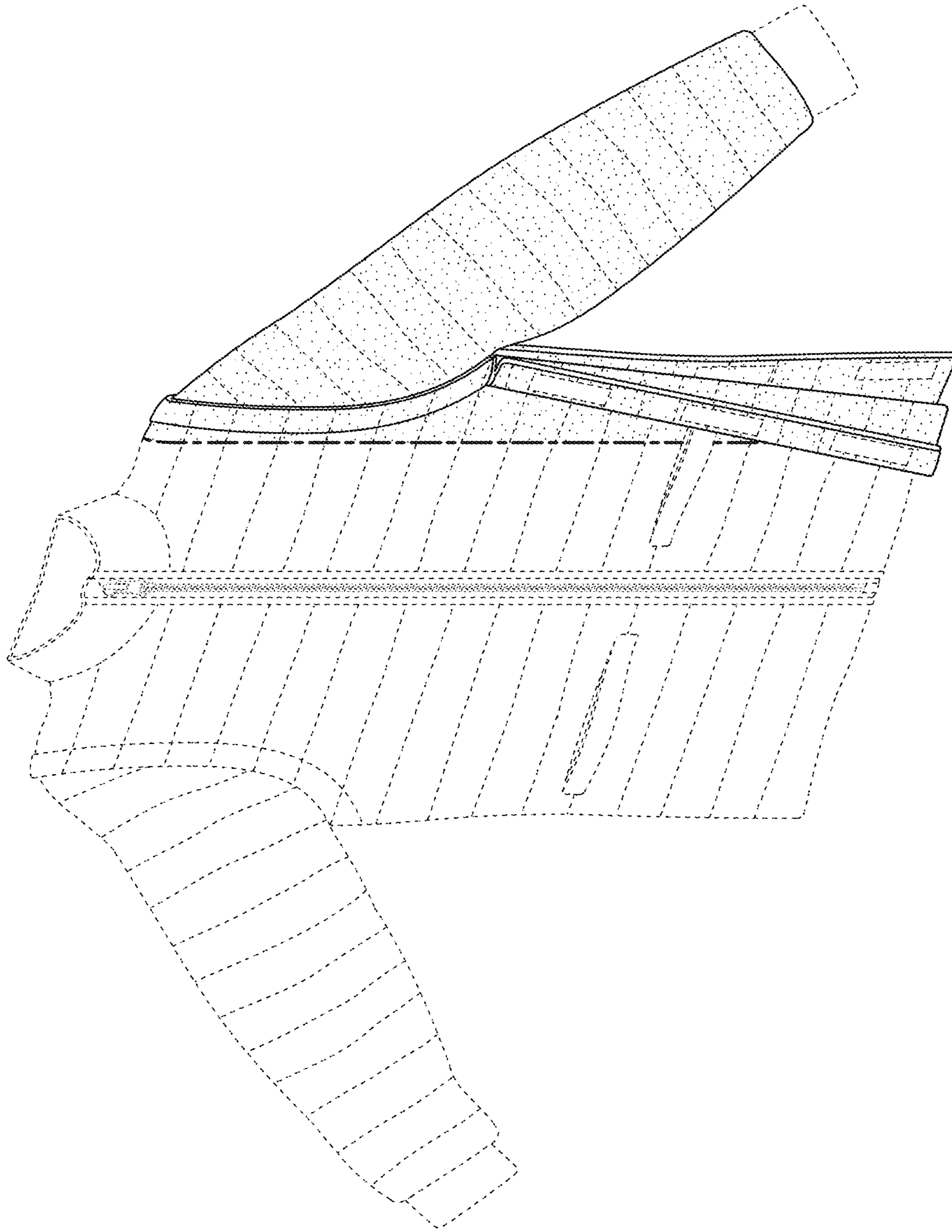

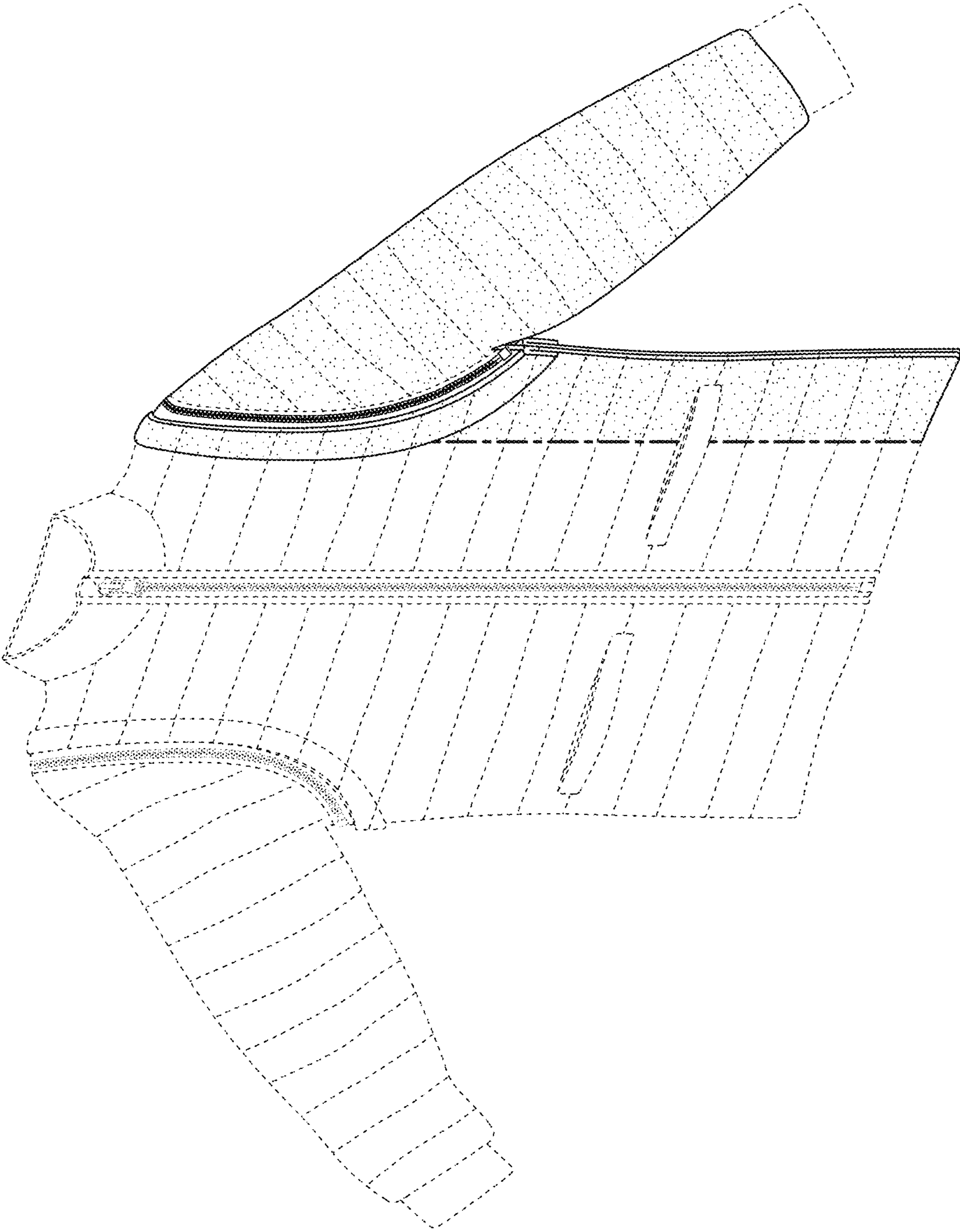

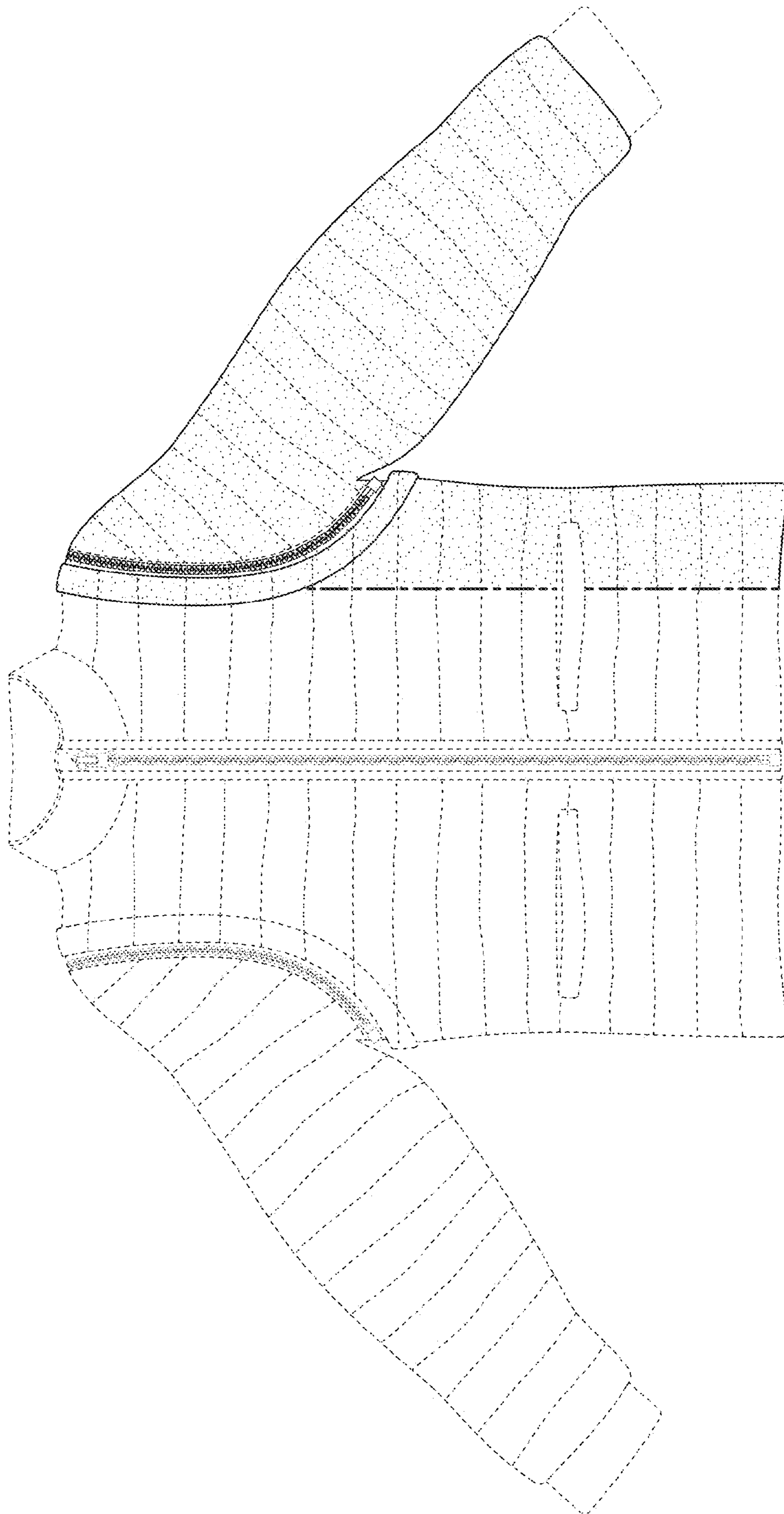

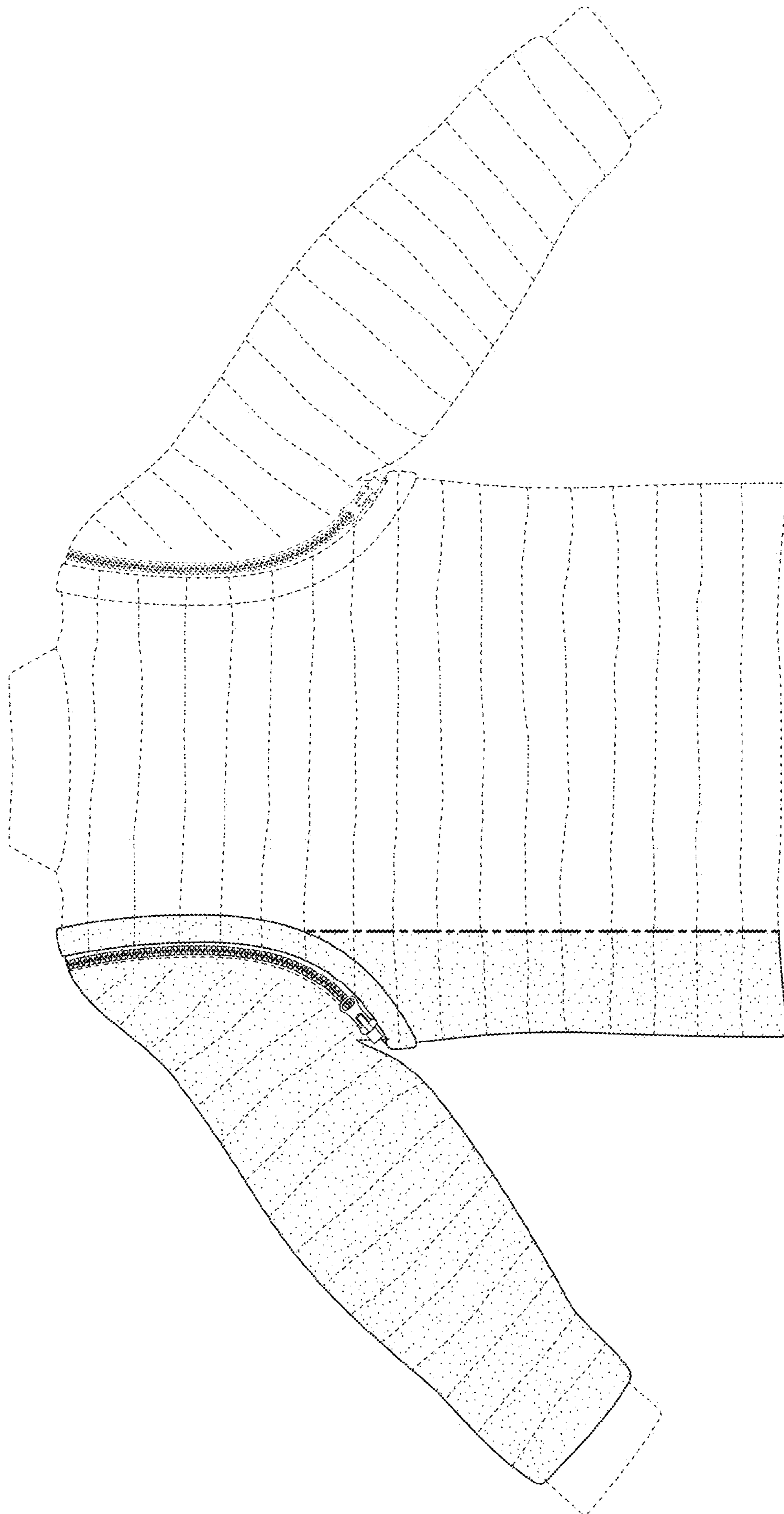

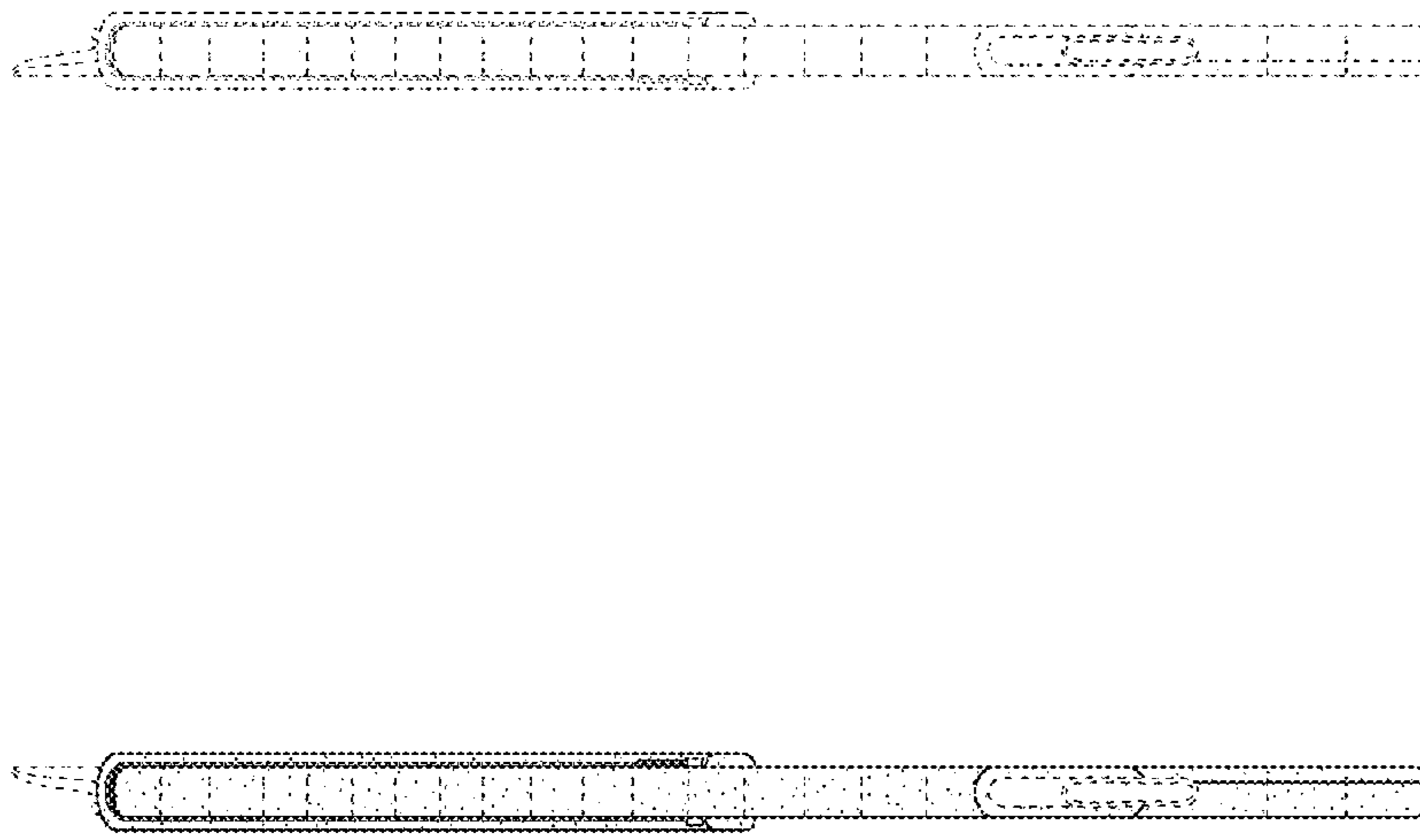

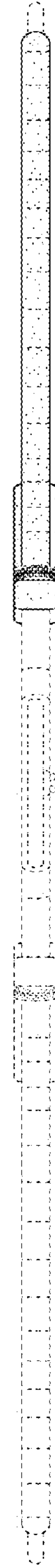

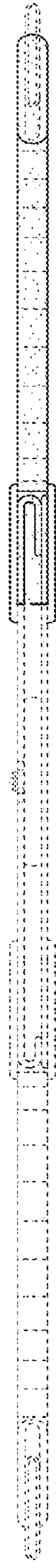
