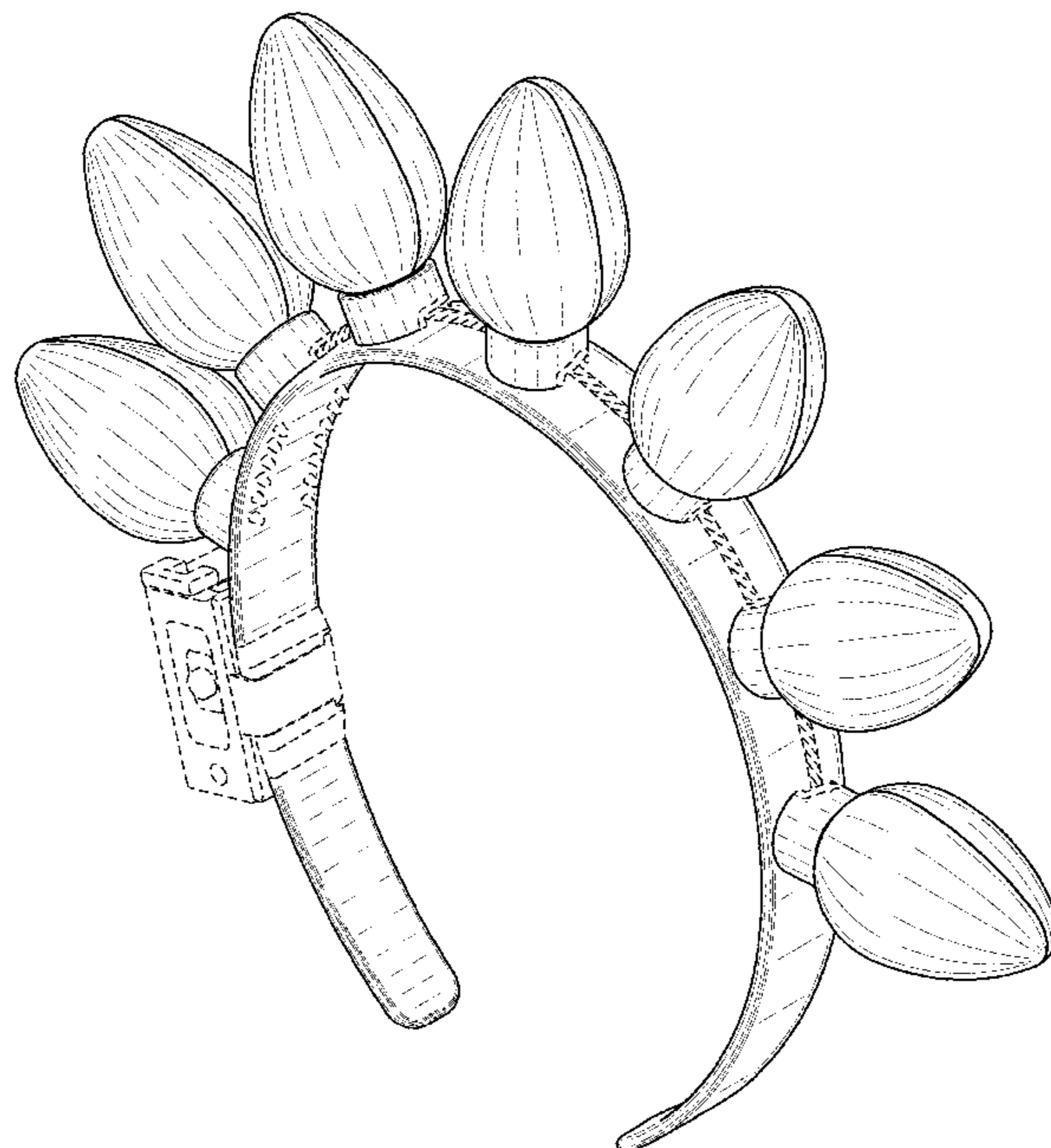
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a lighted headband;
FIG. 2 is a front view thereof;

FIG. 6 is a top view thereof; and,

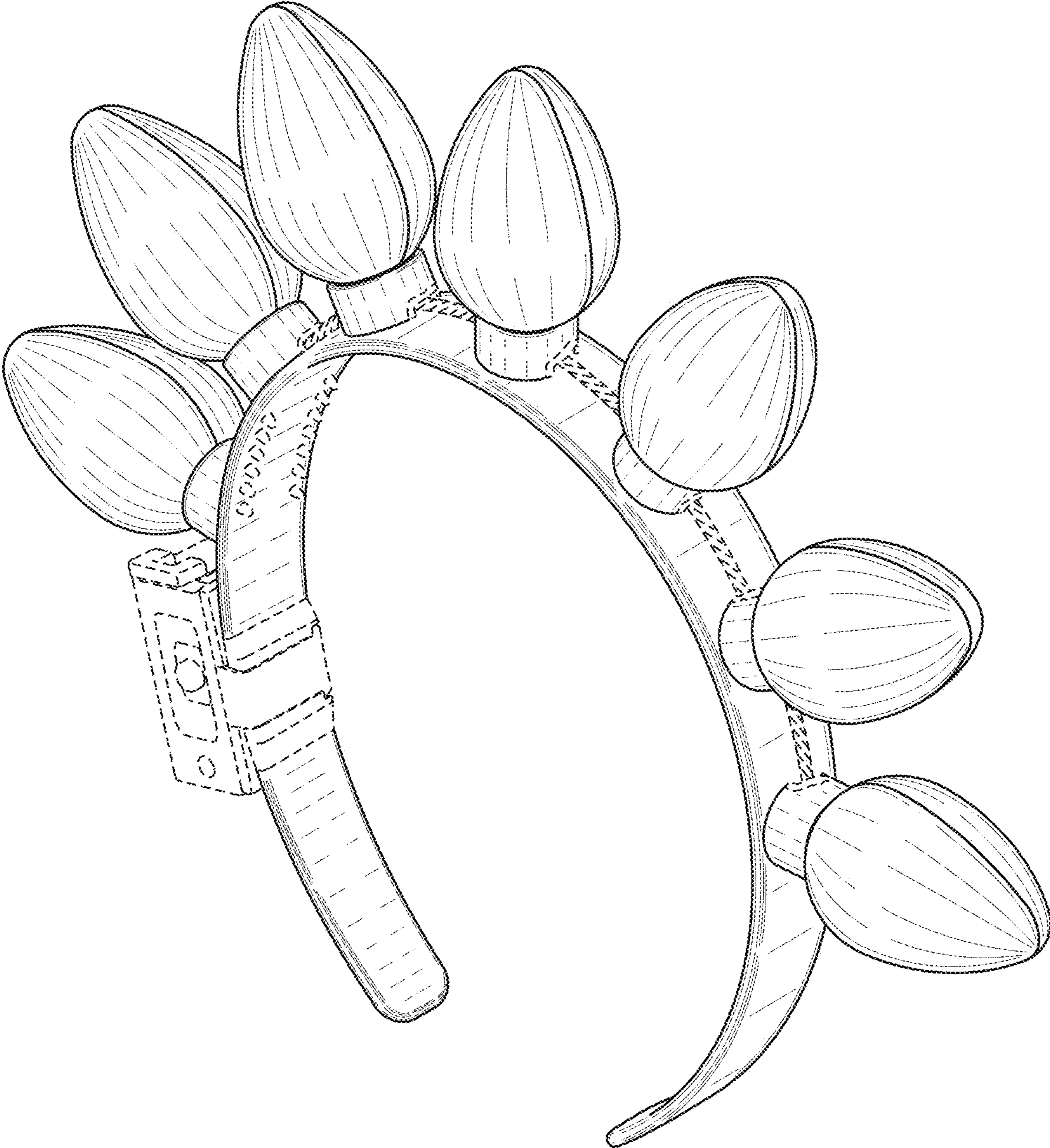

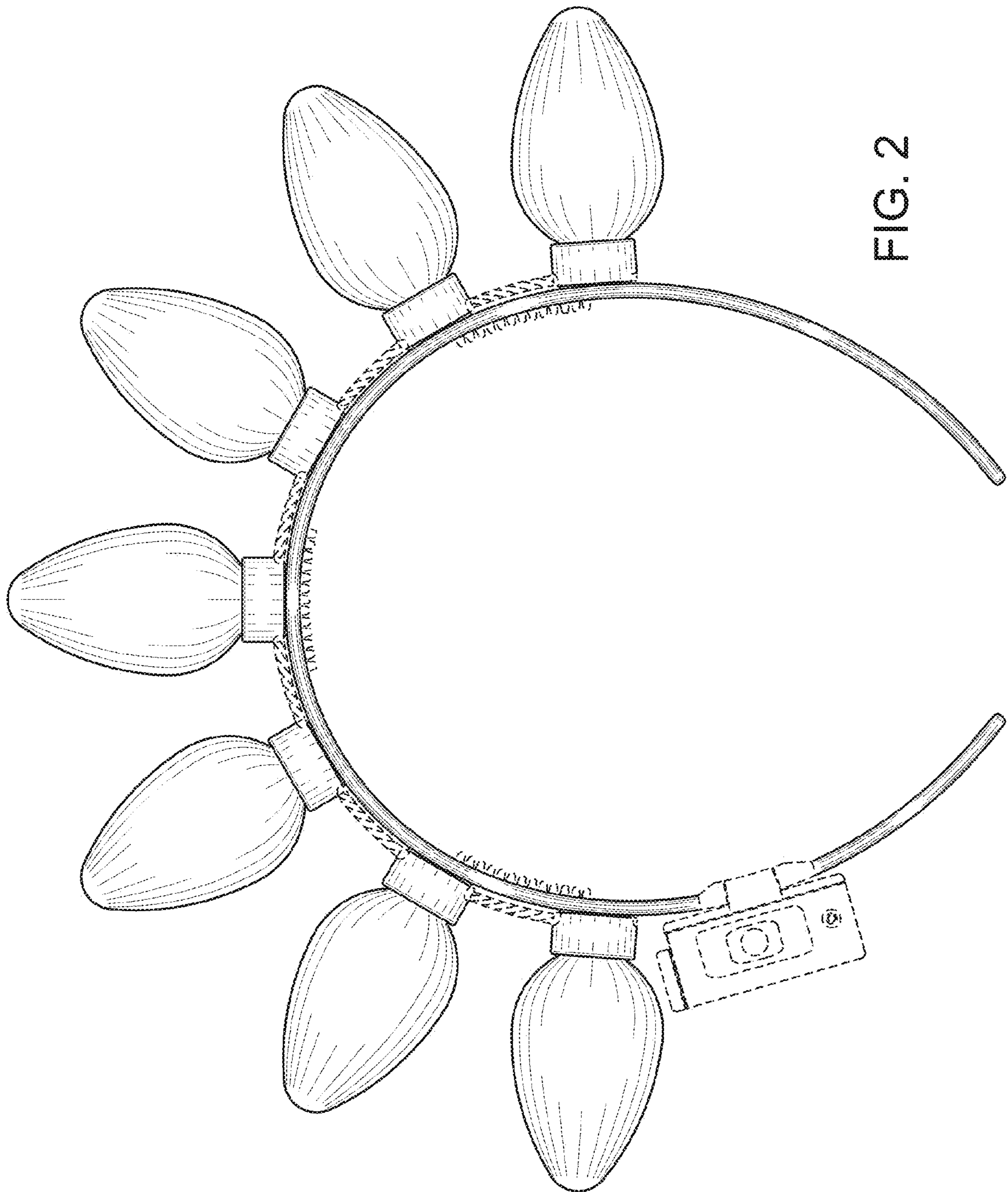

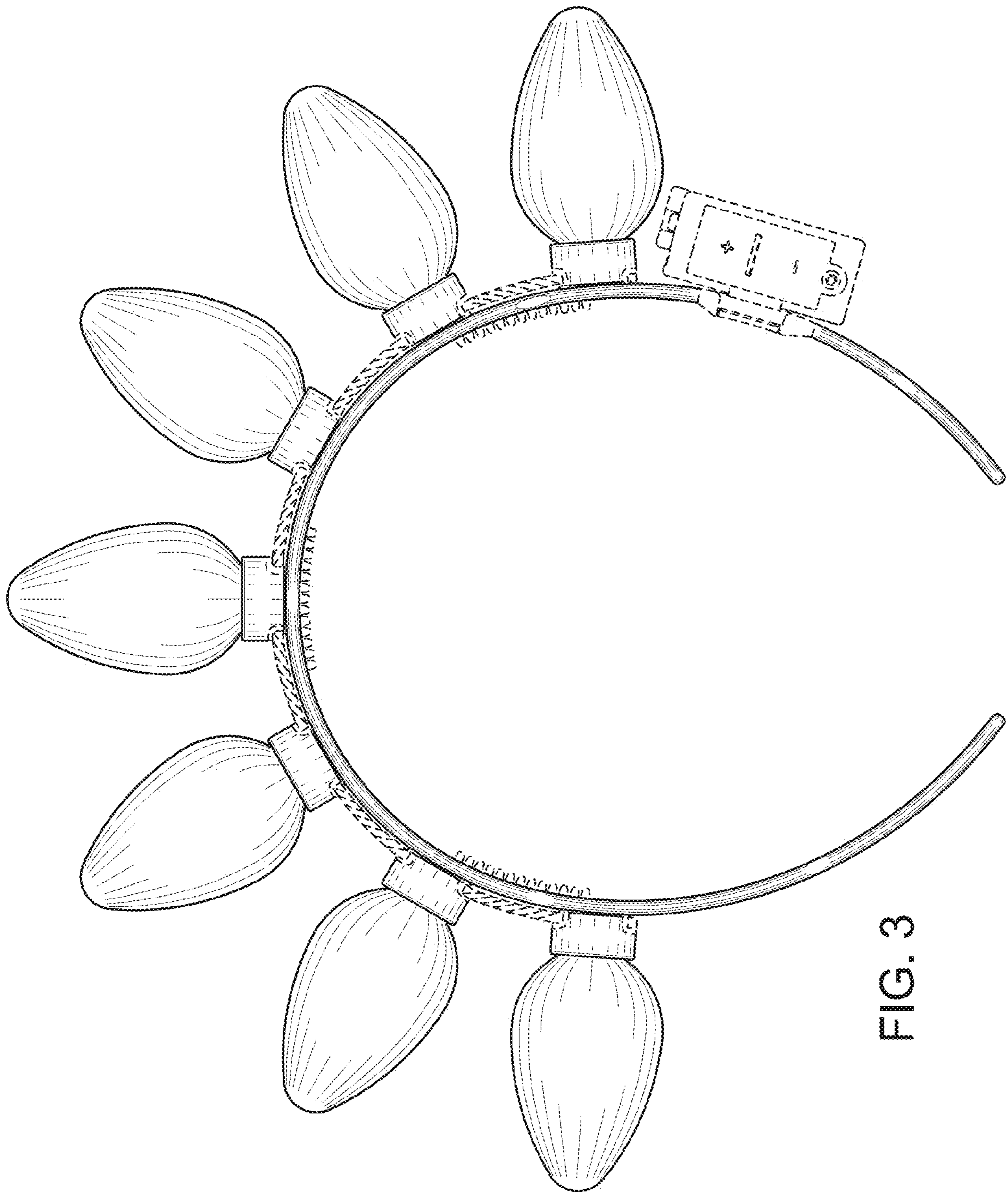

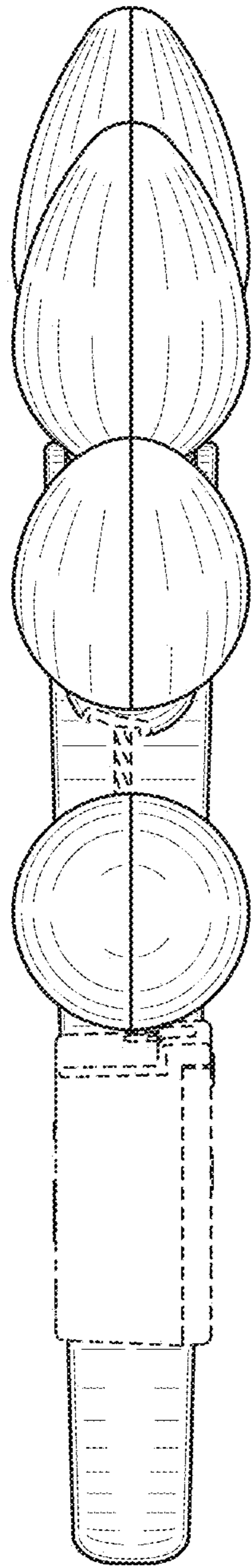

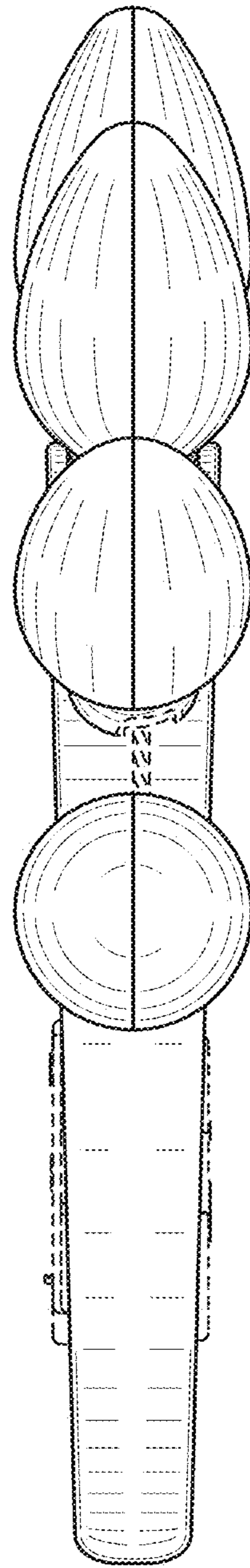

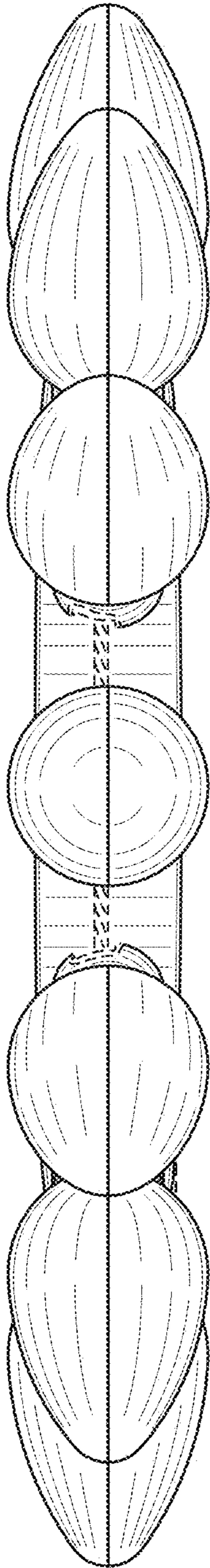

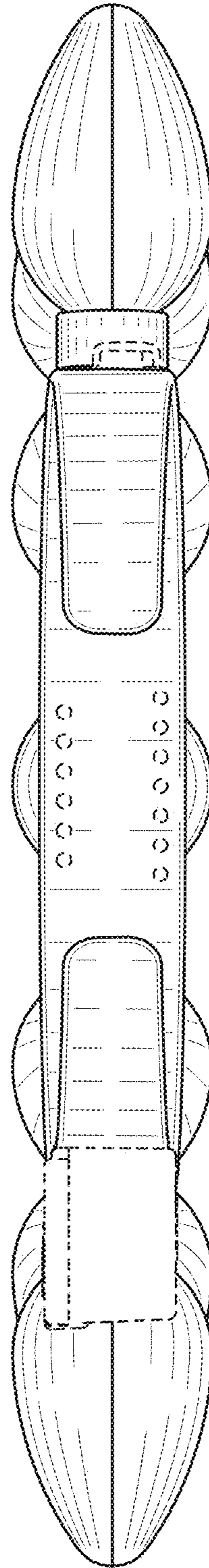
