DESCRIPTION

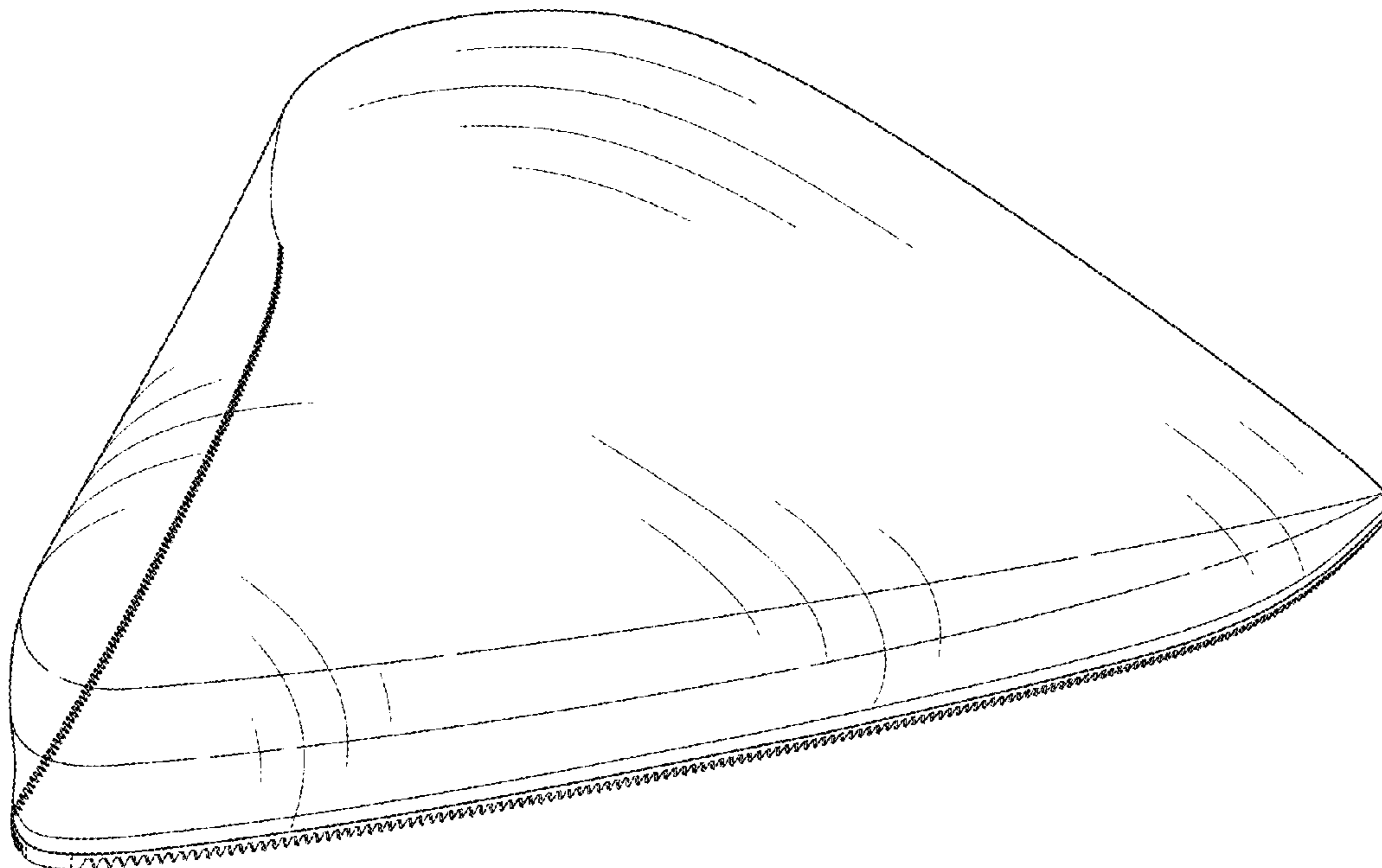
FIG. 1 is a perspective view of the shoe sleeve, showing the new design;
FIG. 2 is a front elevational view of the shoe sleeve thereof;
FIG. 3 is a rear elevational view of the shoe sleeve thereof;
FIG. 4 is a left side elevational view of the shoe sleeve thereof;
FIG. 5 is a top plan view of the shoe sleeve thereof; and,
FIG. 6 is a bottom plan view of the shoe sleeve thereof.
The right side elevational view of the shoe is a mirror image of the left side elevational view of the shoe sleeve shown in FIG. 4.

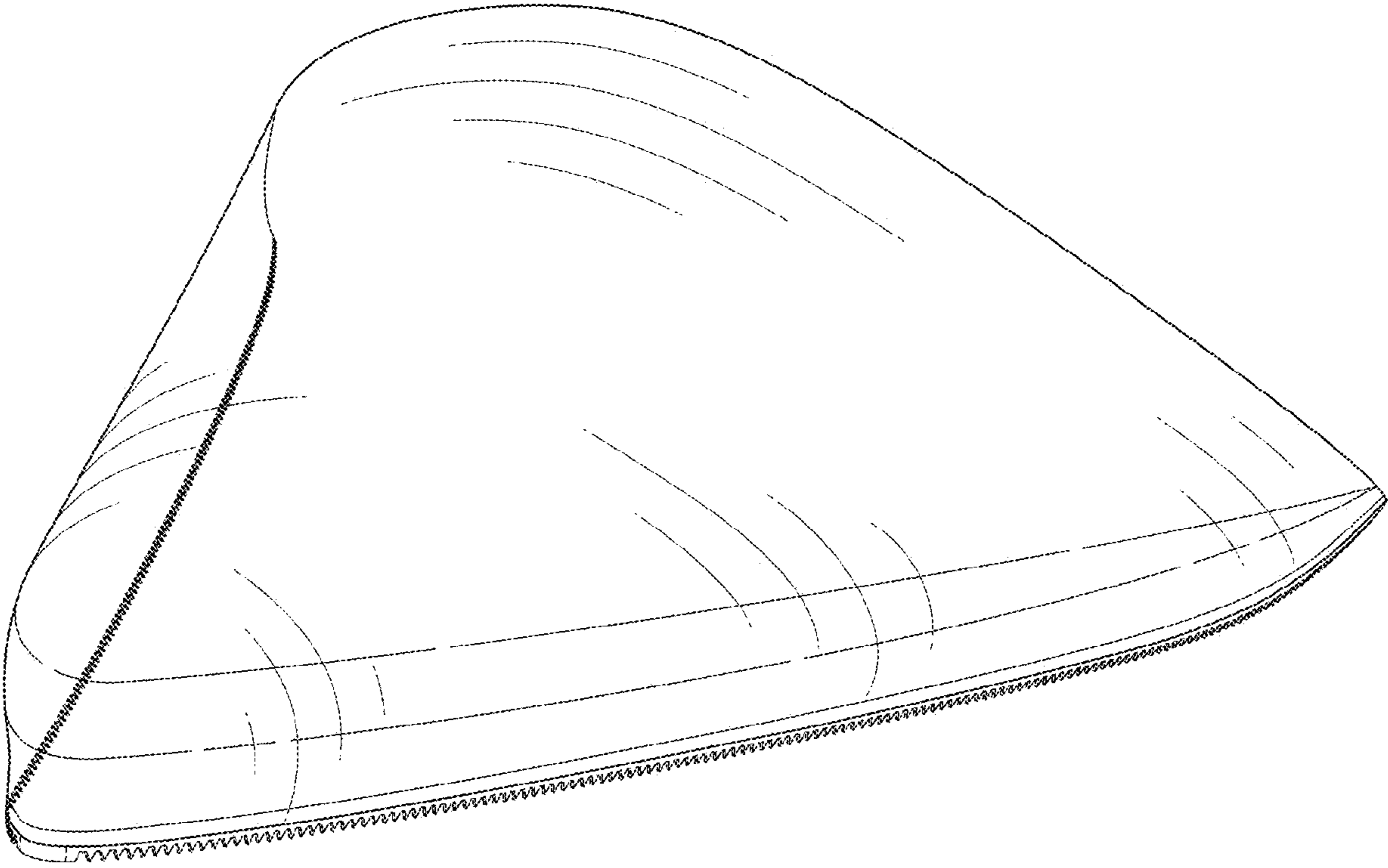

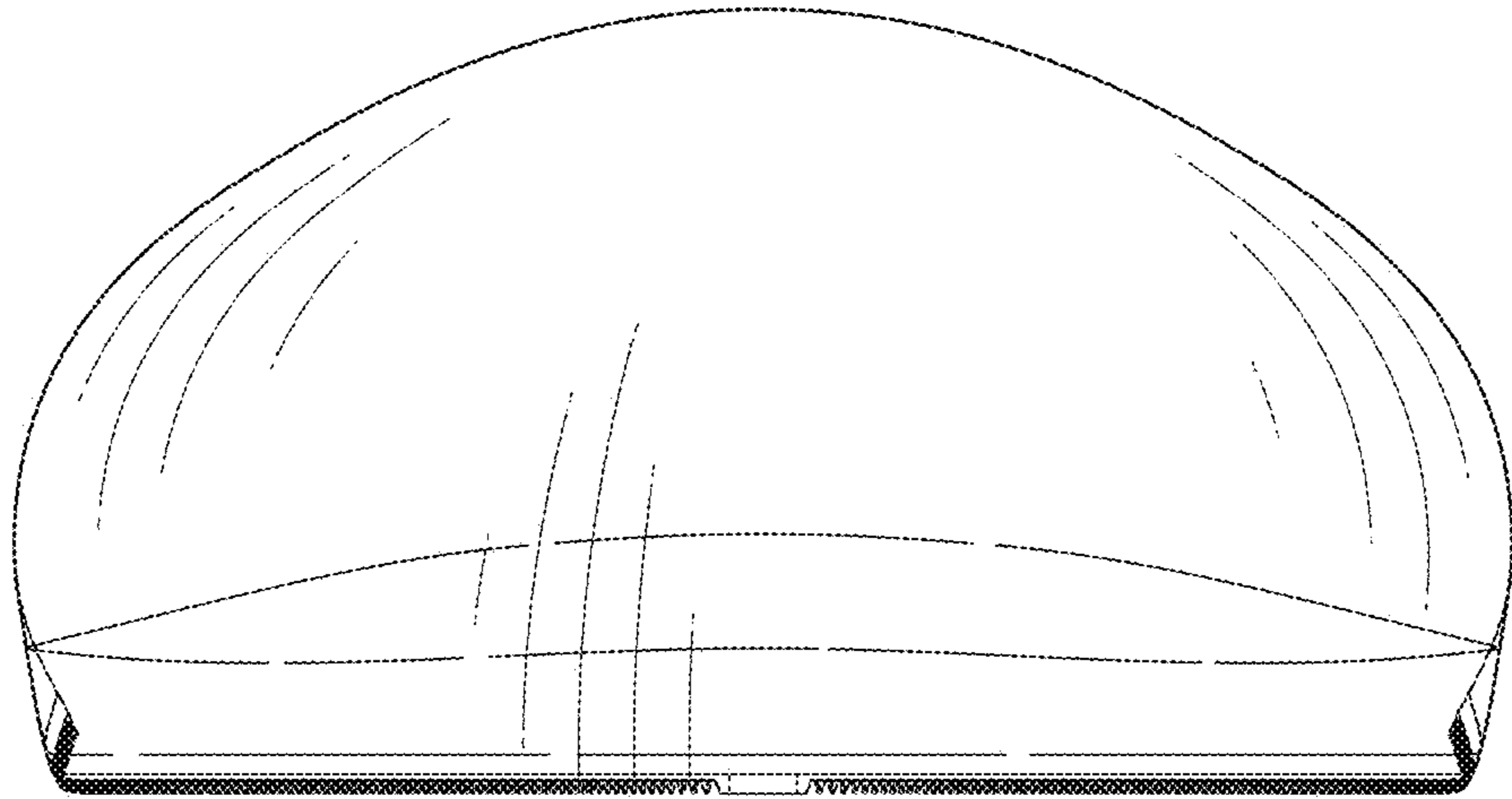

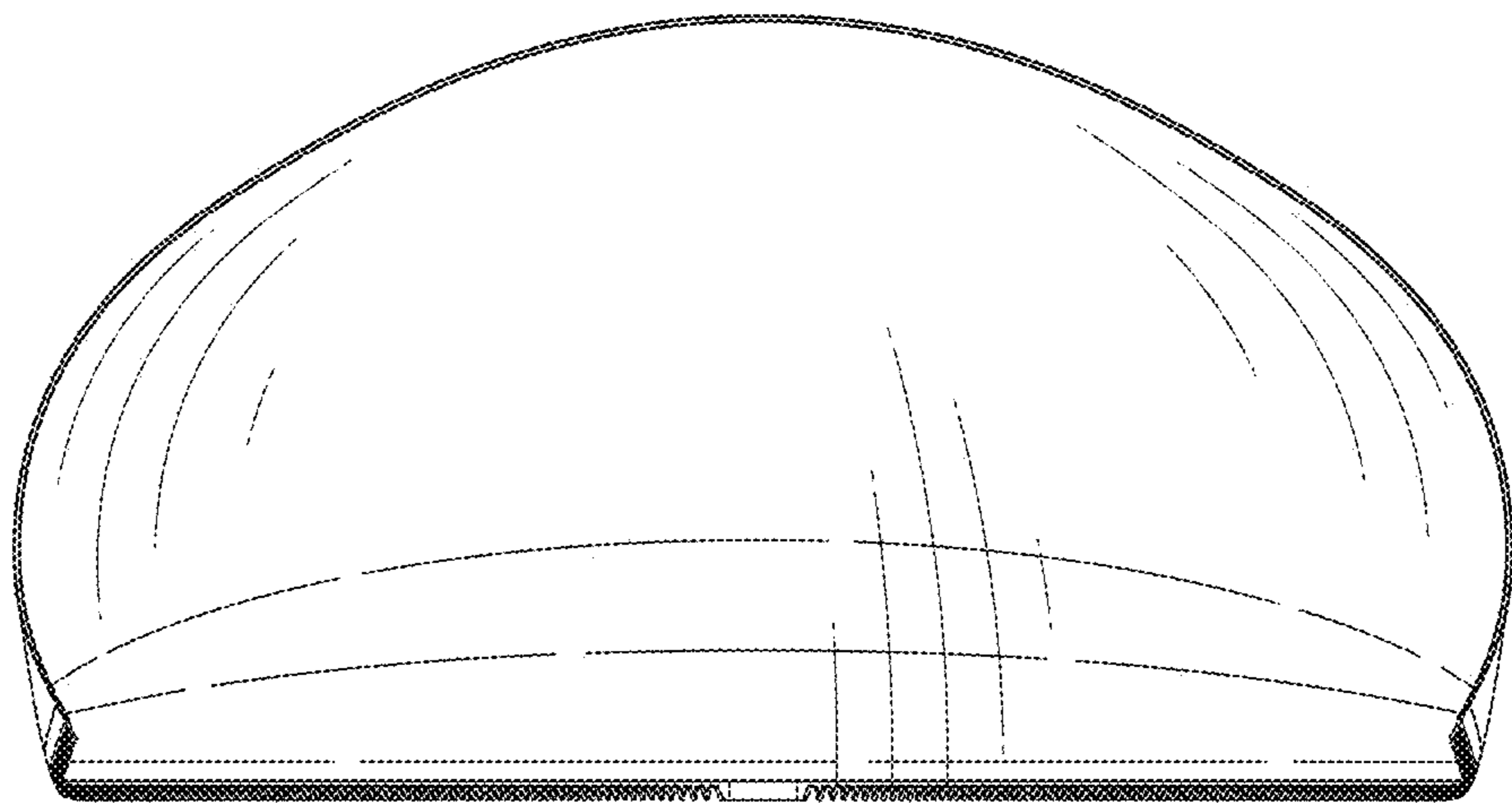

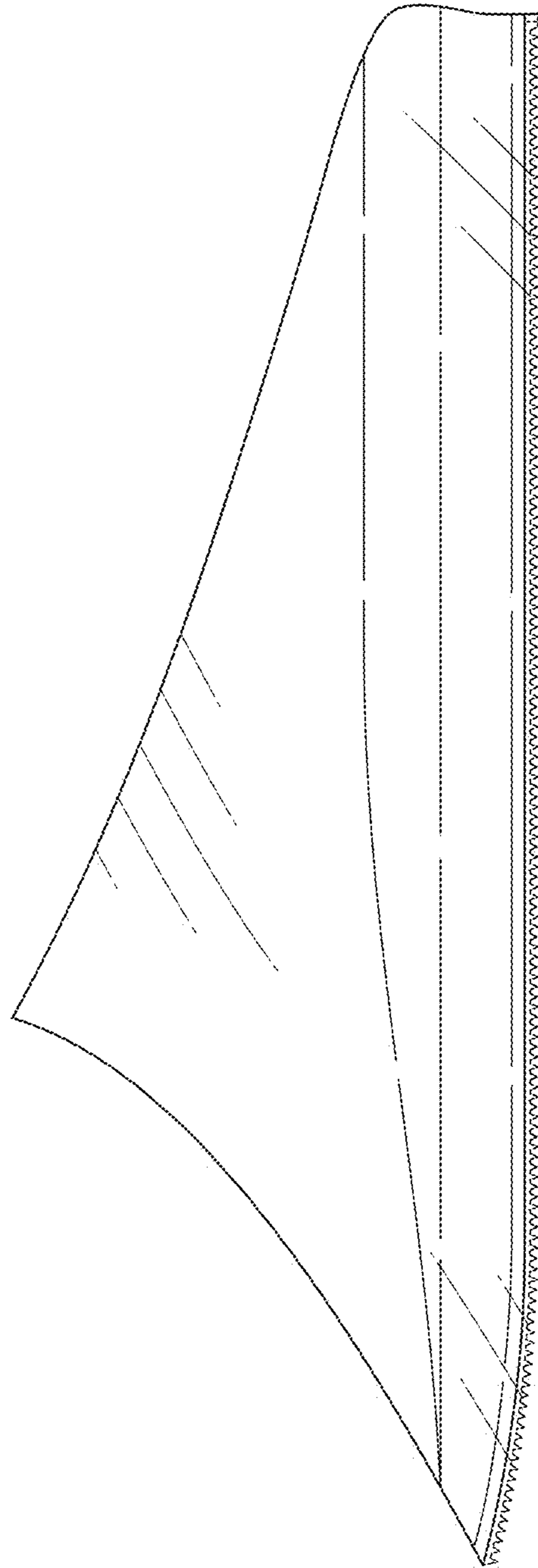

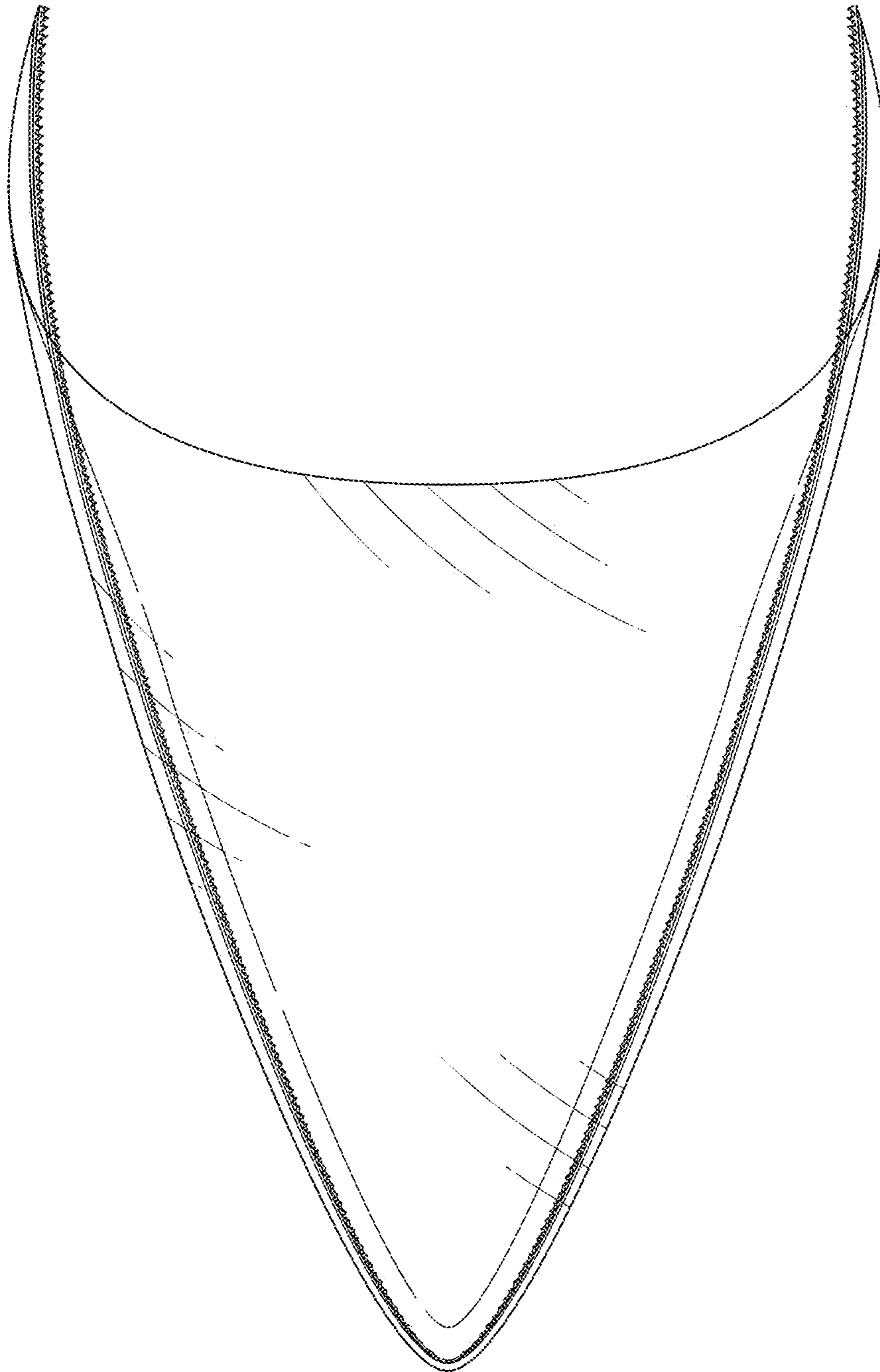

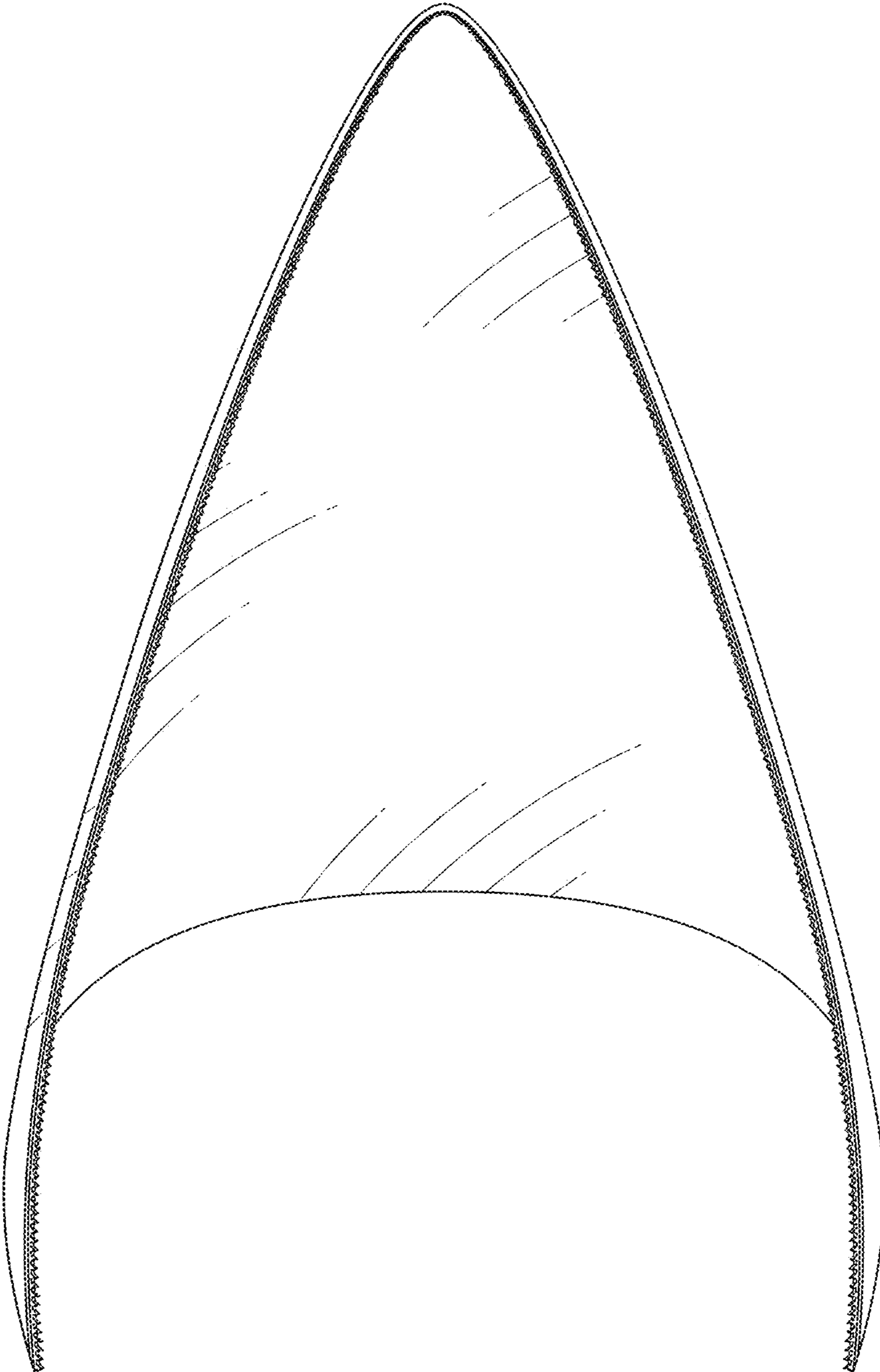
