DESCRIPTION

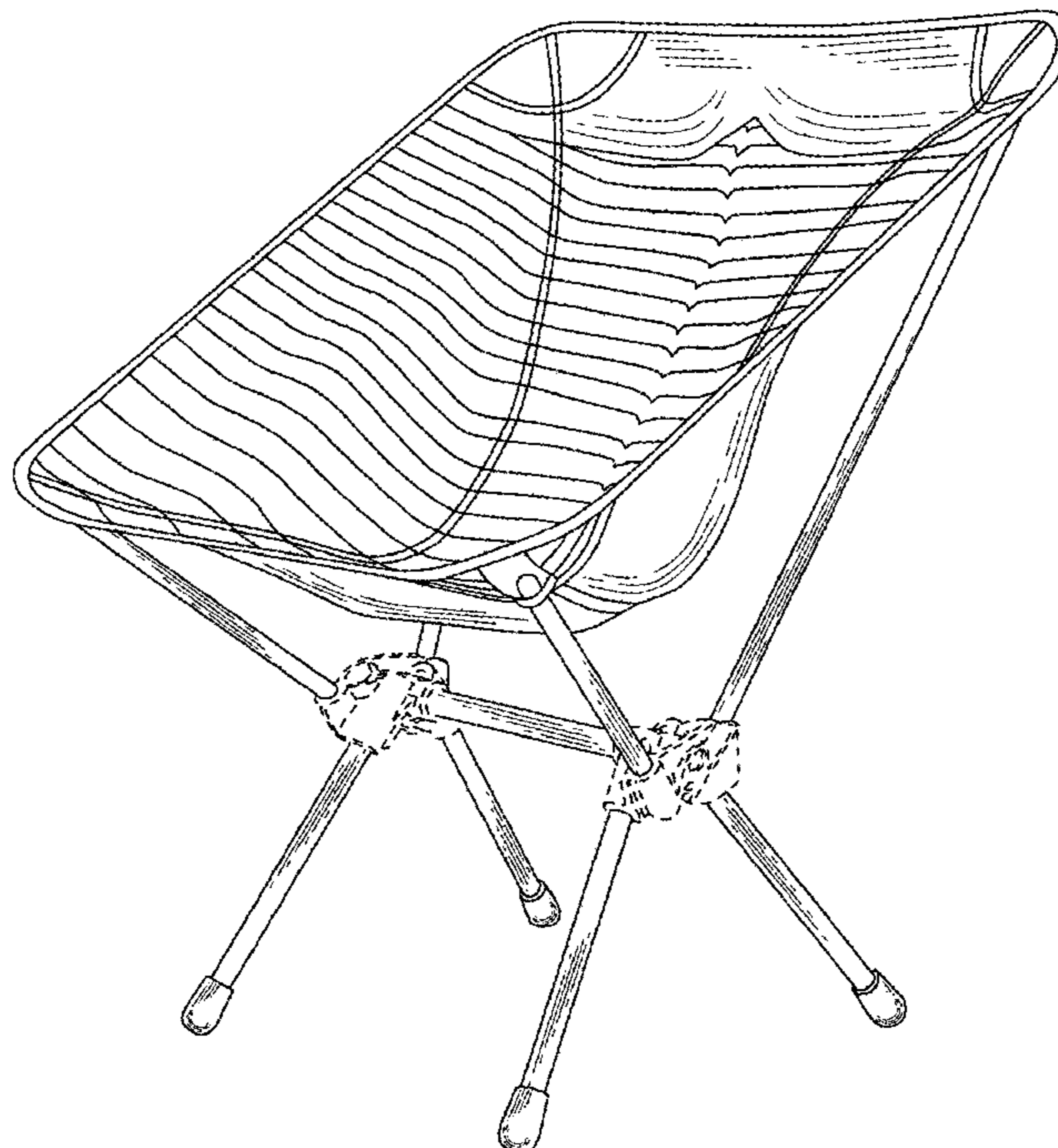
FIG. 1 is a front elevational view of a folding chair showing my new design;

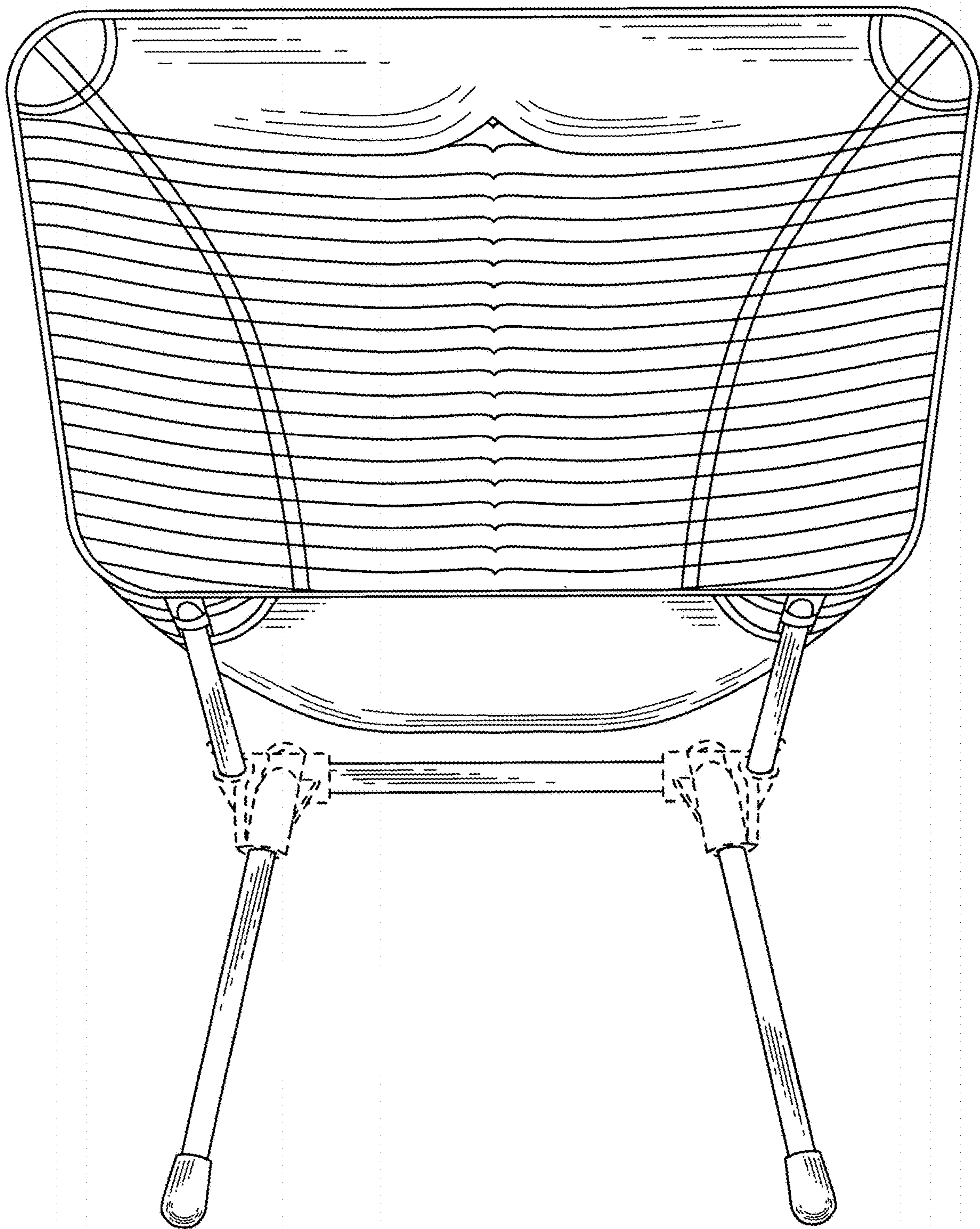

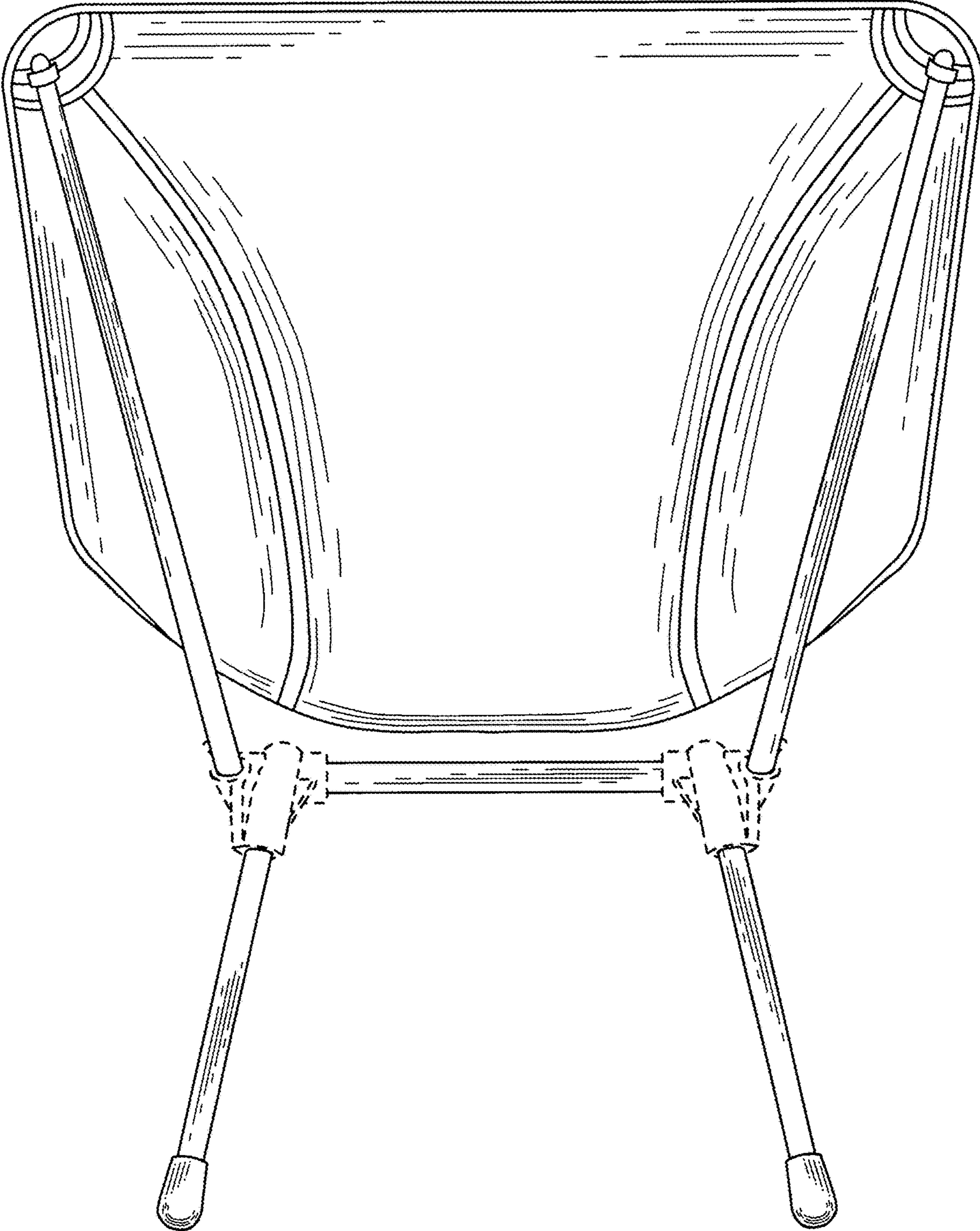

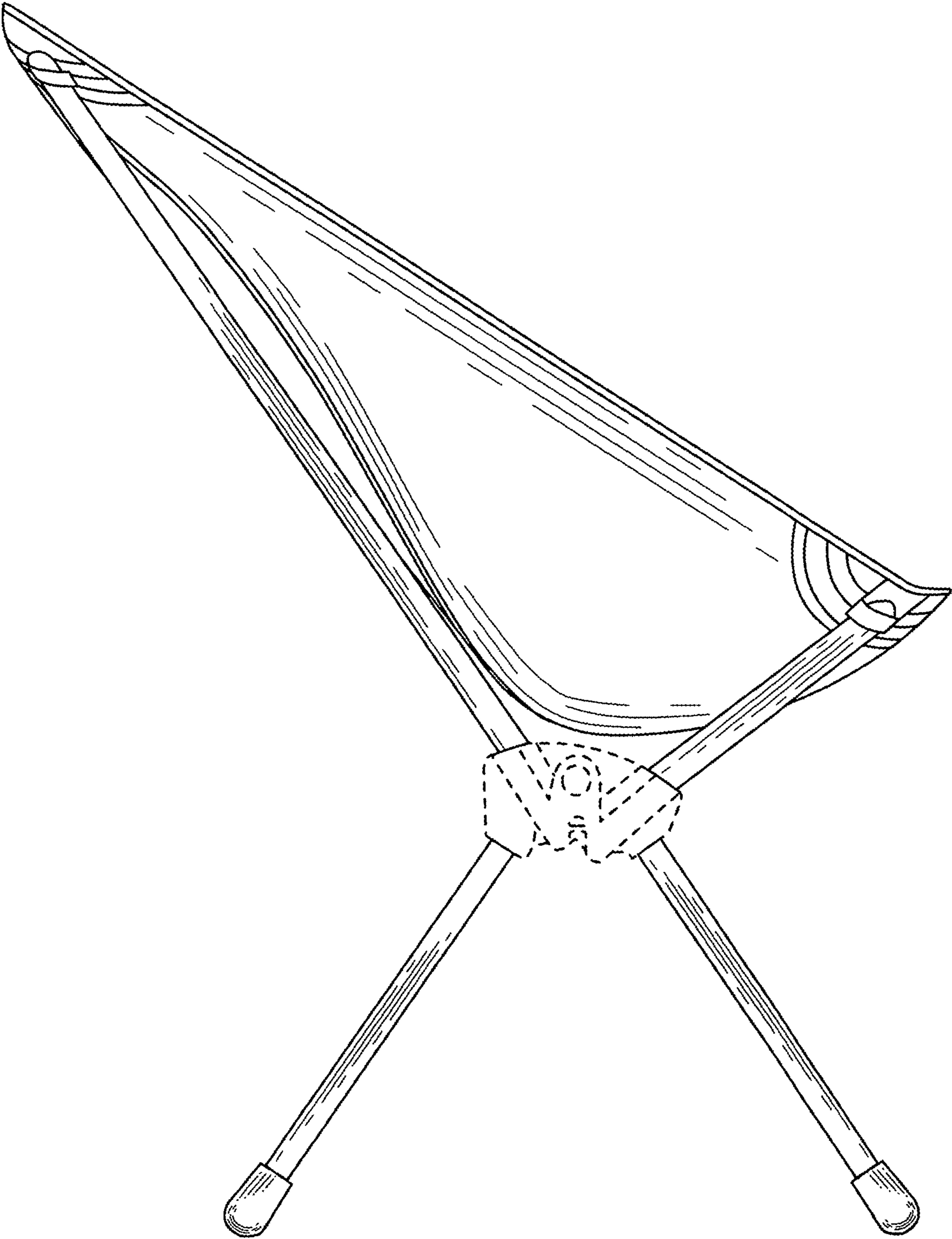

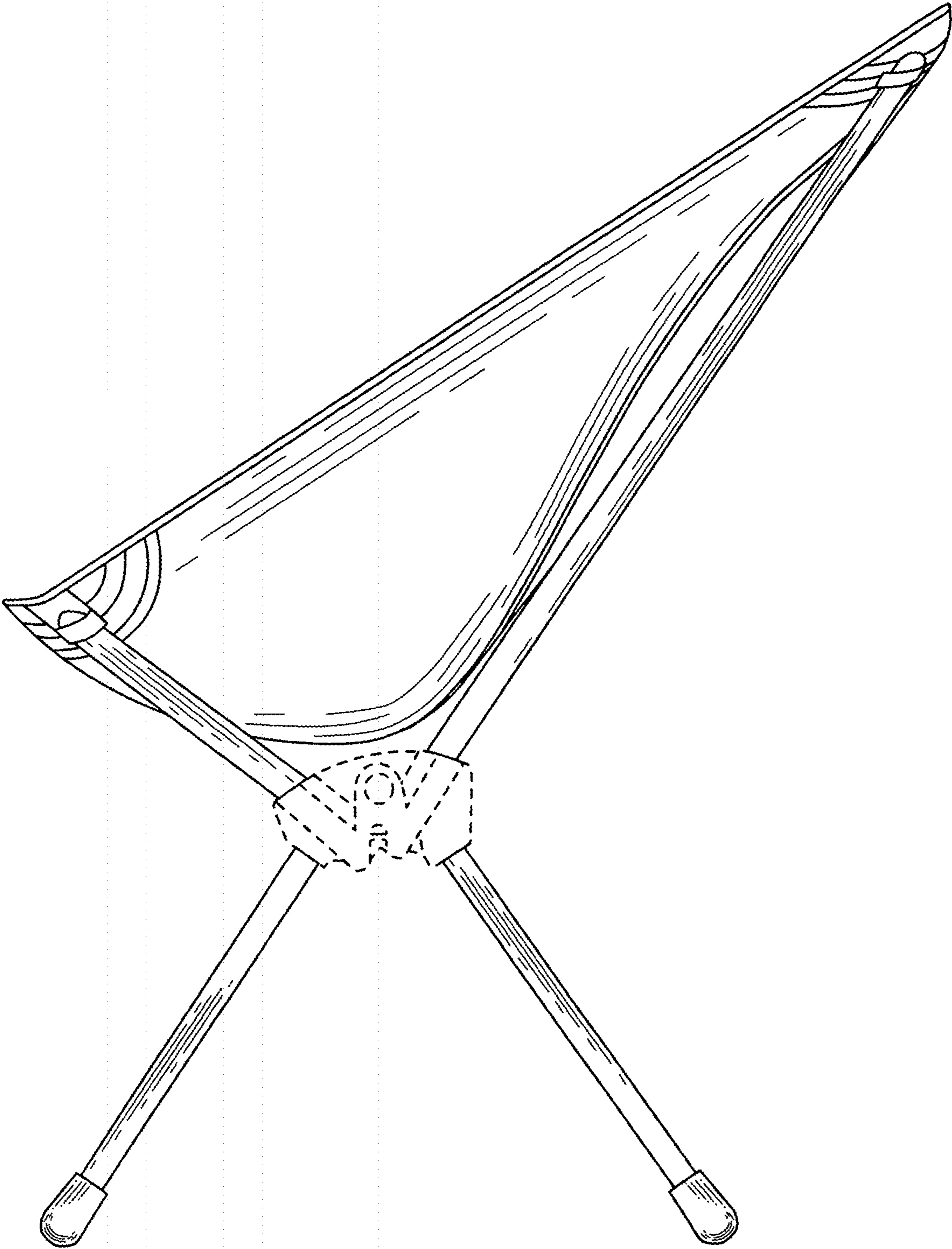

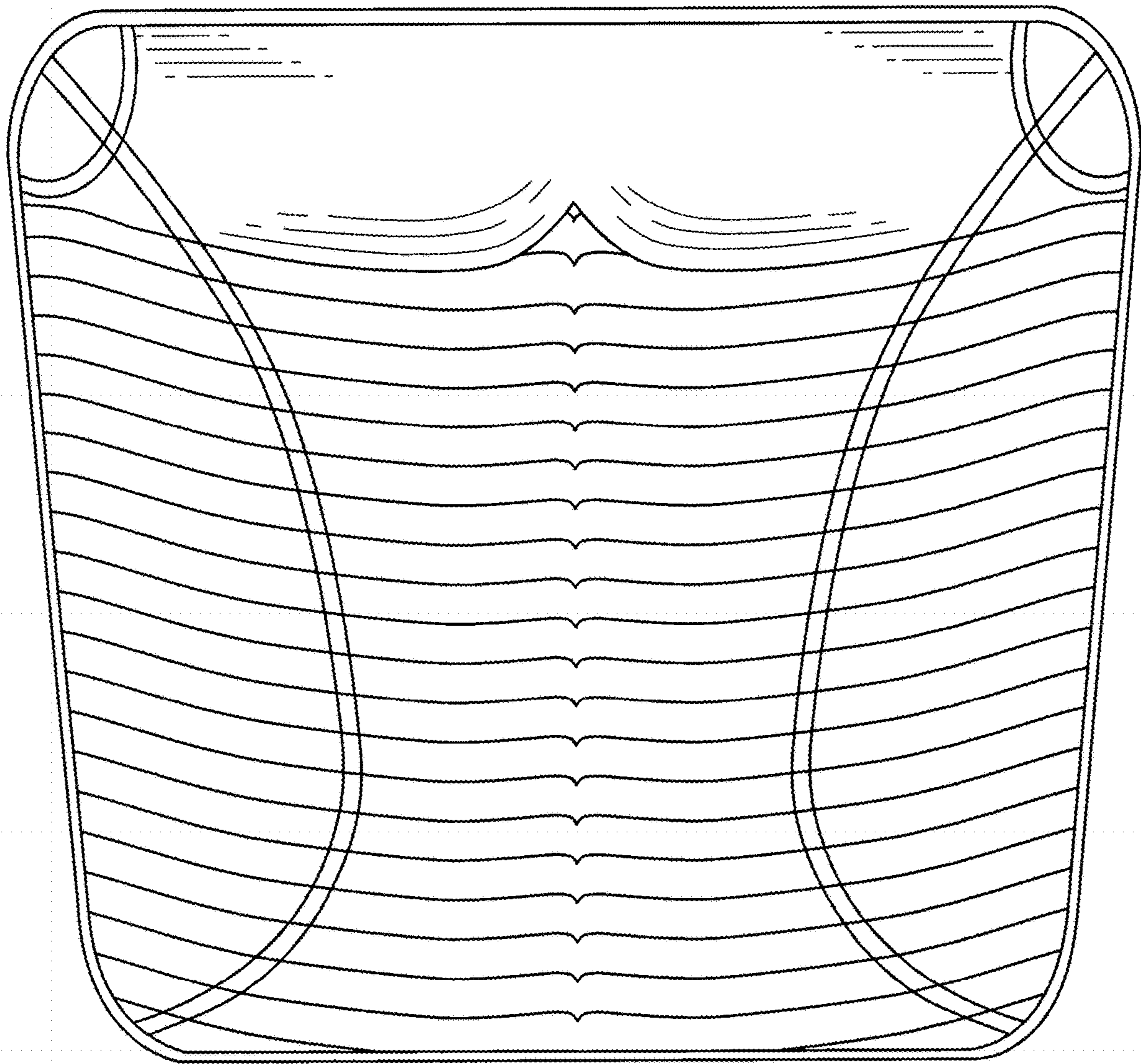

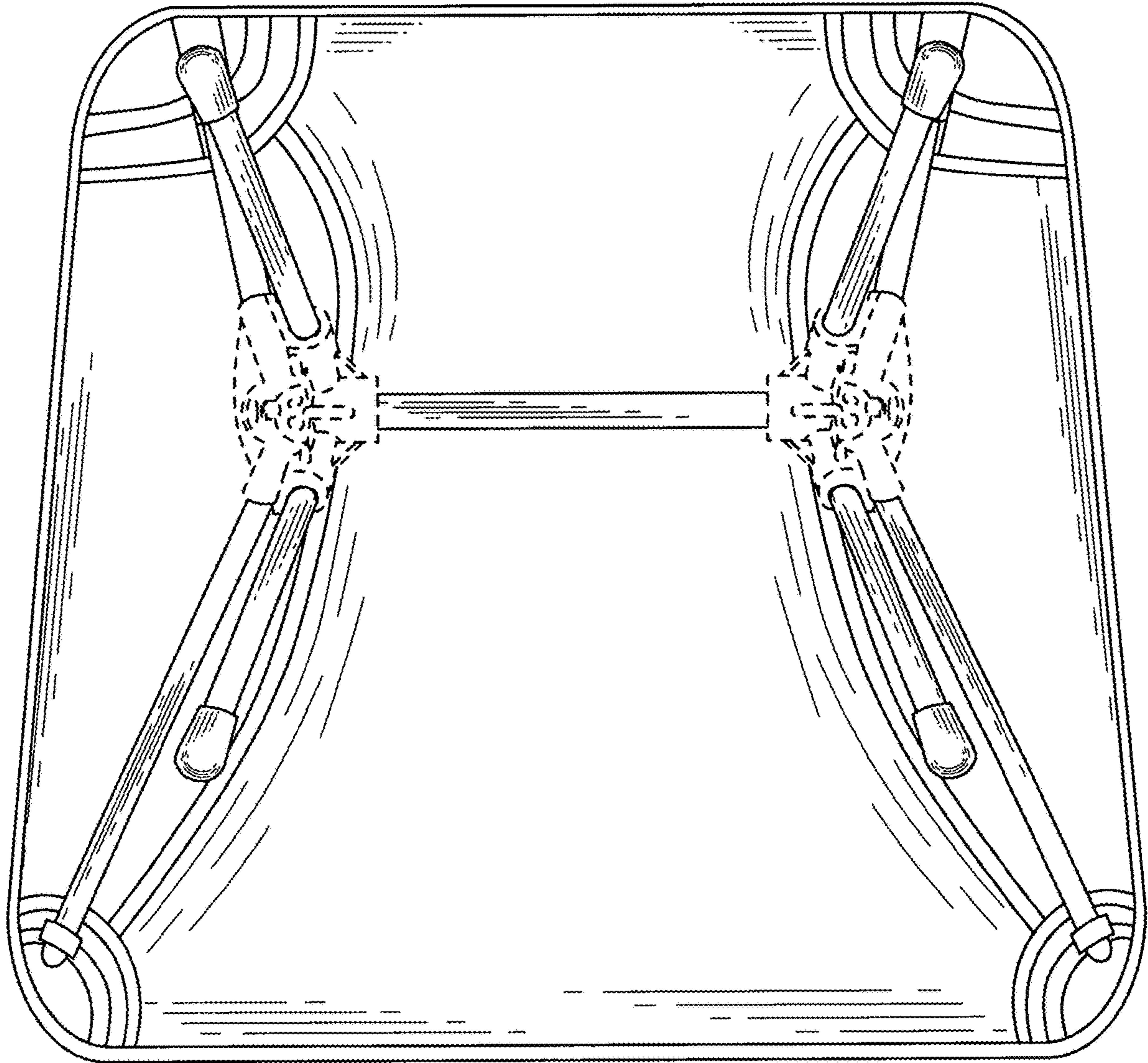
