(57) **CLAIM**

The ornamental design for a flatware handle, as shown and
described.

DESCRIPTION

FIG. 1 is a front view of a flatware handle showing my new
design;

FIG. 2 is a right side view of the flatware handle illustrated
in FIG. 1, where the left side view is a mirror image thereof;
FIG. 3 is a rear view of the flatware handle illustrated in FIG.
1;

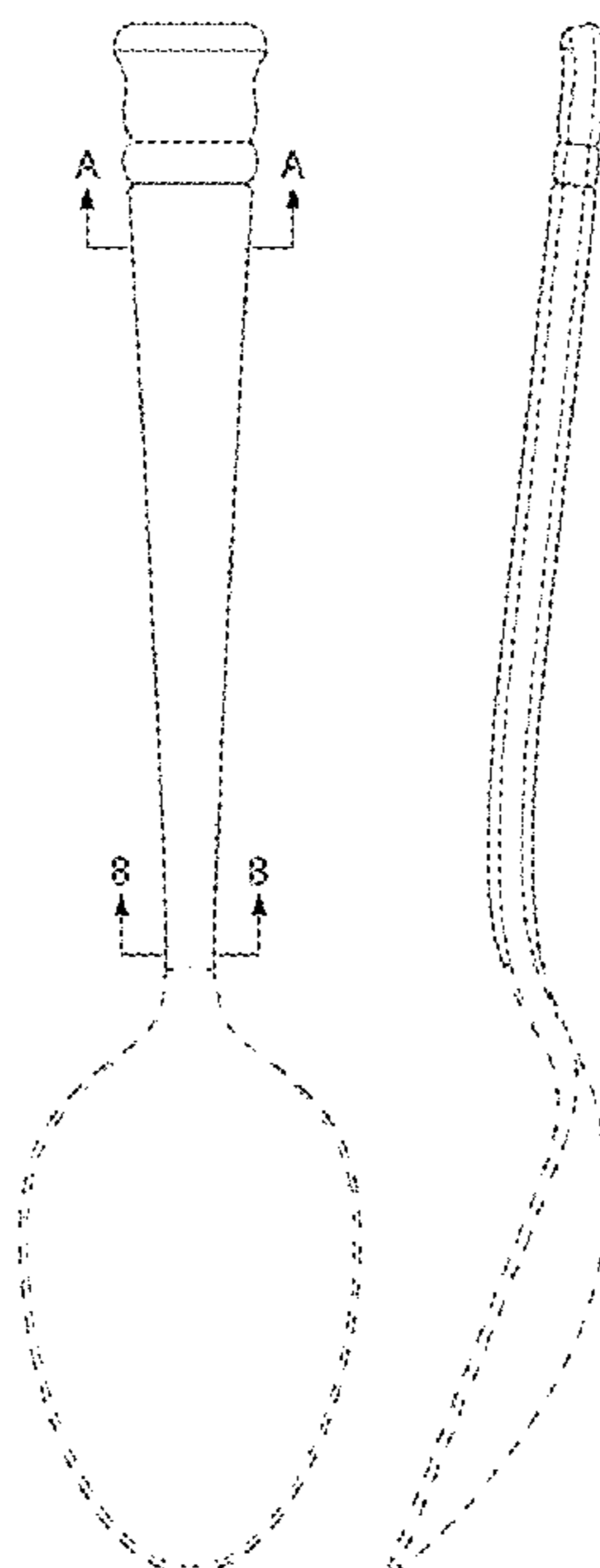
FIG. 4 is a cross-sectional view of the flatware handle taken
about line A-A illustrated in FIG. 1; and,

FIG. 5 is a cross-sectional view of the flatware handle taken
about line B-B illustrated in FIG. 1.

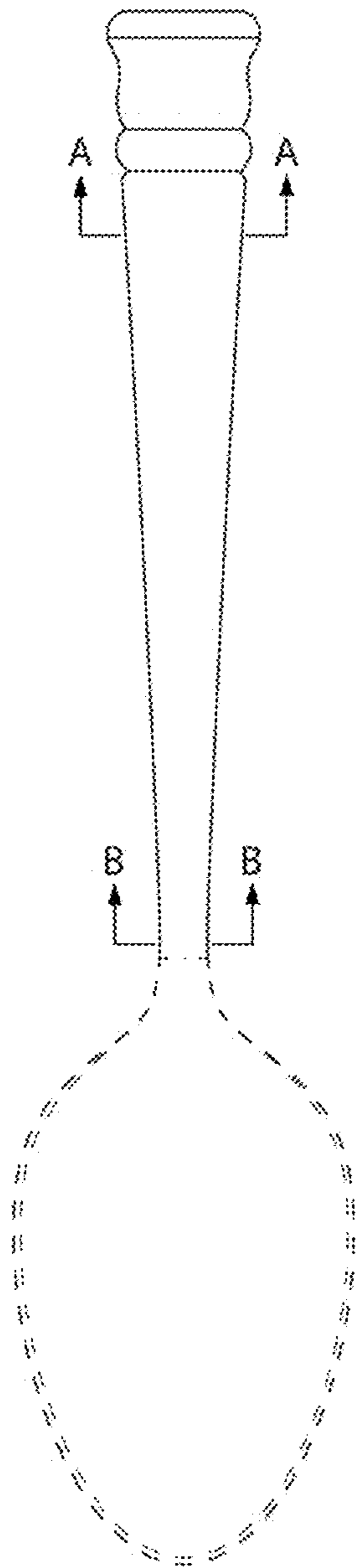

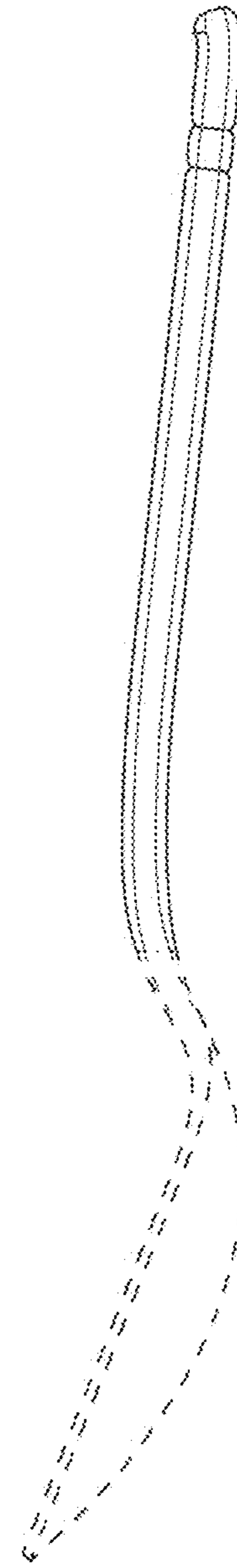

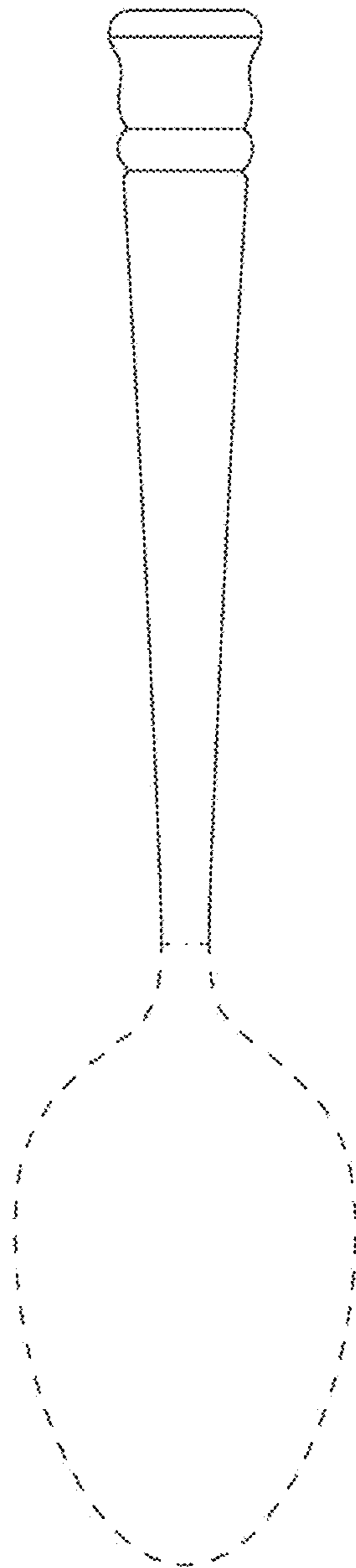
