DESCRIPTION

FIG. 14 is a bottom view of FIG. 8.

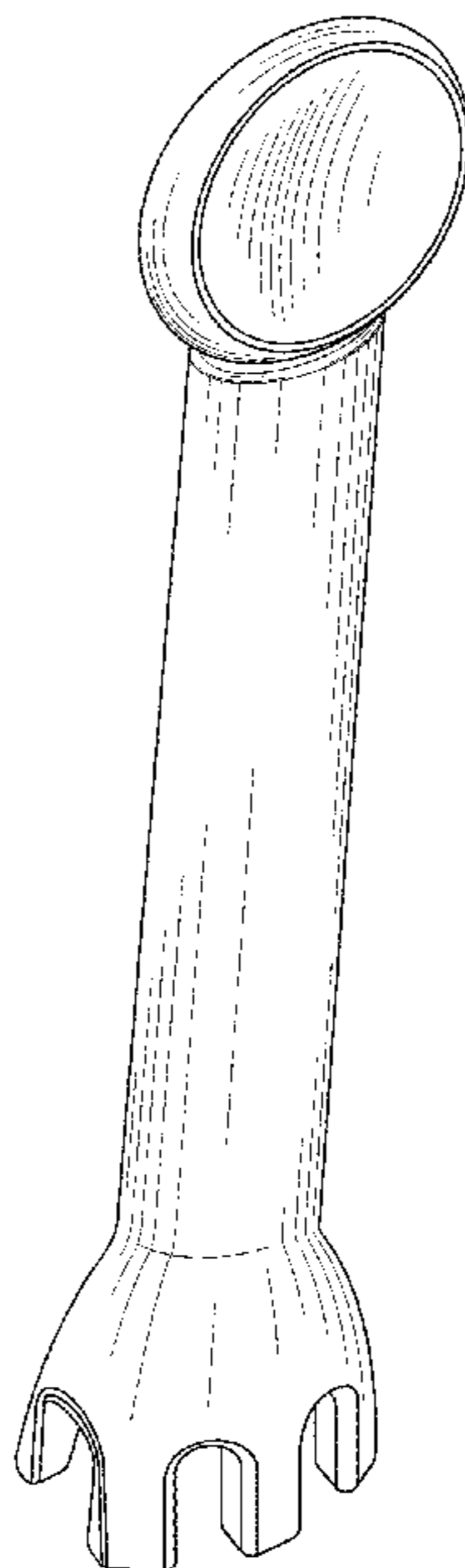

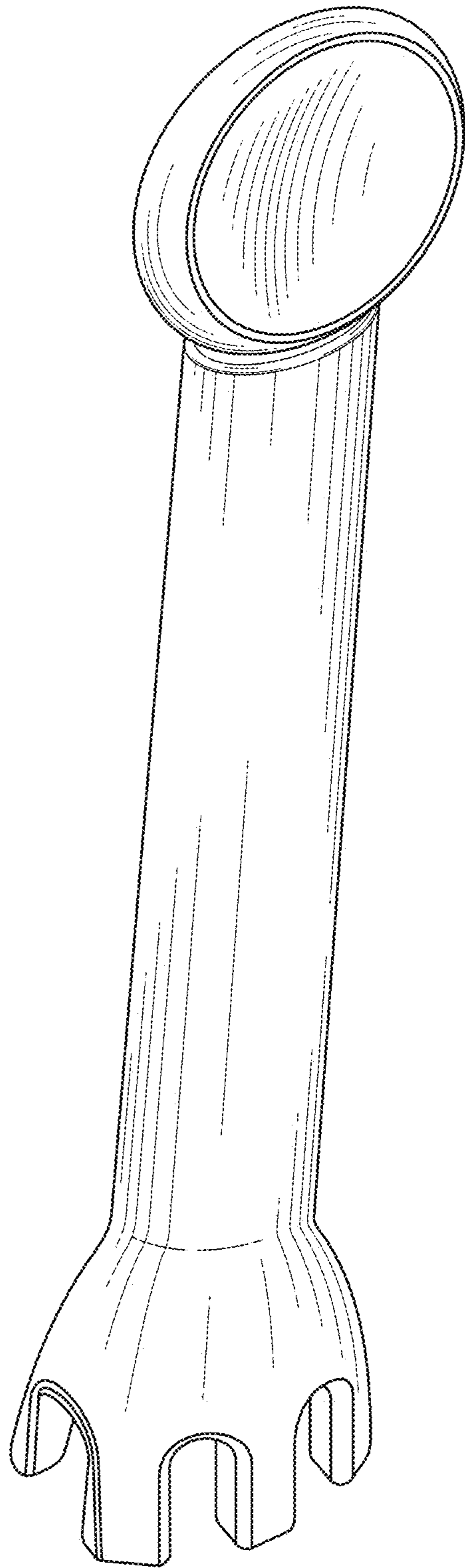

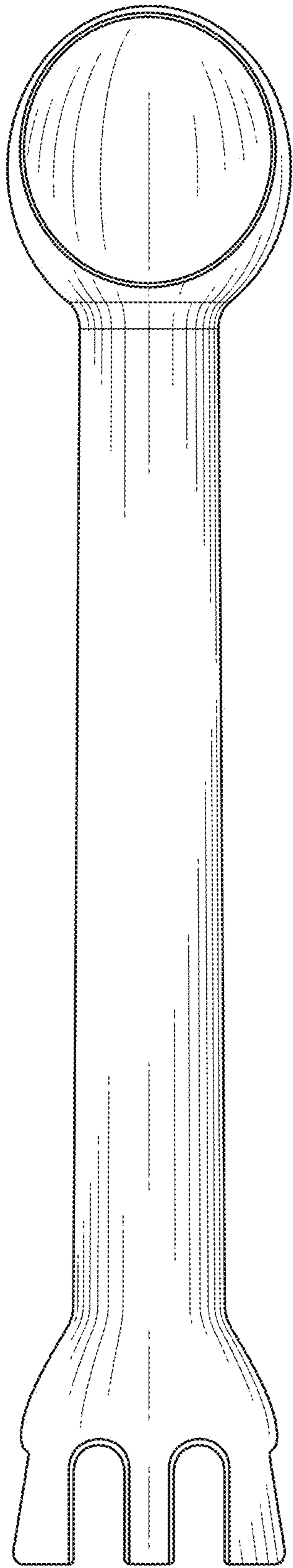

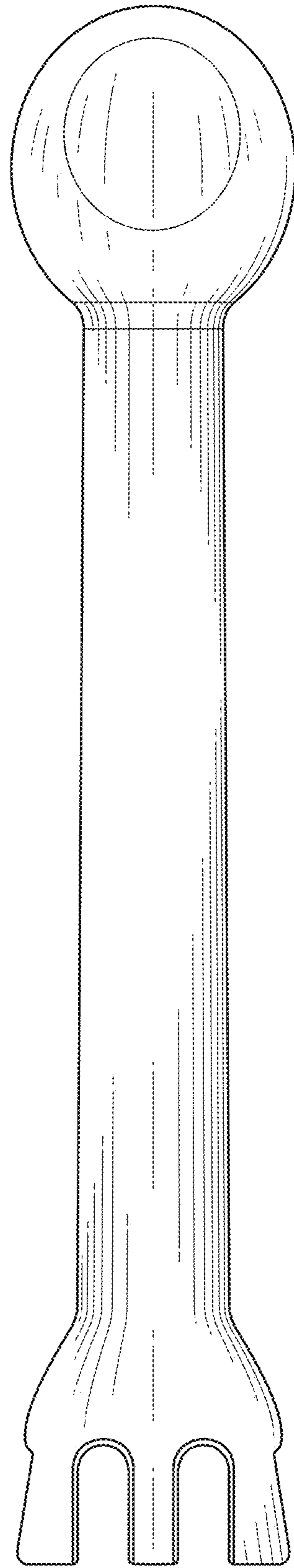

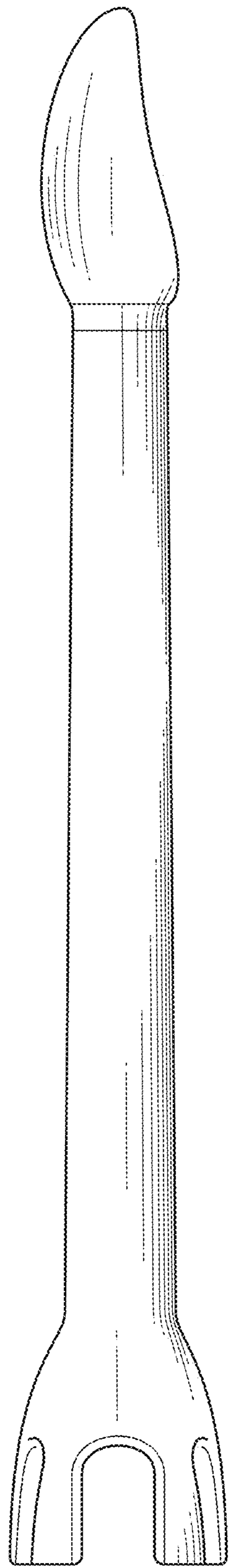

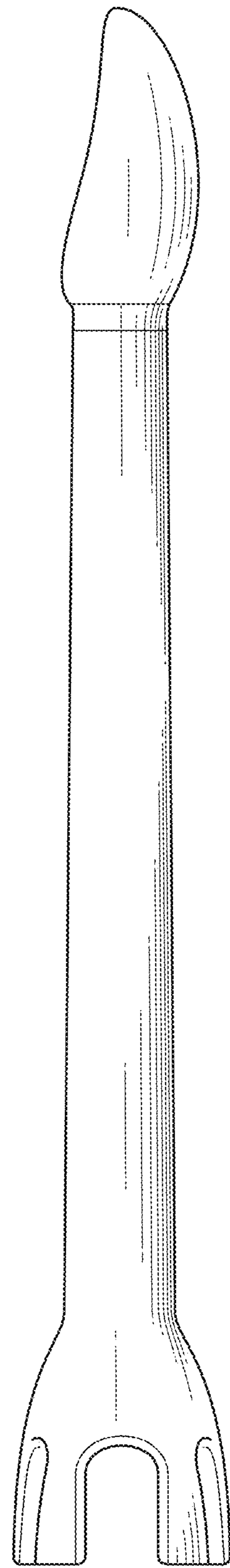

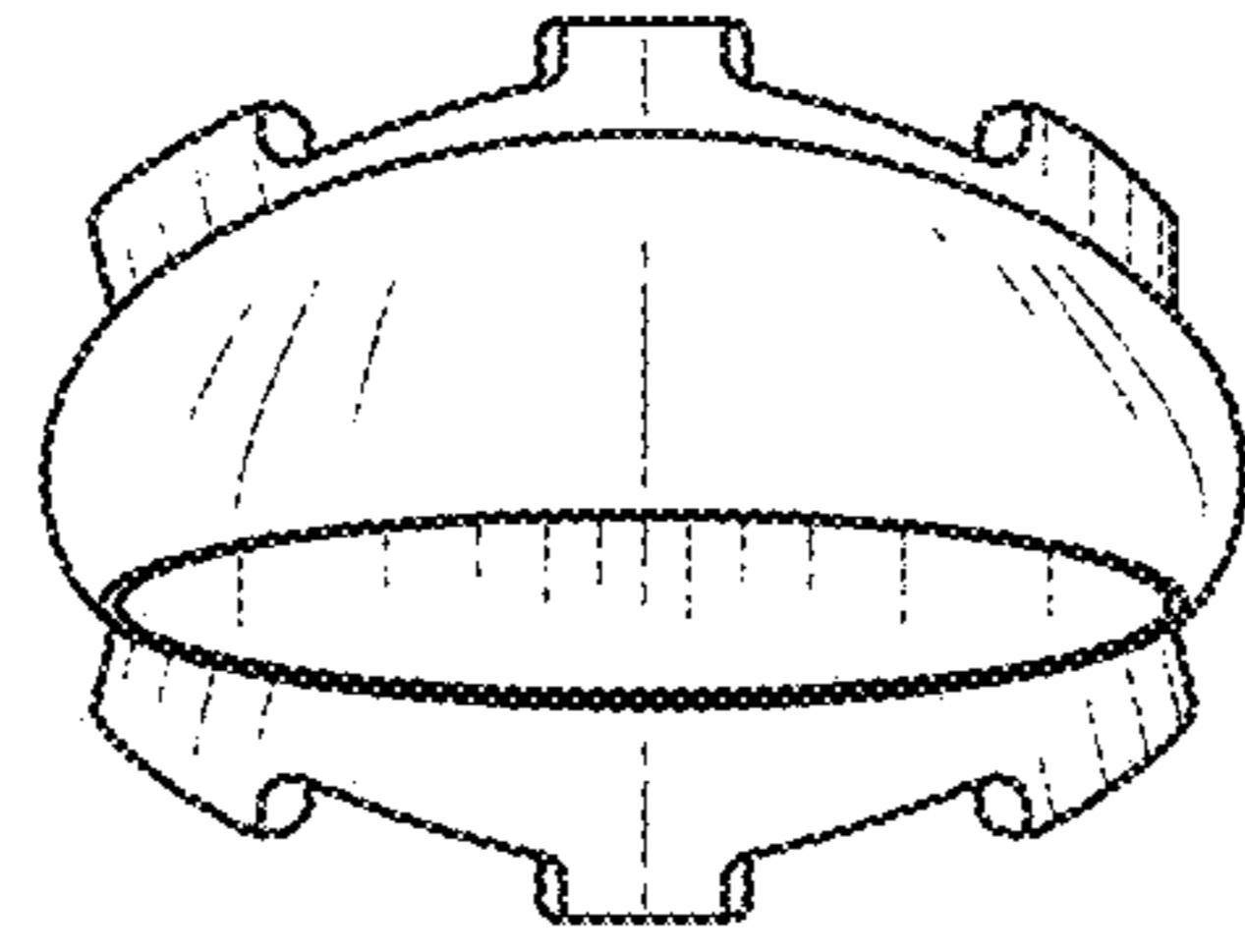

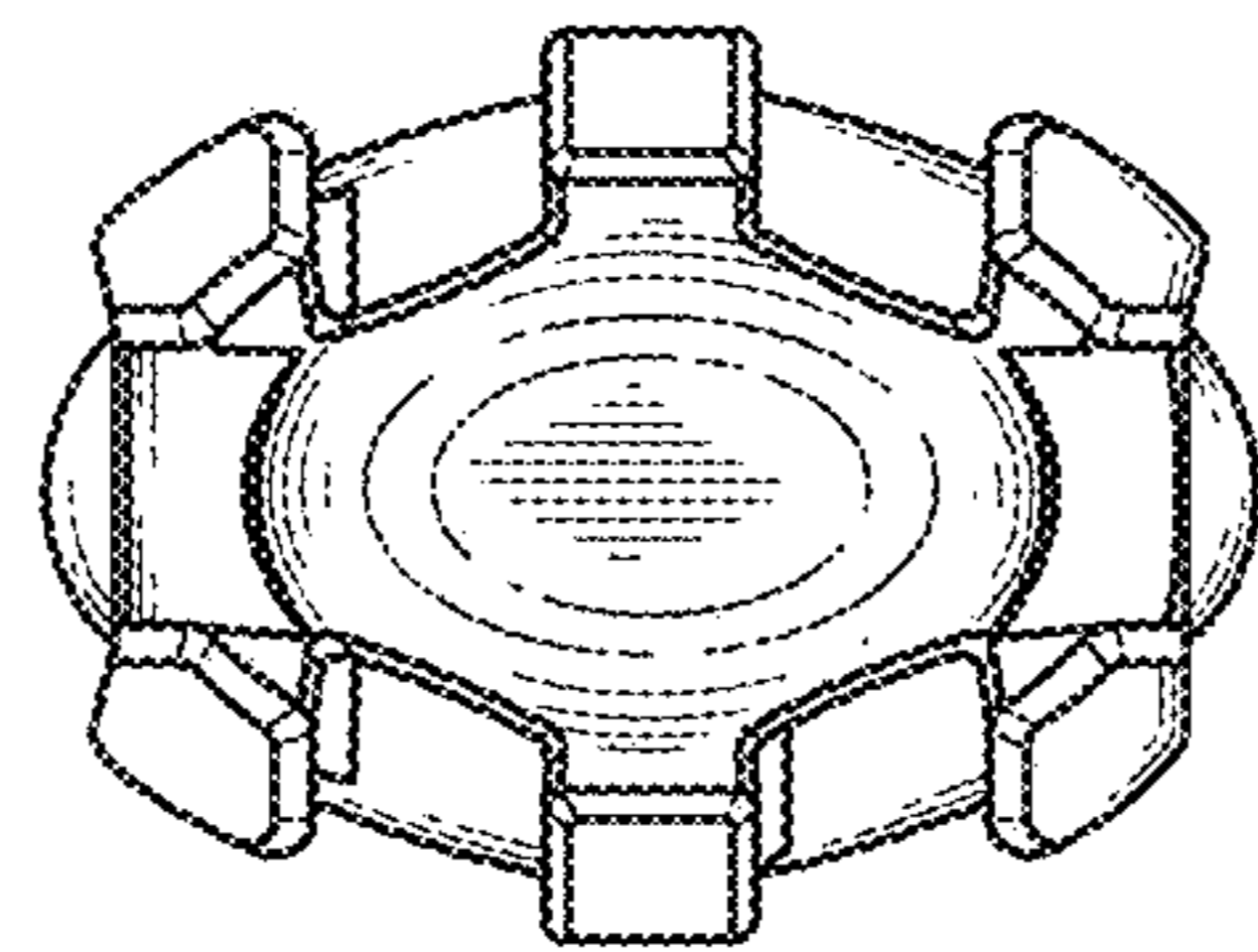

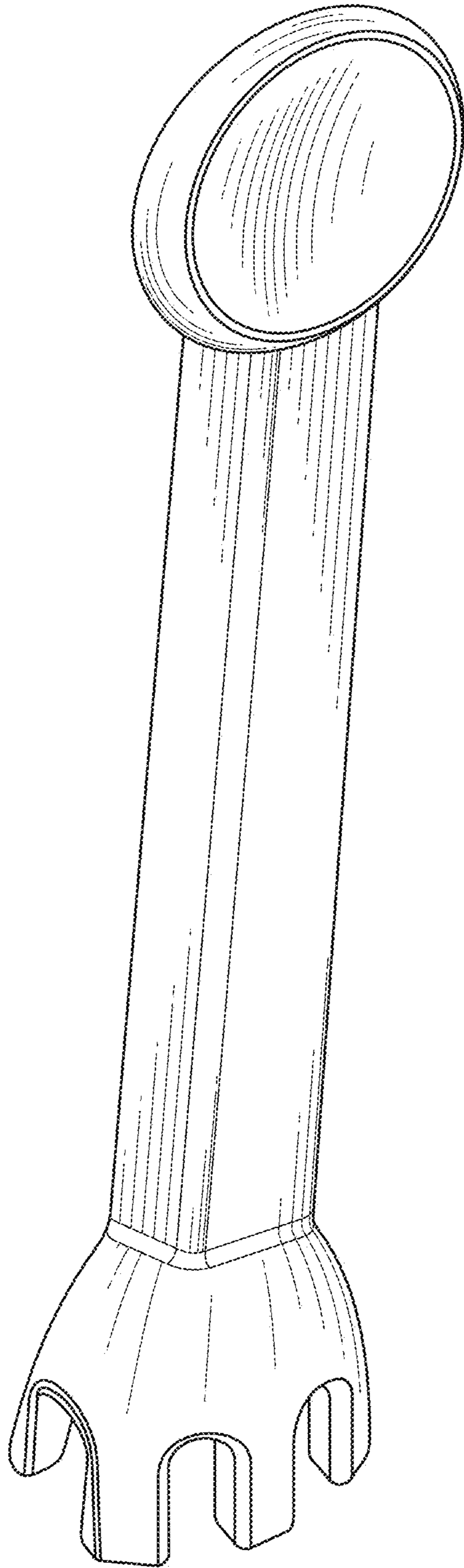

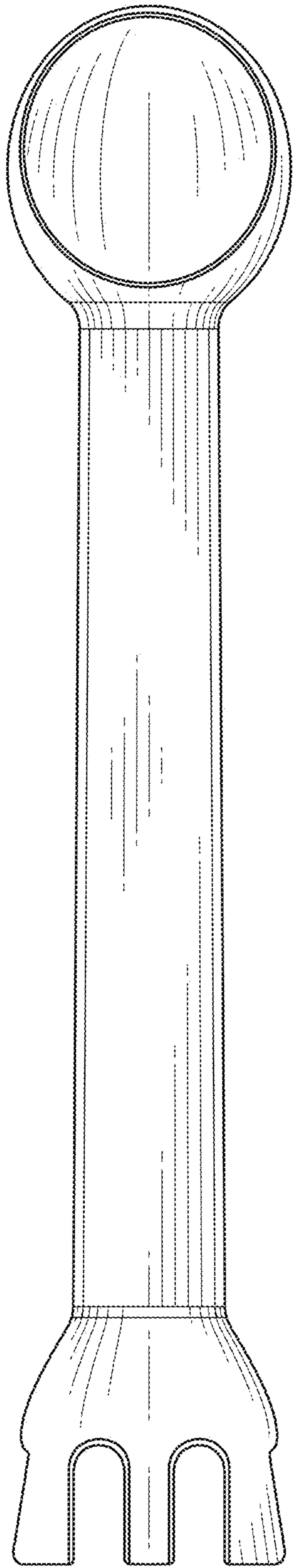

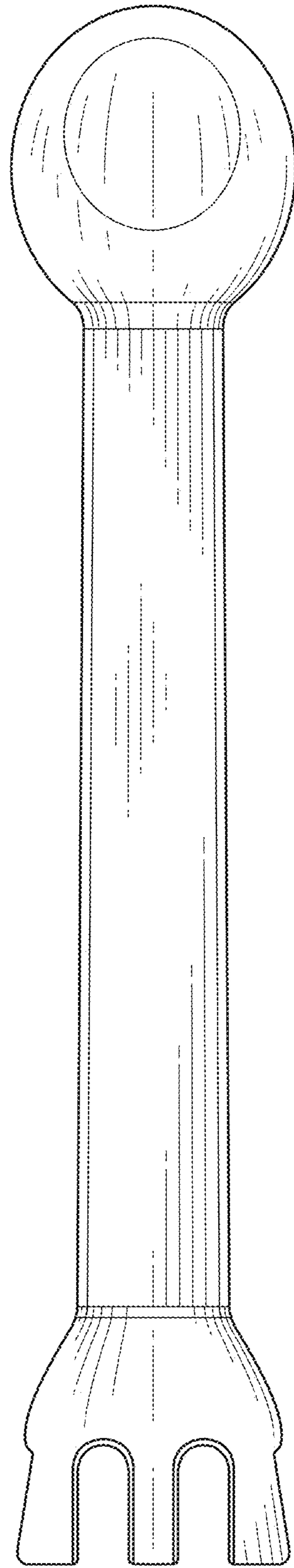

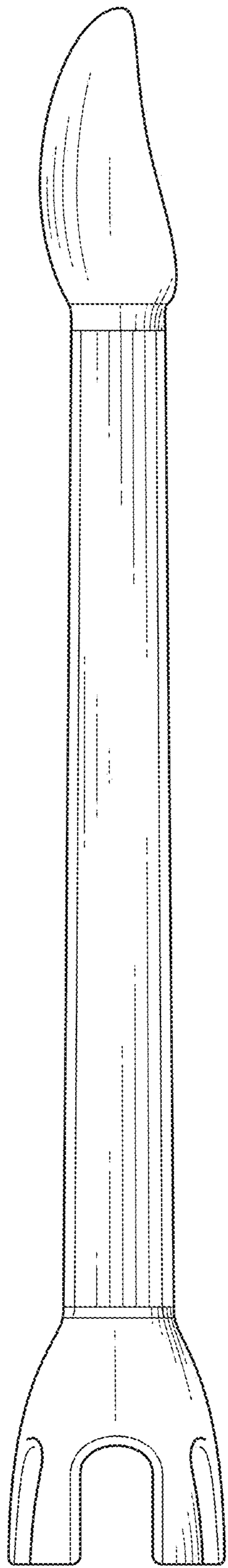

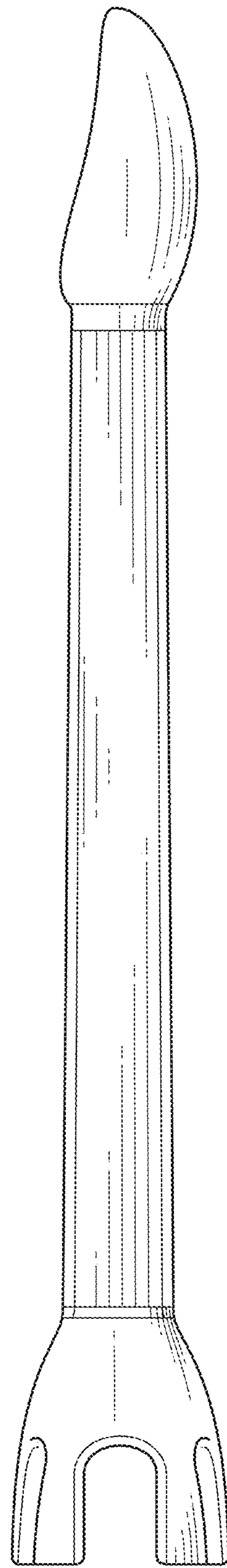

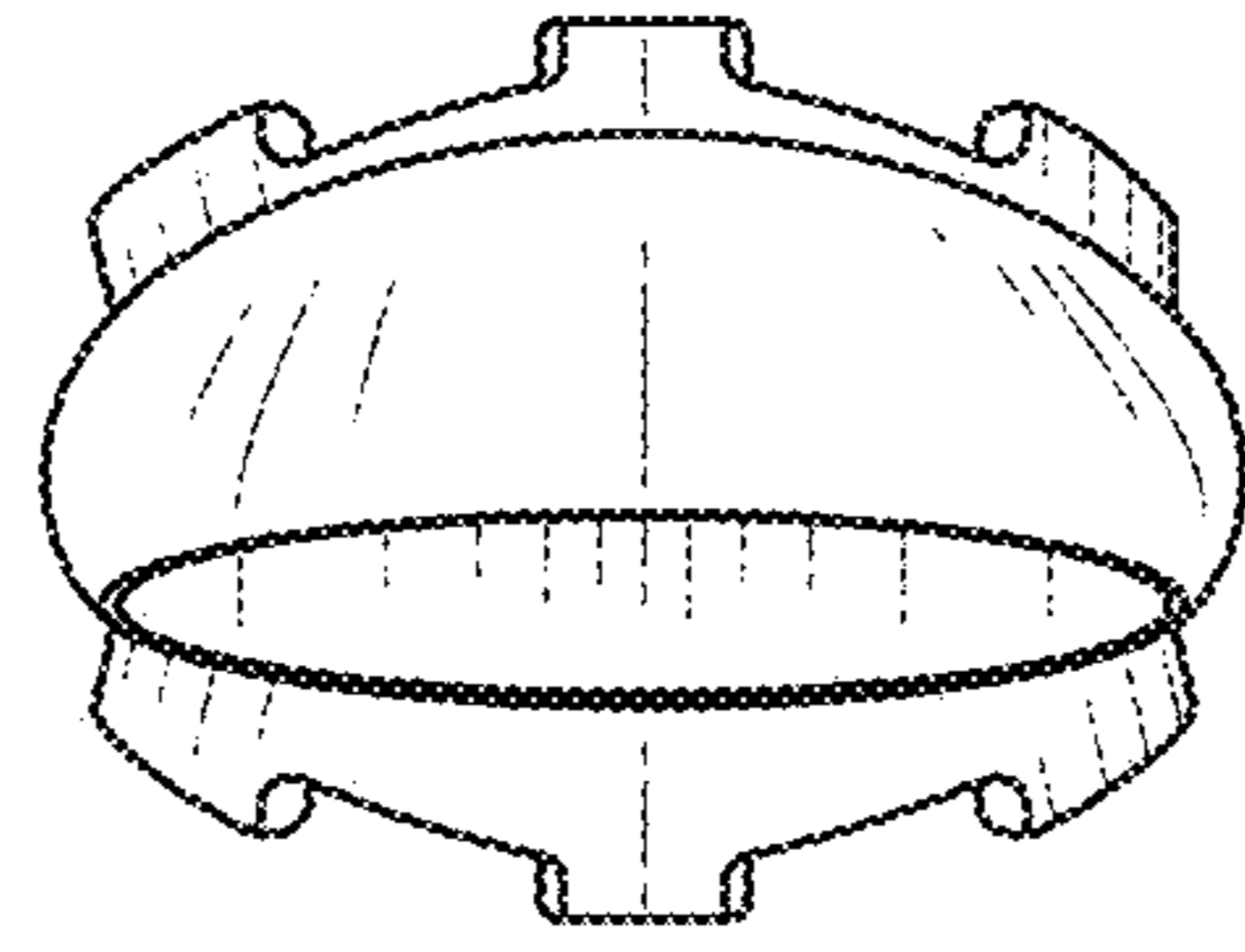

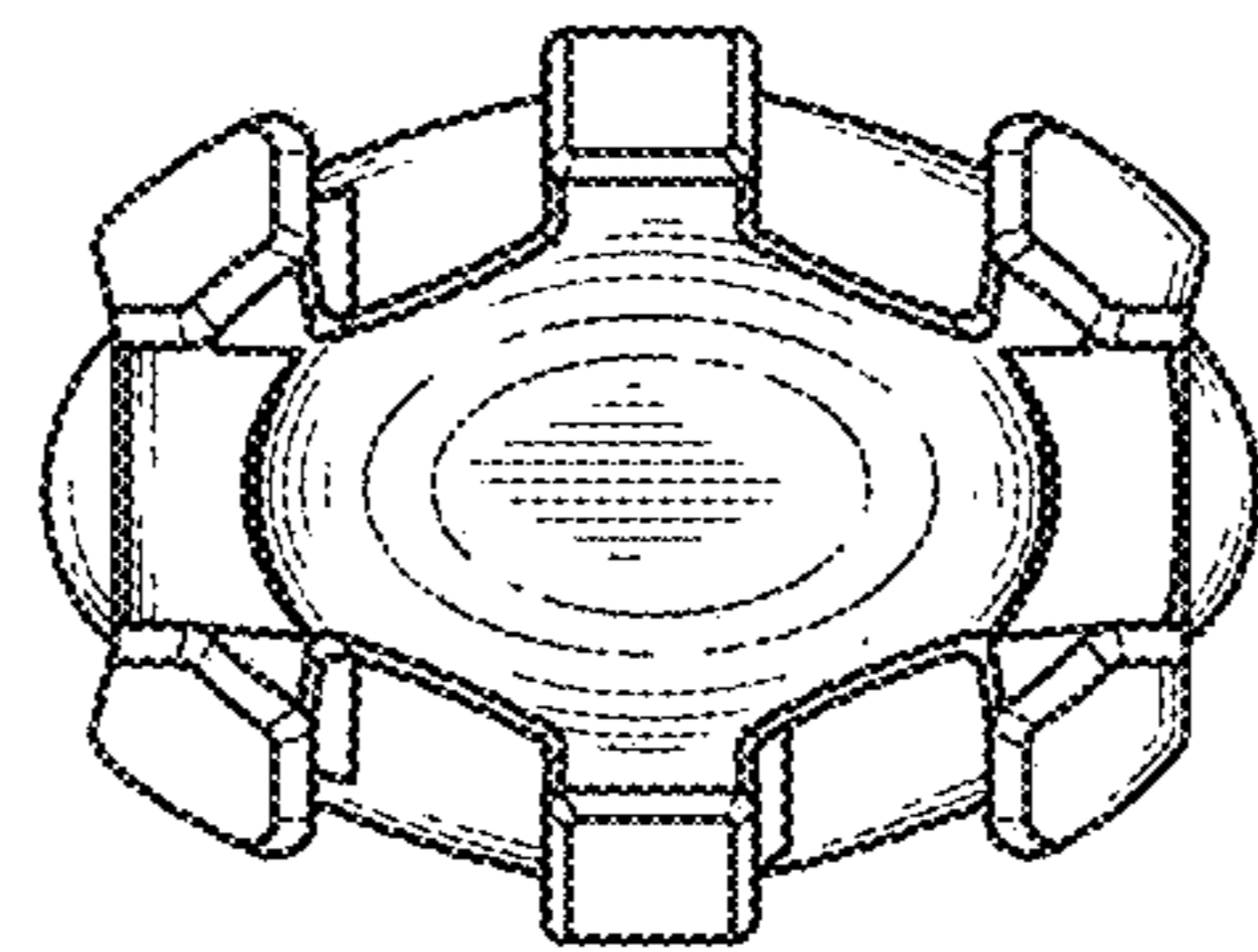
