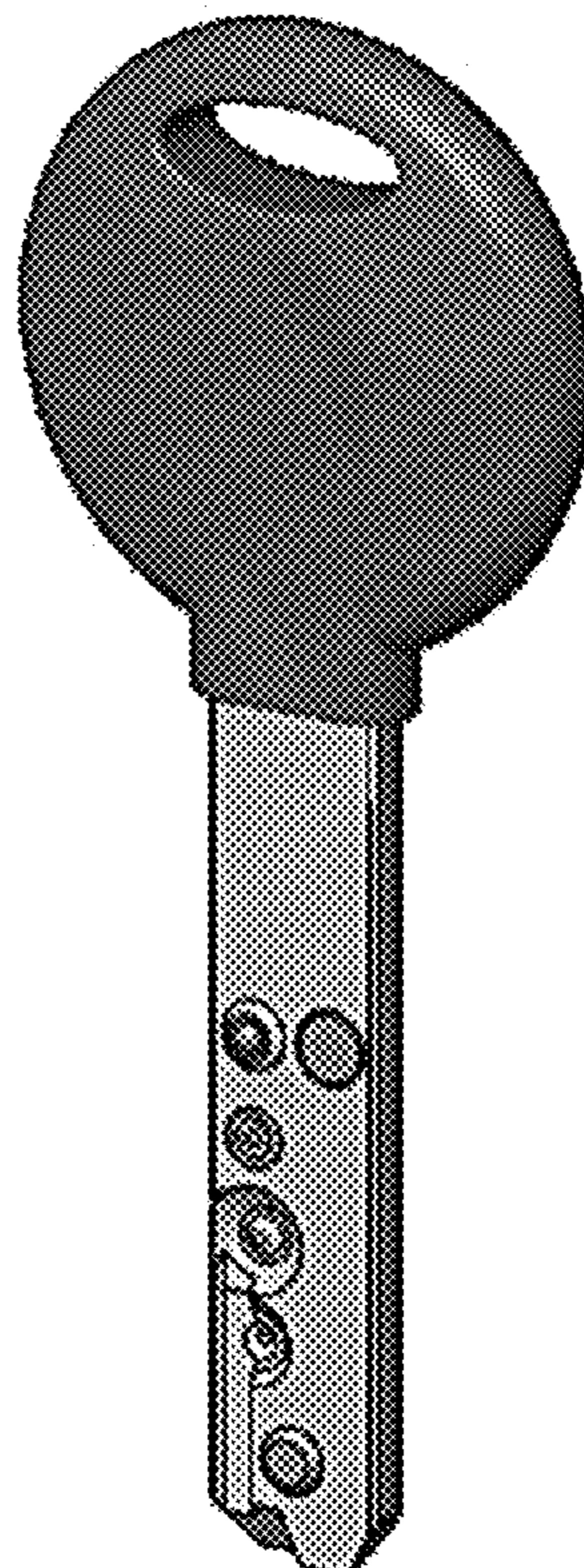
(57) **CLAIM**

DESCRIPTION

FIG. 1 shows a top left perspective of a key showing our new design;
FIG. 2, shows a front elevation view thereof, the rear view being a mirror image of that shown;
FIG. 3, shows a top plan view thereof;
FIG. 4, shows a bottom plan view thereof; and,

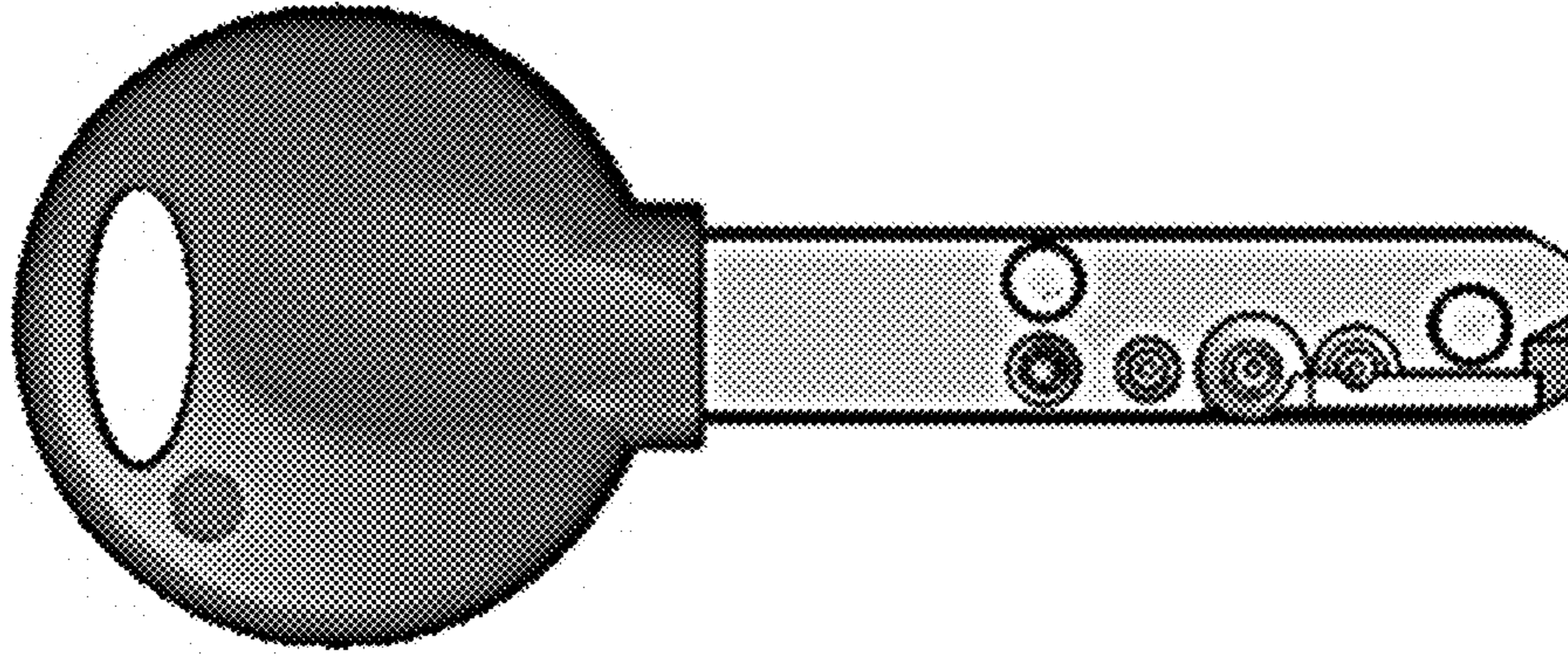

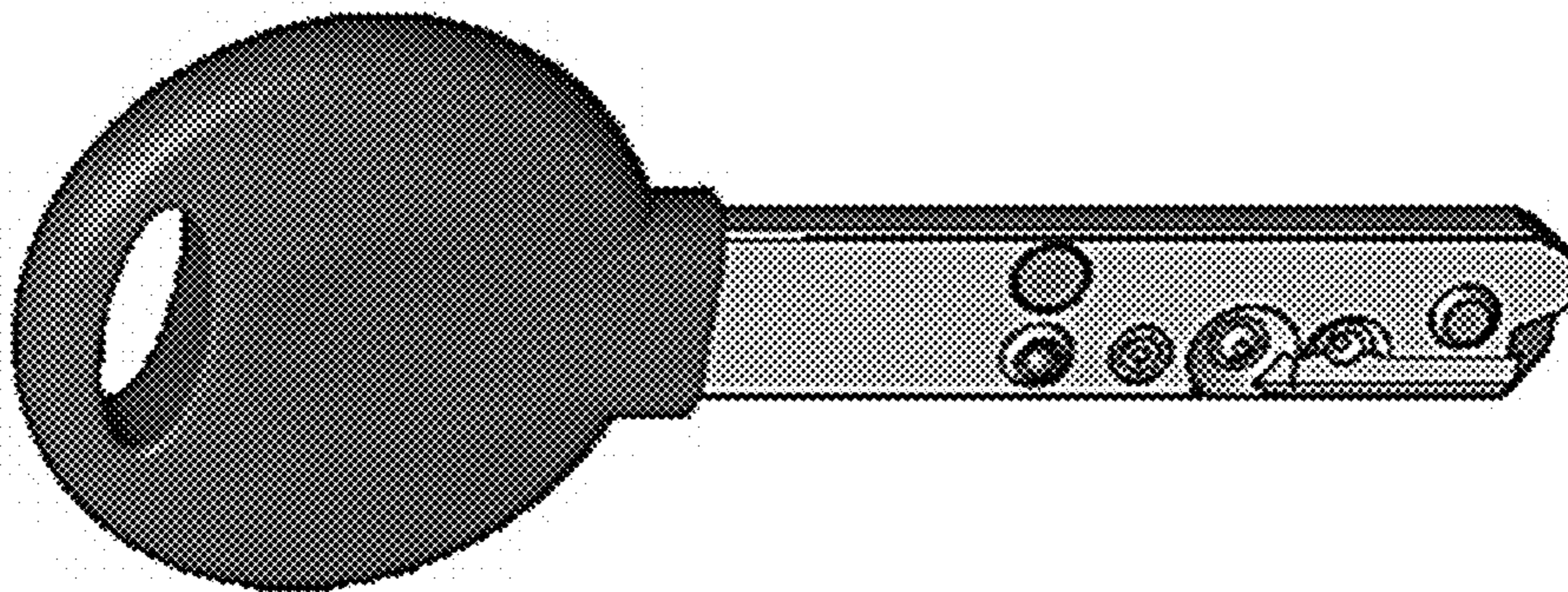

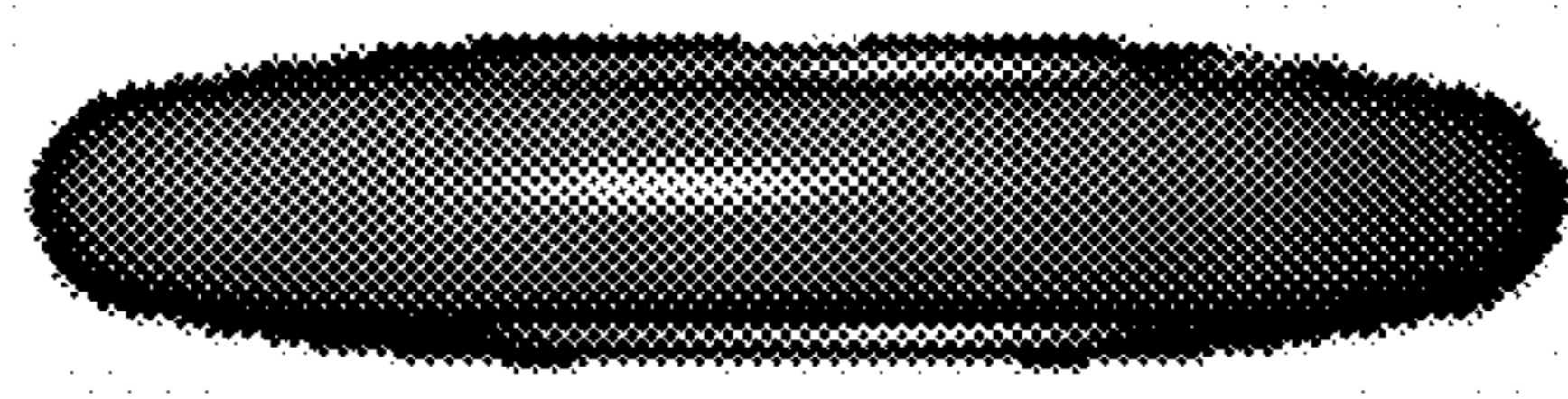

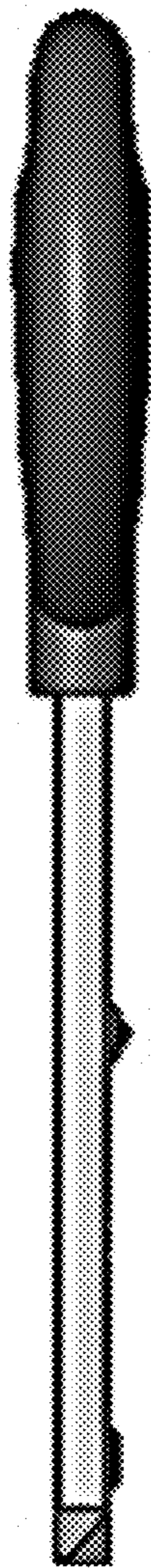
