FIG. 20 is a left side view thereof, shown without the base for ease of illustration;

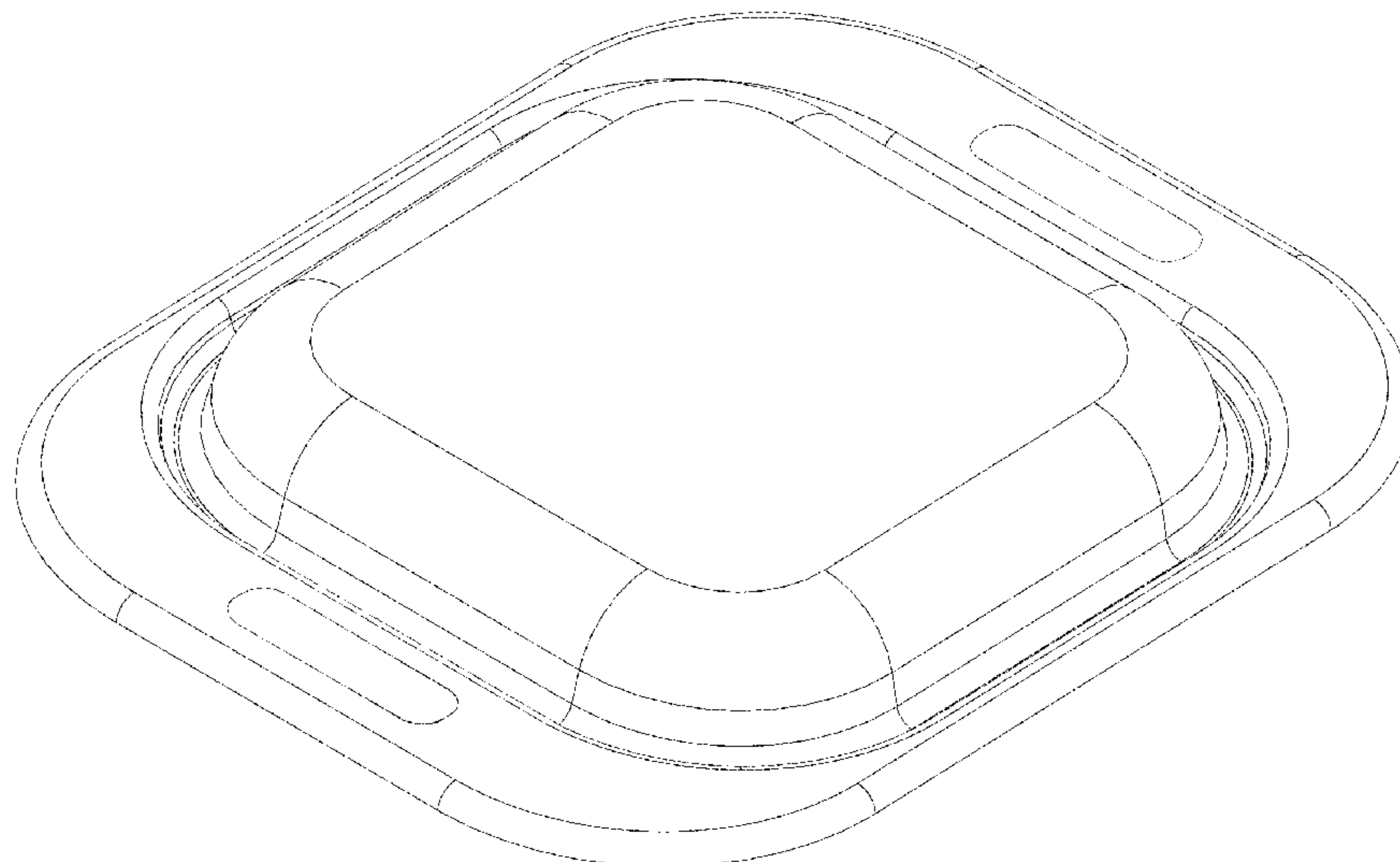
FIG. 21 is a front view thereof, shown without the base for ease of illustration;

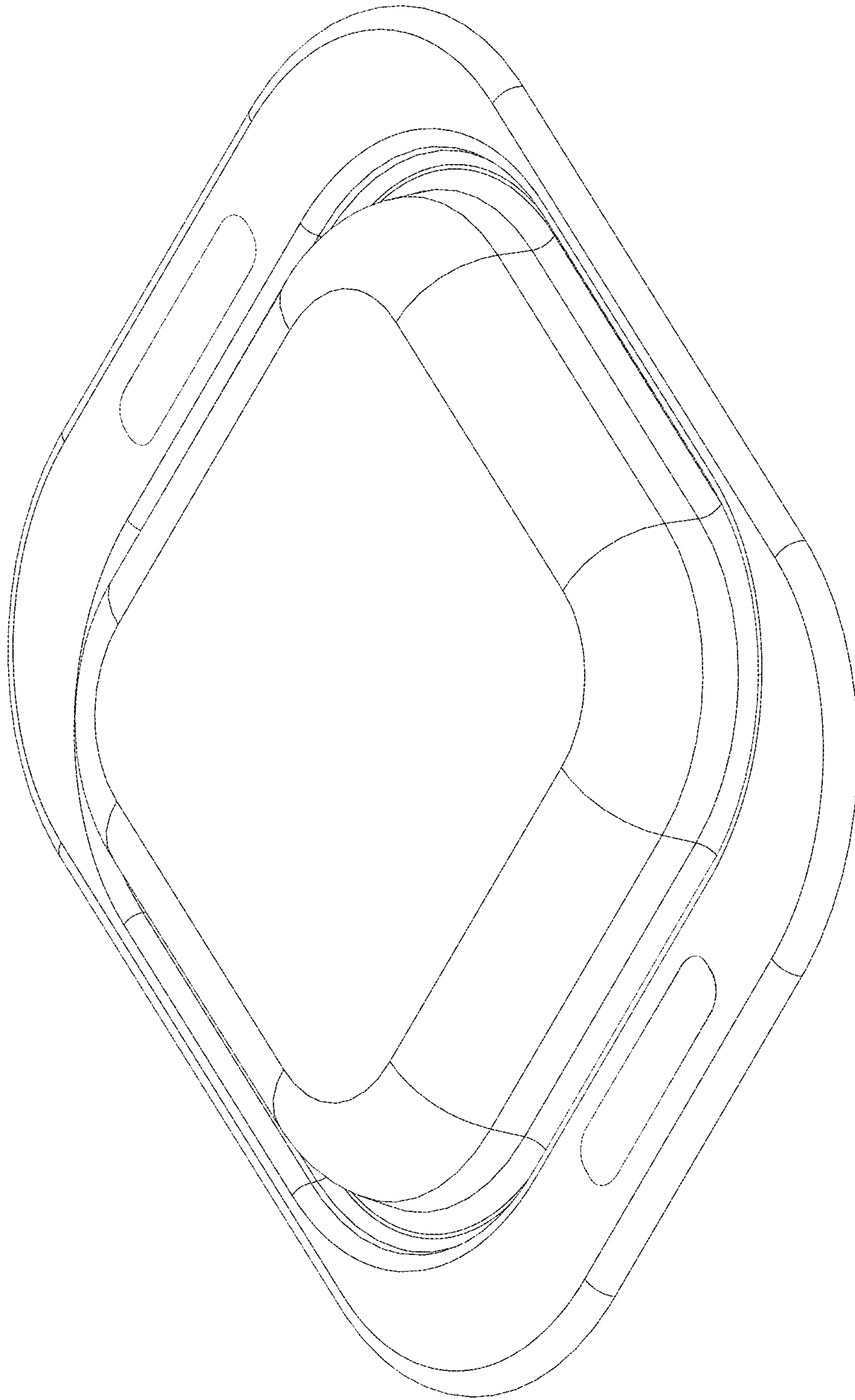

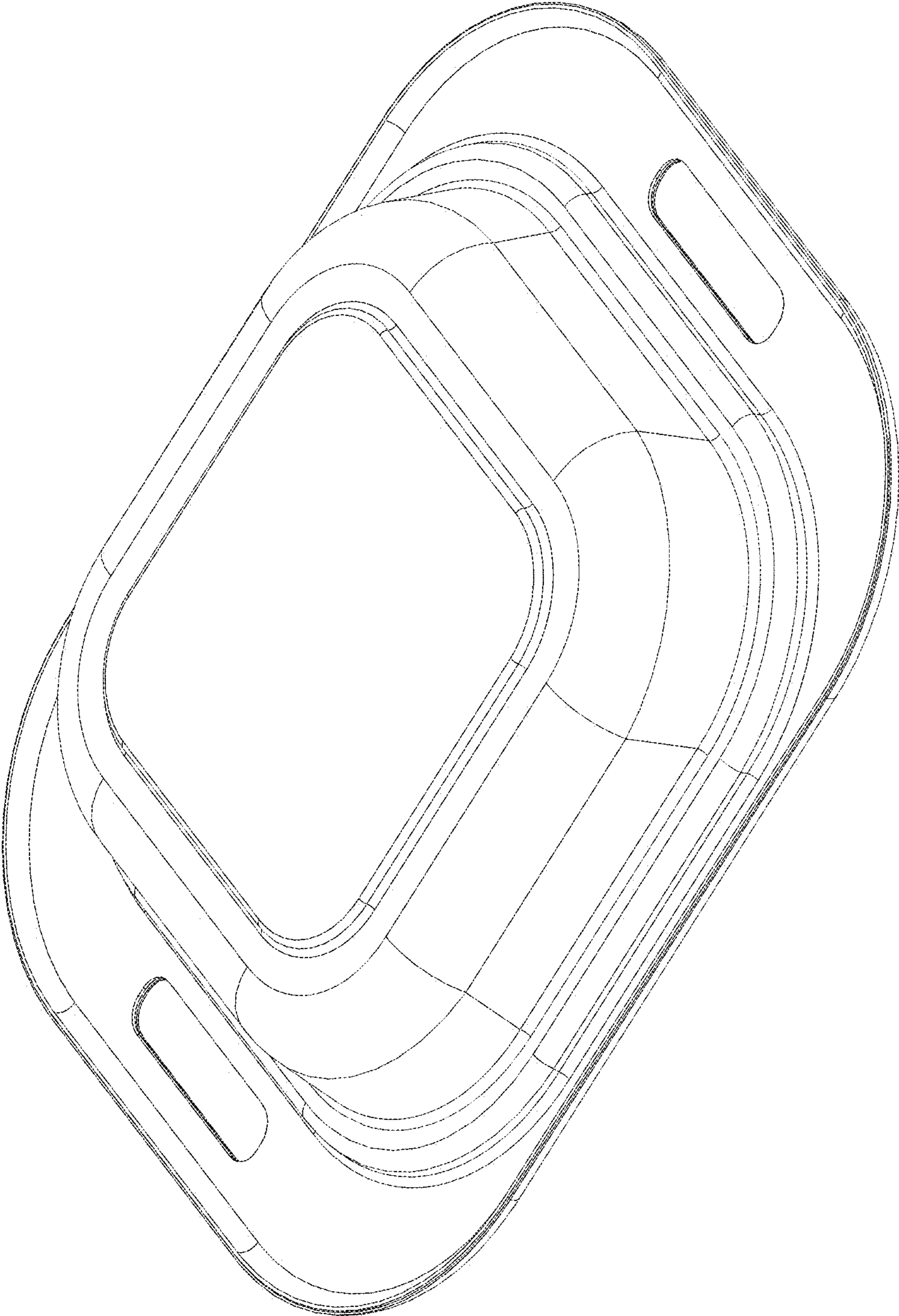

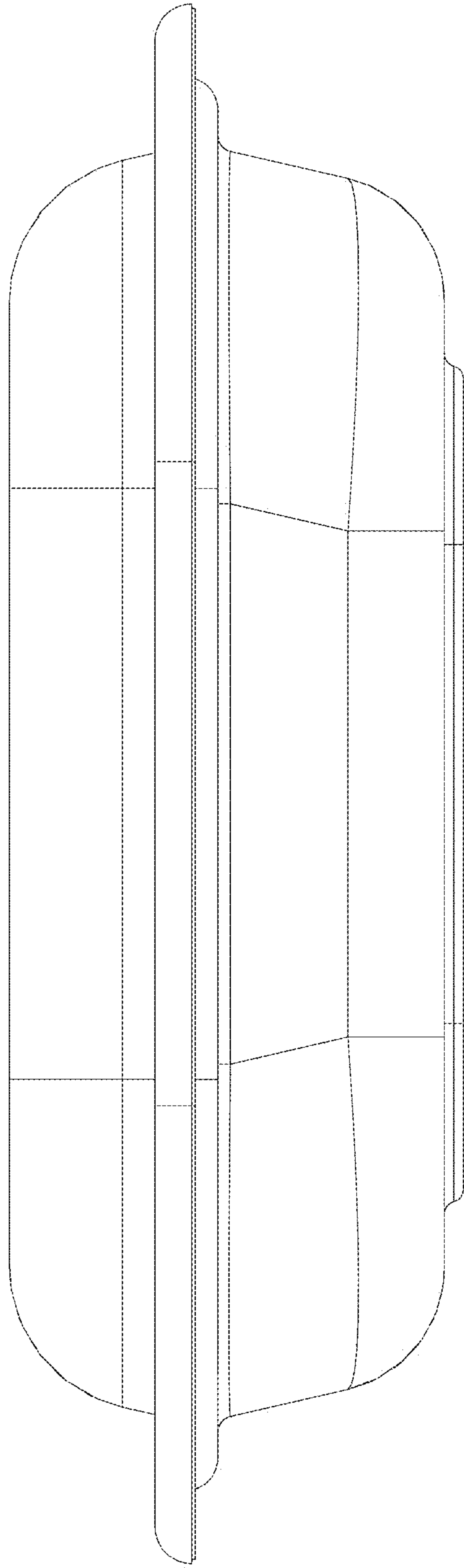

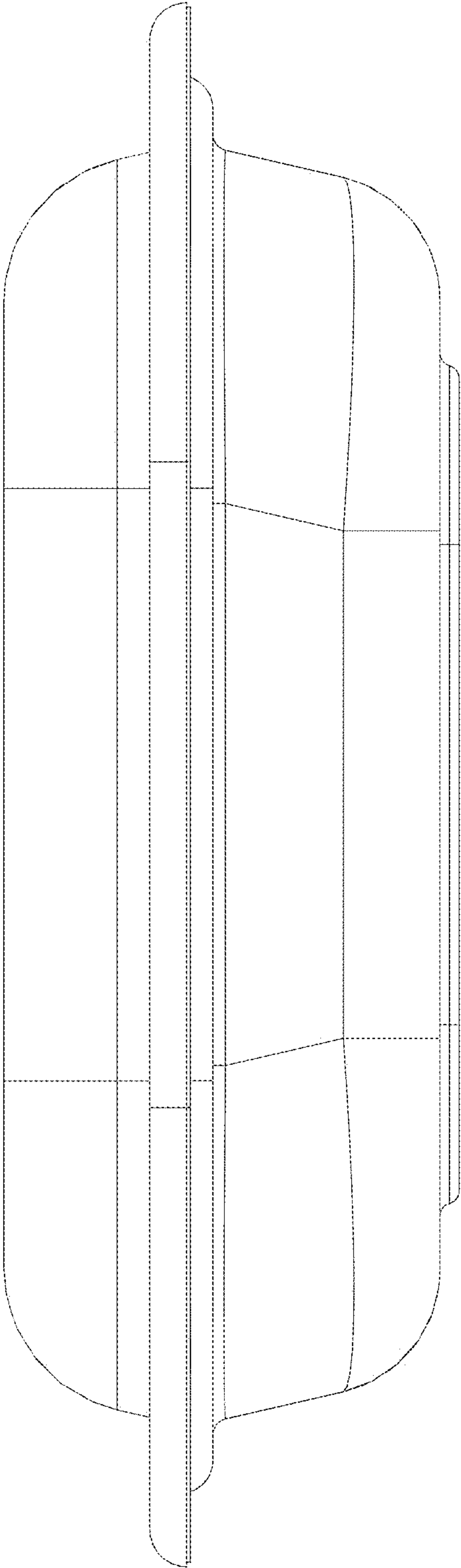

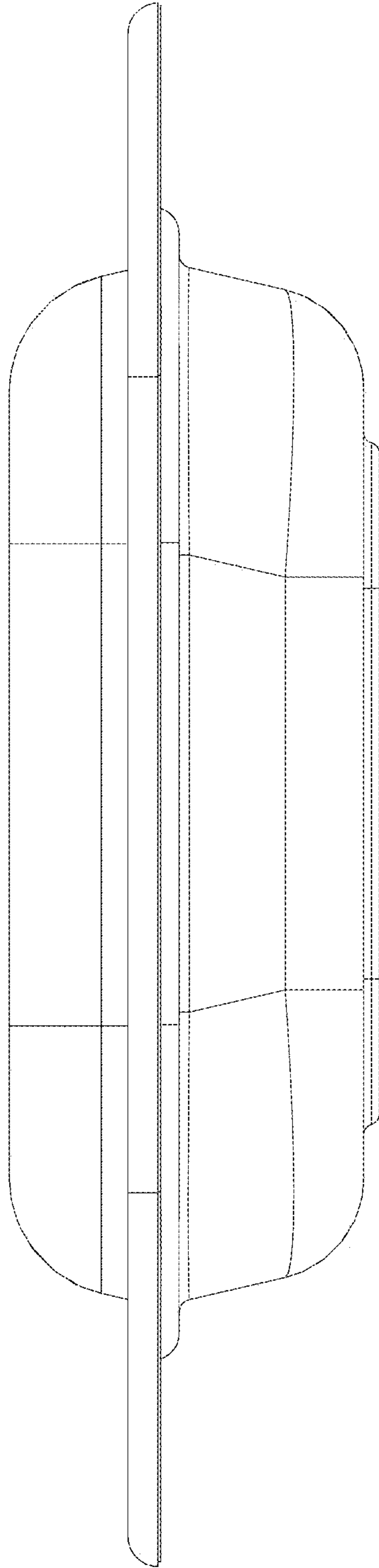

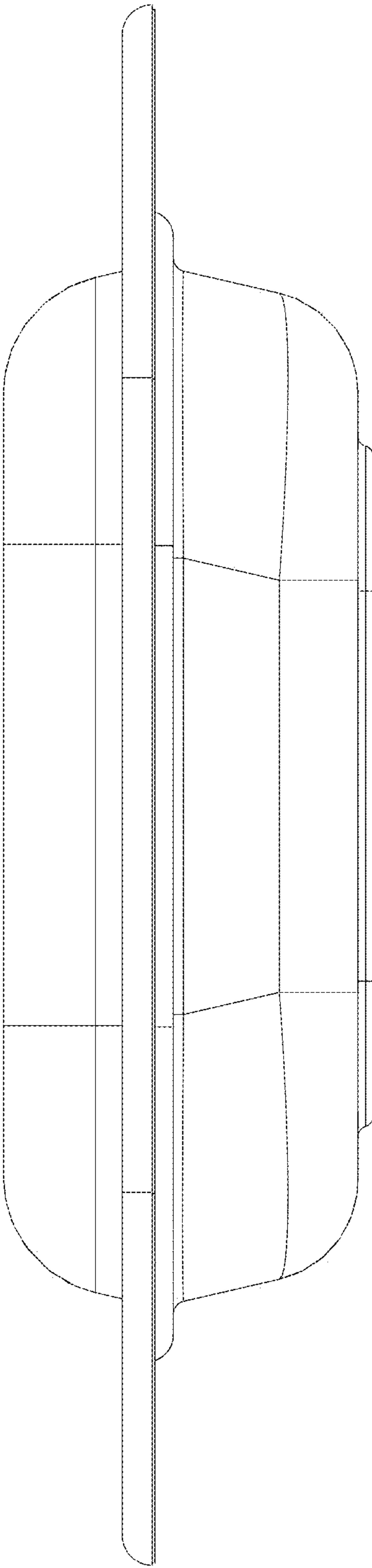

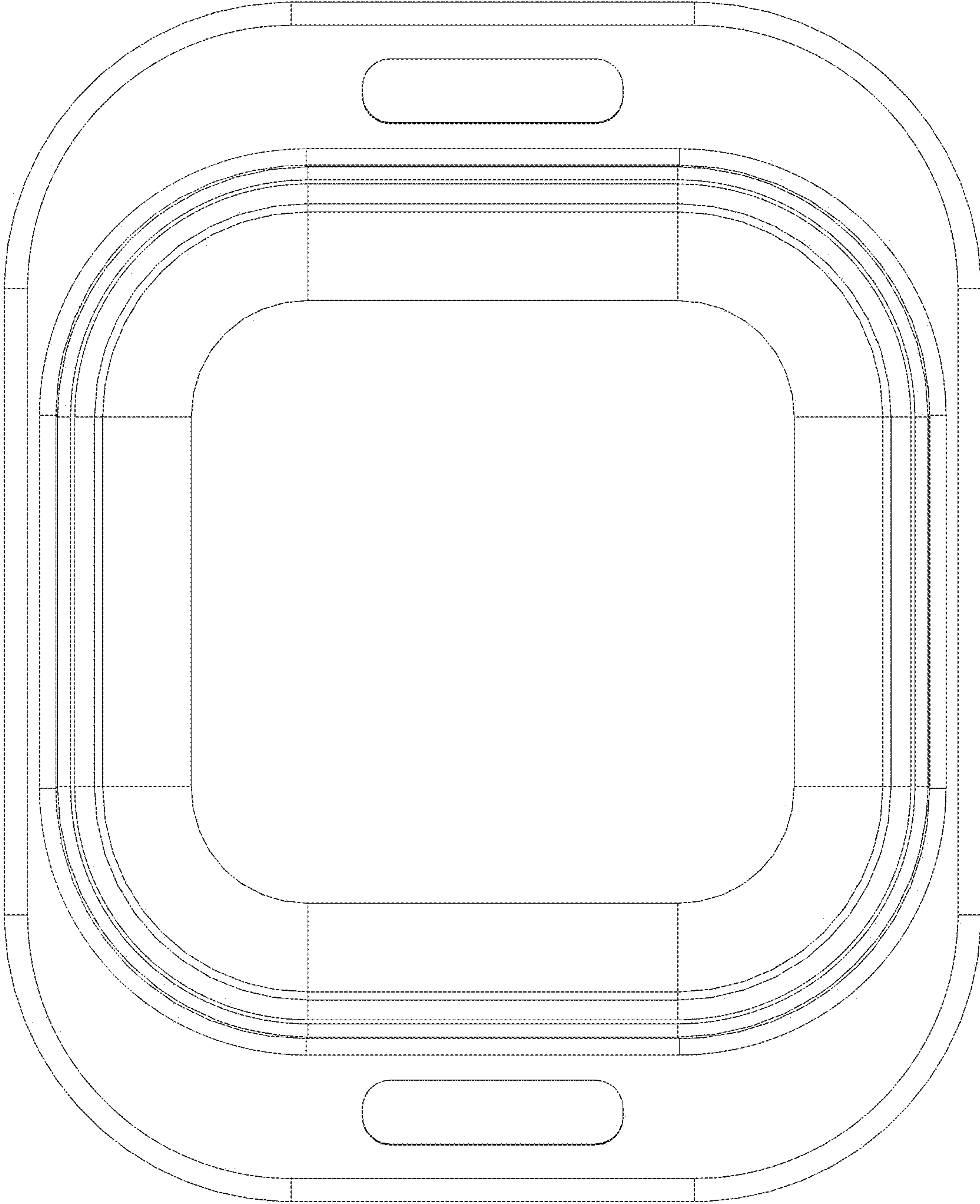

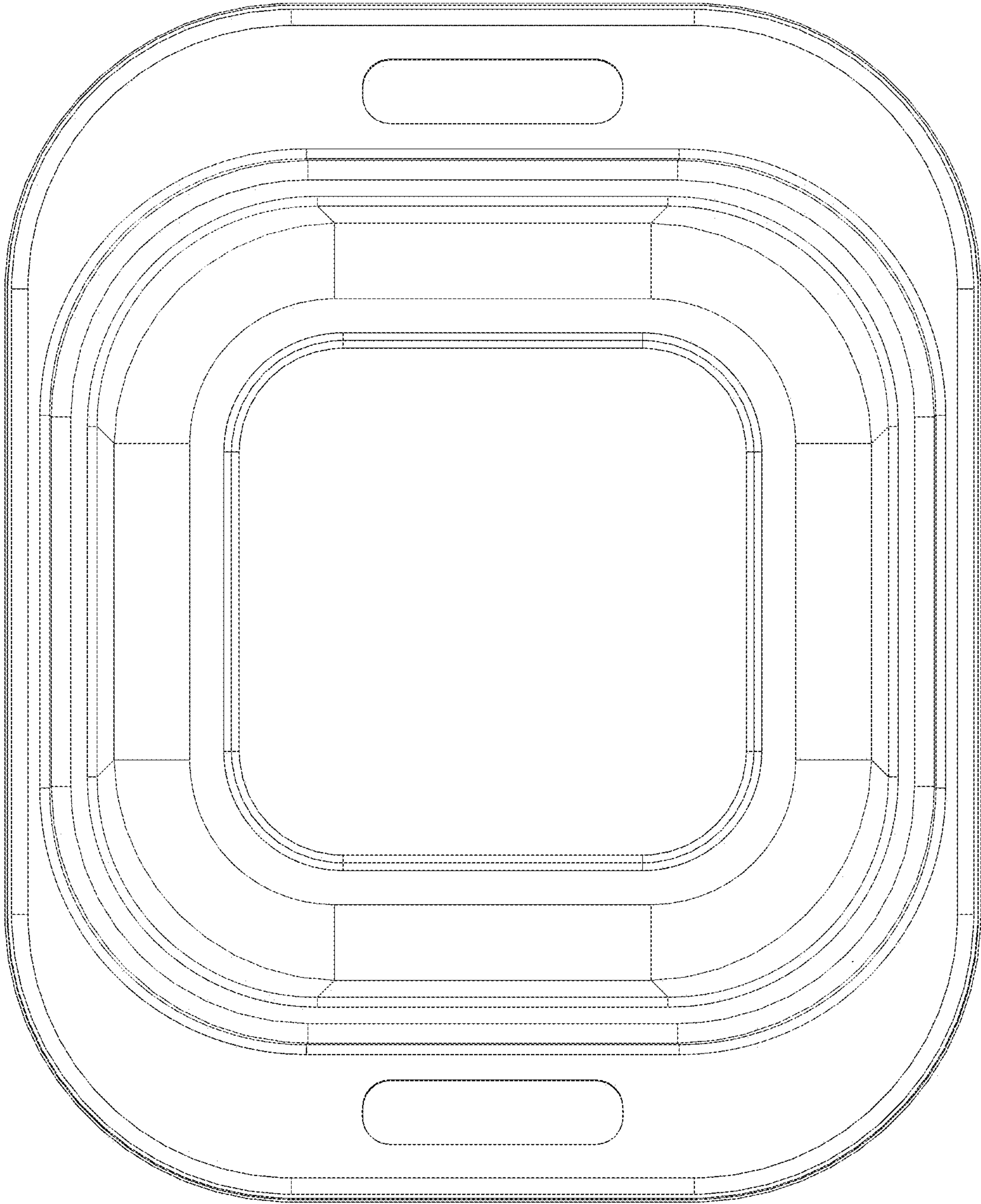

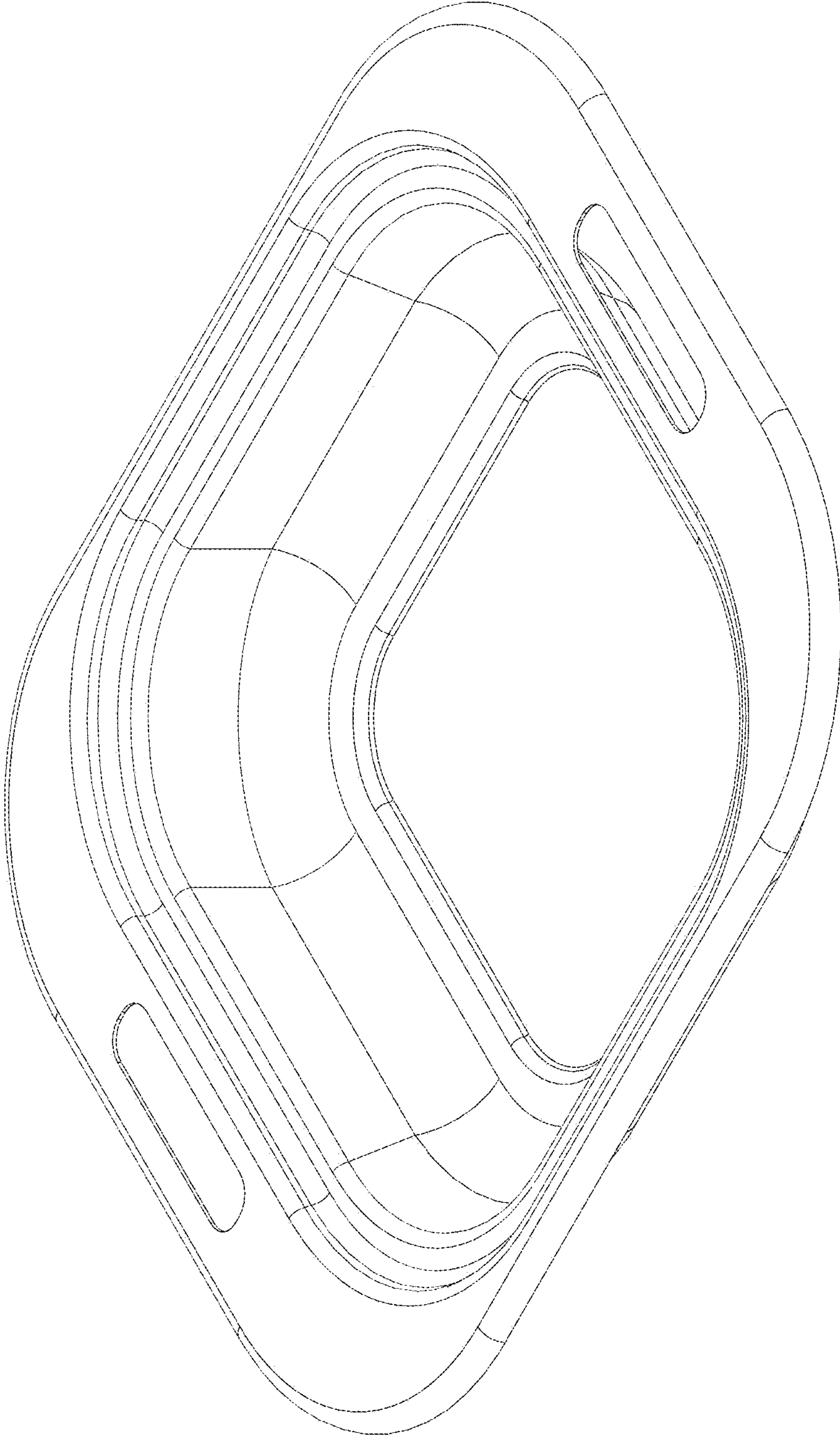

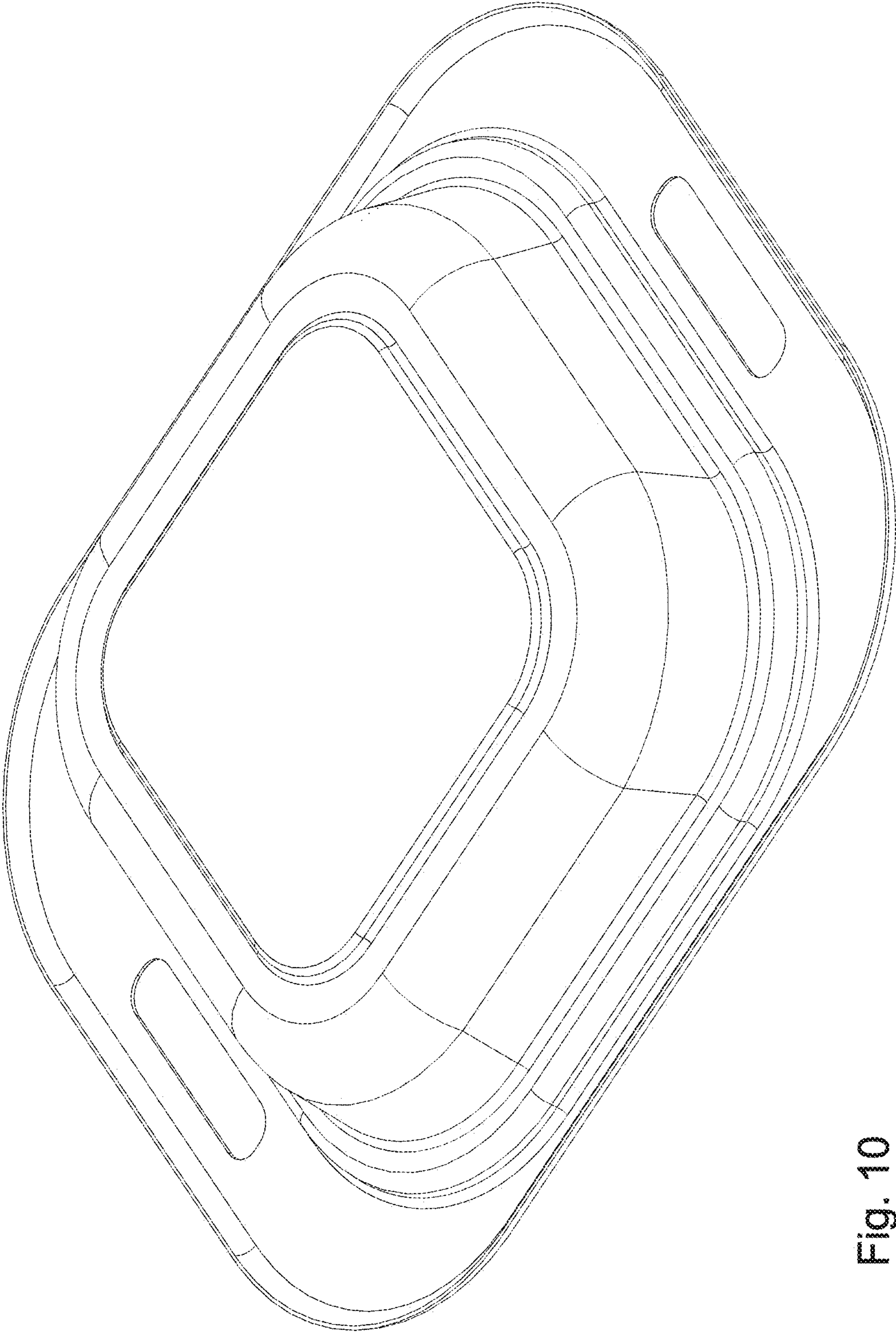

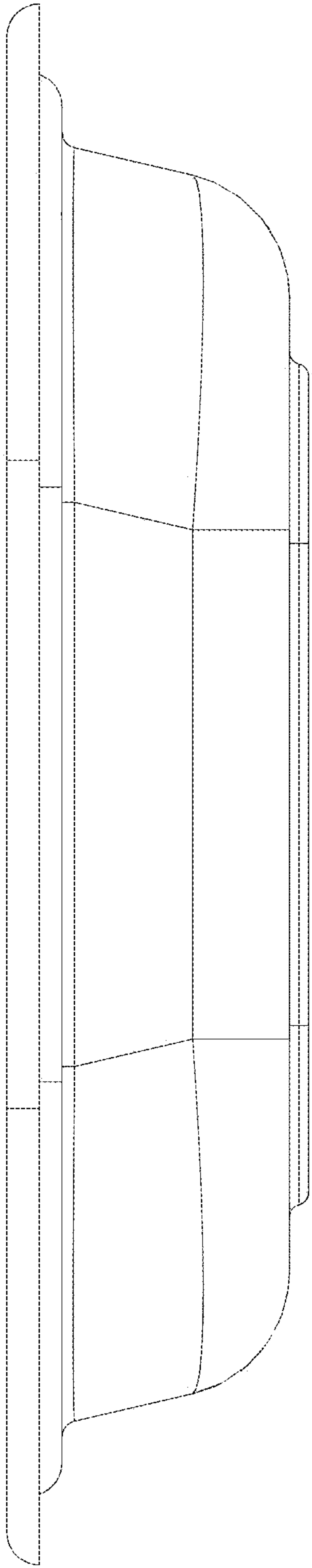

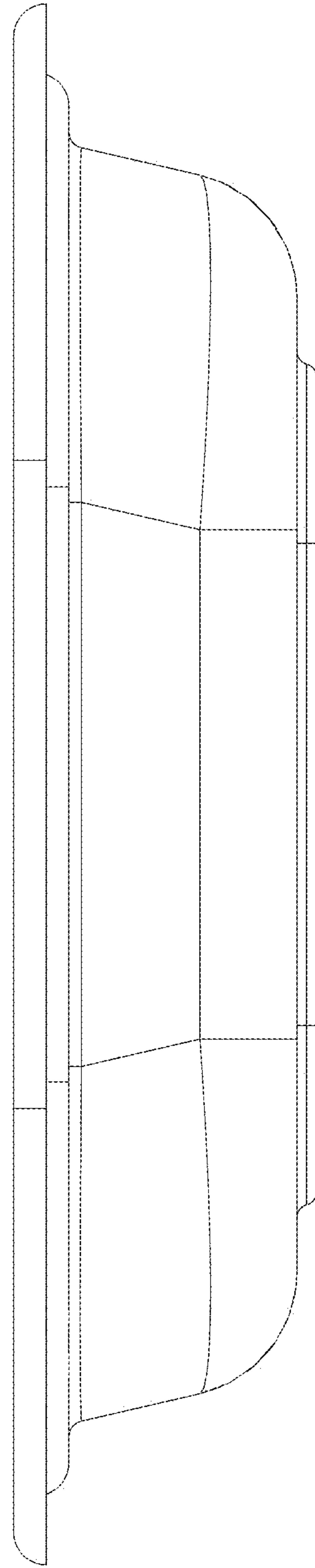

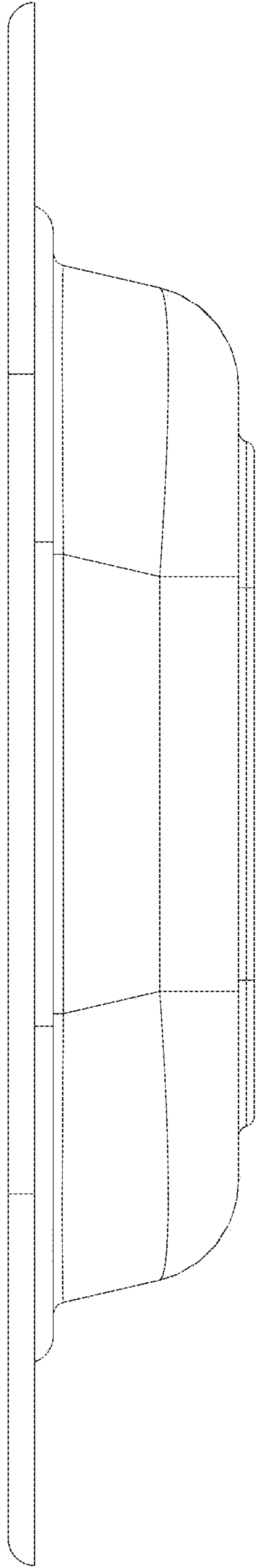

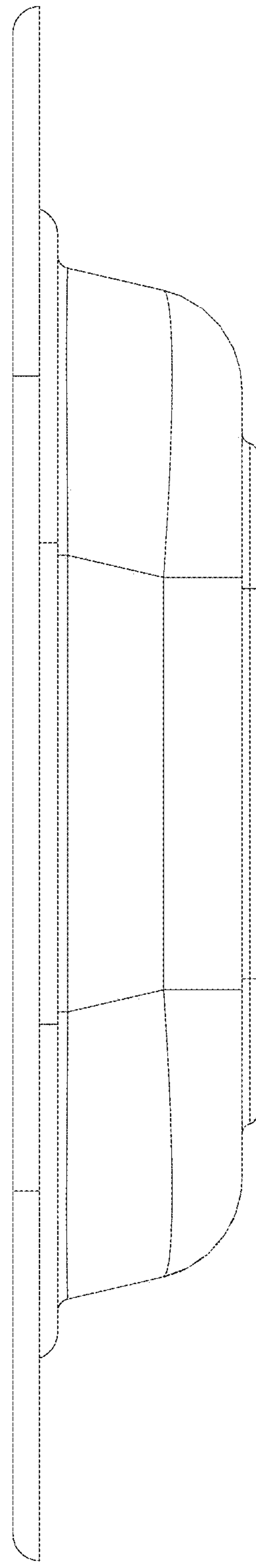

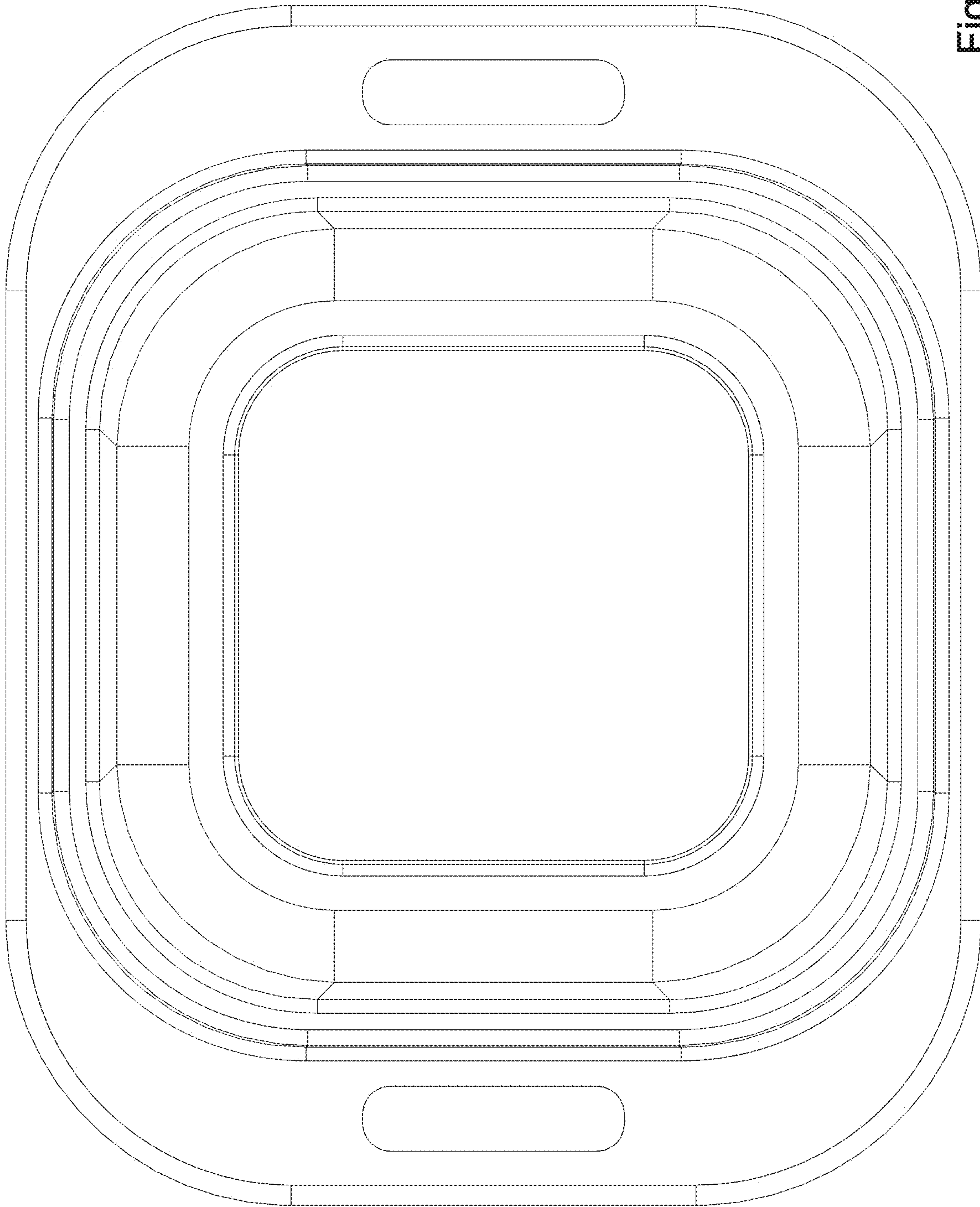

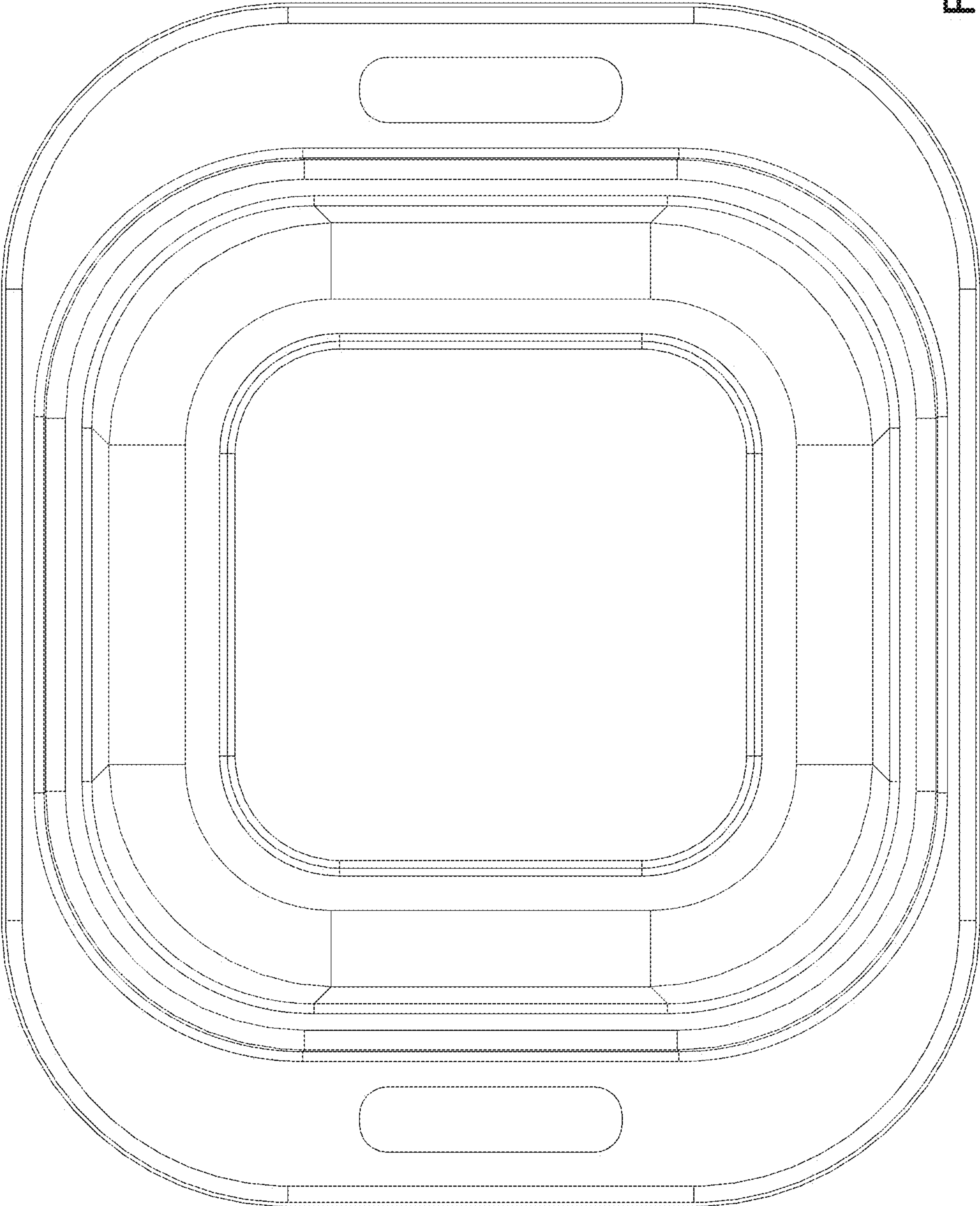

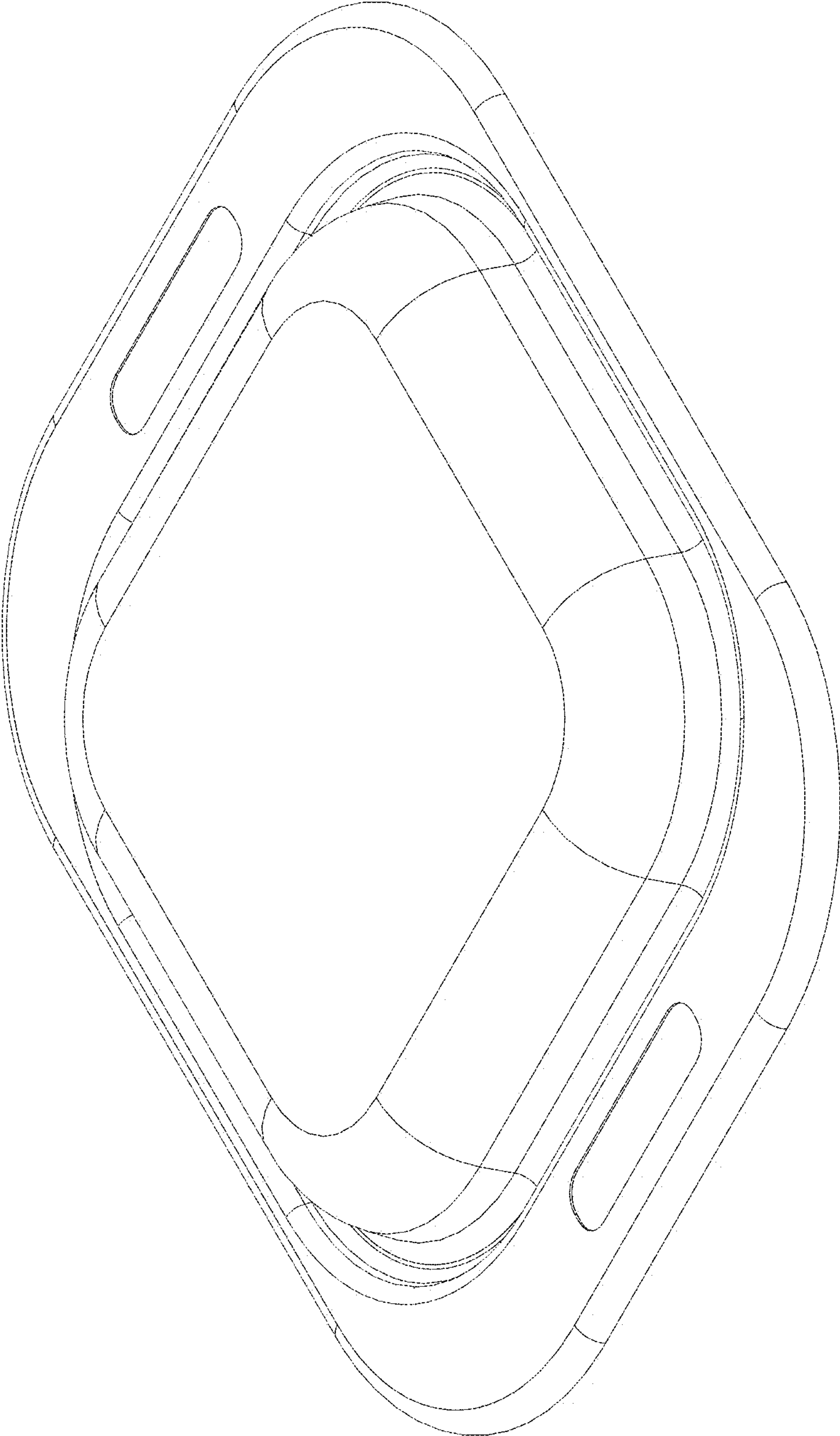

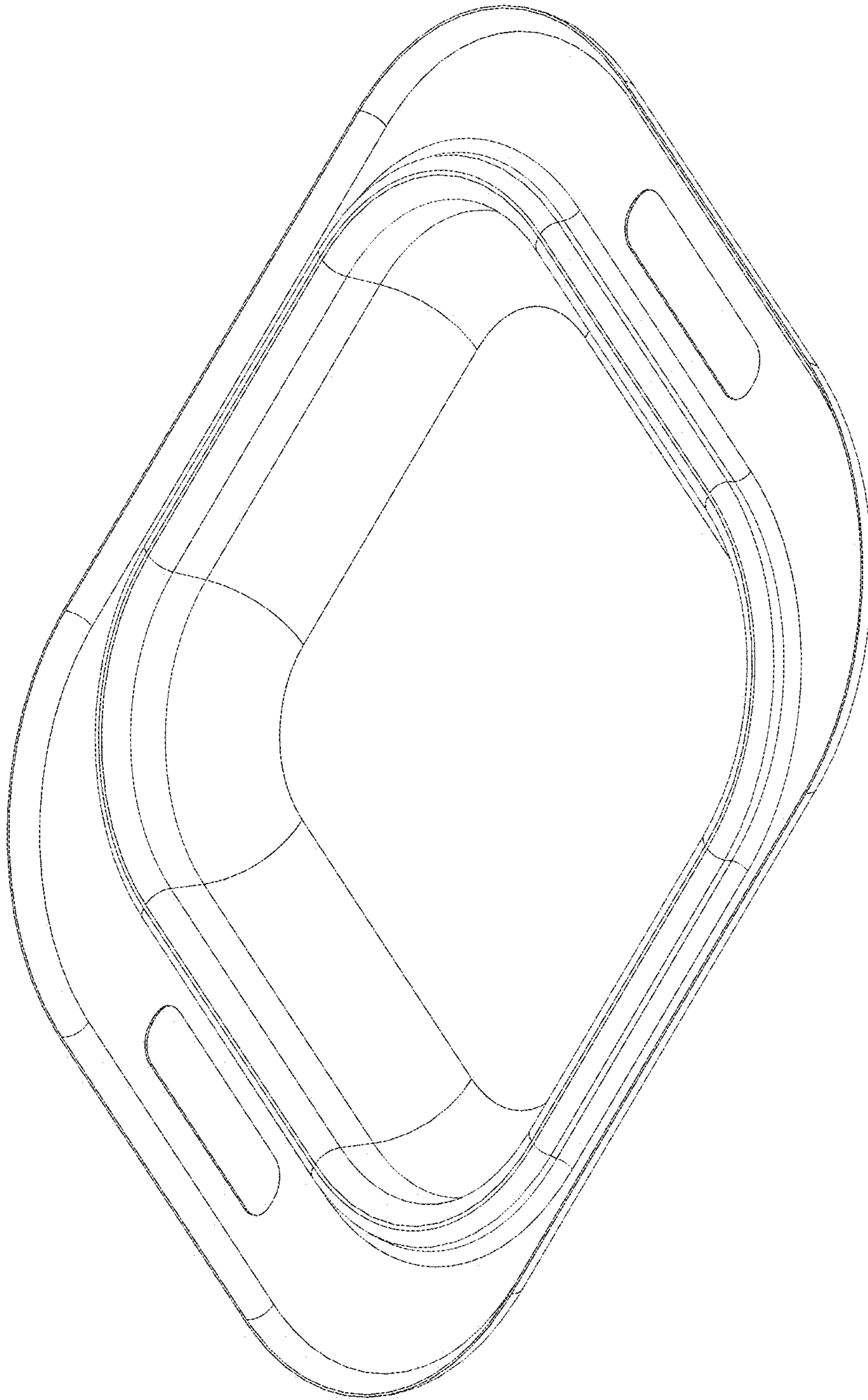

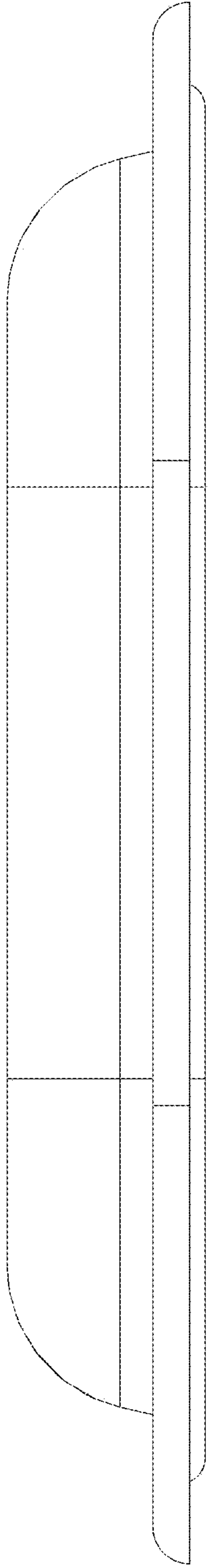

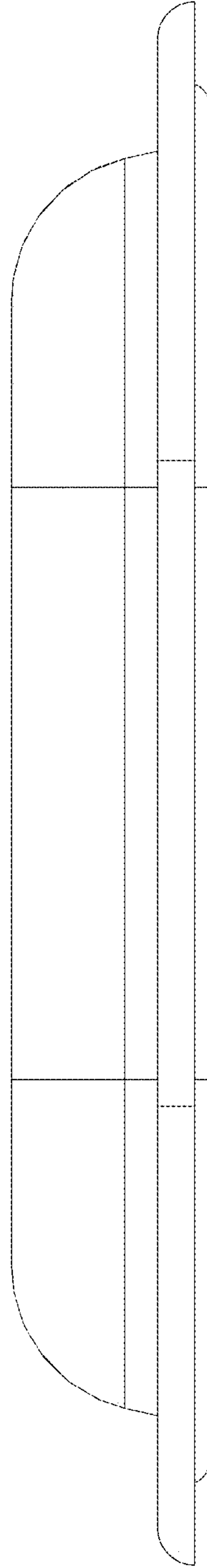

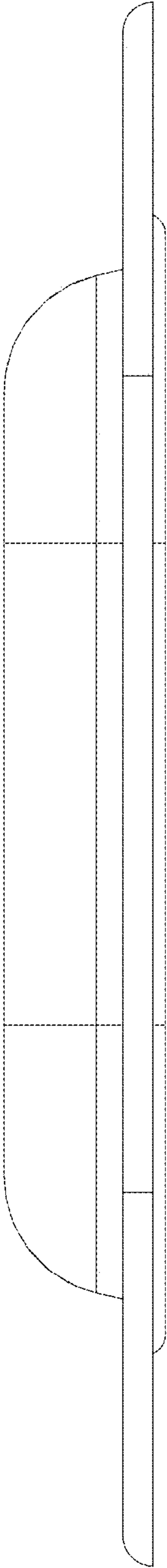

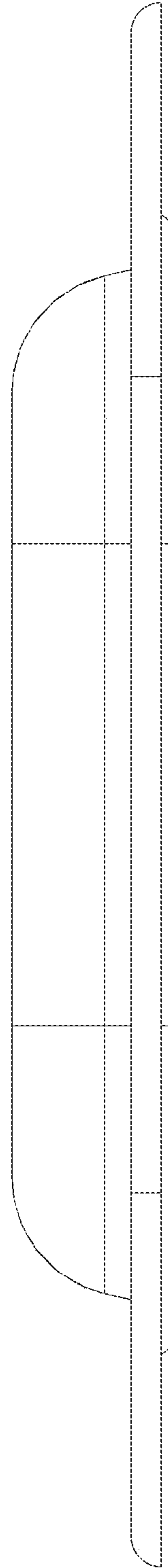

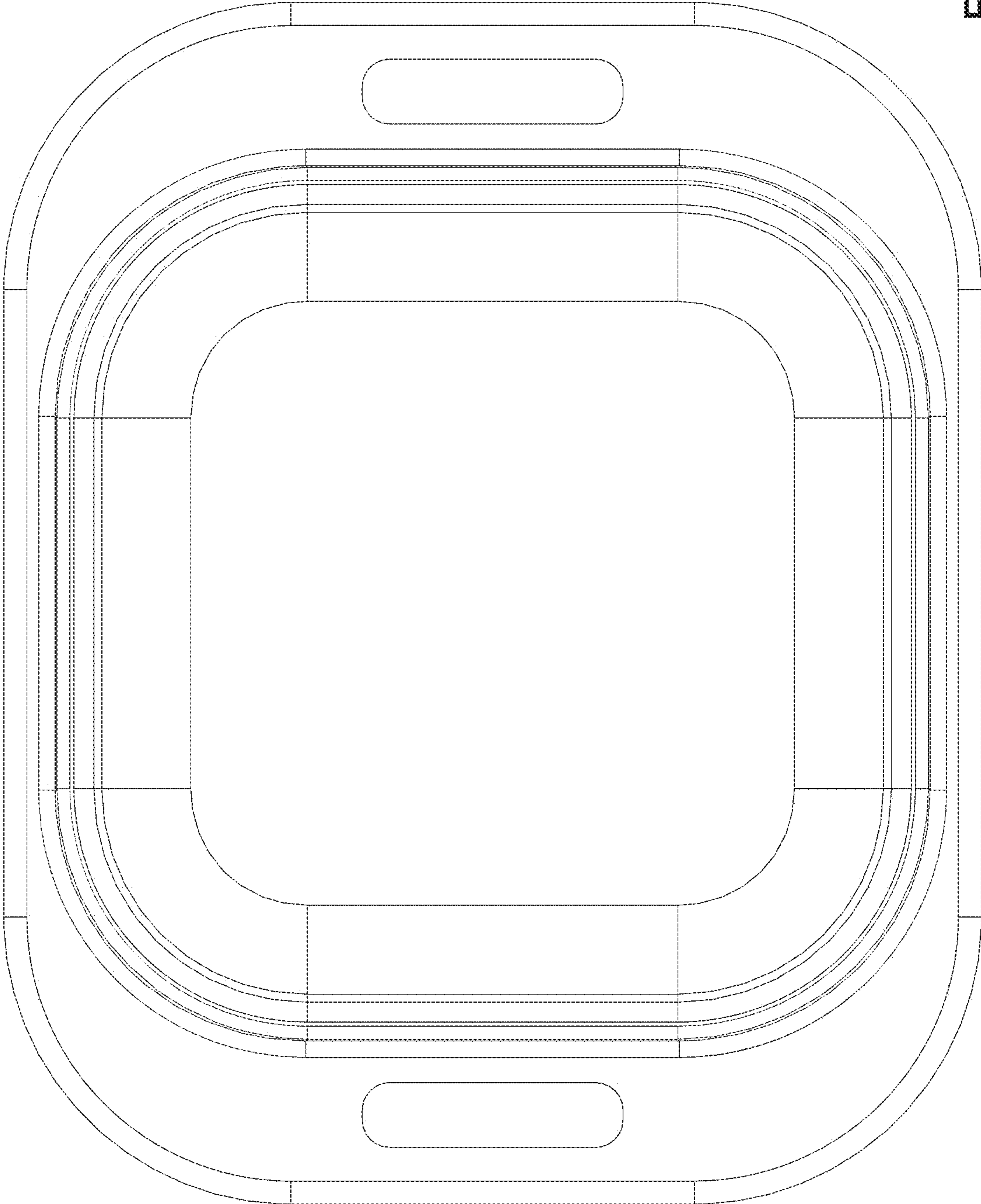

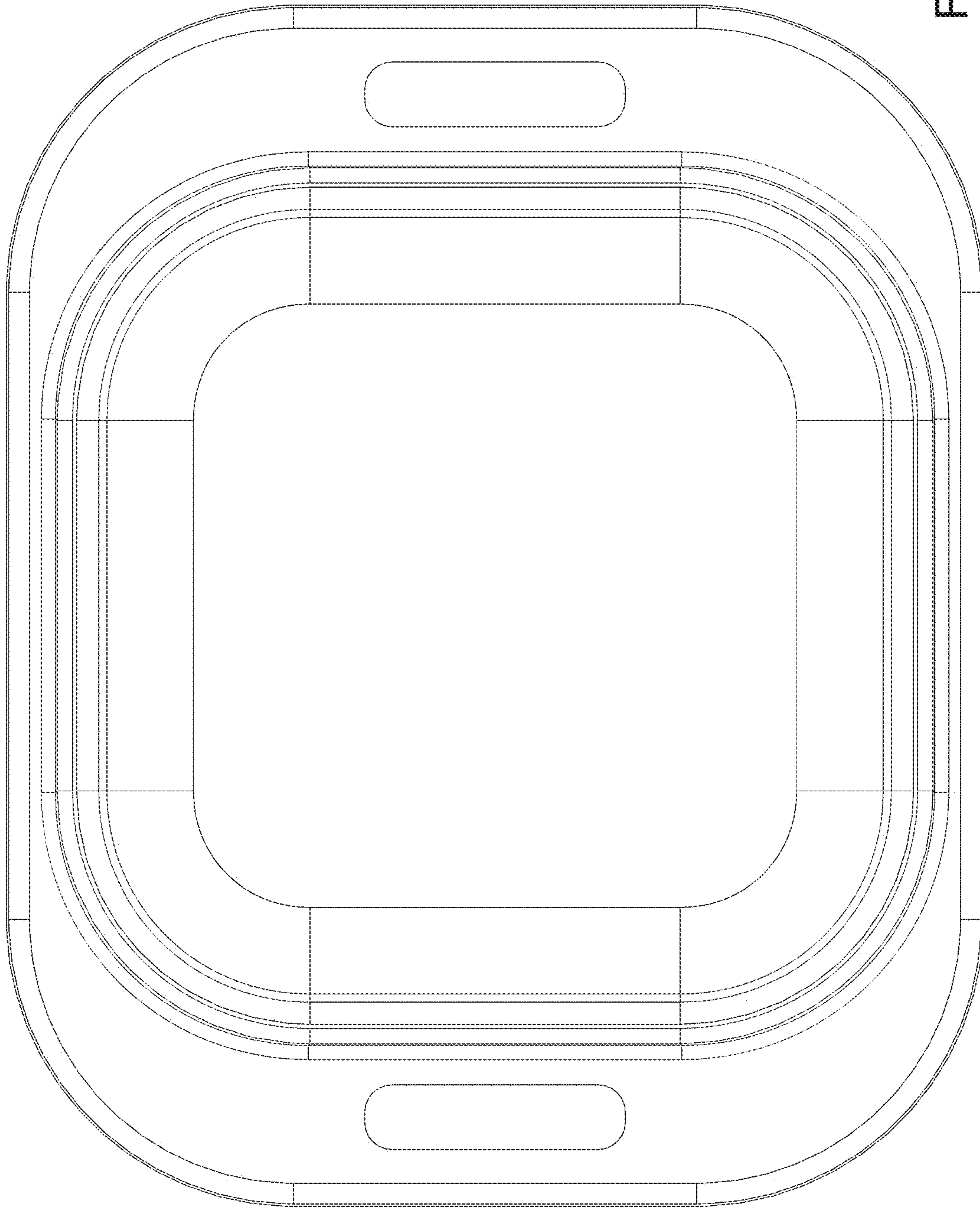
