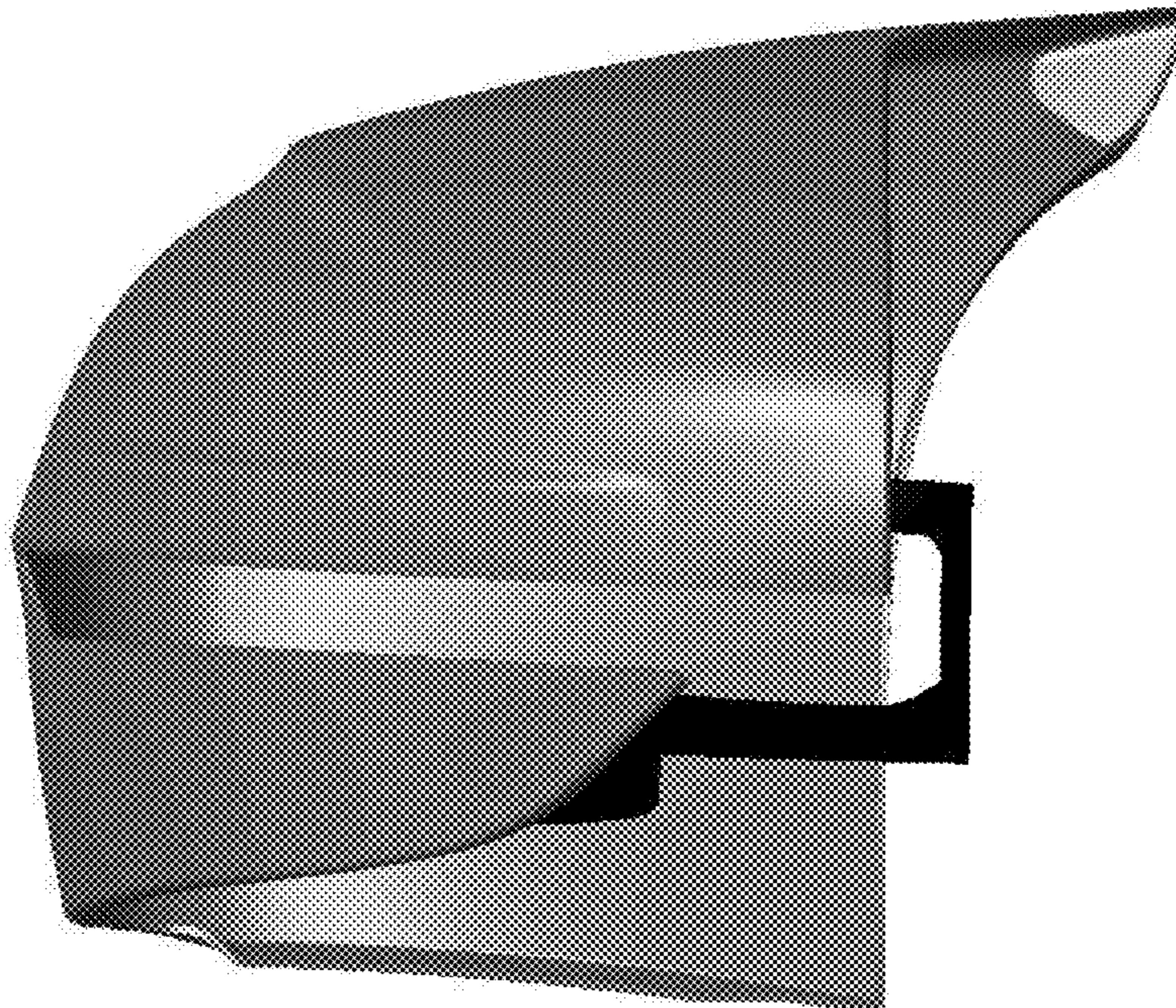

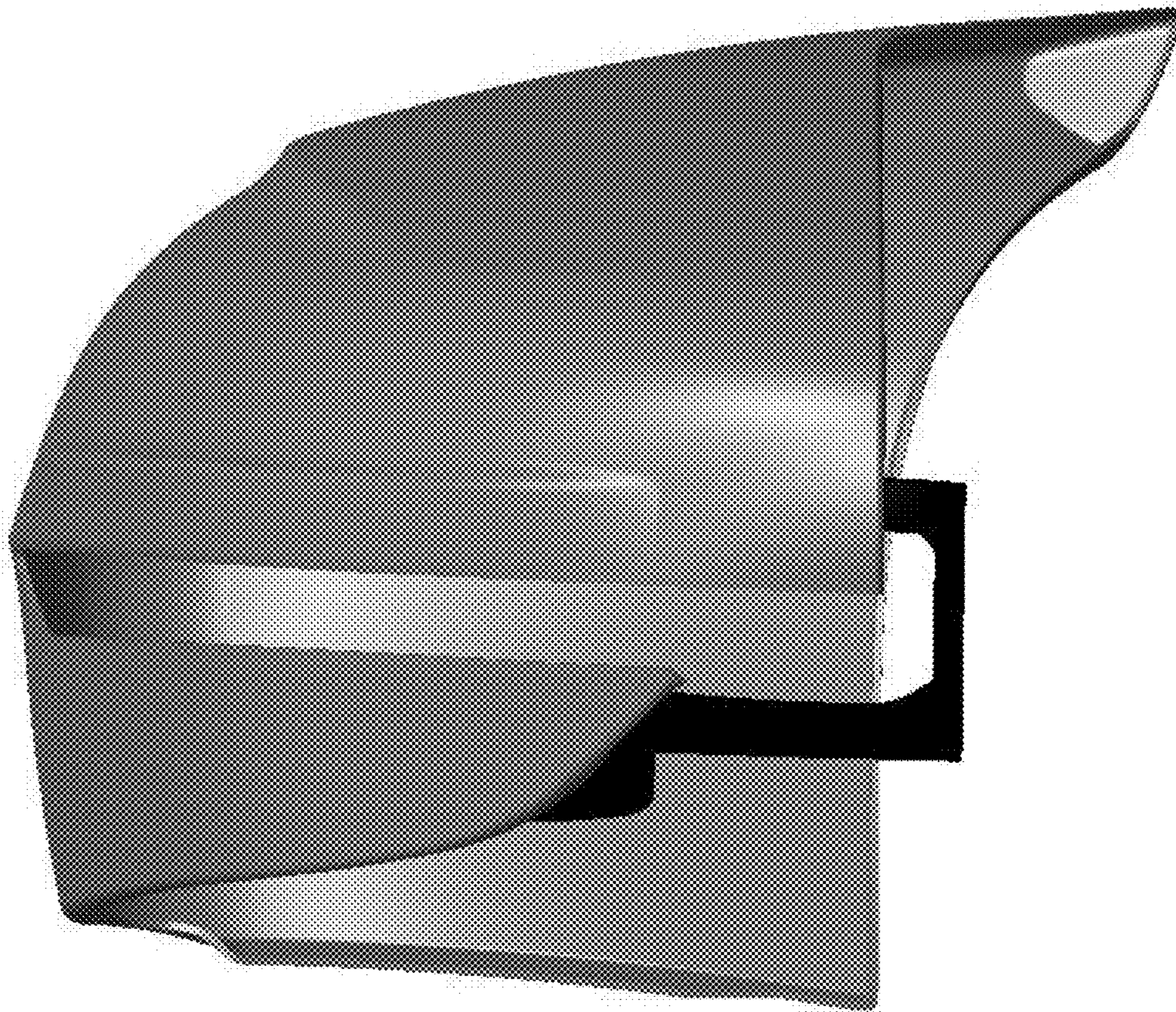
DESCRIPTION

- 1.6 is a front and right side perspective view thereof.

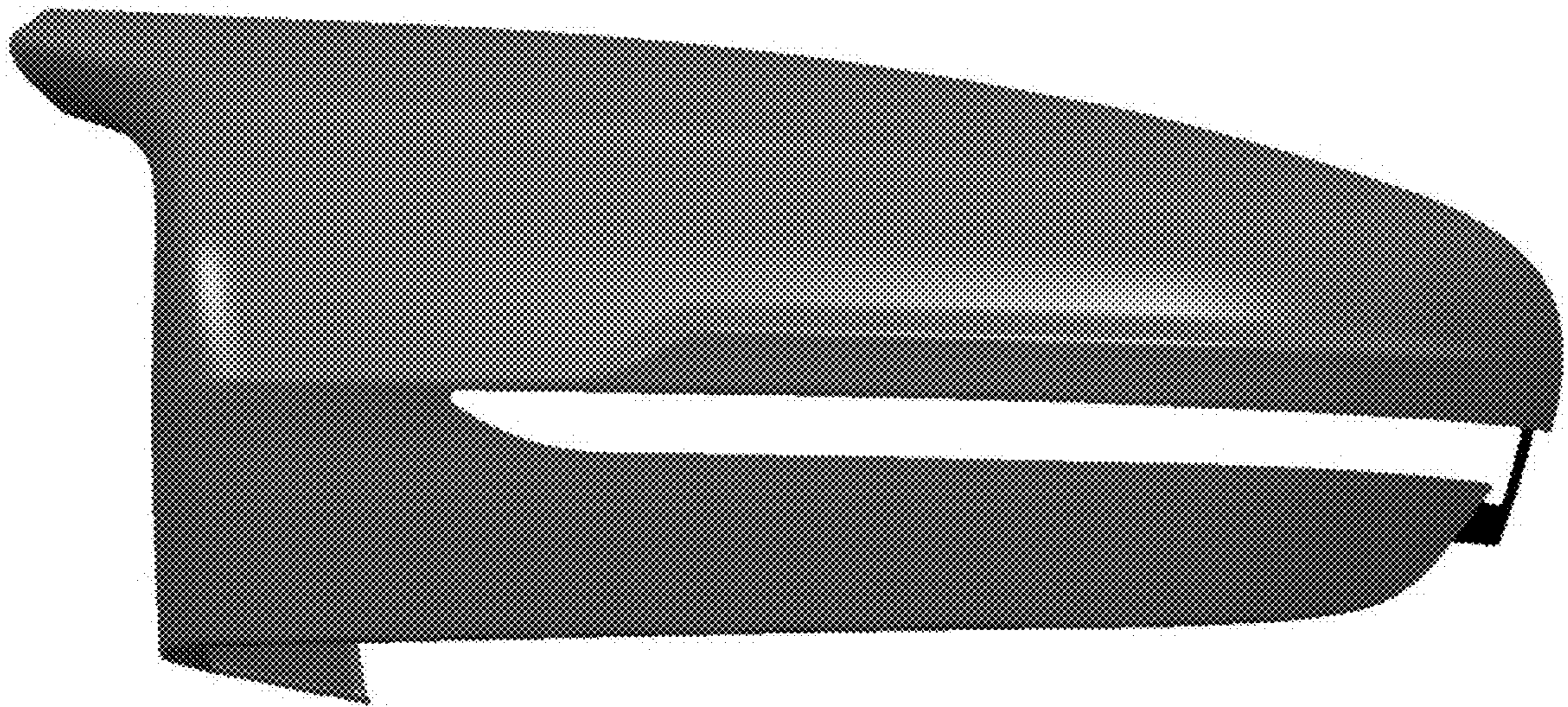

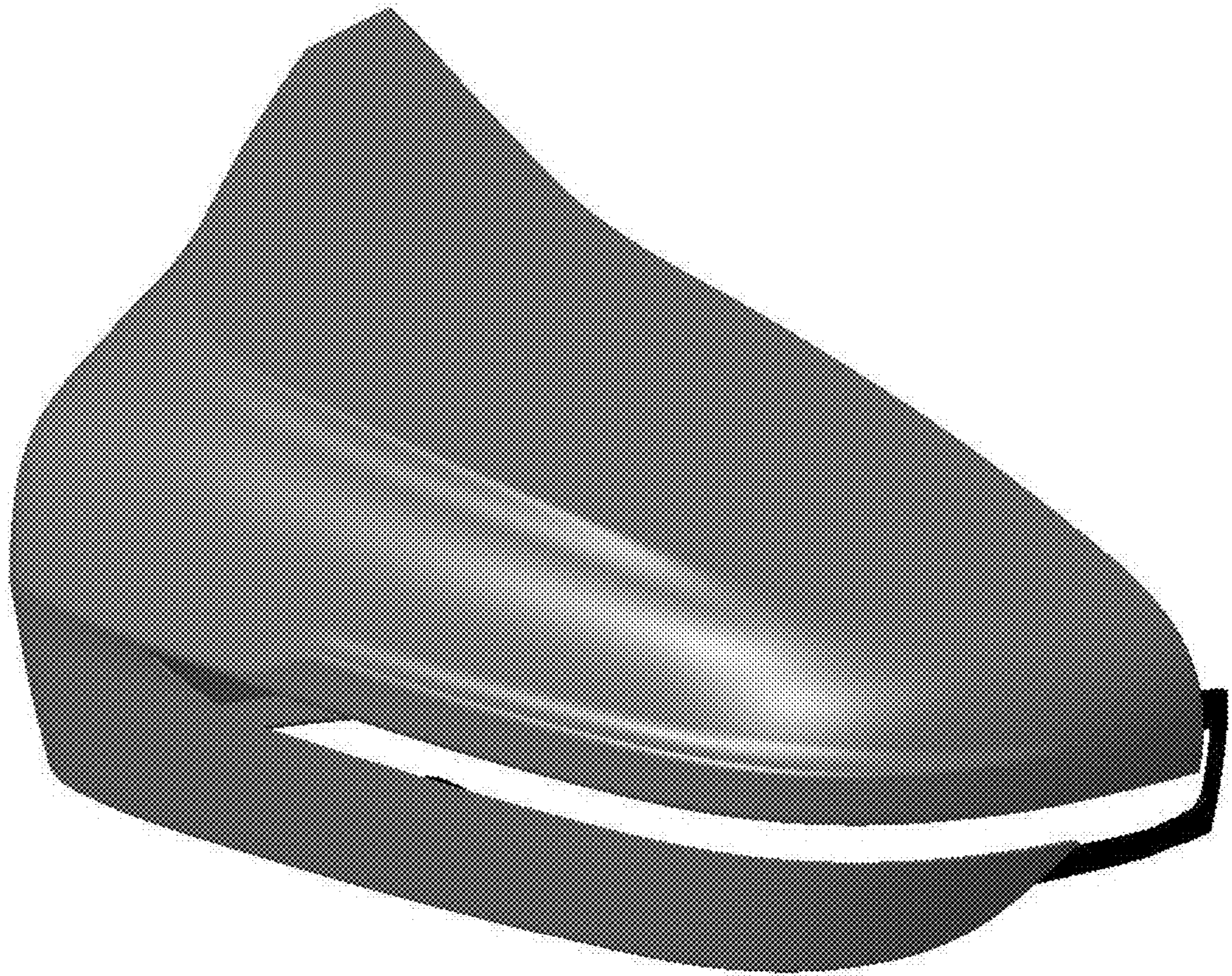

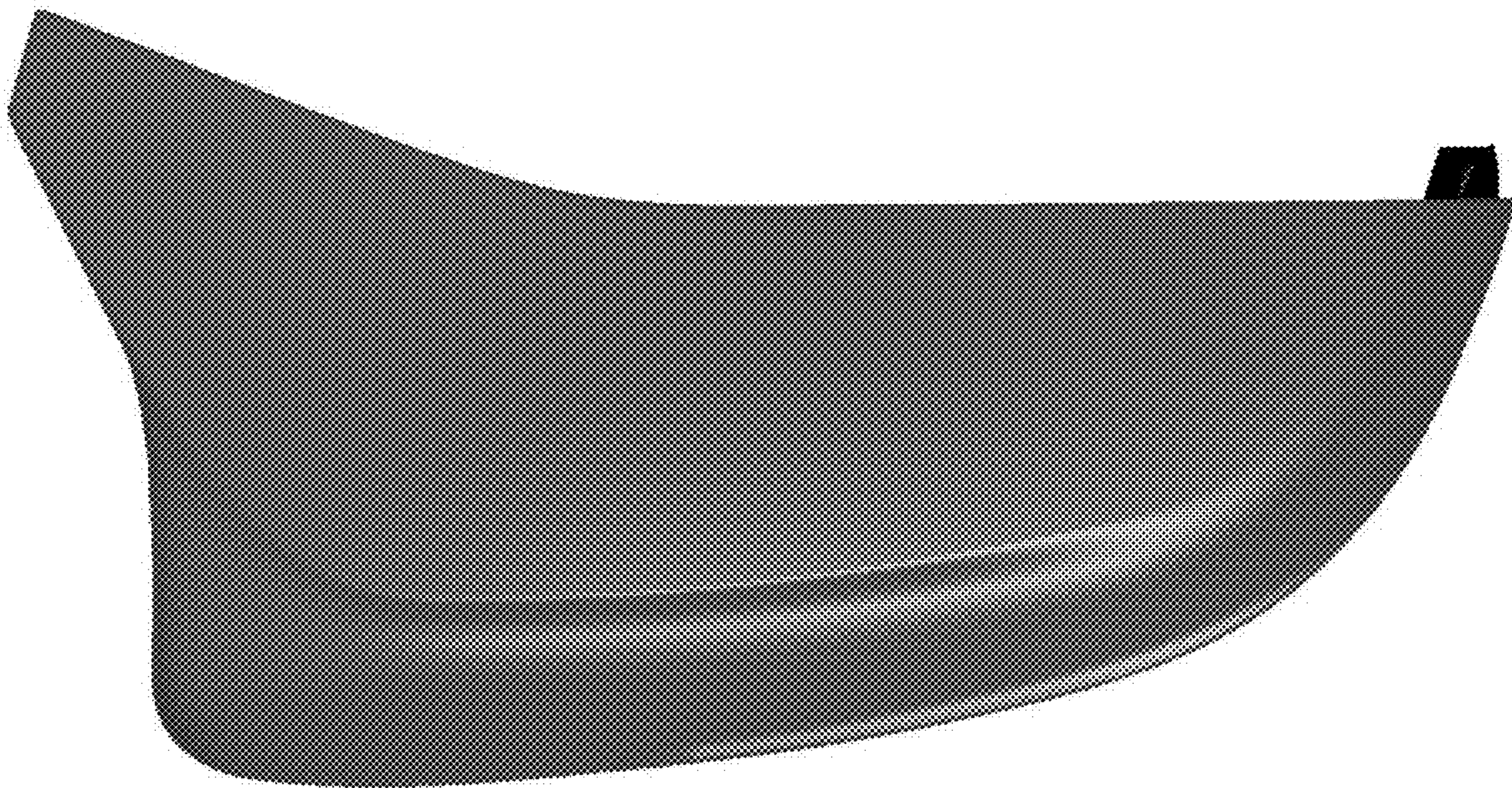

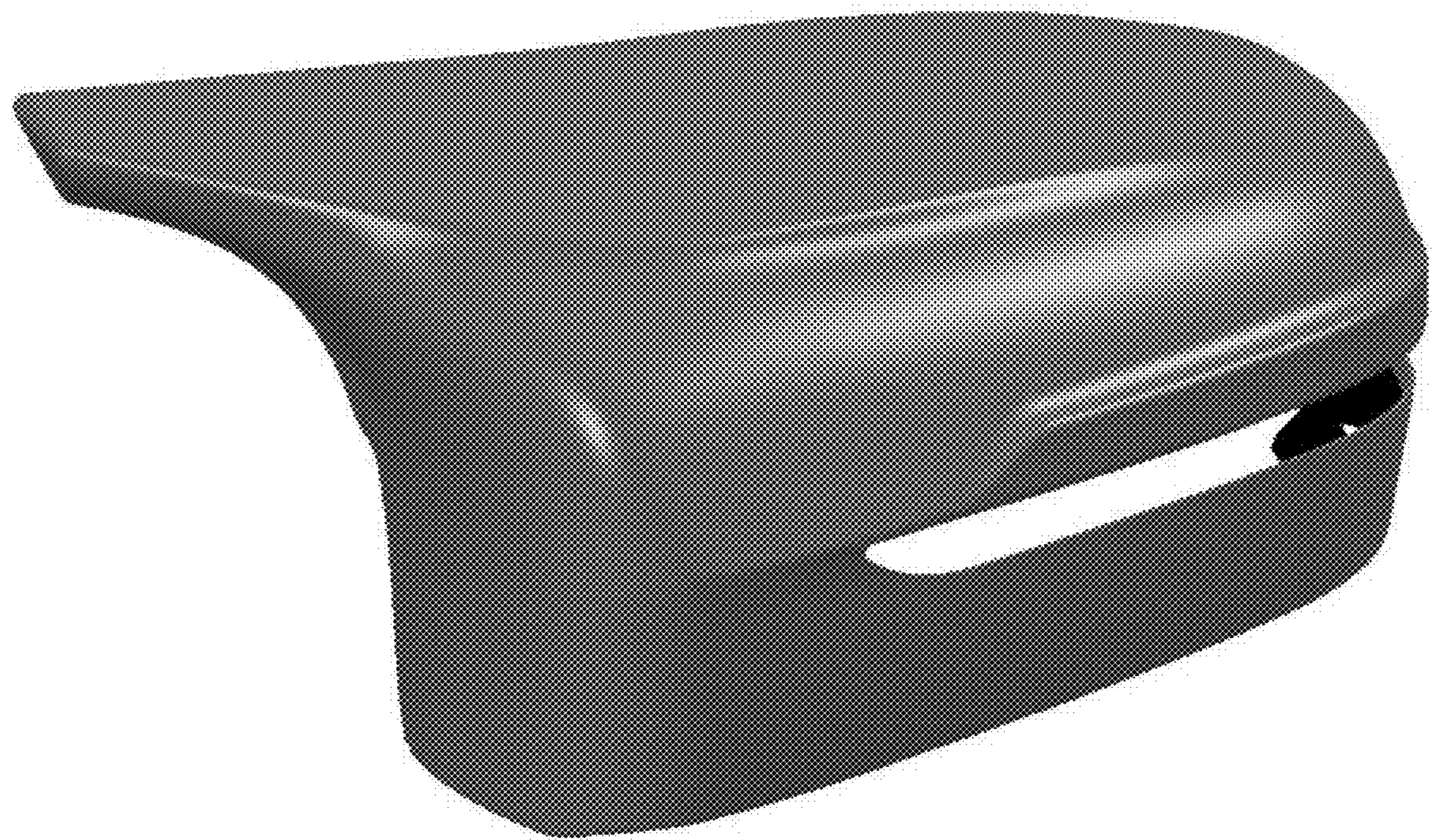
