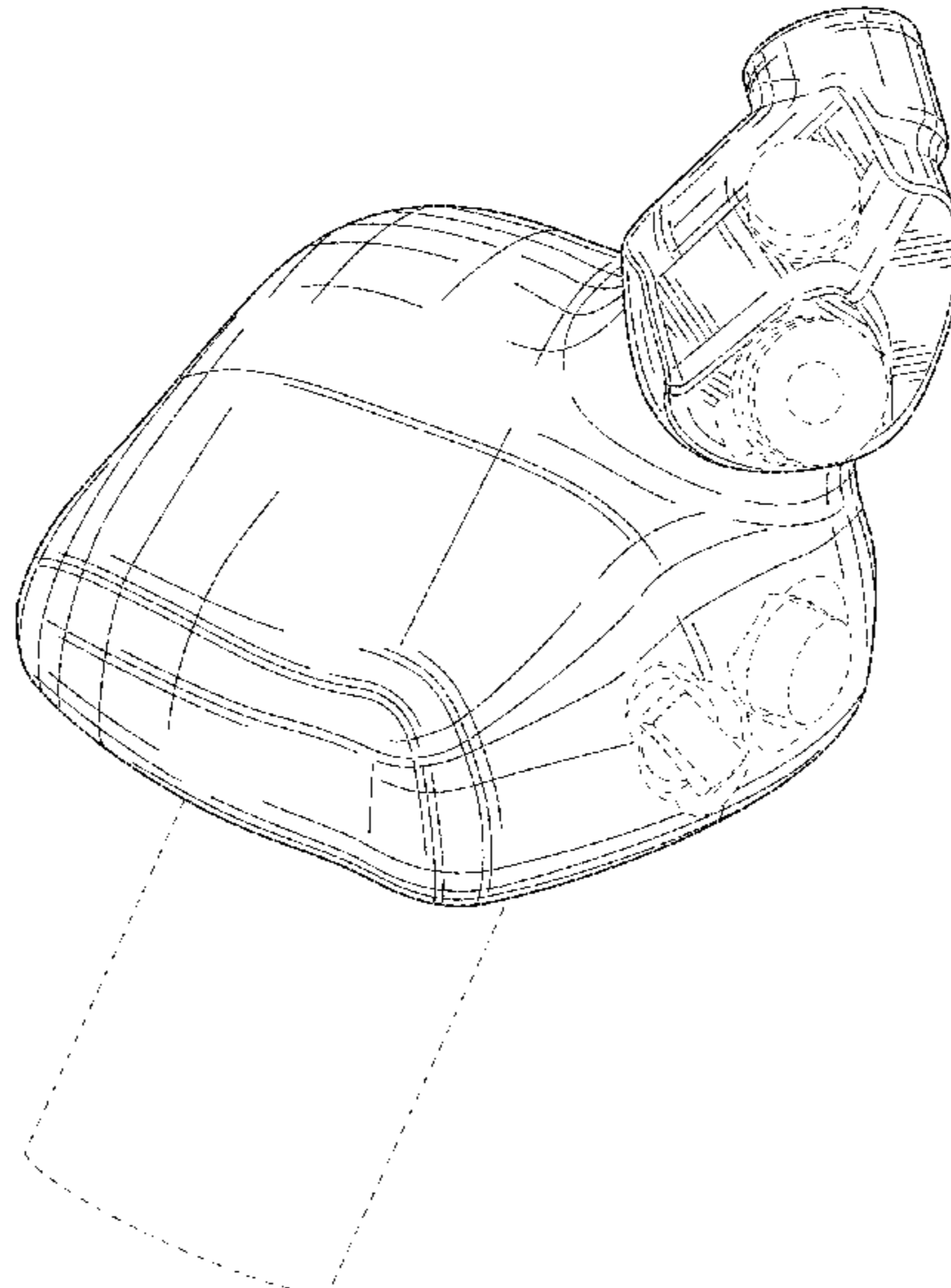
(57) **CLAIM**

The ornamental design for a controller for a rotorcraft, as shown and described.

DESCRIPTION

FIG. 1 is a left rear perspective view of a controller for a rotorcraft showing our new design.
FIG. 2 is a front view of the controller for a rotorcraft.
FIG. 3 is a rear view of the controller for a rotorcraft.
FIG. 4 is a left sided view of the controller for a rotorcraft.
FIG. 5 is a right side view of the controller for a rotorcraft.
FIG. 6 is top plan view of the controller for a rotorcraft; and, FIG. 7 is a bottom plan view of a controller for a rotorcraft.
The broken lines shown in the drawings depict portions of the controller for a rotorcraft that form no part of the claimed design.

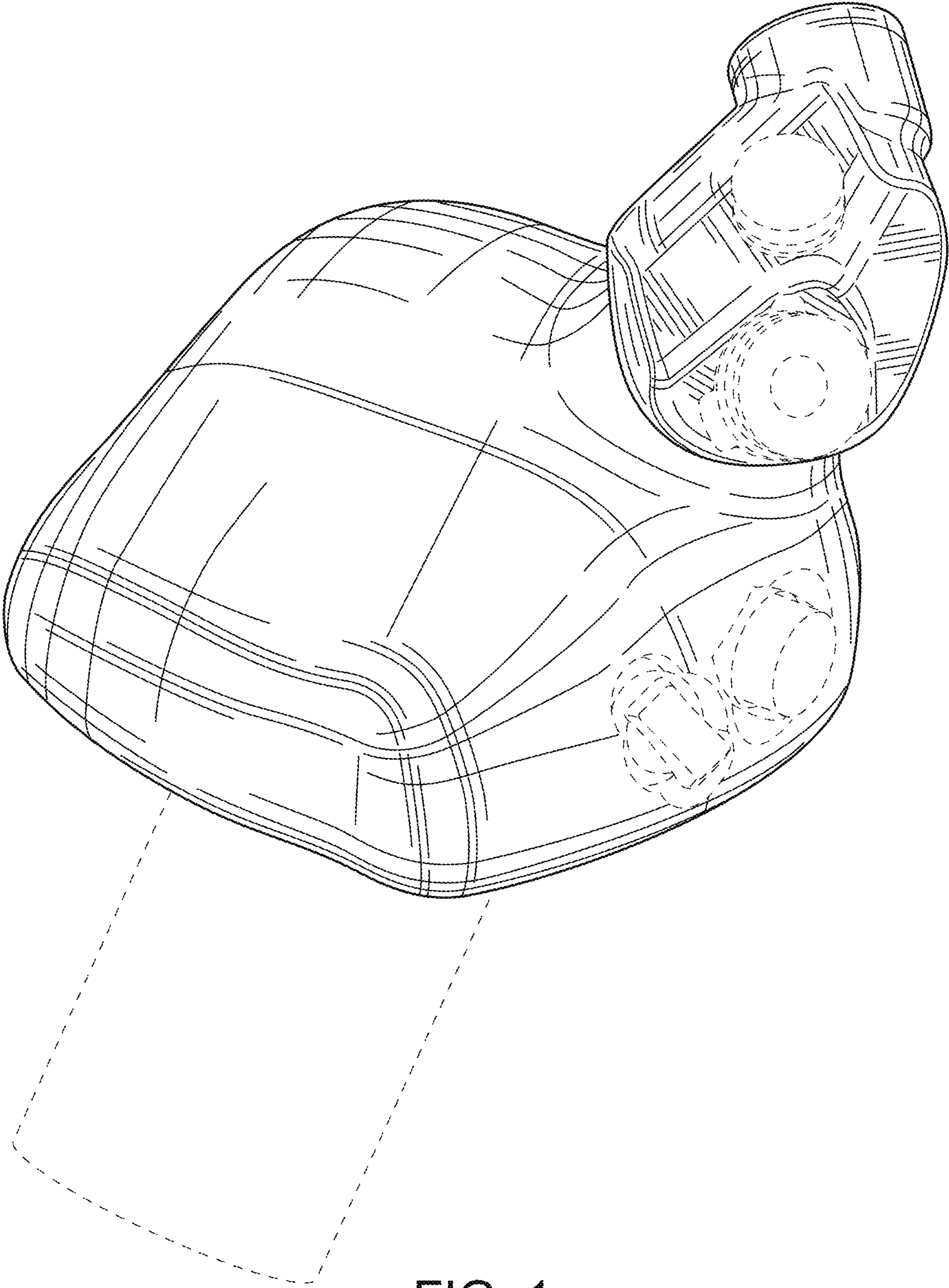

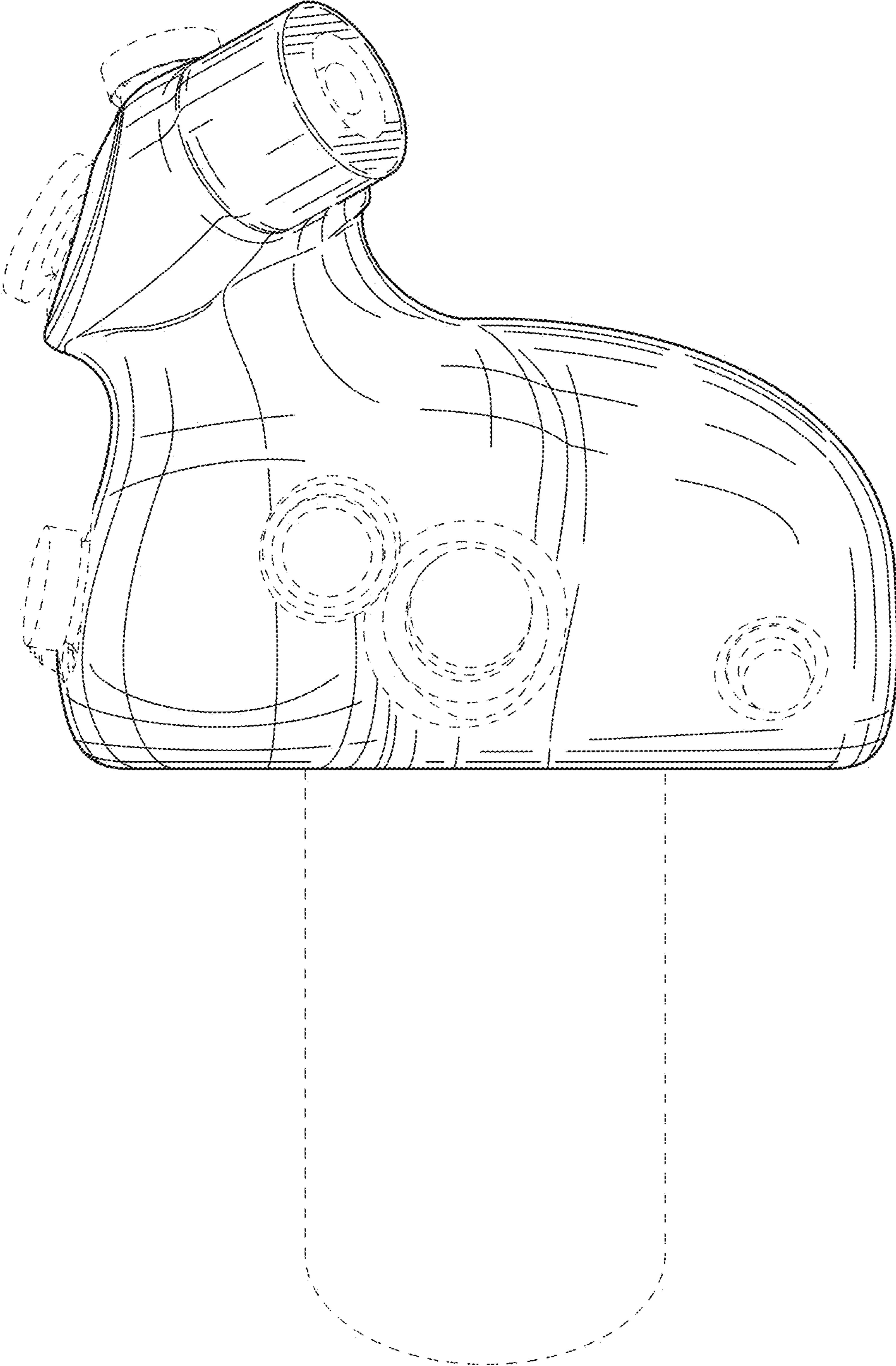

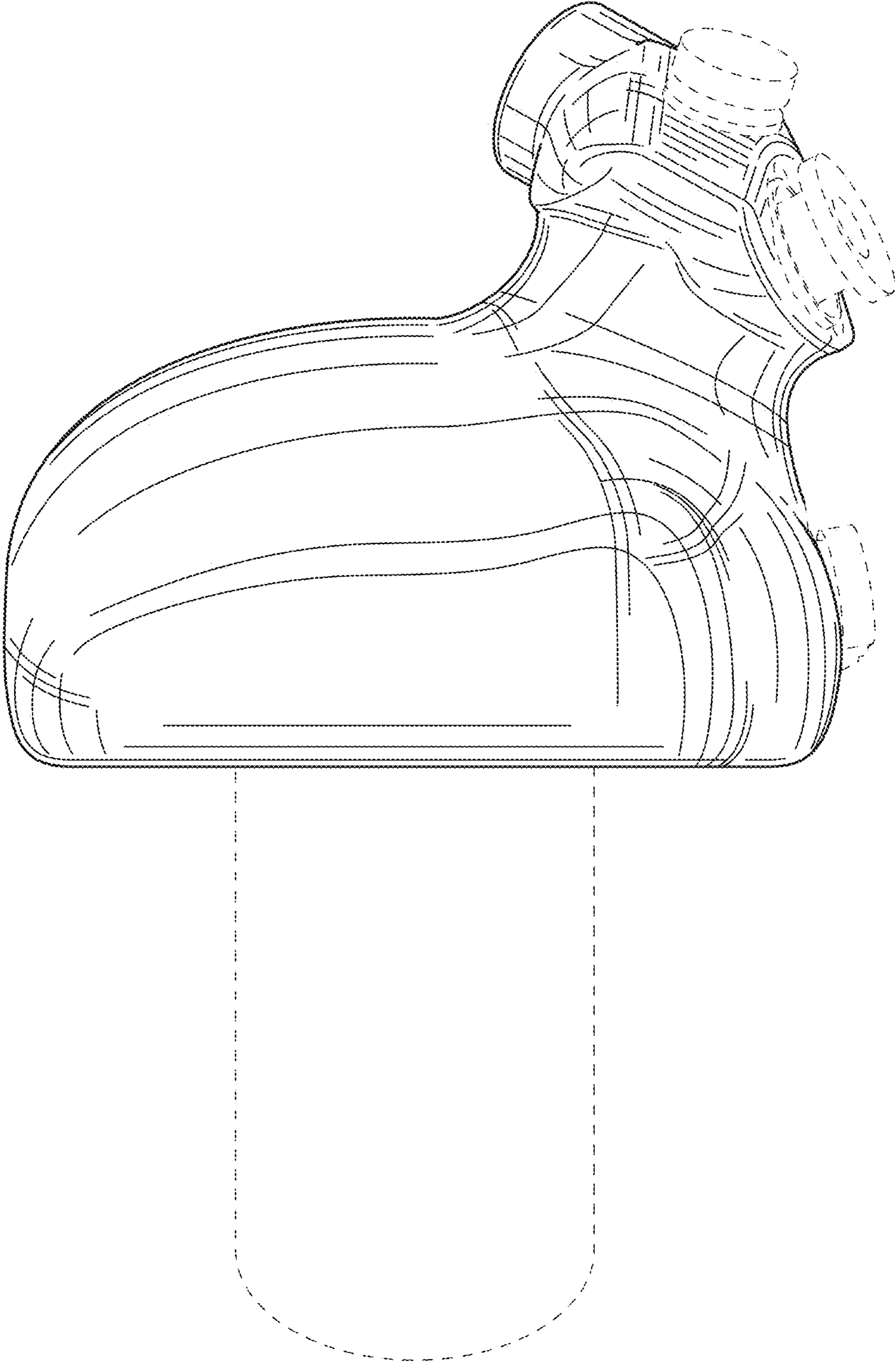

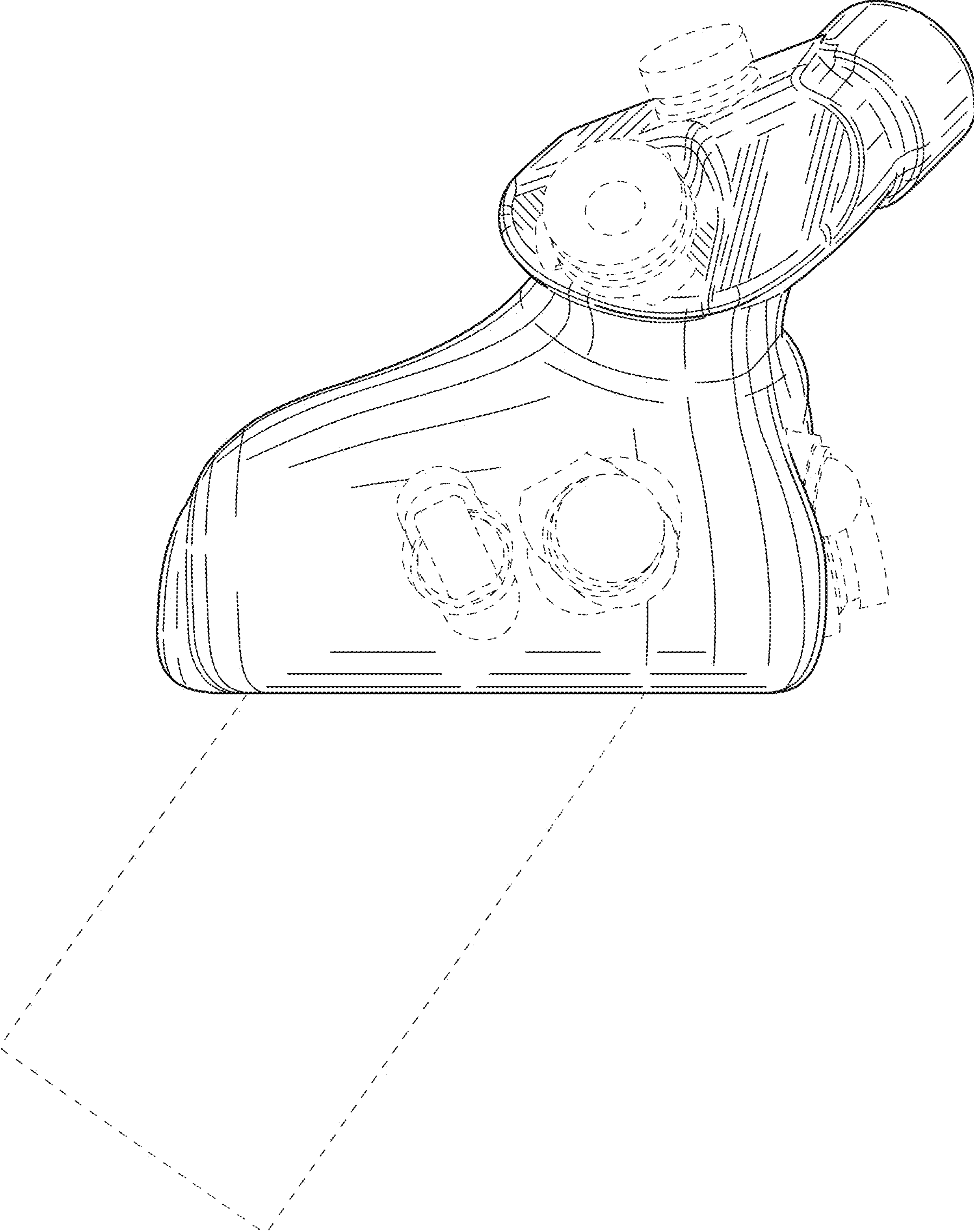

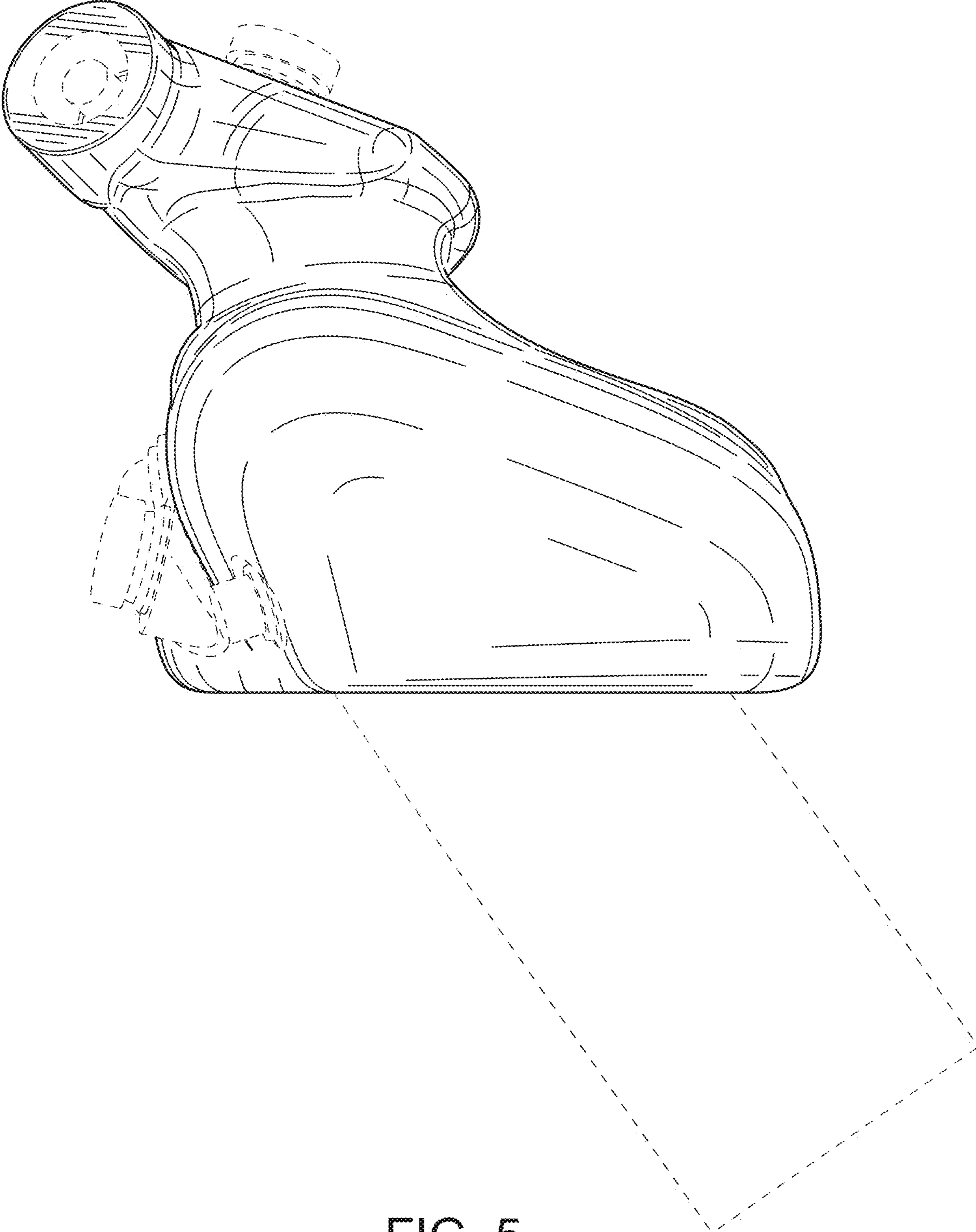

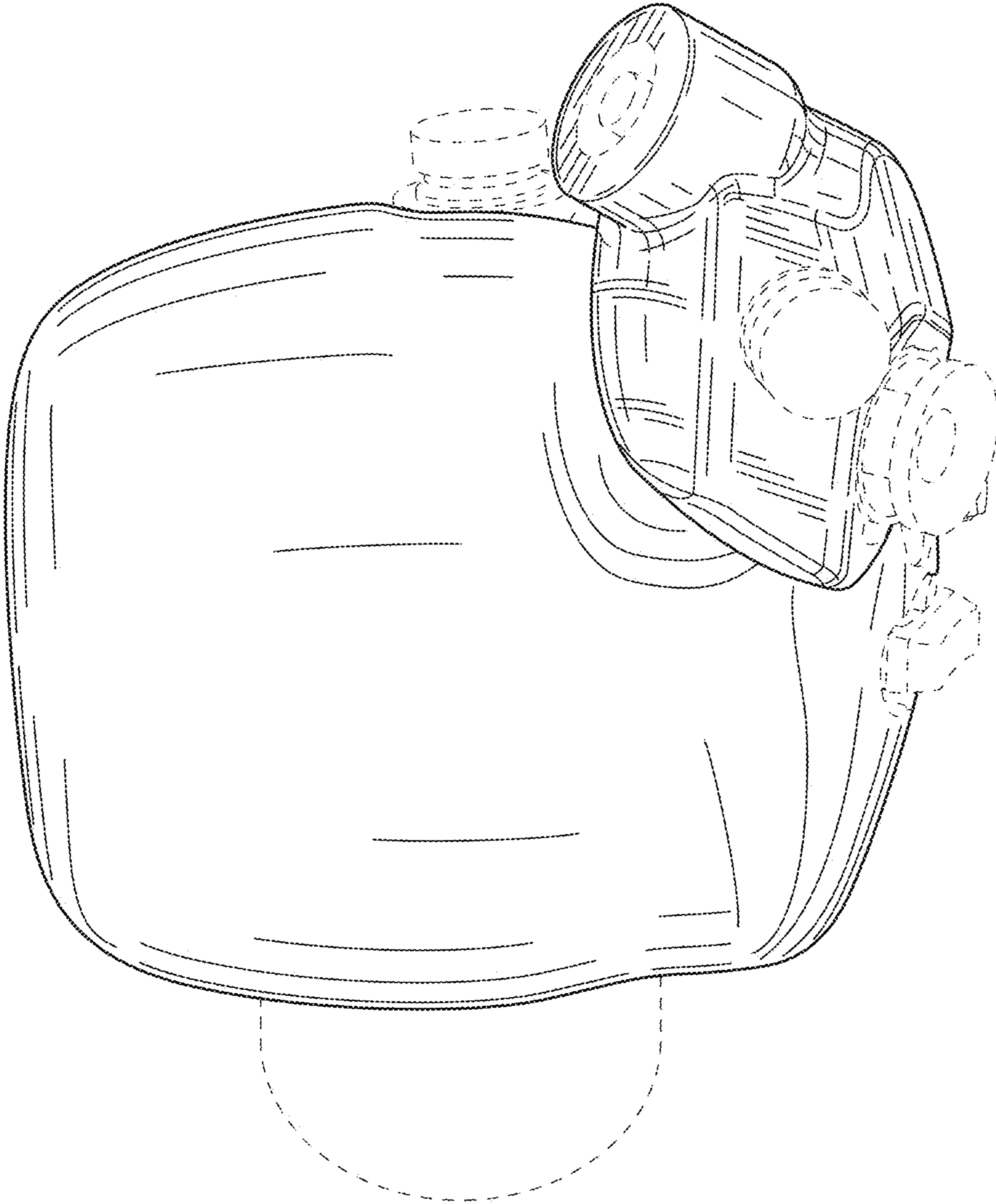

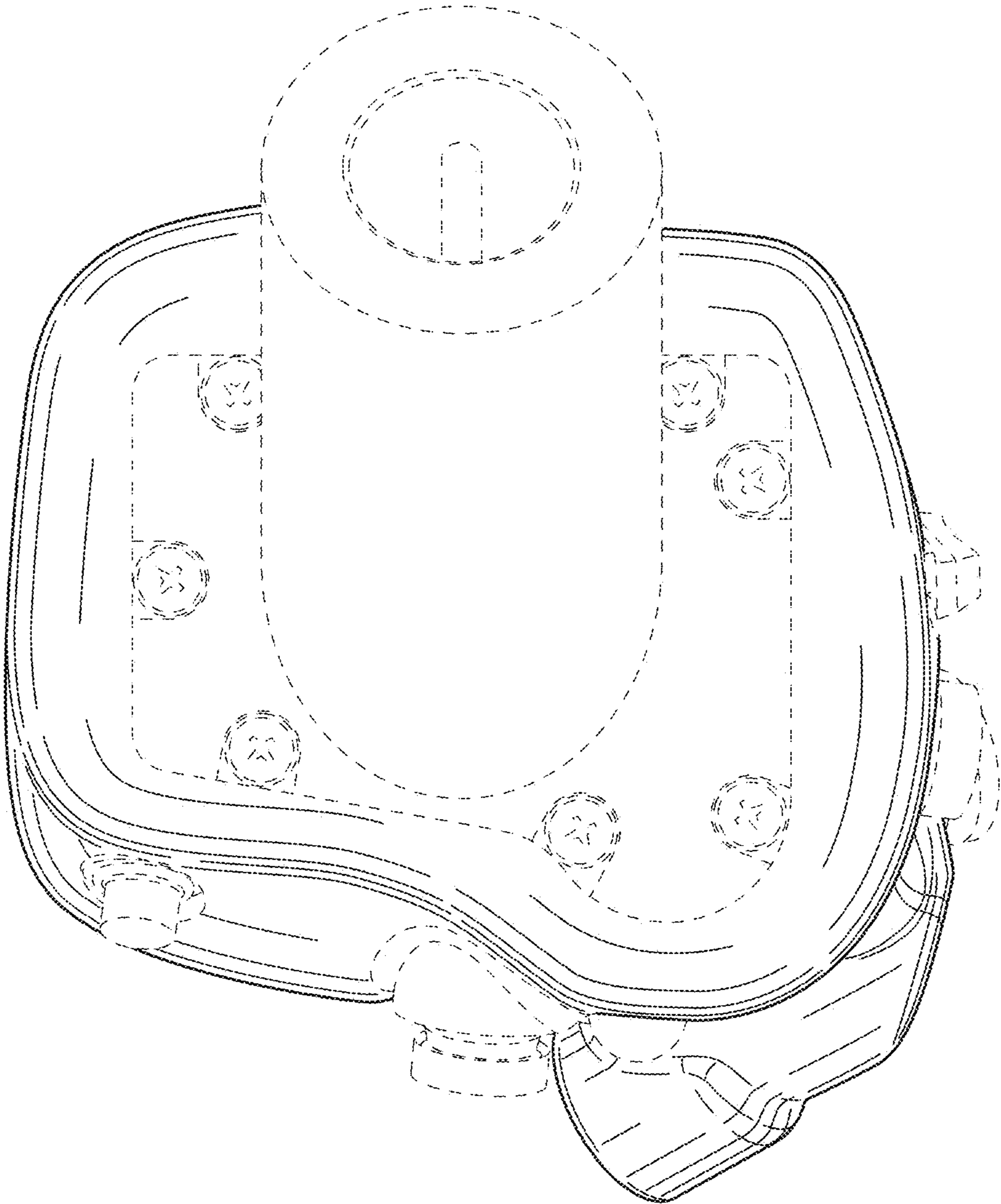
