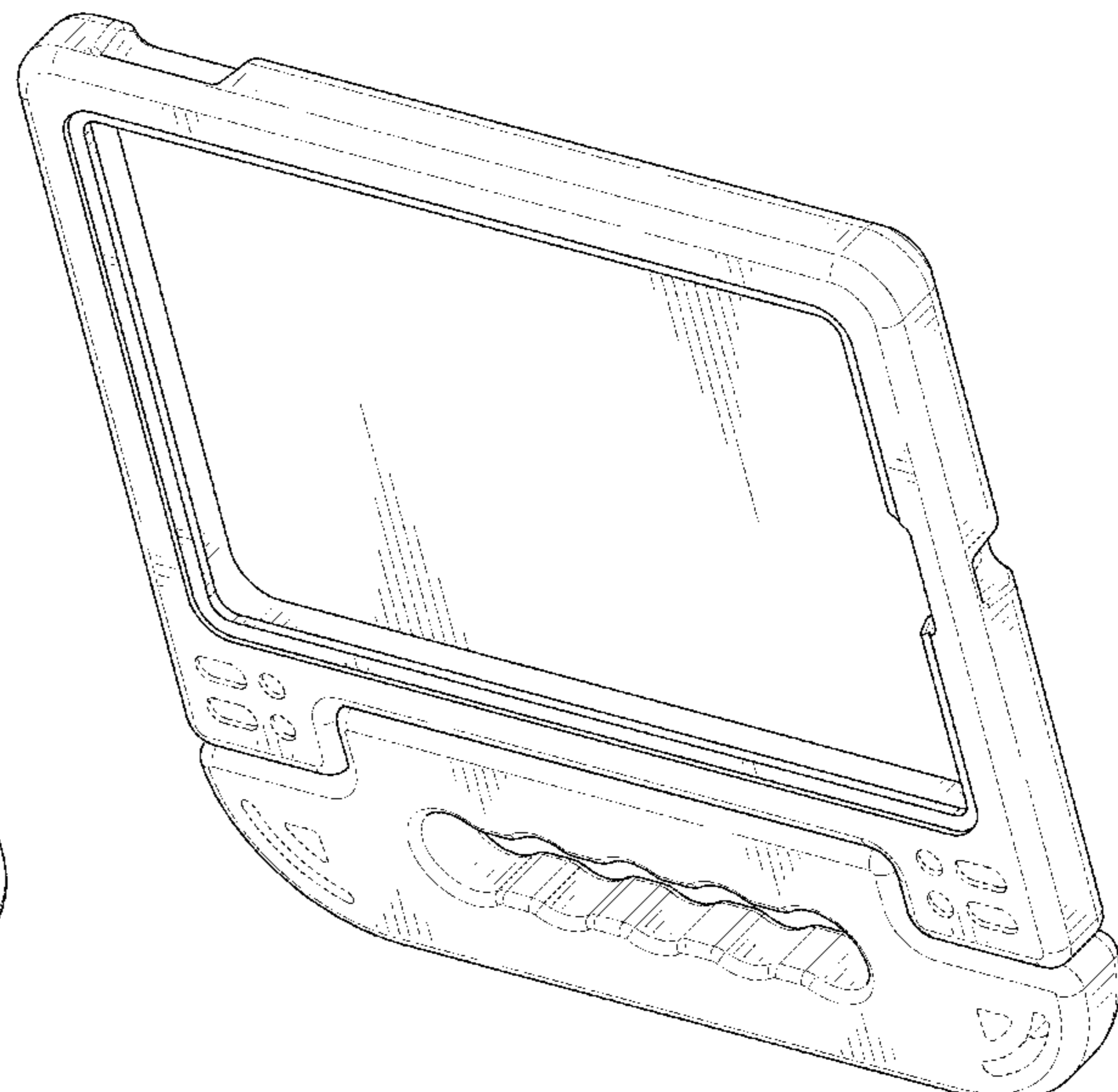
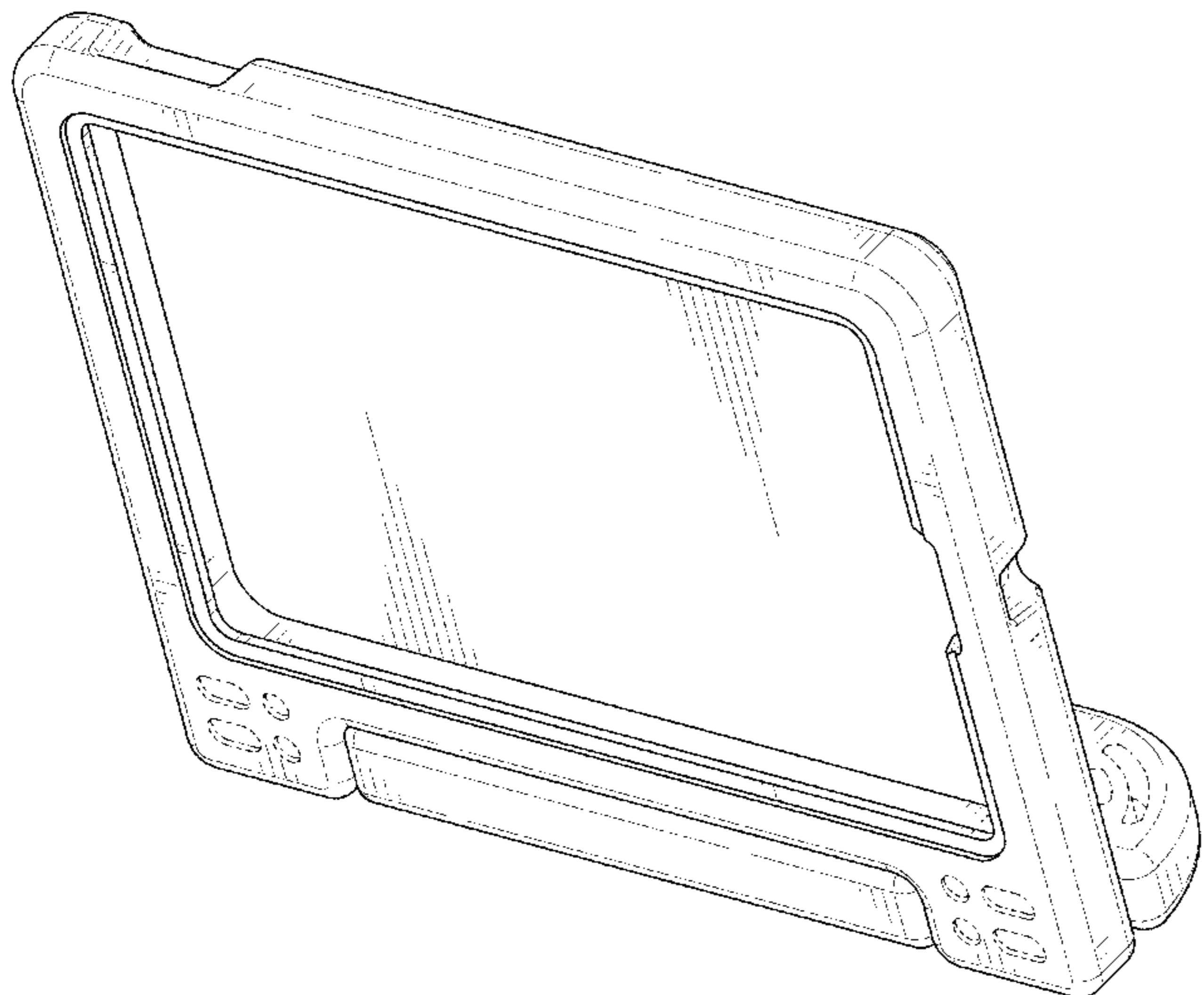
(57) **CLAIM**

The ornamental design for a tablet case, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a tablet case showing my new design;
FIG. 2 is a rear, left side, bottom perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a front, right side, top perspective view thereof showing the handle portion of the tablet case moved from its support base position to its carrying position.
The broken lines depict portions of the tablet case that form no part of the claimed design.

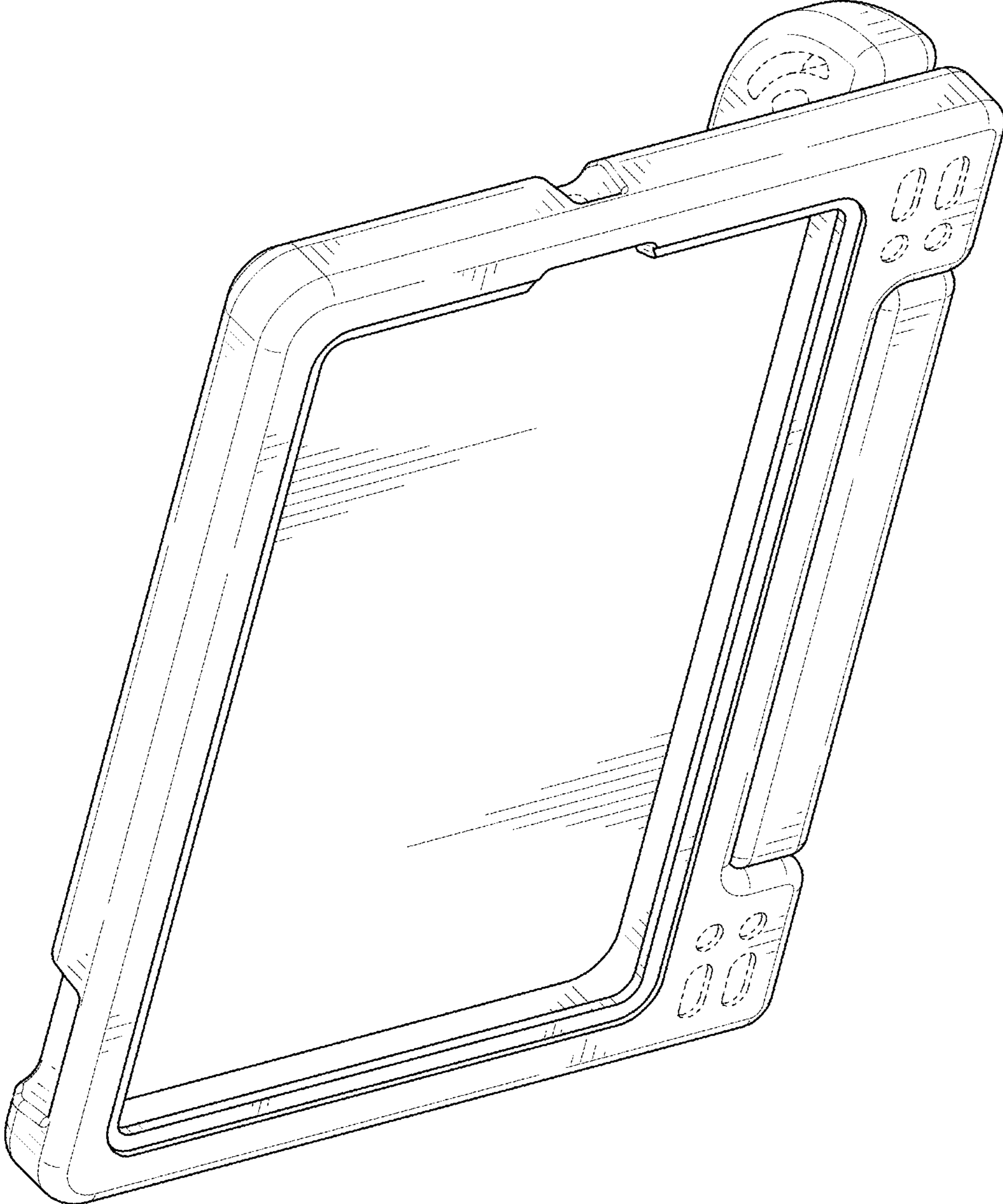

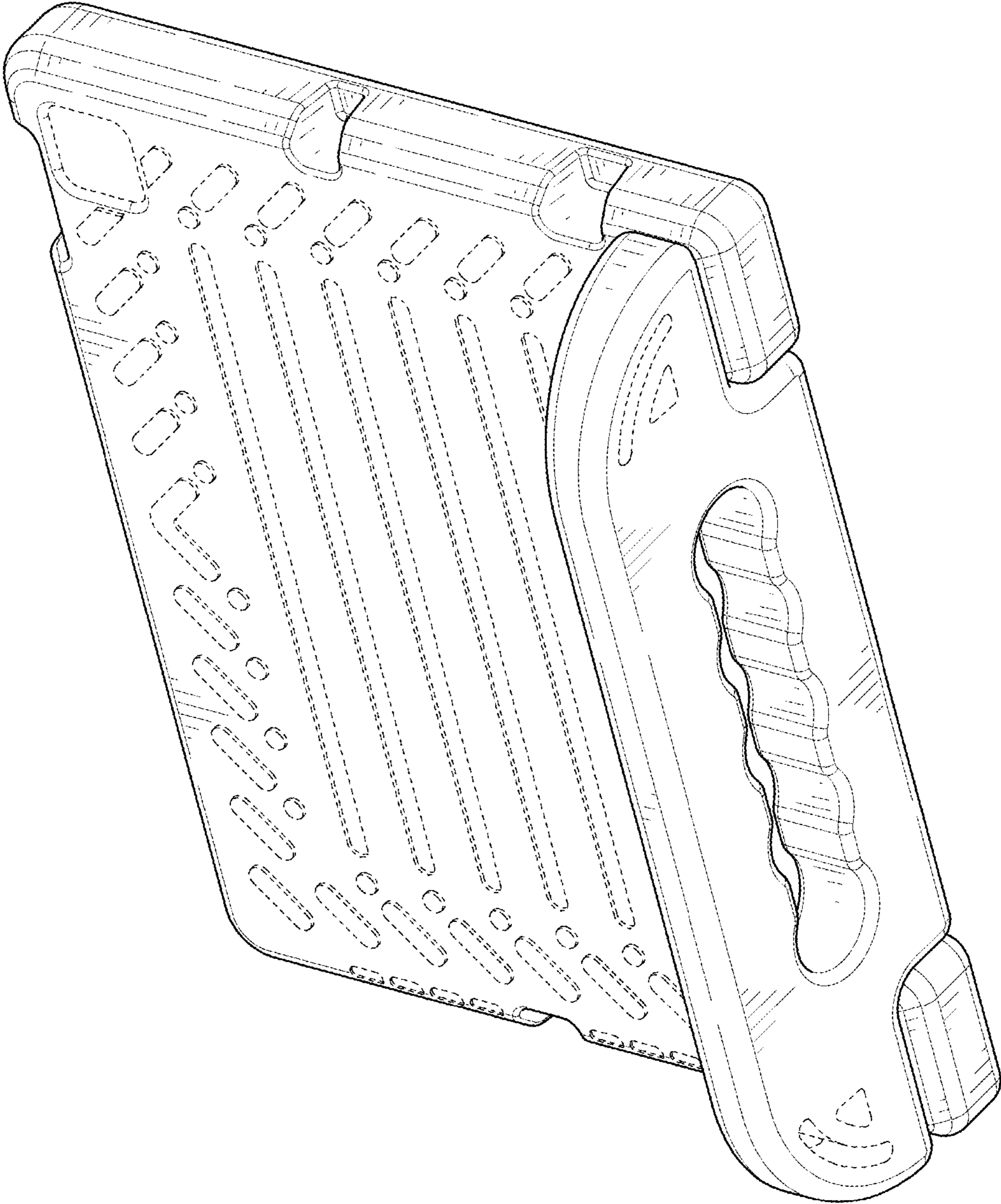

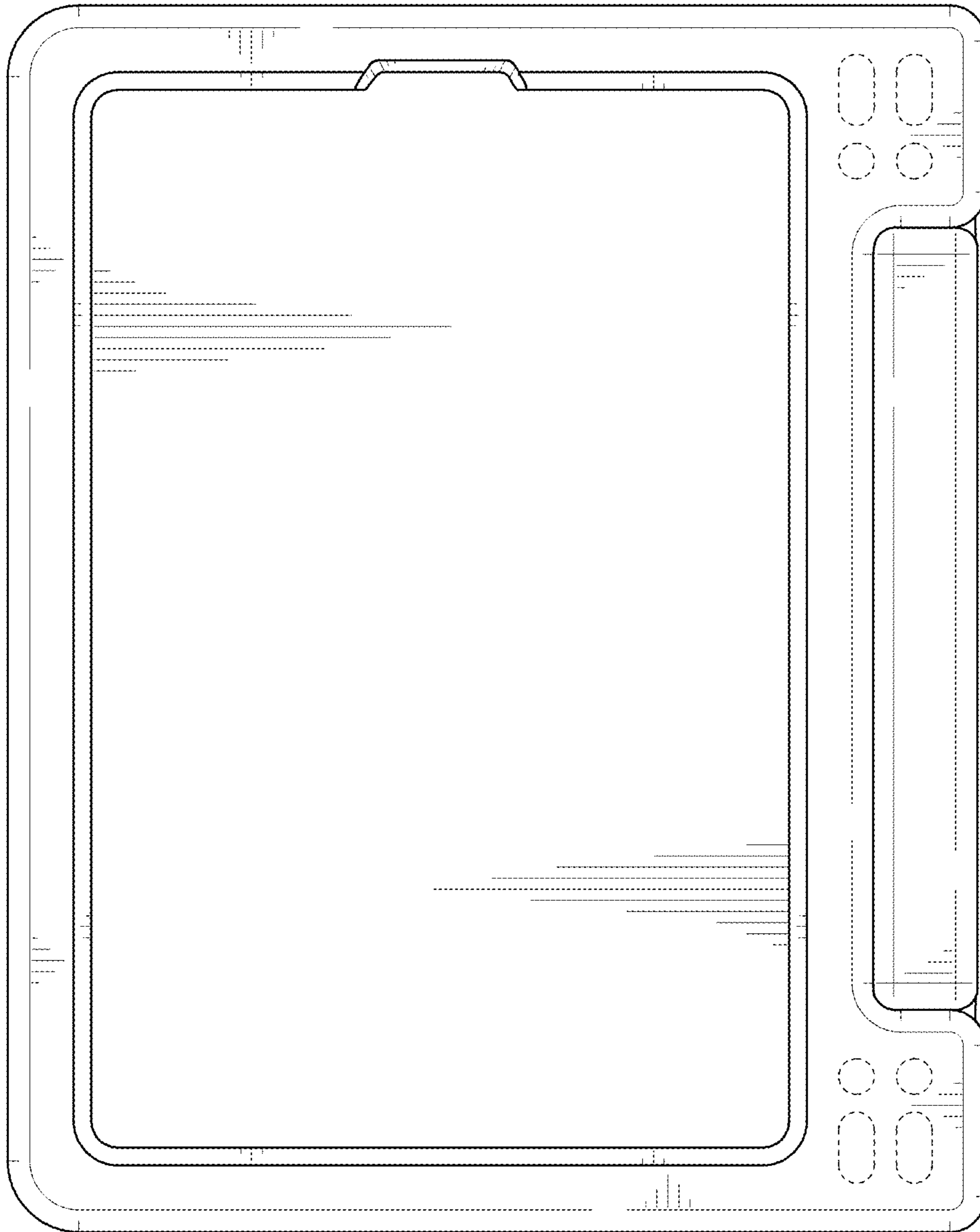

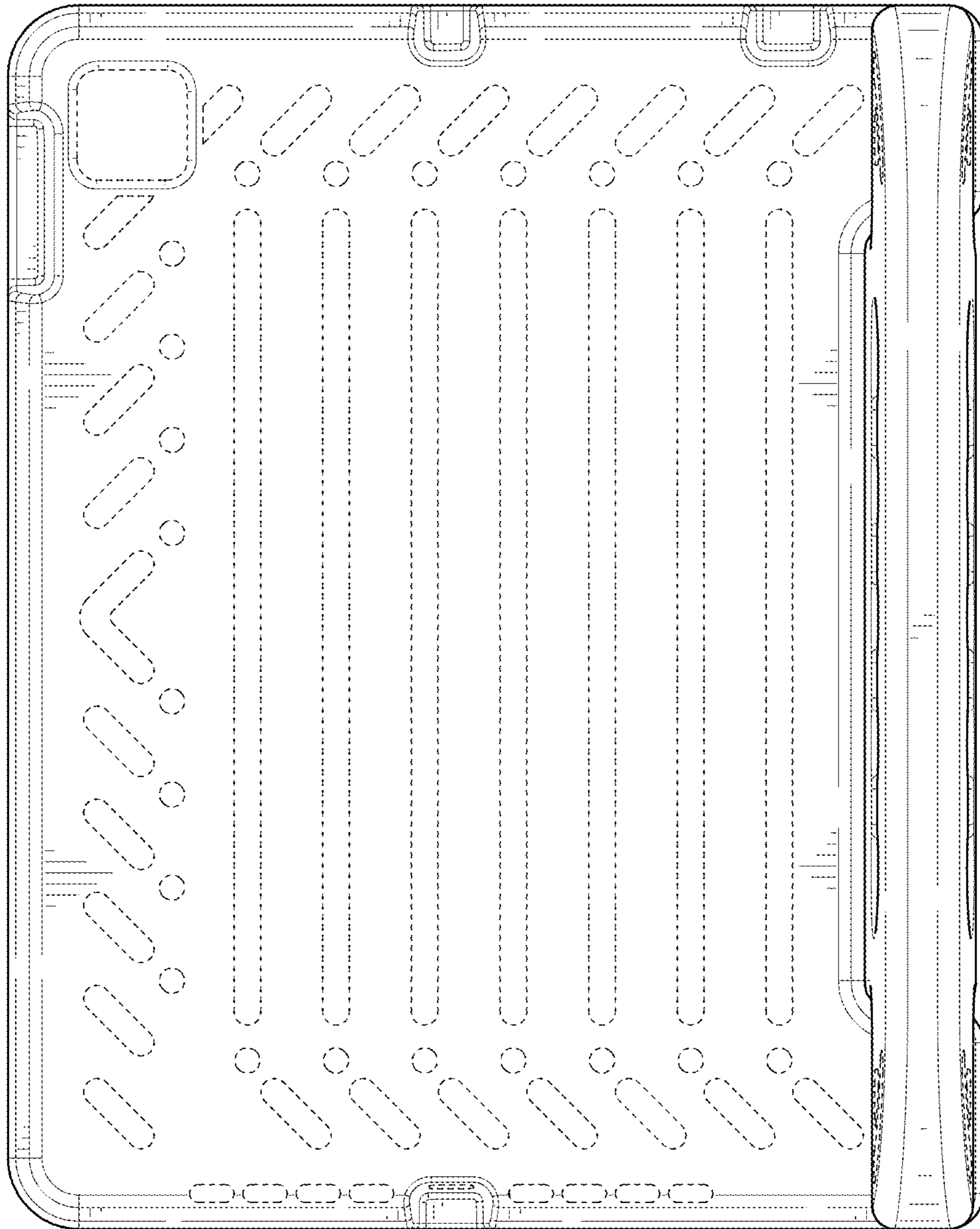

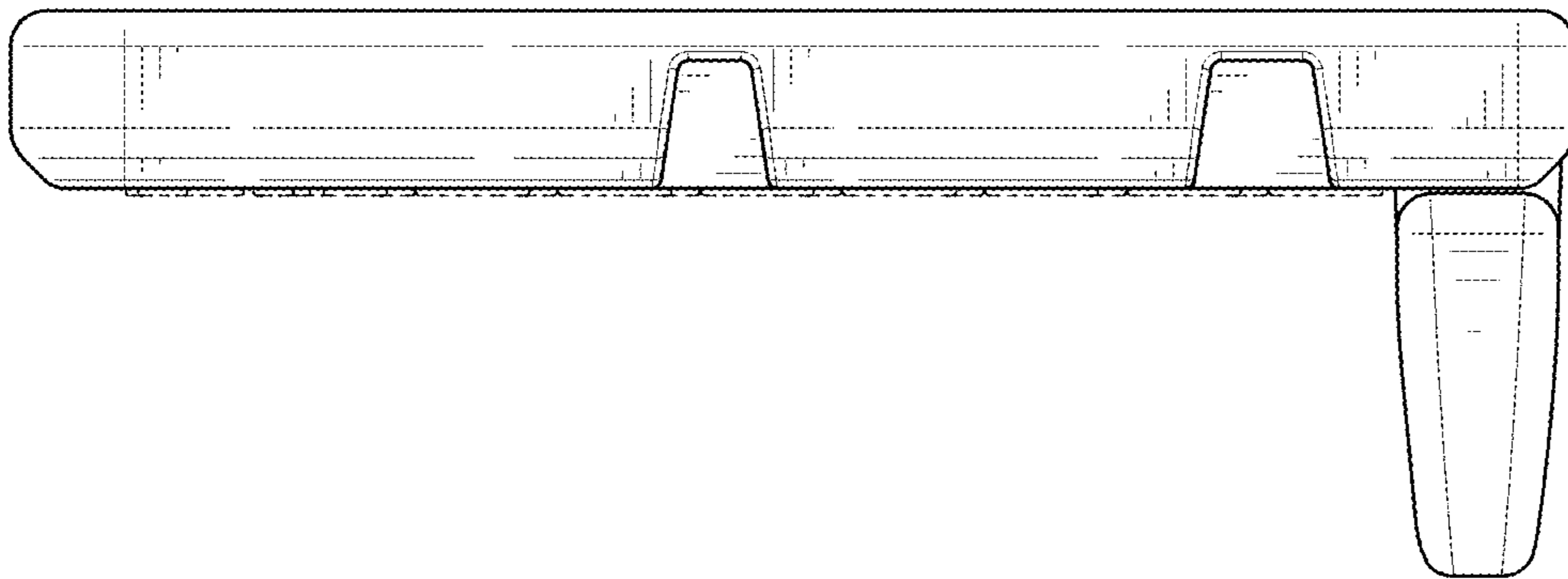

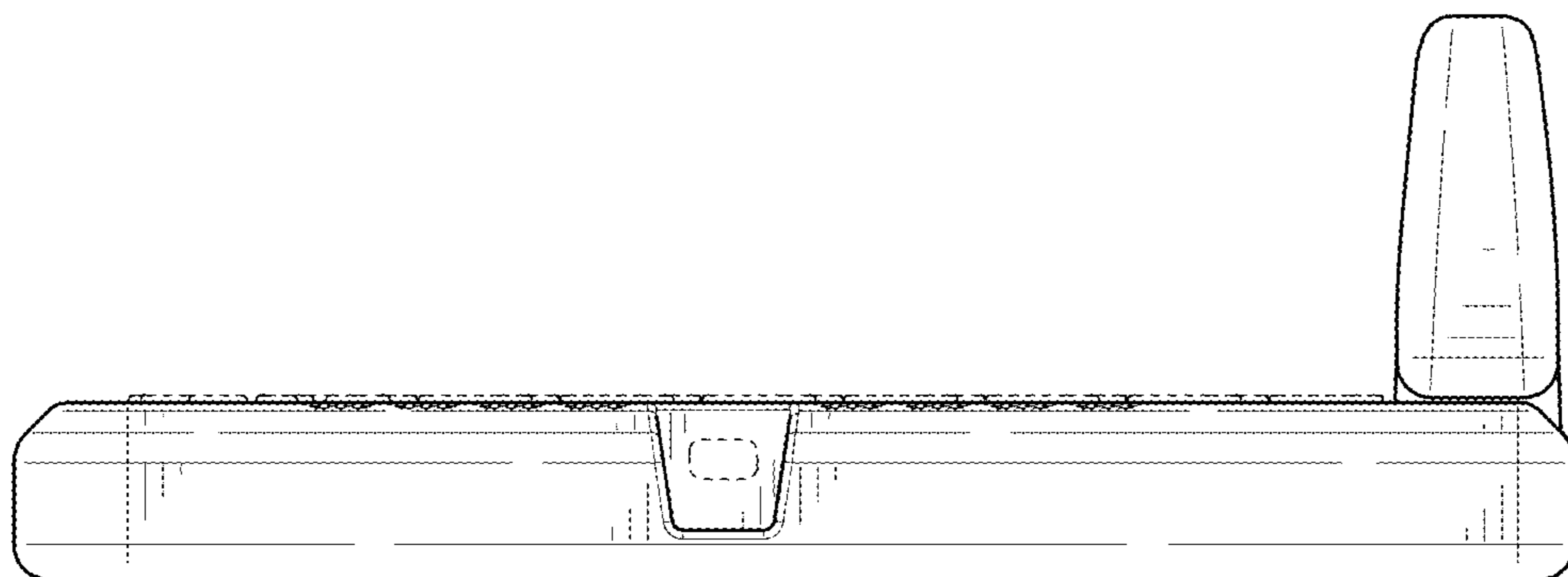

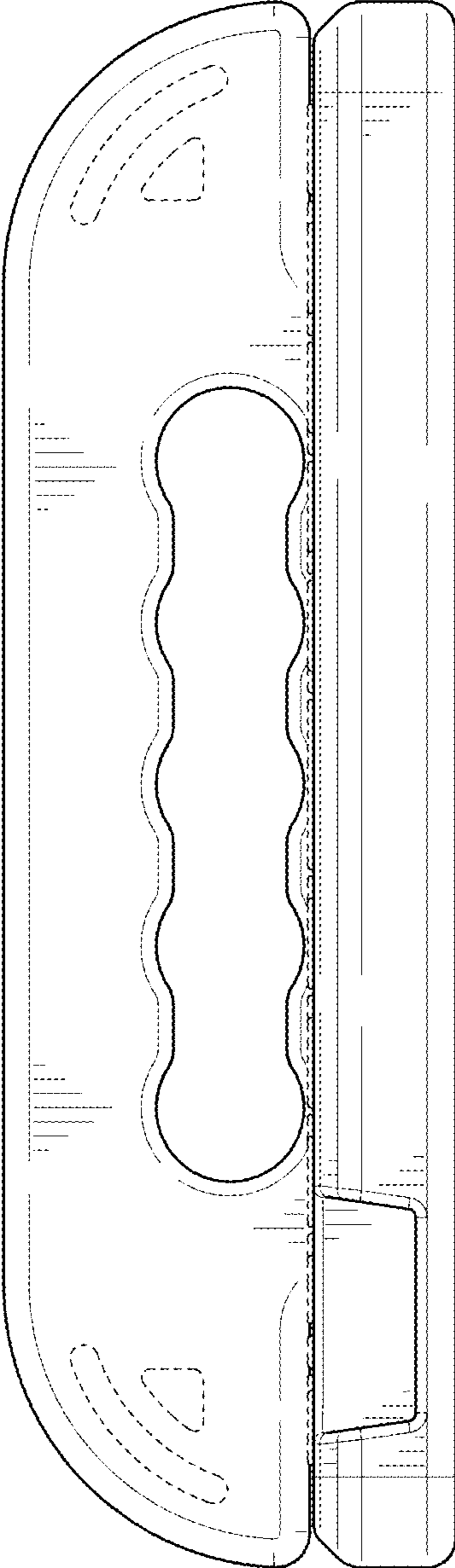

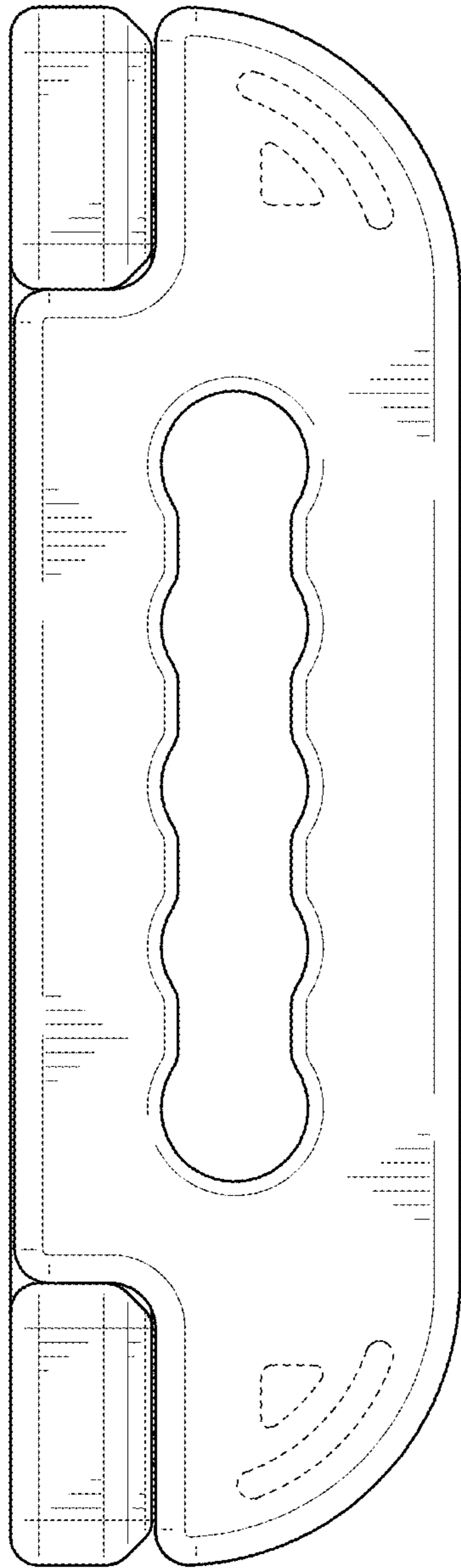

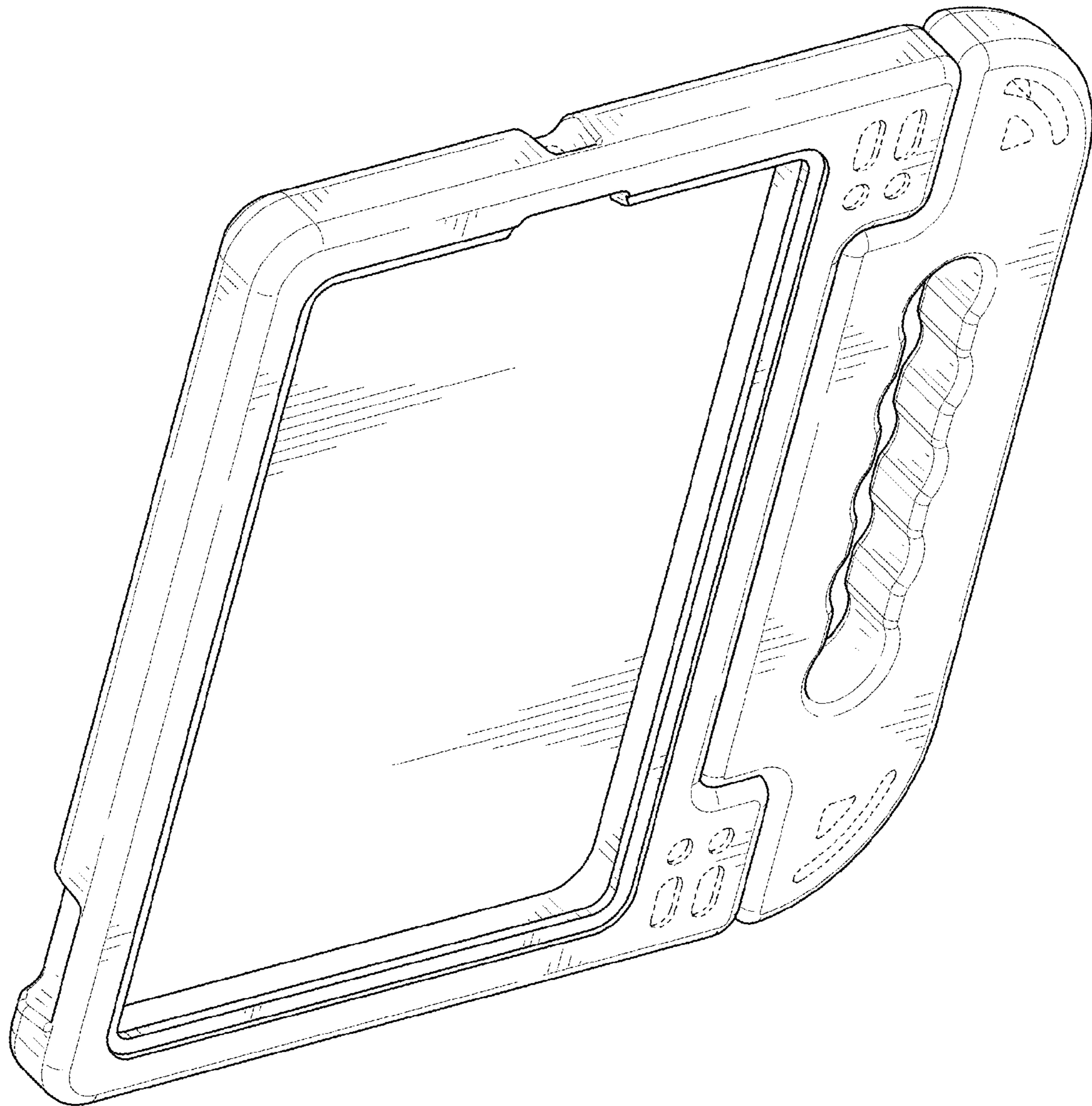
