We claim the ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

FIG. 8 is the eighth image in a sequence thereof; and,

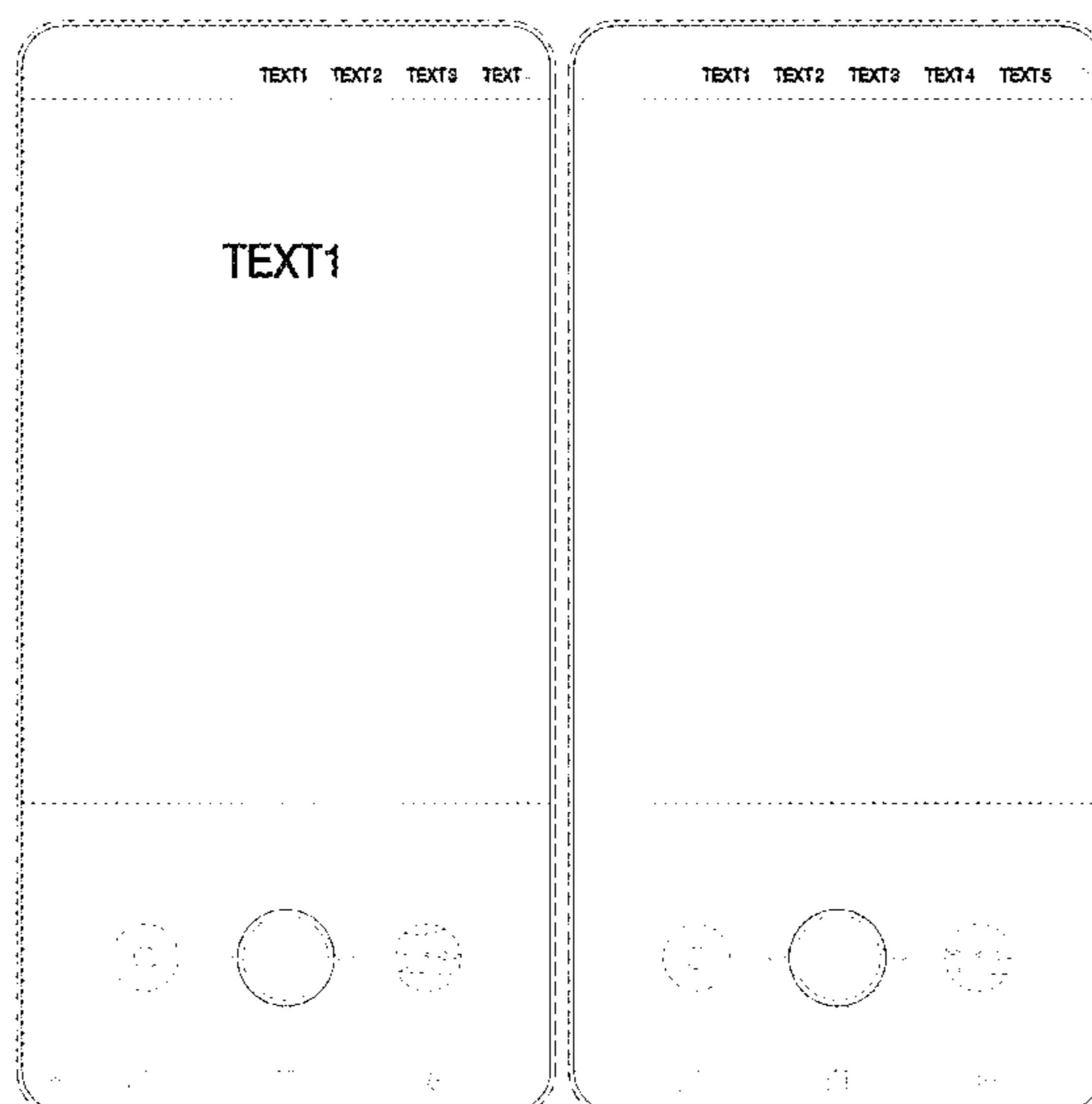
FIG. 9 is the ninth image in a sequence thereof.

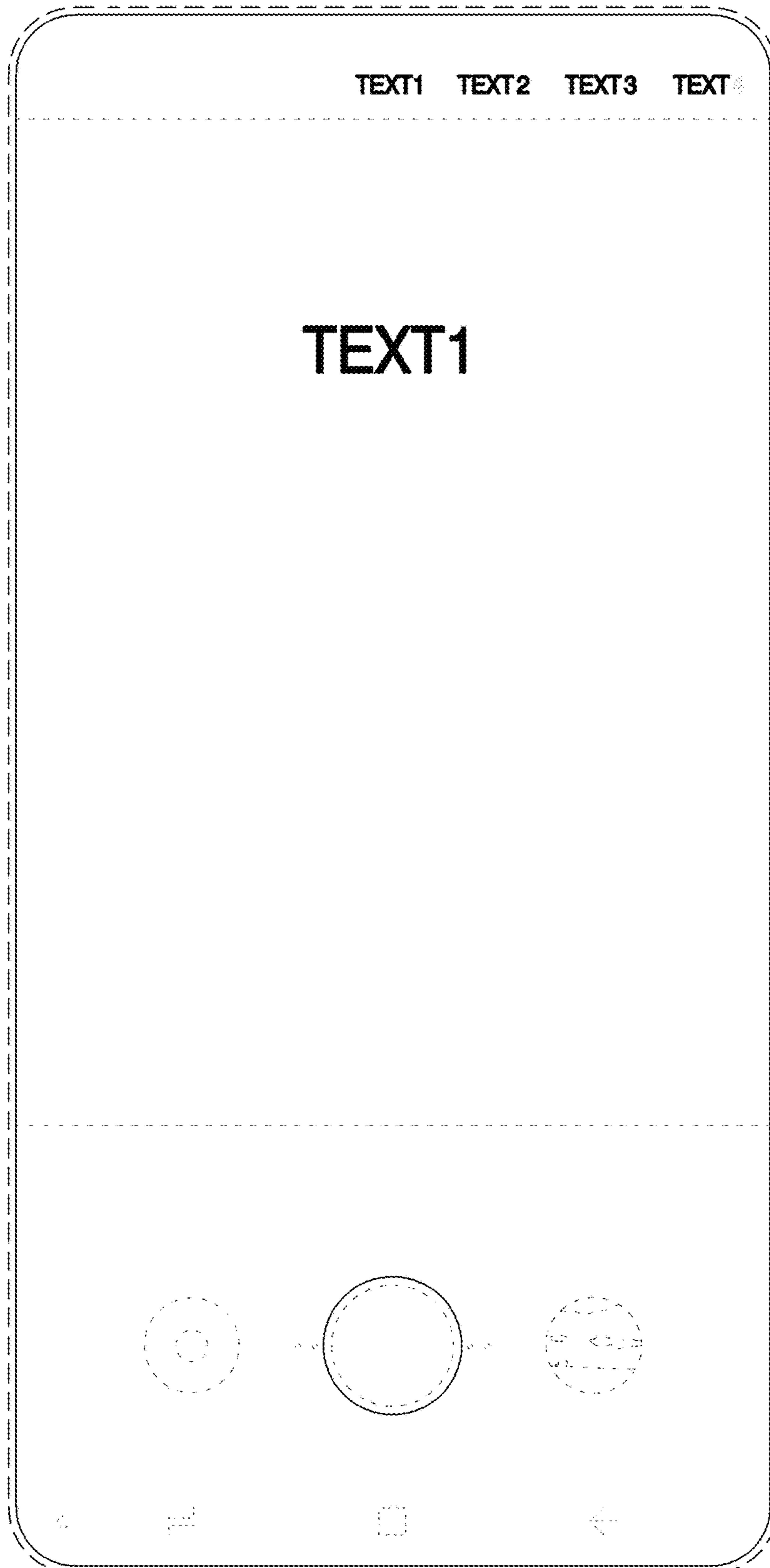

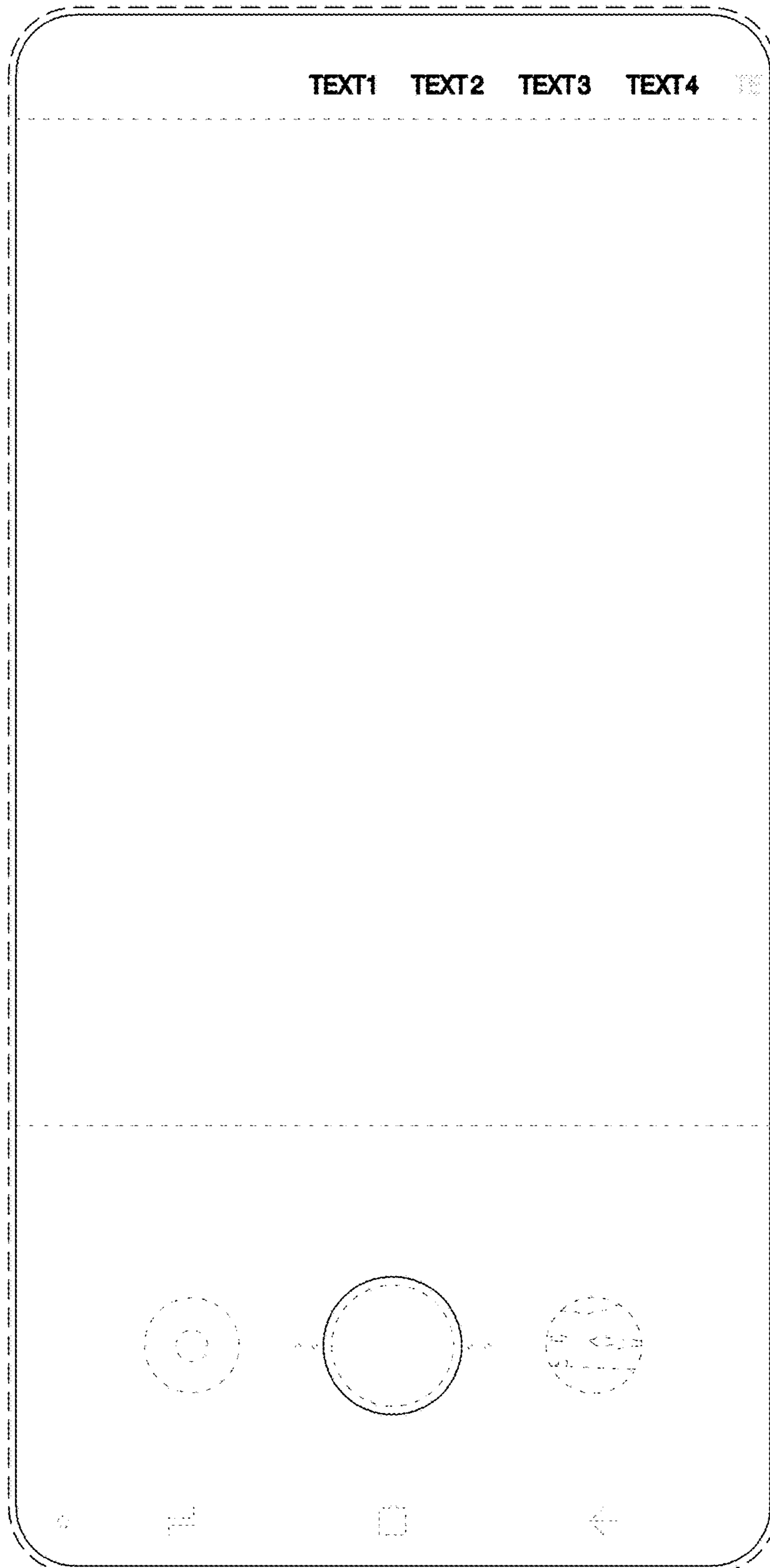

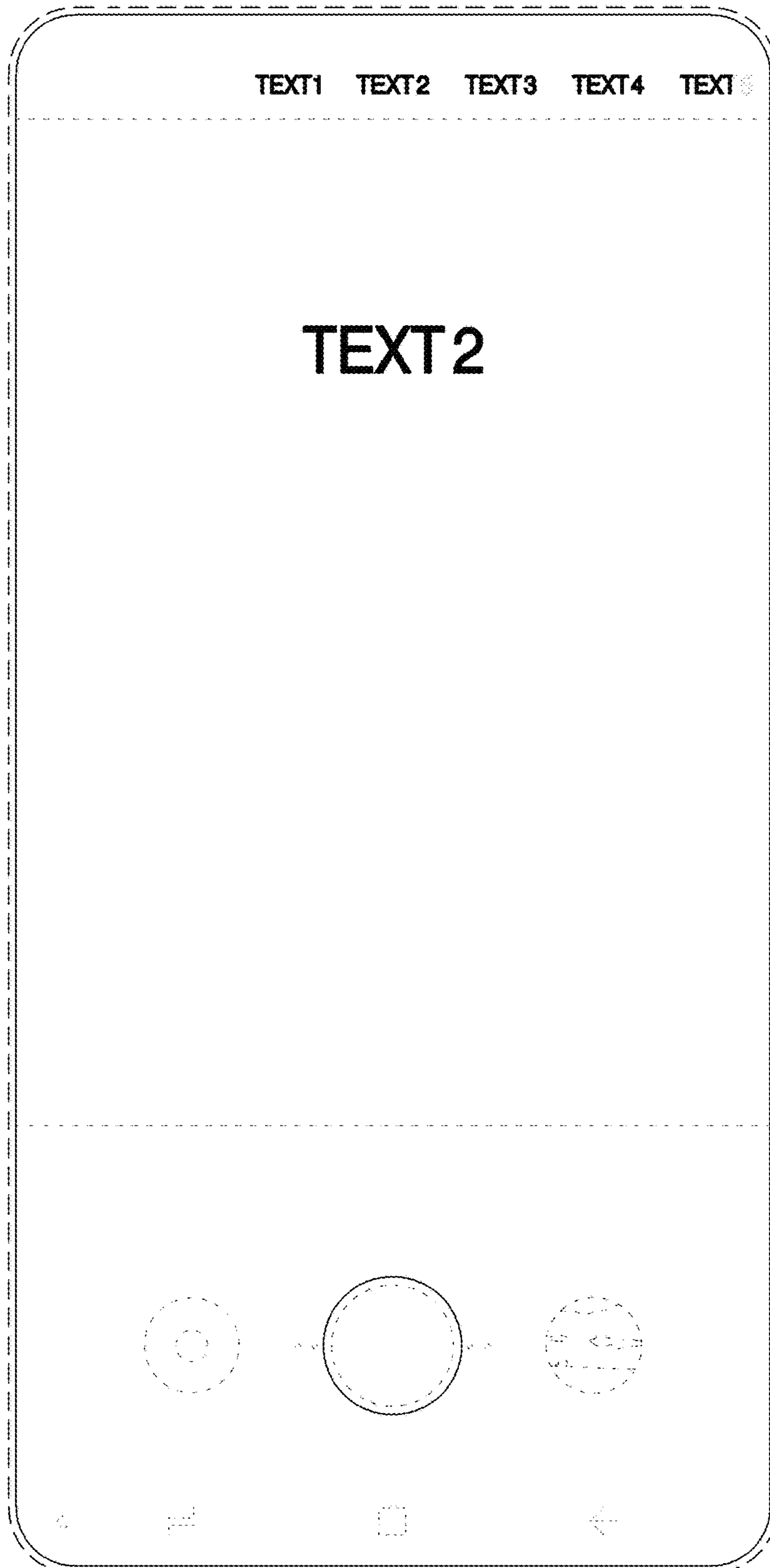

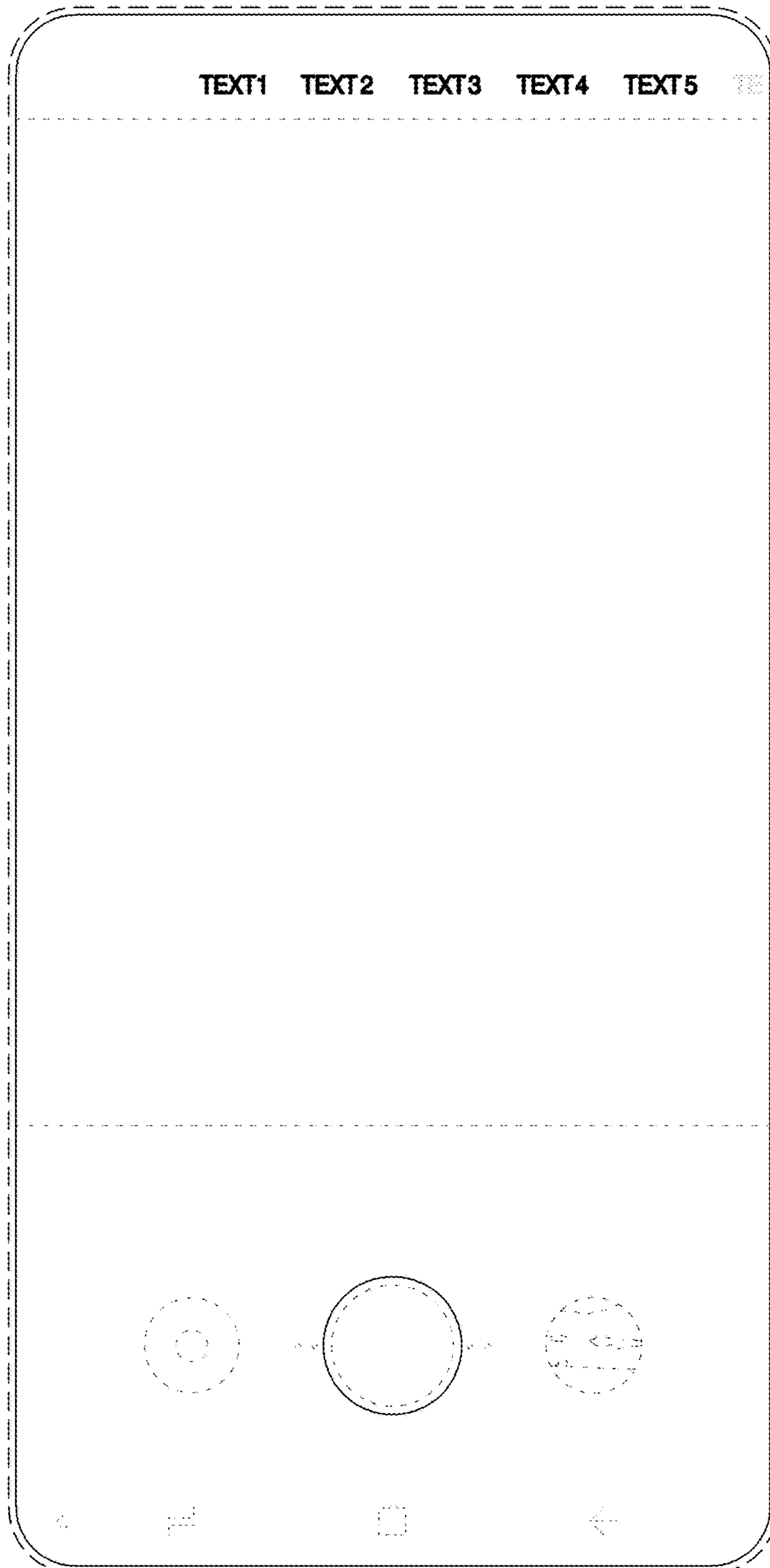

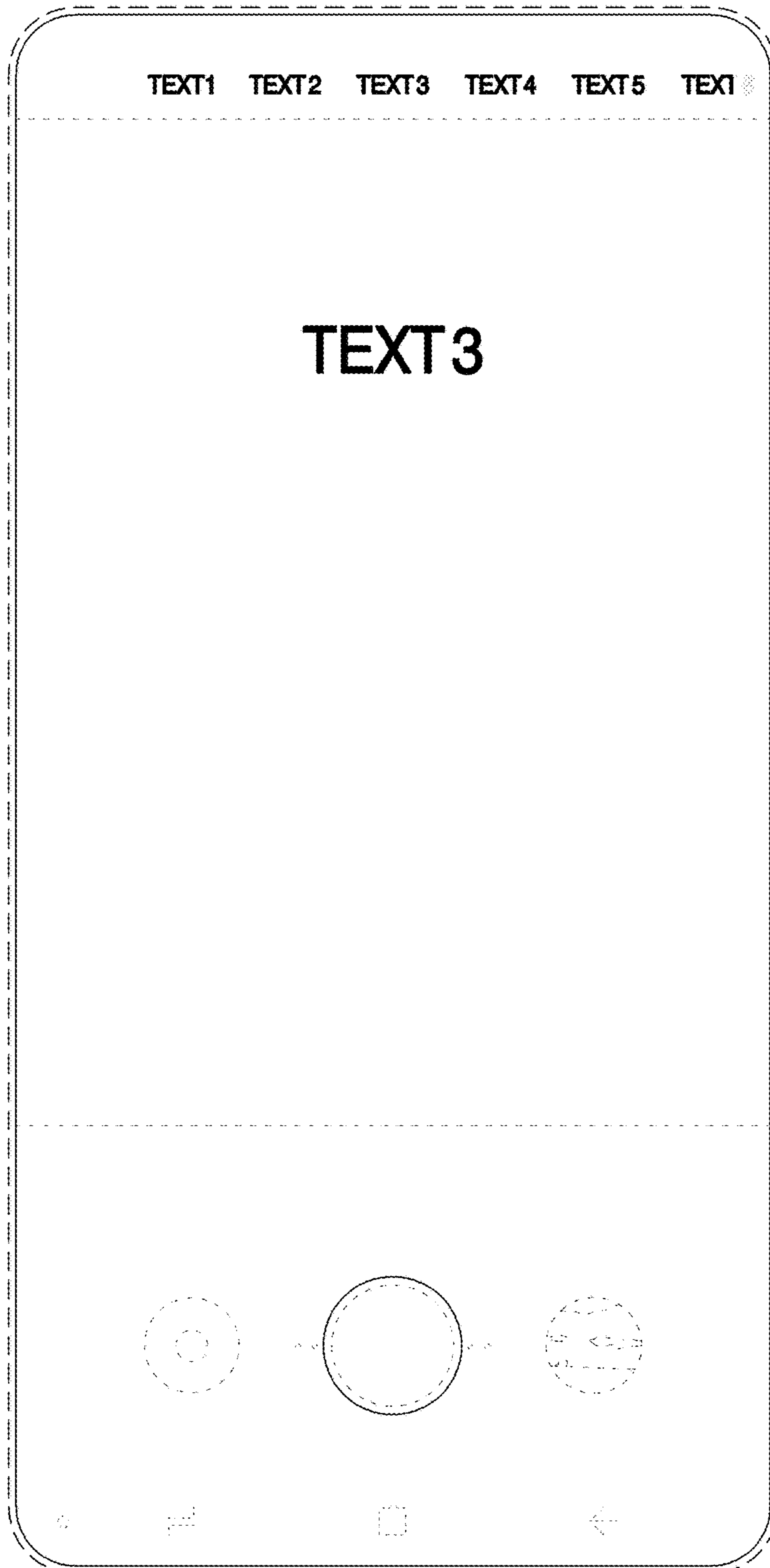

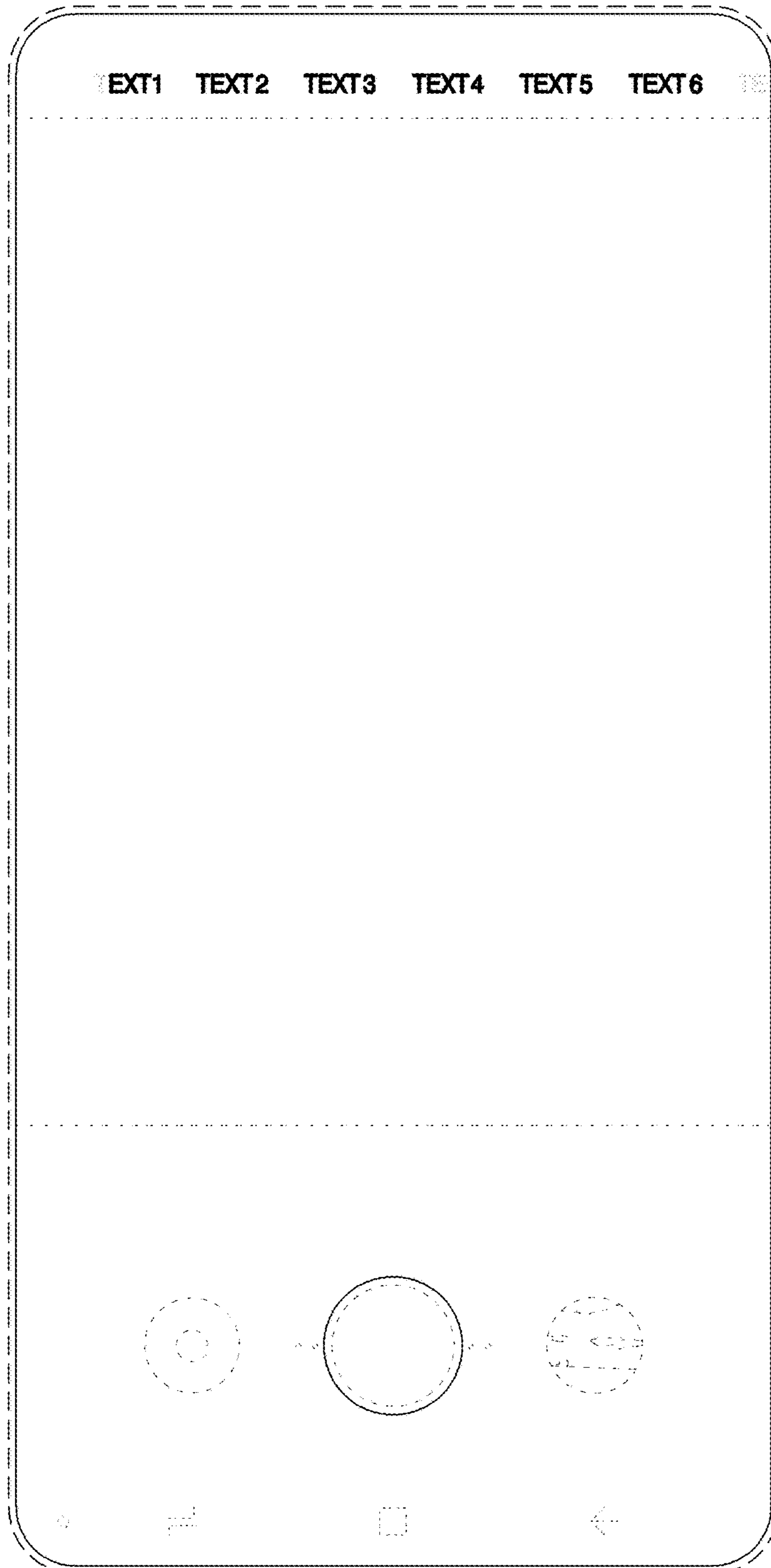

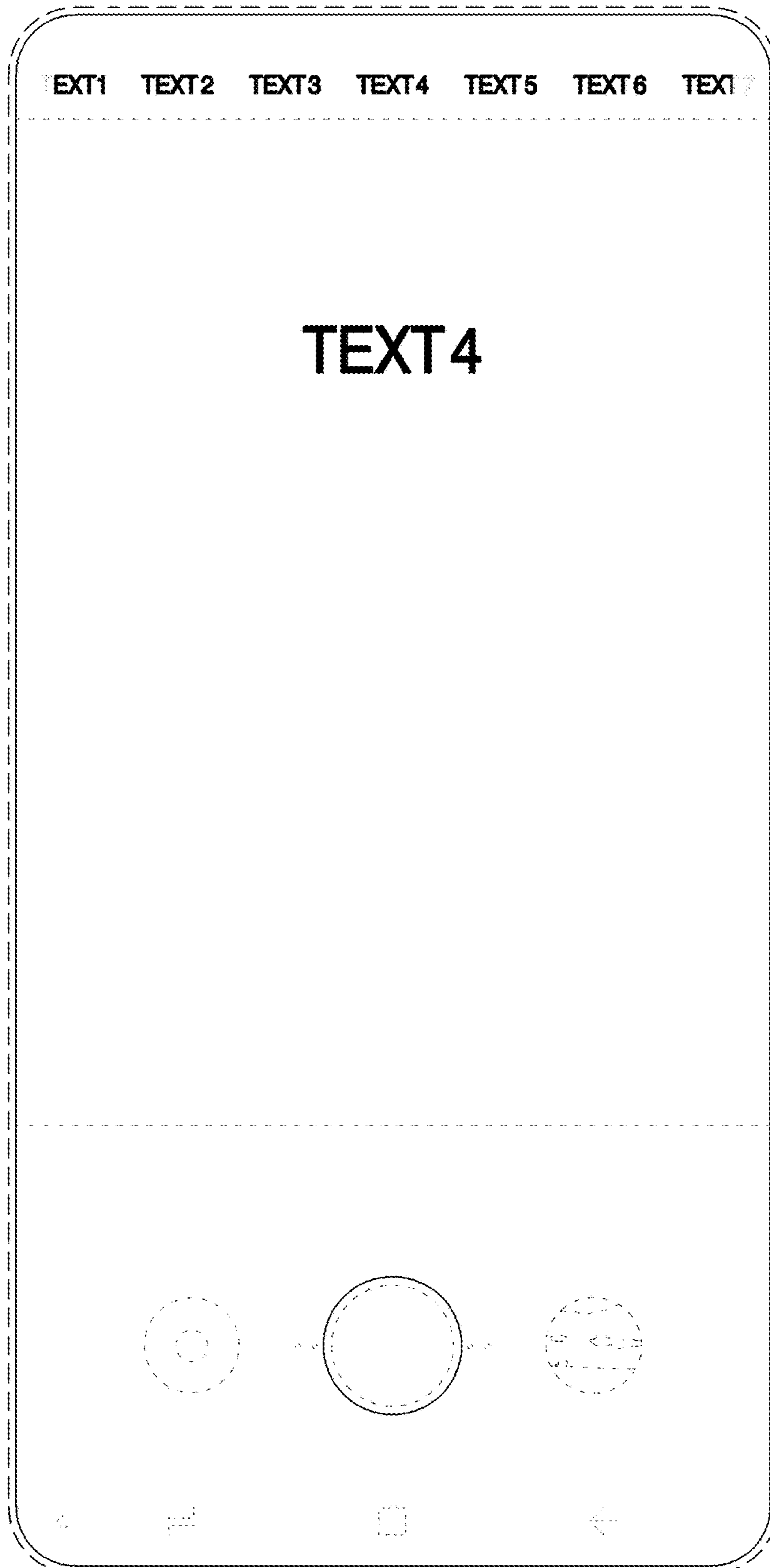

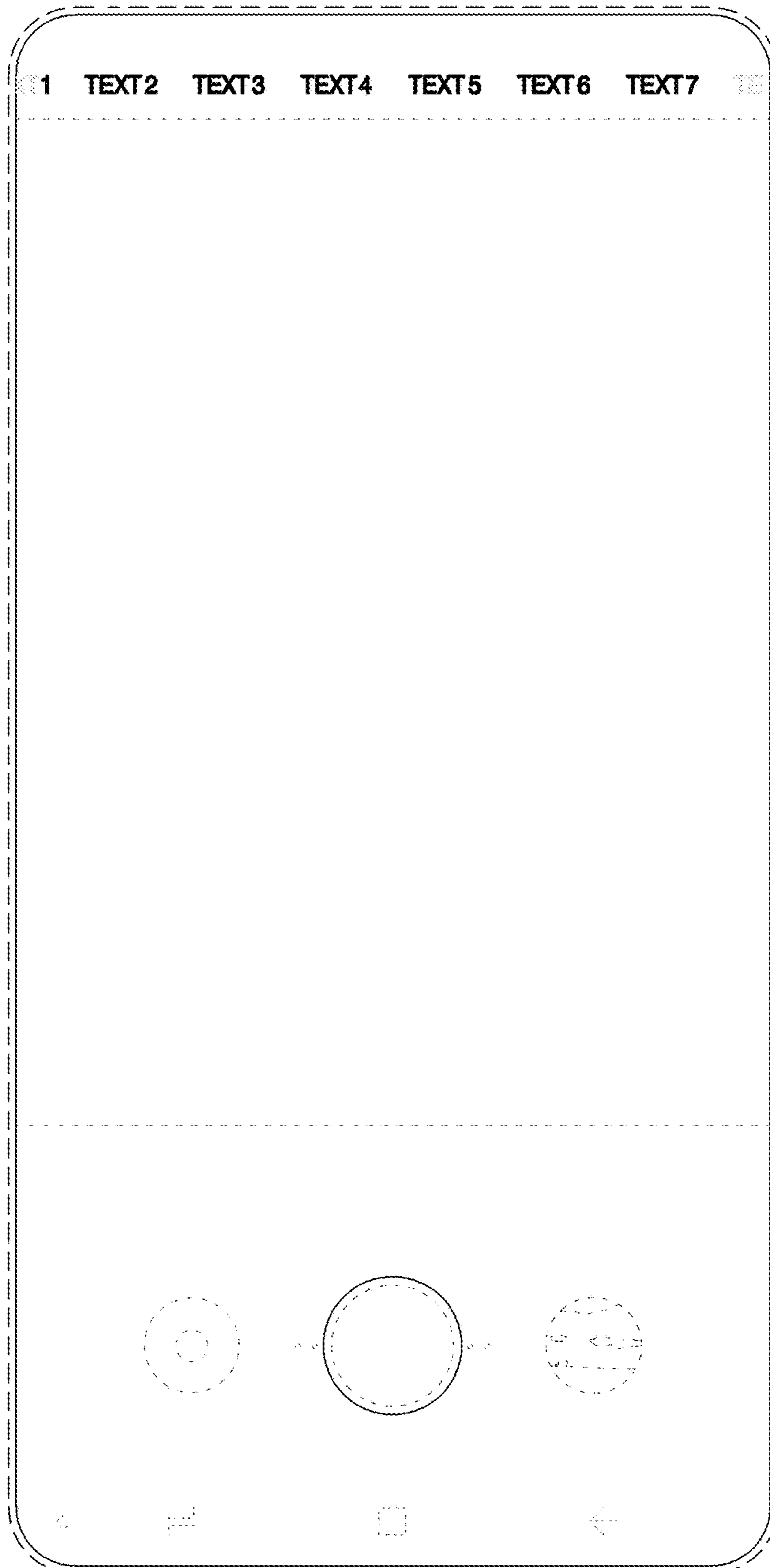
