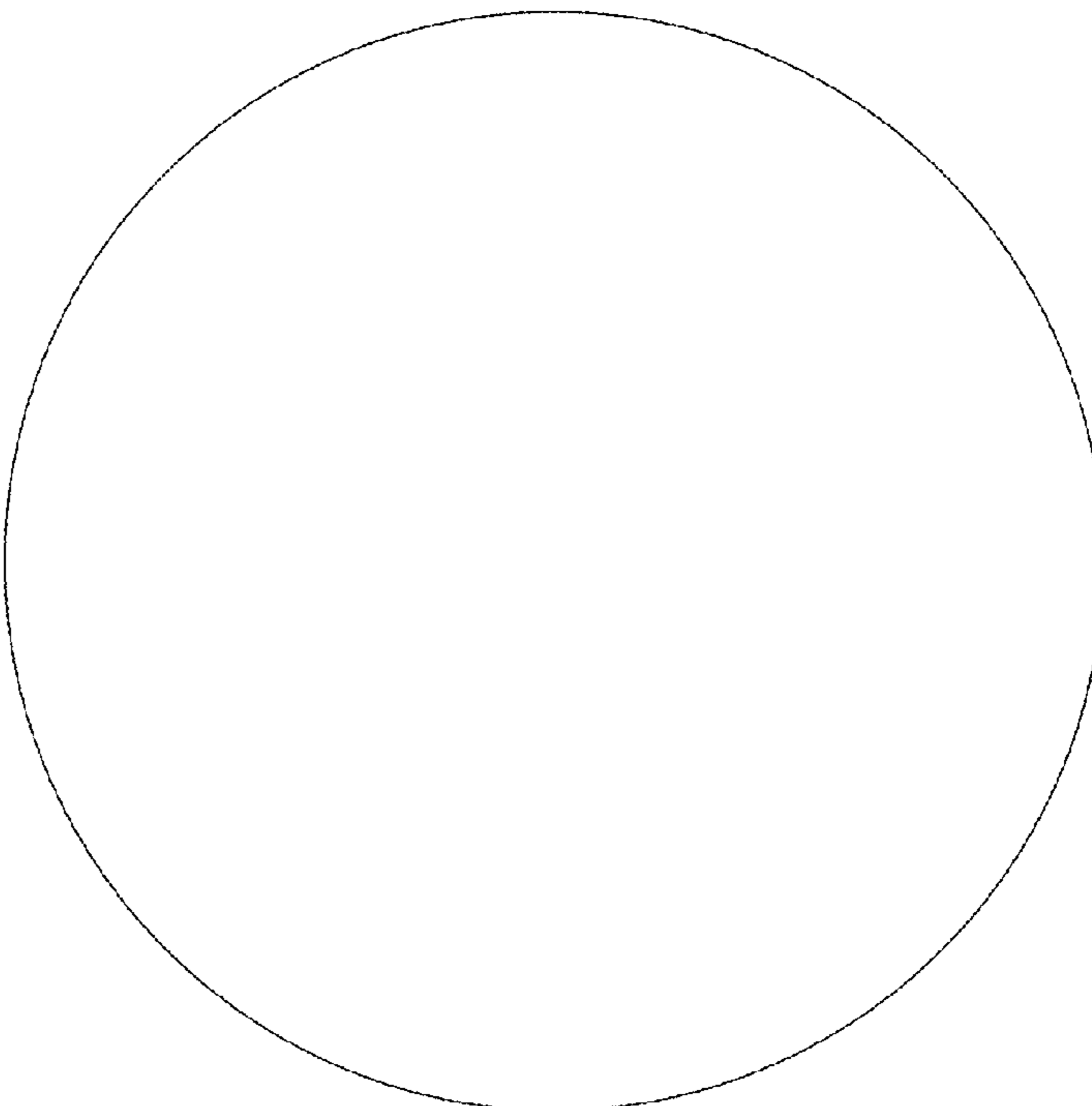
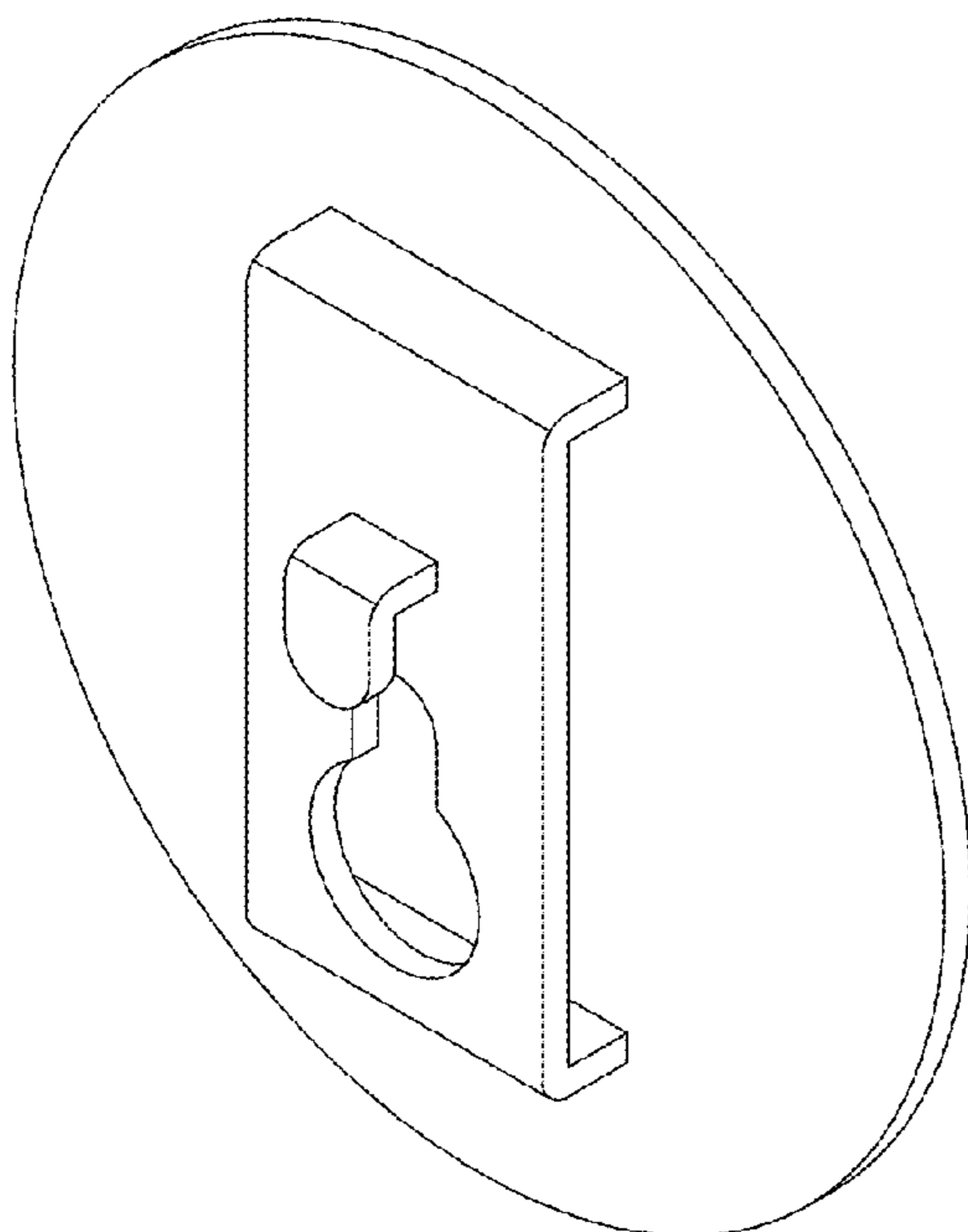
I claim the ornamental design for a seat tag, as shown and described.

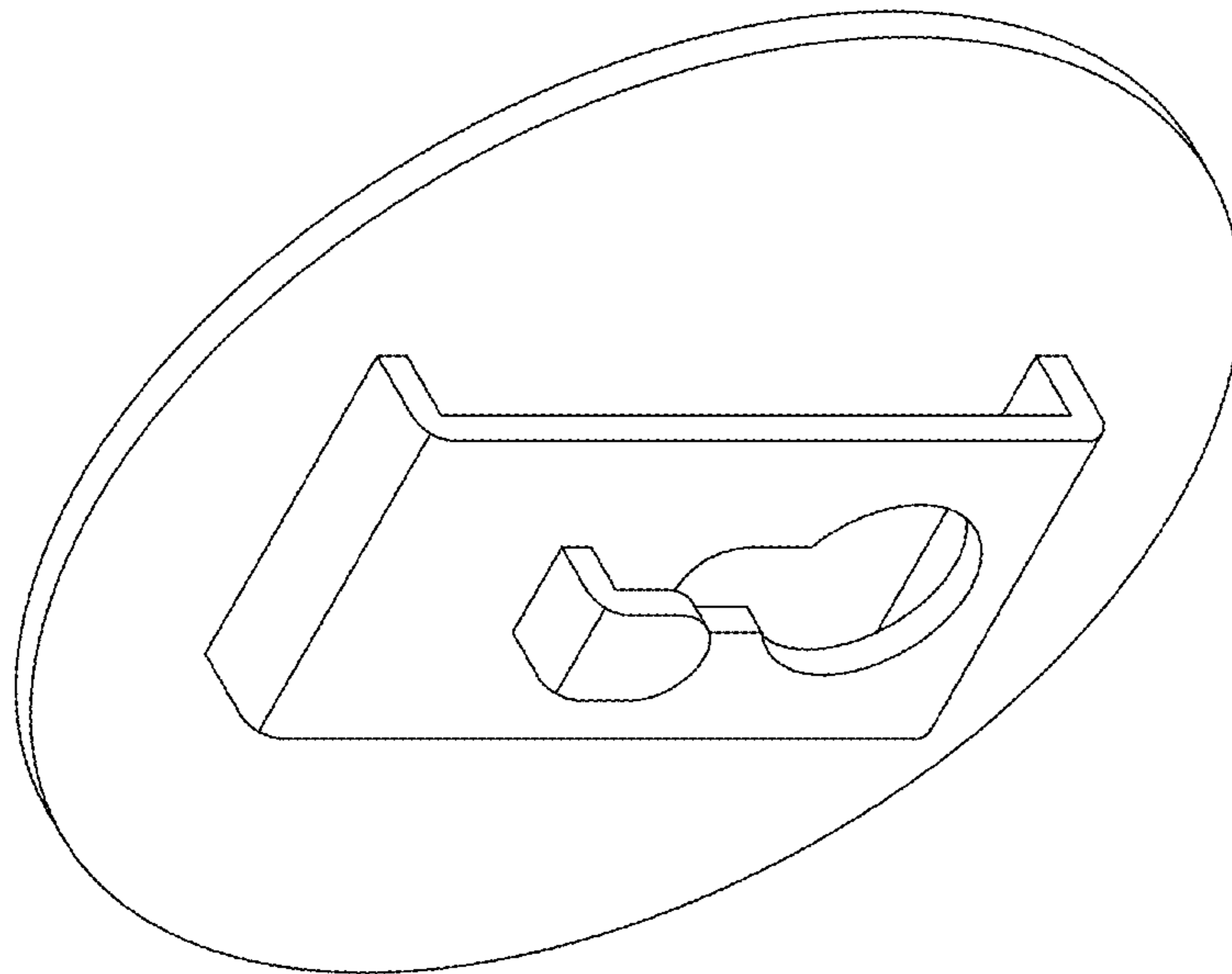
**DESCRIPTION**

The broken line portion of the figure drawings is included to show environment that forms no part of the claimed design.

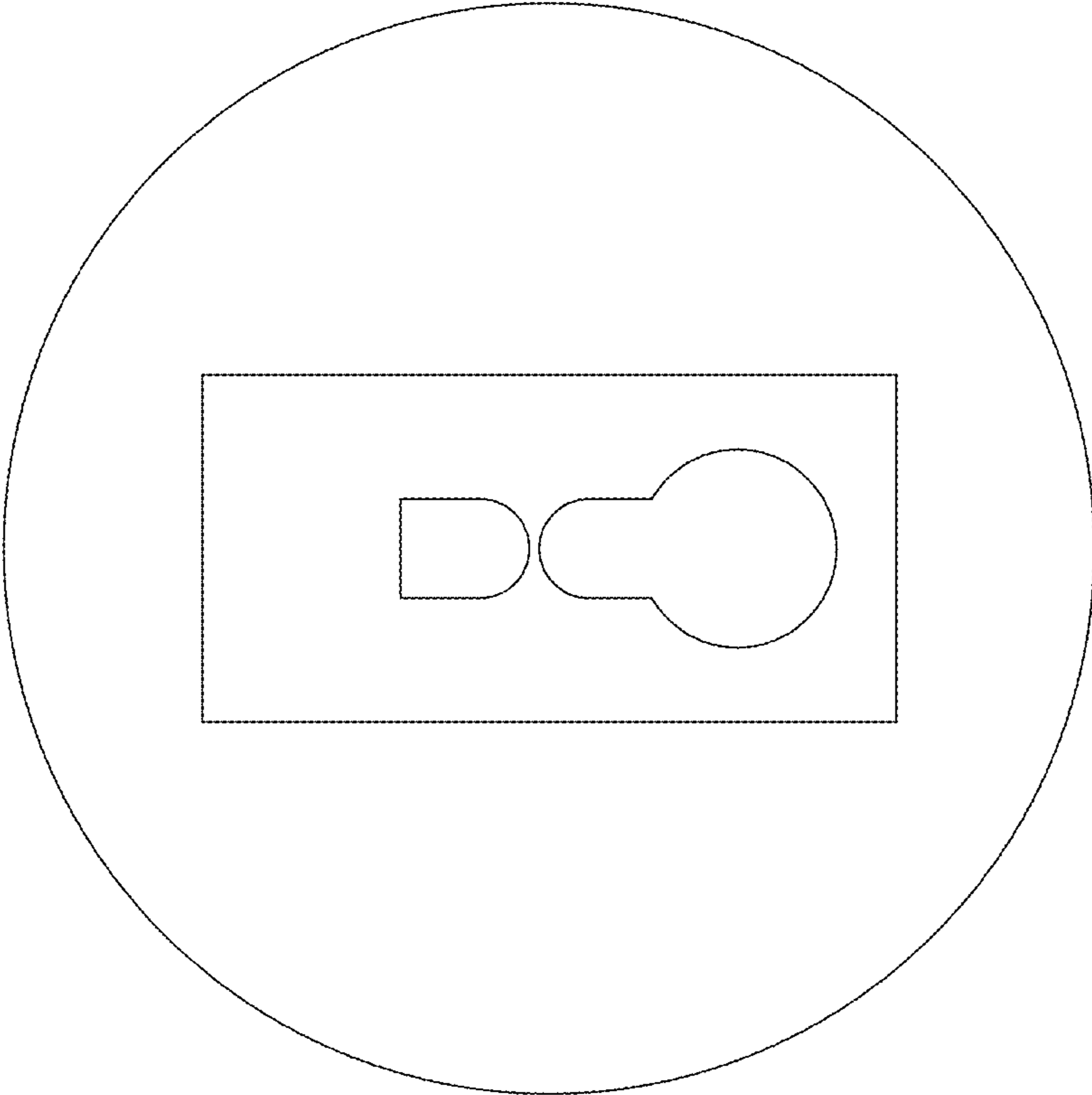

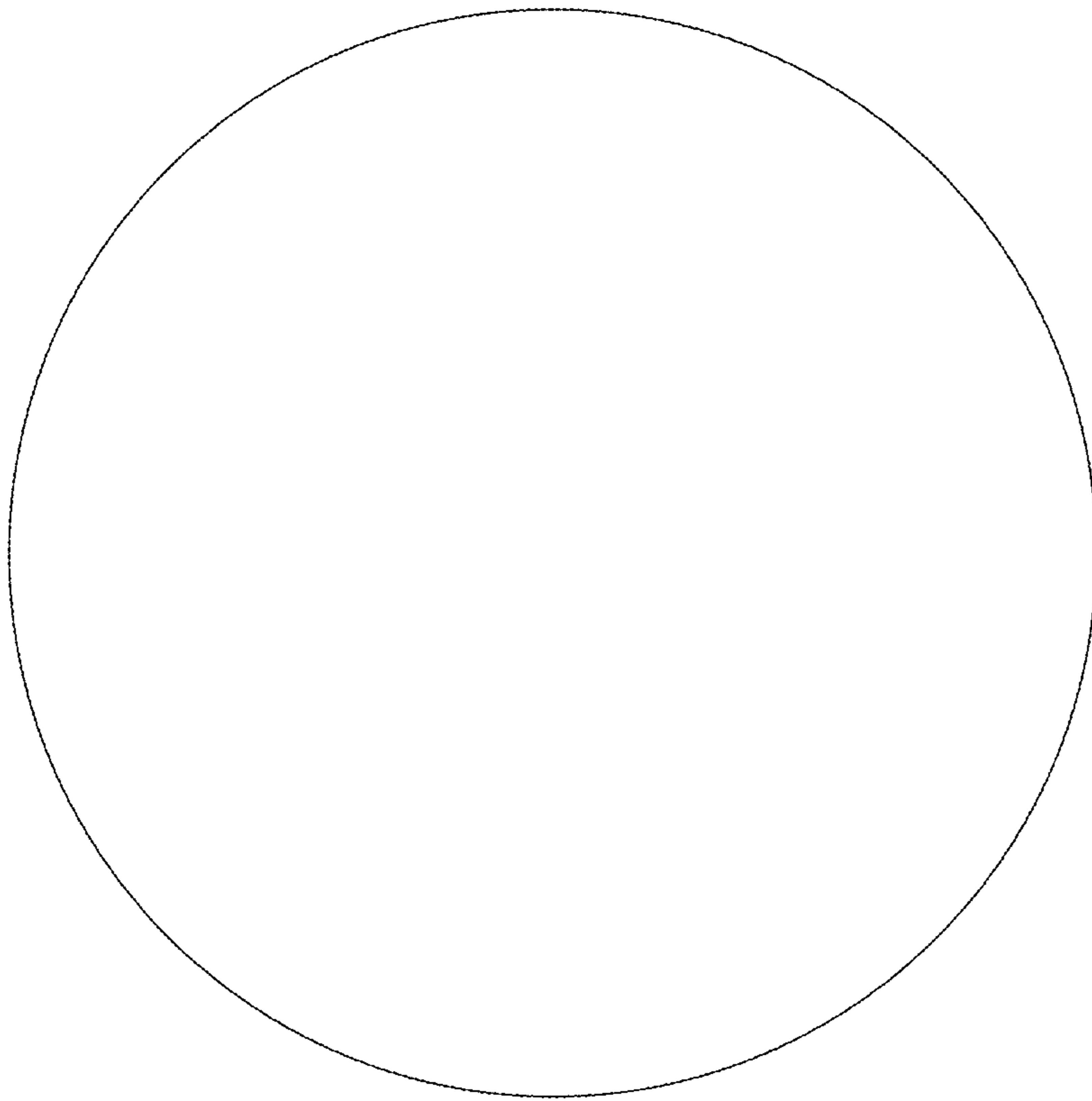




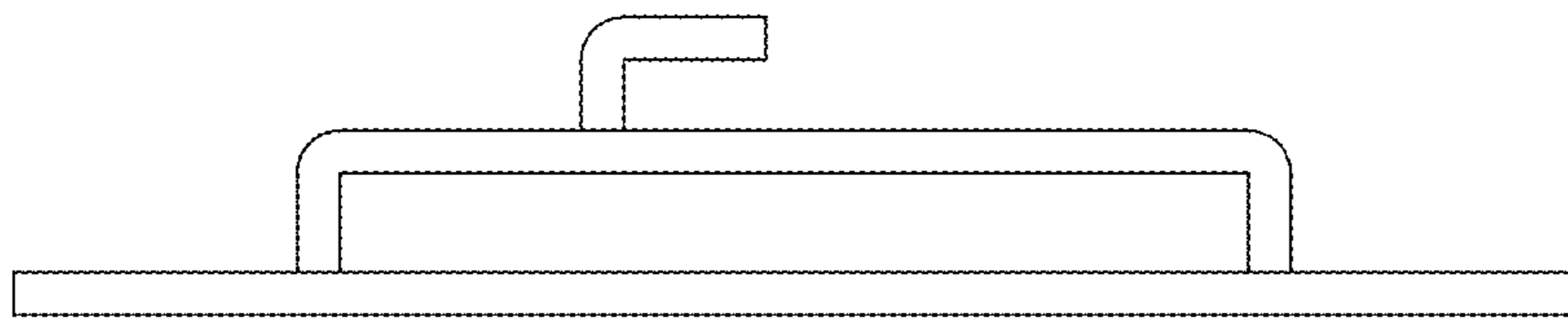

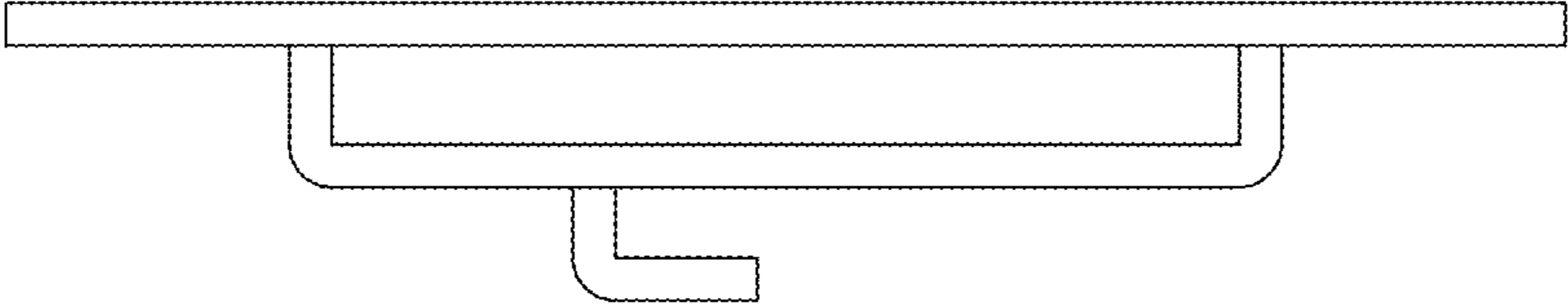

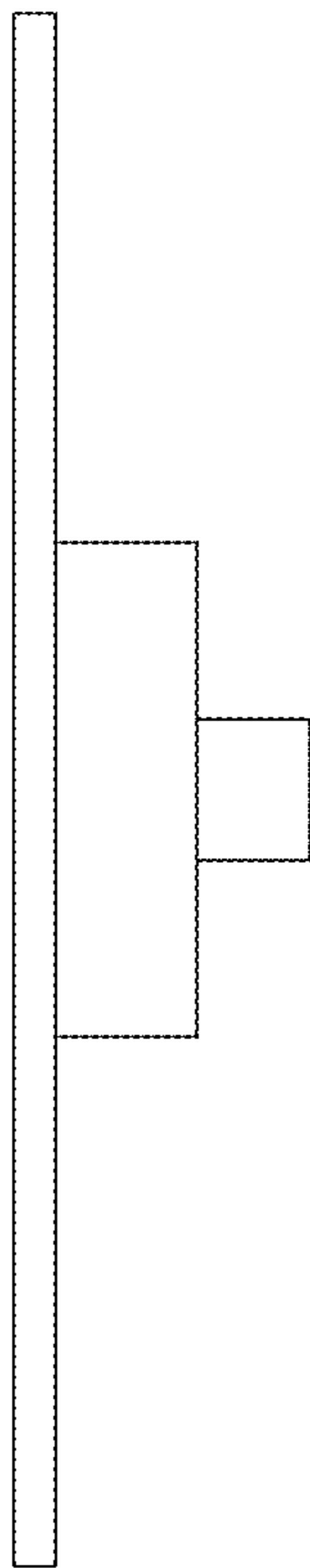

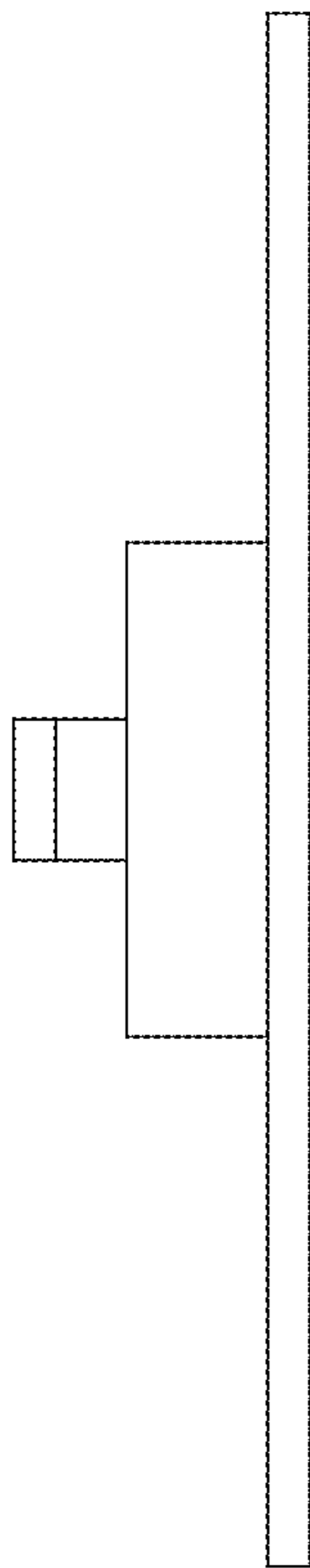

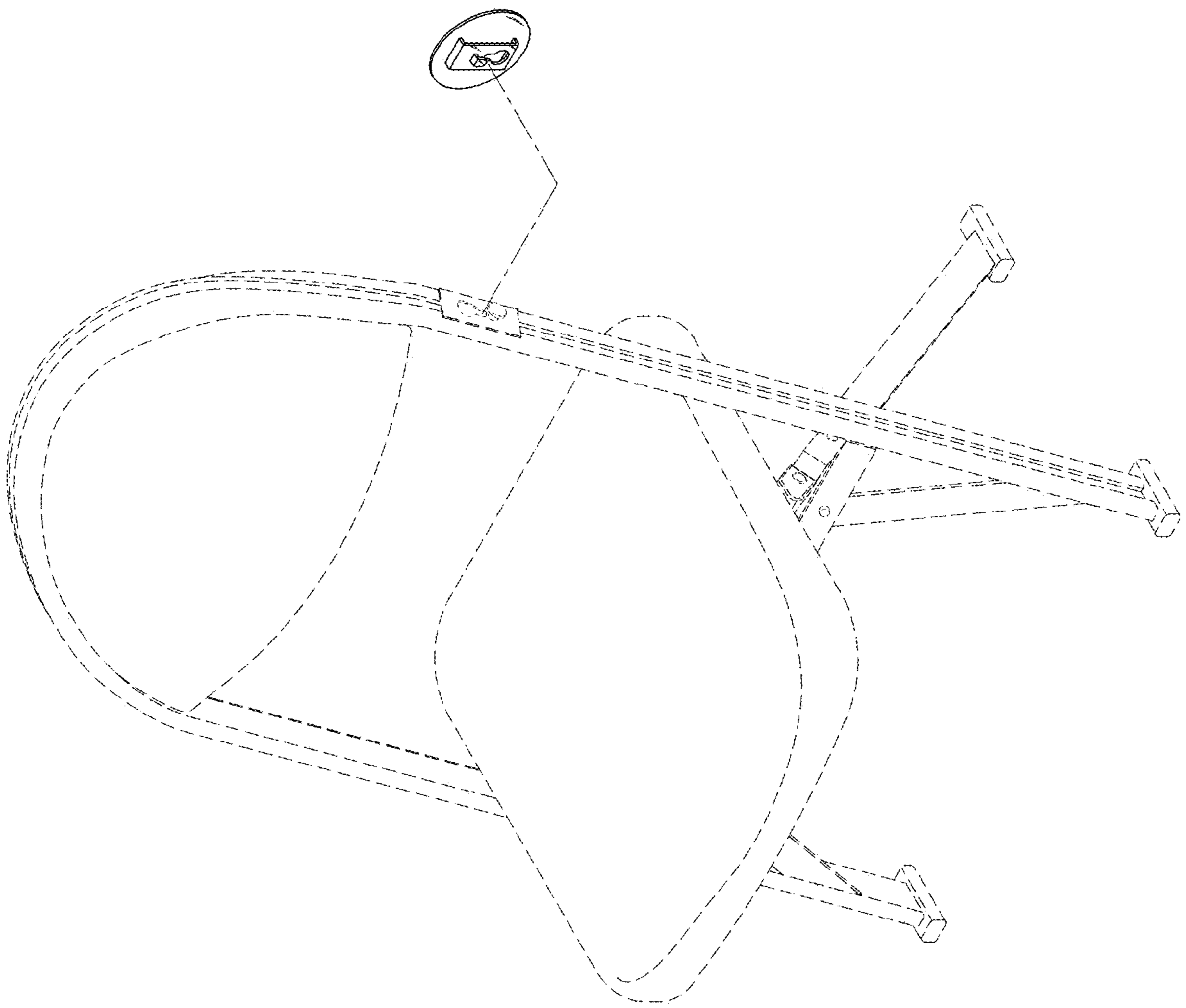

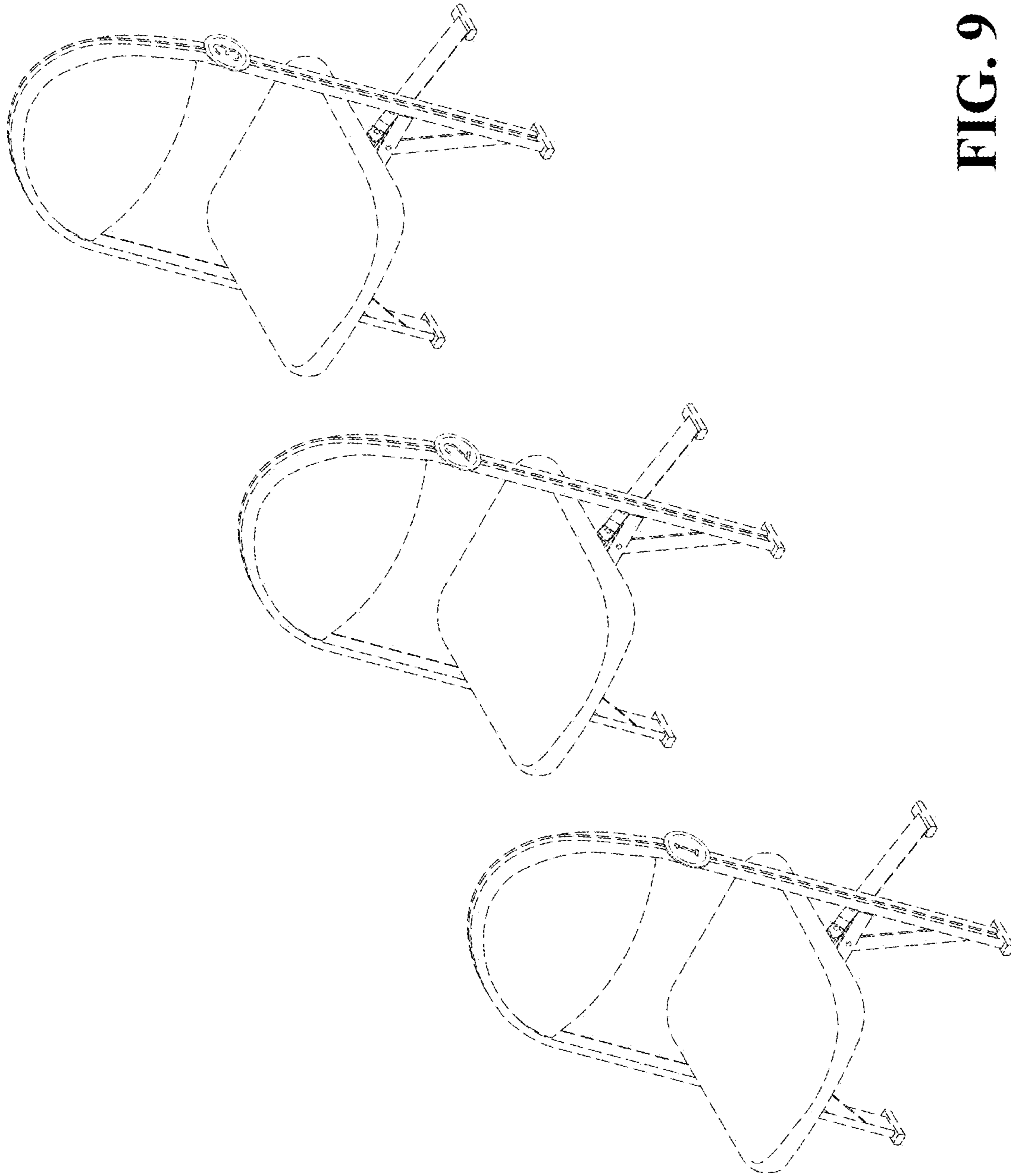
