 FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. 5.

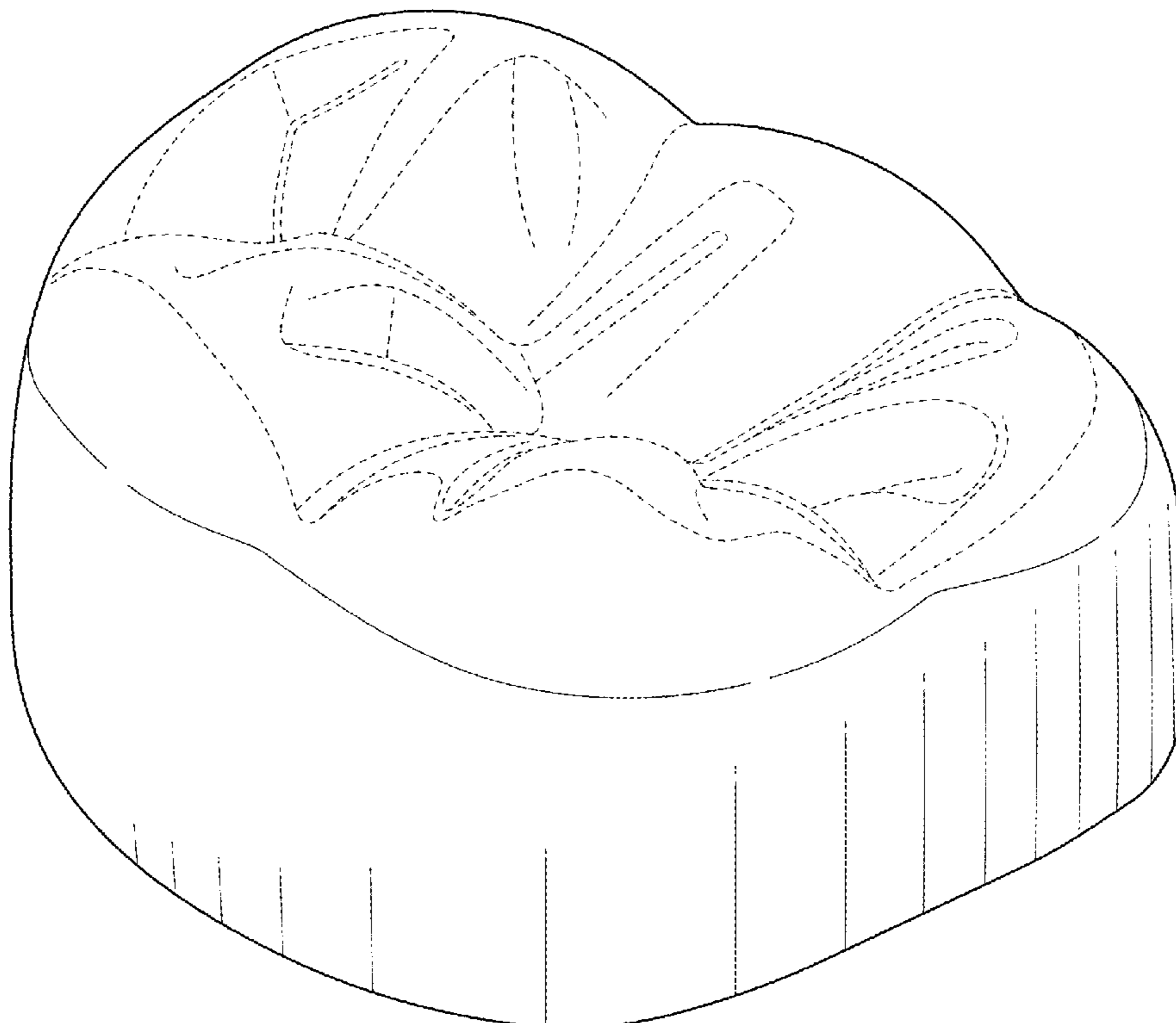

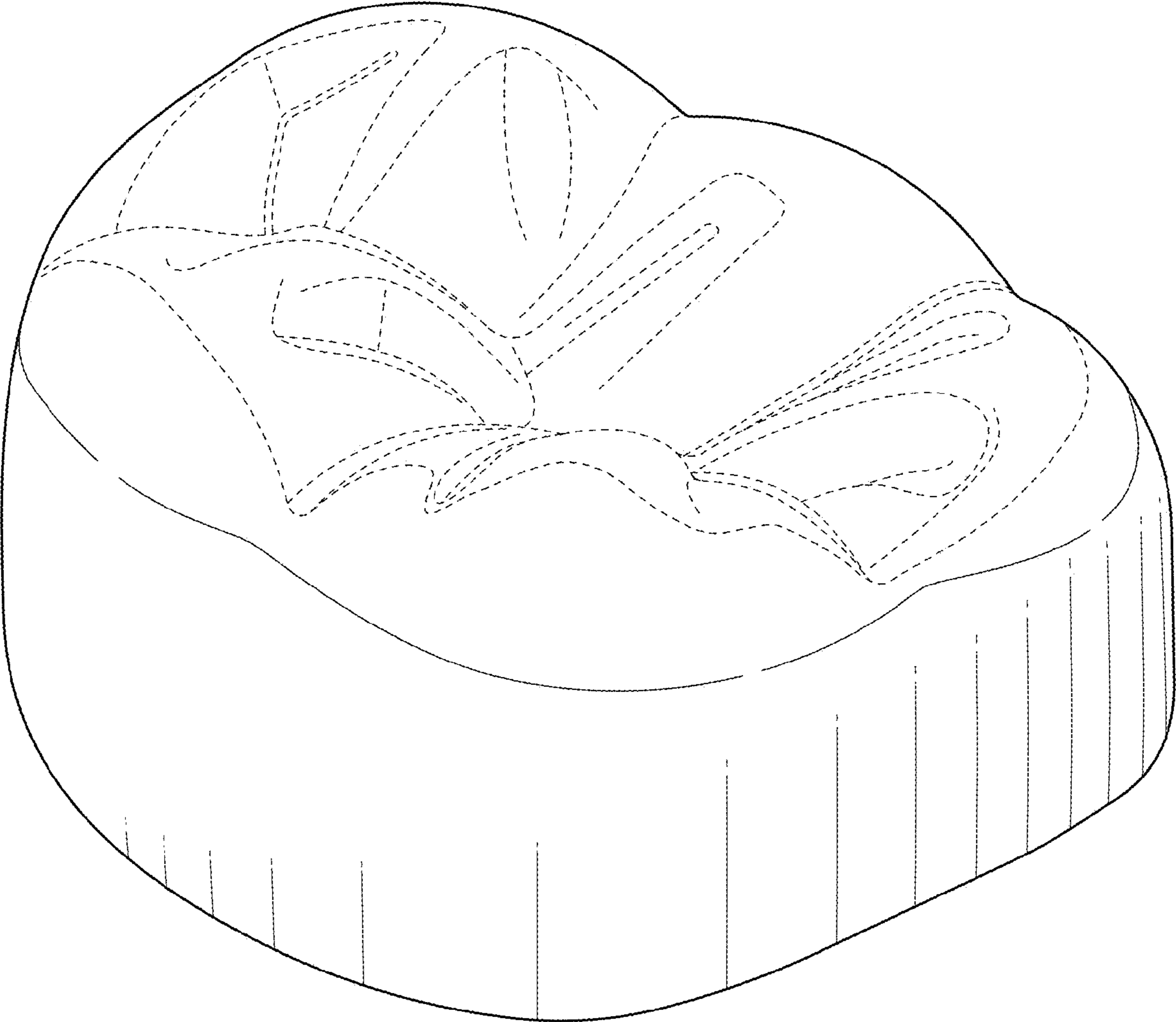

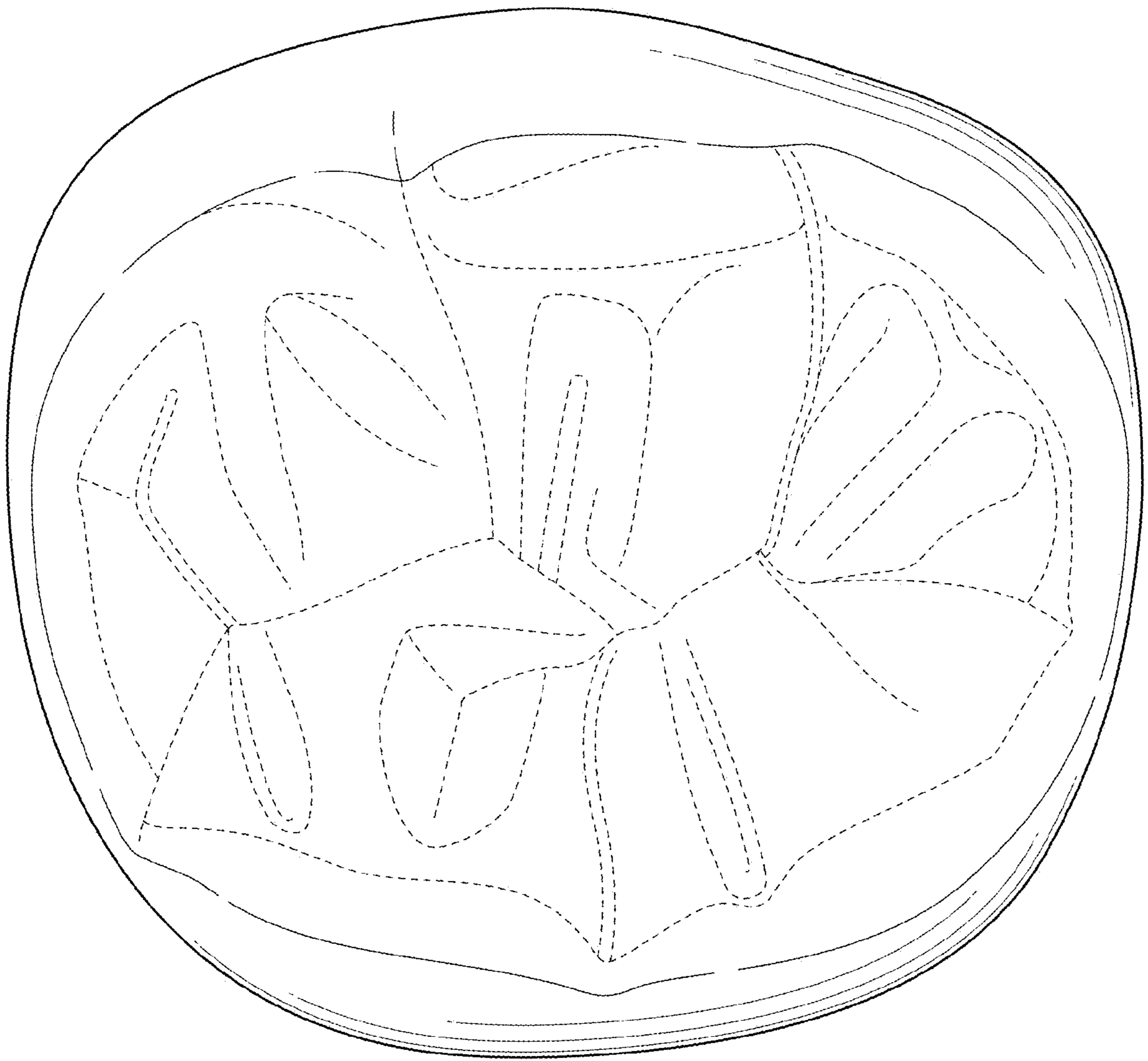

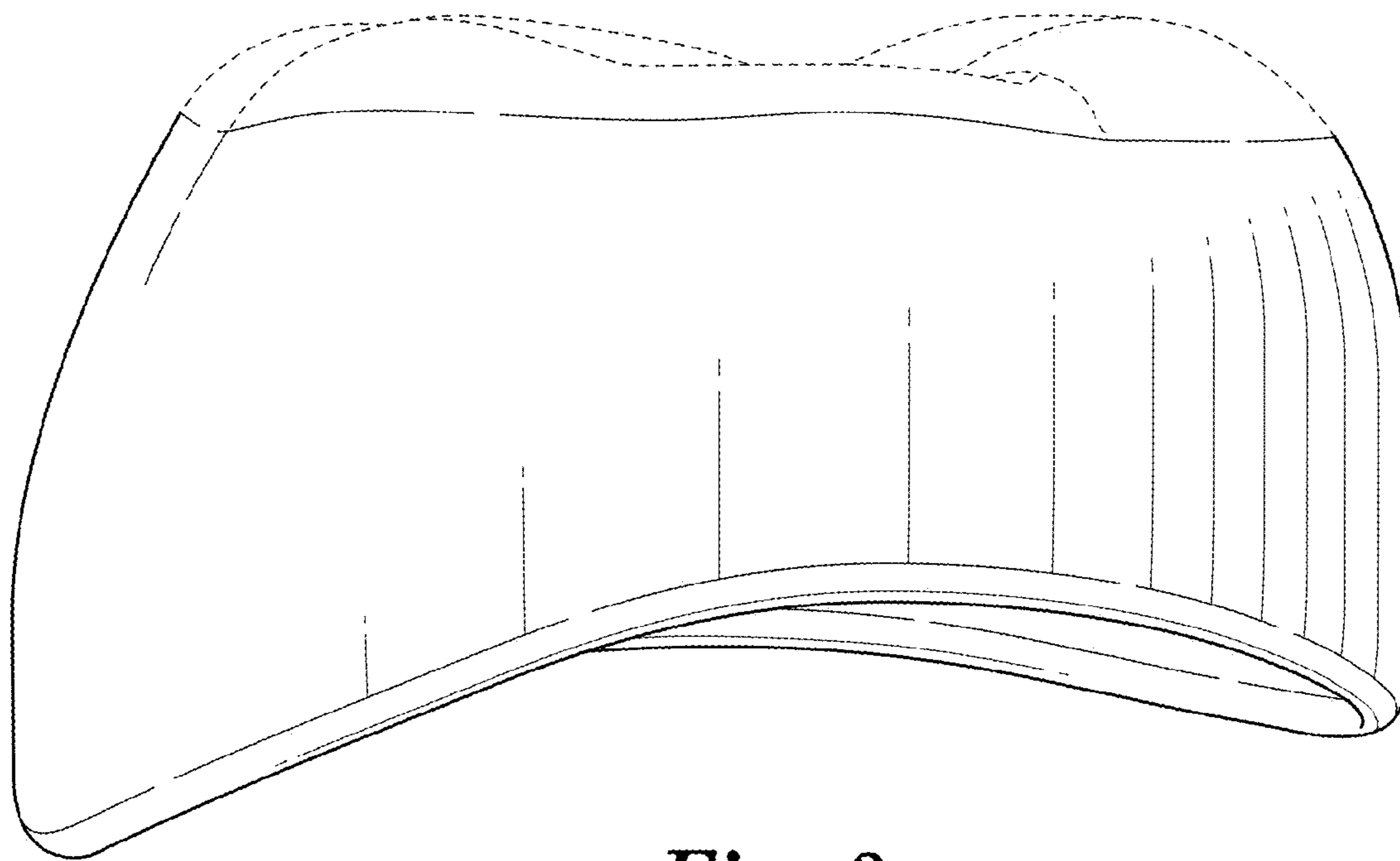

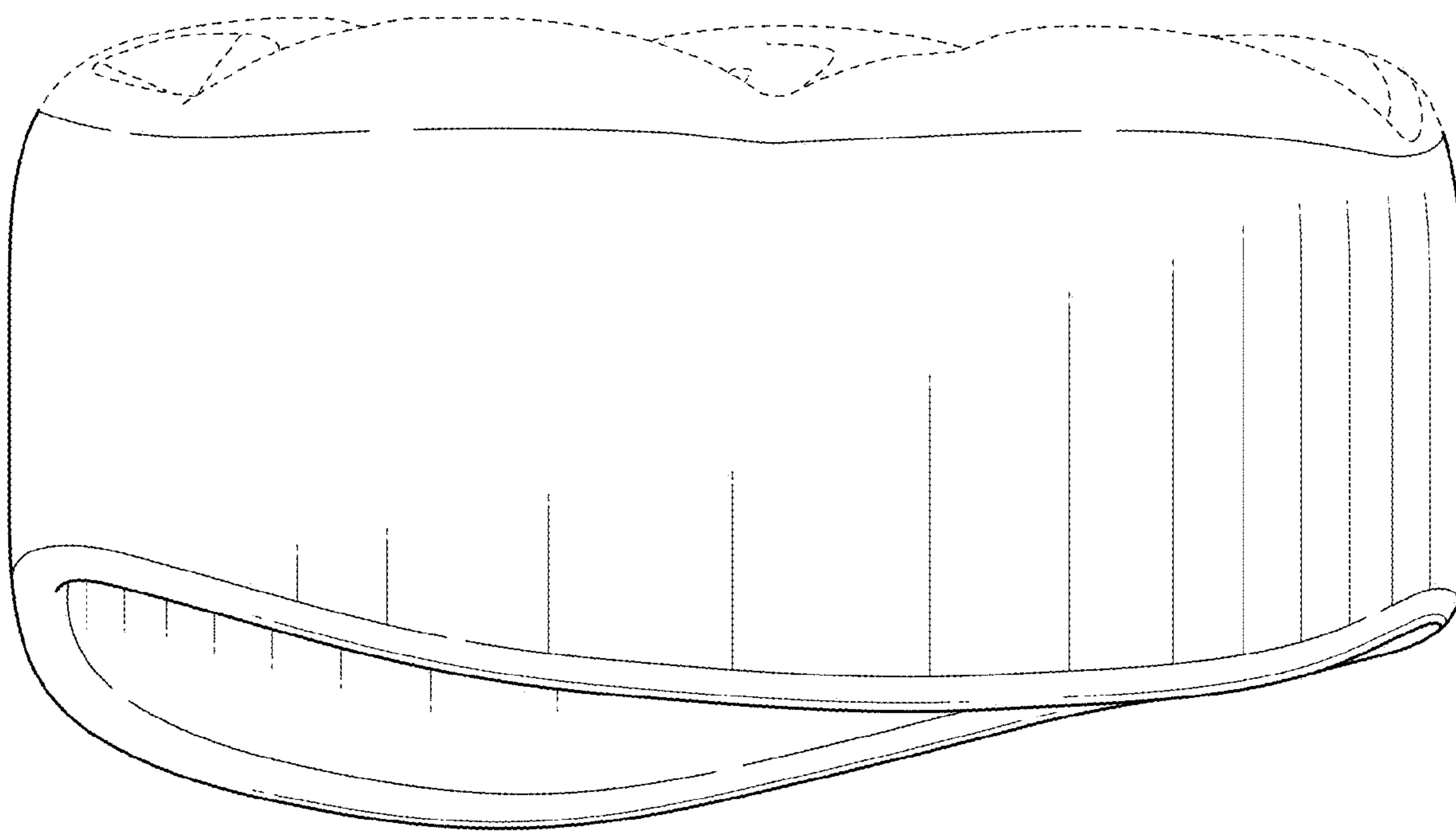

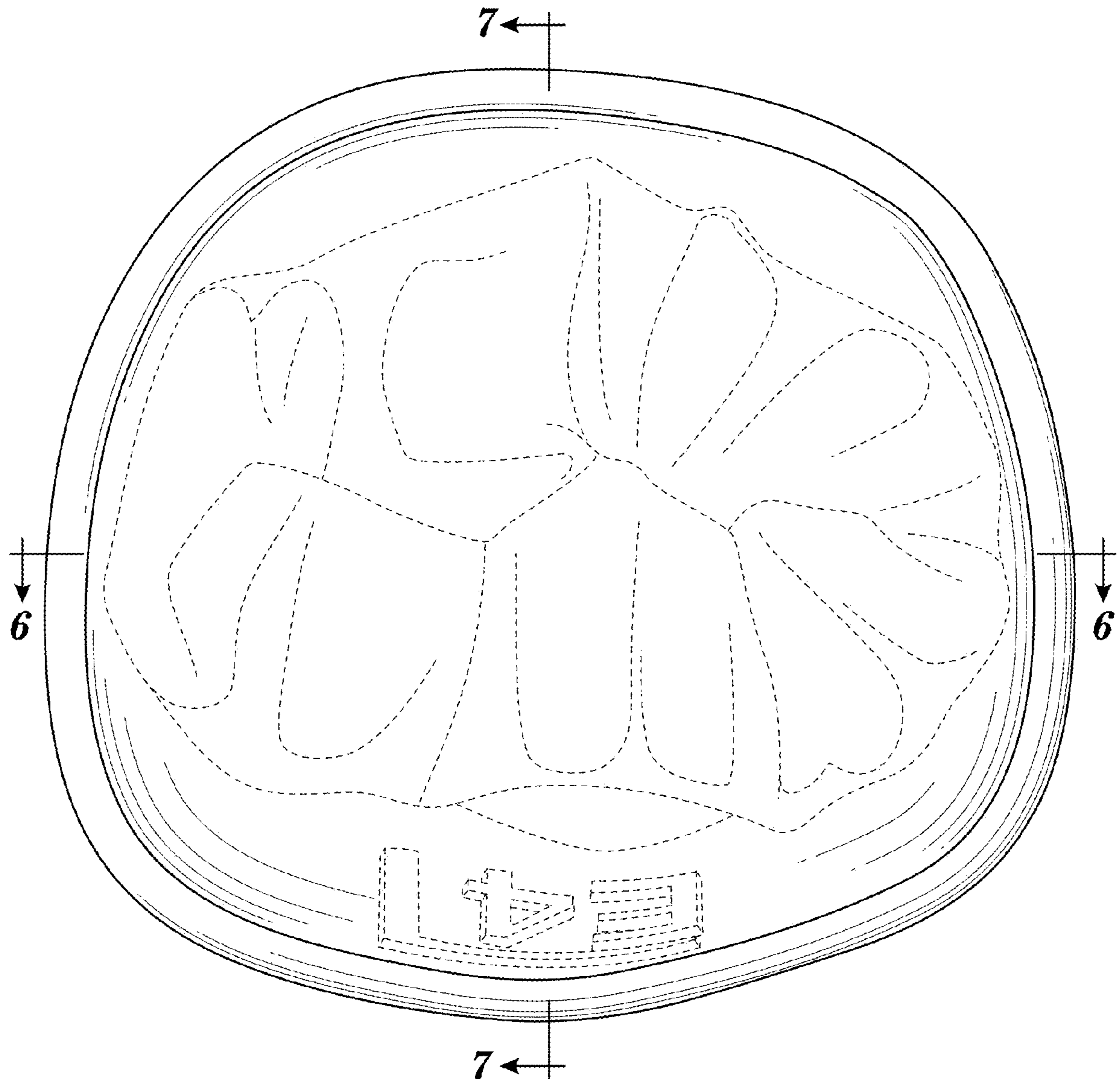

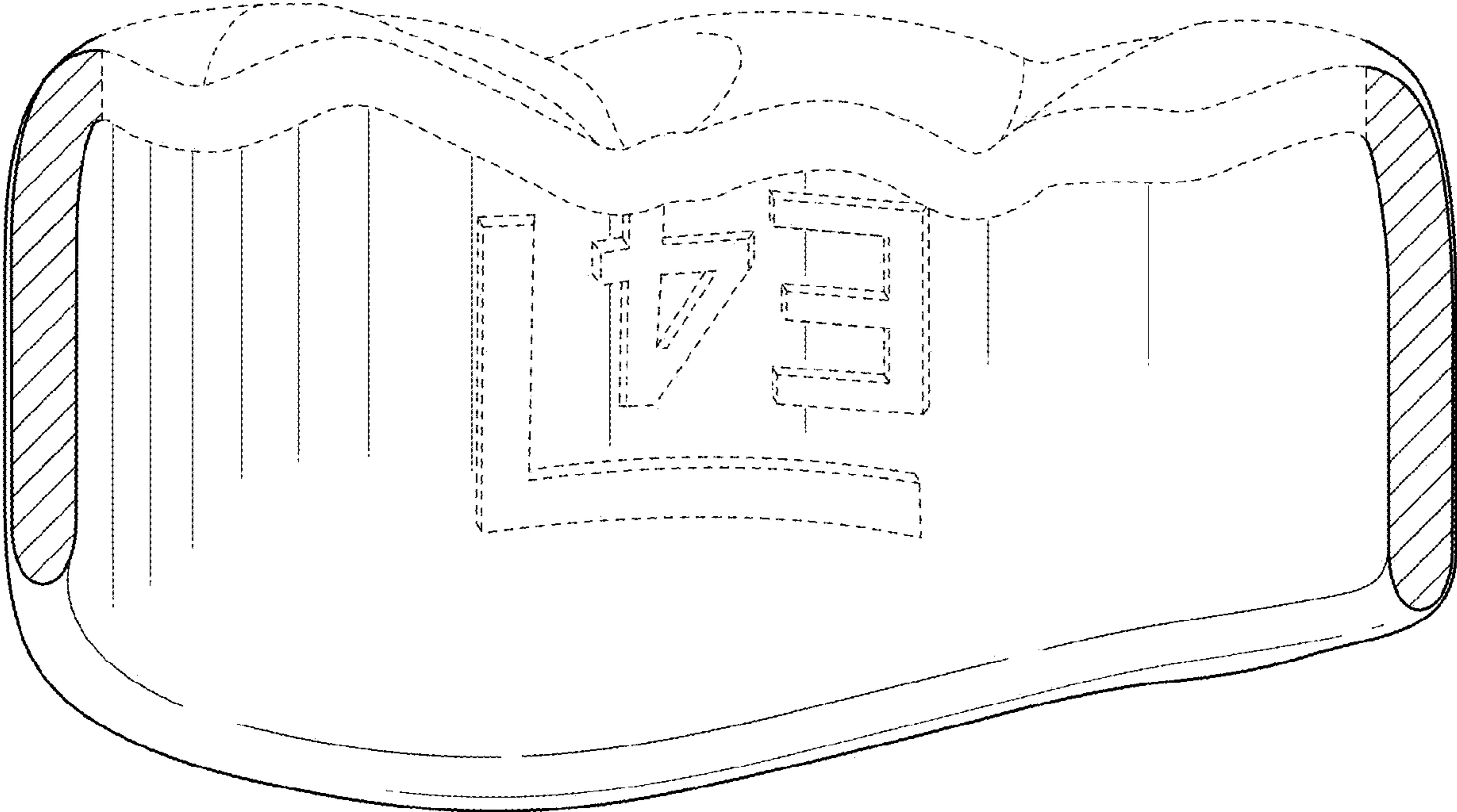

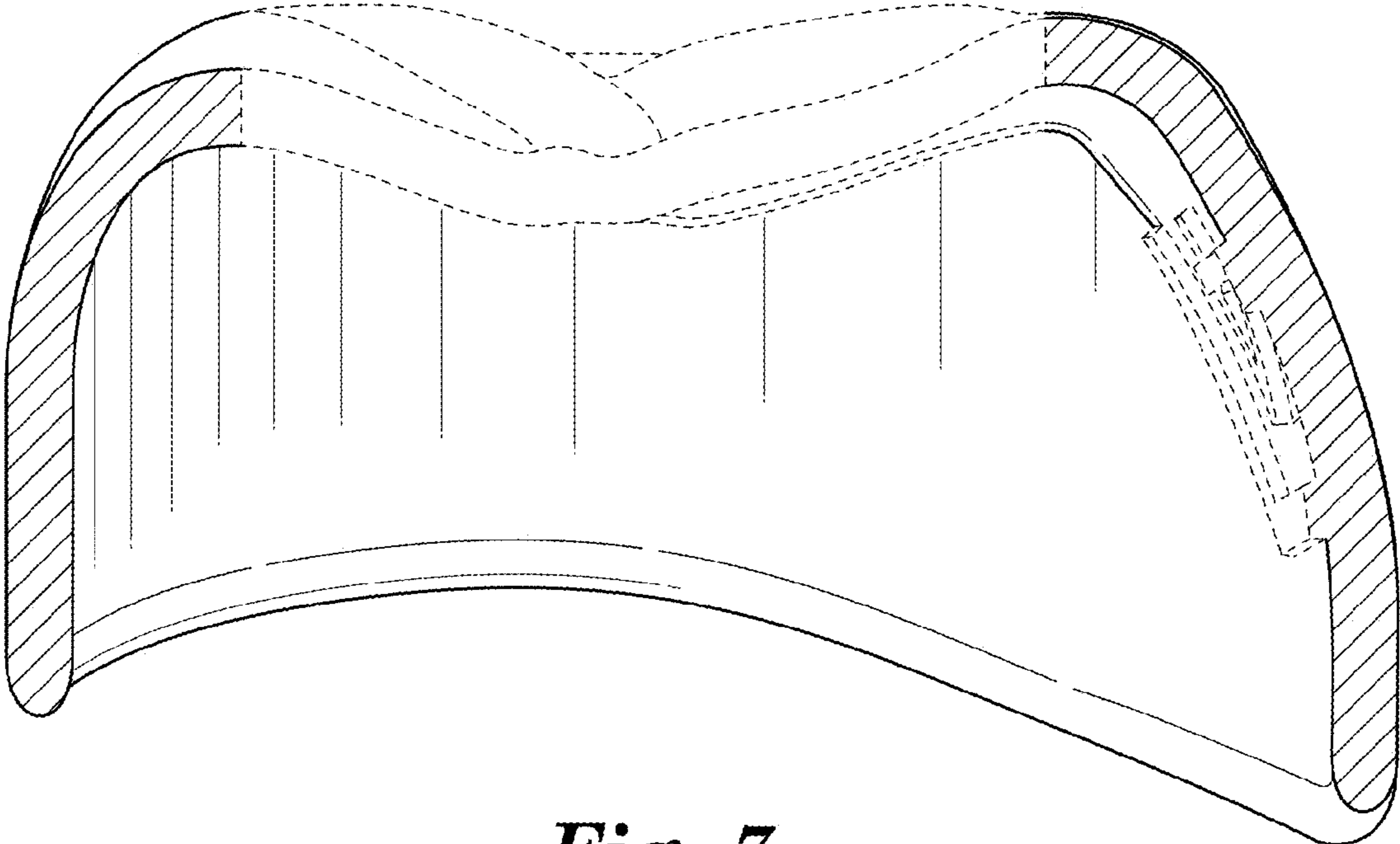
