FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. 5.

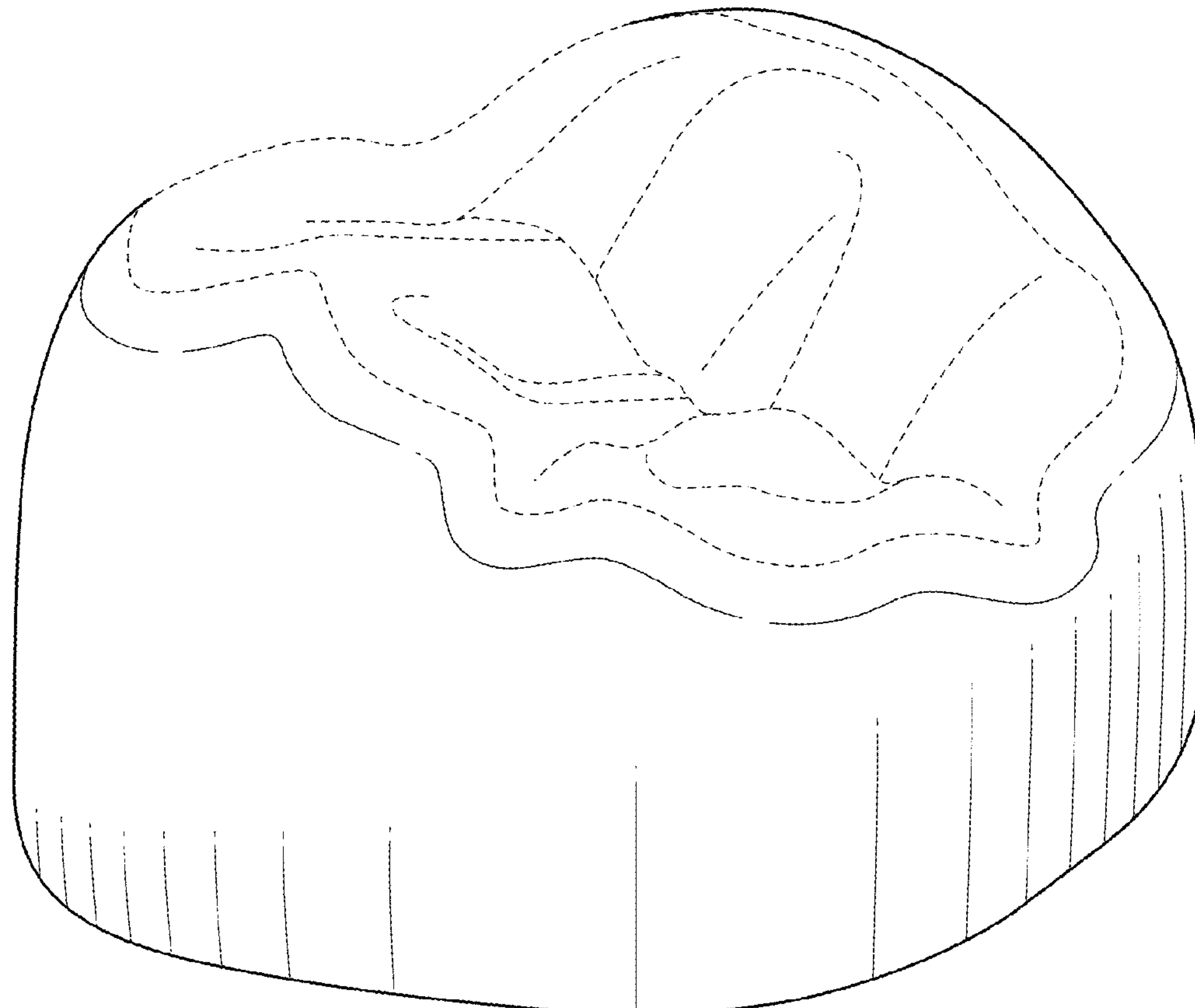
The portions of the pediatric crown in FIGS. 1-7 shown in broken lines are included to show features that form no part of the claimed design.

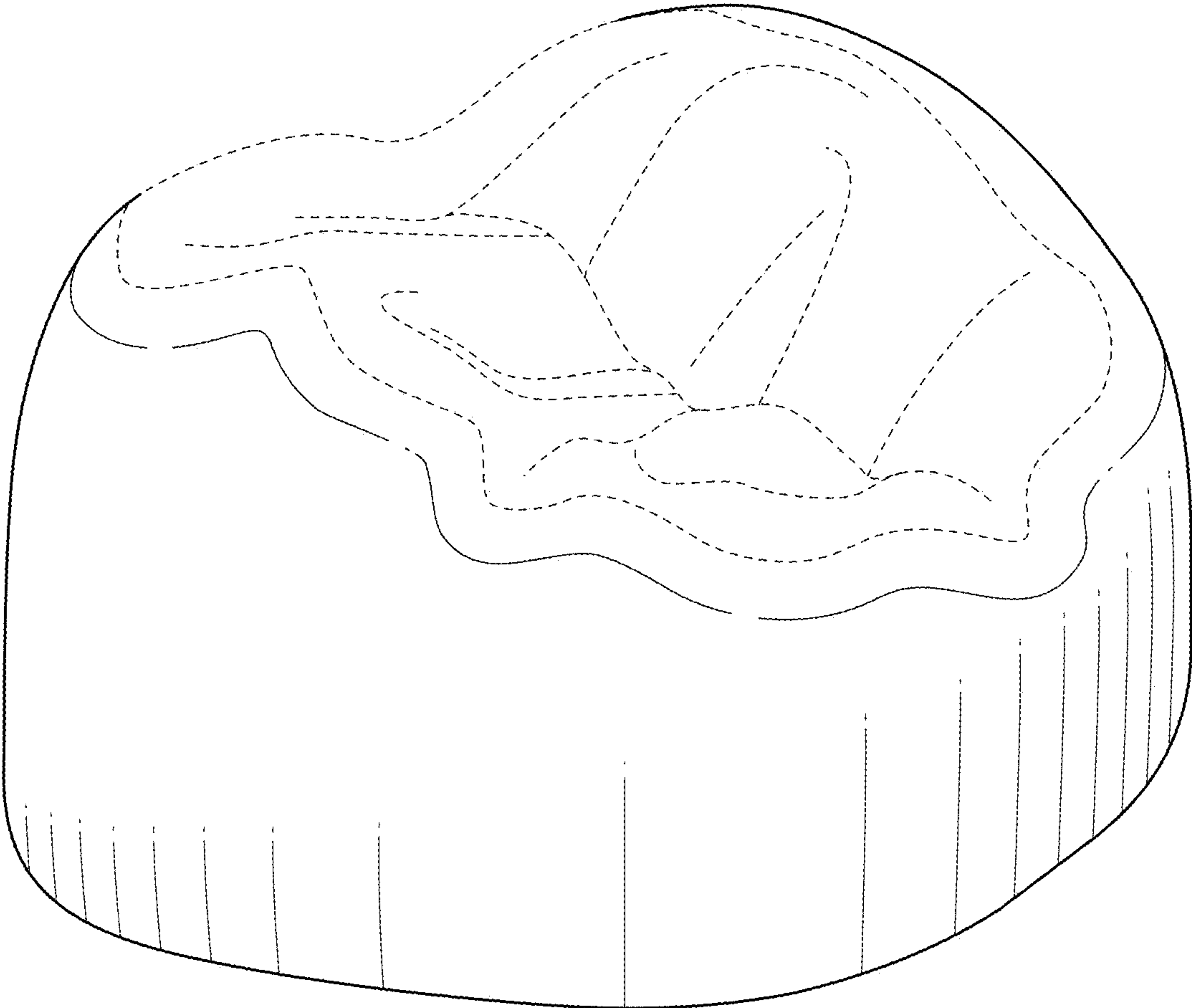

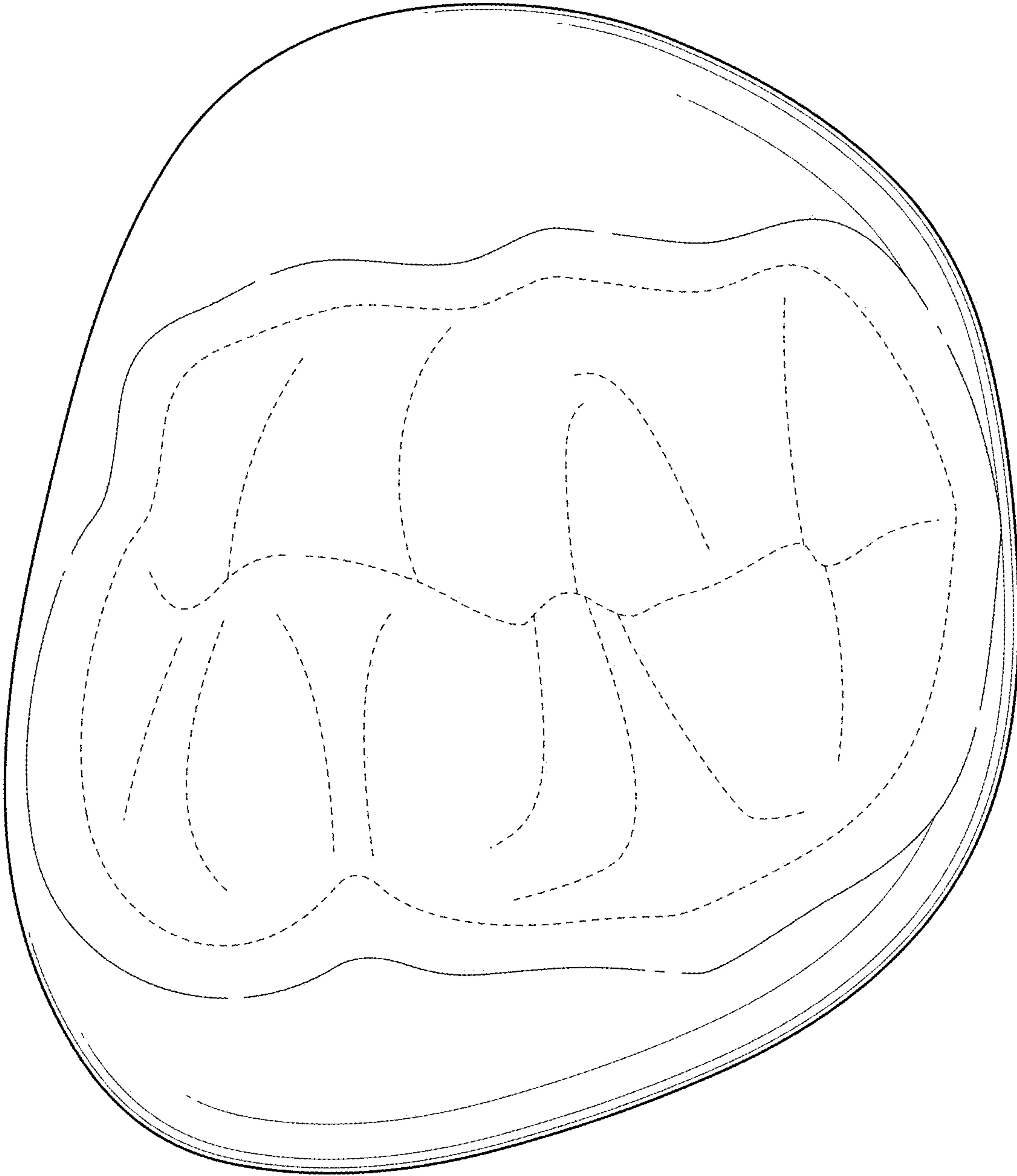

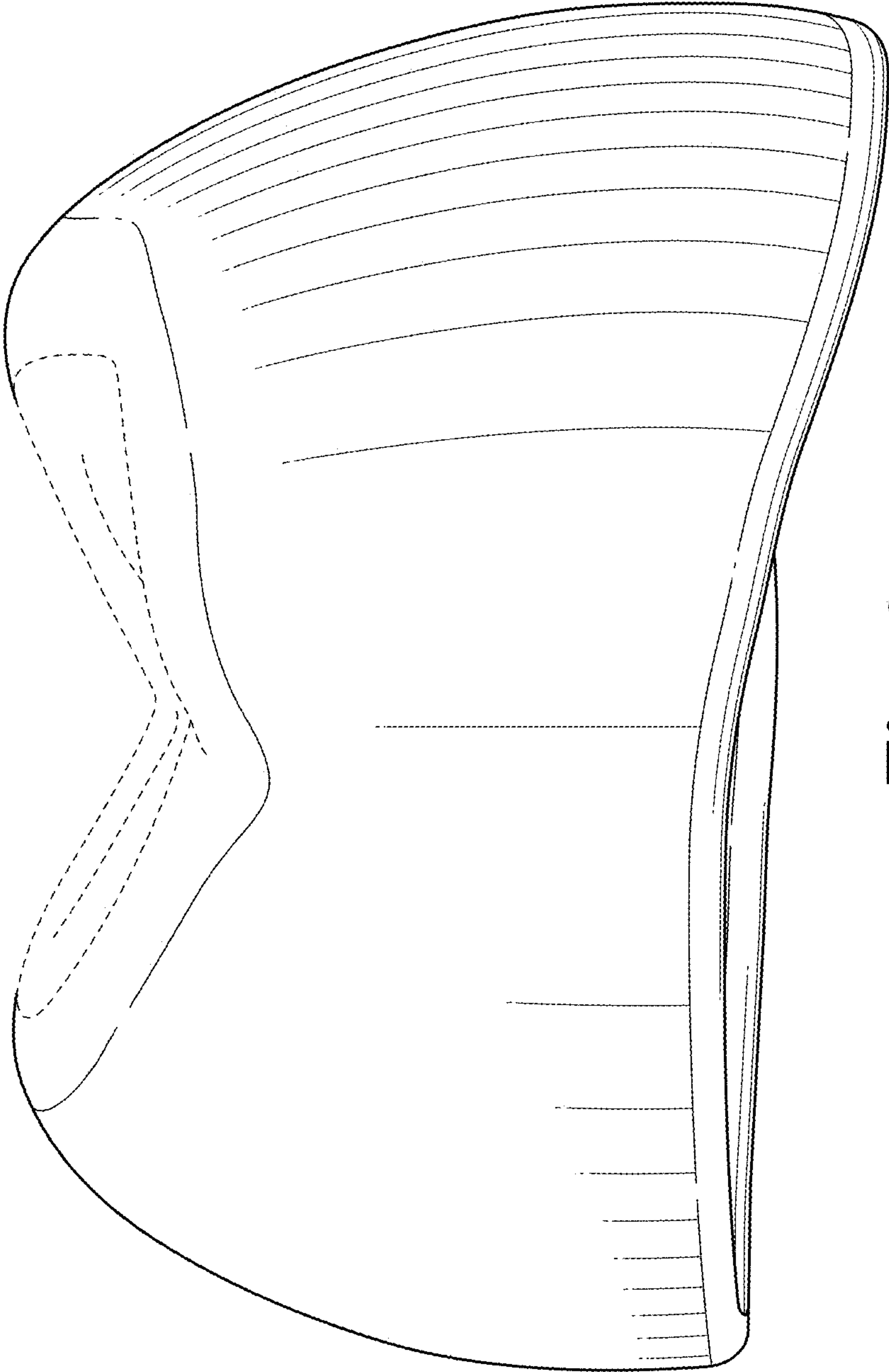

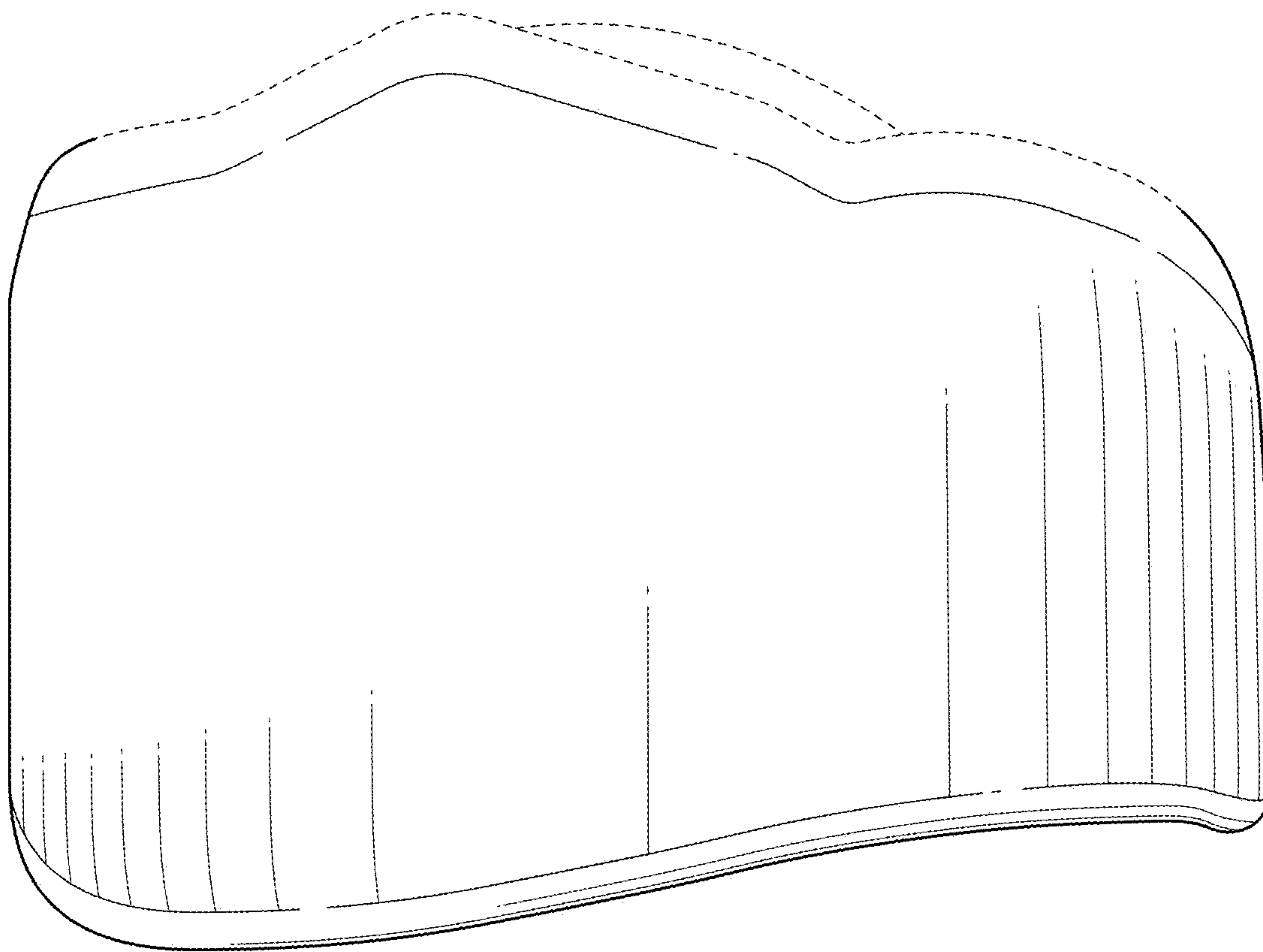

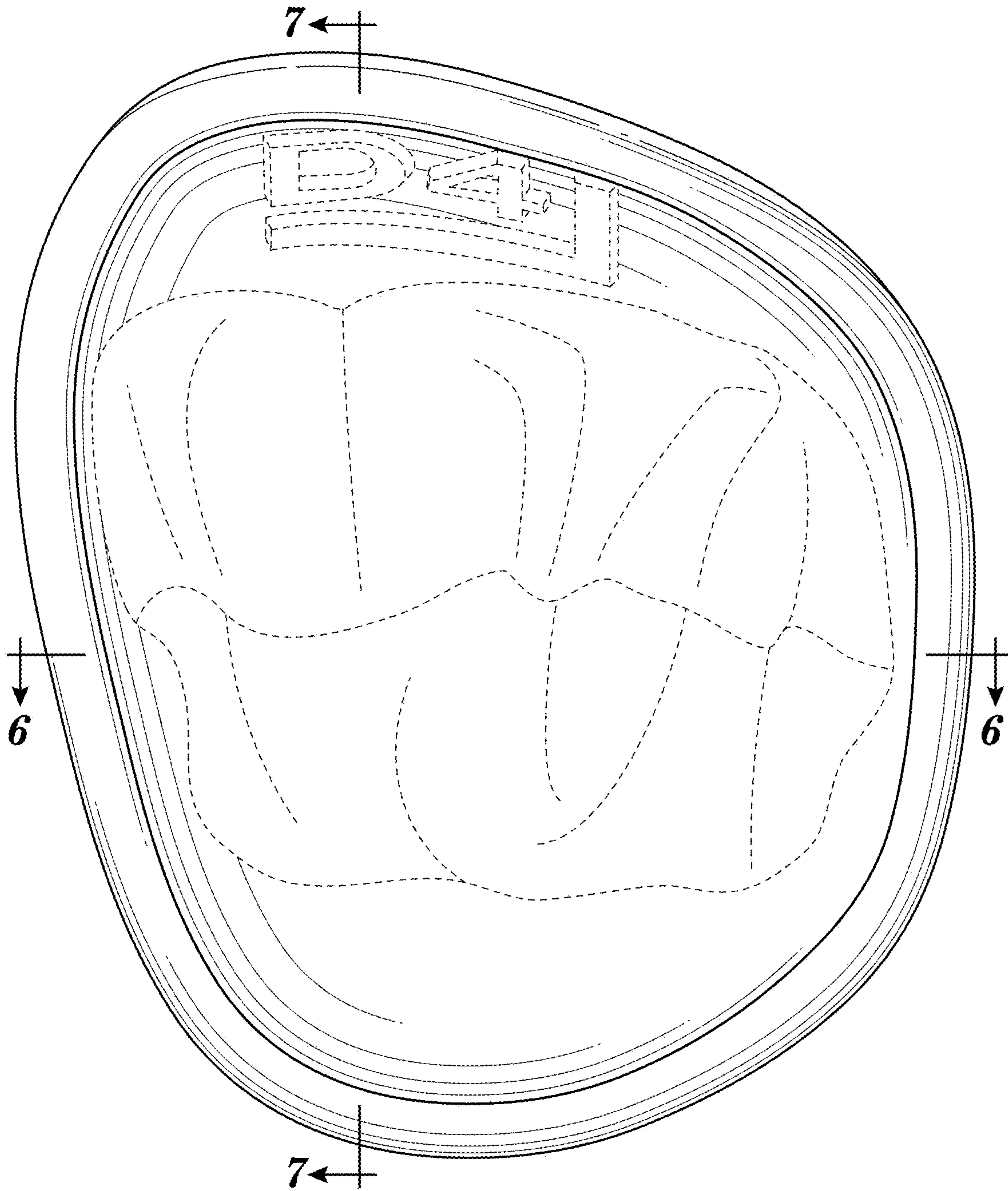

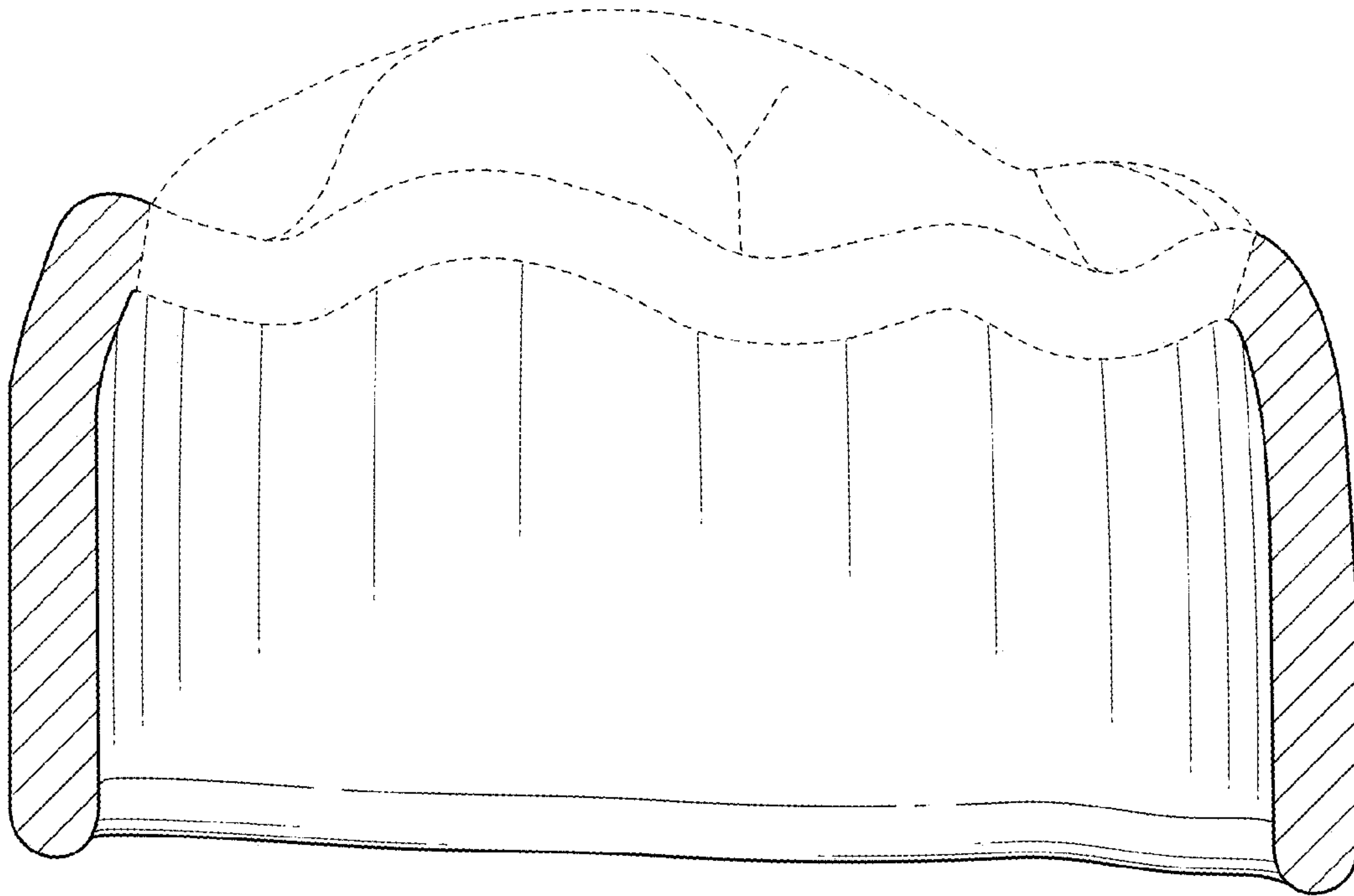

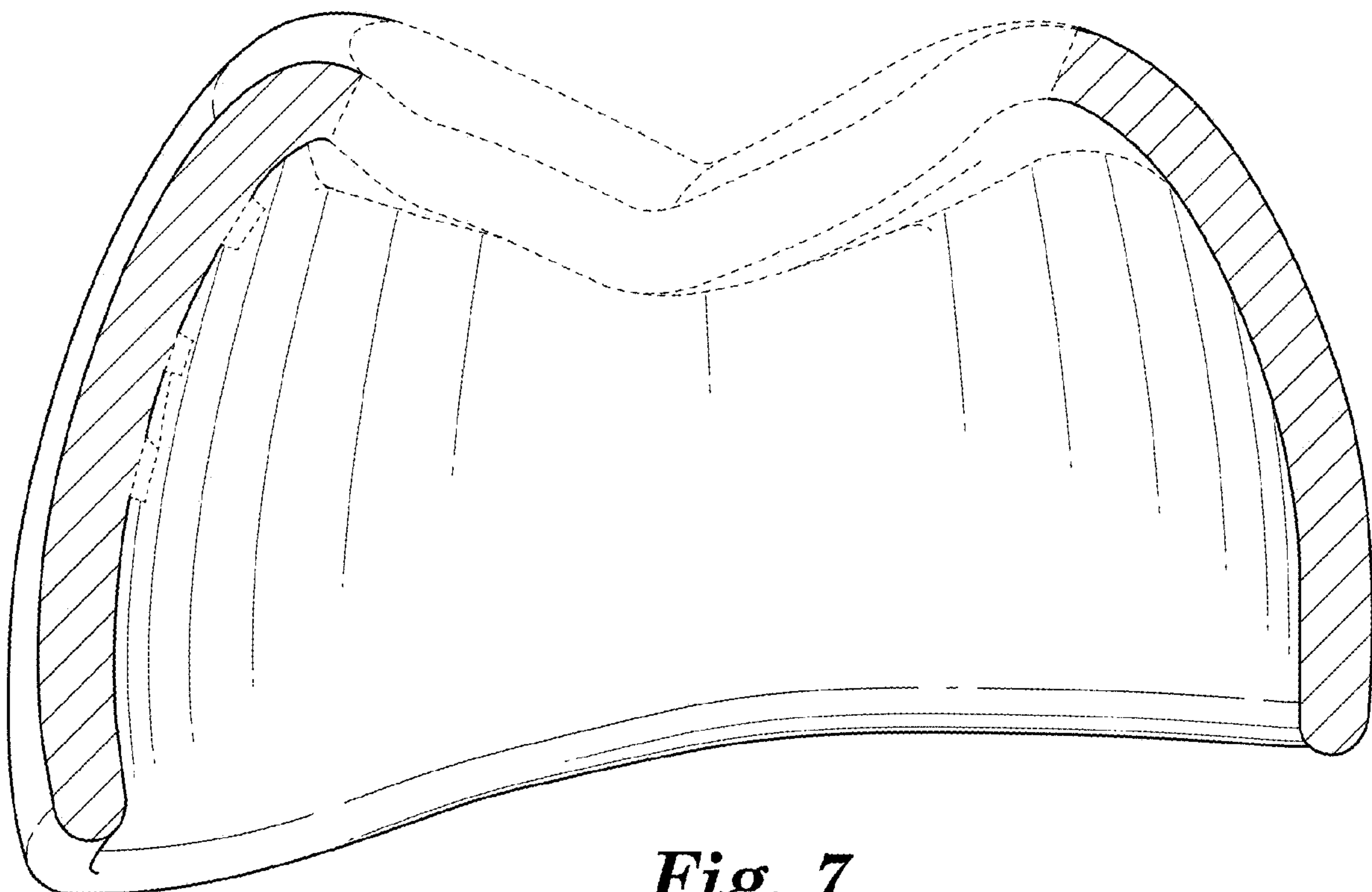
