I claim the ornamental design for a trellis, as shown and described.

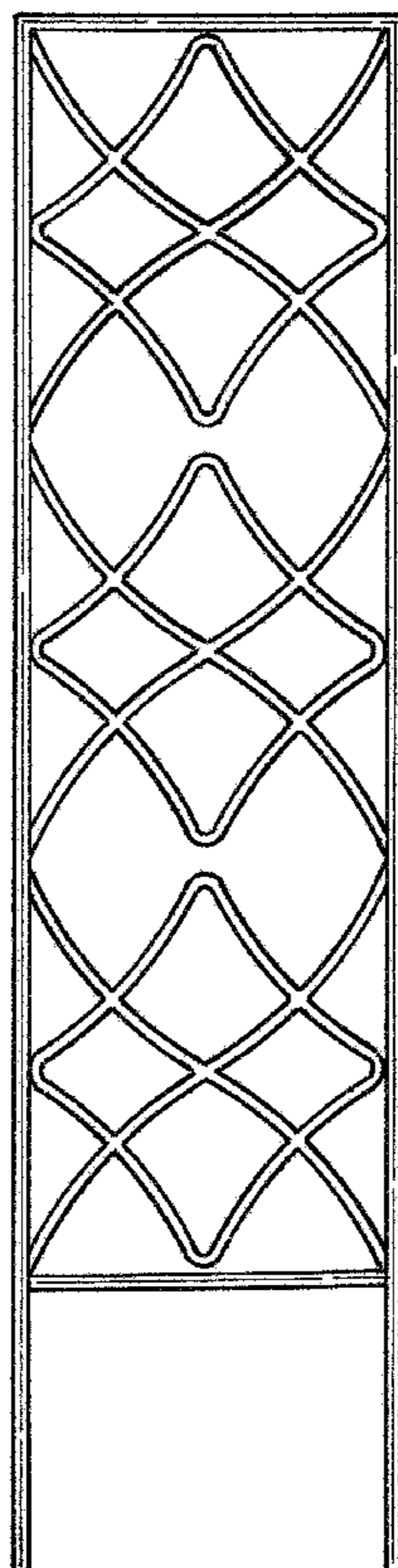
**DESCRIPTION**

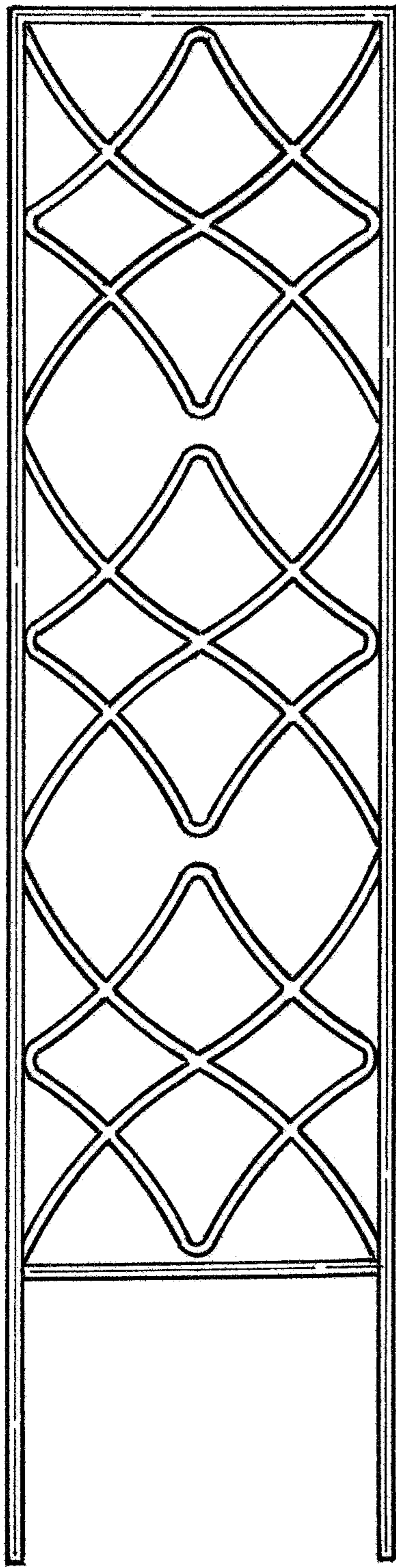

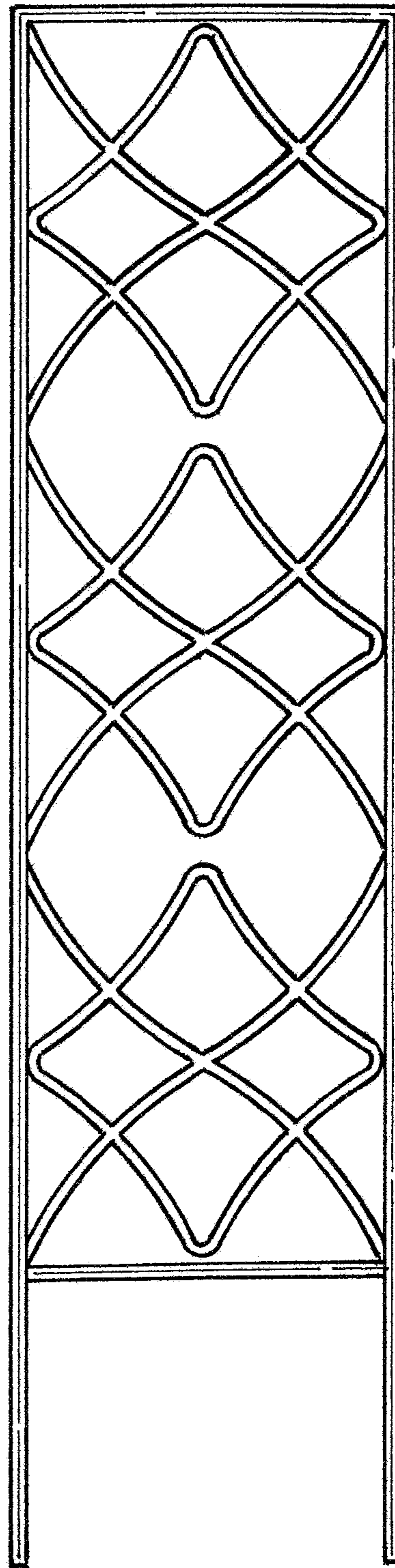

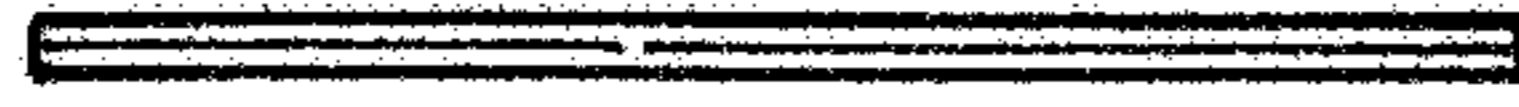

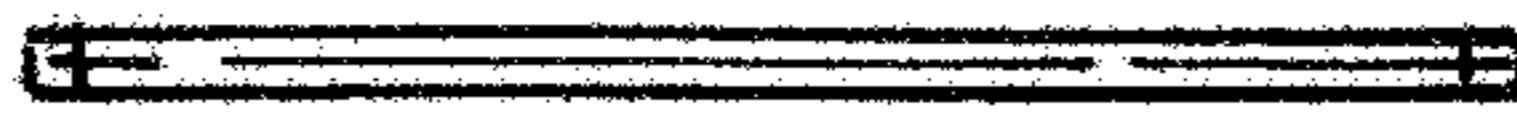

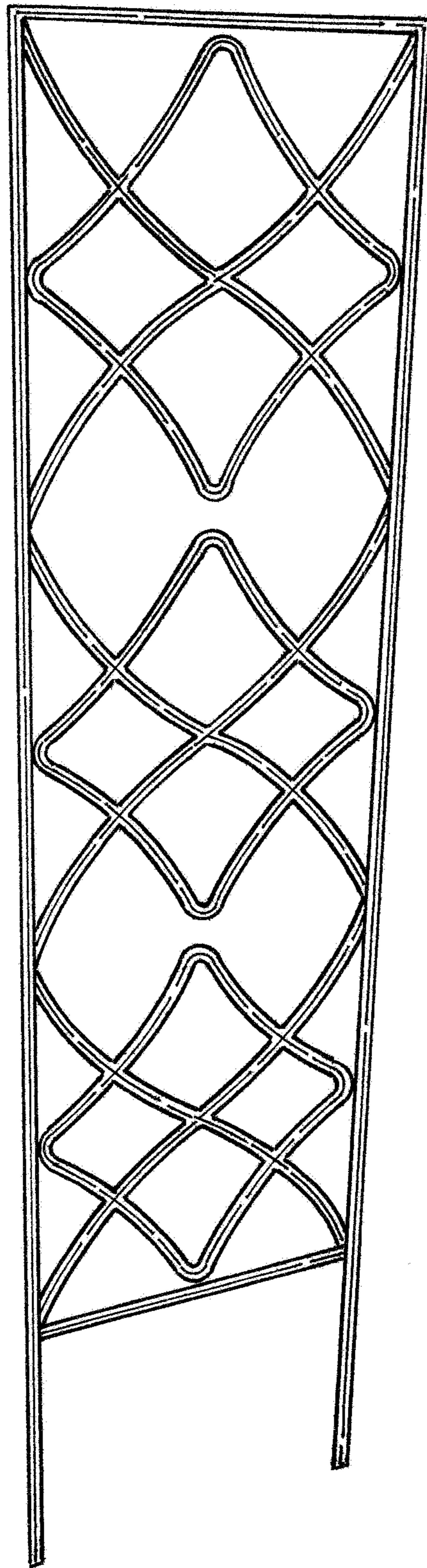
