**DESCRIPTION**

FIG. 1 is a perspective view of a pet stairs and ottoman in  
accordance with the present invention, shown in a non-  
extended configuration;

FIG. 2 is a front elevational view of the pet stairs and  
ottoman;

FIG. 3 is a top plan view of the pet stairs and ottoman;

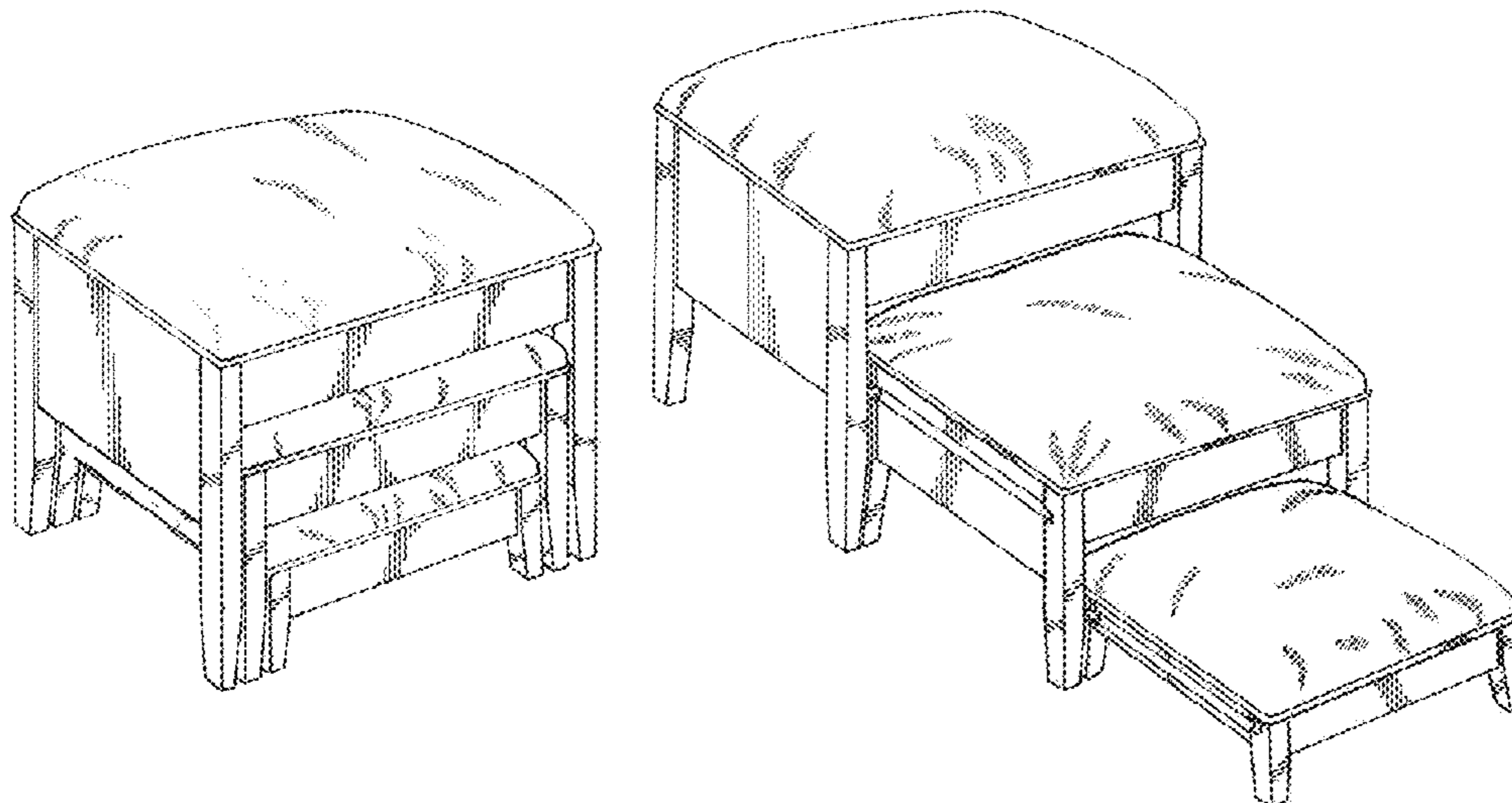
FIG. 4 is a first side elevational view of the pet stairs and

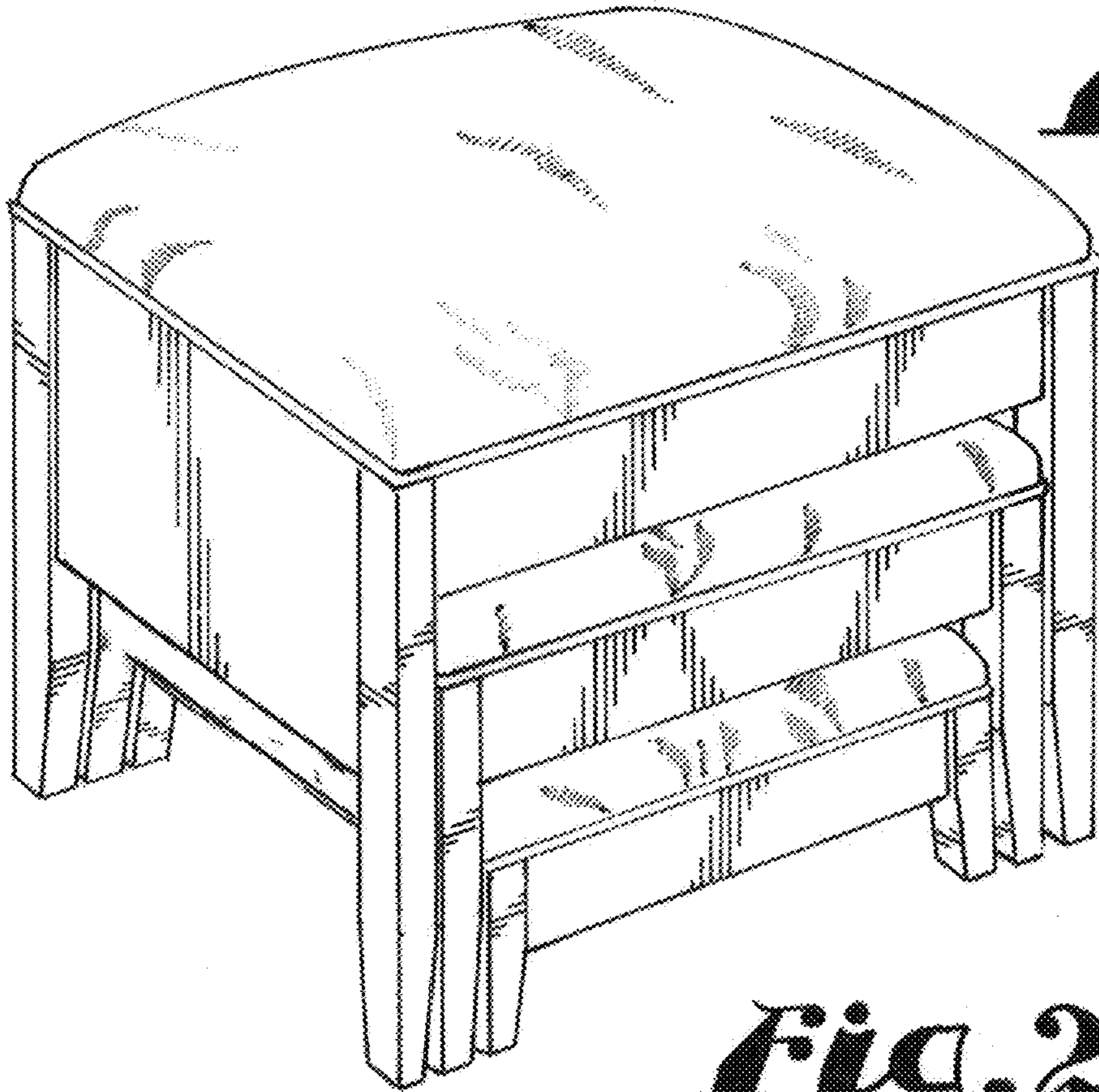

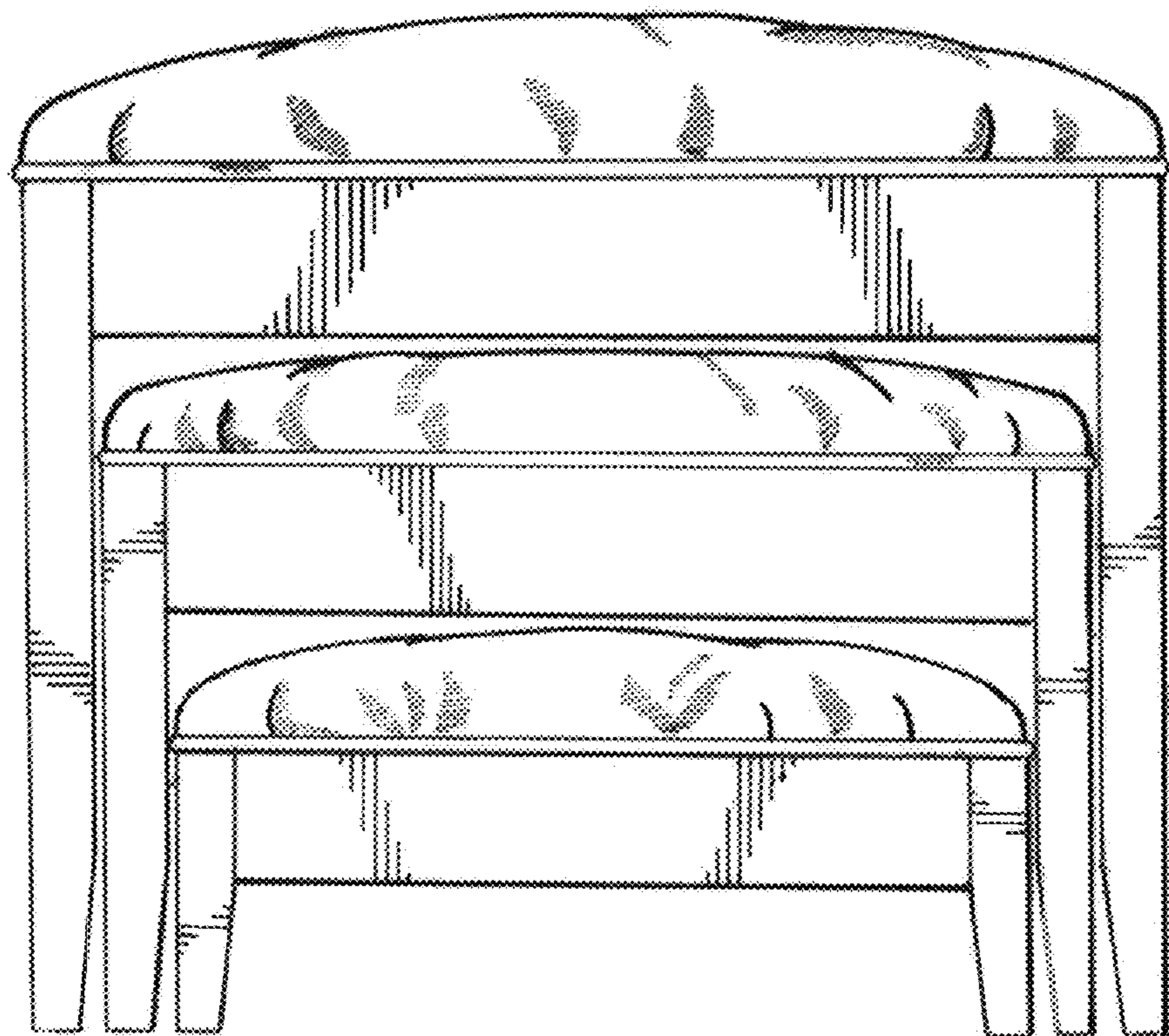

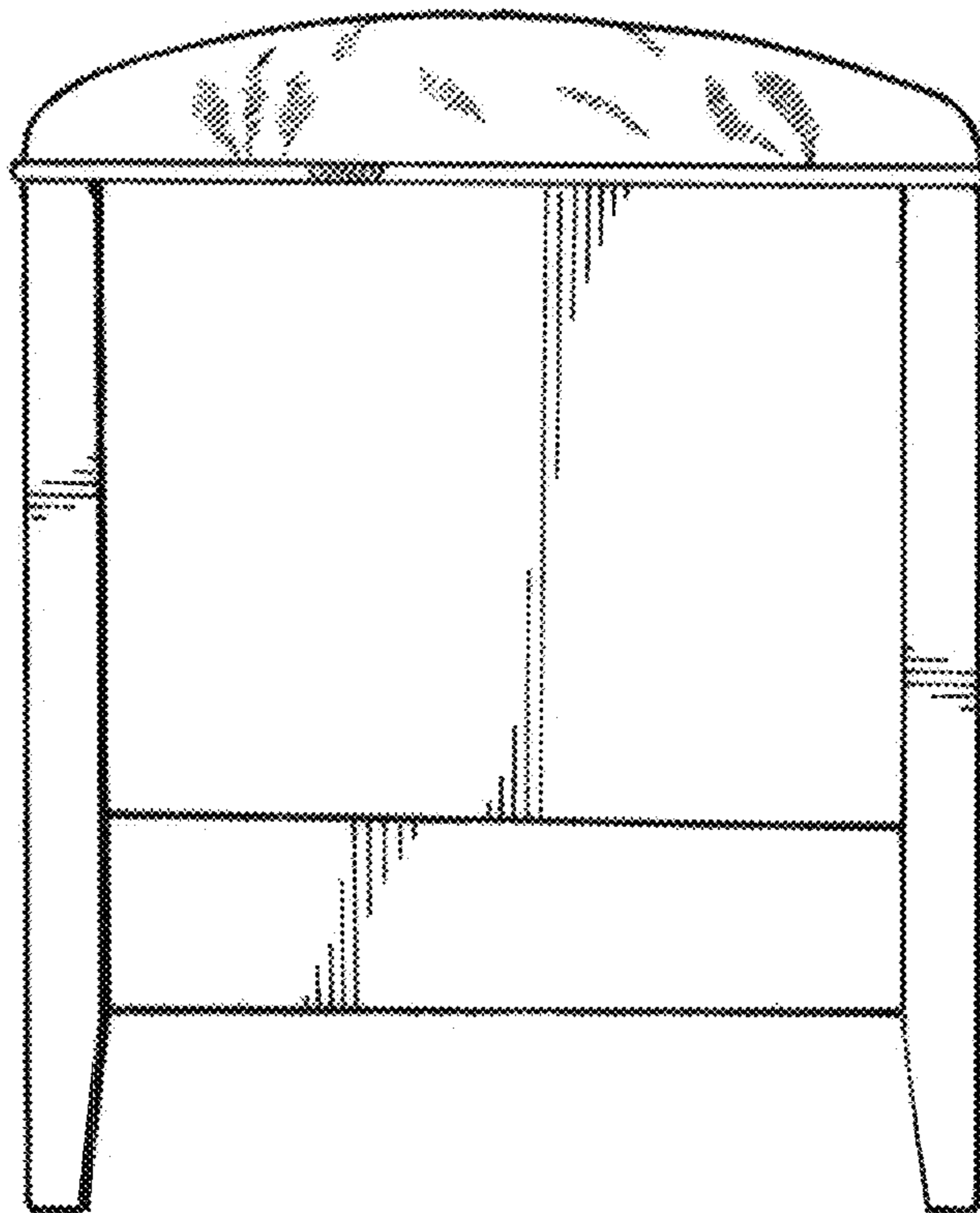

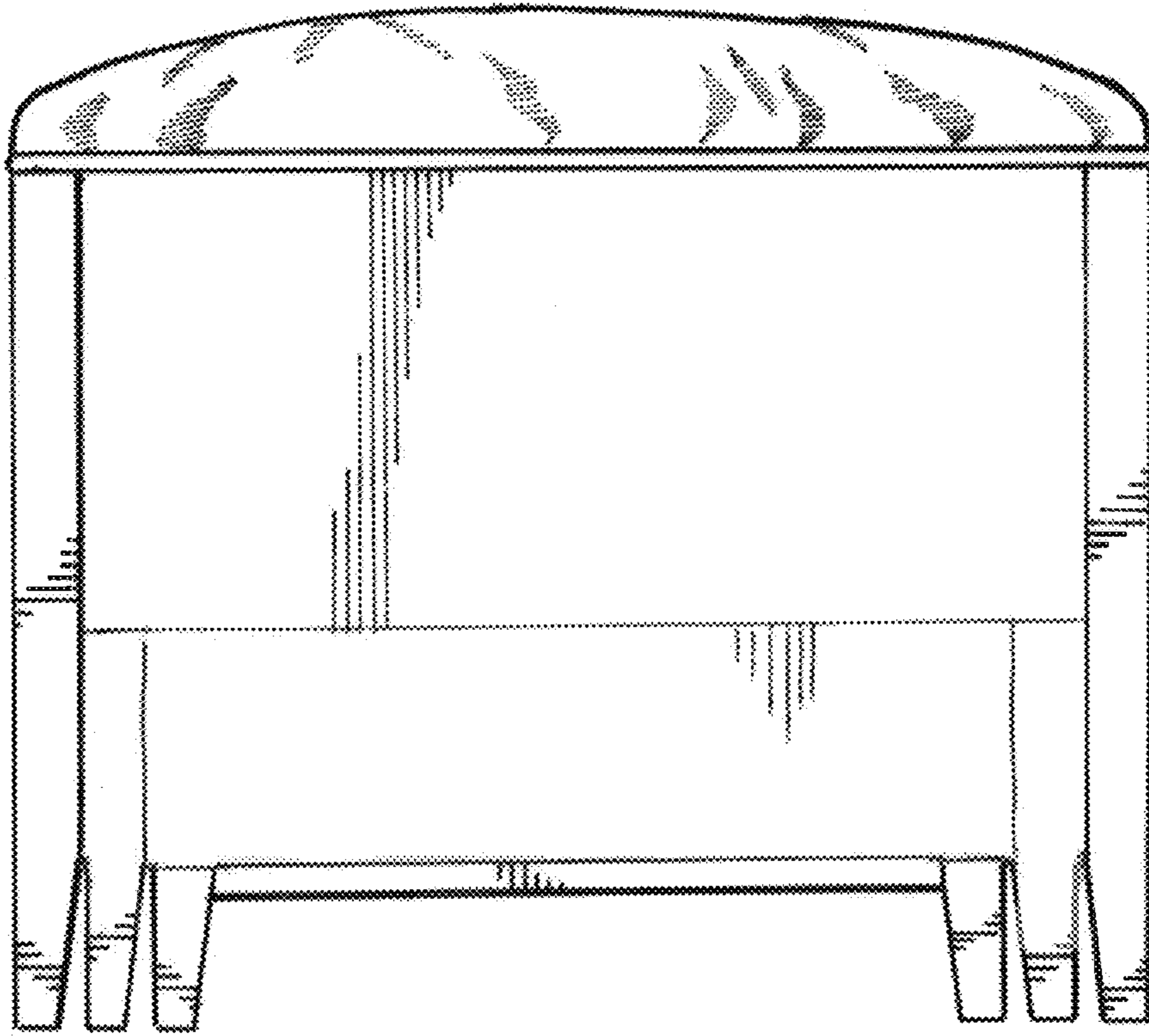




***Fig. 3.***

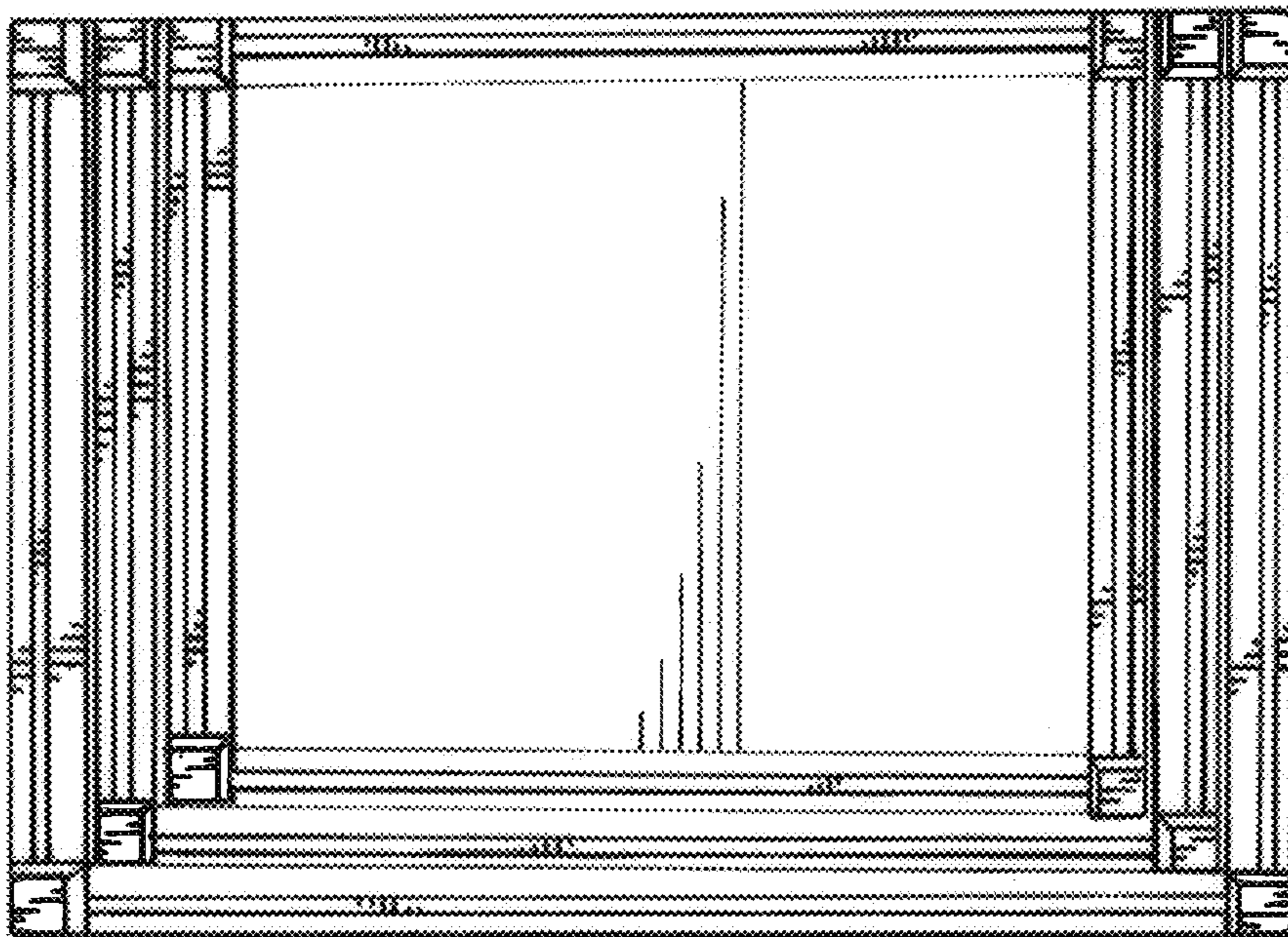
***Fig. 4.***
